Open Societies Statement reworked to prioritise national security over freedoms

Internet freedoms are subject to national security, said government sources, claiming that India's tough negotiations on the joint communique issued by G7 and Guest Countries at the session on Open Societies had ensured that the original language criticising "Internet shutdowns" was amended to include New Delhi's concerns.

The explanation came after the 'G7 and Guest Countries: 2021 Open Societies Statement' referred to "politically motivated Internet shutdowns", which indirectly addresses Internet blackouts in various parts of the world including India.

Kashmir has experienced Internet and mobile telephony shutdown since Article 370 was amended on August 5, 2019. Similar communication shutdowns were witnessed in Delhi and Assam during the protests against the Citizenship Amendment Act during 2019-2020 and the farmer's protest last January. Communication shutdowns were also witnessed in other parts of the world, including Hong Kong where a protest against Chinese security laws intensified dur-

The statement went on to say that the G7 and guest countries would "promote respect for internationally accepted norms that drive inclusivity and protect digital civic-space, including through capacity building, and ensure that the design and application of new technologies reflect our shared values, respect human rights and international law, promote diversity and embed principles of public safety".

Government sources said that "politically motivated Internet shutdowns" clarified that national security and public order concerns are an exception to the need for Internet freedoms.

According to the sources, during his visit to London in early May, External Affairs Minister S. Jaishankar fielded questions about the government's actions against protesters and the clampdown in Jammu and Kashmir after August 5, 2019. The sources said Mr. Jaishankar "made it clear" that law and order concerns were important and public safety had to be prioritised when regulating the flow of information.

He also fielded questions about the Internet shutdown for months in Jammuand Kashmir, as well as during the Republic Day protests by farmers in Delhi this year.

Mr. Jaishankar attended the meetings virtually as he was under quarantine in London.

The G7 Foreign Ministerslevel statement issued earlier in May, however, also referred to "Internet shutdowns" as a subject that the organisation would counter.

Both the foreign-funding of the study, which cost an estimated ₹1.9 crore, as well as concerns over the storage of the bat samples collected came up for scrutiny.

No Wuhan link The findings of the report became significant given the debate over the origins of COVID-19 worldwide, and handling of bat samples at the Wuhan Institute laboratory. However, scientific experts and officials that The Hindu spoke to made it clear that the Nagaland bat study on filoviruses (Ebola and Marburg) was in no way related to the coronavirus (SARS) studies at Wuhan.

When contacted, NCBS Director Satyajit Mayor said he had no knowledge of the Health Ministry's report's conclusions.

Rajasthan govt. to set up Vedic Education Board

The Congress government in Rajasthan will set up a Vedic Education and Sanskar Board to revive the knowledge of ancient Sanskrit scriptures and connect the learnings of the Vedas with science and yoga. The board is likely to be set up in the coming four to five months.

Minister of State for Sanskrit Education Subhash Garg said here on Monday that a committee appointed to define the aims, objectives and functioning of the board had submitted its report to the State government. Based on the panel's recommendations, board will adopt education modules revolving around Vedic knowledge.

The ruling Congress had promised the establishment of the Vedic Education and Sanskar Board as well as steps to promote Sanskrit

Summer effect at Singhu: farmers start collecting milk from villages

Group of protesters make rounds, bring hundreds of litres of milk to agitation site

With the summer at its peak, the availability of milk for consumption of protesting farmers has gone down. They have now resorted to collecting the dairy product from other villages.

Why the shortage?

Komaldeep Singh Cheema, a resident of Doaba, has been a part of the protest since the beginning. He said because of summers, the cattle are producing less milk and is leading to a limited supply from Haryana. As a result, Mr. Cheema and a few others from the district, have decided to collect milk for the consumption of farmers at the protest.

"Those from Punjab don't prefer packaged or powdered milk. Most of them fall sick if they consume it. This essentially has made us decide to take up this initiative," he said.

Mr. Komaldeep said announcements are being made in five villages since June 2, asking people to donate milk for the protesters. "Some people gave a litre

while others gave 2. Some even donated litres, and some gave a bucket full of milk. In one of the five villages, people donated more than 450 litres," he added.

Milk collected over four days was kept in an ice-making unit for preservation. The group then started for Singhu border from Doaba on June 6. "We finally collected 750 litres, put it in a water tanker with lots of ice, and covered it with wet sacks," he said.

At the protest site, they

drive across the lengthy stretch distributing milk to people and those running langar services. The kheer langar, which was running for months, stopped a while ago because of milk shortage and also the dishes being perishable.

The group made two rounds from the villages to Singhu and is set to make its third round to the protest site. Mr. Komaldeep said that after she shared his initiative on social media, people from Canada and the UK have called him to extend help.

Help pours in

"A man called me from the UK and asked how we were transporting the milk. When I explained we were taking it in water tankers, he said he'll send ₹1.5 lakh for a special tanker to be built for milk. Another person called from Canada and extended help for unlimited petrol for the journey," Mr. Cheema said.

Another initiative taken at the protest site is Kisan Express, a trolley fitted with seats for people to be transported from their lodging to the stage. The initiative was taken by Life Care Foundation, Kisan Aid, and Swach Kisan Morcha.

"The reason Kisan Express has been started is to increase the number of people coming to the stage area. Because of heat and mostly the elderly staying here, it became important for them to have a vehicle for commute," said Avtar Singh, who runs a makeshift hospital at the protest site. He added that the battery rickshaw was proving to be expensive and less efficient

Delhi govt.'s claim on ONORC misleading, Centre tells SC

Ration card portability dependent on ePoS machines

The Central government maintained in the Supreme Court that the Delhi government's claim to have launched 'One Nation One Card' (ONORC) Ration scheme was "misleading".

"The claim of Government of National Capital Territory of Delhi regarding launch of One Nation One Ration Card [ONORC] plan in NCT of Delhi is misleading, as they claim to have implemented it only in circle 63 Seemapuri. Only a handful of transactions conducted in a single circle with about 42 electronic points of sale (ePOS) machines cannot be considered as implementation of ONORC," the Centre submitted before the court.

The Centre, represented by Additional Solicitor General Aishwarva Bhati, observed that the implementation of the ONORC would require national portability transactions to be rolled out formally in all the fair price shops of all the circles of Delhi in which more than 2,000 ePoS (electronic point of sale) machines had been supplied and were waiting for operation.

"It is pertinent to appreciate that a very large number



of inter-State migrants are present across Delhi, such as migrant workers, street dwellers, ragpickers, migratory labourers, construction workers, rickshaw pullers, auto/taxi drivers, and others, who do not have access to their National Food Security Act food grains," the Centre

None of these economically marginalised population, who were away from their native villages and towns, were able to access their quota of subsidised food commodities assured to them under the Food Security Act, it stated.

"There is no full implementation of the ONORC and reporting of such transactions/distribution details of NFSA/PMGKAY food grains on the central portals/dashboards," it noted

The onus of implementing the ONORC was on the States.

While most States were implementing it, Assam, Chhattisgarh, Delhi and West Bengal have not yet integrated into the scheme. Their integration would depend on their "technical readiness" to implement the portability of ration cards, it pointed out.

The Centre's submissions came despite Delhi's stand that it was implementing the ONORC scheme.

Recently, Food Secretary Sudhanshu Pandey had written to the Delhi government to resume the use of ePoS machines at ration shops. He said at least 10 lakh migrant workers, who had ration cards in their home States, would be able to access subsidised food grains in the Capital.

Ration card portability under the ONORC scheme is dependent on ePoS machines, as they use Aadhaar-linked biometric authentication to verify the identity and entitlement of beneficiaries even if they are not registered at that particular shop. Delhi had suspended the use of ePoS in early 2018, after widespread complaints of poor network leading to authentication failures and exclusion of genuine beneficiaries.

Senior citizen murdered in east Delhi

Accused held; police say it seems to be case of sexual assault

A 62-year-old woman was allegedly stabbed to death in east Delhi's Dallupura village, the police said on Monday. They said prima facie, it appears to be a case of sexual assault, however, a postmortem report is awaited.

The accused - Vipin Dedha from Dallupura village has been arrested, a senior

The police received information about the incident from Dharamshila Hospital on Sunday at New Ashok Nagar police station. "A team reached the hospital and found that the victim, a resident Dallupura village, was declared brought dead in

the hospital. Her throat was slit with a sharp-edged weapon, and she also sustained multiple injuries on her stomach," said DCP (East) Priyanka Kashyap.

Next, a case under Section 302 (Murder) was registered at New Ashok Nagar police station. During investigation, the police analysed the CCTV footage of the area and identified the accused following which he was

During interrogation, he admitted having committed the offence, the police said, adding that a knife, used in the crime, has been recovered. The accused told the police that he was in an inebriated condition at that

time. The incident came to light when the woman's son came home after completing his duty as a guard in Noida and found her lying in a pool of blood. The woman was from Begusarai in Bihar and used to live in the city with her son and grandson. She used to sell vegetables near her house. The incident happened on Sunday when she was selling vegetables with her grandson. At 12 p.m., she went home to cook food when the accused attacked

The accused stabbed her over 20 times, an officer said, adding that the body has been sent to Lal Bahadur Shastri hospital for medical

Civil volunteer impersonates ASI at station to travel for free

A 22-year-old Delhi Civil Defence (DCD) volunteer was arrested for allegedly impersonating a Delhi Police Assistant Sub-Inspector at Old Delhi Railway station to travel without a ticket, the police said on Monday.

DCP (Railways) Harendra Kumar Singh said the accused has been identified as Jai Kishan Yadav.

The incident came to the fore on Sunday morning after Constable Yogesh Kumar spotted Yadav in Delhi Police ASI uniform. Yadav told the Constable that he joined the force in 2019.

"When the Constable posted with the 7th battalion of Delhi Armed Police asked Yadav as to how he got promoted to the ASI rank at such a young age, the accused could not give a satisfactory response," Mr. Singh said.

'Wanted to go home'

During interrogation, he allegedly told police that he is a resident of Mayapuri Phase-II. He said he along with his two brothers wanted to go to their home in Uttar Pradesh by Farrakka Express train but they had only two confirmed tickets. "Yadav said he wore the uniform so that he is not questioned during his travel," Mr. Singh said.

HC quashes bail to former Fortis chief

The Delhi High Court on Monday quashed a local court order granting bail to former promoter of Fortis Healthcare Shivinder Mohan Singh in a case of allegedly misappropriating funds of Religare

Finvest Ltd. Justice Suresh Kumar Kait noted that "continued detention of respondent No.2 (Mr. Singh) in this FIR case is necessary not only to unearth the conspiracy hatched by him, but also to derive out/ trace the siphoned money which he has credited for his personal be-

The court said the "nature and gravity" of accusation against Mr. Singh was serious.

"The grant of bail in a case involving cheating, criminal breach of interest by an agent of such a large magnitude of money, affecting a very large number of people would also have an adverse impact not only on the progress of the case but also on the trust of the criminal justice system that people repose," it said.

On the argument of Mr. Singh that other co-accused have been granted bail in this case, the court observed, "while granting or refusing bail, the role attributed to each accused has to be seen independently and reasoning for one may not be bind-

Delhi bans soaps, detergents not conforming to new BIS rules

To reduce pollution in the Yamuna, the Delhi government on Monday banned the sale, storage, transportation, and marketing of soaps and detergents, which do not conform to the revised Bureau of Indian Standards rules, as per an official order.

The order was issued by the Delhi Pollution Control Committee. In January, the National Green Tribunal had accepted recommendations of a two-member expert panel which had suggested directing the Delhi government to take such a step.

All authorities should ensure compliance of the order through strict vigil and surprise checks, read, the order.

Experts have cited soaps and detergents as one of the major reasons behind pollution in the Yamuna. Many times, visuals of toxic froth floating on the surface of the river in Delhi also make their way to social media.

DSSSB exam: HC upholds order for registering FIR under SC/ST Act

The Delhi High Court on Monday upheld a trial court's order directing authorities to lodge FIR under the provisions of the Scheduled Caste and Scheduled Tribe (Prevention of Atrocities) Act, in a case of caste-based questions being allegedly asked in the primary teachers' recruitment exam by the Delhi Subordinate Services Selection Board (DSSSB).

The HC said the questions in two examinations held on October 13, 2018, and August 18, 2019, were "undoubtedly prima facie fall within the domain of an intentional insult or intimidation with an intent to insult members of the SC/ST within public view".

The HC said whether the DSSSB was aware of the contents of the papers can be ascertained only through an investigation.

CPI(M) seeks relief for locals of illegal colony

Leader of the Left parties here on Monday demanded that the residents of Khori Basti, an unauthorised colony on forest land, be rehabilitated and compensated before carrying out the demolition drive in adherence to the Supreme Court order.

The demand was made by a joint delegation of the Communist Party of India (Marxist) and Communist Party of India leaders in a memorandum addressed to Chief Minister Manohar Lal submitted at the Faridabad Deputy Commissioner office.

The Supreme Court had on June 7 directed the Municipal Corporation of Faridabad (MCF) to remove encroachments on the forest land without any exception within six weeks. The matter is listed for hearing on July 27.

MCF Commissioner Garima Mittal told The Hindu that the civic body had not decided on the date of demolition, but the court orders would be implemented "in letter and spirit". She said that no rehabilitation plan was discussed so far.

Junaid murder: Nuh MLA seeks strict action

Deputy Leader of the Congress Legislative Party and Nuh MLA Aftab Ahmed on Monday demanded strict action against the policemen accused of beating up Junaid, a resident of Jamalgarh, in police custody leading to his death. Sixth sero survey can't be compared to last one as it had to be halted, says official

There is "no significant" change in the percentage of people, who have developed antibodies against COVID-19. as per the sixth serological survey, compared to the previous such survey, according to an official privy to the development.

The result of the sixth serological survey, which was done in April, has been submitted to the Delhi government last week.

But the survey was stopped in April due to the surge in COVID-19 cases and could not reach the planned target of samples.

Around 13,000 blood samples from 141 wards were collected against a target of 28,000 samples from all 272 wards in the city, officials said. The result of the sixth sero





Badal not to appear before SIT tomorrow in Kotkapura case

The former CM cites health reasons, asks for rescheduling of appearance date

Former Punjab Chief Minister and Shiromani Akali Dal patron Parkash Singh Badal will not be appearing before the Special Investigating Team (SIT), probing the 2015 Kotkapura police firing incident, due to health rea-

Mr. Badal has been summoned by the SIT at a resthouse in Mohali on June 16.

In a letter to the SIT chairman, Mr. Badal said that he was committed to fully cooperate with the law and that he had complete faith in the judiciary. He had, however, asked the SIT "to reschedule the date for his apfor pearance investigations as he was not keeping good health and

had been advised complete bed rest for ten days by doctors."

The former Chief Minister said that as soon as his health gets better he would be available to join the investigation as per law. Mr. Badal added that he was hopeful that "the newly set-up SIT, unlike the previous one, would respect the law of the land and conduct a fair investigation, withstanding political interference from the ruling dispensation."

In his two-page response to the summon from the SIT, Mr. Badal said that "the entire process of investigations already stands brazenly compromised through blatant and unapologetic political interference and it reeks too strongly of political vendetta to inspire any confidence about a fair process of law being followed."

The Akali Dal leader pointed out that the very need for the present SIT had "arisen out of the brazen politicisation of the case by the previous SIT." In this regard, Mr. Badal came down heavily against one of the members of the previous SIT for his "openly political conduct" which had allegedly subverted the entire investigative process.

SIT role questioned

"With a callous and contemptuous disregard for all the established procedures and norms, this officer completely usurped and appropriated to himself the entire functioning and designated role of all the other members of the SIT, including it Chairman, and rendered them totally redundant and they were reportedly not even a part of the investigative process," said Mr. Badal.

Mr. Badal said that the findings of the previous SIT had been scripted jointly by half a dozen high profile members of the ruling party.

"At the behest of the government, the police administration has violated our constitutional right to protest, but we will continue our struggle and the AAP workers would go on hunger strike on June 15 in front of the offices of Deputy Commissioners in all the districts across the State," he said.

'Register case'

Mr. Cheema said AAP's struggle would continue until a police case was registered against the wrongdoers under Scheduled Castes and Tribes (Prevention of Atrocities) Act. Senior AAP leader Manwinder Singh Giaspura said the investigation report submitted by senior IAS officer Kirpa Shankar Saroj on the alleged post-matric scholarship scam revealed that the scholarships were given to fake colleges. "As a result, genuine private colleges have not received funds and lakhs of Dalit students have been deprived of their right to education," he said.

Deputy Leader of Opposition Saravjit Kaur Manuke, said "while the government has embezzled the scholarship money of Dalit students, it has also discriminated in giving jobs to Dalit youth and promotions to employees.'

+ 'Under-reporting of virus deaths in Odisha' STAFF REPORTER

The Odisha Congress on Monday accused the Naveen Patnaik government of under-reporting COVID-19 deaths to cover up its failure in tackling the pandemic.

In about 40 days, Nayagarh, a small district, has officially communicated that 117 persons have succumbed to COVID-19. However, the State government has been maintaining Nayagarh's COVID-19 death-toll at 59, combining fatalities of both first and second waves," Congress leader Nishinkant Mishra told a press

Mr. Mishra said Nayagarh's actual deaths got exposed when the internal communication of inclusion of pandemic victims found its way to public domain.

Special audit sought

"The government document says 117 persons died of COVID-19 between April 28 and June 10," said the Congress leader. Demanding a special audit of all COVID-19 deaths in the State, the Congress said there was no harm in making the actual death figure public.

Alleging that under-reporting of deaths was deliberate, Mr. Mishra said the government must own responsibility for mismanaging the pandemic as many people in rural areas were left to die without the robust healthcare system.

COVID: child rights panel to identify children for relief

SPECIAL CORRESPONDENT

The Rajasthan State Commission for Protection of Child Rights will render assistance to voluntary groups in the identification of children who have lost their parents to the CO-VID-19 infection, for a financial relief package announced by the State government. The orphans will get an ex gratia of ₹1 lakh each, followed by a financial assistance every month.

Commission chairperson Sangeeta Beniwal said here on Monday though the pandemic had affected all sections during the last one year, children in the rural areas had borne the brunt because of poverty and vulnerability. Coupled with the child labour, the pandemic had brought havoc to children.

Ms. Beniwal said at a virtual event here that the community participation at the grassroots would help eradicate child labour and extend relief to the children affected by the pandemic. Banswara-based Vaagdhara group, which is working on the livelihood issues in the tribal areas, organised the event, attended by social activists and child rights volunteers.

As part of the Chief Minister's Corona Baal Kalyan Yojana, the children who lost their parents will get, besides the ex gratia, ₹2,500 a month till they attain 18 years of age.



An elite club

The G-7 needs to be more open and less exclusive in an increasingly interlinked world

The G-7 summit, at Carbis Bay, sent out two very strong messages. The first was driven by the United States's new President Joseph Biden and his vow that "America is back" to take the lead on global challenges. The G-7 commitment to donate one billion coronavirus vaccines to poorer countries and to invest \$12 trillion in their combined pandemic recovery plan depends on U.S. commitments for a large part. The special communiqué on "Open Societies" for the G-7 outreach, and the invitation to "fellow democracies" India, Australia, South Korea and South Africa are also an extension of his stated commitment to convening a Democracy Summit this year. Even the slogan for the G-7, "Build Back Better", was a White House term to declare America's economy and jobs recovery plan. The second message was the consensus amongst the seven-member countries on countering China. The final G-7 communiqué holds no less than four direct references to China, each negative, including criticising Beijing for its rights record in Xinjiang and democratic freedoms in Hong Kong, its "non-market policies and practices...", concerns over its actions in the China Seas, and a demand for a transparent investigation into the origins of the COVID-19 virus. Though the bonhomie among the G-7 leaders was palpable, the differences and contradictions in the grouping remain a challenge. Even two decades ago, questions were raised about whether the grouping (earlier, the G-8), could claim its mantle as the world's "richest" countries, when emerging economies, China and India, are not included. On economic issues, the EU is a more representative unit than the individual European G-7 member countries. Finally, the premise of a group like the G-7, that of an exclusive club of the "haves" or "the best vs the rest", seems anachronistic in a world that is much more interlinked now than in 1975, when the grouping first came about.

India, a special guest to the G-7/G-8 since 2003, has also maintained its independent course, especially on political issues. It is significant that the G-7 outreach communiqués that included the guest countries, did not make the same references to China as the main document, and MEA officials clarified that Chinese aggression was not raised at the outreaches, which focused on the pandemic, climate change and democratic freedoms. India voiced concerns about some clauses in the joint communiqué on Open Societies which condemned "rising authoritarianism", net shutdowns, manipulation of information, and rights violations – areas where the Modi government has often been criticised itself. Addressing the session on Open Societies, Mr. Modi said that India is a "natural ally" to the G-7. In the present, the Government will be expected to walk the talk on its commitments at the G-7 outreach, especially in the areas of information clampdowns, given that India had the largest number of Internet shutdowns in 2020.

Numero Uno

Djokovic is now in sight of a Golden Slam after winning on a difficult surface

ovak Djokovic has always maintained that ending his career with the most number of Grand Slam titles is one of his prime motivations to keep playing tennis. In the Roland-Garros final on Sunday, he took a giant stride in realising this dream with a sensational come-from-behind five-set victory over the fast-rising Greek Stefanos Tsitsipas for his 19th Major, pulling him within one title of his celebrated rivals Roger Federer and Rafael Nadal. It was the Serb's second French Open trophy, making him only the third man in history (after Roy Emerson and Rod Laver) and first in the Open Era (post 1967) to win all four Slams at least twice. The rhythmic allure of the record aside, the sense of completeness and the feeling of sporting immortality it brings, even to a career as storied as Djokovic's, is unparalleled. So will the 34-year-old's semifinal victory over 13-time champion Nadal, the greatest of all clay-courters. That Djokovic had the tennis to challenge the Spaniard was never in doubt. What was astonishing was the way he bounced back from the shell-shocking in last year's final and outwitted an in-form Nadal. For Djokovic to not fall off the emotional cliff and defeat Tsitsipas – a player 12 years younger – brought to light one of his constant themes - poise and resilience under relentless pressure.

The triumph is yet another reminder that Djokovic is this era's most complete player. Where Federer has tweaked his shot-making with a larger racquet-head and Nadal has displayed new levels of aggression, Djokovic has prioritised balance, footwork and timing. Currently, no one can perhaps hit as well as Djokovic, from both wings, with pace and spin, at varied angles, even when on defence. As Nadal and Tsitsipas found out over exactly four hours and 11 minutes each, a tennis court had never felt smaller. This has now kindled hopes of a 'golden' Grand Slam, a herculean feat of winning all four Majors and the Olympic gold in a single year. However, if there is one man who has dared to dream and succeeded, it is Djokovic. Unseeded Barbora Krejcikova perhaps took cue and became the Czech Republic's first singles champion in Paris in 40 years, providing a storyline to latch on to after Naomi Osaka's withdrawal because of mental health concerns and Serena Williams' early exit. Nine months ago, Krejcikova was ranked outside the top-100 and had appeared in only three singles main draws at Slams. But with two doubles and three mixed doubles trophies, she was no stranger to success. Over the last fortnight, with her delightfully languid but polished game, she became the first woman since Mary Pierce in 2000 to sweep both singles and doubles at Roland-Garros.

China is now in a different league, competing with the U.S., and New Delhi faces the task of living with an uneasy calm



n June 15 last year, the Line of Actual Control (LAC) witnessed its first deaths after 1975 when 20 Indian soldiers and at least four soldiers of China's People's Liberation Army (PLA) died in a violent clash in Galwan in Ladakh. An Indian news report (https://bit.ly/3wmUefH) mentioned that around 50 Indian soldiers had been taken captive by the PLA during the clash and released in batches over three days. Although both countries have given gallantry awards to the fallen soldiers, details about the violent incident have not been officially made public so far.

Political accountability

This is in keeping with the broader approach of the Government where no official briefing or press conference about the situation in Ladakh has taken place in the last 13 months. The ministerial statements in Parliament were monologues with no questions allowed from other representatives of the people. The official excuse was operational security, but the actual reason was to avoid political embarrassment for Prime Minister Narendra Modi. Four days after the Galwan clash, Mr. Modi addressed an all-party meet where he unequivocally stated, "Na koi wahan hamari seema mein ghus aaya hai aur nahi koi ghusa hua hai, na hi hamari koi post kisi dusre ke kabze mein hain" (No one has intruded and nor is anyone intruding, nor has any post been captured by someone)." A huge public outcry led to an official clarification by the Prime Minister's Office which contained rhetoric that dodged the offending remarks (https://bit.ly/3vjqoaJ).

The Government's political strategy for dealing with the Ladakh border crisis has been based on dodging, denial and digression. An honest appraisal of the situation in Ladakh would be politically costly for a government led by a "strong" Prime Minister, as PLA soldiers remain in control of what was hitherto in Indian control. Despite the largely supportive news channels, the Government has not been able to convince the public about its version of events. In the recent 'State of Nation' poll conducted by C-Voter, 44.8% respondents said the Chinese encroachment in Ladakh was a failure of the Modi government, while only 37.3% said it was not (https://bit.ly/3gmiadA).

The crisis in Ladakh erupted months after Mr. Modi had held his second informal summit with the Chinese President Xi Jinping (at Mamallapuram, Tamil Nadu) and weeks after he hosted the then United States President Donald Trump for a political event in Ahmedabad, Gujarat. For someone attributing his foreign policy prowess to the power of his persona and his personal chemistry with other world leaders, there could be no worse rebuttal of his claims than the timing of the Chinese incursions. In a government identified solely with the Prime Minister and dominated by his office there is no record of the Cabinet Committee on Security being convened to discuss the Ladakh border situation – Mr. Modi is being held responsible in the public imagination for the setback.

Military situation

The current situation is not militarily precarious in Ladakh. With a continued deployment of 50,000-60,000 soldiers, the Indian Army has been able to hold the line to prevent any further ingress by the PLA. The Chinese presence on the Indian side of the LAC in Gogra, Hot Springs and Demchok gives the PLA some tactical advantage but the area which majorly jolts Indian military plans is the Chinese control of Depsang Plains. With "official sources" trying to palm it off as a legacy issue, despite evidence to the contrary from many



retired military officers, the Indian Army has only weakened its negotiating position during the talks with the PLA. In any case, there has been no progress in talks after the disengagement at Pangong lake and Kailash range in

Outside of Ladakh, the Indian Army remains in an alert mode all along the LAC to prevent any Chinese misadventure but the bigger change has been its reorientation of certain forces from Pakistan border towards the China border. The basis of this shift was articulated by the Chief of Defence Staff General Bipin Rawat when he recently said that China is a bigger security threat for India than Pakistan. The Ladakh crisis has also exposed India's military weakness to tackle a collusive threat from China and Pakistan: to avoid such an eventuality, the Government opened backchannel talks with Pakistan which led to the reiteration of the ceasefire on the Line of

External rebalancing

The Ladakh crisis has also led the Government to relook external partnerships, particularly with the United States. After his meeting with External Affairs Minister S. Jaishankar late last month, U.S. Secretary of State Antony Blinken tweeted that they discussed the "India-China border situation". The Indian side was silent about it but senior U.S. military officials have earlier spoken of the intelligence and logistics support provided to the Indian forces in Ladakh, while the Indian military has sought to learn from the American experience of implementing the Multi Domain Operations (MDO) doctrine to wage a war of the future against a technologically superior PLA.

That China is "a larger neighbour, which has got a better force, better technology", was acknowledged by General Rawat recently, to argue that India will "obviously prepare for a larger neighbour". The military importance of the Quad remains moot, with India reportedly refusing to do joint naval patrolling with the U.S. in the South China Sea; the two treaty allies of the U.S., Japan and Australia, also refused. Moreover, India's focus on its land borders and its limited resources for military modernisation in a period of economic decline impinge on its maritime ambitions in the Indo-Pacific.

Balancing act

Even as India has tried to talk tough with Beijing and shown greater interest in the Quad, its attempts to counter the burgeoning Chinese influence in the neighbourhood have faltered, exacerbated by the mishandling of the second wave of the novel coronavirus pandemic. With the widening power gap between New Delhi and Beijing, the challenge is as much economic as it is geopolitical. Despite the border crisis and the Indian restrictions on Chinese technology companies. China displaced the U.S. to be India's biggest trade partner in 2020-21, up to nearly 13% of India's total trade compared to 10.4% a year ago (https://bit.ly/3cFydRs).

For the Modi government, it has been a difficult balancing act between its domestic rhetoric and external reality. Even though India has been dependent on China for medical equipment to fight the pandemic and asked for assured supplies, the Government has been reluctant to publicly acknowledge this dependence: it underplayed Mr. Xi's message to Mr. Modi offering support and assistance. It has asked Beijing to grant visas

to Indian students and businesspersons but has refused medical aid or Chinese vaccines. Simultaneously, New Delhi has placed the border issue at the centre of the relationship with China, arguing that there can be no normalcy without restoration of status quo ante at the

Unappetising choices

For the past few decades, Indian planners operated on the premise that their diplomats will be able to manage the Chinese problem without it developing into a fullblown military crisis. That belief has been laid to rest. Militarily, Chinese incursions in Ladakh have shown that the idea of deterrence has failed. A return to the status quo ante of April 2020 remains a mirage with the Chinese side refusing to engage meaningfully after February. New Delhi has learnt that it can no longer have simultaneous competition and cooperation with Beijing; the dramatic engagement that started with Rajiv Gandhi's historic visit to China in 1988 is over.

The bouquet of choices before the Modi government is not appetising. A new reset in bilateral ties, àla the early 1990s, is difficult because China is now in a different league, competing with the U.S. India will never be comfortable taking sides in a new Cold War between the U.S. and China, as it has always valued its strategic sovereignty. Beijing seems as keen as New Delhi to avoid a military conflict, though accidents such as Galwan can never be ruled out. That leaves India with the daunting task of living with this tense and uneasy calm with China for some time, a challenge brought to the fore by the Ladakh crisis.

The events of the past one year have significantly altered India's thinking towards China. The relationship is at the crossroads now. The choices made in New Delhi will have a significant impact on the future of global geopolitics.

Unlocking war histories with a purpose

The declassification of India's military history should also lead to building on successes and avoiding past follies



aturday's announcement by Defence Minister Rajnath Singh on archiving, declassifying and compiling of war histories (https://bit.ly/3zroOqL) is a long overdue initiative that signals that the Ministry of Defence (MoD) is at last willing to shed its shroud of confidentiality over happenings long gone by. Largely conforming to global practices, the policy has the potential to kick-start multiple initiatives within the MoD and the three services that will offer researchers, analysts and historians an easy lens into studying military operations in the post-Independence period.

Interlinked challenges

Drawing on my own experiences of nine years as a practitioner-historian who has struggled to put together two definitive historical and joint narratives of war and conflict in contemporary India, conversion of this policy into deliverables will be a tough and unglamorous grind. The four biggest challenges facing this initiative will be the fusion of political directives and strategic decision making with the operational and tactical happenings on ground; compilation and reconciling and analysis of events at multiple levels (headquarters, commands and field formations); putting together a team of dedicated researchers and historians with a mix of academics and practitioners with access to records and files; and lastly, putting together a concurrent oral history and digitisation of all archival initiative.

Decisions to go to war and wage conflict in democracies are largely political decisions and it is important that such decisions are fused into compilations of war histories. For example, one of the reasons why the Indian Army is reluctant to declassify the Henderson Brooks Report that considered operational failures during the 1962 war with China is because it is largely a scathing indictment of the Indian Army's leadership without any accountability assigned to the political establishment led by Jawaharlal Nehru and Krishna Menon. On the other hand, several histories of the Vietnam War can now be considered credible and well-rounded because researchers have had access not only to operational accounts but also to archived discussions between the political architects of the conflict such as Presidents J.F. Kennedy and Lyndon B. Johnson and Defence Secretary Robert S. McNam-

Similarly, General K. Sundarji and Ambassador J.N. Dixit have borne the brunt of much criticism by researchers examining India's intervention in Sri Lanka from 1987-1990 because they expressed themselves in the open domain without fear. But it is only when researchers get access to records of



discussions involving other generals, admirals and air marshals and even Prime Minister Rajiv Gandhi, Minister of State for Defence Arun Singh and even political heavyweights in Tamil Nadu such as M.G. Ramachandran and M. Karunanidhi, that the cobwebs around Operation Pawan will be cleared.

On 'Brasstacks' 'Most military historians of contemporary India agree that Exercise Brasstacks (1986-87) heralded the transformation of Indian war fighting doctrine, tactics, techniques and procedures in conventional war fighting, particularly in the plains and the desert. However, all of them, including this writer, have relied on oral recollections to put together a mosaic of what may have transpired in the confines of the Military Operations (MO) Directorate of the Army HO and thereafter. Writing the official history of Exercise Brasstacks must be high on the list of the initial projects in this initiative as it will highlight the fusion of decisions taken at multiple headquarand squadron level.

The right approach needed Notwithstanding the effort taken

to put together official histories of the 1965 and 1971 wars, these are considered as safe histories that only scratch the surface of strategic decision making, operational analyses, leadership and lessons for the future. The reason for this is the absence of robust multi-disciplinary teams that are required to put together each such history and the desire to bring out noncontroversial documents. While highlighting controversies and failures must not be an obsession with such initiatives, it is only a robust academic-cum-practitioner flavour accompanied by good and contemporary writing that will

lend weight to such histories. Unlike the Ministry of External Affairs which has stolen a march over other ministries in declassifying files, the three service headquarters and MoD have been rather slow in initiating this. Not only is it difficult to trace files from eras gone, it is highly possible that in the absence of digital conversion, several priceless discussions have been destroyed in the periodic discarding of files. But even if such files are available, who will spend long hours trying to identify elements that remain historically relevant?

Digitisation and creation of oral histories will form a critical component of this transformation. Both are either unfolding at a snail's pace or are absent in our existing official repositories of histo-

war colleges. A software major must be roped- in for this and an outreach must be made to individual historians, think tanks and global repositories to share their oral history collections on contemporary indian military history

The first chapter

Considering the timeline of 25 years, a suggested list of declassifications to trigger this transformative initiative are the Nathu La skirmish of 1967, 'The Lightning Campaign' in the Eastern Theatre during the 1971 War, Operation Meghdoot (Siachen), Exercise Brasstacks and its subsidiary operations, and Operation Falcon (Sumdorong Chu). Lest the initiative be accused of only showcasing successes, Operation Pawan (Indian Peace Keeping Force; *picture*) too needs to be officially written about, albeit with due sensitivity. One of the hallmarks of a leading power/emerging power/power of consequence and a leading military is the ability to take criticism, tackle institutional reluctance to expose faultlines and push forward with reform with the big picture in mind. History does not offer a blueprint for the future, but it is certainly instructive in building on successes and not repeating the follies of the past. That proposition must be the bedrock on which this initiative takes off.

The ideas that Satyajit Ray couldn't film

Ray was always assessing the cinematic potential of literary sources that ignited his imagination



Satyajit Ray is universally admired for his cinematic creations. However, to understand his mind, it may be worthwhile to reflect on the literary ideas that he could not transform on celluloid. Some are well known -The Alien, A Passage to India and the *Mahabharata*. But there were many more which only the Ray aficionados are aware of. Fortunately, the essays and letters of Ray and his son Sandip; the biographies by Marie Seton (*Por*trait of A Director, 1971) and Andrew Robinson (Satyajit Ray: The Inner Eye, 1989); Suresh Jindal's My Adventures with Satyajit Ray - The Making of Shatranj Ke Khilari (2017), Nasreen Munni Kabir's Conversations with Waheeda Rehman (2014); and articles by Bangladeshi photojournalist Amanul Haque and others throw some light on the subject.

An idea about aliens

Based on his own story and ideas, and encouraged by the famous author Arthur C. Clarke, Ray drafted the screenplay of his sci-fi film The Alien in 1967. Columbia Pictures agreed to produce it with Peter Sellers in an Indian role. Steve McQueen was contacted and even Robert Redford considered, and the Indian cast was almost finalised. Columbia even advanced some money for the project. However, there were many unexpected twists and turns, as recounted by Ray in "Ordeals of the Alien" (The Statesman, October 4 and 5, 1980), and the project had to be abandoned. Ray wrote to Sellers:

"Dear Peter, if you wanted a bigger Why, you should have told me so

right at the start. By declining at this juncture

You have simply punctured The Alien balloon, Which I daresay would be ground-

Causing a great deal of dismay

To Satyajit Ray."

The project was revived later, but by then Steven Spielberg's E.T. the Extra-Terrestrial was released (1982),



with 'striking parallels' noticed by Clarke and others. Ray held, as Robinson quotes, that E.T. "would not have been possible without my script of The Alien being available throughout America in mimeographed copies". However, Spielberg commented, "Tell Satyajit I was a kid in high school when his script was circulating in Hollywood'. Despite advice, Ray did not pursue the matter further. His depiction, as communicated to Jindal, that the aliens were "benign by nature, small and acceptable to children, possessed of certain supernatural powers, not physical strength but other kinds of powers, particular types of vision, and that they take interest in earthly things" was indeed influential.

The West's image of India

Ray met E.M. Forster at Cambridge in 1966 with the intention to film A Passage to India. Robinson quotes Ray, ... but he knew my name. He kept shaking his head much of the time which meant that he didn't want the book to be filmed. That was the drone - no! - in words, gestures, looks, everything. He was adamant. And I felt there was no point in asking why." Later, much after Forster's death, Ray was approached in 1980 by the trustees at King's College, but by then he had lost interest in the subject. David Lean's version (1984), understandably, could not satisfy Ray – "... The whole thing is too picturesque... For me none of the characters come alive... Peggy Ashcroft's performance notwithstanding..." In a famous essay "Under Western Eyes" (Sight & Sound, Autumn 1982),

Ray had touched upon the limitations of the West's interest in India and how its views were often distorted and unreal, sometimes even with "grotesque stereotypes as Hurree Jamset Ram Singh..." He ended, "Slighted for so long, India will not yield up her secrets to the West so easily..." It is a pity that A Passage...

All on paper

could not be filmed by Ray.

The Mahabharata fascinated Ray from his early childhood. From the late fifties he had been planning to film it. But in what language? "How to introduce even the main characters to a non-Indian audience?" At one time, he intended to cast Dilip Kumar, Toshiro Mifune and others. Ray was interested in the dice game part. More than the war, it was the exploration of personal relationships between the characters that appealed to him cinematically. In jest, he once told Jindal, "I gave up, because I couldn't imagine Kirk Douglas playing Arjuna."

Waheeda Rehman, who acted in Ray's Abhijan (1962), said that Ray had been keen to adapt R.K. Narayan's *The Guide* and had contacted her for the female lead. As she observed, the approach and treatment of the film would have been entirely different under Ray's direction. But then we would have missed the Bollywood blockbuster.

There were many Bengali film ideas that Ray had nurtured at some point or the other, as detailed by Sandip Ray in *Ananya Satyajit* (1998) and others. Bankimchandra Chattopadhyay's Rajasimha (with Balraj Sahni) and Devi Chaudhurani (with Suchitra Sen), Saratchandra Chattopadhyay's Mahesh, Bibhutibhusan Drahamaveer Bandyopadhyay's Kashibash and Ichhamati, Manik Bandyopadhyay's Padma Nadir Majhi, Mahasweta Devi's Bichhan, Buddhadeva Bose's Ekti Jiban, Prafulla Roy's Ram Charitra, Shibram Chakraborty's Debotar Jonmo, Banaphool's Kichhukshan, Bangladeshi writer Shahed Ali's Jibrailer Dana and Selina Hossain's Hangor Nodi Grenade were thought of. For a variety of reasons, including non-availability of actors (Chunibala Devi and Suchitra Sen, for example), these ideas had to be abandoned at different stages. According to Sandip, his father moved on with his work, never regretting what could not be

Ray was approached by Indira Gandhi to make a documentary on Jawaharlal Nehru for whom he had admiration. Besides, in a letter of June 1, 1978, Ray wrote to Jindal about the proposals he had been requested to consider "... (a) documentary on Rajasthani music for French TV... (b) a 3-part film for BBC (each 90 minutes long) on any subject or subjects of my choice... (c) a proposal from UNO to make a film on 'the horrors & miseries of war', for worldwide TV screening... (d) a revival of The Alien under a major U.S. company backing with an updated script and a new title..." UNICEF approached him for a film on child labour. Ray was also interested in the operatic form of Balmiki-Pratibha, and documentaries on notables like Radhanath Sikdar who first calculated the world's highest mountain peak. None of these eventually took off for reasons not publicly known.

Conscious of what's happening all around, Ray was immersed in ideas. A storyteller, both in celluloid and print, he was always assessing the cinematic potential of literary sources that ignited his imagination. Now, on the occasion of Ray's 100th birth anniversary celebrations, it is for the researchers to probe and delve into the available material in order to fathom why many of these ideas couldn't get transported to the medium of cinema.

A policy difficult to defend

Allowing money spent out-of-pocket to feed vaccine production in India is regressive and inequitable

The Union government recently reversed the liberalised vaccination strategy. States no longer have to bear the responsibility of procuring vaccines; the Centre will procure them on behalf of the States as the single purchaser. While this move has been applauded, some doubt that a few things will change under the new regime. One area of objection has been that the private sector's share of total vaccines remains unchanged at 25%.

Problematic decision

As some experts have rightly pointed out, the private sector's share of total manufactured vaccines is out of sync with its share of total vaccination centres, which are far fewer than the government's, thus entailing a demand-supply mismatch between government and private centres and concomitant inequities. Although capacity to vaccinate is a more important metric to consider than just the relative share of vaccination centres. it is unlikely to be a redeeming factor. However, the policy looks problematic even if the number and the share of private vaccination centres increases substantially to accommodate their share of total vaccines.

Writ large, a 25% share for private vaccination entails an implicit assumption that 25% of the population is willing and able to pay for a commodity for which social benefits exceed private benefit. This is indicative of our mistaken assumption of an inflated 'middle class'. The fact is that the affluent form only a small fraction of the uppermost 25% of our population based on income.

Markets tend to under-produce commodities having significant positive externalities. Preventive services like vaccines generate a lower private demand than curative services. Subsidising or incentivising users and penalising non-users of preventive services are two ways of promoting consumption of such services. Even assuming reasonably higher levels of wealth, education, and COVID-19 awareness in the uppermost 25% of the population, significant demand generation concerns would remain, which may lag behind desirable levels. Not to mention that this section is also likely to have better access to free vaccines provided by the government, creating a 'crowding out' effect for the poorer sections. Of course, we assume here that India doesn't have a large surplus of vaccines. We

also need to consider the age structure and its possible implications. A large chunk of self-payers are likely to be younger, productive individuals, who are at lesser risk of severe disease and mortality than the elderly.

It's intriguing as to what motivates this 25% share for private players. Is the government driven by herd immunity considerations, which project that between 60% and 80% of the population needs to be imperatively immunised? It is crucial to realise that vaccinating the poorer and marginalised sections, even if it is free of charge, is much more challenging than vaccinating the easily accessible better-off sections. The resultant disparities along geographic and socioeconomic lines would not be consistent with the notion of herd immunity.

All this points to the need to increase the government's share of total vaccines. It is unfair to demonise private hospitals in this situation, especially since service charges have now been capped. The benefits, if any, of differential pricing are likely to accrue mainly to vaccine manufacturers. But vaccine production is also a costly process, and the government's track record of investing in domestic COVID-19 vaccine production has been anything but phenomenal. The result of this is that money spent out-of-pocket is feeding vaccine production in India, which is an inequitable and regressive way of doing things.

Better engagement with private sector Traditionally, India's approach to dealing with the private sector has been 'all or none' of sorts. On accusations of extortionate pricing by private players, the government hasn't hesitated to impose often unreasonable and unfavourable pricing restrictions. On the contrary, successive governments have frequently been criticised for adopting an unduly favourable attitude towards the private sector in healthcare. It's time we moved beyond this. Greater reach, innovative processes, and efficiency are some of the strengths of the private sector. Any engagement with this sector needs to sufficiently exploit such strengths as part of a strategic purchasing framework. But this will require the government to engage with smaller players too, not just big private hospitals. This will be replete with challenges, including the need for strong regulatory and information systems. More decentralised but accountable regulation might be called for. However, it is possible to envision a favourable risk-benefit trade-off with such engagement. The pandemic is the right time to attain the appropriate public-private policy mix.

Preserving India's archives

Moving the collections in the National Archives annexe needs careful planning and execution

The National Archives is the primary repository of documents on India's past. The last time it was in the news was in 2016 when digital copies of files relating to Netaji Subhas Chandra Bose were made publicly accessible. The imminent demolition of its annexe by the Government of India has brought the institution to public attention once again. A petition by leading Indian and foreign scholars is in circulation demanding that the government show greater openness in the proposed demolition of the National Archives annexe and the safe storage of its contents since "several centuries of India's history lie in the documents that make up the National Archives of India". The petition said: "The archival records include 4.5 million files, 25,000 rare manuscripts, more than 100,000 maps, treaties, 280,000 premodern documents and several thousand private papers... The loss or damage of a single object or archival record would be an irrevocable loss.'

The annexe also houses the cartography section and 1,50,000 oriental records in Persian, Arabic and Urdu. The birch bark and clay coated Gilgit Manuscripts in the National Archives are, according to UNESCO, "the oldest surviving manuscripts in India". These include "canonical and non-canonical Buddhist works that throw light on the evolution of Sanskrit, Chinese, Korean, Japanese, Mongolian, Manchu and Tibetan religion-philosophical literature".

Poor shape

The National Archives is in poor shape. A series of articles published in *The New York Times* in March 2012 by the historian Dinyar Patel laid bare the parlous state of the National Archives. He noted, among other things, that "letters penned by Mohandas K. Gandhi, B.R. Ambedkar, Gopalkrishna Gokhale, and other eminent Indian nationalists have suffered from exposure to humid weather, staff negligence and mishandling, and improper preservation methods." Things have improved since then, but not enough. Writing in *The* Telegraph Online, of May 30, 2021, Sana Aziz, Assistant Professor of His-

tory at Aligarh Muslim University, pointed to lack of expertise to manage acquisitions which has led to "the locking up of some of the rare documents in Persian, Urdu, Arabic, Sanskrit, Prakrit, Tamil, Malayalam, and Modi (records from Maharashtra)".

Moving the collections in the National Archives annexe needs careful planning and execution. Few know this better than The British Library. Its guide from its Preservation Advisory Centre, titled 'Moving Library and Archive Collections', is succinct and comprehensive, covering every aspect of shifting an archive. A significant point it makes is that "the order in which the collection is to be moved and unpacked must be carefully considered and mapped. In the long term, it is cheaper to put items into their correct place straight away, rather than being rushed into a random storage arrangement."

Moving contents

Those who are protesting the demolition of the annexe include scholars holding important positions in some of the best institutions. They have access to the finest archival expertise in the world. They are best placed to produce a detailed report on how to move the contents of the National Archive annexe and share it with the government giving names of institutions and experts willing to help. Not just the National Archives, but those of the States too are in poor shape. A case in point is the Goa archives, one of the oldest in the country. It contains material relevant not just to India but also to the rest of Asia, Europe, Africa and South America. While making their proposal, these scholars would do well to recommend an integrated national approach to archival management bringing together State archives too. The private sector could be brought in to construct a world-class building within the next two years as part of CSR and have the annexe collections shifted there. Such a project will do a lot of good for India's image rather than all the protests from a "community of concerned", which, inci-



Out in the open | On October 2, 2019, all the villages in India were declared open defecation-free (ODF). However, recently published data from the National Family Health Survey-5 (NFHS-5) show that in not one of the 18 States surveyed did all the households have access to a toilet facility. The share of access to any type of toilet ranged between 61.7% in Bihar to 99.9% in Mizoram. The survey was initiated in mid-2019 and continued till March 2021. President's Rule for Punjab (From an editorial)

The dissolution of the Punjab Assembly by the Governor, Dr. D.C. Pavate, has obviously upset the long-nurtured plans of the topplers who were getting ready to replace the shaky Akali Dal Ministry headed by Mr Badal by what could have only been an equally shaky and ramshackle coalition. No tears need to be shed over the exit of the Badal Government which, along with the Akali Dal itself, had been riven by faction and intrigue for months. Those who thought that the reunion of the faction headed by Mr. Gurnam Singh with the parent Dal under Sant Fateh Singh in November last would ensure stable government in the State would seem to have reckoned without the Akalis' penchant for groupism and infighting. The present crisis which has sparked off some vague and unspecified charges of corruption against some of the Ministers by another Minister, Mr. Trilochan Singh Riasti, was but part of this factious struggle within the party, though his demand for a smaller and more compact Cabinet for so small a State was reasonable. Mr Badal's reluctance to get rid of some of the Ministers on the eve of the Assembly session is also easily explained, as with the outgoing Ministers would also have gone some of the needed support in the Assembly.

Govt. report flags 'lapses' in Nagaland bat study

"We are not aware of lapses," said Mr. Mayor, in written replies to The Hindu. "The [bat] samples we have collected are invaluable to research and understanding zoonotic pathogens," he added, directing all further enquiries on the clearances and bat samples to the Ministry of Health.

However, both the Ministry of Health report dated February 2021, as well as a series of communications between the Ministry of Health and Welfare, and the Department of Atomic Energy, which oversaw the NCBS study in October-November 2020, referred to the issues. The Hindu has seen copies of these documents.

"The research publication raised serious concerns as the samples were collected from humans and bats with intent to test for viral pathogens and resulting antibodies of highly infectious pathogens (risk group 4 viruses).

The study didn't have the requisite approval of ICMR. Moreover, the facility at NCBS was not equipped in terms of biosafety and biosecurity to undertake such testing," states the Health Ministry report.

"The inquiry committee (including Health Ministry and ICMR officials) visited NCBS, Bangalore as well as Nagaland to understand the work done, methodology followed, and places visited during the course of the study," said the report, adding that they found "concerning lapses in the study protocols and procedures".

"All the lapses were discussed and appropriate actions were suggested," it ad-

Safe storage issues Meanwhile, differences over

the storage of the Nagaland bat samples between the Department of Atomic Energy (DAE), and the Ministry of Health continue. The Health Ministry wants the samples of nucleic acid extract stored at the Bio Safety Level -4 (BSL-4) standard facility at the National Institute of Virology laboratory in Pune, rather than NCBS's Bengaluru facilities, that are rated BSL-3 at present.

While the DAE contends that the samples were "noninfectious" and had been checked for the presence of filoviruses (Ebola and Marburg), the Health Ministry contends that such samples must be handled in a laboratory equipped for "biosafety and biosecurity conditions" as otherwise they can pose a "significant public health hazard".

"The issue of bio-security comes under the Department of Biotechnology, and the ICMR has no business raising any concerns on a study done by the NCBS, which is an institution under the Department of Atomic Energy," said noted virologist Gagandeep Kang.

When asked, however, an official said that a 1987 Health Ministry order had designated ICMR Director General and the Health Secretary as the Chairpersons on the committee clearing all research involving foreign funding and foreign collaboration.

According to the citation in the study, named "Filovirus-reactive antibodies in humans and bats in Northeast India imply zoonotic spillover", that was published in 2019, the research was funded by U.S. Dept of Defense, U.S. Naval Biological Defense Research Directorate, and Indian Department of Atomic Energy, and credits researchers at Duke-NUS Singapore, U.S. Uniformed Services University as well as Shi Zhengli and Xinglou Yang from the Wuhan Institute for "writingreview and editing" the pap-

For Onam, marigolds from a floating raft

Youth undertakes farming experiment

K.A. MARTIN

A small fraction of the millions of marigold flowers used during the annual Onam season to make floral carpets and decorate homes will come from a floating raft farming experiment undertaken by an enterprising young farmer in the Vembanad backwaters in Alappuz-Thanneermukkom ha's panchayat.

Sujit Swami Nikarthil, who has been into farming for over a decade, said he had put up marigold plants on about 400 sq.ft. of floating raft set up on bamboo frames and held together by coir geotextile with a bed of degraded water hyacinth. He said the flowers from the one-cent raft would be harvested for the Onam season.

Floating raft agriculture, with water hyacinth forming the bed, has been experimented with extensively. It was found, over the last five years, that amaranthus flourishes on the floating raft beds, said K.G. Padmakumar, veteran agricultural scientist and director, International Research and Training Centre for Below Farming, Level

Kuttanad.

Floating raft farming had been taken up as a measure of improving adaptability and resilience in the background of climate change, said Dr. Padmakumar. He said experiments in the Alappuzha-Cherthala Canal near Kalavoor with amaranthus had been a great success. Another experiment had been taken up at Kanjippadom. These showed that crops like vegetable cowpea, chillies and tomatoes too were suited for the farming method. The crops should be of short duration so that they can be harvested in about 45 to 60 days, by which time the water hyacinth bed degrades

completely. Dr. Padmakumar said floating raft agriculture with cage fish farming could be remunerative for people. The activities could be taken up even on part-time basis to generate additional income, he added.

Vice president of the panchayat Praveen G. Panicker said the local body looked upon the novel idea as a means to get rid of water hyacinth, which posed problems across water bodies.

Trying to rescue LJP: Pashupati Paras

He indicates that the party will not follow Chirag Paswan's line against JD(U) chief Nitish Kumar

NEW DELHI

Just hours after five of the six MPs of the Lok Janshakti Party (LJP) met Lok Sabha Speaker Om Birla over replacing party president Chirag Paswan with his uncle, Pashupati Nath Paras, as the Leader of the Parliamentary Party, Mr. Paras said he had no complaints against his nephew.

Speaking to mediapersons on Monday morning, Mr. Paras said he was only trying to rescue the party. In the same breath, he also praised Bihar Chief Minister Nitish Kumar, calling him 'vikas purush', in a clear indication that the party would not follow Mr. Paswan's line against the JD (U) chief. Mr. Paras, who earlier served as a Minister in Mr. Kumar's Cabinet, made it clear that the six MPs would not join the JD (U). The rebel MPs had an hour-long meeting with another JD(U) leader Lallan Singh at party MP Veena Singh's residence.

What is particularly damaging for Mr. Paswan is that among the rebel MPs is

his cousin, Prince Raj, who is said to be very close to him and whom he had anointed as the Bihar unit chief, replacing Mr. Paras.

Mr. Raj is the son of LJP founder Ram Vilas Paswan's vounger brother Ramchandra Paswan, who died in 2019. Ram Vilas Paswan never recovered from the shock of his brother's death and in some way that accelerated the deterioration of his own health, leading to his death a

year later. The Sunday evening events are the culmination of a nearly seven-month long discontent in the party against Mr. Paswan for his particularly twisted political stand.

He launched a campaign targeting the JD(U) and Mr. Kumar without severing ties with the NDA. He continued to sing paeans about Prime Minister Narendra Modi. The LJP won one Assembly seat, managed to garner nearly

6% of the vote share and cost the JD (U) nearly 35 to 40

Within the party forum, many leaders, including Mr. Paras and Mehboob Ali Kaiser, had criticised Mr. Paswan. Mr. Paras had also made a public statement praising Mr. Kumar, but had to retract it under pressure from his nephew. Mr. Paras and other rebelling MPs have also accused Saurav Pandey, another close aide of Mr. Paswan, of excessive interference and arrogance.

'Fallout of State poll'

Speaking to The Hindu, Mr. Kaiser, observed, "The Sunday events are a fallout of the Bihar elections. We advised him not to go against Nitish Kumar. A leader has to listen to people, but Chirag was impervious to any of our sug-

'May 28 order has no link with CAA'

Notification by Centre facilitated non-Muslims to apply for citizenship

The Union Home Ministry maintained in the Supreme Court on Monday that its May 28 order delegating power to Collectors in 13 districts across five States to grant citizenship to non-Muslims from Pakistan, Afghanistan and Bangladesh has "no relation whatsoever" with the controversial Citizenship (Amendment) Act

The 2019 Act, better known as 'CAA', is under challenge before the Supreme Court. The law is accused of "fast-tracking" citizenship for non-Muslim persecuted minorities – Hindu, Sikh, Jain, Buddhist, Parsi and Christian - from the three neighbours. The CAA is blamed of illegally granting citizenship on the basis of religion.

Petitions in the Supreme Court have drawn parallels between the CAA and the May 28 notification, which facilitates non-Muslims from the three countries residing in 13 districts of Gujarat, Rajasthan, Chhattisgarh, Haryana and Punjab to apply for citizenship.

The Indian Union Muslim League, represented by advocate Haris Beeran, said the May 28 order was a deliberate ploy to implement the CAA's "malafide designs". The Ministry countered that the May order "merely dele-



gates the power of [granting citizenship by registration and naturalisation] to the local authorities in particular

"The Central government used its authority under Section 16 of the Citizenship Act... It is merely a process of decentralisation of decisionmaking aimed at speedy disposal of the citizenship applications of such foreigners... It has no relation whatsoever to the CAA," the MHA affidavit said.

But Mr. Beeran expressed

his doubts, saying "if it has no relation to CAA, where does the May 28 notification draw authority from to specify the same communities for the same three countries for facilitating the citizenship process".

The government reasoned that the notification did not "provide for any relaxations to the foreigners and applies only to foreigners who have entered the country legally". The applicants should possess valid documents like passports and Indian visa. "Any foreigner of any faith can apply for citizenship of India at any time," the MHA affidavit said. The government, however, said the May 28 notification was only one among numerous such orders passed in the past to meet "administrative exigen-

Indian labs widen net for a mutant form of Delta variant

It allows the virus to escape antibodies, similar to virulent South African variant

An emerging form of the Delta variant that allows the coronavirus to "escape" antibodies, in recently approved treatment regimes, is appearing on the radar of Indian scientists. Five Indian labs have sub-

mitted data on this modified variant in May and June to GISAID, a global repository of coronavirus variants. Public Health England (PHE), a United Kingdom body, has also stated that of the 63 genomes in its repository as of June 7, six were from India. This does not, however, mean that only six instances of this form of the virus exist in India. Evidence of the mutant have been found in Andhra Pradesh, Maharashtra, Telangana and Karnataka.

Called AY1 or B.1.617.2.1, it is a variant of Delta (B.1.617.2), but with a mutation called K417N, which has previously been identified in the Beta variant – first identified in South Africa. This is an international Variant of Concern (VOC), marked by being highly infectious and

significantly able to reduce the potency of vaccines.

"It has all the mutations that make the Delta variant, along with an additional concerning one with the South African variant," said Shahid Jameel, former adviser to the Indian SARS-CoV2 Genomic Consortium (INSACOG). "It is indeed a matter of concern, and we should be sequencing more to identify how widely prevalent it is in

The Delta variant is now regarded as the most prevalent variant in India, comprising nearly 31% of the 21,000 community samples

processed until late May.

The ICMR-National Institute of Virology and the CSIR-Centre for Cellular and Molecular Biology, Hyderabad, have conducted laboratory tests to determine the potency of Covishield and Covaxin against the new var-

While antibodies continued to be produced against the variant, they were fewer than against the strain used by the vaccine companies to prepare their vaccines. However, antibody levels are not the only markers of immunity.

An additional concern

with the K417N mutation, according to a database of the CSIR-Institute of Genomics and Integrative Biology (CSIR-IGIB), was that it was associated with resistance to a newly developed monoclonal antibody treatment drug, Casirivimab and Imdevimab, for treating those with moderate and severe disease, but at high risk. Marketed by Roche and Cipla in India, the drug was recently approved by India's Central Drug Standards and Control Organisation. The price for each patient dose, a combined dose of 1200 mg (600 mg of Casirivimab and 600 mg of Imdevimab), will be ₹59,750 inclusive of all taxes, a statement said.

Anurag Agrawal, Director, CSIR-IGIB, New Delhi, however, said as of now, the AYI was "just something to keep track of".

A report from PHE on June 11 said that of the 36 identified cases of the AY1 in the U.K., 27 occurred in those who had taken at least one dose of vaccine. There were no deaths reported so far among the 36 cases.

Centre lists food schemes for migrants labourers

States responsible for distribution: govt.

The Centre on Monday informed the Supreme Court that the States and the Union Territories have purchased nearly 3.7 lakh tonnes of foodgrains at concessional rates from the Food Corporation of India this year to supply to migrants without ration cards and others outside the protective cover of the National Food Security Act (NFSA), debunking apprehensions raised in court that those without ration cards may be left to die amid a devastating

pandemic. The Supreme Court had asked the Centre to explain "how food will reach migrant labourers without ration cards". The Centre has placed on record details of its schemes to feed migrants, the poor and the badly affected in the public health crisis.

Besides the purchase of grains by the States and the UTs under the Open Market Sales Scheme (OMSS) in 2021-22, the Centre said, NGOs and charitable organisations had purchased 421 tonnes of food commodities. "NGOs run kitchens for supply of cooked food to non-card migrants," the Centre, represented by Additional Solicitor-General



The SC had asked for details on "how food will reach migrants without cards".

Aishwarva Bhati, said in written submissions in the court. However, the responsibility to distribute foodgrains lies with the States, it noted. "Union of India is committed to making sufficient foodgrains available to the States at highly subsidised prices under the above schemes, to tide over the difficulty of food security during the current crisis. However, the responsibility of identification and distribution to the beneficiaries lies with the States/UTs," it submitted.

The Centre also said it had written twice to the States/UTs - on May 20 and May 25 – advising them to "avail their requirements of foodgrains under the schemes and to provide foodgrains to those not covered under the National Food Security Act".

ONORC is tailor-made for migrants'

The 'One Nation One Ra-Card' (ONORC) scheme makes food security "portable" and is "tailormade" for migrant labourers, the Centre told the Supreme Court on Monday. 'One Nation One Ration

Card plan aims to empower all National Food Security Act migrant beneficiaries to access foodgrains from any Fair Price Shop [FPS] of their choice anywhere in the country by using their same/existing ration card with biometric authentication," the Centre told the court, which had asked it to detail the schemes to provide food to migrant workers hit by COVID-19.

The government, represented by Additional Solici-Aishwarya tor-General Bhati, said, "A total of 32 States/UTs covering around 69 crore NFSA beneficiaries, i.e., 86% NFSA population in the country, were swiftly brought under the ONORC plan by December 2020".

The effort was to ensure that migrant workers and their families got assured access to nutrition via national portability of ration cards under the Food Security Act, the Centre

Choksi's legal team releases videos

Michael Polak of Justice Abroad said the intention behind the entire episode was to "whisk away" Mr. Choksi to India by shortening the legal process. "The evidence in this case shows that Mr. Choksi was kidnapped from

Antigua, where he had outstanding cases before the Courts, and unlawfully renditioned to Dominica. We believe that the aim was for him to be whisked away to India, bypassing the proper legal processes in Antigua and Dominica," said Mr. Polak in a statement.

In documents and photographs seen by The Hindu, the legal team fighting the case in Dominica shows a few men who appeared to be of Indian origin on the deck of a boat that was allegedly used to transport Mr. Choksi from Antigua.

Two videos shared by the legal team show an unnamed boat allegedly carryof its movement from Antigua's Jolly Harbour North Finger to a rendezvous with another boat, which eventually took the fugitive diamond trader to Dominica. Mr. Choksi's legal team claimed that he came to the beachfront villa in Antigua of his recent acquaintance Barbara Jarabik on May 23 and was soon overpowered by a group of men who "rushed out and beat him". He was "gagged and tied to a wheelchair" at knifepoint and placed on the unmarked boat. This boat placed him on the Calliope of Arne, which took him to Dominica.

The Commission also demanded an action taken report "within 10 days" from each of the four entities.

SC misled about law and order in Bengal

The Mamata Banerjee government on Monday named BJP members, while maintaining in the Supreme Court that "concocted stories" on social media spread the narrative of State complicity in the "post poll violence".

"It is untenable to categorise each and every act of violence following the declaration of elections results as 'post poll violence' while

adopting a premise that such violence is ongoing in West Bengal to which the State machinery is turning a blind eye," the State government said in its affidavit.

The 425-page counter-affidavit detailed complaints and petitions concerning the post poll violence. It named the vice-president of the BJP's South Kolkata unit and a member of the BJP legal cell. It said false allegations of "State complicity" were drawn on the basis of hearsay reports disseminated on social media by miscreants. The State said the apex

court was misled about the law and order situation. The petitions "reek of political motivation". The petitions have asked the court to form a Special Investigation Team (SIT) and to order immediate relief to internally displaced persons affected by the vio-

"No person can be forced to stay away from his/her house, as it is their inherent

right to live in their houses peacefully," the State said.

It said the petitions in the Supreme Court conveyed a "misleading narrative" while a five-judge Bench of the Calcutta High Court was already hearing a gamut of issues arising from the "alleged post poll violence". The High Court had been passing effective orders in the case, the State noted. Three counter-affidavits were filed in the High Courts on the FIRs registered and arrests made.



Speciality of Ramayana

Of the two Itihasas, namely the Ramayana and the Mahabharata, the former is special, said M.A. Venkatakrishnan, in a discourse. While the Mahabharata contains the Bhagavad Gita and the Vishnu Sahasranama, yet, the Gita and the Sahasranama are a small part of the Mahabharata. The latter is mostly about the fight between the Kauravas and the Pandavas. Of the more than one lakh verses, the Gita and the Vishnu Sahasranama take up only a few hundred verses. That is why Vyasa wrote a follow up, called Hari Vamsa, where he speaks about the greatness of Hari. Although the Mahabharata and Hari Vamsa are considered to be separate works, Hari Vamsa is actually like an addendum to the Mahabharata. In the case of the Ramayana, the entire work talks about Rama. It is called Adi kavya, for it was the earliest of all kavyas in Sanskrit. Dandin wrote the rules for writing kavyas. But it was the Ramayana which provided material for all those rules. So the work of how to write kavyas was based

on the pattern provided by the Ramayana. Before the Ramayana, we did have the Vedas, but the Samhita portion of the Vedas was entirely about how to perform yagas. The Upanishads were about Brahman. There was no story told. So, Valmiki's Ramayana was a pioneering work. Valmiki saw a hunter kill a krauncha bird, and saw the distress of its pair. He cursed the hunter. But what was surprising was that the curse came out in a metre! This was not due to a conscious attempt by Valmiki. It just happened that way. His curse had come out as a verse, with four padas, with each pada having eight syllables. While the Vedas also have chandas, the difference is that they are Vaideeka chandas, and Valmiki's is laukeeka chandas. Vedic chandas have tonal variations, which chandas in kavyas do not have.

A year on, unanswered questions on Galwan clash

China's accounts reveal few details that appear aimed at conveying a carefully crafted message to the domestic audience

A year after the June 15, 2020 clash in the Galwan Valley, China's official accounts of what led to the worst violence on the India-China border since 1967 still leave many questions unanswered, revealing few and selective details that appear aimed at conveying a carefully crafted message to the domestic audience.

While Chinese officials have said repeatedly in recent months "the rights and wrongs are clear" of what led to the LAC tensions, Indian officials say Beijing is, in fact, yet to provide any clarity or credible explanation of its actions last year, starting with mobilising a large number of troops in April following annual military exercises and deploying them close to the LAC, not just in Galwan

That mobilisation in April, coming at a time when India had to delay its own summer exercises because of the CO-VID-19 outbreak, is one of several key missing details in China's official accounts so

A reading of all of China's public statements issued in the year since the Galwan clash underlines a two-fold approach in Beijing's messaging: a focus only on the Galwan Valley with little to no mention of the other troubled spots on the LAC, where PLA transgressions led to multiple stand-offs, and since February this year, a more proactive propaganda effort aimed at emphasising the bravery of China's troops in Galwan and portraying Beijing not as the aggressor, but as defending its sove-

Since this year, China has also firmly clamped down on any questioning of the official narrative. Earlier this month, Chinese authorities sentenced Qiu Ziming, one of at least half a dozen people who have been detained over comments on Galwan, to eight months in prison "for defaming martyrs". Mr. Qiu had questioned why India had promptly recognised the loss of 20 Indian soldiers in Galwan Valley but China was yet to fully reveal casualties, with the first announcement of honours coming on-

ly eight months later.

Sparse details

In the past year, China has issued two detailed statements on the LAC, a "step-by-step account" from the Foreign Ministry on June 19, 2020 and accounts in February 2021 published in the official PLA Daily after the Chinese government revealed it had suffered casualties as it announced military honours for five soldiers, four of them recognised posthumously.

The first Chinese account of tensions came in the Communist Party-run Global Times on May 18, which said Chinese troops had "bolstered border control mea-

sures and made necessary moves in response to India's recent, illegal construction of defence facilities across the border into Chinese territory in the Galwan Valley region". The June 19 statement from the Chinese government said "since April, the Indian border troops have unilaterally and continuously built roads, bridges and other facilities at the LAC in the Galwan Valley." It referred to the early morning of May 6 as the start of more serious tensions, alleging the Indian troops had "crossed

Indian officials said the reverse had happened: that In-

the LAC by night".

been prevented from reaching Patrolling Point 14, which they go up to every summer, and that construction of facilities had taken place on India's side of PP14. Satellite images later released suggested the June 15 clash had happened near PP14. Most Indian patrolling points lie short of the LAC on India's

Video release

In February, the announcement of military honours for five soldiers was accompanied by the release of a video on Chinese state media from Galwan Valley.

The video clips, which triggered an outpouring of anger in China, showed Indian soldiers crossing the river and Chinese troops holding their ground. The message was to show India as the aggressor, which is the widely prevailing view in China. Left unsaid was the context of the video, in which Indian troops were trying to push back Chinese troops who had come up to

On June 11, in the lead up to the one-year anniversary

of the clash, which also comes just two weeks before China is planning a major military parade to mark the centenary of the Communist Party on July 1, state broadcaster CCTV interviewed Qi Fabao, the regimental commander who was among the five honoured in February. Mr. Qi spoke at a military meeting, appearing with "the scar on his head clearly seen", the Global Times reported. Chen Hongjun, one of the four soldiers who was named as being killed in the clash, will be among 29 people honoured with a medal on the July 1 anniversary.

The continued focus on Galwan, while the still unresolved tensions in Depsang, Demchok, Gogra and Hot Springs, remain almost entirely ignored in the coverage, is one key element of the broader messaging effort, as acknowledging multiple stand-offs, as well as the fact that it is India and not China that is demanding a return to status quo in the slow-moving negotiations, would undermine the Chinese military's central claim of not

At NATO meet, Biden vows to defend Europe

He calls it a 'sacred obligation' of U.S.

U.S. President Joe Biden told fellow NATO leaders on Monday the defence of Europe, Turkey and Canada was a "sacred obligation" for the United States, a marked shift from his predecessor Donald Trump's threats to withdraw from the military alliance.

Arriving in Brussels from the weekend's G7 summit in England, Mr. Biden again sought to rally Western allies to support a U.S. strategy to contain China's military rise as well as showing unity in the face of Russian aggression.

"Article Five is a sacred obligation," Mr. Biden said, referring to the transatlantic alliance's collective defence pledge. "I want all Europe to know that the U.S. is there," he said after arriving in his presidential limousine.

"NATO is critically important to us," said Mr. Biden, who is seeking to mend ties after Mr. Trump's denigra-



liance over the past four years and what Mr. Trump said were its "delinquent" members.

Allies are expected to brand China a security risk to the Western alliance for the first time, a day after the Group of Seven rich nations issued a statement on human rights in China and Taiwan that Beijing said slandered its reputation.

Mr. Biden said both Russia and China were not acting "in a way that is consistent with what we had hoped", referring to Western efforts since the mid-1990s to bring both countries into the fold of lib-

The reign of 'Bibi' is over, for now

The ousted leader has vowed to topple the 'dangerous' new govt. of PM Bennett

Supporters call him 'King Bibi of Israel'. Detractors deride his right-wing politics, polarising leadership and bellicose foreign policy. But Benjamin Netanyahu has been a domineering presence in Israel's politics for more than three decades. On Sunday, his illustrious political career suffered a major setback when a coalition formed by his former protégés proved majority in the Knesset, the Israeli Parliament, bringing an end to Mr. Netanyahu's 12 years of consecutive rule.

Arguably, no politician has managed to influence Israel's domestic and foreign policies as much as Mr. Netanyahu has done in the new century. He ruled from the right, made alliances with a host of Jewish orthodox parties, took a harder line towards the Palestinians, expanded the Iewish settlements in the Palestinian territories, repeatedly bombed Gaza, clashed with the Obama administration over the Iran deal, took Israel's covert and overt operations to Iran and Syria, made peace with four Arab countries and clung on to power despite repeated failures to form a stable government since 2019.

Even after the 'change' coalition was formed under the leadership of centrist politician Yair Lapid and right-wing leader Naftali Bennett, Mr. Netanyahu tried till the last moment to subvert government formation. And after it became certain that Mr. Bennett would

be elected Prime Minister on Sunday, in the Knesset, he threatened to "topple the dangerous left-wing government". The message is clear - Mr. Netanyahu is already plotting a comeback.

Opposition to Oslo talks

Born in Israel and brought up partly in the U.S., Mr. Netanyahu, like most Israelis, served in the military in the 1970s, along with his brother Yonatan Netanyahu. Yonatan was killed in 1976, at age 30, during an operation to rescue hostages held at Uganda's Entebbe Airport. Mr. Netanvahu rose to fame in the 1980s when he was posted as Israel's Ambassador to the UN. A fluent speaker in English with an East Coast accent, he was a regular presence in American TV shows during that time. After returning to Israel, he plunged into politics, in 1988, in the midst of the First Intifada by the Palestinians. Mr. Netanyahu built a political career by opposing the Oslo peace

process in the early 1990s. In 1993, when he was 43, Mr. Netanyahu became the leader of Likud. He lambasted the Oslo Accords, attended right-wing rallies held to

oppose the peace policies of Labor Prime Minister Yitzhak Rabin and continued to call Yasser Arafat a terrorist. When Rabin was assassinated in November 1995 by a Jewish extremist, many critics said Mr. Netanyahu's hyperbole speeches at rallies where crowds chanted "death to Rabin" fuelled extremism and incitement.

But it did not deter Mr. Netanyahu. In 1996, he became Israel's youngest Prime Minister. Under his watch, the Oslo process slowed down. After losing power in 1999, he was in the wilderness briefly when Labour leader Ehud Barak revived the peace process. But the 2000 Camp David summit failed. Palestinian territories erupted into the Second Intifada.

When Liku came back to power, Mr. Netanyahu

played second fiddle to Ariel Sharon. But the party came into his hands when Sharon left Likud in 2005 to form Kadima. As Likud chief, he sat in the Opposition. It was during this period that Mr. Bennett joined the Netanyahu team. A U.S.-based entrepreneur, Mr. Bennett became Mr. Netanyahu's Chief of Staff. Mr. Netanyahu came to power again in 2009. Twelve years later, the same Bennett would dislodge his former boss from power and take

In the past, Mr. Netanyahu had mastered the art of survival. But his repeated failure to form a stable government after four elections since 2019 appeared to have weakened the brand of Netanyahu. He is also facing corruption charges. Even the Gaza bombing, which many predicted would help him politically, appears to have backfired as his right-wing allies criticised the ceasefire with Hamas, calling it "a surren-

Fragile coalition

When his grip on Israeli politics finally started loosening up, his political rivals found an opportunity. Mr. Lapid stitched together a coalition of eight parties, from the right-wing Yamina of Mr. Bennett to the Arab Ra'am. This is the first time an Arab party is joining a ruling coalition in the history of Israel. In the Knesset, Mr. Neta-

nyahu has made it clear that he will not give up. He has called the coming together of the diverse parties an "election fraud". On the other side, the Lapid-Bennett coalition is visibly weak. When Mr. Lapid announced the coalition earlier this month, he had the support of 61 Members of the Knesset (MKs) out of 120. During the vote on June 13, the government got the backing of 60 MKs as against the Opposition's 59 - one MK from Ra'am abstained. It would be an uphill task for Mr. Bennett to keep his bloc together, especially when sensitive issues such as Jerusalem and Jewish settlements come up.

But to begin with, they did what seemed impossible till a few months ago - ousting Mr. Netanyahu from power. For Messrs, Lapid and Bennett, that itself is an achieve-

Novavax announces efficacy of about 90% for its vaccine

In India, it is slated to be produced in partnership with SII

U.S. vaccine manufacturer Novavax said its COVID-19 vaccine had shown an overall efficacy of 90.4% in trials in the U.S. and Mexico, potentially adding - in a few months – another vaccine to the world's arsenal against the disease, which has killed close to 4 million people. Trials have already occurred in the U.K. and South Africa.

The Maryland-based company, which tested its two dose 'NVX-CoV2373' vaccine on a population of just under 30,000 adults in the U.S. and Mexico, said the jabs provided 100% protection against moderate to severe disease and an overall efficacy of 90.4%. Of the 77 individuals out of 29,960 in the trial who contracted CO-VID-19, 14 received the actual vaccine, doses of which were spaced three weeks apart, while 63 had received placebos.

Ten moderate to severe cases of the disease were observed, but all were confined to the placebo group, the company said. All 14 infections in the vaccinated group were mild. Preliminary data suggest that the vac-



cine is safe, according to a press release from Novavax. Novavax detected strains of the virus found first in the

U.K., U.S., Brazil, South Africa and India, according to data released by the company during a Monday morning conference call. Vaccine efficacy was 91% in "high-risk "populations

(above 65 years of age, or under 65 years with comorbidities or frequent COVID-19 exposure) the company said. Novavax said it plans to apply for authorisations in the third quarter (July-Sep-

tember) and is on track to manufacture 100 million doses a month by the end of September, and 150 million doses a month by the end of 2021. The U.S. has more doses than it will need to vaccinate its entire population and as a result, much of the Novavax vaccine may be used in developing countries. That it can be stored at 2-8 degrees Celsius makes it easier to use in developing countries, where maintaining unbroken cold chains can be challenging. The vaccine works by eliciting an immune response to a prefusion spike protein built from Novavax's recombinant nanoparticle technology and an adjuvant (a substance increases immune response).

The vaccine is likely to be

authorised first in a country other than the U.S., its CEO Stanly Erck said, according to the New York Times. "Many of our first doses will go to... low- and middle-income countries, and that was the goal to begin with," Mr. Erck told The Associated Press. Novavax has signed an agreement with international vaccine access coalition Gavi, to supply 1.1 billion to low-and middle-income

countries. In India, the vaccine is slated to be produced in partnership with the Serum Institute of India (SII), under the name Covavax. Earlier in June, the Drugs Controller General of India had given permission to SII to go ahead with Phase 2/3 trials.

G7 of 'political manipulation

China accuses

China on Monday accused the G7 of "political manipulation" after it criticised Beijing over its human rights record in Xinjiang and Hong Kong.

In a communique after a three-day summit in England, G7 leaders slammed China over abuses against minorities in the Xinjiang region and pro-democracy activists in Hong Kong, while U.S. President Joe Biden called for Beijing to "start acting more responsibly in terms of international norms on human

rights". The Chinese Embassy in the U.S. responded angrily on Monday. "The Group of Seven (G7) takes advantage of Xinjiang-related issues to engage in political manipulation and interfere in China's internal affairs, which we firmly oppose," an Embassy spokesman said in a statement.

The statement accused the G7 of "lies, rumours and baseless accusations".

Activists say China has rounded up an estimated one million Uighurs and other minorities in Xinjiang into internment camps, which Beijing says is to eradicate extremism.

EU resolution puts spotlight on Sri Lanka's rights situation

It does not take cognisance of multi-faceted progress: govt.

A recent resolution adopted by the European Parliament, urging the EU Commission to consider temporary withdrawal of the GSP+ status given to Sri Lanka, has put the spotlight back on Sri Lanka's human rights situation, prompting Colombo to defend its "multifaceted progress" in its response.

Sri Lanka regained the GSP +, or the EU's 'Generalised Scheme of Preferences' in 2017, on Colombo's commitment to implement 27 international conventions on human rights, labour conditions, protection of the environment and good governance. The status effectively

removes import duties on goods from Sri Lanka entering the EU.

The June 10 resolution, expressing "deep concern over Sri Lanka's alarming path towards the recurrence of grave human rights violations", makes specific reference to the use of the Prevention of Terrorism Act, pointing to arrests of lawyer Hejaaz Hizbullah and poet Ahnaf Jazeem, among others, who are in "arbitrary"

detention for over a year. The resolution notes the "continuing discrimination" against and violence towards religious and ethnic minorities, while voicing "serious concern" about the 20th Amendment passed in 2020, and the "resulting decline in judiciary independence, the reduction of parliamentary control, and the excessive accumulation of power with the presidency". Responding, Sri Lanka's

Foreign Ministry on Friday said it regrets the adoption of the resolution that, it observed, "contains factual inaccuracies, and does not take cognisance of the multifaceted progress made by Sri Lanka in reconciliation and development." Rejecting claims that the PTA is used for arbitrary detentions, the Ministry said it was "revisiting provisions" of the Act to propose "necessary amend-

ments", drawing upon inter-

national best practices.

Rural areas see sharper spurt; WPI inflation races to record 12.94% spurred by rise in fuel, edible oils

NEW DELHI

Retail inflation hit a sixmonth high of 6.3% in May, thanks to a persistent rise in fuel and edible oil prices, which also played a part in pushing wholesale prices to a record 12.94% inflation in the month, as per data released on Monday.

Consumers experienced an inflation of 11.58% for the 'fuel and light' category in May, with urban India bearing a bigger hit of 14.24% on the same account. Food inflation reheated to 5.1% from just 1.96% in April.

Overall retail prices, however, saw a sharper spurt in rural areas from 3.75% in April to 6.5% in May, while it was less pronounced in urban India at a little more than 6% from 4.7% in April, as per the National Statistical

'RBI will find it tricky'

Economists said the hardening inflation numbers would make it trickier for the Reserve Bank of India to balance the need to spur growth while keeping a lid on price rise, but they don't expect a change from its 'accommodative' stance any

The RBI had recently revised its inflation estimate for 2021-22 to 5.4%, while moderating growth hopes for 2021 to 9.5%

"Although it is still too early to believe that retail inflation will remain in excess of 6% on a sustained basis, given the high base of last year, we believe the rising wholesale inflation which is gradually finding a reflection in the retail inflation as well, is going to make things difficult for RBI," said Sunil Kumar Sinha, principal economist at India Ratings.

Ratings agency ICRA said core retail inflation had hit an 83-month high of 6.6% and is expected to remain higher than 5% through the

"The phased unlocking of the States may temper the CPI inflation to around 6% in June. We have raised our forecast for the FY2022 average CPI inflation to at least 5.4%," said its chief economist Aditi Nayar.

She, however, expects the RBI's monetary policy committee to maintain 'a high tolerance' even if average retail inflation hovers between 5.5 and 6%, given the uncertainties regarding the growth

Cement offtake drops 25% in April-June: ICRA

'Pent-up demand to drive sales in Q2'

The second wave of CO-VID-19 has adversely impacted the domestic cement sales in the April-June quarter, reducing 25% on a quarter-on-quarter basis but pent-up demand is expected to push up volumes starting in the July-September quarter, as per a report.

In April, when the second wave was on the rise, domestic production was down 35% month-on-month in April and 4% lower in comparison with the pre-pandemic April 2019, said ratings agency ICRA.

Unlike last year, rural areas have also been impacted in the second wave. "The recovery in the ru-



gradual," it said. However, it added that pent-up demand is likely to drive offtake once lockdowns are relaxed.

ICRA AVP and sector head Anupama Reddy said cement firms have raised prices by an average of 5% in April from a year earlier, spurred by the rise in input costs, primarily power & fuel and freight expenses.

Adani stocks tumble on reports of NSDL action

Group says 3 FPI accounts not frozen

Shares of Adani Group companies witnessed a massive drubbing in morning trade on Monday, tumbling up to 25%, amid reports that the National Securities Depository Ltd. (NSDL) had frozen certain foreign portfolio investor (FPI) accounts that have holding in some of these firms.

Billionaire Gautam Adani's group on Monday said it had written confirmation that accounts of three foreign funds, that were among its top shareholders, had not frozen and reports to the contrary were "blatantly erroneous and misleading".

Following the statement, shares of some group firms witnessed partial recovery from their early losses.

Adani Enterprises closed 6.26% lower at ₹1,501.25 and Adani Ports and Special Economic Zone tumbled 8.36% to ₹768.70 on the BSE.

In morning trade, Adani Enterprises had tanked 24.99% to ₹1,201.10, while Adani Ports dived 18.75% to ₹681.50. Adani Green Energy dipped 4.13% to ₹1,175.95, Adani Total Gas fell 5% to ₹1,544.55, Adani Transmission declined 5% to ₹1,517.25 and Adani Power slumped 4.99% to ₹140.90.

All these stocks hit their respective lower circuit limits during the trade.

'Albula, Cresta, APMS' According to media reports, the NSDL had frozen the accounts of three foreign which together owned shares in four Adani Group firms. The accounts were frozen on or before May 31, the report added.

Adani Enterprises, the conglomerate's flagship company, as also Adani Ports and Special Economic



Zone, Adani Green Energy Ltd., Adani Transmission Ltd., Adani Power and Adani Total Gas Ltd., in identical filings to the stock exchanges, said the reports of NSDL freezing accounts of Albula Investment Fund, Cresta Fund and APMS Investment Fund, holding shares in the group firms, were "blatantly erroneous and done to deliberately mislead the investing community.

"This is causing irreparable loss of economic value to the investors at large and reputation of the group," it said.

"We requested Registrar and Transfer Agent, with respect to the status of the Demat Account(s) of the aforesaid funds and have their written confirmation vide its e-mail dated 14th June, 2021, clarifying that the Demat Account(s), in which the aforesaid funds hold the shares of the company, are not frozen," the firms said.

Ajit Mishra, VP-Research, Religare Broking Ltd., said, "Initially, a news report on the Adani group triggered a weak start, however the benchmark gradually recovered as the day progressed, thanks to noticeable buying in select index majors. The clarification by the company further comforted the market and helped the index to close flat.'

The Sensex fell 538.45 points to 51,936.31 but later recovered to close 76.77 points higher at 52,551.53.

Coal India Q4 profit drops 1% on lower sales

I-T Dept. allows manual filing as new portal stalls



"We got a chance to speak to Rahane, who has a lot of experience in Tests," she said. "He told us about how to bat and what should be our approach in long-form cricket. He told us how to divide an innings into five-minute periods.'

'Chopra model' could have been tried for others

Without competitions, very difficult for athletes to stay motivated: Uwe Hohn

As javelin thrower Neeraj Chopra gets ready for his next meet, Sweden's Karlstad GP, back home Shivpal Singh must be really desper-

ate for meets. Shivpal, like Chopra, has qualified for the Tokyo Olympics but the Athletics Federation of India's plans to send him and others to Turkey and more recently to Kyrgyzstan and Kazakhstan for competitions have failed. Visa restrictions and 14-day quarantine have often been given out as hurdles for athletes' travel abroad.

That brings us to the big question: Why didn't the AFI try the 'Chopra model' to send Shivpal and others abroad at this crucial stage with the Olympics just 40 days away. Chopra, the country's brightest hope for a medal in Tokyo, flew to Portugal via France on June 6 and won a meet in Lisbon



four days later.

"We tried since ages to get a camp or get to Europe for competitions for our top throwers but it's very difficult because of strict restrictions of other countries. But there is also no support from AFI or SAI. And the fact that Neeraj was able to leave is based on contacts of JSW (which is supporting him),"

said German Uwe Hohn, the national javelin throw coach, in a chat with *The Hindu* on Monday.

"Few athletes had one competition in 2020, for others last competition was in 2019 so they need to catch some competition. It's part of training and eight to 10 competitions should be okay."

Some Indian shooters, swimmers, wrestlers and boxers are either training or taking part in events abroad. So one can imagine the

frustration of athletes like Shivpal, Annu Rani (19th and well placed on the Road to Tokyo women's javelin rankings), long jumper M. (qualified), Sreeshankar shotputter Tajinderpal Singh Toor and the 4x400m men's and women's relay runners who are in the danger zone in the rankings. They are all desperate for competitions.

"Athletes realise that there's no support from anyone... so it's also very difficult to stay motivated," said Hohn a former world record holder. "Probably only Neeraj will have the advantage of international competitions (before Tokyo)."

AFI president Adille Sumariwalla and SAI directorgeneral Sandip Pradhan did not respond to calls or messages sent for their version.


