GST brought down on 14 COVID relief goods

Council leaves the 5% tax levied on vaccines unchanged

The Goods and Services Tax (GST) Council on Saturday decided to waive the tax levied on two critical drugs against COVID-19 and mucormycosis – tocilizumab and amphotericin B – and reset the tax rate to 5% for 14 major pandemic relief items, till September 30.

Non-BJP-ruled States registered a strong dissent, terming the continued imposition of GST on critical COVID supplies and drugs as 'insensitive' and 'totally anti-people'. They alleged that their proposals for zero-rating or reducing GST rates to 0.1% on critical supplies were ignored by the Union Finance Ministry at what turned out to be another stormy Council meeting.

Mitra's remarks deleted

West Bengal Finance Minister Amit Mitra said the Council's chairperson, Union Finance Minister Nirmala Sitharaman, allowed his comments to be deleted at the behest of his Uttar Pradesh counterpart, and accused the Ministry of muzzling his voice and cutting off the virtual conference link when he was trying to voice objections.

cines was left unchanged, following the recent changes in the country's vaccine procurement strategy that puts the Union government in charge of augmenting supplies. The GST rate on Remdesivir and anti-coagulants like Heparin has been reduced from 12% to 5%. The Council recommended that the same rate be levied on any other drug that may be recommended by the Health and Family Welfare Ministry and the Department of Pharma for COVID-19 treatment.

Ms. Sitharaman an-

nounced that the Council had accepted all but three recommendations on COVID-19 supplies' tax rates submitted by a group of ministers (GoM) under Meghalaya Chief Minister Conrad Sangma on June 6.

Ambulances, which are currently taxed at 28%, will attract a GST levy of 12%, while temperature checking equipment and electric furnaces used in crematoriums will attract a 5% GST instead of 18%.

New declassification policy gets nod

Cases like 1962 war, Operation Bluestar will be taken up on case by case basis

Defence Minister Rajnath Singh on Saturday approved a policy on archiving, declassification, compilation and publication of war and operations histories by the Ministry of Defence (MoD). However, declassification of older wars like the 1962 war is not automatic and will be taken up on a case by case basis by a committee to be constituted under the policy.

"According to the policy,

records should ordinarily be declassified in 25 years. Records older than 25 years should be appraised by archival experts and transferred to the National Archives of India once the war/operations histories have been compiled," the Ministry said on Saturday.

Confidential cases

Asked about cases like the highly confidential Henderson Brooks report on the 1962 war with China and the

Operation Bluestar of 1984, a defence official said a committee will take a view on the earlier wars and operations. The compiled history on wars and operations, within

five years, will be for internal consumption first, and later the committee may decide to publicly release whole or parts of it, considering the sensitivity of the subject, the official said. "The policy mandates constitution of a committee headed by Joint Secretary, MoD, and comprising representatives of the Services, Ministry of External Affairs, Ministry of Home Affairs, and other organisations and prominent military historians for compilation of war and operations histories."

Breach exposes govt. officials' data to hackers

IDs on @nic.in, @gov.in compromised

Emails and passwords of hundreds of Union government officials have been exposed to hackers due to the recent data breaches of Air India, Domino's and BigBasket, the government has warned officials.

The internal communication, accessed by *The Hindu*, said the compromised emails on government domains such as @nic.in and @gov.in are potential cyber threats as they are being used by "ad-

versaries" to send malicious mails to all government users.

Days after the alert was sent on June 10, several government offices, including Defence Ministry officials, were targeted by a malicious web link sent on WhatsApp and SMS, asking them to update their vaccination status.

The message asked officials to click on <https://covid19india.in> to generate a digital certificate of COVID-19 inoculation.

'Operation Olivia' to the rescue of Olive Ridleys

The Coast Guard helps enforce laws to protect turtles as they arrive to nest in Odisha

Every year, the Indian Coast Guard's "Operation Olivia", initiated in the early 1980s, helps protect Olive Ridley turtles as they congregate along the Odisha coast for breeding and nesting from November to December.

"For optimal results, round-the-clock surveillance is conducted from November till May utilising Coast Guard assets such as fast patrol vessels, air cushion vessels, interceptor craft and Dornier aircraft to enforce laws near the rookeries," a Coast Guard officer said. "From November 2020 to May 2021, the Coast Guard devoted 225 ship days and 388 aircraft hours to protect 3.49 lakh turtles that laid eggs along the Odisha coast."

The Olive Ridley (*Lepidochelys olivacea*) is listed as vulnerable under the International Union for Conservation of Nature's Red

list. All five species of sea turtles found in India are included in Schedule I of the Indian Wildlife Protection Act, 1972, and in the Appendix I of the Convention of International Trade in Endangered Species of Wild Fauna and Flora which prohibits trade in turtle products by signatory countries. The Orissa Marine Fisheries Act empowers the Coast Guard as one of its enforcement agencies.

"Studies have found three main factors that damage Olive Ridley turtles and their

eggs – heavy predation of eggs by dogs and wild animals, indiscriminate fishing with trawlers and gill nets, and beach soil erosion," the officer said.

Dense fishing activity along the coasts of Andhra Pradesh, Odisha and Bengal, especially ocean-going trawlers, mechanised fishing boats and gill-netters pose a severe threat to turtles.

Coordination of efforts is done at various levels, the officer explained, including enforcing the use of turtle excluder devices (TED) by

trawlers in the waters adjoining nesting areas; prohibiting the use of gill nets on turtle approaches to the shore; and curtailing turtle poaching.

Nesting habits

The Olive Ridley has one of the most extraordinary nesting habits in the natural world, including mass nesting called arribadas. The 480-km-long Odisha coast has three arribada beaches at Gahirmatha, the mouth of the Devi river, and in Rushikulya, where about 1 lakh nests are found annually.

"Sea turtles generally return to their natal beach, or where they were born, to lay eggs as adults," the Coast Guard officer explained. Mating occurs in the offshore waters of the breeding grounds and females then come ashore to nest, usually several times during a season.

It was mayhem everywhere. Bodies wrapped in white were being brought in – in hands and on wheels. Siren of ambulances is all that was heard the entire day. The only sight day in and day out was that of burning pyres, recalled Hemant Kumar Sharma, priest of Seemapuri crematorium.

Mr. Kumar (29) – clad in a white kurta pyjama – sat in the courtyard of the crematorium, his mask below his chin, in the company of another priest. There is one pyre burning on the premises with 26 platforms, and another body is due to come. There are hens roaming around...their clucking is now audible.

"It's relaxed now. There's probably one COVID-19 body coming in once in 3-4 days. We have time to breathe, eat, sleep, drink water," he said.

Looking back, he said he had never imagined that he would have to witness such a sight. He wished never to see it ever again.

New platforms

Walking through the crematorium ground, he pointed at an empty space and said they had built nine platforms apart from the 26 allotted platforms. At another space, they had prepared five platforms. Now, what remains of the extra space are huge black spots and a few bricks lying here and there.

Mr. Kumar then walked a few steps and showed an empty field adjacent to the crematorium premises.

"This is where children are buried. But when deaths were peaking, we had converted it into a cremation space and built 72 platforms. We had to break a wall to make way for wood," he recalled.

For more than 10 days in April, over 20 workers here, including priests, sanitation workers and helpers, worked for 24 hours a day and cremated bodies at night as well, against the Hindu beliefs for cremation rites.

"People used to leave bodies outside here without even informing us. There have been so many families who used to leave asking us to send the video of cremation on WhatsApp. We

used to cremate those bodies at night," he said.

Chant mantras in sleep

Talking about the impact this period had on him, Mr. Kumar said, "During that time, my mother used to forcefully ask me to come home for a few hours of sleep. My family says that I used to chant mantras in my sleep also."

I am able to sleep now, he added. Mr. Kumar, who has a six-month-old daughter, didn't hold her for a month-and-a-half of fear. Back at home, he used to eat and sleep in a corner, trying to stay away from the other family members as much as possible. "Here we didn't use PPE kits because it used to be so hot. It was impossible to breathe...we used only masks and gloves," he said.

However, they were all a little at ease because the staffers at the crematorium were fully vaccinated. Mr. Kumar said when the vaccination began, they received a call from government officials and were asked to get vaccinated because they were to deal with COVID-19 bodies.

"Sapne main bhi nahi socha tha aisa manzar dekhenge. Dil se

Tales of horror

rona aata tha. Ek 6 mahine ke bacche ka antim sanskar kiya tha humne. Uske papa itna ro rahe they. Vo ankhon ke samne se jaata nahin. [Didn't imagine in my dreams that I'll see something like this. We performed last rites of a six-month-old boy [who died of COVID-19]. His father

was crying inconsolably. I can never forget that," he said.

Signs of new life

At Punjabi Bagh crematorium, plants in the premises had died because pyres were set up right next to them when the number of deaths increased.

The plants have now been cut and there's a semblance of life as new leaves have started to appear.

"I had become used to it since last year, so it didn't affect me much," said Pankaj Sharma (40), one of the priests here. But he insisted the situation wasn't as bad here as it was at other crematorium grounds. "Yes, people had to wait here as well but not for as much time as in other crematorium grounds."

Now, there are only one or two COVID-19 bodies coming daily and most of the ground remains empty.

But for the inexperienced priests and staffers, seeing the sight of innumerable bodies had an impact, unlike for Mr. Sharma.

"There were days when we didn't get time to have meals or even drink water. We would start our day at 6.30 a.m. and as-

ist people with the mortal remains. The family members of the victims were seen crying and scared themselves, wondering what to do, where to go. We would only get free around 9 p.m. or 10 p.m.," said 23-year-old Deepanshu, for whom the images of the pyres are still haunting.

Vaccination woes

At this crematorium, none of the staffers has been vaccinated. While some of the senior ones are hesitant to get the jab, most staffers are disappointed that no vaccination camp has been set up for them despite their details being listed.

"We received calls from government officials who took our details when the vaccination drive started and they asked us to go to a nearby hospital for the same. When we went there, we filled a form and they told us

that our names were not on the list," said a sanitation worker who didn't wish to be named.

"We were around COVID-19 bodies and COVID positive patients. We deserved it," said Deepanshu.

At Lok Nayak Hospital, the area outside the emergency ward now stands deserted and the two white tents installed as waiting area, a few weeks ago, are empty. There are no people waiting outside with oxygen cylinders. No queue of ambulances and no relatives crying and pleading to admit their loved ones.

It's all gone and everyone's breathing a sigh of relief.

A civil defence volunteer, Abhay, on duty outside the hospital, recalled his duty at the mortuary "during those days" and all he saw was bodies being wheeled in. "I don't want to remember it at all."

CM launches 22 oxygen plants at nine hospitals

We are preparing for the next surge on war footing: Kejriwal

Chief Minister Arvind Kejriwal on Saturday inaugurated 22 oxygen plants at nine Delhi government hospitals.

The Pressure Swing Adsorption (PSA) oxygen plants have a total production capacity of 17.3 metric tonnes. Seventeen more oxygen plants are scheduled to become operational by July.

Mr. Kejriwal said the people of Delhi as well as doctors, nurses, paramedic staff and sanitation workers fought with discipline and hard work to control the latest surge. "I know of many doctors who did not go back to their homes for days. I want to thank them on behalf of the people of Delhi. The latest wave was very fatal," he added.

Mr. Kejriwal said the intensity of the latest surge was "very severe" with people falling "dangerously sick" resulting in loss of many loved ones so much so that virtually no home was left untouched.

The Delhi government is preparing to tackle a possible "third wave" and is setting up necessary infrastructure to ensure sufficient oxygen supply, he said.

"We are now at risk of a third wave. We are receiving indications that the U.K. has already started experiencing the third wave and the cases are rising rapidly even though 45% of the people are already vaccinated there. So, we also have to be fully prepared for the same. Your

government is committed to preparing with full conviction," the CM added.

"I want to thank the industries for their support during this pandemic, especially Roshni Nadar Malhotra, chairperson of HCL Technologies, who agreed to provide 6,000 cylinders at my single phone call," Mr. Kejriwal said.

The latest surge in Delhi saw a huge shortage of oxygen, Mr. Kejriwal said, adding that the city is not an industrial State and therefore does not have its own source of oxygen production. The requirement of oxygen had increased manifold to 700 MT during the crisis.

Delhi did not have the means of production or even tankers to procure oxygen from Haryana and Uttar Pradesh on the directions of the Centre, but now we have to be fully prepared, he said.

"We cannot do away with our responsibilities of managing the third wave. Your government is working on war footing. A few days ago, I

inaugurated oxygen storage tanks, because even if we procure oxygen from outside Delhi, we do not have the capacity to store the oxygen," he said. "I am very happy to be inaugurating the 22 oxygen plants. This is a huge development. A total of 27 PSA plants have been started in Delhi," he further said.

More supply
The CM added that six oxygen plants had already been started by the Centre and seven plants were going to begin soon. "The pandemic cannot be fought alone and I thank the Central government for supporting the Delhi government," he said.

Another 17 plants will be installed by July, the CM said, adding that the government was also procuring oxygen tankers to mitigate the impact of the third wave.

Earlier in the day, Delhi Legislative Assembly Speaker Ram Niwas Goel inaugurated three PSA oxygen plants at Rajiv Gandhi Super Specialty Hospital.

Delhi reports 213 new cases, 28 deaths

The downward trend in COVID-19 cases continued in Delhi with 213 new cases reported over the past 24 hours, taking the total to 14,30,884 on Saturday. Twenty-eight more deaths pushed the toll to 24,800.

A total of 71,513 tests were conducted in a single day and the test positivity rate was 0.3%.

There are 3,610 active cases in the city.

During the latest surge, the positivity rate had touched 36% on April 22.

Vaccination picks up
Earlier in the day, Aam Aadmi Party leader Atishi said the 18-44 age group is coming out in large numbers to get the jab.

"One lakh doses of vaccines are available for the youth, including 33,000 doses of Covaxin, which is being used to give the second dose, and 67,000 doses of Covishield. Covaxin stock for the youth will last three days and Covishield for two days. We hope that the Centre maintains a regular supply of vaccines for the youth."

Meanwhile, Delhi Finance Minister Manish Sisodia said that during a GST Council meeting on Saturday, he had urged the council to make many items related to COVID-19 tax-free, but the Central government opposed it.

"Masks, sanitisers, oximeters and thermometers have become part of daily expenditure. The Centre should make them tax-free," Mr. Sisodia said.

2 policemen assaulted at Singhu border

Two Delhi Police assistant sub-inspectors were allegedly assaulted by a group of people at the Singhu border where farmers have been protesting against the new agriculture laws.

A senior officer said that two policemen, posted with the Special Branch, were on duty in civil clothes. The incident happened on June 10 when they were deployed at the Singhu border.

Protesting farmers said that the officers were assaulted when they were found taking photographs at the protest site.

Sustained injuries
A senior officer said that one of the policemen suffered a fracture in his hand and another sustained injuries in his leg. They were rushed to a hospital and were discharged after treatment. The officers were "beaten up by people present at the

protest site and an investigation is being conducted to ascertain the identity of those involved".

Talking about why the officers were in civil dress, the officer stated that policemen from Special Branch are regularly sent to the protest site to gather intelligence for any possible action that needs to be taken by security agencies. A case has been registered on charges of assaulting a public servant while on duty.

2041 draft plan envisions Capital as a '24-hour city'

Document lays out steps to promote night-time economy

Apart from promoting the concept of a '24-hour city' and fostering night-time economy, the draft Master Plan for Delhi (MPD) - 2041 also proposes to encourage public transporters such as the Delhi Metro Rail Corporation (DMRC) and the Delhi Transport Corporation (DTC) to operate low frequency night-time services along earmarked routes across the national Capital.

In its bid to develop and strengthen economic centres, the plan proposes to foster night-time economy. "Nodes, precincts or circuits shall be identified for continuing work, cultural activity and entertainment at night to attract tourists and locals. This will improve economic yield by extending utilisation of work spaces and safety by promoting a vibrant night life," read the draft plan.

Public transport
The draft MPD-2041 states that one of the primary objectives is to build on the Capital's extensive public and shared transport infrastructure to reduce dependence on private vehicles.

As a part of special services, the draft MPD - 2041 states: "The plan targets night-time economies to promote higher economic

productivity as well as increasing availability of vibrant and safe public spaces at night. The DMRC and the DTC will be encouraged to operate low frequency night-time services along earmarked routes or for special events or festivals."

The plan also suggests fare rationalisation to improve utilisation of public transport for short and medium distances, frequent intra-city trips and increased ridership in high-density areas.

Congestion charges
To disincentivise private transport and increase reliance on public or shared modes of transport, the draft plan also proposes congestion pricing and restricting availability of public parking in markets, cultural hubs and work centres.

"Road-owning agencies in consultation with traffic police shall notify specific areas

in the city as congestion pricing zones. Parking charges to be used as a tool for disincentivising private transport usage. Dynamic pricing for peak and off-peak periods, on and off-street parking to be utilised to decongest areas with high vehicular footfall," the plan reads.

According to the draft MPD-2041, concerned agencies will also be required to identify specific areas with heavy footfall such as tourist hotspots and markets as "pedestrian only" zones. "Tactical urbanism measures to convert streets into fully pedestrian zones for specific time durations to be encouraged, so that overall traffic flow is not hampered," the draft plan stated.

The draft plan was recently put in the public domain by the Delhi Development Authority and stakeholders were invited to put forth objections and suggestions.

Over 4.5 lakh have received ration: Delhi govt.

Scheme is a walk-in process and does not require beneficiaries to pre-register

More than 4.5 lakh residents have been provided free ration by the Delhi government so far and efforts are under way to iron out issues related to the supply of ration at a few sites over the last few days.

According to the Delhi government, as much as 5,000 MT of dry ration has been provided at centres in the form of combined entitlement consisting of 5 kg of foodgrains, including 4 kg of wheat and 1 kg of rice, per beneficiary so far.

The Delhi government is

distributing dry ration at such sites, which include 280 schools, and 5,000 MT will become available at such centres within a week.

The distribution is carried out by the staffers of the Directorate of Education, municipal corporations and other departments in coordination with the area District Magistrate between 10 a.m. and 4 p.m. on all working days except gazetted holidays and Sundays.

The scheme does not involve the beneficiaries to do any pre-registration and is a walk-in process on the basis of beneficiary details such as

name, parentage, mobile number, Aadhaar which are utilised to generate token number via SMS.

According to the government, those in need of dry ration, who do not possess ration cards, are eligible to receive relief under the initiative.

Helped many

Amrita, a resident of Kichdiur village said, "A lot of people have lost their jobs, and are finding it difficult to feed their families being the sole breadwinners. The scheme has aided such people and many others who

were facing adversities during this pandemic."

Delhi Food and Civil Supplies Minister Imran Hussain said, "A large number of people turned up at several centres in excess of what was expected. But people should not be concerned. We have placed orders with the FCI for more foodgrains, which will arrive soon."

Mr. Hussain added that the government had taken note of all kinds of grievances reported and sought to issue an assurance that the process will be further streamlined in the coming days.

Major fire breaks out at Lajpat Nagar Central Market

33 fire tenders were pressed into service

A major fire broke out at Lajpat Nagar's Central Market on Saturday. No injuries were reported, the police said, adding that a case has been registered.

Delhi Fire Services chief Atul Garg said that a call was received at 10.30 a.m. regarding a fire in a showroom after which 33 fire tenders were pressed into service in the next four hours till the fire was doused.

Cause not ascertained

Cooling-off operation continued till late evening, Mr.

Garg said.

The Fire department said that the blaze first started from four showrooms and later spread to the fifth shop.

Mr. Garg said that the cause of fire is yet to be ascertained. He also added that it was due to the firemen and timely response that the blaze

didn't spread to residential areas behind the showrooms. "There were 100 firefighters on the spot," he said.

The police said that senior officers from the force and fire department reached the spot and also asked to cut supply immediately. "The crime team and forensic team were also called to inspect the spot. A case under Section 285 [for negligent act endangering human life] of the Indian Penal Code has been registered and investigation will be done accordingly," said a senior officer.

Delhi Chief Minister Arvind Kejriwal tweeted: "I am constantly monitoring the situation and in constant touch with the fire department officials".

BJP attacks AAP govt. over ration scheme

The Delhi BJP on Saturday staged a demonstration over the Delhi government's alleged failure to implement the 'one nation one ration card' scheme.

The protest was staged at the Shahdara chowk taxi stand and led by Delhi BJP president Adesh Gupta. North-East Delhi MP Manoj Tiwari, Leader of Opposition Ramvir Singh Bidhuri, State general secretary Harsh Malhotra and MLA Jitender Mahajan also participated in the agitation.

"When 34 States and Union Territories have already started this scheme, what is Chief Minister Arvind Kejriwal's compulsion not to do so in Delhi? The Delhi government is in the grips of the ration mafia and hence wants to start 'Ghar Ghar Ration Scheme'. It is a scam and not a scheme," said Mr. Gupta.

"Mr. Kejriwal wants to distribute ration under the PM Gareeb Kalyan Yojna as his own scheme, which smacks of corruption. When this ration reaches the needy and poor it will include cost of packaging and delivery, making it costlier," Mr. Bidhuri claimed.

Mr. Tiwari alleged that the Delhi government's decision to deprive residents of the Central States of the ration benefits by not implementing the 'one nation one ration card' scheme was "cheap politics".

Rajasthan announces package for COVID-19 orphans, widows

It includes ex gratia of ₹1 lakh, free education and pension

The Rajasthan government on Saturday announced a financial relief package for the children who lost their parents to the COVID-19 infection and the women whose husband died of the disease during the pandemic. The orphans and widows will get an ex gratia of ₹1 lakh each, followed by a financial assistance every month.

As part of the Chief Minister's Corona Baal Kalyan Yojana, the children who lost their parents will get ₹2,500 a month till they attain 18 years of age. The orphans

will be provided an assistance of ₹5 lakh on the completion of 18 years as well as free senior secondary education and other benefits under the scheme.

Amount for each child
The women whose husband succumbed to the infection will be given an ex gratia of ₹1 lakh and a pension of ₹1,500 a month, irrespective of their age and financial status. They will also get ₹1,000 a month for raising their children and ₹2,000 per year for their school books and uniform. The amount will be calculated for each child separately.

The State government has formulated the package following the instructions of CM Ashok Gehlot, who was concerned about the future of orphans and widows following the death of the earning head of the family.

Official sources said here that the girl students of these families studying in the college would be given preference in the admissions to the hostels run by the Department of Social Justice and Empowerment.

The youths affected by the tragedy in the family will also get priority in the sanctioning and payment of unemployment allowance.

'Sisodia's accusation on Punjab school education atrocious'

Amarinder says AAP leadership is obsessed with electoral politics

Punjab Chief Minister Amarinder Singh on Saturday described as "atrocious" the Aam Aadmi Party's accusation that he has a "secret" friendship with Prime Minister Narendra Modi.

The Chief Minister was reacting to AAP leader and Delhi Deputy Chief Minister Manish Sisodia's statement after Punjab was ranked number one in the Performance Grading Index 2019-2020 for school education by the Centre.

In a hard-hitting reply to the allegation, Capt. Singh said the AAP leadership is so "obsessed" with electoral politics that it saw poll conspiracies even in something as basic as school education.

The fact is that AAP, which "failed" to make a dent in Punjab's political arena over the past few years, can see the rout which it is facing in the 2022 Assembly elections, he said in a statement.

"Come to Punjab and I will show you around our schools," Capt. Singh said, adding that the revamp of the State's schools was an exercise undertaken by his government as top priority and the ranking released by the Union Education Minis-

The Delhi Education Minister went on to say that quality education and learning has become a "joke" in Punjab government schools. "Modiji has released this report to hide the inadequacies in quality education of Punjab. Many children had to bear the brunt and parents had to transfer their children to private schools," he said.

BJP flays AAP

Reacting to Mr. Sisodia's allegations, the BJP said that the problem with the AAP leadership is that they are Delhi's local leaders but wish to speak on every State's politics, including that of Punjab, whose people have repeatedly rejected the party in every election after 2017.

"When a Central government report favours Delhi government, they claim credit for their work. Why then they try to discredit the Centre's report which goes against them? Why did the Delhi government during the last six years push out 15 lakh weak students from Class IX and XI, forcing them to opt for NOIS schooling instead of helping them improve," BJP spokesperson Harish Khurana asked. (With inputs from PTI)

'Jugalbandi' invite

"If you are really interested in improving the education system of Delhi, may be you should do a 'jugalbandi' with me and I will teach you how to manage things better," the Chief Minister replied to Mr. Sisodia's charge. Punjab Education Minister Vijay Inder Singla also hit out at his Delhi counterpart saying: "The desperation of Manish Sisodia was quite visible and understandable as paid clamour about the rosy picture of Delhi schools in media by the AAP government had comprehensively been exposed. While Punjab got the top rank, Delhi has not been placed in top five...It has been placed on sixth position."

Mr. Singla said the teach-

ers and other staff of the Education department have worked hard to bring the State on the top position. "Punjab has emerged as a leading State in rejuvenating school education by being a pioneer in bringing in infrastructural development, qualitative improvement and complying with RTE norms in government schools," he added.

Mr. Sisodia on Saturday raised strong questions against the report released by the Central government. "Crediting Punjab government with the best government schools in the country at a time when the State has seen the closure of more than 800 schools, and several schools found to be functioning as alcohol factories, is a farce. It is crystal clear that Captain Singh has the blessings of Modiji," he said.

Trust party cadre, says Mayawati

BSP chief's statement comes after sacking 2 senior leaders

Bahujan Samaj Party chief Mayawati on Saturday asked her supporters and workers to trust her party cadres, but not party leaders as she said some of them did not hesitate before hurting the interests of the party for self-gains and often got sold out.

Ms. Mayawati's warning, at a meeting held here in preparation for the 2022 Ut-

tar Pradesh Assembly polls, comes days after she sacked two senior party MLAs Ram Achal Rajbhar and Lalji Verma on charges of indiscipline. Members of the OBC community, the two leaders were some of the few remaining fragments of the BSP's old-guard, still associated with the party in the post-Kanshiram era.

Following their expulsion, the leaders had hinted that a dispute with a BSP

coordinator from Ambedkar Nagar district had led to a misunderstanding between them and the chief.

Ms. Mayawati urged her 'party people' to trust the BSP's cadre more than the leaders who, despite taking the names of B.R. Ambedkar and Kanshiram, give importance to their personal greed. "They don't hesitate from hurting the interests of the party and the movement and get sold out."

'Corona mata' temple built, demolished

'Take corrective steps in housing scheme'

Centre pulls up Odisha after irregularities were found in PMAY-G implementation

After coming across large scale irregularities in the implementation of the Prime Minister Awas Yojana - Grameen in Odisha, the Centre has asked the State government to take corrective measures.

A Central team led by Gaya Prasad, Deputy Director General of Department of Rural Development, had visited the State on February 9 and 11 to conduct an inquiry after a complaint from former Union Tribal Affairs Minister and Sundargarh MP Jual Oram. "The Central team ob-

served several cases of irregularities relating to absence of PMAY-G logo on houses, lack of quality construction and houses being shown as completed on AwaasSoft, but found incomplete during inspection," Union Rural Development Minister Narendra Singh Tomar wrote to Mr. Oram.

'Recover funds'

Some of the prominent irregularities flagged by the team include allotment of PMAY-G houses to both father and son and construction of PMAY-G houses on government land.

The Rural Development

Department had directed the State Chief Secretary to recover funds from ineligible beneficiaries of the flagship housing scheme.

At one place, beneficiaries were found constructing houses on government land.

"The State government may consider regularising allotment of land to beneficiaries and allow them to proceed. If it is not agreeable to the State government, then the funds released to them should be recovered," the team recommended.

The department also asked the State government to take stern action against people involved in irregular-

ities and file police cases against erring officials.

"The quality of construction noticed during inspections is very poor. The State is requested to take measures to improve the quality of the houses that have been inspected during inquiry and bring them to liveable condition," Nagendra Nath Sinha, Rural Development Secretary, said in a letter to Odisha CS. The State must improve the system of quality monitoring and administrative supervision to bring significant improvements in the quality of houses under construction and those inspected, Mr. Sinha said.

Odisha's daily cases drop below 5,000

47 deaths were reported, taking the State's toll to 3,257

Odisha reported less than 5,000 daily COVID-19 cases for the first time in 53 days, with the State reporting 4,852 cases on June 12.

The State last reported less than 5,000 cases at 4,851 on April 21. Odisha's total case load stands at 8,47,313. Its active cases stand at 62,515, which had once crossed the one lakh mark.

Highest number of cases - 649 - were reported from Khordha district, followed by 500 in Cuttack. Jajpur and Balasore are two other districts where more than 300 new cases were found.

The State has been steadily reporting a decline in the daily spike in the cases since the fourth week of May.

Test Positivity Rate (TPR), an indication of prevalence of infection, is 7.22% compared to 7.87% on June 11. Of the 67,122 tests conducted in the last 24 hours, 4,852 persons were found infected. The TPR was once hovering around 23% in the State, while in some districts it had soared to above 55%.

The highest daily spike of 12,852 was reported on May 23.

Forty-seven persons were reported dead in the last 24 hours taking the total death toll to 3,257, the highest ever

single-day death toll. As death audits have picked up at the district level, the number of deaths has been gradually rising.

Out of 30 districts in Odisha, nine currently have more than 2,500 active cases, which put them in the red category. Another nine districts have active cases between 1,000 and 1,500, for which they have been marked yellow. The remaining 12 districts are green as the total active cases are under 1,000.

Since the beginning of June, the number of patients recovering daily has exceeded the number of fresh cases.

Ministry of Environment, Forest and Climate Change, Govt. of India has notified the Plastic Waste Management (Amendment) Rules, 2018. These rules shall apply to every waste generators, waste processors and manufacturers of plastic carry bags, multi-layered packaging material.

As per Plastic Waste Management (Amendment) Rules, 2018, all persons who generate, collect, store, transport, re-use, recycle and dispose plastic waste in any form including importer, producer, individuals or agencies, groups of individuals voluntarily engaged or authorized, are required to obtain registration under the Plastic Waste Management (Amendment) Rules, 2018 and Consent to Operate under Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 from Delhi Pollution Control Committee.

The Rule 13 of the Plastic Waste Management (Amendment) Rules, 2018 provides:-

- No person shall manufacture carry bags or recycle plastic bags or multilayered packaging unless the person has obtained a registration from Delhi Pollution Control Committee, prior to the commencement of production;
- Every producer shall, for the purpose of registration or for renewal of registration, make an application of DPCC, in Form I.
- Every person recycling or processing waste or proposing to recycle or process plastic waste shall make an application to the DPCC, for grant of registration or renewal of registration for the recycling unit, in Form II.
- Every manufacturer engaged in manufacturer of plastic to be used as raw material by the producer shall make an application to the DPCC, for grant of registration or for the renewal of registration, in Form III.

The rule of 4(1) (c) of the Plastic Waste Management (Amendment) Rules, 2018 provides carry bags made of virgin or recycled plastic, shall not be less than fifty micron in thickness.

All the Producers, Recyclers and Manufacturers of Carry Bag, Recycle Plastic Bags or Multi-layered Packaging in NCT of Delhi, are hereby directed to apply online at the website of DPCC at : <http://dpcc.delhigovt.nic.in> for registration under the Plastic Waste Management (Amendment) Rules, 2018 and Consent to Operate under Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 by **30th June, 2021**, failing which, action shall be taken against the defaulter units including closure of the unit, disconnection of electricity/ water supply as per provisions of the aforementioned acts including levying of Environmental Compensation. Further, the units, who have already obtained Registration under PWM Rules, 2018 shall also apply for renewal of the same well in advance to avoid penal action.

Ministry of Environment, Forest and Climate Change, Govt. of India has notified the Plastic Waste Management (Amendment) Rules, 2018. These rules shall apply to every waste generators, waste processors and manufacturers of plastic carry bags, multi-layered packaging material.

The Rule 9 of PWM Rules, 2018 provides Responsibility of producers, Importers and Brand Owners. -

- The producers, within a period of six months from the date of publication of these rules, shall work out modalities for waste collection system based on Extended Producers Responsibility and involving State Urban Development Departments, either individually or collectively, through their own distribution channel or through the local body concerned;
- Primary responsibility for collection of used multi-layered plastic sachet or pouches or packaging is of Producers, Importers and Brand Owners who introduce the products in the market. They need to establish a system for collecting back the plastic waste generated due to their products. This plan of collection to be submitted to the State Pollution Control Boards while applying for Consent to Establish or Operate or Renewal. The Brand Owners whose consent has been renewed before the notification of these rules shall submit such plan within one year from the date of notification of these rules and implement with two years thereafter.

The Rule 13 (2) of the Plastic Waste Management (Amendment) Rules, 2018 provides:-

- Every producer shall, for the purpose of registration or for renewal of registration, make an application of DPCC, in Form I.

The rule of 4(1) (c) of the Plastic Waste Management (Amendment) Rules, 2018 provides carry bags made of virgin or recycled plastic, shall not be less than fifty micron in thickness.

Producers, Importers & Brand-owners (PIBOs) are required to fulfill Extended Producers Responsibility (EPR) for the plastic waste generated due to the products introduced by them in the market. EPR is responsibility of a producer/ importer/ brand owner for environmentally sound management of the product till the end of its life. PIBOs are required to obtain registration from CPCB, if operating in more than two States/ UTs and from concerned SPCB/PCC, if operating in one or two States/UTs only. CPCB has evolved Standard Operating Procedure for Producers, Importers & Brand-owners in March, 2021 which is available on CPCB and DPCC's website. PIBOs are required to follow the said SOP to fulfill EPR for the Plastic Waste generated due to the products introduced by them.

This notice is being issued to inform all the PIBOs to obtain Registration from CPCB/ DPCC (as applicable). Those PIBOs who have not yet applied for registration are informed that they shall submit application for registration complete in all respects, to CPCB (for those operating in more than two States/UTs) or otherwise submit application for registration to DPCC. All the PIBOs are also required to submit EPR Action Plan as per SOP evolved by CPCB by 30th June, 2021 otherwise action, as deemed fit under the Environment (Protection) Act, 1986, including levying of Environmental Compensation and Closure of PIBO's operations, shall be taken against the defaulters.

Former Minister and Telangana Rashtra Samithi (TRS) rebel MLA Eatala Rajender on Saturday submitted his resignation from the Assembly. Mr. Rajender, who represented Huzurabad, was sacked from the Cabinet last month over land encroachment allegations. He will join the BJP on June 14 in New Delhi.

Sonu Sood's firm begins home delivery of oxygen

The Sood Charity Foundation, set up by actor Sonu Sood, began delivering medical oxygen at the doorstep here in Andhra Pradesh on Saturday. Anyone living within a radius of 80 km from the city can dial 7609999961 and get medical oxygen, the foundation said. More centres would be set up in the State in a phased manner, it said.

Let her face law here: IS recruit's mother

Nimisha's mother, who has been petitioning leaders for her extradition, is shocked at Centre's stance

The Centre's disinclination to permit the return of four Kerala women who had joined the Islamic State in Khorasan Province (ISKP), has shattered the confidence of Bindu Sampath, the mother of Nimisha, alias Fathima Isa, one of those languishing in an Afghanistan prison.

Nevertheless, the Thiruvananthapuram native has resolved to continue her five-year-long battle to bring her daughter and granddaughter to India.

Nimisha is said to have surrendered after her hus-

band was killed in an attack in Afghanistan.

"How can the government abandon us at a time of crisis? We never expected them to break our trust when my daughter could have been brought to her motherland after so many years," Ms. Sampath asks from her home at Attukal, near Thiruvananthapuram.

Appeals in vain

The news reported by *The Hindu* came as a blow for Ms. Sampath who has been repeatedly petitioning leaders, including Prime Minister Narendra Modi, Home Minis-

ter Amit Shah and External Affairs Minister S. Jaishankar. "I have been knocking on all doors in New Delhi for many years. Sadly, none of

our leaders has responded to my pleas. My son, an Army Major, and I have always served the country. Ironically, the Afghanistan authorities had responded to a mail seeking details of her well-being," Ms. Sampath, a trustee of the Attukal Bhagavathy Temple, says.

She urged the Centre to extradite Nimisha and her daughter to the country and face trial for the crimes she has committed.

"I have full faith in our rule of law and the justice system. I have no qualms in letting my daughter face punishment for her mis-

takes. We only hope that it happens in our country and not in a foreign land."

Ms. Sampath says those who had "brainwashed" her daughter walk scot-free, despite her seeking action against them.

"Five people, including Nimisha, who studied together in a private dental college in Kasaragod had left the country to join the extremist organisation. Besides, my daughter had revealed her room-mate's role in convincing her to convert to Islam. No agency has bothered to investigate their roles," she alleges.

Two FIRs against Kannada actor Chetan

His posts criticised 'Brahminism'

The city police have registered two FIRs against Kannada actor Chetan Kumar for allegedly "hurting religious beliefs" and "imputations prejudicial to national integration", for his recent remarks on Brahminism.

The two cases have been booked based on complaints by Sachidananda Murthy, chairman, Brahmin Development Board, and Vipra Yuva Vedike, a community organisation. The complaints were registered with the Ulsoor Gate and Basavanagudi police stations, respectively. In both FIRs, the police have booked the actor under Sections 153B and 295A of Indian Penal Code.

Mr. Kumar had recently made a series of social media posts critical of Brahminism, arguing that it is negation of the spirit of liberty, equality and fraternity.

The controversy began

with Kannada actor Upenendra posting a video on social media and Mr. Kumar's response to it.

In the video, Mr. Upenendra appealed to people to not talk of caste as it would only perpetuate it further. Mr. Kumar responded with another video in which he denounced Brahminism as the root of caste inequality in India. In the same video, he clarified that he was not against Brahmins as a community but against "Brahminism", which he said had crept into all communities and even other religions.

Appeal for CBI probe into rosewood felling in Kerala

'Given the complicity of govt. officials, SIT inquiry farcical'

While the illegal felling of centuries-old rosewood trees in Wayanad roils the Kerala Assembly, environmental organisations in the district have sought an investigation by the Vigilance wing of the police or the CBI under the supervision of the High Court. The State government has set up a Special Investigation Team to probe the incident.

"The massive felling of ancient rosewood trees in Wayanad by misinterpreting a government order by the timber lobby, with the alleged support of a group of top brass at the Secretariat and the Forest Department, is not an isolated incident," said N. Badusha, president, Wayanad Prarthuthi Samrakshana Samiti, in a memorandum submitted to Union Environment Minister Pra-

kash Javadekar, Minister of State for External Affairs V. Muraleedharan and Chief Minister Pinarayi Vijayan.

Since the involvement of officials of the Revenue and Forest departments and top leaders of political parties was suspected, an investigation by lower rank officials would make the probe farcical, he added.

The government order is-

sued by the Revenue Secretary on October 24, 2020, for felling rosewood trees on revenue land assigned for farmers was illegal, said Mr. Badusha. The silence of the senior officials in the Forest Department, despite getting a copy of the order the very next day, was inexplicable, he added. The District Public Prosecutor had advised the Wayanad District Collector and South Wayanad Divisional Forest Officer on January 12 that the felling was illegal. However, no steps were taken to prevent the loot, said Mr. Badusha.

Though the tree felling was stopped later, the accused, including Anto Augustine, Roji Augustine, and Josekutty Augustine, were yet to be arrested. Instead, officials filed a police complaint against 68 farmers three days ago, when the issue came to light, he said.

Powai lake overflows due to heavy rains

With heavy rains lashing Mumbai, Powai lake started overflowing on Saturday afternoon, an official from the Brihanmumbai Municipal Corporation (BMC) said. Water from the lake, which has a capacity of 545 crore litres, is used for industrial purposes and it flows into Mithi river. The lake had last overflowed on July 5, 2020.

When the lake is full, the water area is around 2.23 sq km, while the catchment area is 6.61 sq km. Mumbai has been receiving heavy rainfall and the India Meteorological Department (IMD) has issued a red alert for the city on Sunday and an orange alert for Monday.

The BMC issued a "high alert" to all agencies considering "very heavy rainfall" in the next two days. Seven reservoirs — Bhatsa, Upper Vaitarna, Middle Vaitarna, Tansa, Modak Sagar, Vihar, and Tulsi — supply 385 crore litres of water to the city.

A year on, over 17,000 treated at Navi Mumbai's COVID centre

NMMC plans to build an oxygen plant for the jumbo facility to make it more capable of handling the third wave

A total of 17,023 COVID-19 patients have so far received treatment at the COVID Care Centre (CCC) set up by the Navi Mumbai Municipal Corporation (NMMC) at the CIDCO Exhibition Centre in Vashi.

The CCC was set up in a record time of 20 days after work commenced on May 20, 2020. The facility became operational on June 11 when 61 patients were admitted to the 1,150-bed facility. On July 11, the first phase of providing oxygen support to 500 beds was completed and by August, all beds had oxygen support. When the second wave struck the city, 75 more ICU beds were added with 40% ventilator capacity. While the CCC has an X-ray

ed 341 paediatric patients, all of whom have fully recovered. "Children from the age of one have been admitted here along with their mothers," Dr. Vasant Mane, who has been in-charge of the facility since the start of operations, said.

Yoga sessions, library

Dr. Mane said regular yoga sessions were conducted for the patients and a library was added to the facility recently. He said the facility admitted patients both from poor families, who could not afford treat-

ment at private hospitals, and affluent families during both waves of the pandemic.

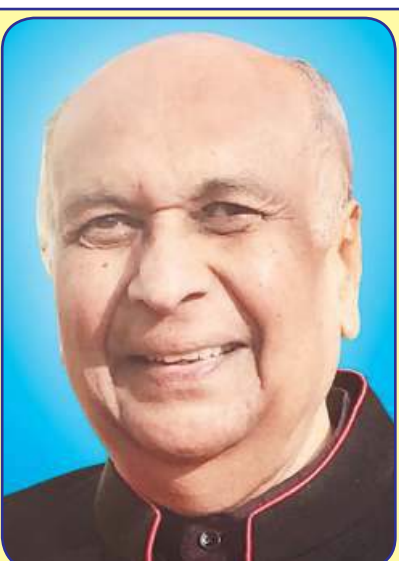
Dr. Mane said, "An IAS officer's sister and her husband did not find beds at a private hospital and were provided admission at our facility. A few days into treatment, they found beds at a private hospital, but were so happy being at the centre that they refused to seek treatment elsewhere."

'Boon to the city'

According to NMMC Commissioner Abhijit Bangar, the jumbo facility has been a boon to the city. "Going forward, we will be adding more beds, equipment, and an oxygen plant to make the centre more capable of handling the third wave," Mr. Bangar said.

SAD, BSP to jointly contest Punjab polls

Alliance will last beyond next year's election, says Badal

As the battle for the upcoming Assembly election in Punjab gains momentum, the Shiromani Akali Dal (SAD) and the Bahujan Samaj Party (BSP) joined hands on Saturday to contest the polls due in the State in early 2022.

SAD president Sukhbir Singh Badal and BSP national general secretary Satish Chandra Mishra made an announcement in this regard here.

"Under the seat-sharing arrangement, the SAD will contest 97 seats and the BSP 20 — eight seats in the Doaba region, seven in Malwa and five in Majha region of the State," Mr. Badal said here at

a press conference. There are a total of 117 Assembly constituencies in Punjab.

Mr. Badal said the alliance was not a temporary one and would remain intact as both parties will contest not just the upcoming Assembly poll but other elections to-

gether as well. "Both the SAD and the BSP have the same ideology and had always worked for the welfare of farmers, poor and farm labourers," he added.

Hitting out at the ruling Congress government, Mr. Badal said: "The Congress party has not initiated a single welfare scheme for the weaker sections and is instead responsible for closing down schemes such as the SC scholarship scheme. It was because of these factors that there was a demand from the grassroots level workers of both the SAD and the BSP to form a common front."

He thanked BSP president Mayawati for her decision to join forces with the SAD.

JD(U) should get a berth in Cabinet'

Bihar CM Nitish Kumar had earlier sought proportional representation

Amid talk of expansion of Prime Minister Narendra Modi's Cabinet, the BJP's ruling alliance partner in Bihar, the Janata Dal (United), said on Saturday that every constituent of the National Democratic Alliance (NDA) should be represented at the Centre.

Speaking to mediapersons in Patna, JD(U) national president R.C.P. Singh said: "I too have come to know about the Cabinet expansion of the Union government. Every constituent of the NDA should get participation in the Cabinet. And, being an ally, the JD(U) too should naturally get a berth in the Central Cabinet. In an alliance, every constituent should be respected."

The buzz in political circles is that the Modi Cabinet

would be expanded before the monsoon session of Parliament.

Earlier in May 2019, Chief Minister and then JD(U) president and Nitish Kumar had said his party would not be part of the NDA government as the BJP's offer was only "symbolic representation".

"They [the BJP] said they want to give one Cabinet rank to every ally. Then we said that we will discuss it with party members and then only we can say anything

over this symbolic representation. I spoke to my party leaders and the unanimous view was that we should stay out of the Ministry. Everybody felt there should be proportional representation in an alliance government," Mr. Kumar had said after the oath-taking ceremony of the Union Cabinet of NDA-2.

Mr. Singh, Mr. Kumar's close confidant, had been among the frontrunners for a Cabinet berth at that time.

The Bihar Chief Minister was said to have insisted on "proportional representation" for his party in the Union Cabinet.

In the 2019 Lok Sabha election, the JD(U) won 16 of the total 40 seats in Bihar, while the BJP got 17 seats. The JD(U) has also six members in the Rajya Sabha.

Now, after Mr. Singh's comment, names of three JD(U) leaders have started floating as probables for the Union Cabinet.

Besides, party president R.C.P. Singh, names of MPs Rajiv Ranjan Singh, alias Lalan Singh (Munger) and Santosh Kumar Kushwaha (Purnia) are also doing the rounds. However, NDA leaders declined to comment on the issue.

"Only party's top leadership can say anything on this," they said.

Row over Digvijaya's comments

A row erupted on Saturday over Congress leader Digvijaya Singh's purported comments in an audio chat on social media that his party will have a "relook" at Article 370 revocation and Jammu and Kashmir's lost statehood if it returns to power, with the BJP accusing him of speaking "the language of Pakistan" and spewing venom against India.

Mr. Singh's remarks to a person, who the BJP said was a journalist of Pakistani origin, were seized by its leaders to unleash a torrent of criticism against the opposition party and demand statements from Congress president Sonia Gandhi and her son Rahul Gandhi on the issue.

"The decision of revoking Article 370 and reducing the statehood of J&K is extremely, I would say, sad decision, and the Congress party would certainly have a relook on the issue," Mr. Singh said, according to excerpts of the Clubhouse conversation available on social media.

He was responding to a question about the "way forward" on the issue "once the Modi government is gone".

"It was the Congress which committed the sin of imposing Article 370 in Kashmir...Congress speaks the language of Pakistan," Madhya Pradesh Chief Minister Shivraj Singh Chouhan said.

Onus of dialogue on J&K lies with Centre: Gupkar alliance

There has to be credible agenda for engagement: Tarigami

CPI(M) leader and Gupkar alliance spokesman M.Y. Tarigami on Saturday said the onus of engagement and dialogue lay with the Centre and there had to be a credible agenda for it.

"Have we [J&K parties], together or separately, ever obstructed any dialogue since August 5, 2019 [when the Centre ended the special status]? In fact, on August 4, 2019, we appealed to the Prime Minister to provide us a chance to be heard but instead the leaders were placed in preventive custody. The onus of engagement and dialogue now lies with

the government of India," Mr. Tarigami said, in an interview to *The Hindu*.

Mr. Tarigami, who is also a spokesman for the amalgam of five political parties, said no one had approached the group so far. "J&K has seen a major assault without consulting its political class, civil society, traders, etc. We remain a deprived lot," he added. Dropping broad hints at being open to engage New Delhi 22 months after the abrogation of J&K's special constitutional position, Mr. Tarigami said, "It's the Centre that obstructed the processes of debate, discussion and dialogue and it [the Centre] should come up

with a credible agenda for engagement."

In a veiled demand, Mr. Tarigami said the Centre reduced J&K to a Union Territory and there was no harm to restore the status of statehood unilaterally. "Both the Prime Minister and the Home Minister had publicly promised to return statehood to J&K at an appropriate time," he pointed out.

He said it was unfortunate to see Prime Minister Narendra Modi becoming adamant on Kashmir. "It does not suit the PM and his stature. He is the leader of the country and should hear and respond to people's demands," he added.

Now, Rajib Banerjee reaches out to Trinamool leadership

BJP leader reiterates his displeasure with the party

A day after Mukul Roy severed ties with the Bharatiya Janata Party and joined the Trinamool Congress, another key BJP leader, Rajib Banerjee, reached out to Trinamool Congress spokesperson Kunal Ghosh on Saturday.

Mr. Banerjee, a former Minister in the Trinamool Congress government, who contested and lost the Assembly polls on a BJP ticket, met Mr. Ghosh at his residence in Kolkata. Though he described his meeting as a "courtesy call", Mr. Banerjee reiterated his displeasure with the BJP and said he maintained that it was not proper to threaten a government that has won such a massive majority with the imposition of President's Rule under Article 356.

Mr. Banerjee was one of the BJP's prize catches before the Assembly polls and

the party had sent a private jet so that he and a few other leaders could travel to Delhi and join the BJP. He contested from Domjur and lost by a margin of over 40,000 votes. Mr. Banerjee maintained that "he was with the BJP till now", but also added the politics of religious division won't succeed in the State of West Bengal. Like Mr. Roy, Mr. Banerjee has been absent at meetings of the West Bengal BJP after the results of the Assembly polls were declared.

There were frantic political developments in the day, with reports of Mr. Roy try-

ing to reach out to a number of BJP leaders and MLAs. Biswajit Das, BJP MLA from Bagda, also praised Mr. Roy and stated that he respected Chief Minister Mamata Banerjee. Mr. Roy hails from North 24 Parganas and is said to have considerable influence in the district. Sources in the BJP said Mr. Roy had reached out to several BJP MLAs, both in south Bengal and north Bengal.

During the day Mr. Roy also met TMC general secretary Abhishek Banerjee at his office. On Friday, the 67-year-old former Railway Minister had joined the TMC in the presence of Ms. Banerjee after his 3-year-7-month stint as a BJP leader.

"We are not worried about committed workers [because they will stay in the party]. The defectors ('aaya Ram, gaya Ram') do not make much difference," State BJP president Dilip Ghosh said.

Modi govt. has failed on every front: Priyanka

Congress general secretary Priyanka Gandhi Vadra, in a scathing attack on Prime Minister Narendra Modi on Saturday over his handling of the COVID-19 pandemic, said he behaved like a "coward".

"Indians do not come first for the Prime Minister, politics does," Ms. Vadra alleged in a social media post as part of her *Zimmedar Kaun* (Who's responsible?) campaign.

"The government failed us in every front. They could have managed the situation so that we could have had enough oxygen in the hospitals; they could have listened to experts and increased the number of beds; they could have ordered vaccines when other countries ordered them, back in June, July and May, 2020. They did none of this and just left people to fend for themselves," Ms. Vadra said posting a 39-second video.

Cong. working to unite rival Rajasthan factions

Differences over Ministerial berths to Pilot camp holding up Cabinet expansion

The Congress party's top leadership is working on a formula to bring the rival factions of Chief Minister Ashok Gehlot and former deputy chief minister Sachin Pilot to a compromise, but differences over the number of Ministerial portfolios to be allotted to the Pilot camp is holding up the expansion of the State government in Rajasthan, a highly placed source said on Saturday.

However, contrary to media reports, there were no meetings between Mr. Pilot, who arrived in Delhi late on Friday evening, and the cen-

tral leadership, on the issue of Cabinet expansion.

Of the nine available Ministerial slots in the State Cabinet, the source cited above told *The Hindu* that the Pilot camp expected six-seven positions. They argue that this was what was promised to them by the late Ahmed Patel, one of the key negotiators with Mr. Pilot when the latter had revolted against Mr. Gehlot in July 2020.

After Mr. Pilot led an unsuccessful rebellion against Mr. Gehlot last July, his camp lost three slots, including Mr. Pilot's position as the deputy CM. The Pilot camp had then complained that the Chief

Minister had kept far too many portfolios with himself.

But the Congress party's central leadership has to proceed cautiously as the Gehlot government has to keep in mind 18 lawmakers — 12 independent MLAs and six former Bahujan Samaj Party MLAs who merged with the Congress — who also expect to be "rewarded" by the Gehlot government.

"Once both sides agree to a number, the next stage of identifying the Ministries and the criteria to become Ministers won't be a problem," said a senior Rajasthan leader.

This leader said that the criteria to become a Minister would include seniority of the MLAs as well as the caste and region they represent.

"We not only have to ensure no first time MLA from the Sachin camp becomes a Minister as we have more than half a dozen MLAs who have won five-six terms, it is also important that the new Cabinet represents the State in terms of regions and castes," he said.

On Friday, All India Congress Committee in-charge Ajay Maken had asserted that there would soon be an expansion of the Ashok Gehlot government but hadn't spelt out a specific timeline.

INTERVIEW | BRANKO MILANOVIC

'No trade-off between lives and livelihoods in the long run'

India has a problem that is different to and deeper than the problem that the rich countries have, says a former lead economist of the World Bank

As the world stumbles through a second year of the COVID-19 pandemic, it is clear that both its catastrophic toll on human life and the severe socio-economic dislocation it has caused matter equally. Yet there is growing inequality associated with governments' and private citizens' responses to the pandemic regarding access to vaccines and policies to support vulnerable groups. Professor Branko Milanovic, of the Stone Center on Socio-Economic Inequality at the City University of New York, and former lead economist in the World Bank's Research Department for almost 20 years, share his perspective on the relationship between inequality and different forms of capitalism across the world.

You have for decades studied capitalism, analysing its sub-types – liberal and political capitalisms – in your 2019 book 'Capitalism Alone.' The pandemic has thrown its features into relief. How would you describe the way capitalist systems across the world have responded to this global crisis?

■ If I were to summarise now the situation, I would say that both the U.S. and China have played up to their

strong suits, and really have played very miserably in the areas where they were weak.

China did a pretty bad job in the beginning, not because it did not stop the pandemic immediately, but because the political system in China is such that lower levels of administrative units, in this particular case the province of Hubei and the city of Wuhan, had an incentive to not reveal what was happening to the higher authorities hoping that actually they will be somehow

able to push it under the carpet. That proved to be a disastrous decision. Then, the good side of the Chinese system kicked in, in their ability to share very strong centralised decisions, to have a disciplined population, to implement draconian measures quickly and to have everybody or most mostly everybody agree to that.

The U.S. [response] also has two sides. The negative side was the total disarray, which is not only due to the Trump administration, but general inability to impose any measures, sniping between different levels of government, whether it is the federal, state, or county governments. That's why the U.S. still has the highest number of deaths and cases.

But on the other hand, the technology of the U.S. and Western Europe kicked in and the success in vaccines was absolutely extraordinary. It has never been the

case that in 12 months, we have actually developed a vaccine for an entirely new disease and the rollout of the vaccines in the U.S. was quite successful.

Vaccine shortages have hobbled India's battle against the coronavirus with

deadly consequences during the second wave. Is this a case of domestic inequality getting exacerbated by global inequality?

■ In India's case we have to be a little bit careful. If we had this conversation in February, India was actually considered a success case compared to the expectations, which were actually quite dire for India, taking into account what happened in 1918, and the fact that is an enormous country with many people living in close proximity.

But that's the issue with the virus – whatever you say now, three months later, that turns out that you've been half wrong. Now the situation in India is improving. But it was, as you mentioned, disastrous only months ago.

It could be said that the disregard by the government of the dangers of the virus coming back, and maybe the

disregard by the people who believed that the virus was behind them, led to the catastrophe that we have witnessed in the last two months.

While mRNA vaccines are seen as cutting edge, and they've been largely deployed in the U.S. and parts of Europe and the U.K., India has not had that.

■ This is the result of what is called vaccine nationalism in the U.S., U.K. and to a much less extent Europe. These countries have decided that they are not going to export vaccines until they have finished vaccination at home. This shows the talk about cosmopolitan approaches and everybody being equal to be wrong.

Is India doing enough by way of welfare measures to support those who otherwise lack a safety net during economic shocks

associated with the pandemic?

■ India has a problem that is different to and deeper than the problem that the rich countries have. Rich countries such as the U.S. and Europe have been able to go through massive stimulus packages and the support packages, which have never been seen in history. It is much more difficult for countries that do not have resources like that. India could have printed that money, but then you have other issues to face.

Second, the poor population in India is huge. But it was pointed out from very early on that the lockdowns are not really a trade-off in the sense that the lockdowns were saving lives and enabling a relatively fast return to economic activity. There is a trade-off on a daily basis but if you maybe extend it to one or two months, the trade-off disappeared.

Does India's model of capitalism fall between the liberal capitalism of the West and the political capitalism of China, and if so, will it continue to face challenges of inequality and corruption?

■ It's not by accident that India had a Planning Commission, given the very strong influence of the Soviet Union in the organisation of the economic sphere, in terms of planning the economy so as to be able to grow faster. That was the similarity which India had in the past. If you look at India today, it is much closer to liberal capitalism because of this political system.

But it is also true that under [Prime Minister Narendra] Modi, there are certain features that really make India [akin to] hybrid liberal capitalism, [including] the general emphasis on growth, and disregard of certain democratic norms.

Expand GST waiver, urges Punjab Minister

'It should apply to all COVID-19 goods'

Punjab's Finance and Planning Minister Manpreet Singh Badal questioned the GST Council's decision to temporarily cut tax rates on COVID-19 essentials instead of waiving them altogether and asked if COVID-19 is going to end in sync with the tax concession deadlines.

Demanding that all COVID-related goods be zero-rated during the pandemic, Mr. Badal, along with other Finance Ministers representing the Congress, vehemently opposed the imposition of GST on COVID-related items and recorded their note of dissent.

He also reiterated the Congress' concerns about no representative from the party being included in the GST Council's Group of Ministers (GoM) that reviewed the tax rates on COVID-19 essentials. Finance Minister Nirmala Sitharaman dismissed the charge saying that GoM members are not selected or excluded on the basis of 'party'.

The GoM should "stop acting like a shahenshah (emperor) amid a once in a century crisis", Mr. Badal said.

"COVID-19 GST should be zero-rated... How would a consumer feel seeing GST reflected on an invoice on COVID-19 treatment?" he remarked, terming the retention of GST levies on several preventive material and treatment essentials as "in-

sensitive". While the Council exempted two medicines – tocilizumab and amphotericin-B – from GST altogether, other medicines and goods such as masks, PPE kits, hand sanitisers as well as medical grade oxygen, testing kits, ventilators, BiPAP machines and pulse oximeters continue to be taxed at a lower 5% rate.

"Stop collecting revenues on furnaces for crematoriums. Stop taxing RT-PCR machines. They are already purchased at concessional rate, and practically all States also regulate the price of the COVID-19 test," he pointed out.

"It is preposterous that the principal opposition party of India in both the Lok Sabha and the Rajya Sabha has been excluded in the GoM," Mr. Badal said.

Mr. Badal cautioned that the attempt to pick and choose exemptions on the grounds of inverted duty structure or cheaper imports would end up destroying the very foundation of GST.

Voices muzzled, says Bengal FM

Amit Mitra sends dissent note after GST Council meet

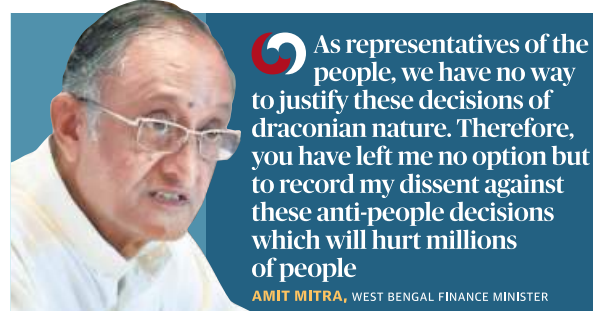

Terming the GST Council's move to retain tax levies on COVID relief materials as a 'totally anti-people decision' that was 'thrust' upon members, West Bengal Finance Minister Amit Mitra accused the Union Finance Ministry of muzzling his voice in the Council, in a strongly worded dissent note.

Mr. Mitra said he repeatedly tried to voice objections after Finance Minister Nirmala Sitharaman announced the Council's decision as its chairperson, but "the Secretary brought the meeting to a close and the virtual link was cut off".

"Whither GST Council?" Mr. Mitra remarked in a missive addressed to Ms. Sitharaman, marked to all State Finance Ministers.

The West Bengal Finance Minister said that he, along with several Ministers, proposed zero-rating or imposing a 0.1% GST on COVID related materials for a limited period, keeping the likely

third wave of infections in mind. Even former Bihar Finance Minister Sushil Kumar Modi, now a BJP MP in the Rajya Sabha, has recommended a 0.1% GST as a solution "cutting across party lines", Mr. Mitra said.

"Unfortunately, you decided not to agree with the suggestions of so many Ministers," the West Bengal Minister told the Union Finance Minister. "The GST Council was to consider providing significant relief to the sufferings of the common people and the struggling health infrastructure... The consumers of the COVID materials in this hour of need would be greatly benefited with only a 0.1% GST," he wrote.

"As representatives of the people, we have no way to justify these decisions of dra-

conian nature. Therefore, you have left me no option but to record my dissent against these anti-people decisions which will hurt millions of people," he emphasised.

Mr. Mitra said that Ms. Sitharaman referred to several of his observations towards the end of the Council's meeting, but he was not allowed to respond.

"Instead, you gave the floor to the Minister from Uttar Pradesh, who sought deletion of some of my comments by name and shockingly, you agreed. I could never imagine that this would come to pass in a GST Council meeting where my voice is muzzled, despite the restraint and decorum I have maintained in 44 meetings of the Council," the Minister added.

Anurag Thakur blames 'poor connection'

Union Minister of State for Finance Anurag Thakur said it seemed as if West Bengal Finance Minister Amit Mitra, who said his voice was muzzled at Saturday's GST Council meeting, did not have a 'stable VC connection' for the meeting.

"Revenue Secretary (Tarun Bajaj) repeatedly informed him his line was breaking, that he was not properly audible and to turn off his video for better connectivity," Mr. Thakur said in a series of tweets.

"During the speech made by the Uttar Pradesh Finance Minister, nobody heard Dr Mitra ji speak nor did he ask to have his opinion heard. Other members can attest to this," Mr. Thakur asserted.

"The Finance Minister has never stifled dissent in the GST Council," Mr. Thakur added.

IMA to hold protest on June 18

The Indian Medical Association will hold a protest on June 18 against assault on doctors.

In a statement, the apex medical body asked all its State and local branches across the country to observe the protest, with the slogan of 'save the saviours', by wearing black badges, masks, ribbons and shirts and running an awareness campaign against violence targeting healthcare professionals.

The IMA said press conferences will also be organised, and they will also meet local NGOs and voluntary service leaders.

It termed "extremely disturbing" a series of violence against doctors in the past two weeks in Assam, Bihar, West Bengal, Delhi, Uttar Pradesh, Karnataka and other places.

It demanded the implementation of the Central Hospital and Health Care Professionals Protection Act with the Indian Penal Code and the Code of Criminal Procedure, standardisation and augmentation of security in each hospital, and declaring hospitals as protected zones, among others. It further said that June 15 will be observed as a National Demand Day and press meets will held across the country.

Claims of CoWIN hacking and data leak are baseless: Centre

The government on Saturday dismissed the claims of hacking of the CoWIN portal, which facilitates the national COVID-19 vaccination drive, and data leak as "baseless".

In a statement, the Union Health Ministry said the matter of the alleged hacking of the Co-WIN system has been investigated by the Computer Emergency Response Team of the Union Ministry of Electronics and Information Technology.

R.S. Sharma, Chairman of the Empowered Group on Vaccine Administration, clarified that "the claims of so-called hackers on the dark web, relating to alleged hacking of the Co-WIN system and data leak, is baseless."

Outwitting the virus

"Antibodies for COVID target specific proteins and destroy them before they initiate inflammation, which causes worsening of symptoms like breathlessness, blood clotting and severe pneumonia. In simple words, antibody response, which takes 7-10 days after infection, gives the virus the window period to attack the body. This window period is covered by injecting mono-

clonal antibodies, which help in reducing the symptoms and disease progression," said Dr. Budhreja.

In the national capital, the therapy was successfully used in two patients recently – a 36-year-old healthcare worker and an 80-year-old male at the Sir Ganga Ram Hospital. According to the doctors here, both patients showed improvement within 12 hours of administering the treatment.

Treating physician Pooja Khosla, senior consultant, Department of Medicine, Sir Ganga Ram Hospital, said that the two patients were administered REG-Cov2 (Casirivimab and Imdevimab), designed to produce resistance against the SARS-CoV-2 coronavirus.

"Monoclonal antibody treatment isn't a one-size-fits-all therapy. It is to be given only to mild COVID-19 patients who are not requiring oxygen, and there is high risk of progression or hospitalisation due to existing comorbidities," warns Akshay Budhreja, senior pulmonologist, Aakash Healthcare.

"The doctor added that monoclonal antibody therapy cost ₹60,000-70,000 and significantly reduced hospital stay.

"The key principle while using the therapy was that it should be given at the right time to the high risk group," she said.

72,899 cases, 1,558 deaths recorded

Tamil Nadu reports highest number of infections followed by Kerala, Maharashtra

India recorded 72,899 COVID-19 cases and 1,558 deaths till 9.30 p.m. on Saturday. The country has so far reported 2,94,63,255 cases and 3,69,135 deaths.

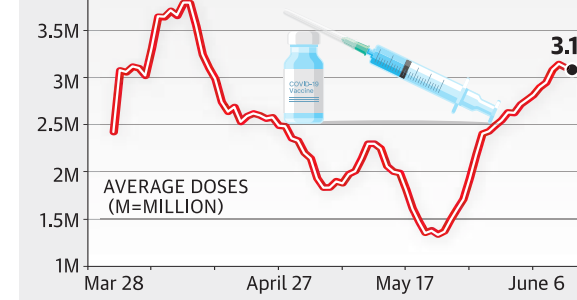
Tamil Nadu reported 15,108 new infections, followed by Kerala (13,832) and Maharashtra (10,697). Maharashtra recorded 1,966 new fatalities, followed by Tamil Nadu (374) and Kerala (171). Maharashtra's fatalities include backlog deaths which were missed in the previous reports.

The figures do not include cases and deaths from Punjab, Odisha, Arunachal Pradesh, Chhattisgarh, Jharkhand, Tripura, and Ladakh. The data is sourced from the respective States' health bulletins.

India's average daily COVID-19 vaccination rate has improved significantly from the dip observed in May. An average of 3.1 million doses was administered on June 11



ples were tested on Friday (the results for which were made available on Saturday).

About 34.33 lakh vaccine doses were administered in the 24 hours ending 7 a.m. on Saturday, which is nearly 1.6 lakh doses more than what was recorded in the

previous 24 hours. However, it is 2.16 lakh fewer than what was recorded during the corresponding period a week ago. The seven-day rolling average of daily vaccinations continues to increase. It stood at 29.96 lakh on June 12, which is more

than the 26.42 lakh recorded a week before (June 5).

Vaccine doses

About 21.6% of adults, 42% of those aged above 45, and 45.8% of people aged above 60, have been administered at least one dose of vaccine until 8.30 p.m. on Saturday. While 14.9% of the population has received at least one dose, only 3.4% are fully vaccinated. The figures are based on the estimated population in 2021.

The share of people who are fully vaccinated in comparable economies such as Brazil, Russia and South Africa is 11.07%, 9.59% and 0.81% respectively. Among the neighbours, 2.57% of Bangladesh's population is fully vaccinated while the figure for Pakistan and Sri Lanka stood at 1.15% and 1.81% respectively.

Covaxin: data on Phase 3 trial out soon

Bharat Biotech on Saturday said scientific standards of the indigenously-developed Covaxin are transparent, and the company has so far published nine research studies on its safety and efficacy.

"Covaxin's scientific standards+commitment is transparent. Academic journals, peer reviewers, NIV-ICMR-BB researchers-scientists, 9 studies & data published," Bharat Biotech co-founder and joint managing director Suchitra Ella said in a tweet. "Currently, data from both efficacy and safety follow-up of Covaxin's Phase III trial is being analysed and compiled. The company will make the data from the final analysis public soon," Bharat Biotech said in a statement.

PLA campaign highlights LAC actions

Ahead of CPC centenary, soldiers to present China's flag 'raised on Pangong Lake' during nationwide tour

China's People's Liberation Army (PLA) has begun a domestic campaign ahead of the ruling Communist Party's July 1 centenary in which it is highlighting last year's actions of its border defence troops along the Line of Actual Control (LAC), specifically in Pangong Lake, as part of a broader push to underline the military's firm support to President Xi Jinping.

Under the campaign, two groups of eight "youth role models", a mix of military and students, are visiting colleges and universities across China. The group is being organised by the Central Military Commission's Political Work Department and the Party's Youth League. The group includes "elite and skilled" PLA soldiers, including some stationed in units along the LAC, along with "anti-epidemic pioneers, elite female coastguards and scientists dedicated to polar region research", the military said.

As part of the campaign, the soldiers are presenting

China's national flag "once raised on Pangong Lake", a key site of tensions in 2020, at various military units and educational institutions as they tour the country.

Two-fold message

The aim is "to learn and internalise the spirit of President Xi's important speech delivered during his recent visit to Tsinghua University and to celebrate the 100th anniversary of the founding of the Communist Party of China," the PLA said. Mr. Xi had, in his speech, "encouraged young people to rise up

to the mission of national rejuvenation".

The campaign appears aimed at delivering a two-fold message targeted more at a domestic audience than abroad: to declare the military's unequivocal support to Mr. Xi, and to also send a message of patriotism ahead of the July 1 anniversary. The PLA is unique among militaries in serving, first and foremost, a political party and not a state, and political education is a key part of military training in China.

The PLA's actions during the LAC tensions of 2020 ap-

pear to be figuring prominently in the campaign. Four service members of "the border defence troops in the Karakoram went to visit several military or civilian units to share their stories of guarding the border and defending the motherland," PLA spokesperson and Senior Colonel Tan Keifei said at his monthly briefing last month, announcing the campaign.

An "emphasis of combat readiness" was part of the message. "One group of the role models went to the coastal regions in southeast China, and the other group went to the Gobi Desert in northwest China, where they boarded fighting vehicles and warships, visited squads and border sentry posts," he said. "They went to combat positions and training grounds, where they joined the service members in training and guard duty, providing professional knowledge counselling and skill training to soldiers. The Karakoram border defence troops presented the Chinese national flag once raised on the Pangong Lake to the National Flag Guards,

a way of conveying their enthusiasm for defending the motherland."

The PLA spokesperson referred to the campaign highlighting a message to promote what he called the "Karakoram spirit", that was "characterised by devotion to border defence, hard work, selfless dedication and tenacity".

The LAC tensions, which began in late April and early May 2020, culminated in a clash on June 15, 2020 in the Galwan Valley, which marked the worst violence along the border since 1967. Both sides have since disengaged in Galwan Valley and on the north and south banks of Pangong Lake, but talks have remained stalled in other areas, including Depsang, Demchok, Gogra and Hot Springs. Indian officials have said the disengagement process remains partially completed and the de-induction process of troops still deployed in forward areas near the LAC, a key measure to restore normalcy, is yet to take place more than a year after the tensions began.

China, U.S. diplomats clash over human rights, pandemic origin

Top U.S. and Chinese diplomats appear to have had another sharply worded exchange, with Beijing saying it told the U.S. to cease interfering in its internal affairs.

Senior Chinese foreign policy adviser Yang Jiechi and Secretary of State Antony Blinken held a phone call on Friday that revealed wide divisions in a number of con-

tentious areas, including the curtailing of freedoms in Hong Kong and the mass detention of Muslims in the Xinjiang region.

The State Department said Mr. Blinken "stressed the importance of cooperation" regarding the origin of the virus, including the need for (World Health Organization) Phase 2 expert-led studies in China.

China is sensitive about

calls for investigation into the origin of the SARS-CoV-2 because of suggestions that it might have escaped from a laboratory in Wuhan, where cases were first discovered.

China "firmly opposes any despicable acts that use the epidemic as an excuse to slander China and to shift blames," Mr. Yang was quoted as saying by the official Xinhua News Agency.

Putin hopes Biden is not impulsive like Trump

Russian President Vladimir Putin voiced hope on Friday that U.S. President Joe Biden will be less impulsive than his predecessor Donald Trump, ahead of his first summit with the U.S. leader.

Mr. Putin described Mr. Biden as a "career man", who has spent his life in politics.

Though he described relations with the U.S. as hav-

ing "deteriorated to its lowest point in recent years," Mr. Putin said he expects he can work with Mr. Biden.

"It is my great hope that, yes, there are some advantages, some disadvantages, but there will not be any impulse-based movements on behalf of the sitting U.S. President," he said, adding that, "I believe that former U.S. President Trump is an extraordinary individual, talented individual."

G7 leaders take on China, plan to stop new pandemics

They pledge huge infrastructure investment to counter BRI

The G7 on Saturday unveiled U.S.-led plans to counter China in infrastructure funding for poorer nations, and a new accord to prevent future pandemics, as the elite group sought to showcase Western unity at its first in-person summit since 2019.

Promising to "collectively catalyse" hundreds of billions of infrastructure investment for low- and middle-income countries, the G7 leaders said they would offer a "values-driven, high-standard and transparent" partnership.

Their "Build Back Better World" (B3W) project is aimed at competing with China's trillion-dollar Belt and Road infrastructure (BRI) initiative, which has been widely criticised for saddling countries with unmanageable debt but has included even G7 member Italy since launching in 2013.

The White House said President Joe Biden and fellow leaders addressed "stra-

tegic competition" with Beijing on the second day of their three-day summit in Carbis Bay, southwest England.

Meanwhile, Britain hailed G7 agreement on the "Carbis Bay Declaration" - a series of commitments to curb future pandemics after COVID-19 wrecked economies and killed millions around the world.

The collective steps include slashing the time taken to develop and license vaccines, treatments and diagnostics for any future disease to under 100 days,

while reinforcing global surveillance networks.

The G7 - Britain, Canada, France, Germany, Italy, Japan and the U.S. - will formally publish the pact on Sunday.

German Chancellor Angela Merkel called it an "important initiative". "We can't sit back and say that China will do it but it's the G7's ambition to have a positive agenda for a number of countries in the world which are still lagging behind... I welcome it," she said.

British PM warns EU over post-Brexit trade in N. Ireland

U.K. Prime Minister Boris Johnson on Saturday warned Europe he would suspend a deal for post-Brexit trading arrangements in Northern Ireland unless a solution could be found to a row over border checks.

Brussels has been angered by London's failure to introduce checks on goods heading across the Irish Sea

from the mainland U.K. - England, Scotland and Wales - to the province of Northern Ireland.

European leaders delivered an ultimatum to Mr. Johnson on the sidelines of G7 summit, urging him to keep his word and implement the Northern Ireland "protocol", which was signed separately from a trade deal between them.

But Mr. Johnson defiantly

restated his calls for the EU to compromise, urging a more pragmatic approach after talks on the issue broke down earlier this week.

He said he was not prepared to endanger the territorial integrity of the U.K., and would "not hesitate to invoke Article 16" of the protocol, suspending its application.

"We need to sort it out," he told Sky News.

Riyadh limits Hajj to 60,000 vaccinated

Saudi Arabia announced Saturday it will allow 60,000 residents vaccinated against COVID-19 to perform this year's hajj, but Muslims from abroad will be barred for a second straight year.

The hajj - a must for able-bodied Muslims at least once in their lives - typically packs millions of pilgrims into congested religious sites and could be a major source of contagion amid the coronavirus pandemic.

This year it would be "open for nationals and residents of the Kingdom, limited to 60,000 pilgrims", the hajj ministry said, quoted by the official Saudi Press Agency.

The pilgrimage, scheduled to be held in July, would be limited to those who have been vaccinated and are aged 18-65 with no chronic illnesses, it said.

Security of airports, embassies Afghan responsibility: Taliban

Turkey was ready to keep troops at Kabul airport: reports

Foreign forces should hold "no hope" of keeping a military presence in Afghanistan after the U.S. and NATO withdraw troops, the Taliban said on Saturday, warning the security of embassies and airports would be the responsibility of Afghans.

It comes as western diplomats and military officials scramble to work out how to provide security for any future civilian presence they keep in the country.

Turkey has reportedly said it is prepared to keep troops in Afghanistan to protect Kabul airport, the main exit route for western diplomats and humanitarian workers.

"Every inch of Afghan soil, its airports and security of foreign embassies and diplomatic offices is the responsibility of the Afghans,

consequently no one should hold out hope of keeping military or security presence in our country," a statement issued by the Taliban on Saturday said.

"If anyone does make such a mistake, the Afghan people and the Islamic Emirate shall view them as occupiers and shall take a stance against them," it added.

The United States is in the final stages of completing a military drawdown, along-

side NATO forces, by September 11 - twenty years after they invaded Afghanistan and toppled the Taliban.

The decision to end America's longest war has raised fears that an emboldened Taliban could topple the Western-backed government in Kabul.

The possibility of keeping troops in Afghanistan is expected to be discussed during a meeting of NATO leaders in Brussels on Monday.

NATO Secretary General Jens Stoltenberg said last month the alliance would provide funding to help run Kabul airport and train Afghanistan's special forces after it had left.

Turkish media later reported that Ankara was willing to maintain a presence in the country, including at the country's main gateway, if NATO provided financial support.

China's roaming jumbos are on the move again

China's famed wandering elephants are on the move again, heading southwest while a male who broke from the herd is still keeping his distance.

The group left a wildlife reserve in the southwest of Yunnan province more than

a year ago and has trekked 500 km north to the outskirts of the provincial capital of Kunming.

As of Saturday, they were spotted in Shijie township in the city of Yuxi, more than 8 km southwest of the Kunming suburb they had arrived at last week, according to state media reports.

Sri Lanka seeks \$40 mn in damages over ship fire

Vessel released tonnes of plastic waste

Sri Lanka is seeking \$40 million in damages from the operator of a ship that left massive pollution when it caught fire off the country's west coast, officials said on Saturday.

Ports and Shipping Minister Rohitha Abeygunawardena said an interim claim had been lodged with X-Press Feeders, which controls the Singapore-registered MV X-Press Pearl.

The vessel has been submerged in seas off Colombo since June 2 after burning for almost two weeks and releasing tonnes of plastic raw materials.

Environmentalists have

called it the "worst marine disaster" in the country's history.

"In addition to this (claim), we will also seek reimbursement of the cost of putting out the fire," Mr. Abeygunawardena said, adding that the full damage to the environment was still being assessed.

Sri Lanka has sought help from Australia in studying the impact on the local marine economy, which has been hit by a fishing ban imposed since the disaster.

Fisheries Minister Kanachana Wijesekera said the ban along an 80 km stretch of coastline was lifted on Saturday except for in the vicinity of the wreckage.

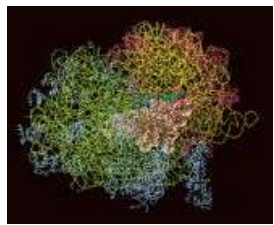

Great apes in peril

Will 25% vaccines for private hospitals aggravate inequity?

On June 7, when India announced a reversal of vaccine procurement to a system of centralised procurement with free vaccines to be provided for the 18-44 age group, it allowed 25% of vaccine procurement exclusively by the private sector. In an email to *The Hindu*, Dr. Gagandeep Kang, Professor of Microbiology at CMC Vellore, and Dr. Chandrakant Lahariya, physician-epidemiologist and a vaccine and health systems expert, discuss the ethical and structural challenges of setting aside 25% of vaccines for private hospitals.

Is it prudent to allocate 25% of vaccine supplies to private hospitals when there is shortage of vaccines? Does selling vaccines, and that too at a far higher price, go against the grain of the universal free vaccination programme that is needed during the pandemic?

Gagandeep Kang: The universal vaccination programme should provide for free vaccines to all. The goal of the immunisation programme should be clearly defined, whether it is prevention of severe disease or deaths, or restoration of the economy, or a calibrated mix of the two primary aims.

When there is a shortage of supply, groups of individuals that need to receive vaccines first should be clearly delineated in the prioritisation policy. Sometimes it is not possible to identify or address all priority groups in an initial listing.

In India, we have always followed a two-tiered structure for immunisation. The bulk of immunisation is provided by the public sector which reaches the length and breadth of the country. A smaller proportion of immunisation is provided by the private sector, on payment basis; a much wider range of vaccines are available for those who can afford to pay for them.

If it is decided, as it has been by the government, the private sector purchase of vaccines is justified then clearly selling vaccines follows prior practice. The difference is the shortage in supply, and the need to ensure the coverage required for the target population. It would have been useful to have

some guidance on the expected coverage that needed to be achieved before opening up to the private sector.

With regard to the pricing, the private sector has always charged a higher price for immunisation both for the purchase of the vaccine, which is determined by vaccine companies, and for the clinics and hospitals that deliver the vaccination.

Chandrakant Lahariya: The private sector has around 3-4% of total COVID-19 vaccination sites. Even if we factor in 'on the campus vaccination drives', which are being carried out by the private sector, the total vaccine requirement of the private sector is not more than 10% of the current availability. Therefore, allocation of 25% of available vaccines to the private sector is essentially cutting down the vaccine supply to the public sector facilities.

Moreover, allocating one-fourth of vaccination at an average 7-8-fold higher price (even if we factor in share of various vaccines); essentially means the total cost which people have to pay for vaccines would be around 1.75-2-fold higher than what the government would spend for three-fourths of the vaccine supply. At the vaccine sharing formula, of the total COVID-19 vaccine cost in India, two-thirds will be paid by the people. Then it becomes predominantly a paid programme, rather than a free vaccination programme, as the government is calling it.

Will private hospitals being predominantly found in urban areas lead to vaccine inequity in rural areas?

We also need to think about the communication and vaccination messages and processes that need to be in place for rural areas, and the potential private partners to deliver these vaccines in rural or hard to reach areas, to reduce vaccine inequity.

GAGANDEEP KANG

GK: Vaccine inequity is a critical area of concern. However, immunisation in rural areas is not usually undertaken by large private hospitals. Private hospitals are located in and serve the populations of urban areas. Even before the private provision of vaccination started, inequity was a concern, both because of the digital divide as well as the delivery of vaccines in rural areas.

We also need to think about the communication and vaccination messages and processes that need to be in place for rural areas, and the potential private partners to deliver these vaccines in rural or hard to reach areas, to reduce vaccine inequity.

CL: This is actually the key concern. Vaccination from private facilities would remain mostly for urban settings. This essentially

means the rich and urban population has higher availability and easier access to the vaccines. This further aggravates vaccine inequity as even the government vaccination sites are far and few in rural areas. We have already seen that with technology-driven solutions to get registered the gap widens and puts poor, vulnerable, rural and marginalised - who actually need the vaccine most - at the end of vaccine access. There is reportedly higher vaccine hesitancy in the rural population. All of this understanding should be used to develop special strategies by the government to proactively address vaccine hesitancy.

Despite claims that allowing private hospitals will lead to exponential increase in vaccination coverage, only about 10% of vaccines were administered by private hospitals early on when there was a cap on price. Will we see an encore of this with a cap on vaccine administration charges?

CL: In the four-decade old universal immunisation programme (UIP) of India, the private sector share of total vaccines is around 15%. It is the government facility which delivers around 85% of UIP

vaccines. Thus, there is no reason to believe that the private sector would have any big role in COVID-19 vaccination. Moreover, the market price of currently licensed COVID-19 vaccines is far too high and is affordable to only the rich. The service charge is a fraction of the vaccination cost. The core issue is the vaccine price.

Should vaccine procurement be 100% centralised and private hospitals provided free vaccines by the government?

GK: I think that vaccine procurement should be 100% by the government. This should be provided through both public and private vaccination facilities until we reach at least 70% coverage of the above 45 years age group and the high-risk categories in the younger ages. After that, the government could consider the allocation of a proportion of vaccines through the private sector and let the free market operate. Of course, once it comes to children needing vaccination, we will need to reconsider based on supply and strategy.

CL: The Central government should pay and procure 100% of vaccines at a single price. For people, vaccines should be completely free, no matter whether they go to a government or a private facility. At a private facility, the service charge should be paid by the government, on behalf of people. It is a public health emergency and not normal times.

Serum is supposed to increase capacity to 100 million doses per month by July. Covaxin production too is supposed to increase to 60-70 million per month by July-August. But the government is set to procure only 250 million Covishield doses and 190 million doses of Covaxin between August and December. This translates to procurement of just 50 million doses of Covishield and 38 million doses of Covaxin

per month during this period by the government. Will that mean that private hospitals will get more than 25% of vaccines produced?

GK: I think the orders currently placed by the government are not the entirety of the vaccine doses that will be needed or procured given the policy announced by the government. Therefore, the figures currently available for the gap between the production and the availability of future doses within the public immunisation programme, are unlikely to be directed entirely to the private sector. I think we should wait for the government to place additional orders with existing manufacturers.

CK: I believe the manufacturers would use some of this to fulfil their bilateral sales/purchase commitment and global commitment such as COVAX, which in my opinion is a fair deal.

Will allocation of vaccines based on a few parameters including wastage lead to fudging of data or denial of vaccines in some cases to ensure reduced wastage? With several States under-reporting cases, will allotment based on disease burden negatively impact virus spread?

GK: It is a truism in public health that we need to accurately measure what matters in order to decide what action needs to be taken. If measurement is inaccurate or deliberately misreported then we have a problem of allocation becoming inappropriate. There are several alternative ways of deciding on allocation, and perhaps the simplest is to do it on the basis of the eligible population.

I think we need to be aware that the most important thing is to be vaccinating as quickly as possible. Allotment based on disease burden would require an approach that could saturate the most affected areas with vaccines to prevent further spread.

Meet *Bharitalasuchus tapani*, a carnivorous reptile that lived 240 million years ago

The Indian fossil specimen was not studied earlier because it was not as complete as the specimens found in other countries

In the mid 20th century, researchers from the Indian Statistical Institute, Kolkata, carried out extensive studies on rocks of the Yerrapalli Formation in what is now Telangana, uncovering several fossils. By studying some of these specimens stored at the Institute, an international team has now thrown light on a carnivorous reptile that lived 240 million years ago.

This reptile belongs to a genus and species previously unknown to science. They

named it *Bharitalasuchus tapani*. In the Telugu language, *Bhari* means huge, *Tala* means head, and *Suchus* is the name of the Egyptian crocodile-headed deity. The species is named after paleontologist Tapan Roy Chowdhury in honour of his contribution to Indian vertebrate paleontology and especially his extensive work on the Yerrapalli Formation tetrapod fauna.

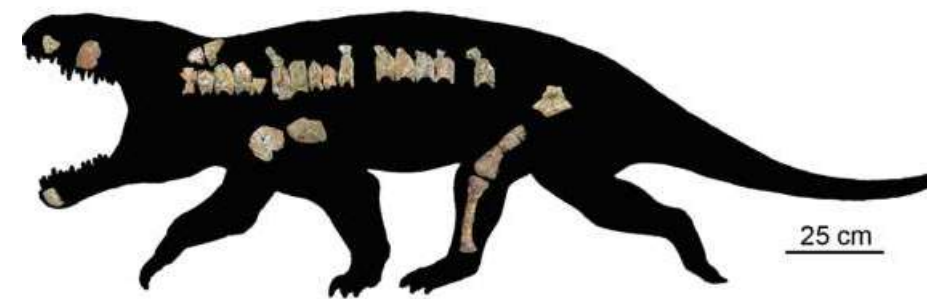
Further studies revealed that the reptile belonged to a family of extinct reptiles named Erythrosuchidae. "A precise identification had

not been possible earlier because the family was not known from other examples in India. It was neglected because the fossil specimen was not as complete as those of other erythrosuchids from other countries. Also, because the few palaeontologists with expertise in the family had not examined the fossil or carried out the detailed comparative work needed," explains David Gower from the Natural History Museum London, in an email to *The Hindu*. He is one of the authors of the paper recently published in

Ameghiniana.

The team notes that *Bharitalasuchus tapani* were robust animals with big heads and large teeth, and these probably predated other smaller reptiles. They were approximately the size of an adult male lion and might have been the largest predators in their ecosystems.

"The first Erythrosuchidae remains were discovered in South Africa in 1905 and more were found in China and Russia. The South African one is about 245 million years old, while the ones from China and Russia

are around 240 million years old. So the Indian one is one of the youngest fossil records we have of an erythrosuchid," explains the first author Martin D. Ezcurra from the Argentinian Mu-

seum of Natural Sciences in Buenos Aires.

Biological interaction

He adds: "It was surprising to find tooth marks in the first trunk vertebra of *Bharitalasuchus*

indicating that a smaller animal took a bite probably after the death of the specimen. This is a nice example of evidence of biological interaction that occurred 240 million years ago." One of

the authors Saswati Bandyopadhyay from the Indian Statistical Institute adds: "Apart from this erythrosuchid reptile, the fossil assemblage of the Yerrapalli Formation includes many other extinct creatures such as ceratodontid lungfish, rhynchosaur and allokotosaurian."

She adds that future exploration and excavation in this unit are important in finding new fossils. "Unfortunately, deforestation, mining, agricultural expansion, urbanisation are gradually destroying the fossiliferous localities of India, and the Yerrapalli Formation of the Pranhita-Godavari Basin is not an exception," she concludes.

A molecular view of SARS-CoV-2, the novel coronavirus

How scientists make out the difference between variants of a virus

Our happy memories of school often include chemistry practicals - test tubes and Bunsen burners. Chemistry is the study of the properties of molecules. Everything is made of molecules. The simple chemicals that were learnt in school, such as hydrochloric acid (which has two atoms, one hydrogen; one chlorine), are dwarfed by the complexities of biological chemistry. A protein molecule can have thousands of atoms.

Simulating molecules With increasing knowledge of chemical principles, it has been possible to move from the 'test tube' to theoretical studies of molecules, their structure and their interactions. Just as there are games that let you simulate the landing of an aircraft on your computer screen, one can simulate the interactions bet-

ween complex biological molecules with reasonable accuracy. Whether in simulating flight, or a molecule, mathematical methods are being linked to fundamental laws of physics. After all a protein is only a linear chain of linked amino acids (of which there are 20, each made up of between 10 and 27 atoms), neatly folded into a unique shape. Amino acids vary in their charge (positive, negative, neutral) or stickiness. Some regions of the chain of amino acids are buried in the core of the molecule. Others are on the surface. Surface amino acids determine interactions between proteins - important for assembling a structure, for binding to receptors, to antibodies and so on.

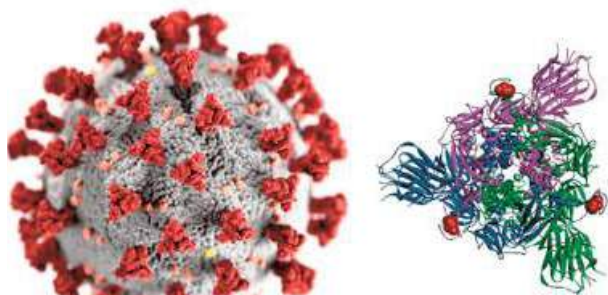
Back in the real world, many of us have anxiously followed the progress of the covid-19 pandemic, looking for

signs of it slowing down. We have learnt new jargon, got accustomed to scary images of a ball-like virus particle studded with "spikes". Now, we are confronted with new and worrying variants, each of which is described either with a geographical moniker, or with a WHO classification (Greek alphabets alpha, beta, etc.) or more accurately, with a code such as E484K, D614G. The numbers take us back to our linear chain of amino acids in a protein, which in this case is the spike protein on the surface of the virus. The spike protein initiates infection - it is attracted to and binds to a receptor molecule that lies on the surface of cells in your lung and

other tissues. This protein molecule is a chain of 1,273 amino acids, and three individual molecules lock together to form the familiar 'spike' shape. The 484 is the position in the chain. It lies within the crucial motif that binds to the host receptor E is shorthand for Glutamate, an amino acid with a negative charge, which is now mutated to K (Lysine) - an amino acid with a positive charge. This mutation is found in the Beta and Gamma variants.

Effect of mutations

Notice that the mutation has replaced a negatively charged Glutamate with a positively charged Lysine.

Modelling gives us approximations of what to expect whenever a new variant of a viral protein arises

Will this bode well for us humans? Available data from the field suggest that infectivity of this particular variant of the virus seems to be enhanced. It also appears to make this variant less recognisable to some antibodies generated against the virus.

The Delta variant, much in the news, has a E484Q mutation, Q standing for Glutamine - which is not very different from Glutamate (E), but is neutral in charge and polar. The second mutation is L452R, which also lies within the receptor-binding motif of spike. L is Leucine, an uncharged, 'sticky' amino acid and R the positively charged Arginine.

An important point to be made here is that the numerous variants of concern do not just have the one or two amino acid changes in the receptor-binding domain of the spike protein described above. The Alpha variant first seen in the U.K. has a total of 23 mutations. Nine of these are in other parts of the spike protein, some more are in other constituents of the

virus, and are not well understood.

It is apparent that changes of this sort - a replacement or two in a macromolecule - can be modeled in a computational environment quite efficiently and with reasonable confidence. Such modelling would give us quick approximations of what to expect whenever a new variant of a viral protein arises. Going further, modelling could help design and refine drug molecules that would bind tightly to a target protein. For example, the coronavirus has an enzyme, a protease that trims the spike protein to its correct size before a new virus particle is assembled. A drug molecule that would bind tightly to this enzyme would inhibit the trimming action and curtail the growth of the virus. Molecular modelling allows you to try out thousands of potential candidates for narrowing down to a few best-fit candidates that could then be tested in real laboratory experiments.

Hardy, vigorous corals

Why do some corals withstand climate change better than others?

In 2014 and 2015, the brown rice coral in Hawaii was completely bleached, but the blue rice coral recovered quickly after bleaching, and blue coral was unaffected by the elevated ocean temperatures.

Researchers from the Smithsonian Conservation Biology Institute, U.S., have now decoded the reason for this resilience. Hawaiian blue rice corals have a deep blue pigment derived from algae called zooxanthellae that live inside the coral tissue. The researchers found that these algae produce sunscreen for the coral. This pigment has a protein named chromoprotein which

filters out harmful UV radiation. The findings of this study were published this week in *Scientific Reports*.

After the 2014 and 2015 Hawaii bleaching events, the blue rice coral was found to have exceptional reproductive vigour at 90% motility. But the brown coral's motility was only half this. A key factor in the blue rice coral's ability to reproduce successfully might be its sunscreen pigment, which the coral may retain even if it bleaches.

Lead author Mike Henley, explains in a release that by studying blue rice corals' reproductive successes, we can better understand how other corals weather climate change and ocean warming.

Bitcoin push

How does El Salvador plan to use the cryptocurrency as legal tender and what are the risks involved?

The story so far: On June 9, El Salvador became the first sovereign nation to make a cryptocurrency legal tender. The law pushed by its 39-year-old President, Nayib Bukele, passed with 62 out of 84 votes. It mandates that Bitcoin should now be accepted as a valid payment by all establishments, except those that do not have the technical wherewithal to do so. This puts the digital currency that does not answer to any government monetary policies on the same footing as the country's primary currency, the United States dollar.

Why is the U.S. dollar the currency in El Salvador? El Salvador fully 'dollarised' its economy in 2001. Countries adopt the U.S. dollar as their official currency for several reasons, such as when their local currencies fail (for example, Zimbabwe, which saw inflation in multimillion percentages), or to take advantage of the stability that it offers and attract investments. One of the downsides is that the economies of 'dollarised' countries get linked to the monetary policies of the Federal Reserve in Washington. The U.S. central bank could set rates that may benefit the U.S. economy but end up hurting economies that use the same currency.

What is the rationale for using Bitcoin?

The Bill that Mr. Bukele proposed said that "Central banks are increasingly taking actions that may cause harm to the economic stability of El Salvador" and that Bitcoin was being adopted "in order to mitigate the negative impact from central banks". The country's economy is also heavily reliant on remittances from El Salvadorians working abroad. According to World Bank data, remittances made up almost \$6 billion in 2019, which was about 20% of the country's GDP – one of the highest ratios in the world. By enabling the transfer of money via Bitcoins, Mr. Bukele says El Salvadorians will save on transaction fees of banks and agencies.

Politically, the current government in El Salvador and the Joe Biden administration in the United States are at odds. Recently, some of President Bukele's right-hand men found mention in a U.S. State Department list of corrupt officials in central America. The United States's international aid agency is also moving money away from the Bukele government after it voted to remove all members of the Supreme Court.

How does Bitcoin work?

Bitcoin is the first and biggest of decentralised cryptocurrencies, which are online payment systems that are increasingly becoming mainstream. Ethereum, Tether, and Binance Coin are some of the many others that have emerged after Bitcoin. Cryptocurrencies are built on the back of blockchain technology, a system of distributed,

cryptographically-secured account keeping. In this system, the users keep a tab on every digital 'coin' and transaction rather than a banking system with a governing body at its centre.

Why are governments wary?

Due to their core nature that shuns centralised control, governments globally have been wary of cryptocurrencies. A report from the U.S. Library of Congress notes that most countries have warned their citizens against investing in cryptocurrencies, let alone allowing transactions in them. Some have tried to use the technology to create government-sanctioned digital currencies. China, a hub of cryptocurrency activity, has issued a digital Yuan on blockchain while it cracks down on other cryptocurrencies. The Bank of England has also proposed a digital Sterling.

However, many countries, including India, have allowed the treatment of cryptocurrencies as commodities, resulting in a rising tide of investment in them. After its introduction in 2009, Bitcoin saw its biggest gain in value last year, having started 2020 at \$7,200 per coin and touching \$65,000 in April of 2021, before falling to \$30,000 in May.

Cryptocurrencies as commodities are highly volatile, a recent example being the massive swings in the values of Bitcoin and Dogecoin, based merely on the tweets of cryptocurrency 'evangelist' Elon Musk.

Another problem is the increasing energy use associated with cryptocurrencies. The 'mining' of Bitcoin, where individuals or companies set up powerful systems to support the blockchain network, for which they are rewarded in the currency, consumes "about the same amount of energy annually as the Netherlands did in 2019", says a Reuters report citing data from the University of Cambridge and the International Energy Agency. "Bitcoin production is estimated to generate between 22 and 22.9 million metric tonnes of carbon dioxide emissions a year, or between the levels produced by Jordan and Sri Lanka," says the report.

How is El Salvador mitigating the risks?

According to Mr. Bukele, the government will protect citizens from the volatility of Bitcoin prices by guaranteeing quick convertibility to dollars. If a shopkeeper does not want to hold the Bitcoin which they now have to accept from customers, the government will purchase it through a \$150-million trust created at the country's development bank.

As for the carbon footprint, Mr. Bukele says he has asked the State-owned geothermal electric company, LaGeo, to connect renewable energy from the country's volcanoes to bitcoin mining facilities.

Changes in vaccine policy for COVID-19

What modifications has the Centre announced and how will the supply of doses be ramped up?

The story so far: Prime Minister Narendra Modi on June 7 reversed the Central government's decentralised policy for procurement of COVID-19 vaccines, declaring that from June 21, vaccines for everyone above the age of 18 years would be procured by the Central government and distributed free to the States. This ended the month-old controversial system of States being asked to procure vaccines for the 18-44 years age group at prices announced by domestic manufacturers and import vaccines through open tenders.

Why was the policy reversed?

The Centre's announcement came after the Supreme Court on May 31 held that the Union government's policy of not providing free vaccines to those in the 18-44 years age bracket was prima facie "arbitrary and irrational". "The policy of the Central Government for conducting free vaccination themselves for groups under the first 2 phases, and replacing it with paid vaccination by the State/UT Governments and private hospitals for the persons between 18-44 years is, prima facie, arbitrary and irrational," the court said in its order.

Under the latest policy, the Centre said it will procure up to 75% of the doses of vaccines from manufacturers and will provide them free of cost to the State governments. Private institutions can procure the remaining 25% of doses.

What is the state of vaccine availability?

Data on availability from individual manufacturers and supplies to each State have not been published uniformly by the Centre. Amid reports of severe shortages in many States and the vaccination drive being suspended for the 18-44 years age group in a number of places, the Centre said on June 9 that thus far, over 25 crore (25,06,41,440) vaccine doses had been provided to the States and Union Territories through the free distribution channel and direct procurement category. Of these, 23,74,21,808 doses had been consumed, including wastage, and 1,33,68,727 remained to be administered.

Some data is available from the Centre's arguments in the Supreme Court on the three available vaccines at present. The court recorded the position on May 31 as follows: the production at the Serum Institute of India (SII), which makes Covishield, is being raised from 5 crore doses a month to 6.5 crore doses by July 2021; Bharat Biotech, the maker of Covaxin, will raise capacity from 90 lakh to 2 crore doses per month, touching 5.5 crore doses per month by July; availability of Sputnik V will go up from 30 lakh doses to 1.2 crore doses a month by July.

In a letter to Union Home Minister Amit Shah, sent at the end of May, SII said it would be able to provide 10 crore doses in June. Moreover, the Union Health Ministry said the production capacity of Covaxin, which was 1 crore doses in April this year, was expected to touch 10 crore doses a month by September. The Centre said it was in talks with other manufacturers, such as Pfizer, Moderna and Johnson & Johnson, for procurement, but the negotiations were reportedly bogged down by demands from the companies for indemnity against any compensation claims.

Soon after the reversal of the Centre's vaccination policy, it was announced that fresh orders for 44 crore doses of Covishield and Covaxin had been placed by the Union government, which would be available from August-December this year. In addition, it also placed an order for 30 crore doses of a protein sub-unit vaccine produced by Hyderabad-based Biological E.

The Supreme Court has directed the Centre to provide

specific details of its vaccination initiative, including procurement, percentage of population covered, and plan for coverage.

What is the outlook for June supply?

The Centre has said that a total of 12 crore doses will be available for June this year. Of this, 6.09 crore doses will be available to the States and UTs for the

priority groups – healthcare workers, frontline workers and people aged 45 years and above – as free supply from the government. Besides this, around 5.86 crore doses will be available for direct procurement by the States, UTs and private hospitals.

This statement was issued at May-end, and the court ordered the Centre to outline its plan and the official policy for the future. Greater clarity will come from the court submissions on how the available doses will be used, including the quantum for private hospitals.

Meanwhile, regulatory requirements for approved imported vaccines have been relaxed and they can be used almost immediately upon receipt, as the government has waived the requirements of bridging trials and testing of each batch at the Central Drugs Laboratory, Kasauli. Small quantities of doses were supplied to State governments in the first week of June as immunisation rates dropped sharply.

How has the pricing of vaccines changed?

Pricing of COVID-19 vaccines, both for government procurement and for beneficiaries, has shifted since the first round of sponsored vaccinations in January for healthcare and frontline workers. For vaccination of these priority sectors, the two vaccines were initially sold to the Centre at special prices – ₹200 a dose for Covishield up to 100 million doses, and ₹295 per dose for Covaxin, with free doses of it provided to the Centre effectively reducing the price to ₹206.50 each.

When the second phase of vaccination was launched on March 1, the Centre capped the price for Covishield and Covaxin at private hospitals at ₹250 per dose.

Under the decentralised distribution of vaccines from

May 1, this cap was removed and manufacturers announced differential pricing for State governments and private hospitals.

However, these developments were soon rendered moot by a widespread shortage of vaccines, and governments largely provided vaccines only to the 60-plus and targeted 45-plus categories.

Now, having taken over the responsibility of free vaccination for all age groups from June 21, the Central government has announced new prices for private hospitals. They can charge a maximum of ₹150 per dose as service charge and a GST of 5%, and with these, the maximum price for a dose of Covishield would be ₹780, for Covaxin it will be ₹1,410 per dose, and Sputnik V would be available at ₹1,145 a shot.

What is the situation in the States?

According to data compiled by *The Hindu*, as of June 12, 14.9% of the population had got at least one dose of a vaccine, and 3.4% had got both doses.

Many big States had fully vaccinated only a small segment of the population as of that date: 51.2 lakh in Maharashtra, 45.1 lakh in Gujarat, 29.8 lakh in Karnataka, 22.2 lakh in Kerala, and 26.1 lakh in Andhra Pradesh. Single-dose coverage in these States varied between 88.7 lakh (in Kerala) and 2 crore (in Maharashtra).

The shortage of doses prompted many States to announce a partial suspension of vaccinations, particularly for the 18-44 years age group, and in some cases, for first doses.

The Hindu's Data Team, based on official data up to May 24 – after which they were not published – estimated that utilisation in the largest States ranged from 86.6% in Uttar Pradesh, 84.7% in Tamil Nadu, 97.9% in Maharashtra and 92.8% in Bihar; the figure was 95.4% for Delhi. In the second wave of infections, the demand for vaccines shot up. For instance, in the past few weeks, Tamil Nadu's utilisation rate has increased sharply, and as of June 6, the State had utilised over 95% of vaccines it received from the Centre and through its own channels.

Most States drew a blank with their efforts to directly procure vaccines at the global level, since pharma companies preferred to deal only with national governments. The Delhi government has complained that the Centre issued a gag order to States and UTs against publishing information on vaccine supply and availability, as the world's "largest immunisation programme" came under intense scrutiny.

New guidelines on Remdesivir, steroids

Why has the Centre revised the protocol for mild cases and which drugs are not recommended anymore?

The story so far: The Union Health Ministry has revised its guidelines for the treatment of COVID-19 patients, particularly for the use of steroids, with doctors reporting a worrying rise in medical complications, such as mucormycosis, due to the abuse of drugs and therapies during treatment. The new protocol advises doctors to drop from usage medicines such as ivermectin, doxycycline and hydroxychloroquine to treat mild COVID-19 cases. The revised guidelines, issued on May 27, recommend the use of antipyretics for fever and antitussives for cold in asymptomatic and mild cases.

What are the complications being reported?

Mucormycosis causes black lesions on the nasal bridge or the upper inside of the mouth, which can quickly become more severe, leading to blurred or double vision, chest pain, breathing difficulties, and coughing of blood. COVID-19 patients with diabetes and a weakened immune system are particularly prone to this fungal attack.

Doctors point out that it is clear that the virus affects not just the respiratory system but other organs as well, including the liver and kidneys. "Long COVID-19 is also seen among recovered patients well into three months and beyond. People with co-morbidities are more vulnerable and irrational use of drugs can have extreme adverse effects on the outcome with COVID-19," they say.

Which drugs have been dropped from the list?

For patients with mild symptoms, the Ministry dropped from its recommendations several drugs that were being used widely for treatment until now. For example, the Ministry has removed hydroxychloroquine, ivermectin, azithromycin, doxycycline, zinc and favipiravir from its list of recommended drugs for treating patients with mild infection. Plasma therapy, which was previously used extensively, has also been dropped from the list.

The Ministry also dissuaded medical practitioners from prescribing unnecessary tests, such as CT scans. For asymptomatic cases, the guidelines said no medication is required, while medications for other co-morbid conditions should be continued. The new protocol calls for a healthy balanced diet with proper hydration, while advising patients and their families to stay connected and engage in positive talks through phone, video calls, etc.

In mild cases, the guidelines recommended self-monitoring for fever, breathlessness, oxygen saturation or worsening of any symptoms. People may take antipyretics or antitussives for symptomatic relief, and may inhale



budesonide at a dose of 800 mcg twice a day for five days for cough, the guidelines said. "No other COVID-19-specific medication required. Patients may have to be investigated further if symptoms persist or deteriorate," the document states.

What do the guidelines specify on medicines?

The Ministry has also revised its policy on Remdesivir, stating that it can be given only to "select moderate/severe hospitalised COVID-19 patients" on supplemental oxygen. The Ministry noted that this is a reserve drug approved under Emergency Use Authorisation based only on limited scientific evidence globally. It further stated that the drug is not to be prescribed for patients with mild symptoms who are under home care or at COVID Care Centres, and that doctors are advised to exercise extreme caution in using this reserve/experimental/Emergency Use Authorisation drug.

The Ministry said the advisory and revised guidelines are aimed at stopping the misuse of drugs and therapies which cost a lot and have limited availability, along with the potential to cause harm.

In the case of Remdesivir, particularly, the government said that the drug should be taken on advice by senior faculty members or specialists directly involved in a patient's care. "It should be procured and provided by the hospitals only; the patient's attendants/relatives should not be asked to procure Remdesivir from the retail market," the Ministry said.

On Tocilizumab, the guidelines said that it is an immunosuppressant drug and that it has been approved for use as an off-label drug only in severe and critically ill patients. The document notes that steroids are harmful in asymptomatic and mild cases of COVID-19. It points out

that steroids are to be prescribed only in patients who are hospitalised with moderately severe and critical symptoms and are to be administered at the "right time, in the right dose and for the right duration".

What do the guidelines say for asymptomatic patients?

For asymptomatic and mild cases, the guidelines suggest a six-minute walk

test. Patients should walk for six minutes with a pulse oximeter attached to a finger. If oxygen saturation falls below 94% or if the reading varies from three to five percentage points, or if the patient feels unwell (lightheaded, short of breath), admission to a hospital for observation may be required.

Has anything been suggested for children with COVID-19?

The government has issued comprehensive guidelines for the management of COVID-19 among children under 18 years of age, in which Remdesivir has not been recommended and rational use of HRCT (high-resolution computed tomography) imaging has been suggested. Also, the guidelines note that steroids are harmful in asymptomatic and mild cases of infection. Mask is not recommended for children below five years of age. However, children aged between six and 11 years may wear a mask, but only under the supervision of parents and the consulting doctor, the guidelines said.

For asymptomatic infection among children, the guidelines recommend no specific medication and advise following appropriate measures (wearing a mask, following strict hand hygiene, physical distancing) and a nutritious diet. The guidelines say that for mild infection, paracetamol at 10-15mg/kg/dose may be given every four to six hours for fever; throat-soothing agents and warm saline gargles in older children and adolescents have been recommended for cough.

Doctors have noted that a high percentage of children who got infected and were hospitalised during the second wave of infections had either co-morbidities or low immunity. They added that healthy children with mild illness recovered without the need for hospitalisation.

Reviving the spirit of multilateralism

The G7 countries seek to overcome internal differences and strengthen their economic and geopolitical bond to face multiple challenges from fighting COVID-19 to tackling the rise of China

As the leaders of seven nations – the U.S., Germany, the U.K., France, Canada, Japan and Italy – meet in Cornwall in south-west England, they would be marking the 47th edition of the “Group of seven” summit. Besides the international milieu in which this summit is being conducted – the ongoing COVID-19 pandemic – its significance lies also in who is not attending the summit: former U.S. President Donald Trump.

The G7 prides itself as a group of nations that steadfastly promote liberal democracy and enjoy economic prosperity, which they seek to institutionalise through multilateral cooperation. When Mr. Trump was at the helm in the U.S., his transactional approach to international relations showed disdain for multilateralism, evidenced in particular in the way he pulled the U.S. out of the Paris Accord, and openly complained about the summit itself being “outdated”. The current President of the U.S., Joe Biden has sought to reorient his country's policy towards multilateralism, which includes closer coordination with traditional allies in the Global North and this sets the stage for a renewed emphasis of purpose for the G7 as they meet in Cornwall.

Already, the Finance Ministers of the G7, who had met on June 4-5 in the run-up to the summit, had agreed to backing a minimum global tax rate of 15% for multina-

tional corporations, thereby setting the stage for MNCs to pay a fairer share of taxes in jurisdictions where they make money and profits, rather than playing governments in a race where they will compete on who will tax them the least and allowing MNCs to take advantage of “tax havens”. Even considering the fact that the tax rate of 15% is low according to some critics (Mr. Biden had himself proposed 21%), this move will herald corrective steps that could benefit both large and medium economies. The U.S. in particular is desperate to shore up its revenues as its government announced big spending plans to tide over the economic crisis wrought by the pandemic. The Biden administration has hinted that it could gain nearly \$500 billion in tax revenue over a decade if the global minimum tax idea comes to pass.

More steps remain for this to become reality – the G7 countries would have to convince other nations in the broader G20, which includes China, India, Russia and South Africa. According to the U.K.-based Tax Justice Network, India suffers an annual loss of \$10 billion due to lax tax laws on MNCs globally and countries such as Ireland, which benefits from lower taxes on MNCs, will not be easy. Even within the U.S., where President Biden's power to get legislation passed rests on a razor-thin majority at the Senate and House of Representatives of

Congress, the going would not be easy as the Republican Party is loath to taxing corporations.

Yet, for the G7 to have made a global minimum tax a possibility was a “multilateral” breakthrough of sorts for cooperation among these nations. Despite its collectively large economies and a commitment to liberal democratic values, the G7 is no longer the behemoth that it was. Formed in 1975 in the aftermath of the 1973 Oil Crisis, the G7 then collectively produced 70% of the world's GDP, a number that has dropped to 40%, as the *Economist* points out. The larger G20 has become a more rele-

vant multilateral body due to the inclusion of economies such as Brazil, China, India and South Africa but the ability of the G7 summit to set the tone for cooperation on global issues has not diminished.

Economic differences

When the G7 summits began in the mid-1970s, the heads of states sought to resolve economic differences related to exchange rate policy, growth, inflation, energy policy among others and this set the stage for multilateral trade arrangements and negotiations with the European Union and Japan assuming greater responsibilities on multilateral issues along with the U.S. Interestingly, the consensus among these nations, especially in the 1990s, to promote policies for the ease of flow of multinational capital and a concomitant reduction in expansive welfareism by the states, set the tone for the “tax competition” among states which went on to benefit MNCs.

As the summits progressed, the emphasis on

economic issues remained salient and endured, but the heads of States began to prioritise other matters as well, especially after the end of the Cold War – the environment, debt relief for developing countries, and the strains on globalisation. Terrorism also became a key agenda for discussion and action. The G7 also became the G8 with Russia's admission into the group in 1998, despite its limited national wealth compared to the other countries. The G8 reverted to the G7 again in 2014, following Russia's expulsion after its annexation of Crimea.

The Cornwall summit includes invitees in heads of state from outside the G7 as well – Australia, South Korea and India with Prime Minister Narendra Modi set to attend it remotely. The presence of these three countries is seen as a nod to the recognition of their discontent with the influence of China, which persists with what the West believes is an anachronistic single party regime but is also an economic

superpower. In the summit, G7 leaders unveiled the Build Back Better World project, which pledges hundreds of billions of infrastructure investment in low- and middle-income countries based on “values-driven, high-standard and transparent” partnerships. It is seen as a counterweight against China's multi-billion-dollar Belt and Road Initiative.

While U.K. Prime Minister Boris Johnson has sought to hail the traditional trans-Atlantic ties with the U.S. and a revival of their mutual role in setting the multilateral tone for G7 and beyond, the Brexit issue has cast a shadow over their ties.

Mr. Biden, unlike Mr. Trump, had steadfastly opposed Brexit and his advisers have raised concerns over the Britain's dispute with the EU over Northern Ireland. Mr. Johnson might be pressed to make concessions to address such concerns.

Global health

More significantly though, the G7's declaration on global health in which they

commit to resources to quickly develop and license vaccines, medicines and diagnostics for future diseases is an important step that recognises the havoc that COVID-19 has wrought across the world and the need to prepare for future epidemics.

Mr. Johnson has said he wishes for the entire world to be vaccinated by 2022, but has not specified details as to how this can be achieved. If the summit manages to agree to substantially extend vaccine availability for low-income countries, that would be a great achievement.

After all, the disparity in vaccine availability with the U.S. and EU cornering vaccines far more than what their populations need while other countries, India and those in Africa, are hampered by shortages, is a consequence of the autarkic turn during the Trump period.

If the G7 seeks to revive its multilateral emphasis in the spirit of globalisation, addressing the vaccine disparity will truly take it forward from the dregs of Trumpism.

The rise of the daughter

YSR's daughter is entering active politics in Telangana with her own party

A new party will be born in Telangana on July 8, the birth anniversary of former Andhra Pradesh Chief Minister Y.S. Rajasekhara Reddy, when his daughter, Y.S. Sharmila, begins a new political journey. When news broke about her plans to float a political party in Telangana, many wondered what impact her move would have on the State's politics as she hailed from Kadapa in Andhra Pradesh, where her elder brother, Y.S. Jagan Mohan Reddy, is the Chief Minister.

Ms. Sharmila had never been into the rough and tumble of politics until June 2012, when she campaigned for her brother in his absence in byelections to 18 Assembly and one Lok Sabha constituencies. Jagan, as Mr. Reddy, president of the YSR Congress Party (YSRCP), is popularly known, was then in jail in connection with a dozen assets cases. The YSRCP then won 15 Assembly seats and the lone Nellore Lok Sabha constituency in the polls, which took place after Jagan parted with the Congress.

In October 2012, Ms. Sharmila launched a 3,112-km padayatra (journey on foot), from her father's grave in Idupulapaya near their hometown Pulivendula in Kadapa. The yatra culminated at the column “Vijaya Vatika”, constructed to symbolise the success of the ‘Maha Prasthanam’ yatra of

her father at Ichapuram in Srikakulam in 2003.

Ms. Sharmila was received by huge crowds at the over 150 public meetings she addressed en route. She had to take a two-month break in the midst of the yatra because of a fractured knee, which required surgery. During the speeches, she invoked memories of her father, with his trademark wave to crowds with the left hand. She walked 13 km a day and held several *racha banda* meetings (interaction with village communities). She remained at home following Jagan's release on bail after a year and a half of imprisonment in September 2013. He then resumed his own “Odaru yatra”, to console the families of his father's supporters who died.

Nearly five years later, Ms. Sharmila shot back to fame again, this time with an 11-day bus yatra to campaign for the YSRCP in the 2019 Assembly and Lok Sab-

ha elections. The yatra went with a brand name “Bye bye Babu” and the bus had a ticking clock, suggesting that it was a countdown for Chandrababu Naidu, who was then the Chief Minister of Andhra Pradesh. The YSRCP secured a resounding victory in the polls.

Differences in family

With the rout of Mr. Naidu in the elections and Jagan becoming Chief Minister, Ms. Sharmila and her mother, who was the honorary president of the YSRCP, became silent. There were reports that differences had cropped up in the family when Ms. Sharmila made public her political ambitions by convening a meeting of her supporters from Telangana at her Lotus Pond residence on February 9.

Jagan's chief adviser and YSRCP general secretary Sajjala Ramakrishna Reddy claimed that the differences were sorted out. “We have tried our level best to dis-

suaude Sharmila from plunging into active politics, which is a tough area, but her decision is [her] conscious choice. She feels there is a political vacuum in Telangana,” said Mr. Ramakrishna Reddy.

He made it clear that neither Jagan nor the YSRCP will have anything to do with Ms. Sharmila's party.

Ever since, there has been hectic political activity at Lotus Pond. A close aide of the family, Vaduka Rajagopal, applied for registration of the party as YSR Telangana Party with the Election Commission. Ms. Sharmila then announced formation of the party at a public meeting in Khammam, following a series of meetings with supporters. She also held a hunger strike at Dharna Chowk in Hyderabad, focusing on unemployment in Telangana, but she was moved away by the police in a day after giving permission for three days.

Ms. Sharmila visited a village in Medak district to console the kin of youth who committed suicide due to unemployment on Telangana State formation day (June 2) and also paid tributes to Telangana martyrs memorial in Hyderabad. On Twitter, she is lashing out at the government. She seems determined on what should be done – build a political party as a counterweight to the Telangana Rashtira Samithi like her brother did in Andhra Pradesh. It's to be seen whether she would manage to pull it off.

A bureaucrat for all seasons

The former U.P. Chief Secretary has been appointed Election Commissioner

When the news of Anup Chandra Pandey's appointment as Election Commissioner came on Tuesday night, it surprised many because the buzz in Delhi's power corridors was about a few other names who retired from the Government of India at the secretary level. However, the government picked the retired Chief Secretary of poll-bound Uttar Pradesh for the coveted position.

A former IAS officer of the 1984 batch, the 62-year-old Mr. Pandey joins the three-member Commission as its third member. Former Central Board of Direct Taxes (CBDT) chairman Sushil Chandra, who is the Chief Election Commissioner, and former Finance Secretary Rajiv Kumar are the other two members.

Mr. Pandey retired after an extended tenure as the Chief Secretary of Uttar Pradesh. He became Chief Secretary in June 2018 and retired in August 2019, after a six-month extension. As the Election Commissioner, his first major task would be to conduct the Assembly election in Uttar Pradesh, where Yogi Adityanath will seek reelection.

However, a cursory glance at Mr. Pandey's career suggests that he has been a man for all seasons and has enjoyed crucial postings during all governments. “He served at impor-

tant positions in all governments in the State and his tenures have remained mostly non-controversial,” a political insider in Lucknow said. Apart from his wide experience in industries, finance, health, education and development administration, Mr. Pandey is known for his networking in the industrial sector, strategic planning and crisis management, as per the observer.

In his LinkedIn profile, Mr. Pandey describes himself as a “career bureaucrat” with more than three-and-a-half decade experience in the administration at the State as well as in the Union level in various positions. “Strong skill-set to handle complex administrative problems,” he writes in his bio, referring to his strengths.

Mega events

Further, he credits himself for successfully piloting schemes and holding mega events such as the farm loan

waiver, investors' summit in 2018 in Lucknow, Kumbh Mela in Prayagraj and Pravasi Bharatiya Divas in Varanasi, the Prime Minister's Lok Sabha constituency, in 2019.

'Able official'

In August, 2019, when he retired as the Chief Secretary, Chief Minister Adityanath showered him with accolades calling him an “able and proficient official” who carried out the tasks given to him efficiently. In almost all major policy initiatives of the U.P. government or politically important schemes such as farm loan waiver, Mr. Pandey's imprints could be seen. The political bosses in Delhi, who are very choosy about appointing officials in high-profile positions, apparently saw several plus points in him besides his seeming closeness with the government in Lucknow. Interestingly, under the NDA government, he is another ex-Chief Secretary to be appointed in the poll body.

Earlier, former Gujarat Chief Secretary A.K. Joti was made the Election Commissioner.

Another factor that also swung in his favour is his amiable nature to work with colleagues as well as subordinates which could help him create a sense of balance in the three-member body, which recently saw the two incumbents sparring over the holding and handling of the Assembly polls in Tamil Nadu, West Bengal, Kerala and Puducherry in the midst of the COVID-19 pandemic.

As Election Commissioner, Mr. Pandey will see crucial Assembly polls starting with Uttar Pradesh, Punjab, Goa, Uttarakhand and Manipur in early next year and then Gujarat and Himachal Pradesh in the last month of 2022. Subsequently, in 2023, there will be Assembly polls in Karnataka and Madhya Pradesh, Chhattisgarh and Rajasthan. He will demit office in February 2024, just before the next Lok Sabha polls. As per the age criterion guiding the Election Commissioners, the retirement age has been fixed at 65 years.

With his appointment, all the three members of the poll body have a common thread – U.P. Chief Election Commissioner Chandra is a former Indian Revenue Service officer from U.P. and so is Rajiv Kumar, a former Jharkhand cadre official. Mr. Pandey was born in Punjab but was allotted the U.P. cadre after he passed the civil services exam.

Denmark's Eriksen taken to hospital after collapsing

Danish FA tweets he is awake and receiving treatment

Denmark midfielder Christian Eriksen was taken to a hospital on Saturday after collapsing on the field during a match at the European Championship.

The governing body of European soccer said Eriksen has been stabilised and the Danish soccer federation said he was awake.

"Christian Eriksen is awake and is undergoing further examinations at Rigshospitalet," the Danish federation wrote on Twitter.

The Euro 2020 match between Denmark and Finland was suspended after Eriksen was given urgent medical attention on the field near the end of the first half.

He was treated for about 10 minutes after collapsing. He was then carried off on a stretcher. UEFA then announced the game had been suspended "due to a medical emergency."

Restart

Danish soccer federation later said the game would res-

ume at 8:30 p.m. local time (midnight IST).

A stadium announcer asked fans to stay in their seats and stay calm.

Eriksen had just played a short pass when he fell face-forward onto the ground. His teammates immediately gestured for help and medics rushed onto the field. Erik-

sen was given chest compressions as his Denmark teammates stood around him in a shielding wall for privacy.

The Finland players huddled by their bench and eventually walked off the field while Eriksen was still getting treatment, as did the referees. Eriksen was even-

tually carried off to a loud ovation, with his teammates walking next to the stretcher.

Eriksen is one of Denmark's biggest stars and the incident brought an instant sense of shock to the Parken Stadium, where about 15,000 fans fell into hushed silence. Some supporters could be seen crying.

Italy zips off the starting blocks

Wales escapes with draw as Switzerland misses chances

Italy got its Euro 2020 campaign off the mark with an impressive 3-0 win over Turkey in the curtain-raiser for the postponed continental tournament in front of home fans here on Friday.

Playing its first major tournament in five years after failing to qualify for the 2018 World Cup, all the goals came in the second half in front of a Stadio Olimpico that had a quarter of its capacity.

Merih Demiral's own goal put Italy ahead before Ciro Immobile and Lorenzo Insigne netted for Roberto Mancini's side in the Group A opener. There was a party atmosphere, with a spectacular sound and light show and

firework display before kick-off for the opening of the month-long 24-team event, which will be played across 11 countries.

On the pitch, Italy dominated early on with a three-man attack led by Immobile. The 31-year-old had several near misses in the first half, coming up against a solid Turkey defence.

Turkey could also thank goalkeeper Ugurcan Cakir for pulling off a big save on 23 minutes.

Italy finally got on the scoreboard eight minutes after the break when the unfortunate Demiral found himself in the path of a Federico Bernardini cross for Immobile, the Juventus defender bundling the ball into his own net.

Immobile finally got his goal, his 14th for Italy, and first in a major tournament, in the 66th minute, scoring from a rebound after Cakir had saved from Spinazzola.

And Insigne curled in the third with 11 minutes to go.

A header from the towering Kieffer Moore allowed Wales to come from behind and draw 1-1 with Switzerland in their opening Group A game in Baku on Saturday.

Moore headed home in the 74th minute to cancel out Brel Embolo's headed opener at the other end, which had come just after half-time.

Krejcikova, the new queen in town

Becomes the sixth new champion in Paris in six years, beating Pavlyuchenkova

Barbora Krejcikova won her maiden Grand Slam singles title on Saturday, beating Russia's Anastasia Pavlyuchenkova to become the first Czech woman in 40 years to conquer Roland-Garros before dedicating her victory to former Wimbledon champion Jana Novotna, who died four years ago.

Krejcikova, ranked 33 in the world and playing just her fifth Grand Slam singles main draw, triumphed 6-1, 2-6, 6-4.

The 25-year-old emulates compatriot Hana Mandlikova, who claimed the trophy in Paris in 1981.

Emotional tribute

The 25-year-old Krejcikova paid an emotional tribute to her mentor Novotna, who died of cancer at the age of 49 in 2017.

"It's hard to put into words. I cannot believe I have just won a Grand Slam," said Krejcikova, who was still outside the top 100 when the 2020 French Open took place last October.

"I spent a lot of time with Jana before she died. Her last words to me were 'enjoy tennis and try and win a Grand Slam'.

"I know she's looking after me. All this is pretty much because she is looking

after me. It was amazing that I got the chance to meet her. She was such an inspiration. I miss her and I hope she's really happy," added Krejcikova, who had to save a match-point in her semifinal to defeat Maria Sakkari.

Krejcikova was presented with the trophy by Czech-born Martina Navratilova, who won two French Opens in 1982 and 1984, but as an American citizen.

Up and down

In a nervy start to the final, Krejcikova was broken in the first game, serving up two double faults.

However, the Russian was unable to capitalise and dropped the next six games

as her Czech opponent grabbed three breaks and raced way with the opener inside half an hour.

Krejcikova was rewarded for her bold attacking, hitting 13 winners to the Russian's seven.

Pavlyuchenkova, who made her Slam debut back in 2007, was the more composed player in the second set, stretching out to 5-1. A medical timeout at 5-2 merely delayed the Russian levelling the final.

In the decider, the players exchanged breaks in the third and fourth games, before the Czech broke to love for 4-3 on the back of a 10-shot rally.

Pavlyuchenkova saved

- Krejcikova is the sixth first-time Grand Slam champion to be crowned in the last six editions of the French Open. She is also the 13th first-time singles winner in the last 22 Majors
- The 25-year-old is the third unseeded winner in Paris in the last five years after Ostapenko (2017) and Swiatek (2020)

Djokovic ends Nadal's reign with 'greatest' win in Paris

Novak Djokovic handed 13-time champion Rafael Nadal only his third defeat in 16 years and 108 matches at the French Open on Friday to reach a sixth Roland Garros final after an epic showdown which even forced the organisers to relax Paris' COVID-19 curfew.

In their 58th career clash, Djokovic, the 2016 French Open champion, triumphed 3-6, 6-3, 7-6(4), 6-2. Nadal, 35, remains tied on 20 Majors with Roger Federer.

Salute

"It was a privilege to face Rafa in such an incredible match," said Djokovic after four hours and 11 minutes of intense action. "Tonight, it was my greatest ever match in Paris."

He now leads Nadal 30-28 in their career rivalry. It was Djokovic's second win in eight meetings in Paris with Nadal, a sequence which also included three losses in finals.

"Definitely one of the top three matches that I ever played in my entire career," said Djokovic.

It was Nadal's first defeat in 14 semifinals in the French capital.

"Probably it was not my best day today, even if I fought," said Nadal. "Sometimes you win, sometimes

you lose. I had a big chance, a set point in the third set, and made a double fault and missed a volley in the tie-break. There were some crazy points, but fatigue was also there."

Djokovic had two break-points in the opening game of the first set which stretched to 10 minutes but was unable to convert. They exchanged breaks in the second and third games of a big-hitting second set but it was Djokovic who repeated the feat for a 4-2 lead before levelling the match.

Twice in the third set Djokovic edged ahead, only to be reeled back in by Nadal who broke back in the 10th game as the World No. 1 served for the set.

A 92-minute third set ended with Djokovic taking the tie-break. Djokovic finished off the match on a second match-point.

On Saturday, speaking to the Spanish press, Nadal said that he wouldn't play at the grass tune-up Mallorca Championships (starting June 20) and decide about Wimbledon soon. "After two intense months on clay the body usually suffers a slump. Wimbledon this year is in two weeks. It's different from when I was 25. I am now 35," said Nadal.

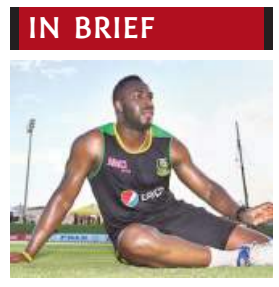




