Monsoon may be delayed by a week: IMD

A westerly trough has impeded the rapid progress of the monsoon in northwest India and it will take 7-10 more days for the wind system to reach the Capital, the India Meteorological Department said on Tuesday.

"The situation will be more clear on Wednesday," said Kuldeep Srivastava, head of IMD's regional forecasting centre.

IMD had earlier predicted that the wind system may reach Delhi by June 15 12 days early.

Normally, the monsoon reaches Delhi by June 27.

Court urges caution in use of the

term for 'conventional offences'

Notwithstanding the fact that the definition of 'terrorist act' in Unlawful Activities (Prevention) Act (UAPA) is "wide and even somewhat vague", the phrase 'terrorist act' cannot be permitted to be casually applied to criminal acts that fall squarely within the definition of conventional offences, the Delhi High Court remarked on Tuesday.

A bench of Justice Siddharth Mridul and Justice Anup Jairam Bhanbhani said the word 'terrorism' or 'terror' has nowhere been defined in the UAPA.

Hence, the court must be careful in employing the definitional words and phrases used in section 15 (of the UA-PA that defines 'terrorist act') in their absolute literal sense or use them lightly in a manner that would trivialise the extremely heinous offence of 'terrorist act', without understanding how terrorism is different even from conventional, heinous crime, the bench said.

The High Court's observation came while granting regular bail to JNU students Natasha Narwal and Devangana Kalita, and Jamia Millia Islamia student Asif Iqbal Tanha, arrested in connection with the north-east Delhi

UAPA's origin

The 'terrorist act', including conspiracy and act preparatory to the commission of a terrorist act, were brought within the purview of UAPA by an amendment made in 2004, on the heels of Parliament repealing Prevention of Terrorism Act (POTA).

POTA's precursor, the Terrorist & Disruptive Activities (Prevention) Act (TADA) was repealed in 1995.

The High Court said the phrase 'terrorist act' must

get its colour and flavour from the problem of terrorism as was earlier addressed by the Parliament under TA-DA and POTA.

Defining 'terrorism'

To understand the concept and construction of 'terrorism', the High Court referred to various judgments of the Supreme Court where the issue has already been

"Terrorism is one of the manifestations of increased lawlessness and cult of violence... A 'terrorist' activity does not merely arise by causing disturbance of law and order or of public order. The fallout of the intended activity must be such that it travels beyond the capacity of the ordinary law enforcement agencies to tackle it under the ordinary penal law," the Supreme Court had said in Hitendra Vishnu Thakur versus State of Maharashtra

In the same judgment, the Supreme Court said, "Every 'terrorist' may be a criminal but every criminal cannot be given the label of a 'terrorist' only to set in motion the more stringent provisions of TADA.

The High Court said, in its opinion, "The intent and purport of the Parliament in enacting the UAPA, and more specifically in amending it in 2004 and 2008 to bring terrorist activity within its scope, was, and could only have been, to deal with matters of profound impact on the 'Defence of India'. nothing more and nothing

"Foisting extremely grave and serious penal provisions engrafted in sections 15, 17 and 18 UAPA frivolously upon people, would undermine the intent and purpose of the Parliament in enacting a law that is meant to address threats to the very existence of our Nation," the court

It reminded that a sacrosanct principle of interpretation of penal provisions is that they must be construed strictly and narrowly, to ensure that a person who was not within the legislative intendment does not get roped into a penal provision.

"Also, the more stringent a penal provision, the more strictly it must be construed," the High Court remarked pointing at the use of the stringent provision under UAPA against the three students in the north-east Delhi riots case.

Teenager on joyride rams autorickshaw, kills driver

He was driving his father's luxury car

An autorickshaw driver died after he was allegedly hit by a luxury car being driven by an 18-year-old boy in west Delhi's Moti Nagar on Saturday morning, the police said on Tuesday.

The victim, Brindeshwar Mahto, used to reside in Trilokpuri with his family.

The Class XII accused, from Punjabi Bagh, has been arrested.

The victim's brother, Chandeshwar Mahto, told the police that along with Brindeshwar, he had gone to Khyala with passengers in their respective autorickshaws at 6 a.m.

He said the accident hap-

pened when they were going towards Ramesh Nagar.

The accused, who was driving his father's car, was coming from the wrong direction when he hit Brindeshwar's autorickshaw.

The impact was such that the autorickshaw turned turtle. Chandeshwar, who was driving behind the victim's auto, rushed to the spot and nabbed the boy. Brindeshwar was declared dead at a nearby hospital.

The accused was with his three other friends at that time. A case on charges of rash and negligent driving and causing death due to negligence has been registered and the accused has

Speeding car kills two in Daryaganj

Two arrested in the hit-and-run case

Two persons were killed when a speeding car hit an e-rickshaw in Central Delhi's Daryaganj, the police said on Tuesday.

Two persons have been arrested in connection with the case, they said.

A senior officer said a PCR call was received on Monday night at 10.30 p.m. regarding a road accident near Delight Cinema. On reaching the spot, an e-rickshaw was found damaged. The police learnt that the injured were taken a hospital.

Further inquiry revealed that a couple and their two

children were travelling in the e-rickshaw when they were hit by the car.

All five occupants of the erickshaw, including the driver, were injured. However, the driver and the woman passenger were declared brought dead at the hospital. The condition of the others is said to be stable.

The driver of the offending vehicle tried to escape but was chased by a man on a bike and nabbed near Jama Masjid. Next, two involved in the crime were held.

A case under relevant sections has been lodged and further investigation is under way, the police added.

'Bail for riots accused holds mirror to govt.'

Activists seek release of Umar Khalid, Sharjeel Imam, other anti-CAA protesters

Students, activists and some political parties on Tuesday welcomed the Delhi High Court order granting bail to the three students, who were arrested under the UA-PA in connection with the north-east riots, which took place in February last year.

Iamia Millia Islamia student Asif Iqbal Tanha and Jawaharlal Nehru University students - Natasha Narwal and Devangana Kalita – were granted regular bail by the Delhi High Court.

The Communist Party of India (Marxist) said through the order, the court had "shown a mirror to the government"

"It is a step towards undoing the gross injustice com-

mitted by the Home Ministry in manufacturing cases against activists protesting against the unconstitutional CAA [Citizenship Amendment Act]. The court has shown the mirror to the government. This applies to numerous cases in which any form of dissent is termed

anti-national and individuals are bullied, intimidated, threatened and imprisoned under UAPA and laws of sedition," a statement by the CPI (M) read.

Further, it added that similar standards should be applied to all the "false cases" and all political prisoners should be released.

Delhi University professor Apoorvanand, who was also questioned by the Delhi Police last vear in connection with the riots, on social media said: "None of them should have been charged or arrested in the first place. All others must be freed. This whole exercise is a conspiracy to shield the real conspirators and perpetrators of the violence of Feb 2020 in Delhi. They are out and ruling us. Spreading hate, planning violence [sic]."

The All India Students' Association (AISA) said the order had exposed the "legal and moral corruption" of the government.

It added: "While the bail has been granted, the struggle against UAPA and release of all political prisoners must continue. AISA demands immediate release of Umar Khalid, Sharjeel Imam and other anti-CAA protestors arrested in Delhi violence case under UAPA."

Stating that it was one of the happiest days of her life, Safoora Zargar, a Jamia Millia Islamia scholar – who was also arrested last year and later granted bail - tweeted: "...Let more follow. Let justice prevail..."

'Serving liquor in hotels, eateries not allowed yet'

The clarification was issued in view of queries related to serving alcohol in bars at hotels, clubs and restaurants after the govt. allowed restaurants to reopen.

The MP blamed the BJI for the attack

Two persons have been arrested in connection with the case, said DCP (New Delhi) Deepak Yadav.

"My house in North Avenue – around 100m from the President's house - has been attacked just now. I want to tell the BJP government and their goons, you can launch attacks or murder me, but I will keep talking about theft of money collected from the public for Ram Mandir. The people who steal money collected for Ram Mandir should be put behind bars," AAP Rajya Sabha MP Sanjay Singh said

in a video on Tuesday. Mr. Singh said the incident happened when he was sitting on the lawns of his residence with a few persons at 12 p.m. He told the police that at that time, a few men came to the spot and started raising slogans against him. They then tried to damage the nameplate and threw ink on it before fleeing the spot.

Mr. Singh added that the people, who were with him at that time, managed to nab two of the accused and handed them over to the police.

The Aam Aadmi Party has been alleging that there is a "big scam" involving BJP leaders in the land bought for Ram Mandir by Ram Janmabhoomi Trust.

Mr. Singh tweeted: "The pace of construction of the temple of Lord Shri Ram has been stalled due to 'donation thieves'. The construction of Ram temple is not being done because thieves stole the money for the construction. I request crores of Ram devotees to demand back the money for the temple from the 'donation

thieves."

A scripted drama: BJP Reacting to the alleged attack, Delhi BJP Spokesperson Praveen Shankar Kapoor said in a tweet that it a scripted drama. "Yesterday, he tried to malign Ram Mandir's construction. Today, he claimed an attack on house, everything is a scripted dra-

ma," Mr. Kapoor said. Mr. Yadav said an FIR has been registered under Sections 188 (disobedience to order duly promulgated by public servant) and 34 (common intention) of the IPC and Sec 3 of Delhi Prevention of Defacement of Property Act 2007.

BJP-led civic bodies failed to clean drains

The AAP on Tuesday claimed that the BJP-led municipal corporations have failed to clean drains, which has resulted in increased waterlogging.

"The BIP-led civic bodies is playing with the lives of Delhiites by not cleaning the drains," AAP leader Durgesh Pathak

"The AAP demands that the civic bodies should immediately start cleaning all the drains under their jurisdiction. On behalf of the AAP, I also want to appeal that the work should be done immediately and later they should not blame others for their failure," he added.

He said monsoon can arrive in Delhi anytime soon now and every year the national capital faces a massive waterlogging problem. "Last year, a child died due to waterlogging and in Karol Bagh, many jhuggis were washed away due to waterlogging. The reason behind this repeated waterlogging is that the BJPruled civic bodies does not clean the drains. In Delhi, around 90% of drains are under its jurisdiction," Mr. Pathak said.

He claimed that only 20% of the drains have been cleaned before the monsoon.

'50% of jab centres for 18-44 age group shut, rest will close today'

AAP MLA Atishi says stock will last one day; city reports 228 new COVID-19 cases

AAP MLA Atishi on Tuesday said that half of the government-run vaccine centres for the people of 18-44 age group were shut down on Tuesday and the rest will be shut down on Wednesday due to vaccine shortage.

"Only 31,000 doses of vaccine are available for the youth in Delhi. For 18-44 age group, less than one day's stock is available. Half the centres in Delhi are closed today and the rest of the vaccination centres will be closed tomorrow," she said.

Vaccine stocks

Both Covishield and Covaxin stocks for the age group will last for less than a day, as per the bulletin released by the government on Tues-

"Delhi is being unlocked and the vaccination of youth is most important at such a time. The youth are going back to their office. That is why our appeal to the Central government is to pro-

She said that the pace of vaccination of youth in Delhi has started slowing down again due to the shortage.

Meanwhile, the downward trend in COVID-19 cases continued in the national capital with 228 new cases being reported in the past 24 hours, taking the total cases to 14,31,498, according to a health bulletin released by tive cases. the Delhi government on

Also, 12 deaths were reported and the total number of deaths stood at 24,851. A total of 71,291 tests were done in a day, the bulletin said.

14,03,569 people have recovered and there are 3,078 ac-

The test positivity rate (TPR) was 0.32%, which means that less than one person out of 300 people taking COVID-19 tests are now positive for the virus. The TPR was as high as 36% on April 22 and has been coming down since then.

In last 30 days, over 50 tested positive for virus every hour

Out of 40K cases, around 1,500 were children aged below 14

Over 52 residents in the Capital tested positive for the novel coronavirus every hour during the last month out of which at least two were children below the age of 14. Over half were aged between 30 and 60, and a quarter were below 30 years of age.

According to Delhi government records, more than 1,500 people found COVID-19 positive between May 15 and June 15 were below 14 years of age. Senior citizens accounted for over 17% of recorded infections.

Statistics related to CO-VID-19 collated by the Delhi government state that 40,470 citizens tested positive over a 32-day interval - an average of more than 1,264 per day.

As the city enters its third week of the 'unlock' process with more activities allowed and new cases dipping on a daily basis, records state that the population most engaged in these activities was among the most vulnerable.

A majority of those who tested positive - 20,672 -

were aged between 30 and 60 years, while 11,427 were aged below 30. Together, they accounted for 32,099 of total cases and constituted over 79% of total COVID-19 positive caseload.

According to records, over 1.589 COVID-19 patients were aged less than 14 years and 6,782 were aged above 60.

Males more vulnerable

More males were found to have been infected compared to women in each age group, according to the data. Men accounted for 3,904 of the total caseload for those above 60 compared to 2,878 women. In the 30-60 age group, 12,308 men were found to have been infected against 8,364 women and, in the below 30 category, 6,548 men tested positive compared to 4,879 women.

For the below 14 category, 909 male children were infected as opposed to 680 female children.

District-wise data

The data also posited that most infections were found in the South West district of the Capital which reported 1,292 cases in the 60+ category, 4,091 cases in the 30-60 age group, 2,147 cases in the less than 30 years category and 337 cases in the below 14 group.

The North West district accounted for 786 cases in the 60+ group, New Delhi district had 2,769 cases in the 30-60 category, the South district for 1,463 cases in the less than 30 years of age group and the New Delhi district, again, for 209 cases in the below 14 category.

Delhi prisons see only single COVID-19 case this month

Number of active cases till June 8 stood at 12: official data

Delhi prisons on Tuesday stated that only a single inmate had tested positive for COVID-19 this month so far.

According to the prison administration, the last inmate to have tested positive for COVID-19 was reported on June 8 and the last staff member tested positive for the virus on May 29. "COVID-19 cases have de-

creased but we are taking all the precautions, COVID-appropriate behaviour, including social distancing among the inmates, is being strictly followed. The new inmates are initially isolated and later shifted to barracks." Director General (Prisons) Sandeep Goel said.

According to the data from prison administration, the number of active CO-

VID-19 cases in Delhi prisons till June 8 stood at 12, which includes two staff members.

Till Tuesday, a total number of 1,139 inmates above 45 years of age and 680 below 45 years lodged at Tihar jail have been vaccinated; 132 inmates above 45 years and 200 below 45 years have received the vaccine at the Rohini jail. At the Mandoli Jail, 412 inmates aged above 45 years and 132 below 45 years have been vaccinated, ac-

cording to the data. Since March this year, 382 cases of COVID-19 infection have been reported among inmates. Of them 364 have recovered while there are 10 active cases, according to data. Eight inmates have succumbed to the virus too. Among the prison staff fected since March and of

them, 219 have recuperated while two are still undergoing treatment.

Interim bail

According to officials, over 2,000 undertrial prisoners were released on interim bail and around 700 convicts released on emergency parole under the department's decongestion drive.

The first COVID case was reported from Rohini jail on May 13 while two COVID-19 positive inmates lodged at the Mandoli jail, both senior citizens, had passed away on June 15 and July 4.

Jail officials have maintained that the Prisons Department remained vigilant and instructed its staffers to not only maintain hygiene and social distancing but also spread awareness about the infection.

SAD-BSP alliance may not deliver in Punjab Assembly polls

While the BSP is barely relevant, the SAD is trying to recover lost ground in the farming community

VIKAS VASUDEVA CHANDIGARH

The Shiromani Akali Dal (SAD) and the Bahujan Samaj Party (BSP) recently decided to jointly contest the Punjab Assembly elections, due early next year. The announcement has set the tone for the upcoming polls, even as keen political observers feel the alliance may not yield the "desired" results for either party.

In Punjab, which has the highest percentage of Dalit population among the States at close to 32%, the BSP used the Dalit vote as a political plank for the first time in 1992. However, since then, the party has received a declining response in the State. In 1992, it secured over 16% votes winning nine seats in Punjab, but that dropped to around 4% in the 2012 Assembly polls. In 2017, the BSP's vote share percentage hit a further low of 1.5%. Now, with the new alliance, the BSP is attempting to remain "relevant" in State politics.

On the other hand, the SAD has faced wrath of farming community, its key support base, which is de-

"If the SAD is finding it difficult to maintain its heritage status – being a Panthic party of the Sikhs – for not defending the interests of the farmers of the State, who mostly happen to be Jat Sikhs, the BSP has been struggling hard at least to keep itself alive in its birth place," he said.

sive factor of the caste divide in the State, it seems quite unlikely that the SC votes would be transferred to the SAD. Besides, the SCs of Punjab, like their counterparts in other parts of the country, are not a homogeneous category. They are sharply divided into 39 castes among themselves and got further fragmented into different religions and syncretic faiths, which metamorphosed into deras. The SAD-BSP alliance may not fetch SC votes for SAD across the socio-religious divisions within Dalits. Similarly, the BSP may also have to pay the price for signing the alliance with the SAD. Those SC affiliates of the BSP who were not comfortable with the SAD may like to dissociate themselves from the former for its political marriage of convenience,"

Foodgrain 'scam' hits Meghalaya

An alleged foodgrain scam involving the Food Corporation of India (FCI) has added to the embarrassment of the Meghalaya government facing flak for poor management of the CO-VID-19 crisis.

Chief Minister Conrad K. Sangma has denied his government's involvement in the "scam" detected in adjoining Assam a few days ago. But the Bharatiya Janata Party (BJP), a constituent of his coalition government, and the Opposition Congress, have demanded a probe.

NGOs in the State have also slammed the government for shielding the supplier-official nexus and giving a long rope to "tainted companies".

1 lakh rice bags seized

The police in Assam's Kamrup district had last week seized an estimated 1 lakh bags of rice, each weighing 50 kg, from a warehouse in Boko, west of Guwahati.

Officials said the rice was procured by FCI, Shillong but the owner of the warehouse had repackaged the rice to be supplied to the Assam Rifles. Mr. Sangma insisted the

rice bags seized had no connection with the public distribution system (PDS) in Meghalaya. He said the State had already received its quota of PDS rice for May and June.

"We have no idea if rice belonging to Meghalaya is lying in Assam," he added.

SC closes trial against Italian marines

Govt. plea to stop proceedings follows UN tribunal decision in May last year

The Supreme Court on Tuesday ordered the closure of court proceedings in India against the two Italian marines who allegedly killed two fishermen off the Kerala coast after mistaking them for pirates in 2012.

Taking a jibe at Maharashtra Congress chief Nana Patole over the latter's alleged Chief Ministerial aspirations, Deputy Chief Minister Ajit Pawar on Wednesday said that while there was nothing wrong in someone expressing their desire to become CM, the magic figure of 145 MLAs was needed to become one.

Mr. Pawar said that as per the formula worked out by the heads of the Congress, the Nationalist Congress Party and the Shiv Sena, Uddhav Thackeray would remain the State's Chief Minister, leading the tripartite 'Maha Vikas Aghadi' (MVA) government.

"Even if all three parties are together in this government, all three have the right to increase their strength. The 'Maha Vikas Aghadi' has been formed by the agreement of Sharad Pawar, Uddhav Thackeray and Sonia Gandhi and under the formula, Mr. Thackeray will head it... While there is nothing wrong with anyone expressing a desire to become Chief Minister, he must realise that the magical figure of 145 is required to become the CM," said Mr. Pawar.

Earlier this week, the Congress chief had reportedly remarked that if his party's high command gave him the responsibility of the Chief Ministerial post, he would take it up. A video clip of Mr. Patole shows him exhorting new party workers to begin working with the aim of getting the Congress on the top in the 2024 Assembly elections while positioning himself as a possible future CM.

Hitting out at the BJP over the Maratha reservation issue, Mr. Pawar said the Opposition had no work but to stoke fumes of resentment between communities.

Meanwhile, in a bid to send out a message of social harmony, Vanchit Bahujan Aghadi chief Prakash Ambedkar is said to be joining BJP Rajya Sabha MP Sambhajiraje Chhatrapati'srally on Wednesday.

The invisible tax

Emergent action is needed to rein in inflation as people face income losses, medical costs

The pandemic's second wave may have subsided but hopes of a smooth rebound in the economy in tandem with easing restrictions remain muddled, with the inflation numbers for May compounding the problem. The soaring pace of rising prices, both retail and wholesale, in the month that saw widespread lockdown-like restrictions, has come as a negative surprise. Inflation based on the Wholesale Price Index is reckoned to have hit a 25-year record of nearly 13%, while retail inflation touched a six-month high of 6.3%. While runaway fuel prices, that include high excise duties and taxes, were a key factor in driving up both the inflation indices, they were not the only ones at work. Retail inflation in food hit a six-month high of 5%, from barely 2% in April, with pulses and eggs as well as edible oils leading the surge. 'Fuel and light' inflation hit 11.6%, the highest in over nine years, and no respite is in sight on this front as pump prices for petrol raced past ₹100 a litre in even more parts of the country this month. Diesel has also crossed the century mark in Rajasthan's Sri Ganganagar, where freight costs add up on top of State and central taxes. Even if one were to discount food and fuel prices, core inflation has crossed the 6% mark for the first time in 31 months and is estimated at 6.6%.

Reacting to the April retail inflation print of 4.3%, after averaging a steep 6.2% through 2020-21, the RBI Governor had remarked earlier this month that it brought some relief and 'elbow room' for sticking with growthsupportive policy. If anything, May's inflation prints leave no such room for manoeuvre. Though the bank's Monetary Policy Committee may not switch away from its dovish policy, no further easing of interest rates can be expected at these price levels. Most economists expect inflation to remain higher than the average 5.1% estimated by the central bank for this year. If the Government wants the RBI to persist with its accommodative approach to facilitate growth, it must take some actions of its own to curb price rise, including meaningful cuts in fuel taxes that the RBI Governor has been advocating since February. So far, it has only obfuscated the issue with arguments ranging from 'the States should cut taxes first' to 'let's bring petroleum products under GST', and the latest claim by the Petroleum Minister who admitted that the prices are problematic, but the Government is 'saving money to spend on welfare schemes' and buying vaccines. For a population already reeling from job and income losses and higher medical costs since the pandemic's onset, the persistently high inflation is untenable. No welfare scheme can offset its disproportionately adverse impact on the poor.

Bracing for a threat

India must be alive to the dangers of emerging variants of the coronavirus

n emerging form of the Delta variant called AY.1 is raising global concern. Five of India's leading ▲ laboratories, since May, have submitted data to the Global Initiative on Sharing All Influenza Data (GI-SAID) on its presence in India. Public Health England, a body in the United Kingdom, has said that of the 63 genomes in its repository as of June 7, six were from India. AY.1, or B.1.617.2.1, is a variant of Delta (B.1.617.2) and has all its characteristic mutations along with one called K417N. This particular one has previously been identified in the Beta variant (first detected in South Africa), which is an international variant of concern as it is highly infectious and known to reduce vaccine potency. The Delta variant is reportedly the most prevalent coronavirus variant in India and comprises close to a third of the genome samples, sourced from those with no international travel history, processed until late May. An additional concern with the K417N mutation is that some studies have found that it was associated with resistance to a newly developed monoclonal antibody treatment drug cocktail, Casirivimab and Imdevimab, for those assessed with a moderate to severe disease risk.

Scientists have said that AY.1 marks the continued evolution of the Delta variant. The Delta variant has become globally prominent in the same way as a mutation, D614G, increased the infectivity of coronavirus in March and April last year. Coronaviruses are marked by 'convergent evolution'; some defining mutations that emerge in different strains from around the world start to become more common in subsequent variants. These mutations are beneficial to the virus and, through a process of natural selection, help it infect human cells more efficiently as well as thwart defensive antibodies. Evolution is an incessant process, and it is impossible to forecast if SARS-CoV-2 will become a part of the human ecosystem – less contagious, and manifesting in sporadic outbreaks but ever present or buckling into oblivion under the force of counter-offensive measures such as vaccines, masks, lockdowns. As the virus and people continue to be engaged in a dialectical battle, humanity has a tool that has been absent in previous global pandemics - that of rapid genome sequencing. Several countries, including India, have the infrastructure and the resources to track threatening mutations. Unfortunately, the potency of a mutation to increase infectivity in a region can only be known retrospectively. However, this knowledge can help improve vaccines and enable researchers to perform quick tweaks, or in the parlance of software, develop upgraded patches that can blunt the threat from emergent variants. India has chosen to restrict genome sequencing studies to 10 government labs and not involve private labs, some of which have the capability and the expertise. Time and again, the country has suffered the consequences of a lack of preparedness. It is important not to downplay the seriousness of the threat.

America's mistakes in the 'forever war'

The U.S. misread the situation in Afghanistan, with the long war now leaving the Taliban at the height of their influence

resident Joe Biden has set the September 11 deadline for all American troops to leave Afghanistan, winding up 20 years of the invasion by the United States. Military officials say the withdrawal would be complete about two months ahead of the schedule. The peace talks between the Afghan government and the Taliban that started in Doha last year have been frozen for months. The bid by the U.S. to hold a summit in Istanbul between the warring parties has been a non-starter. On the ground, the Taliban are making steady advances. Since May 1, the Taliban have seized eight districts in four different regions. At least six provisional capitals, including Kabul, Lashkar Gah (Helmand) and Kandahar, have the insurgents at their gates. As of now, about 22% of Afghanistan's 398 districts are in the Taliban's control and 24% with the government, while more than half of the country's territories are contested.

A neocon war

The longest war in America's history is also turning out to be one of its most disastrous. After 20 years of war, when the world's mightiest military is exiting Afghanistan, the Taliban, which it sought to perish, are at the height of their influence since they were driven out of power. Terrorist networks, which the U.S. vowed to destroy when it launched its global war on terror in Afghanistan, are now scattered across Asia and Africa, from eastern Afghanistan to the Sahel region. What went wrong for the

The U.S. made three fundamental mistakes, which led to the superpower's humiliating exit from this clichéd 'graveyard of em-

First, the U.S. went into Afghanistan without learning anything from the country's history, or was blindsided by the unipolar hubris. Afghanistan was invaded by great powers in the 19th and 20th centuries as well. The British empire, which feared a Russian invasion to India via Afghanistan, sent troops to the country in 1839, ousted its ruler Dost Muhammad and established a client regime of its ally, Shah Shujah. But the British had to withdraw in the face of Afghan resistance, mostly by Pashtun warriors; while retreating in 1842, all of the British and Indian troops, except one doctor, were massacred by Afghans. In 1979, the Soviet Union sent troops to Afghanistan to salvage the country's nascent communist regime, orchestrated a coup and established a friendly regime. The Soviets, faced with a bloody Mujahideen resistance (which was bankrolled and trained by the U.S., Saudi Arabia and Pakistan), had to pull back in 1989 in ignominy. The U.S. might have thought that history would have been kinder to them when they launched the Afghan invasion in October 2001. It wasn't.

Once they invaded Afghanistan, the U.S., given the mistakes the British and the Soviets committed, could have had a strategically focused campaign, targeting its enemy, al-Qaeda, which was behind the September 11 attacks. It should have gone after the terrorists, destroyed their networks and then withdrawn. That is what a realist power would do. But the U.S., driven by the neoconservative globalism of the Bush administration, had set more ambitious goals for itself. It wanted to topple the Taliban and rebuild a centralised "de-



mocratic" state in Afghanistan. How did building democratic institutions in Afghanistan from topdown serve America's foreign policy interests? The neoconservatives in Washington might have found it fascinating, but the move made little strategic sense. And now, the U.S. is retreating, practically leaving Afghanistan to the mercy of the Taliban, in return for assurances from them that they would not assist the terrorists such as al-Qaeda and the Islamic State.

Strategic failure

After the Taliban regime was toppled and al-Oaeda driven back into the caves and mountains, the U.S. still had a chance to stabilise the country with help from its different factions and leave. In December 2001, Taliban spokesperson Mullah Abdul Salam Zaeef had offered to surrender. The Taliban sought modest terms - Mullah Omar, their leader, should be allowed to return home. But the Americans rejected the offer and promised to destroy the Taliban in every corner of the country. The Taliban are an indigenous militancy with deep roots in Afghanistan's Pashtun majority. Toppling them from power was easy, but defeating them in their country was not. And after vowing to defeat them, the U.S. launched the Iraq invasion to topple Saddam Hussein and export democracy there. This was the second mistake.

The U.S. took Pakistan's tactical

support for its war on terror for granted, overlooking the fact that Pakistan had deep strategic ties with the Taliban. Pakistan played a double game by supporting the U.S. campaign in Afghanistan while at the same time offering refuge and support to the Taliban. For Pakistan, the Taliban have been their wild card to check India's influence in Afghanistan. When the U.S. declared victory in Afghanistan prematurely and went on to invade Iraq in 2003, it became easier for Pakistan to assist the Taliban's regrouping, at a time when the Afghan government was grappling with corruption and infighting on ethnic lines. For the ordinary Afghans living outside the provincial capitals, life did not change much under the new government. When the U.S. got stuck in the morass of the Iraq war, the Taliban were steadily making a comeback in Afghanistan's hinterlands. By the time the U.S. shifted its focus back to Afghanistan, after defeating the Islamic State in Iraq and Syria and amid growing calls at home to end the "endless wars",

the Afghan war had already been

Surrender to the Taliban Granted, there is a realist case for the U.S. to leave Afghanistan. It seems to have reached the conclusion long ago that the war was one that could not be turned around. The war was also becoming increasingly unpopular at home, prompting Presidents, from Barack Obama to Donald Trump and Joe Biden, to promise to wind it up. The U.S. has also been shifting its focus to East Asia where China is rising. And given the foreign policy challenges the U.S. is facing now elsewhere, continuing troops and commitments in Afghanistan makes little sense. But the U.S. could have opted for a more orderly withdrawal. Instead, it surrendered to the Taliban's terms to pull back its troops. This was the third mistake.

The Taliban have not defeated the Afghan troops yet. The Afghan government has about 200,000 battle-hardened soldiers, including the U.S.-trained elite special forces. The government still controls most of the country's population centres. The Taliban's efforts to take over provincial capitals were successfully thwarted in the recent past, with air power help from the U.S. With the U.S. being present in Afghanistan, the conflict has been in a stalemate – the government not being able to defeat the insurgents and the Taliban unable to overrun the cities. The U.S. should have used this stalemate, coupled with mounting pressure on Pakistan, to extract concessions from the Taliban. Instead, the Trump administration went for talks with the Taliban on their terms. The Afghan government was kept out of the whole process because the Taliban do not recognise them as being legitimate. And the U.S. struck a direct deal with the Taliban, without addressing any of the Afghan con-

The American exit would now decisively shift the balance of power in favour of the Taliban. The insurgents have always known this. They have stepped up attacks and carried out targeted killings aimed at weakening the Afghan government and terrorising society immediately after signing the agreement with the U.S. in February 2020. And ever since the remaining U.S. troops started pulling back from Afghanistan on May 1. the Taliban have started capturing more territories. The war may be winding down for the Americans. But for Afghans, it will continue in one form or another.

An acquittal with no good, but the bad and the ugly

The criminal justice system must observe the basics of a proper investigation, judicial fairness, and the survivor's rights

The recent judgment of a trial court acquitting Tarun Tejpal, a former editor of a newsmagazine, who was charged, in an employee, a young woman journalist, during an event the newsmagazine had organised in Goa, has created a furore and raised many questions about the law. The investigating officer has also been pulled up not only for the lapses in investigation but also for gaps in her knowledge of technology. The Goa government filed an appeal against Mr. Tejpal's acquittal in the Goa Bench of the Bombay High Court requesting an immediate hearing. The Solicitor General of India, Tushar Mehta, during the hearing, said that the lower court's judgment lacked sensitivity regarding crimes against women and awareness of the sections of criminal laws. "The law has evolved. The entire judgement proceeds as if the victim is on trial," he added.

Key changes Back in 2002, based on the recom-

mendations of the 172nd report of

the Law Commission of India, two major changes were made in the bit.ly/3xpoE1k). First, the Act was amended to prohibit the defence counsel from asking questions to the prosecutrix in a rape case about her general character to impeach her credibility. Second, the defence was not permitted to put questions to a witness in the crossexamination about the general immoral character of the prosecutrix and adduce evidence hypothetically assumed that the survivor had had sexual relations with someone, it does not give any person the licence to sexually assault her. The Supreme Court of India has repeatedly said that the purpose of cross-examining a survivor of rape is not to humiliate her but to get to the truth of the case. Therefore, questions about the past sexual life of the survivor should not have been permitted to be asked by the defence counsel as they violated the survivor's right to a fair trial. The law does not permit the character assassination of a victim any more.

Stereotypical evaluation

Second, the conduct of a survivor of sexual assault cannot be cast in a straitjacket formula. Every individual behaves differently under the given circumstances. When in this case, the survivor had been entrusted with an important task/s by her boss during the event and

was afraid of losing her job by exbehaviour (i.e., in the public gaze and with acquaintances) cannot be termed unnatural. It would be too stereotypical and patriarchal to expect a survivor to be seen traumatised all the time in front of everyone. The Supreme Court, in Aparna Bhat and Ors. vs the State of Madhya Pradesh & Ors. (2021) specifically said that courts should desist from expressing any stereotype opinion, in words spoken during proceedings, or in the course of a judicial order' about women. Stereotyping excludes any individualised consideration of a person's actual circumstances and their abilities. It affects women's right to a fair trial. There-

between the statements made before the police and the court would amount to contradiction. It is trite law that the previous statements of the prosecutrix and witnesses can be used to shake their credibility. However, it is quite natural for a survivor to share the incident in different words and details to different individuals. She is not expected to share the same graphic details of the sexual assault on or wishes to reveal the details to. Therefore, if the statement given during the trial is substantially consistent with the statement given to the police and judicial magistrate during the investigation, the difference of details given to other individuals through email or otherwise in the form of written statements, cannot be rejected by terming them as untrustworthy. The High Court, therefore, must clarify on this vital question of the law keeping in view the nature of

Protection of identity

The Indian Penal Code was amended in 1983 and disclosure of identity of the survivor of rape by anyone was made punishable under a newly added Section 228-A. The publication of name or any matter which may make known the identity of the survivor since

then is thus prohibited. The Supreme Court in State of

Punjab vs Ramdev Singh (2003) held that the name of the victim should not be mentioned in the judgments, be it of that Court, $oldsymbol{+}$ High Court or lower court, and she should be described as 'victim' in the judgment. It therefore implies that anything such as the survivor's husband's name, her email address, etc which could reveal her identity, should not have been mentioned in the judgment. It is against the spirit of the law.

Sensitisation is a must

It is true that the investigation must be unbiased, honest, just and in accordance with the law. The entire emphasis on a fair investigation has to be to bring out the truth of the case before the court. However, some lapses in investigation and ignorance about technical terms such as 'hash-value' with regard to electronic evidence, should not lead to a total rejection of the prosecution case. Many amendments have been made in the criminal laws since 1983 with regard to crimes against women. The police must pull up their socks to improve investigation skills, and the application of the law should not elude justice due to a lack of proper sensitisation among other stakeholders in the criminal justice system.

Education in Kerala

The article, "Higher education in Kerala needs a new chapter" (Editorial page, June 14), has overlooked the fact that 'the linear expansion of arts and science colleges and even professional colleges' in Kerala was part of the strategy to enhance Gross Enrolment Ratio (GER) of the State. It is well known that Kerala could not transmit the success in its school education to its higher education sector. There are social, economic, political and historical reasons for the inter- and intra-regional inequalities education in Kerala. According to baseline data of the Rashtriya Uchchatar Shiksha Abhiyan (RUSA) State Higher Education Plan (I), the GER in Palakkad, Malappuram, Kozhikode,

Wayanad, Kannur and Kasaragod was much lower than the State average of 21.9%, thus justifying the establishment of more higher education institutions in these districts. Setting up of more government colleges and government-regulated aided or self-financing colleges will increase the access to higher education with a very low, or reasonable and affordable fee structure. Twenty arts and science colleges from the State including four government colleges have found a place in the list of top 100 colleges in 2020 in the NIRF ranking for India by the HRD Ministry. Similarly, four aided colleges have been recently reaccredited by the National Assessment and Accreditation Council with a superlative grade of

A++. It is worth mentioning that all these are government-aided colleges. Concerted efforts are needed for more expenditure on higher education, both public and private. To increase the expenditure on higher education as a proportion of Gross State Domestic Product (GSDP) from the present 1% to the targeted 2%, Kerala needs a revamped model of public private partnership (PPP) in higher education. Needed: full disclosure on electoral bonds

The Supreme Court's suggestion to 'match the following' on political donations is impractical and incorrect

In 2014, the Delhi High Court held that both the Congress and the Bharatiya Janata Party (BJP) were guilty of illegally accepting donations from two companies registered in India but whose controlling shareholder was Vedanta, a foreign company. The court held that this was in contravention of the Foreign Contribution (Regulation) Act (FCRA), 1976, as the donations accrued from "foreign sources" within the meaning of law.

Following this indictment, the two parties came together in the last memorable bipartisan move. In 2016 and 2018, the government amended the FCRA through the annual Finance Bills, to retrospectively legalise the violations. The amendments and subsequent changes brought in by the current government enabled new and regressive pathways that afford full anonymity to corporate and foreign political donors.

A new form of anonymity

While recently hearing a Public Interest Litigation (PIL) by the Association of Democratic Reforms (ADR), the Supreme Court downplayed the concerns of the corrupting influence of anonymous corporate and foreign money. It offered us voters the suggestion of "match the following".

Earlier, only profit-making domestic companies could contribute to political parties; now loss-making companies can too. Earlier, foreign companies or companies where the controlling stake was held by a foreign company couldn't contribute; now they can. India's political parties could theoretically be fully funded by a foreign company operating in India or by a foreign entity through a shell company.

In 2017, the then Finance Minister said anonymous cash donations to political parties would be reduced from ₹20,000 to ₹2,000 to ensure greater transparency in political funding. However, the concurrent introduction of electoral bonds brought a new form of anonymity to

thousands of crores of donations. It drastically reduced public and legislative oversight. Only the ruling party via the State Bank of India (SBI) has a full account of all donations being made via electoral bonds, to itself and to Opposition parties. Parliament, the Election Commission and the Opposition parties do not have this information, nor do the public.

The ADR PIL challenges electoral bonds as unconstitutional. In March 2021, the Supreme Court refused to stay the sale of electoral bonds before the West Bengal elections. Instead, the judgment listed several documents which supposedly establish a paper trail on donations - "all that is required is a little more effort to cull out such information from both sides (purchaser of bond and political party) and do some 'match the following'."

This is impractical and plainly incorrect. The Right to Information (RTI) Act of 2005 enables easier access to information held by public authorities. No ordinary person has the resources to navigate documents on obfuscating government websites or pore over income tax returns. The few civic and non-profit organisations that attempt to simplify information to enable accountability have been systematically delegitimised.

Suggesting a "match the following" is incorrect for three reasons. If we set aside individual donors and focus just on registered entities, we will find that the full scale of registered entities is unknown. Even if registered companies filed annual financial statements, many do not disclose political donations. Crucially, political parties do not need to disclose their electoral bond donors

reports are submitted with great delays. For instance, the audit reports for 2019-20 of major national parties were made available on the Election Commission's website only a few days ago. The BJP's report is not yet available as the Election Commission extended the deadline for the submission of Annual Audit Reports for 2019-20 to June 30, 2021. Even if these reports are submitted on time, there is no way to match a donation of a company to that received by a political party as only aggregate amounts are available.

Hence, the "match the following" suggestion of the Supreme Court falls flat on its face. It is impossible for an average voter to pore over documents of lakhs of entities and track potential company and firm donors. Further, recipient-wise information is unavailable. Unlike the tall claims of electoral bonds enabling transparency, it is only RTI applications with the SBI that offer a glimpse into the crores of money funding political parties, and therefore influencing public policies. If they chose to, the Supreme Court or the legislature could order full and real-time disclosure, to the actual benefit of transparency and accountability. Instead, meagre civil society resources are expended in filing PILs and RTI applications, at significant personal risk.

Winners and losers In effect, electoral bonds give political power to companies, wealthy individual donors, and foreign entities, thus diluting the universal franchise of one voter-one vote. Every vote is not equally valuable if companies can influence policies through hidden donations. The winner of this arrangement is the ruling party, whether at the Centre or in a State, and the loser is the average voter. Companies and political parties could exercise moral leadership and voluntarily disclose the identity of recipients and donors, as the Jharkhand Mukti Morcha recently did. Till then, voters are stuck with a ruling party with war chests of resources, being subject to relentless election campaigns, while donors surreptitiously and directly influence policy.

A paradigm shift in vaccination

The COVID-19 vaccination drive demonstrates that India has become Atmanirbhar in vaccination against infectious diseases

In his address to the nation about the new vaccination policy, Prime Minister Narendra Modi said, "If you look at the history of vaccinations in India... you will see that India would have to wait decades for procuring vaccines from abroad. When vaccination programmes ended in other countries, it wouldn't have even begun in our country." His remark reflected the harsh reality of the past. Further, indigenous manufacturing of vaccines not only started late but also fell short of the demand for long. This forced the government to continue relying on imports.

Delay in vaccination

Infectious diseases have been an enormous challenge for independent India. Innumerable lives were lost due to delayed response or government apathy. The best example for this is the case of polio. The Inactivated Polio Vaccine (IPV) and Oral Polio Vaccine (OPV) were licensed abroad in 1955 and 1961, respectively. But it took two decades since international availability for India to initiate mass vaccination. The OPV was introduced through the Expanded Programme on Immunisation (EPI) in urban and rural populations in 1978 and 1981, respectively. Prior to the launch of mass vaccination, India was witnessing more than 10,000 officially recorded cases of polio annually, a severe underestimate due to poor official records. India could have saved lakhs of people from the disease if governments had been vigilant and started vaccination earlier.

Moreover, India had to rely on imports for both OPV and IPV. The OPV was produced by the Pasteur Institute of India, Tamil Nadu, but the Health Ministry closed down this unit in 1974. The IPV could not be manufactured as it was licensed only in 2006.

Similarly, India started mass vaccination for Hepatitis B two decades after commercial availability of the vaccine in the U.S. in 1982. The Hepatitis B vaccination was introduced in India's Universal Immunisation Programme in 2002. And even then, it was only introduced in merely 14 cities.

Earlier, the shortage of indigenously manufactured vaccines led to international dependence and delayed smallpox eradication in India. In 1962, almost a decade after North America and Europe had eradicated smallpox, India launched the National Smallpox

Eradication Programme. Most countries had shifted to the highly potent freeze-dried vaccine for better results. While India had adequate stock of domestically produced low-potency liquid vaccine, there was no production of the freeze-dried vaccine. The country depended almost entirely on the Soviet Union and the World Health Organization (WHO) for supply of the freeze-dried vaccine. Domestic production started in the early 1960s with assistance from the WHO and UNICEF. However, it took the country more than a decade to gradually expand domestic production. This might have been too late. States like Bihar and West Bengal witnessed a smallpox outbreak in 1974 which led to the death of close to 31,000 people. This could have been avoided if the Indira Gandhi government did not neglect smallpox eradication and augmented indigenous manufacturing of the freeze-dried vaccine. India also had to rely on the WHO for bifurcated needles required for the smallpox vaccine as these were not manufactured domestically. In sharp contrast now, Indian companies not only fulfill the domestic demand but are also supplying syringes for CO-VID-19 vaccination to countries.

A remarkable achievement

As Mr. Modi noted, the COVID-19 vaccination drive demonstrates that India has become Atmanirbhar in vaccination against infectious diseases. One must appreciate the scale of mass vaccination happening in the country; in a single day, up to 4.3 million beneficiaries received the COVID-19 vaccines. It is a remarkable achievement that India is conducting the world's largest vaccination drive ever and has already administered more than 25 crore doses. Moreover, rather than starting from selected areas, citizens across the country are simultaneously getting vaccinated. Indians did not have to wait longer than the developed world to receive the CO-VID-19 vaccine. Covishield and Covaxin, manufactured in India, have been available to the people since January 16, 2021. India is one of the few countries across the globe with an indigenously developed vaccine. It is expected that a few more COVID-19 vaccines manufactured in India will be available in the second half of 2021.

The government's decision to make the vaccine available free of cost for the public shows a strong commitment to public health. There is little doubt that the CO-VID-19 vaccination drive marks a paradigmatic shift for the country.

Embracing cryptocurrency

The fact that cryptocurrency has no legal classification should not be the impetus to prohibit its use in India

On June 9, El Salvador became the first country in the world to adopt bitcoin as legal tender. This is illustrative of the rising global trend of embracing cryptocurrencies with all its attendant risks. While not every country's approach has been as open as El Salvador's, the dominant theme has been to permit the growth of the cryptocurrency market subject to certain safeguards. As India finds itself at a crossroads of prohibition and regulation in its tryst with cryptocurrencies, globally, the inclination towards permissive regulation recognises the freedom of choice given to people for using a medium of exchange other than a central bankbacked fiat currency.

Swinging between extremes The cryptocurrency market in India has developed in a largely laissezfaire regulatory space since the first recorded cryptocurrency transaction in 2010. Between 2013 and 2018, the government's response to the rise of virtual currencies was cautionary, alerting users to the potential risks posed by cryptocurrency transactions. These fears were legitimate and stemmed from cryptocurrencies' volatility, their susceptibility to hacking, and the fact that they could potentially facilitate criminal activities such as money laundering, terrorist financing and tax evasion. Instead of developing a regulatory framework to address these issues, the Reserve Bank of India (RBI), in April 2018, effectively imposed a ban on cryptocurrency trading. This ban was overturned by the Supreme Court in 2020. The court reasoned that there were alternative regulatory measures short of an outright ban through which the RBI could have achieved its objective of curbing the risks associated with cryptocurrency trading. While the court had an opportunity to put a label on the legal nature of cryptocurrencies, stopped short of doing so.


After swinging between the extremes of non-interference and prohibition, a clue as to India's next move lies in the draft Cryptocurrency and Regulation of Official Digital Currency Bill, 2021. The draft Bill proposes to criminalise all private cryptocurrencies while also laying down the regulatory framework for an RBIbacked digital currency. The Minister of State for Finance, in response to a question in Parliament, stated that regulatory bodies do not have a legal framework to directly regulate private cryptocurrencies owing to their imprecise legal nature in India. As the draft Bill is yet to be tabled in Parliament, there is some hope that his concerns will be addressed in the form of a tailored regulatory approach rather than another ban.

Lessons from other countries

There are lessons in this regard from the U.K., Singapore and the U.S. The U.K. has classified cryptocurrency as property and this has paved the way for cryptocurrencies to be encompassed within a regulated legal framework in the country's economy. The U.K. has sought to regulate the functioning of crypto-businesses while still imposing some restrictions to protect the interests of investors. On the other hand, while there is no exact legal classification of cryptocurrency in Singapore, the amenability of cryptocurrency transactions to the contract law framework of the country has been firmly established and there is now a legal framework for cryptocurrency trading. In the U.S., the open approach taken by the authorities has resulted in the trade in cryptocurrency being both taxed and appropriately regulated. While the approaches are specific to the countries' economic realities and cannot be blindly implemented in India, the global regulatory attitude towards cryptocurrencies offers valuable insights into the alternative ways to achieve balanced regulation. In India, the absence of an existing legal classification of cryptocurrency should not be the impetus to prohibit its use. The government should use this as an opportunity to allow private individuals the freedom to harness a powerful new technology with appropriate regulatory standards.

FIFTY YEARS AGO JUNE 16, 1971

Bangla Desh solution receding: PM

The Prime Minister, Mrs. Indira Gandhi, told the Rajya Sabha to-day [New Delhi, June 15] that with each passing day the possibility of a political settlement in Bangla Desh was becoming more remote. She dismissed fears that India would acquiesce in a political settlement at the cost of democracy and the rights of the people fighting there and said that any settlement "must be arrived at with those people who are to-day being suppressed." The Prime Minister who was replying to a four-hour debate on the situation caused by the influx of six million refugees, assured the House that this nation would make all the sacrifices and even "go through hell" to look after the refugees. Stressing the responsibility of the international community in a situation which not only resulted in a colossal refugee influx, but also involved the question of democracy and human rights, Mrs. Gandhi said India's Ministers and other emissaries who had gone abroad had some successes in bringing home the reality of the situation to those countries. "We are not going to allow the international community to get away with it. They have to realise it is their responsibility," she said.

A HUNDRED YEARS AGO JUNE 16, 1921

Ceylon and the Civil Service.

We understand that under the new rules made by the Ceylon Government to regulate the admission of Ceylonese to the Civil Service, the door has been shut against Indians. The Service in Ceylon will be recruited in future on a percentage basis, two-thirds being Britishers and one-third Ceylonese. The Ceylon Daily News comments thus on the change: "When the Government minute giving effect to this arrangement was published, we early warned the Government that this is bound to provoke India to retaliate. India, as soon as it becomes aware of the ban placed on her own, will effectively bar her doors against the admission of Ceylonese into the Indian Civil Service. Thus, under the plea of enlarging opportunities for Ceylonese in Ceylon, the Government is going about the best way of depriving the Ceylonese of the splendid and more profitable opportunities they have enjoyed in India... It would be well for the Government to remember while there is still time that not in the Civil Service alone are Indians employed. Quite a good few of them are employed in other places."

Delhi riots: 3 student activists granted bail

Ruling that no offence under the anti-terror law is made out against any of the three student activist, the High Court said, "the phrase 'terrorist act' cannot be permitted to be applied in a cavalier manner to criminal acts or omissions that fall squarely within the definition of conventional offences as defined inter alia under the IPC (Indian Penal Code)"

The Delhi police had maintained that the accused engaged in "sloganeering and instigating the public against the government" and tried to create a "communally surcharged environment" with the intent to disrupt the unity and strike terror.

Responding to this, the High Court observed, "We find ourselves unpersuaded and unconvinced with this submission since we find it is not founded on any specific factual allegation and we are of the view that the mere use of alarming and hyperbolic verbiage in the subject charge-sheet will not convince us otherwise".

'Stronger foundations'

"The foundations of our nation stand on surer footing than is to be likely to be shaken by a protest, however vicious, organised by a tribe of college students or other persons, operating as a coordination committee from the confines of a University situated in the heart of Delhi," the High Court observed.

The prosecution case against Ms Kalita is that as part of a women's rights group called Pinira Tod, and other activistic groups, she had participated in a 'larger conspiracy' which led to violence and rioting in the north-east Delhi.

Research must follow protocol, says Ministry

'New mechanisms will be in place'

All research work has to follow a process and action will be taken if protocols are not followed, said the Health Ministry on Tuesday to a question on a probe into a filovirus study of bats in Nagaland undertaken by the Bengaluru-based National Centre for Biological Sciences (NCBS) and the Tata Institute of Fundamental Research (TIFR).

The Ministry's response follows the report "Government report flags 'lapses' in Nagaland bat study" published in The Hindu on

The Hindu first reported the study in February 2020 on the inquiry being initiated into whether adequate permissions had been sought for the study that according to a Central government report now specified "concerning lapses" in the conduct and protocols

Health Ministry Joint Secretary Lav Aggarwal on Tuesday said: "There are protocols for all research work undertaken and wherever there are lapses action will be taken to ensure that mechanisms are put in place to rectify the situation."

The Ministry is also concerned about the storage of the Nagaland bat samples. The Ministry wants the samples to be at the Biosafety Level-4 (BSL-4) standard facility at the National Institute of Virology laboratory in Pune rather than NCBS's Bengaluru facilities that are rated BSL-3. It said samples must be handled in a laboratory equipped for "biosafety and biosecurity conditions' as they can pose a "significant public health hazard". This when the Department of Atomic Energy noted that the samples were "non-infectious" and had been checked for the presence of filoviruses (Ebola and Marburg). Asked about the zoonotic pathogens and need to protect against any spill-over - the Nagaland bat study on filoviruses (Ebola and Marburg) is in no way related to the coronavirus (SARs) studies at Wuhan - Mr. Aggarwal said laboratories had to be supported to ensure that pandemics are prevent-

Comments sought on draft rules on compensation

The Central government has allocated 78,000 tonnes of rice procured for food security purposes to be diverted to ethanol production instead this year, at a subsidised rate of ₹20 a kg, Food Secretary Sudhanshu Pandey said on Tuesday. However, he insisted that the share of rice in ethanol production was "miniscule and transitory", emphasising that maize would form the primary feedstock for grain-based ethanol produc-

This is part of the government's plan to double distilling capacities by 2025, partby encouraging an increase in the share of grain-based ethanol production from the current focus on molasses-based produc-

tion instead.

Earlier this month, Prime Minister Narendra Modi presented a road map advancing the target date for

achieving 20% blending of ethanol in petrol by five years to 2025. The last two vears have seen blending le vels of around 5%, which is likely to jump to 8.5% in the current year, according to a

Ministry statement. Mr. Pandey told presspersons that the Centre was targeting an ethanol production of 1,500 crore litres by 2025, out of which almost half, 740 crore litres, would be from grain-based distilleries, with the remainder coming from sugar-based distilleries. Currently, about a third of the 710 crore litre ethanol production capacity comes from grains. Only 38 crore litres of grain-based ethanol is used for fuel.

This year, the Centre had committed for about three lakh tonnes of rice procured by the Food Corporation of India ethanol production.

However, only 78,000 tonnes would be lifted by six distilleries, said Mr. Pandey.

The breaking away of the majority of the Lok Janshakti Party (LJP) parliamentary unit from Lok Sabha MP Chirag Paswan to form an independent group in the Lower House, had the full backing of the BJP as well as the Janata Dal (U), and will have far reaching consequences for the NDA equations in Bihar.

According to those aware of the run-up to the dramatic developments on Monday, the seeds of this split were sown on the day the results of the Bihar elections were being announced last November. The BJP had almost immediately reached out to the LJP's lone MLA, Raj Kumar Singh to secure his support in a delicately balanced House and got his backing for the Speaker's election.

"We were still talking to

him when the Janata Dal(U) got him to join their party. We were of the opinion that if he had stayed as an Independent he could have been made Minister," said a senior Bihar BJP office-bearer.

Personal equations

After that, both NDA partners were in constant touch with the five MPs of the LJP, in effect isolating Mr. Chirag

The fact that the breakaway LJP has been recognised as a separate party with five MPs, means that the split between the two NDA allies - the BJP and the JD(U) - remains at 17 and 16 seats respectively in the Lok Sabha, with Mr. Paras in a strong position to claim the single Ministerial berth in the Union Council of Ministers promised to the LJP, whenever the next resh-

"If the LJP had merged with the JD(U) parliamentary party, they would have had 21 seats, four more than the BJP; their claim on multiple Ministerial berths would have been stronger, and the struggle with which we (BJP) have shrugged off the junior partner status to ID(U) in Bihar would have been for nought in future negotiations," said a source.

This intricate cut and thrust of alliance politics in a State which is considered to have the most political of electorates is far from over. Mr. Paras will have to do his best to emulate his canny elder brother, the late Ram Vilas Paswan, to stay afloat, while Mr. Chirag Paswan will have to go back to the starting point, albeit much diminished. Coup in LJP is part of JD(U)'s long-term plan

Nitish bid to bolster party in Bihar

The coup in the Lok Janshakti Party (LJP), culminating in the isolation of Chirag Paswan, son of its founder, Ram Vilas Paswan, is just one of the series of attempts made recently by the Janata Dal(U) and Bihar Chief Minister Nitish Kumar to bolster his party after its below par performance in the 2020 Assembly election.

Within seven months of returning as Chief Minister for a record fourth time, Mr. Kumar has been trying to put the house in order. The JD(U) won 43 seats (15.39% of the vote share) in the election, relegated to the third position behind the RJD (75 seats and 23.11% vote share) and the BJP that got 74 seats and 19.4% of votes.

"We did not lose this election, we were tactically defeated by those with us and those against us. The LJP's campaign, which could not have happened without a tacit understanding of the BJP, defeated 46 of our candidates," a JD(U) leader said.

While sitting in the driving seat, the BJP expected him to play the second fiddle, a position he has never been comfortable with.

Nitish's moves

His first step was to put his own house in order. So in December, he appointed R.C.P. Singh in his place as the party's national president. Mr. Singh belongs to the Kurmi caste. To balance the caste arithmetic, two weeks later, Umesh Kushwaha, a low-key leader, replaced Bhashist Narain Singh as the State president. Mr. Kushwaha belongs to the Koeri caste.

Then Mr. Kumar got down to bringing others into the fold. On January 22,

He had walked out in 2013 to form the Rashtriya Lok Samata Party. In the 2020 elections, where the party fought in alliance with the BSP and the AIMIM, Mr. Kushwaha hurt the JD(U) in 25 seats.

In April, the lone LJP MLA, Rajkumar Singh, joined the JD(U), taking the BJP by surprise. Mr. Singh

had walked out of the BJP to join the LJP ahead of the 2020 polls and the BJP was expecting his return.

'The script that Pashupati Nath Paras read out on Monday was definitely not his own. This is the signature style of Mr. Nitish Kumar, who had, post 2010, tried to break the RJD too. Engineering the LJP coup, Mr. Kumar also wants to send a message to the BJP," RJD MP Manoj K Jha told The Hindu.

Speculation is on that the LJP split is not the last political event on the cards. The JD(U), sources claim, is talking to the 19 Congress legislators and five AIMIM MLAs too. It wants to be on an equal keel as the BJP, free from its pressure and influences.

Party general secretary K.C. Tyagi denied any direct role of the JD(U) in the LJP coup. He said his party was doing essential housekeeping. "Our aim and goal is to return to the position we were in 2009 when we won 118 seats, to revive the same acceptability that Mr. Nitish Kumar enjoyed then," he ad-

With Pilot losing support, no early Cabinet expansion in Rajasthan

Several MLAs have expressed faith in CM Ashok Gehlot's leadership

MOHAMMED IQBAL

With former Deputy Chief Minister Sachin Pilot losing his grip on the MLAs who sided with him during the last year's political crisis, the Cabinet expansion and political appointments in Rajasthan are likely to get delayed.

Several of the MLAs considered loyal to Mr. Pilot have expressed faith in CM Ashok Gehlot's leadership.

Sardarshahar MLA Bhanwarlal Sharma,, oldest legislator in the Assembly at 76, said here on Tuesday though he considered Mr. Pilot his leader, Mr. Gehlot was above him in his capacity as the CM.

"Even Mr. Pilot will have to respect him as his leader," Mr. Sharma, who had stayed with the former Deputy CM during his rebellion, told reporters here.

Mr. Sharma said he had camped along with Mr. Pilot outside Rajasthan during the rebellion because the public works in his constituency were not being done by the State government. "I have no complaints against the government now... The issue of resentment in Congress is being exaggerated."

Future moves

The septuagenarian Congress leader is the third Pilot loyalist, after Viratnangar MLA Indraj Gujjar and Todabhim MLA P.R. States hit by unequal supply of vaccines Govt. confirms first death


T.N., U.P. and Bihar get fewer doses from Centre despite high utilisation, show data from RTI query

CHENNAI

The States such as Tamil Nadu, Uttar Pradesh and Bihar continue to experience a crunch in their COVID-19 vaccine supply, while those such as Chhattisgarh, Himachal Pradesh and Gujarat are enjoying a relatively better stock position, data from an RTI query reply reveal.

Till June 9, nearly 25 crore COVID-19 vaccine doses have been supplied to the States and the Union Territories by the Centre and through the direct State procurement channel, the RTI reply reveals. This was about seven crore doses more than what was supplied about a month back on May 11.

A State-wise analysis of the doses received on both these dates relative to the adult population shows that supply to some States continues



to increase at a higher rate than others. For instance, with the number of doses supplied till May 11, Tamil Nadu could have potentially given one dose of the vaccine

to 13.2% of its adult population. A month later, as on June 9, the share of such adults has barely improved to 17.5%. In West Bengal, the share has slightly improved

from 17.2% to 22.5% in the considered period.

On the other hand, in Himachal Pradesh, the share of adults who could have potentially got a dose in the considered period has improved from 39.9% to 52.8%. In Gujarat, the share has gone up from 29.6% to 39.6%.

The population figures are based on government estimates for the year 2021.

The unequal distribution of doses continues to grow despite a high utilisation rate in most of the States. For instance, Tamil Nadu acquired 1.01.07.190 doses from the Centre and through its own channel till June 9. Of these 97,65,284 doses - 96.5% have been utilised by the State till 8 p.m. on June 9. The figures do not include procurement and administration by private hospitals.

States such as Uttar Pradesh and Bihar too have utilised more than 90% of the doses supplied, according to vaccine administration data published by the Union Health Ministry on June 10.

out by the panel. N.K. Arora, Adviser, National AEFI Committee, told The Hindu: "It is the first death linked to COVID-19 vaccination due to anaphylaxis. But compared to the overall numbers, only a small number had a severe reaction. Those getting their vaccination need to wait for 30 minutes at the inoculation centre after vaccination as most of the anaphylactic reactions occur during this period and prompt treatment prevents deaths.

It added that mere reporting of deaths and hospitalisations as serious adverse events does not automatically imply that the events were caused due to vaccines.

The report said the results of the causality assessment of 31 cases approved by the national AEFI Committee on February 5 (five cases), March 9 (eight cases) and March 31 (18 cases) have been released after thorough review and deliberations.

"Only properly conducted investigations and causality assessments can help in understanding if any causal relationship exists between the event and the vaccine," the report said, adding that for causality assessments, priority has been given to

The Health Ministry on Tuesday said the number of deaths reported following COVID-19 vaccination in the country is only 0.0002% of 23.5 crore doses administered which is within the expected death rates in a population. It is also important and pertinent to note that the mortality rates for those testing positive for COVID-19 disease is more than 1% and COVID-19 vaccination can prevent these deaths. Therefore, the risk of dying following vaccination is negligible as compared to the known risk of dying due to CO-VID-19 disease, it said.

The Health Ministry added that AEFI is defined as 'any untoward medical occurrence which follows immunisation and which does not necessarily have a causal relationship with the usage of the vaccine.

"It can be any unfavourable or unintended sign, abnormal laboratory finding, symptom or disease. Healthcare workers, doctors and vaccine recipients have been always encouraged to report all deaths, hospitalisations and events resulting in disability as well as any minor and adverse events following immunisation at any point of time after vaccination," said the release.

Charu Goyal Sachdeva, HOD, Internal Medicine, HCMCT Manipal Hospitals, added that there should be no fear or apprehension about COVID vaccines. "Taking vaccines is advisable even for people who have had the COVID-19 infection. Vaccination should be done after the government prescribed window period following COVID," she said.

IICT inks pact with pharma firm for 2-DG

CSIR-Indian Institute of Chemical Technology Hyderabad (IICT) and Anthem Biosciences Pvt. Ltd., a Bengaluru-based integratbiopharmaceutical company, signed an agreement for technology transfer and manufacture of the anti-COVID drug 2-DG or 2-Deoxy-D-Glucose on Tuesday.

Studies have shown that the oral drug 2- DG has demonstrated quick recovery and reduction in oxygen dependence among moderately and severely affected patients. This drug in the form of powder formulation was earlier launched Dr. Reddy's Laboratories.

Under the agreement, Anthem Biosciences Pvt. Ltd. gets non-exclusive license for the process knowhow for synthesis of 2-DG . "The agreement is in-line with CSIR's efforts to help people access various therapeutic options to combat COVID-19. CSIR labs have undertaken clinical trials various repurposed drugs for the treatment of COVID-19," said IICT Direc-

tor S. Chandrasekhar. Anthem Biosciences Pvt. Ltd. is in the process of filing the application for getting the approval from Drugs Controller General of India, New Delhi, and will manufacture and commercialise 2-DG from their facilities located at Bommasandra and Harohalli in

Karnataka. The firm has also developed domestic vendors for key raw materials for uninterrupted supplies to manufacture 2-DG.

'Jabs help against hospitalisation'

2 doses of AstraZeneca or Pfizer vaccines effective against delta variant: study

A real-world study undertaken by Public Health England in 14,019 people infected with the delta variant (B.1.617.2) in England found that vaccination with two doses of AstraZeneca and Pfizer offered high protection against hospitalisation. Of the 14,019 people infected with the delta variant, only 166 required hospitalisation. The study was undertaken between April 12 and June 4.

In the case of the AstraZeneca, effectiveness against hospitalisation after full vaccination was 92%, while it was 96% in the case of Pfizer. The results have been posted

as a preprint. Preprints are yet to be peer-reviewed.

Public Health England had earlier found that despite modest reductions, vacremain effective against the delta variant. It found that full vaccination offered good protection against symptomatic disease.

effectiveness

against symptomatic disease was 67% in the case of Astra-Zeneca and 88% with Pfizer.

Single dose

Effectiveness against hospitalisation was high even with one dose of AstraZeneca and Pfizer vaccine. In the case of delta variant, one dose of AstraZeneca vaccine offered 71% protection, while two doses offered 92% protection. In the case of Pfizer vaccine, the protection was 94% after one dose and 96% after

"This is reassuring data for India. In order to choose our way forward, I think we should use modelling approaches that lay out different implementation strategies and compare their impact at different stages of the pandemic," says Dr. Gagandeep Kang, Professor of Microbiology at CMC Vel-

Another study posted as a preprint on May 24 found that protection against all symptomatic infections after a single dose of AstraZeneca was only 33.5% against the delta variant and 51.1% against the beta (B.1.1.7) variant. After the second dose, the protection against all symptomatic infections increased to 59.8% in the case of the delta variant and against the beta 87.9%

Odisha records sharp decline in daily COVID-19 cases

State govt. is contemplating easing lockdown restrictions

Odisha on Tuesday reported 3,405 COVID-19 positive cases, registering a sharp drop in daily cases. Compared to 4,339 cases reported on Monday, the State found 3,405 persons testing positive afresh - a decline of 21.52% on a single day.

With 3,405 samples of the 56,807 tests that were conducted during the past 24 hours turning out to be positive, the test positivity rate is estimated at 5.99%.

The Health and Family Welfare Department said 8,735 persons had tested positive while the TPR was 14.2% on June 1. A remarkable improvement has been rising rapidly initially in the noticed in the past fortnight. second wave are returning

As per State government's audited death report, 42 persons were reported to have succumbed to CO-VID-19 taking the toll to 3,388 on Tuesday.

Active cases

Only five of the 30 districts have active cases higher than 2,500 while 12 other districts have active cases between 1,000 and 2,500. Active cases have fallen below 1,000 in 13 districts.

Western Odisha districts such as Nuapada, Balangir, Kalahandi, Sambalpur, Bargarh, Jharsuguda and Sundargarh where cases were





Krishna knew asva sastra. He knew how to treat horses of different kinds - war horses; horses used in chariots other than war chariots; and race horses. Not only did the Supreme One take orders from Arjuna when the fighting was on, but spent the remaining hours of the day also serving Arjuna by looking after his horses. He showed us that we must do our duties without fail.

In the Gita, He says that He had already taught karma yoga to Vivasvan. Vivasvan, in turn, taught karma yoga to Manu, who taught Ikshvaku. Krishna says we must do our Karma without pride. And He demonstrates how this is to be done, when He takes care of Arjuna's horses. At the same time, He is also an Acharya to Arjuna, and His discourse to Arjuna is the invaluable Gita. He shows His Supremacy to Bhishma on the battlefield. Krishna had vowed that He would merely drive Arjuna around, but would not Himself pick up a weapon. Bhishma vowed that He would ensure that Krishna picked up a weapon. To make sure that Bhishma's vow was fulfilled, Krishna picked up the discus during the war. Thus He showed that He was the loving God, who cared so much for His devotees that He would make sure their words came true.

U.S. moves to tackle domestic terrorism

It announces a national strategy that focuses on 'prevention, interruption and dissuasion'

The U.S. government on Tuesday unveiled its "national strategy" to fight domestic terrorism, an issue that is a priority for President Joe Biden after the assault on Congress in January and the rise of white nationalist extremists.

"Domestic violent extremists motivated by a range of ideologies pose an elevated threat to our country in 2021," a senior administration official told mediapersons, speaking on condition of anonymity.

"Racially or ethnically motivated violent extremists, and specifically those who espouse the superiority of the white race and anti-government militia violent extremists, [pose] the most

The government's plan is, however, "ideologically neutral" and consists of four pillars that focus on "prevention, interruption and dissuasion", while preserving individual freedoms.

In March, FBI chief Christopher Wrav told Congress that the number of federal investigations working on "domestic terrorism" had doubled from 1,000 to 2,000 since he took office in 2017.

The U.S. was shocked by the deadly January 6 assault on Congress by Trump supporters. Nearly 500 people have been arrested for their roles in the attack, according

'Trump pressed Justice Dept. to probe poll fraud claims'

Emails show he sought DoJ support for his legal efforts

During the last weeks of his presidency, Donald Trump and his allies pressured the Department of Justice (DoJ) to investigate unsubstantiate ed claims of widespread 2020 election fraud, despite his former Attorney-General declaring there was no evidence of it, newly released emails show.

The emails, released Tuesday by the House Oversight Committee, reveal in new detail how Mr. Trump, his White House chief of staff and other allies pressured members of the U.S. government to challenge the 2020 election over false claims, even though officials at Ho-

meland Security and Justice, as well as Republican election leaders across the country, said there had been no pervasive fraud. Former Attorney General William Barr, a long-time Trump loyalist, was among those who said there was no evidence of such fraud.

The emails also show the extent to which Trump worked to enlist then-acting Attorney General Jeffrey Rosen in his campaign's failing legal efforts to challenge the election result, including suggesting filing a brief with the U.S. Supreme Court.

The ones sent to Mr. Rosen include debunked conspiracy theories and false information about voter fraud.

Mr. Trump's chief of staff, Mark Meadows, asked about investigating allegations of voter fraud caused by satellites from Italy. Mr. Meadows tried to have Mr. Rosen investigate the conspiracy theories and pushed the acting Attorney General to meet with an ally of Trump lawyer Rudy Giuliani who was pitching unfounded election conspiracies.

U.S.-Russia ties are at an impasse: Kremlin official

Biden and Putin will meet today

A top aide to Vladimir Putin said U.S.-Russia relations are at an "impasse" but this week's summit with Joe Biden in Switzerland could help ease tensions.

Mr. Putin and Mr. Biden are to meet at a villa in Geneva on Wednesday with tensions high over a long list of disputes, from cyberattacks and election meddling to human rights violations.

"Russian-U.S. relations are now at an impasse, the situation is close to critical. Something needs to be done," Yuri Ushakov, Mr. Putin's foreign affairs adviser, told mediapersons ahead

of the summit. "I view this meeting with practical optimism, but not much. It is a first meeting under difficult

circumstances," he said. Ambassadors' return

Mr. Ushakov said the Russian and U.S. ambassadors, who returned home this vear amid tensions over sanctions, could go back to their posts immediately if the summit goes well. "It will be a tremendous achievement if the ambassa-

dors return to work." Mr. Ushakov said the two leaders would discuss cybersecurity, climate change, the Arctic and regional conflicts, among other issues.

Statement by NATO is slander: China

The Chinese mission to the European Union denounced a NATO statement that declared Beijing a "security challenge", saying China is a force for peace but will defend itself if threatened.

The Chinese news release said the NATO statement was a "slander on China's peaceful development, a misjudgment of the international situation and [NATO's] own role, and a continuation of the Cold War mentality". NA-TO allies joined the U.S. on Monday in formally criticising Beijing as a "constant security challenge".

Taiwan reports 'largest' incursion by Chinese forces

'28 aircraft entered the air defence identification zone'

As many as 28 Chinese air force aircraft, including fighters and nuclear-capable bombers, entered Taiwan's air defence identification zone (ADIZ) on Tuesday, the island's government said. It is the largest reported incursion to date.

While there was no immediate comment from Beijing, the news comes after the Group of Seven leaders issued a joint statement on Sunday scolding China and underscored the importance of peace and stability across the Taiwan Strait.



The incursion involved J-16 and J-11 fighters, as well as H-6 bombers.

SMAL was incorporated in December last year with a paid up capital of ₹1 crore to manufacture and sell electric vehicles (EVs).

AIRA to aid development of debt market

Two credit rating agencies (CRAs) have established 'Association of Indian Rating Agencies' (AIRA). AIRA is expected to work closely with the regulator and government for debt-market development, the agencies said. While Care Ratings Ltd. and Acuité Ratings & Research Ltd. are the founding members, two more CRAs may join soon, Care and Acuite officials said.

NBFC Authum set to buy

Reliance Home Finance Authum Investment and Infrastructure Ltd. has emerged as the highest bidder for Reliance Home Finance, a group company of the debt-ridden Anil Ambanipromoted Reliance Group, with ₹2,887 crore offer. Sources said lenders led by Bank of Baroda would receive ₹2,887 crore of which ₹2,587 crore, or 90%, would be paid upfront and

Inflation spurs spike in bond yield; rupee hits 1-month low

Latest data would make RBI wary of continuing to boost liquidity, says economist

India's benchmark 10-year bond yield closed at its highest level in more than six weeks while the rupee ended at a one-month low on the back of a larger-than-expected surge in retail inflation.

The benchmark 10-year bond yield ended at 6.04%, after touching 6.05%, its highest since April 30 and up 4 basis points on the day.

Retail inflation rate rose 6.3% year-on-year in May, from 4.29% in April and sharply above analysts' estimate of 5.3%. The wholesale price inflation rate rose 12.9%, its highest in at least two decades.

Traders are worried the

spike in inflation beyond the RBI's mandated target band of 2%-6% could force it to act sooner on inflation, but two senior sources said the growth focus will continue for the time being.

"The latest data would make RBI wary of continuing to boost liquidity in a big way, and whether RBI stops unwinding its forwards book, or limits bond market intervention to announced G-SAP will be closely eyed," Abhishek Upadhyay, economist at ICICI Securities Primary Dealership said in a note.

The G-SAP or government securities acquisition programme of the RBI has been crucial in ensuring the government's massive ₹12.06 trillion borrowing programme goes smoothly, and more measures may be needed to support markets.

The rupee closed at 73.3125 per dollar aftertouching 73.32, its weakest since May 14.

Traders said inflation and demand for dollars by importers weighed on the local unit and they would keenly watch out for the outcome of the upcoming Fed meeting.

Exports surge 69%, trade deficit widens

India's exports rose by 69% to \$32.3 billion in May, driven by healthy growth in sectors such as engineering, petroleum products and gems and jewellery, even as the trade deficit widened to \$6.3 billion, according to government data released on Tuesday.

Imports grew by almost 74% to \$38.6 billion - leaving a trade deficit for the month at \$6.3 billion.

Exports during April-May this year jumped to \$62.9 billion, from \$29.4 billion in the year-earlier period. Imports were recorded at \$84.3 billion, an increase from \$39.3 billion in the same two months of 2020. The trade deficit came in at \$21.4 billion, as against \$9.9 billion.

Retail sales decline 79% from two years earlier

Need government support, says RAI

Retail sales in India slipped 79% in May compared with pre-COVID sales in the same month in 2019, as businesses across States were closed due to the second wave of the pandemic, a survey by Retailers Association of India (RAI) showed.

The decline in sales was the steepest in West and North India, which witnessed an 83% dip last month as compared with May 2019, RAI said in a statement.

Eastern region saw a decline of 75%, while South was relatively better with a contraction of 73% as compared to the same month in 2019. On a sequential basis, the decline in May was much steeper compared to



overall sales across India were down 49% as compared with April 2019, the survey showed.

"Retailers are looking forward to some improvement in June with gradual unlocking. However, the industry needs the collective support of various government bodies to tide over the present situation," RAI CEO Kumar Rajagopalan said.

Canara Bank to buy 12% stake in bad bank

Canara Bank said it will be the lead sponsor of National Asset Reconstruction Company Ltd. (NARCL), or bad bank, with a 12% stake in the entity

"The board of Canara Bank has given in-principle approval for taking stake in NARCL," Canara Bank said in a regulatory filing.

Following the board nod, the bank has sought the approval from the Reserve Bank of India (RBI) for participating in NARCL as a sponsor contributing

RBI restrains DHFL from taking deposits

Move precedes nod for Piramal buyout

The Reserve Bank of India (RBI) has revoked the deposit-taking status of Dewan Housing Finance (DHFL), the first financial services firm to go for bankruptcy proceedings

The central bank had reclassified DHFL as a non-deposit taking housing finance company, before approving the Piramal Group's bid to take over it towards the end of the resolution process.

This was revealed in the June 7 order of the NCLT Mumbai approving the ₹35,250-crore bid by Piramal Capital & Housing Finance, forcing a more than 65% haircut on creditors and just ₹1 to NCD holders to



whom the firm owes more than ₹45,000 crore.

The changes were made in February 2021, after the banking regulator gave a noobjection to the January 25, 2021 application by R. Subramaniakumar, the DHFL administrator, citing Rule 5 of its FSP (financial services providers) Rules.

Max Life settles 33% more death claims

Adani Group shares close on a mixed note

Flagship Adani Enterprises gains 2.45%

A day after seeing a sharp plunge, shares of Adani Group companies closed on a mixed note on Tuesday.

On Monday, the group said that accounts of three Mauritius-based funds that own the conglomerate's stocks were not frozen amid reports to the contrary.

Six Adani Group companies, including the flagship Adani Enterprises, are listed on the bourses.

On Tuesday, Adani Enterprises gained 2.45% to ₹1,538.05 and Adani Green Energy jumped 2.79% to ₹1,208.75 on the BSE. Amid bullish sentiments, the 30share Sensex on Tuesday touched fresh lifetime closing and intraday highs. In contrast, Adani Trans-

mission tumbled 5% to ₹1.441.40 while Adani Total Gas tanked 5% to ₹1,467.35. Shares of Adani Power slumped 4.97% to ₹133.90 and that of Adani Ports and Special Economic Zone declined 0.94% to ₹761.45.

Shares of Adani Group firms plunged on Monday after reports that the National Securities Depository Ltd. froze the accounts of the three foreign funds that were among the top stakeholders in the firms.

While the group said all the accounts of its top shareholder funds were active, NSDL, in an email to the group, had also confirmed their 'active' status.

'Govt. to speed up CCI probe of Amazon'

India's antitrust watchdog plans to expedite a restarted probe into allegations of anti-competitive behaviour at Amazon and Walmart's Flipkart unit, as it intensifies scrutiny of big-tech firms, two people close to the matter said.

The comments come as major U.S. technology firms including Twitter and Facebook are at loggerheads with the government over issues such as data privacy bills and policies some industry executives have called protectionist.

The CCI initiated a probe last year on a complaint alleging Amazon and Flipkart promoted select sellers on their platforms.

U.S. arbitrator tells DRL unit to pay \$46.25 mn

Ruling backs Australia's Hatchtech Pty

was issued by the International Centre for Dispute Resolution, U.S., the pharmaceuticals company said it was exploring all legal options to challenge the award. The subsidiary had been

Covaxin at ₹150 to Centre not sustainable: Bharat Biotech

Higher price in private markets needed to offset costs

SPECIAL CORRESPONDENT HYDERABAD

Covaxin maker Bharat Biotech has said the price of ₹150 per dose at which the vaccine is being supplied to the Centre is a non-competitive price and 'clearly not sustainable in the long run'.

A higher price in private markets is thus required to offset part of the costs, the Hyderabad-based vaccine maker said on Tuesday amid questions on the differential pricing followed for supplies to various sectors.

Vaccine pricing depends on several factors, from cost of goods and raw materials, product failures, at risk product development outlays, product overages, capital ex-



penditure for setting up manufacturing facilities, sales and distribution expenses, procurement volumes and commitments, the firm said. It added that it had so far invested over ₹500 crore 'at risk' for product development, clinical trials and setting up of manufacturing facilities for Covaxin.

Observing that less than 10% of the Covaxin output had been supplied to private hospitals, the company said the weighted average price of Covaxin for all supplies realised by it was less than ₹250 per dose. Unlike most medicines,

vaccines were provided free of cost by the Centre to all eligible citizens. Hence, procurement of vaccines by private hospitals was optional and not mandatory, the company contended.

"In our view, the question of product pricing is only of extraneous interest to all concerned, especially when the same vaccine is made available free of cost," Bharat Biotech said.

Mithali & Co. short on practice but high on confidence as they meet England

When Mithali Raj made her international debut, the third millennium hadn't dawned yet. She was only 16 when she made an unbeaten 114 against England in an ODI at Milton Keynes to announce her arrival, in 1999.

More than two decades later, she is still the mainstay of the Indian women's team, that takes on England in the one-off Test at Bristol from Wednesday. The captain sounded confident on the eve of the match.

She, however, isn't thinking of the record that beckons India - most successive Test wins. India has won its last three Tests and no country has won four in a row.

"I am not looking at the record," Mithali, who became the second woman to score 10,000 international runs three months ago, said at a virtual conference on Tues-

Debutants

Since India's last Test was played seven years ago, a few youngsters are bound to make their debut at Bristol. With hardly any red-ball cricket on India's women's domestic circuit, they could find the long format particularly challenging.

"You don't want to burden them with expectations and responsibilities," said Mithali. "As a team we would support them on the field and they should just enjoy playing this format."

She hopes the current tour could be a new beginning as far as women's Test cricket is concerned. "This and the pink-ball Test in Australia later on - opens the channel to have a three-format bilateral series," the skipper said.

"Cricketers still want to play the longer format. Because... that is the format that tests the skills of the players. Maybe in the coming years, it might also lead to a World Test championship."

After making her Test debut in 2002, she has played only nine more. None of those Tests had attracted as much attention as the one that is about to get underway as it will be telecast live.

Former India batsman Laxman, Ian Bishop and Shane Bond spoke in a virtual press conference organised by official broadcaster Star Sports. "India starts as favourite.

India has been the most consistent team, both home and away, in this two-year Test cycle. There is so much depth and experience in this Indian line-up. New Zealand may have an advantage having just played a Test series in England, but this Indian team is capable of overcoming any challenge," Laxman said. The Hyderabad stylist

stated that the Indian openers, Rohit Sharma in particular, should avoid fishing outside off. "It is very important for every opener to know where his off-stump is. Leaving balls outside off, in the channel of uncertainty, is something which Rohit should focus on. Rohit has another challenge in the form of Trent Boult, who brings the ball in. He also knows that against Boult, he cannot take his left leg across. Rohit has to play with the full face of the bat. These are two things that Rohit needs to address at the start of his innings," Laxman said.

"Boult was swinging the ball, hitting Rohit on the pads, and telling him,

The International Tennis Federation (ITF) will first work on the list of 56 direct entrants in singles for men and women. It will also award the final eight ITF qualification places to the eligible continental

When do you play your best team in a series? It's a question modern captains and coaches have to answer. This, just after they have answered a more important one: Which is your

best team? Two recent series victories, India's in Australia, and New Zealand's in England have shown that the World Test Championship (WTC) final this week will be played between the two best teams in the world. And that's as it

Test cricket is a funny beast, howev-

er. How do you decide which is the best team in the world when it is difficult to tell which is the best team a country possesses? New Zealand won the final Test and the series after making six changes. Some owing to injury, and some for a reason we shall come to

Captain and best batsman Kane Williamson decided to rest his elbow and not aggravate the injury ahead of the WTC final. So New Zealand won comfortably with their next-best team.

In Australia earlier, only two Indians, Ajinkya Rahane and Cheteshwar Pujara, played all four Tests. India's bowling attack in the final Test was possibly their weakest of the series. It wasn't even their next-best team. Yet India won that Test and with it the series. Their best batsman and captain Virat Kohli had flown back home after

the first Test. Predicting victories in cricket -

fraught at the best of times – has just got more difficult. The race is not always to the swift, nor battle to the

New Zealand might think they are strengthening their team for the WTC final with the return of Williamson, B-J. Watling, Tim Southee, and others, but are they really? England might believe that once Ben Stokes, Jos Buttler, Moeen Ali, Chris Woakes, and Sam Curran make the eleven against India, they have a superior team. But will they?

The pandemic, and possibly the bubble associated with it, is causing us to reassess the apparently obvious. An X-factor has entered the calculations, making it all very exciting. Bench strength is vital.

Teams travel now with 24 or more players. They carry their own 'net' bowlers (one of them, T. Natarajan made his debut in all three formats in Australia). The competition is tougher, and no player on tour can afford to take his place for granted.

Whatever it is, the manner in which teams have made huge changes from match to match, and still succeeded, is an interesting development. Not yet a trend, but it might graduate into one. Changes are made for a second rea-

son too, and there might be issues with that. Again, owing to the pandemic, teams have had to rotate their players, ensuring they get sufficient rest and are fresh for each match. England have made a fetish of this,

resting Moeen, Bairstow, Buttler, Curran, and Woakes for the New Zealand series. Woakes had bowled just 21 overs in competition in nine months previously, so 'rest' was hardly what he needed.

The rotation policy is lauded as a masterstroke when the team wins, but seen as foolish and counter-productive when it loses. England's problem was

their inflexibility, the refusal to change plans when the IPL was shortened and players flew home, giving themselves more rest than they originally expected

Team priorities

Teams have different priorities too, and the selections are made accordingly. For England, it is the Ashes series at the top followed by International Cricket Council tournaments like the World Cups. The suspicion that they used the New Zealand series as 'nets' before the Ashes cannot be shaken away. That is hardly fair to the No. 1 Test team in the world. New Zealand have the right to expect the best team to take them on. for beating a second XI is deeply unsatisfying. But you can only beat the team that turns up.

When Roger Federer pulled out in the middle of the French Open, it seemed as if he was merely testing the

waters ahead of Wimbledon to see if his knees could take the strain after surgeries. Federer's largely unblemished record meant he was given the benefit of the doubt; in any case, the stakes are different in individual sport.

Both New Zealand and India should, and probably will, play their best teams in the WTC final commencing on Friday. A final cannot be a stepping stone to something else.

Lessons from history

History has shown that after India won the 1983 World Cup (50-over), that format got a huge shot in the arm, and drew more people to the game. Similarly post-2007 when India won the World T20, the IPL was born, and the format threatened to take over the game.

If India win the inaugural WTC, perhaps something similar will happen with Test cricket. No pressure at all, Virat Kohli!
