Gupkar alliance leaders decide to attend meeting with Modi

Mehbooba Mufti pitches for dialogue with Pakistan on Kashmir issue

SRINAGAR Responding to the invitation from the Union Home Secretary to meet Prime Minister Narendra Modi, senior leaders of the Gupkar alliance including National Conference's (NC) Dr. Farooq Abdullah and Peoples Demo-(PDP) Party's Mehbooba Mufti - on Tuesday decided to attend the meeting on June 24 in New Delhi.

"We have received an invitation from the PM. We are going to attend the all-party meeting. We will place our stand before the PM and Union Home Minister. Later, we will apprise the people about the outcome. Our stand remains the same," Peoples Alliance for the Gupkar Declaration (PAGD) president Dr. Abdullah said.

The announcement followed a meeting of the PAGD, chaired by Dr. Abdullah at his residence, attended by leaders of the NC, the PDP, the CPI(M), the Awami National Conference (ANC) and the J&K Peoples Move-

The three invited leaders are Dr. Abdullah, Ms. Mufti and CPI(M)'s M.Y. Tarigami.

Ms. Mufti, who was said to have been reluctant to attend, said, "We are not against a dialogue process. I

did not want to be seen as one playing spoilsport or creating obstacles. It was an invite from the PM, the highest office. I was of the opinion that Dr. Abdullah should represent the alliance in the meeting since our stand is same."

The PDP leader also called for a dialogue with Pakistan on the Kashmir issue. "There is a need to establish peace in the entire region, not just in J&K. Our government is talking to the Taliban in Doha. There should be a dialogue with people of J&K and also with Pakistan for a resolution," Ms. Mufti said.

Ms. Mufti, who has been a vocal critic of the Centre's move to end J&K's special status and was jailed in 2019, said it would have been much better if the Centre had initiated confidence building measures ahead of the meeting.

"I will raise the issue of political prisoners too. New Delhi should have released

all the political prisoners for creating an atmosphere for talks. I will seek shifting of Kashmiri prisoners to Srinagar jails from outside," she added.

Mr. Tarigami, Gupkar alliance spokesman, seconded Ms. Mufti on the release of political leaders. "Prisoners like Shabir Ahmed Shah are very ill in prisons, and the release of inmates is inevitable now," he said.

Many opposition parties skip Rashtra Manch meet

No deliberate exclusion of Congress, says NCP

The Rashtra Manch meeting, hosted by Nationalist Congress Party chief Sharad Pawar, in the Capital on Tuesday turned out to be a damp squib with a majority of the opposition parties giving it a miss, and many of them sending in second line lead-

The Rashtra Manch was an action group founded by Yashwant Sinha in January 2018 when he was not in any party. He is currently with the Trinamool Congress.

The NCP was at pains to explain that Mr. Pawar was only playing the host and did not organise the meeting. It also explained that there was no deliberate exclusion of the Congress. Other than the Congress, the DMK, the RJD and the BSP too did not send any representatives.

'Pawar did not call meet' Speaking to the media after the meeting, NCP leader Majeed Memon said, "It has been reported in the media that this meeting of Rashtra Manch was held by Sharad Pawar to unite anti-BJP parties. This is totally incorrect. I want to clarify that this meeting took place at Mr. Pawar's residence but he didn't call this meeting."

He also stressed that the meeting should not be mis-

construed as a big political step taken by Mr. Pawar, excluding the Congress.

"Congress leaders Vivek Tankha, Manish Tewari, Kapil Sibal, Abhishek Manu Singhvi and Shatrughan Sinha were invited. Some of them expressed genuine difficulties. The perception that there is going to be a big Opposition group excluding the Congress is wrong," Mr. Memon said.

The participants included National Conference leader Omar Abdullah, Rashtriya Lok Dal's Jayant Chaudhary, Aam Aadmi Party's Susheel Gupta, poet Javed Akhtar, former Chief Election Commissioner S.Y. Qureshi, former diplomat K.C. Singh and Iustice A.P. Shah (retired). among others.

CPI general secretary D. Raja and CPI(M) general secretary Sitaram Yechury too gave it a miss. Instead the CPI was represented by Rajya Sabha MP Binoy Viswom and the CPI (M) by Polit Bureau member Nilotpal Basu.

Team to be set up

Rashtra Manch coordinator and Samajwadi Party spokesperson Ghanshyam Tiwari said Mr. Sinha, who was the convener of the platform, would set up a team that would put forth its vision on important issues affecting citizens. "The summary of the meeting is that there is a need for preparation of an alternative vision in the country that is strong to address issues related to the common man," he said.



Sushil Ansal hid facts to renew his passport, police tell court

3 criminal cases, including the Uphaar fire, were pending against him at the time

The Delhi Police told a court here that Sushil Ansal - convicted in the 1997 Uphaar cinema fire incident that killed 59 people - played a fraud on authorities by concealing information about criminal cases pending against him while getting his passport renewed

"From the investigation, it is clear that Sushil Ansal had deliberately concealed the information regarding criminal proceedings pending against the applicant in any court of law or that she/ he has not been convicted by any court of law for any criminal offence in the past," the police said in its chargesheet.

It also said Mr. Ansal was issued a passport in 2013 on a "tatkaal" application. The affidavit under the "tatkaal"

scheme required specific deposition by the applicant to the effect that there were no criminal proceedings pending against the applicant in any court of law or that she/ he has not been convicted by any court of law for any criminal offence in past.

'Misled govt. authority' "This affidavit was filed by Ansal alongwith his applica-

tion, which resulted in the is-

suance of a passport in 2013.

Ansal was fully aware of the provisions of the Passport Act. He deliberately left the relevant boxes in the application form pertaining to criminality or court proceedings unticked

The accused benefitted from the said passport....He has on oath misled the government authority [Regional Passport Office] that he has not been convicted in any criminal proceedings by any court," the police added.

"Ansal was fully aware of the provisions of Passport Act. He had deliberately left the relevant boxes in the application form pertaining to criminality or court proceedings unticked," it said in

the chargesheet.

The inquiry was initiated on the direction of the High Court after a petition was filed by Association of Victims of Uphaar Tragedy (AVUT) through its chairperson Neelam Krishnamoorthy claiming that the real estate tycoon deliberately made false declarations about his criminal proceedings while applying for passport.

The police had earlier informed the High Court that in 2013, three criminal cases, including the Uphaar fire tragedy matter, were pending against Ansal. Krishnamoorthy, who lost

her two children in the tragedy, has been fighting a legal battle on behalf of the victims' families for the last 20 vears. A fire at Uphaar cinema during the screening of Hindi film "Border" on June 13, 1997, killed 59 people.

Day after godown fire, human remains found

It will be sent for DNA profiling; extreme heat causing hindrance in examination

A day after a fire broke out at the shoe godown in Outer Delhi's Udyog Nagar and six workers were reported to be missing, the Delhi Fire Service found on Tuesday charred human remains on the first floor of the building.

The police said the remains will be sent for DNA profiling to ascertain the identity even as a search operation is under way to trace the six workers

They added that it is yet to be ascertained if the remains found belong to more than one person.

The fire broke out on Monday at the building where shoes were assembled and packed for sale. As many as 35 fire tenders and around 140 fire personnel were pressed into service to douse the blaze.

The men reported to be missing have been identified as Sonu, Vikram, Shamshad, Abhishek, Ajay and Neeraj, said the police. Sonu and his

brother Vikram had come to Delhi from Ghazipur for work, their family members told the police.

Owner absconding Meanwhile, the godown owner Pankaj Garg and his father are absconding, police said.

"There is extreme heat inside the building, causing hindrance in the examination. After the remains are retrieved, they will be sent to the Forensic Science Laboratory (FSL) in Rohini for DNA profiling. The samples will be collected from the family members of those reported missing for DNA matching, which will help us in ascertaining the identity," said DCP (Outer) Parvinder Singh.

During a search operation at 7 a.m. on Tuesday, Assistant Divisional Officer Rajesh Kumar Shukla also sustained severe injuries as he slipped from the staircase of the building, said a senior fire official. He sustained injuries in his ribs and is undergoing treatment at Balaji Action hospital, he said.

A three-member team of forensic experts from FSL visited the spot on Tuesday for an examination, but they could not carry out their operation due to the extreme heat inside the building. "Once the temperature reduces, our team will visit the spot again," said an FSL

Prima facie, an electric short-circuit is suspected to be the reason but only a detailed examination will reveal the exact cause of the fire. The terrace of the twostorey building has collapsed and due to extreme heat and water used to douse the blaze, the structure of the building remains weak, a senior police officer said. The police said they have written to the civic authority concerned seeking details about the building's plan and its legality.

No fire safety

The building did not have any fire safety equipment in place and was heavily jammed with highly combustible materials due to which the fire spread faster, according to fire officials.

"We are scanning the building and its adjacent premises. Our teams have managed to enter some parts of the building," the officer said.

The building has been declared dangerous by the area's civic body on Monday following the blaze.

Not allowed to fly without RT-PCR report, man creates ruckus at IGIA

The businessman was arrested and later released on bail

A man from Uttar Pradesh was arrested for creating ruckus at the Indira Gandhi International Airport (IGIA) after allegedly being denied boarding by an airline for not carrying a mandatory RT-PCR test report, the police said on Tuesday.

The 36-year-old passenger, Suraj Pandey, a businessman, was arrested on Monday based on a complaint received from Deputy Manager of Vistara Airlines Deepak Chadha.

Mr. Chadha said the passenger had come to IGIA's

Vistara airline counter to board his flight for Mumbai but did not have an RT-PCR report, which is mandatory as per government guidelines. He was then not allowed to board the aircraft, the police said.

The airline official said at 3 p.m., Mr. Pandey turned violent and started shouting.

"He got onto the baggage belt and started walking on it," the police said.

DCP (IGI Airport) Rajeev Ranjan said: "From the contents of the complaint, CCTV footage and enquiry conducted so far, Mr. Pandey committed offence under relevant sections of the Delhi Police Act. Subsequently, he was arrested, and his medical examination was also conducted." Since it was a bailable offence, the accused passenger was released on bail and will be produced before a court here, he added.

An official statement issued by the Vistara spokesperson said: "He behaved badly with our staff and other customers. His acts threatened the safety of ground operations. We have provided a full refund of the booking to the customer and notified the authorities of the incident."

Two in police net for ₹55-lakh bank heist in east Delhi

Bank officials had hired accused for renovating strong room

A 34-year-old man has been arrested for allegedly decamping with over ₹50 lakh after breaking into a bank from an adjoining under-construction building in east Delhi's Farsh Bazar, the police said on Tuesday.

Six months ago, the bank officials had called him for renovation work at the strong room, which is inside the premises, they said.

The accused, Hariram. was wearing a helmet at the time of the crime to hide his

identity. The police said another person, 39-year-old Kalicharan, was arrested in connection with the crime.

The accused are both residents of Vishwas Nagar. On Monday at 10.15 a.m.,

the police received information regarding the burglary in a bank in Vishwas Nagar. During preliminary probe,

the police found that two holes were made – one into the server room of the bank and another in sthe trong room in the basement. The accused had fled with ₹55,03,330 cash from the vault, a senior officer said.

Teams were formed to collect details of frequent visitors, guards, contractual staff and of people who entered the locker room in the last six months, the police said.

A CCTV camera installed near an ATM located near an under-construction building, was found facing upward, the officer said.

"The direction of the camera was changed but it captured the palm and some portion of the face of the person," he added.

but could not do it due to the lockdown in the city.

As soon as he got an opportunity, he entered the under-construction building, made small holes there and another one in the strong room. He said he wanted to use the money for gambling.

₹54,48,730 was recovered from a house in the same area where he was working as a guard, and ₹49,200 from Kalicharan. The accused had spent the rest of the money.

Hariram, who comes from Madhya Pradesh, is a trained construction worker.

He lives in the city with his wife and two children.

Kalicharan has a small business and is also involved in illegal gambling activities, the police added.

He used fake website to get account details of victims

A 28-year-old man has been arrested for allegedly cheating people on the pretext of providing them jobs, the police said on Tuesday.

DCP (South-East) R.P. Meena said the accused has been identified as Ashish Rana, a resident of Najafgarh. The police said they received a complaint by one Sartaj Khurana on June 12, who said he had received a call from a woman named Muskan - "executive of a leading job portal".

She had asked him to pay ₹10 on their website www.naukricareer.in., promising him a job. Next, the victim paid ₹10 but instead ₹5,000 got debited from his

account. During investigation, the police nabbed the accused.

During interrogation, the accused allegedly told police that he used to purchase data of job seekers from job portals and create similar websites before calling the victims. The accused would ask them to pay ₹10 on the payment page of his fake

website, which would direct them to a payment gateway.

This way he would get all the details added by the victim and make further transactions.

"From the online accounts, the money is routed to fake bank accounts and taken out via ATMs the same day. Accused further disclosed that he along with his accomplices had been operating several websites from last one year," Mr. Meena said, adding that efforts are being made to trace his accomplices.

'56% of people surveyed have antibodies against COVID-19'

Delhi govt. yet to officially announce the results of sixth serological survey

NIKHIL M BABU NEW DELHI

Over 56% of 12,000-13,000 people whose blood samples were collected in April from different parts of the city, showed antibodies against COVID-19, a Delhi government source said.

The samples were collected for the sixth serological survey, but the sample collection could not reach the target as it had to be stopped in April due to the surge in virus cases. The Delhi government is yet to officially announce the results of the study.

Only 141 wards covered "The current survey shows a

seroprevalence of 56.09%, which is almost the same as THE HINDU the previous one," the source said. The fifth such survey done in January had shown a seroprevalence of 56.13%, but it had covered 28,000 people spread across all 272 wards of the city, whereas the current survey could reach only 141 wards, officials said. "We cannot completely com-

pare this result with the previous survey as we have covered only 141 wards. At best, we can compare the wards from where we have collected samples this time with last time," another official said.

The next serological survey is likely to start in June end or July first week and this might show a considerable change, said officials.

Jugal Kishore, head of the community medicine department at Safdarjung Hospital,

survey] are developed about six weeks to 12 weeks after getting the infection. Since our peak of infection was in April-May, people with antibodies should be high now if we do a sero survey," Dr. Kishore said.

Past surveys

The first such survey done in the city in June-July last year had shown that 23.4% people surveyed have developed antibodies against the virus.

Similar surveys in August showed 29.1% people had antibodies, 25.1% in September, and 25.5% in October.

Blood samples collected from across the city are tested in a lab using antibody testing kits to understand whether the person was infected by the virus and developed antibodies.

A positive result would imply that the person has developed antibodies against the virus. This means that the person was infected at some point by the virus and developed immunity against it.

The DoE said that 2.58 lakh students were enrolled in Class 9 in 2020-21, out of which 2.45 lakh appeared for



BIS makes Hallmarking of Gold **Jewellery Mandatory**

Bureau of Indian Standards (BIS) in a press conference held today shared insights on Mandatory Hallmarking of Gold Jewellery which has come into force from 16th June, 2021. Sh. Pramod Kumar Tiwari, Director General, BIS while addressing the facets of Mandatory Hallmarking shared that mandatory hallmarking has initially started with 256 districts of the country which have Assaying and hallmarking centres. He further added that Jewellers with annual turnover upto Rs. 40 lac will be exempted from mandatory Hallmarking. Export and re-import of jewellery as per Trade Policy of Government of India - Jewellery for international exhibitions, jewellery for government approved B2B domestic exhibitions will also be exempted from mandatory Hallmarking, Watches, fountain pens and special types of jewellery viz. Kundan, Polki and Jadau will be exempted from Hall Marking. Registration of jewellers will be one-time and there will be no fees charged from jewellers for registration. Any manufacturer, importer, wholesaler, distributor or retailer engaged in selling precious metal articles has to mandatorily get registered with BIS. However, artisans or manufacturers who are manufacturing the gold iewellery on job work basis for the jewellers and are not directly related to sale to anyone in the chain are exempted for registration.Hallmark shall be done at the first point of sale which may be manufacturer, whole-seller, distributor or retailer.BIS (Hallmarking) Regulations were implemented w.e.f. 14.06.2018. Hallmarking will enable Consumers i.e. Jewellery buyers to make a right choice and save them from any unnecessary confusion while buying gold. The

8 rare pygmy hogs released in Manas National Park

Eight of 12 captive-bred pygmy hogs, the world's rarest and smallest wild pigs, were on Tuesday released in the Manas National Park of western Assam. The remaining four would be released on June 25.

Second batch

This is the second batch to have been reintroduced into the wild under the Pygmy Hog Conservation Programme (PHCP) in a year. Fourteen of these animals were released in Manas in

The PHCP is a collaboration among Durrell Wildlife Conservation Trust of UK, Assam Forest Department, Wild Pig Specialist Group of International Union for Conservation of Nature and Union Environment Ministry and is currently being implemented by NGOs Aaranyak and EcoSystems In-

Six hogs – two males and four females - were captured from the Bansbari range of the Manas National Park in 1996 for starting the breeding programme. The reintroduction programme began in 2008 with the Sonai-Rupai Wildlife Sanctuary (35 hogs), Orang National Park (59) and Barnadi Wildlife Sanctuary (22).

With Tuesday's release, the number of pygmy hogs reintroduced into the wild under the PHCP reached 142, which is more than their current original global wild population. "Manas has been doing

well in conservation in recent years," Amal Chandra Sarma, Manas' Field Direc-

"Conservation of pygmy hog was initiated by noted naturalist Gerald Durrell and his trust in 1971. The pygmy hog was brought back from near-extinction by the partnership effort, and now we are moving towards the establishment of a population across the entire range," PHCP's Project Director Parag Jyoti Deka


U.P.: Ambedkar statue damaged

The counsel for the company argued that the allegation made by Mr. Gowda about utilising more land than required for implementation of the project was inaccurate. The company had no role in deciding the quantity of land required for the project. The allegation, therefore, was false and made by the defendant without there being any documentary evidence. The counsel also contended that the project was approved by the Karnataka government.

'No illegality'

The High Court of Karnataka and the Supreme Court had issued directions to the State government to take steps for implementation of the project, which showed that there was no illegality and irregularities in the work.

The company had demanded ₹10 crore from Mr. Gowda as damages.

The court concluded that Mr. Gowda had failed to substantiate his claim against the company, which was made during the interview.

A Division Bench of the Kerala High Court on Tuesday stayed the Lakshadweep administration's decision to close down dairy farms run by the Animal Husbandry Department and remove meat from the menu of the midday meal scheme of schools.

The Bench led by Chief Justice S. Manikumar passed the stay order on a writ petition filed by Ajmal Ahmed of Kavarathi island challenging the Animal Husbandry Department's order and the decision of the district task force to drop non-vegetarian items from the menu of the midday meal scheme of schools.

The petitioner contended that the decision to close down the dairy farms was taken as part of the administration's efforts to implement the proposed Ani-Preservation (Regulation), 2021 which bans slaughter of cow, calves, and bulls, etc., and also the sale and purchase of beef and beef products. The closure of dairy farms would curtail the source of milk products and compel islanders to purchase the same from Gujarat. The Administrator was adopting measures to destroy the well-maintained dairy farms and other infrastructure established on the islands for promoting them.

The petitioner said there was a proposal to entrust preparation of food for midday meal to a non-governmental organisation, Akshayapatra, based in Bengaluru.The petitioner termed the decisions of the Administrator illegal and unsustainable in law.

A welcome spike

The threat of a third wave and new variants make speedy, complete inoculation a priority

India began the week with a record, by administering over 8.6 million doses of vaccine on a single day, an Limpressive feat even from a global perspective. For most of May, India struggled to deliver over 2 million doses a day and beginning June, managed to hike it to over 3 million doses daily. These are substantial numbers, but inadequate, given that the benefits of mass vaccination would be discernible – in terms of reducing hospitalisation and mortality - only after a large percentage of the population is inoculated. By that metric, India is a global laggard with only 17% of the population covered by at least one dose and less than 4% by two. The U.S., in comparison, has inoculated at least 53% and the U.K. 64% with a single dose. In that light, India on a single day being able to administer over twice the previous weeks' daily average makes plausible the Centre's aspiration to inoculate all of India's adult population by the year-end. So far, about 25% of them have been administered at least one dose and to reach the 944 million adult population, it requires above eight million jabs every day until the year-end.

While India has, as part of its polio vaccination programmes, administered vaccines to millions of children in a day, a one-day record is not evidence that the trend is sustainable. Most States substantially increased their daily count on June 21 but three stand out: Haryana, Karnataka and Madhya Pradesh. However M.P., records show, never peaked over five lakh a day until Monday when it nearly quadrupled this number. Haryana's historic high (and average) has hovered around 1.5 lakh but it more than tripled that on Monday and Karnataka, with a previous high of 2.6 lakh, multiplied that fivefold with 11 lakh jabs. To substantially increase vaccination, both the number of vaccination sessions and doses administered must increase. Some States had organised mass vaccination drives and the rules allowing spot-registration of those between 18-44 years unlike the previous requirement of pre-registration on CoWIN may have helped with the boost. India's vaccination programme primarily rests on the shoulders of Covishield and by August the numbers of Covaxin are expected to at least equal the monthly supplies of Covishield. Were that to happen, it would help with administering at least between five to six million doses a day and ought to prompt the Government to rethink its policy of a 12-16 week gap between Covishield doses to ensure that more people are fully vaccinated. The threat of a third wave and new forms of the delta variant make speedy, complete inoculation a priority, and this ought to be the driving force of India's vaccination programme.

Policy creep

Overregulation risks retarding growth and job creation in the e-commerce sector

arely 11 months after the Government notified the Consumer Protection (E-Commerce) Rules, 2020, the Department of Consumer Affairs has mooted a set of sweeping amendments, ostensibly "to protect the interests of consumers... and encourage free and fair competition in the market". Among them is a norm stipulating the appointment of a chief compliance officer, a nodal contact person for 24x7 coordination with law enforcement agencies, and another requiring e-commerce entities offering imported goods or services to 'incorporate a filter mechanism to identify goods based on country of origin and suggest alternatives to ensure a fair opportunity to domestic goods'. A third mandates a fall-back liability on online marketplaces in the event of non-delivery of goods or services to the consumer. Registration has also been made mandatory for all e-commerce players; specific 'flash sales', including 'back-to-back' ones, are set to be banned; and all entities must provide information within 72 hours on any request made by an authorised government agency probing any breach of law including cybersecurity issues. While on the face of it none of these new rules appears exceptionable, especially when e-commerce tops the National Consumer Helpline's complaints chart, there is still a distinctly discernible pattern to the changes. Following on the heels of the recent IT (Intermediary Guidelines and Digital Media Ethics Code) Rules, the draft e-commerce amendments show the Government's increasing keenness to exercise greater oversight over all online platforms.

The Centre also appears to be signalling its intent to dig in its heels in an intensifying stand-off with Walmart's unit Flipkart, and Amazon, which are both now in court battling an attempt by the Competition Commission of India to reopen a probe into their business practices. The two large e-commerce players have had to contend with accusations that their pricing practices are skewed to favour select sellers on their platforms and that their discounting policies have hurt offline retailers. The fact that the latest changes expressly seek to ensure that none of an e-commerce entity's 'related parties and associated enterprises is enlisted as a seller for sale to consumers directly' could also impact several platforms that retail products supplied by vendors with arm's length ties. The enforcement of many of these norms is bound to spur protracted legal fights. Asserting that the amendments were not aimed at conventional flash sales, the Government said it was only targeting certain entities engaged in limiting consumer choice by indulging in 'back-to-back' sales wherein a seller does not have the capability to meet an order. In trying to address shortcomings in its rules from last year, the Government appears to be harking back to an era of tight controls. Overregulation with scope for interpretative ambiguity risks retarding growth and job creation in the hitherto expanding e-commerce sector.

Countering a political act that has a legal garb

With sedition cases rising, often solely based on word usage, people need to have a political and legal defence

isha Sultana, a film-maker from Lakshadweep, was recently booked for the alleged offences of sedition and statements prejudicial to national integrity. A crime was registered based on a complaint by a leader of the Bharatiya Janata Party (BJP). Ms. Sultana then moved the Kerala High Court for pre-arrest bail. The court allowed interim bail to her on June 17. Ms. Sultana thus got temporary relief from incarceration. The court will pass its final orders in the application shortly.

Ms. Sultana's case is only one among the numerous sedition cases recently registered in the country. In Lakshadweep, people have had sedition slapped against them for putting up placards or posters against the Prime Minister. Ms. Sultana's case also reveals the regime's political strategy to threaten dissidents.

Background and implications

Ms. Sultana is alleged to have used the word 'bioweapon' in a television discussion about the recent developments in Lakshadweep and its draft reforms. She said it while deliberating over the Lakshadweep Administrator's actions and omissions that allegedly contributed to the spread of the CO-VID-19 pandemic on the island, which was free from the virus in 2020. Ms. Sultana indicated in her petition before the court and to the media that she is apologetic about the word used. In an inter-

view she said that her "bioweapon remark" was a "mistake" and that she was "entrapped".

Hindutva forces have relied heavily on this subsequent posture which she publicly made, to strengthen their stand. They tried to create a false sense of moral victory and legitimacy to back their position, which they thoroughly

Ms. Sultana is not a political activist. And it is probable that she may not be very articulate or even be able to present strong arguments on the affairs of the nation. It seemed like she was partly accusing herself or acknowledging the 'mistake' in some way. This self-accusation was, however, unwarranted. When the purpose of the sedition law is to curtail opposing ideas, her rescission had the effect of legitimising the state's wrongful action.

Lessons from history

Ms. Sultana's case is a case study for those who are concerned about the country's liberal values. The offence of sedition under Section 124A of the Indian Penal Code (IPC) was inserted in the Code in 1870. In the great trial of 1922, Mahatma Gandhi, charged with sedition, described the provision as "perhaps the prince among the political sections of the IPC designed to suppress the liberty of the citizen." Gandhiji, who himself was a lawyer, made two points in his statement given on March 18, 1922. One, he admitted the charge of preaching disaffection towards the then existing regime. Two, he justified his act and said that it was his duty to do so as it is "a sin to have affection for the system (under the British Raj)". He explained that "Affection cannot be manufactured or regulated by law. If one

system, one should be free to give the fullest expression to his disaffection so long as he does not contemplate, promote, or incite to violence. (https://bit.ly/3vP9S2x)"

This statement is not only political but also legal. Curiously, this assertion that Gandhiji made in the court was indirectly laid down as the law by the Constitution Bench of the Supreme Court of India in Kedar Nath Singh (1962) which said that incitement to violence is the gist of the offence of sedition. This proposition was followed by the top court consistently, till Vinod Dua (2021), where the Court said that a journalist cannot be booked for sedition for express-

ing dissent. The law was clear even when Gandhiji was convicted and sentenced. Evidently, the charge and the conviction were political, not legal. Even today, the very registration of crimes against political opponents under the draconian laws is essentially a political act, though it takes a legal form. According to the report by the National Crime Records Bureau (NCRB), between 2016 and 2019 there was a 160% increase in the registration of sedition cases whereas the conviction rate during this period fell from 33.3% to 3.3%. the punishment.

Therefore, one needs to build

up a political defence as well as legal defence against such charges. Litigation is not merely a means for the redress of grievance. When the charges are under 'political sections', as Gandhiji eloquently described, they need to be countered by a political praxis as well. Only such a course would expose the egregious motive of the state in accusing its citizens of the offence of sedition without any legal or factual foundation whatsoever. Only such a resistance would be able to re-educate our judicial institutions constitutionally and historically, and to ensure dialogic democracy.

Unfortunately, Ms. Sultana's subsequent expression of regret does not pass this political test. She could have asserted that the word she used was correct and proper. It was possible for her to justify it as an imagery capable of exposing the regime's unprincipled approach in Lakshadweep.

It needs to be told that the British Raj used the draconian provision only when they alleged that a speech or a writing resulted in violence, or there was at least a remote connection between the overt act and social disturbance. Bal Gangadhar Tilak was tried in 1897 on an accusation that the articles in *Kesari*, a Marathi paper owned by him, incited violence that led to the killing of two British officers. Tilak was convicted and sentenced to undergo rigorous imprisonment for 18 months. In 1908, he was again tried and later sentenced for writing "seditious" articles and by connecting them with certain instances of 'social disorder'. Post-Independence, in *Kedar* Nath Singh, the accusation among others, was that Kedar Nath, a Forward Communist Party leader. had asserted his belief in a revolu-

tion "in the flames of which the capitalists, zamindars, and the Congress leaders of India....will be reduced to ashes...." The Court said that "comments, however strongly worded, expressing disapprobation of actions of the Government, without exciting those feelings which generate the inclination to cause public disorder by acts of violence, would not be penal". In Balwant Singh (1995), slogans for an independent Sikh nation were found to be not seditious for want of the ingredient of incitement to violence. None of these prominent cases relied on the mere use of words to make out the offence.

A new judicial activism

But after 2014, cases of sedition are frequently and intentionally registered solely based on words spoken, written, or tweeted. This can have a chilling effect on people's movements. The clear political object behind the invocation of the law is to create an atmosphere of fear. This, in a way, is the price which the country had to pay for the retention of the law of sedition, among other draconian laws. Therefore, the Supreme Court of India and the High Courts should take suo motu cognisance of the incidents where the state ostensibly uses draconian laws to suppress criticism and protest. This is difficult, but not impossible. Such suo motu proceedings would reflect the kind of judicial activism that our time demands. The organised Bar, especially at the State level, must perform its libertarian role by constantly demanding for a judiciary that values freedom and acts

The picture is clear, it is top-down misinformation

A new report shows that many Indians know misinformation about the pandemic often comes from the top

Then asked what source of false or misleading information about the novel coronavirus they are most concerned about, many more Indians highlight domestic political actors than worry about activist groups, iournalists.

Source of prime concern

Nearly one in four (23%) in our recent survey say that the Government, politicians or political parties are the source they are most concerned about. That is more pe ople than worry about misinformation from platforms such as Facebook (16%) or YouTube (14%). Among platforms, only messaging applications (e.g. WhatsApp) generate more widespread public concern among our respondents. They are named by 28%

Meanwhile, Indian authorities often seem mostly interested in going after alleged misinformation from activists (only 9% of our Indian survey respondents identify activist groups as the most concerning source of false or misleading information about the coronavirus), select journalists and news organisations (named by 13%), or on Twitter (which just 4% identify as the platform they are most concerned about).

(https:// survey bit.ly/3xECltc) only covers English-speaking Internet users in India, so while it captures an important minority, the data are not representative of India's overall population. Still, it provides insight into how many Indians see the "infodemic" that has accompanied the pandemic, an immense wave of information that, unfortunately, also includes some false and misleading material, rumours, and attempts to exploit the crisis for propaganda or for profit.

Are they right? Both academic research and independent journalism suggest that they might

'Network propaganda'

Study after study around the world has found such "network propaganda" (https:// bit.ly/3zQ1djM), where misinformation is spread by some top politicians, nakedly partisan news media who cheer them on, and well-organised communities of political supporters active on social media and messaging applications.

Top-down misinformation from politicians, celebrities, and other prominent public figures are a small part of the false and misleading claims one can come across online in terms of raw volume, but research (https:// our bit.ly/3zJKVst) during the pandem-

ic shows it accounts for a large share of social media engagement. Even when political actors are

not busy drumming up outright propaganda in the media and on digital platforms, authorities also blic in other ways.

In country after country, reporters have found that official CO-VID-19 death tolls are far lower than the actual excess deaths recorded during the pandemic - as The Hindu found in Tamil Nadu (https://bit.ly/3gWGyBG) by comparing Civil Registration System data with the officially reported

Unproven claims

And politicians have sometimes promoted supposed coronavirus remedies with no scientific basis. Former President of the United States Donald Trump and Brazilian President Jair Bolsonaro are prominent international examples. In India, some politicians have, for example, claimed that cow urine can protect people against COVID-19, even as the Indian Medical Association (IMA) pointed out there was absolutely no evidence for this, just as the Ministry of Health and Family Wel-

fare last year came under severe criticism from for recommending a range of unproved, alternative remedies to prevent or treat the

Some misinformation circulates peer-to-peer on social media and on encrypted messaging services as people share supposed miracle cures and ineffective alternative health tips in good faith or carelessly. This can create problems. But arguably, far more problematic is when people in positions of authority and prominent public figures promote measures that have a deadly pandemic.

Examples from India

One prominent example is the Bharatiya Janata Party-led Haryana State government announcing last month that it would hand out one lakh Coronil kits to COVID-19 patients for free.

The ayurvedic remedy was launched in June last year by Baba Ramdev's company, Patanjali Ayurved, and at a press conference the yoga guru claimed (https:// bit.ly/3gKUPCI) the remedy guaranteed "100 per cent recovery from COVID-19 within seven days of consuming the medicine". Hours later, the central government asked Patanjali Ayurved to stop advertising the drug (https:// bit.ly/3gVPjfd) and the Uttarakhand Ayurveda Department responsible for licensing the remedy pointed out the licence was for an immunity booster, not a cure.

In February this year, Ramdey's company falsely claimed Coronil

was certified by the World Health Organization (WHO) - a claim WHO immediately pointed out was untrue. And the yoga guru appeared at an event with Union Minister of Health Harsh Vardhan promoting alternative medicines for COVID-19 patients, leading the IMA to ask the Minister how ethical it is "to promote the product in unethical, wrong and false ways to whole country? (https://bit.ly/3wMJjwk)'

The promotion and provision of what the IMA describes as an "unscientific medicine" marketed an example of how misleading information from prominent public figures and people in positions of authority can lead to bigger problems than random falsehoods spread by ordinary people online and offline.

If authorities in India are serious about addressing misinformation, they might take a cue from the fact that much of the Indian public clearly recognise that misinformation often comes from the top, and spend less time worrying about activists, journalists, and Twitter, and more time thinking about how to ensure that citizens can trust that the health remedies promoted by their own governments and by prominent political figures are actually safe and effective.

With its constitution of an **Economic Advisory Council** to the Chief Minister, comprising global experts, including Nobel laureate Esther Duflo, the Tamil Nadu government may have given an indication that it is serious about streamlining the State's fiscal position (Page 1, "Nobel laureate in economic advisory panel", June 22). However, in the run-up to the recent Assembly election, the now ruling party, the Dravida Munnetra Kazhagam, made tall promises, many commitments recurring in nature, oblivious of the precarious financial situation, compounded by the onslaught of the pandemic. It may find the going tough now to fulfil the aspirations of the people with finite resources at its

disposal. One of the experts on the new panel, former RBI Governor Raghuram Rajan, is not a votary of subsidies, whereas the Government cannot do away with freebies, which have only increased manifold in the last few decades. The politics of an aerial snare

The investigation into the forced landing of a Ryanair aircraft in Belarus could be long-drawn-out

On May 23, a Ryanair flight was forced to make an emergency landing in Minsk by a MiG-29 fighter jet of Belarus. The dissident Belarussian journalist, Roman Protasevich, who was travelling in the commercial, civilian aircraft, was subsequently arrested. The whole operation, it is alleged, was carried out on the orders of President Alexander Lukashenko, who has ruled Belarus for 27 years.

Global reaction

The incident received considerable global attention. The European Union (EU) and the U.S. denounced it and called for a thorough investigation by the International Civil Aviation Organization (ICAO). EU-based carriers have since heeded the call to avoid overflight of Belarus. Belarusian flights have been barred from overflying EU airspace or landing at its airports. Air France, British Airways, Lufthansa, KLM and a host of other airlines have implemented their own suspensions.

At a special meeting convened on May 27, the ICAO Council expressed strong concern at the incident and launched a fact-finding investigation. Official requests for information were sent out to the countries involved in the event. Belarus and Poland have provided some preliminary details. Information is awaited from Greece, Ireland, Lithuania and Switzerland. An interim report is expected to be presented to the ICAO Council by the end of its current session, on or near June 23. The report is expected to be considered only at the next session, which begins on

European Commission President Ursula von der Leyen called the incident an "attack on democracy", an "attack on freedom of expression", and an "attack on European sovereignty". The U.S., EU, and the U.K. have slapped further sanctions on Belarus. How justified was Belarus in taking such a decision? The answer lies at the junction of Belarus's domestic laws as a sovereign country and

international laws governing the action that states can legitimately take to deal with threats to security, real or perceived.

Not the first of its kind

The flight that the 26-year-old fugitive blogger boarded was operated by the Irish low-cost airline, Ryanair. It was on its way from Greece to Lithuania. While traversing the airspace of Belarus, an ostensible 'bomb scare' forced the aircraft to make an emergency landing in Minsk for standard checks. It turned out to be a false alarm. Mr. Protasevich, whose presence on board is suspected to be the real reason behind the action, was taken into custody soon after.

According to media reports, Mr. Protasevich, who had fled Belarus for Poland in 2019, had been in Greece to attend an economic conference with other Belarusian dissidents. There, the blogger also covered the visit of exiled Belarus Opposition leader Sviatlana Tsikhanouskaya.

If convicted, he could face a long prison term or worse. After all, Belarus is the only country in Europe that hands down the death penalty.

Mr. Protasevich's case is not the first of its kind. Abdolmalek Rigi, head of the Jundullah militant group, accused by Iran for fomenting attacks in the province of Sistan-Baluchistan, was similarly arrested in February 2010. According to Iranian media reports, Rigi's plane was forced to land in Bandar Abbas by Iranian aircraft while on a flight from Dubai to Bishkek in Kyrgyzstan. Rigi was subsequently tried and executed. Itek Air, a small Bishkek-based

airline, folded up in 2010 for unrelated reasons. There is no direct parallel between Mr. Protasevich and Rigi except that both men were wanted by the governments of their respective countries and their custody was secured through very unconventional means.

Pressure to divert passenger aircraft from preordained flight paths could be on grounds of a security threat or for political reasons. In 2013, during the manhunt by the U.S. for National Security Agency whistleblower Edward Snowden, Bolivian President Evo Morales's plane was forced to land in Austria after several European countries refused the aircraft permission to enter their airspace, allegedly due to pressure from the U.S. According to reports, there was suspicion that Mr. Snowden might have boarded the President's plane in Moscow. As it turned out, Mr. Snowden, who later obtained asylum and stayed on in Moscow, was not in the aircraft. Following the incident, seven Latin American countries voiced their concerns to the then UN Secretary-General, Ban Ki-Moon, who asserted that "a Head of State and his or her aircraft enjoy immunity and inviolability".

An issue with many dimensions The issue of the use of military aircraft to neutralise potential threats posed by civilian aircraft acquired a different kind of urgency in the aftermath of terrorist attacks in the U.S. on September 11, 2001. Generally speaking, international law grants sovereignty to nations over their airspace as it does in territorial waters.

The Convention on International Ci-

vil Aviation, better known as the Chicago Convention of 1944, to which Belarus is a signatory state, prohibits any unlawful intervention against a civilian aircraft. At the same time, it has various provisions under Article 9 which permit a sovereign state the right to impose restrictions, including enforced landings at a designated airport in its territory, in "exceptional circumstances or during a period of emergency, or in the interest of public safety". Once a flight has landed, Article 16 provides the host country the right to board/search the aircraft. This is probably the clause that provided cover for the local authorities to board Mr. Morales's aircraft in Austria in 2013. But the Chicago Convention applies only to civilian aircraft of the contracting parties. In this case, the national carrier, Belavia Belarusian Airlines, is not involved though it is part of the targeted sanctions by the EU.

International law might also have to be examined in light of the International Air Services Transit Agreement (IASTA), also concluded in Chicago in 1944. According to this agreement, contracting states grant to one another the freedom of air transit in respect of scheduled international air services, that is, the privilege to fly across territories without landing. Belarus is not a signatory of IASTA. For that matter, neither is Russia, which is the main supporter of Mr. Lukashenko.

of Mr. Lukashenko. Given the multiple interpretations possible under the Chicago Convention and related agreements, the investigation could be a long-drawnout affair. The International Court of Justice does consider ICAO-related cases, but it cannot enforce its decisions. The United Nations Security Council is a divided house and, in any case, does not consider unlisted agenda unless the case constitutes a major threat to international peace and security. This is not a matter that easily lends itself to technical consideration, given that it goes beyond the issue of a forced landing of a civilian airliner to encompass broader geopolitical issues. A meaningful outcome from the ICAO investigation may therefore prove evasive.

Chores and conversations: how to keep children engaged

Parents face many challenges but there are ways to cope

The pandemic-related lockdowns have not been easy for anyone, but they have been particularly difficult for children, parents, teachers and the elderly.

Learning from home

Children have been mostly indoors for over a year. Toddlers may not remember this period later, but for older children, there is little at home to stimulate their curious, active minds. With schools remaining shut, children have been attending online classes. Many parents have reported that their children, especially in the 4-6 age group, have been finding it hard to focus during online classes. Mothers have said during counselling sessions that their children have shown disinterest and lack of motivation. Some don't participate during class; they keep themselves busy on their parents' phones and other gaming sites, or by chatting with their friends. To make matters worse, children are inclined to unwind after a long day of virtual learning by again being on their gadgets. Parents deal with this problem in various ways: they grab and hide the devices, turn the WiFi off, and beg and plead with their children to fall in line. But these requests often fall on deaf ears and finally the parents give in. Once the pandemic ends, a great challenge is going to be to cure children of their screen addiction. Studies have found that limiting the use of online time can lead to significant reductions in loneliness and depression.

Since this is a new system for schools too, teachers are unable to constantly keep track of what the children are up to. Online tests and assessments cannot always be monitored. Some parents have said that they have caught their children cheating during tests. Teachers too are heading towards a burnout. They have had to learn new ways of making virtual classes engaging and fun and prepare content accordingly. While in the classroom, teachers give special attention to children with learning difficulties, this hasn't been possible during the pandemic. Children with dyslexia, dyscalculia, etc. have it especially hard at a time like this. It has become almost entirely the parents' responsibility to help the child, when they themselves are overburdened. With no day-care centres, afterschool care centres, play dates, sleepovers, birthday parties and so on, it has become the task of the parents to help in their children's education, look after them, and entertain them, all while doing their own work.

Higher school students have reported different issues. There have been challenges in learning in the absence of laboratories and field visits. Many are set to graduate from school without having met their friends for over a year. While this may not be a problem for all students and some enjoy being at home, others may find it more challenging to re-enter social life and should do so slowly. Entrance exams have been postponed for college admissions and so, students feel demotivated to prepare.

Further, the pandemic has exacerbated the divide between the rich and poor. The lesser privileged children who have had little or no access to smartphones, computers and Internet have reported feeling dejected. School dropouts are becoming a problem.

How can parents help?

While the situation can improve only when the pandemic abates and schools reopen, parents and teachers can do a few things to keep the children happy and engaged. If parents are proactive and positive, this could have a big impact on their children. Children pick up quickly on parents' fears and so it is important for parents to remain calm and patient and meet their children's concerns in an age-appropriate manner. If parents show that they are resilient, children too will learn to be that way. To keep the children engaged at home, parents can assign them tasks and chores. They can train their children to cook, clean, and focus on basic hygiene. All this will help the children throughout their adult life. Parents should also look out for signs that indicate that the child is having trouble coping. If children are unable to follow a routine, sleep poorly, and constantly complain of anxiety, fear, etc., parents should take note. All these emotions could have a long-term impact on the children. Parents can also set an example by doing a digital detox. Spending time with young children and listening to their stories is important as they require a lot of attention. If parents are unavailable, children will seek out others online, which could be dangerous. Pursuing hobbies, exercising, and hitting the outdoors while following COVID-19 protocols will all help keep the body and mind active and refreshed. Each child is unique and needs to be dealt with differently.

Tackling the Hindutva bugbear

Dalit-Muslim alliances are not enough to restore secularism; upper caste Hindus are needed too

Ever since the Sachar Committee Report of 2006 demonstrated that the socio-economic conditions of Muslims have worsened compared to Dalits, some have argued that Muslims have become India's new Dalits. It is further proposed that the two communities should forge an alliance to fight the Hindu Right to restore secularism because together they constitute a significant number: Muslims constitute 14.2% of the population and Dalits, 16.63% (Census 2011).

Differences

There are some basic differences between the two communities. Muslims are historically a multi-class community, whereas Dalits are evolving into one, boosted by reservation policies. There are further nuanced differences. Consider rhetorical questions such as: who is the Shah Rukh Khan or Sania Mirza or Bismillah Khan of Dalits? In the psychological domain, discrepancies are equally apparent. A working class Muslim can embrace the Red Fort or the Taj Mahal as a proud legacy of his ancestors, but Dalits have no such iconic symbols. Thousands of years of subjugation of Dalits by upper caste Hindus have presented them as people not worthy of history or even without history. The Hindu Right has weaponised the history of Muslims against them. Therefore, BSP leader Mayawati had compelling reasons to build statues of Dalit icons, which received flak from many upper caste Hindus.

Dalits continue to suffer from organised violence unleashed by upper caste Hindus. The flogging of a Dalit family in Una in 2016 is a case in point. Some Dalits, research suggests, have occasionally participated in violence against Muslims in riots (in Gujarat in 2002, for instance). In modern India, Muslims have not participated in organised violence against Dalits, nor have they systematically raised their voice against it because Muslims are quite lost as a political community. This explains their failure to organise a worthwhile resistance against lynching. Whatever protest occurred was spearheaded by secular forces with artists and intellectuals at the forefront. Muslims


almost seemed like benign onlookers. The anti-Citizenship (Amendment) Act protests were a face-saver, but those too was below the potential of a 200 million-strong community.

In rare instances, there are warm social relationships between a fraction of the Pasmanda community, Dalit Muslims and Dalit Hindus. Nevertheless, social bonding between the Ashraf Muslims and Hindu Dalits is constricted. B.R. Ambedkar knew this. Once he chastised a Muslim man who declined to offer him water by saying untouchability has no place in Islam. In his speech on conversion on May 31, 1936, Ambedkar exhorted Dalits to leave the Hindu fold for any religion including Islam.

In recent years, upper caste Hindus have gravitated towards the Hindu Right causing the breakdown of the secular project for at least two reasons. First, upper caste Hindus have been persuaded by the Hindu Right's campaign that Indian secularism is a Muslim project. In every election, the BJP deploys incendiary concepts such as 'appeasement' and 'vote bank politics' with greater intensity to deepen the politics of polarisation. This triggers asymmetric counter-polarisation among Muslims. Second, policies of the Western states in the post-9/11 era contributed to Islamophobia's rise. This swayed the Indian diaspora, drawn mainly from upper caste Hindus. They fail to register the distinct multicultural profile of Indian Muslims. While a good fraction of upper caste Hindus is now wedded to the Hindu Right's majoritarian project, plenty embrace it for circumstantial reasons and remain indifferent to Muslim suffering.

The paradox of Indian democracy is that upper caste Hindus, a tiny minority, control the labyrinth of power in all spheres. Even historically, the Mughals and the British had to have upper caste Hindus in their army and bureaucracy to run their empire. Therefore, the upper caste Hindus have to be on board to restore India's wounded secular project because Dalit-Muslim alliances are not enough.

Deepening distress

When lockdowns were imposed during the second wave of COVID-19, 92% of workers did not receive any money from their employer, according to a recent report by the Stranded Workers Action Network (SWAN). The results are based on data gathered from 1,396 worker groups, adding up to 8,023 people, including 4,836 women and children who made distress calls to the organisation in May 2021. Chinese articles dropped in Bihar

New Delhi, June 22: Preliminary investigation has shown broadly that the Chinese literature airdropped by balloons in Bihar villages on June 18 last was of Kuomintang Chinese origin and it would therefore be farfetched to link it with communist or naxalite activites, the Minister of State for Home Affairs, Mr. Ram Niwas Mirdha, told the Lok Sabha to-day. Mr. Mirdha was replying to a volley of supplementaries after making a statement in response to a calling attention motion on the reported air-dropping of Chinese literature, banner, garments, torchlights, biscuits and transmitters for the naxalites by a Chinese plane in the fields of Tidarampur and Palani villages in Monghyr district of Bihar last week. Mr. Mirdha told Mr. Bibhuti Mishra (Cong. R) and four others, who raised the issue, that a full report had not yet been received from the Bihar Government, which was inquiring into it. He was, therefore, unable to give details of the articles recovered and whether or not a tranmitter was among them.

A HUNDRED YEARS AGO JUNE 23, 1921

On India's problems.

London, June 16: Mr. Sastri in course of an interview declared that the burning subject for India at the coming conference was equal rights for Indians within the Empire which were denied by all Dominions in differing degrees and in this connection Mr. Sastri emphasised the distinction between the attitude of Britain and South Africa, Canada and Australia. Mr. Sastri said he could not help wondering whether the Dominions realised the true meaning and greatness of the Empire or whether it was for them simply a matter of convenience for trade connections instead of far greater and higher conceptions. As regards Kenya, Mr. Sastri said that conditions there were a shame to the British name. Indians went to East Africa long before the British. Mr. Sastri paid a tribute to the vigour with which the India Office and the Government of India were fighting India's battles. Referring to the Anglo-Japanese alliance, Mr. Sastri declared that Indians were indifferent to it if reference to India was taken out. He said that there was no ground for any agreement with Japan about the maintenance of peace in India and Mr. Sastri was hopeful with regard to the outlook in India. In his opinion Lord Reading has made an excellent start.

Afghan violence has risen: Jaishankar

Minister says the country's territory must not be used by terrorist groups to attack any other country

NEW DELHI

Talks between the Afghanistan government and the Taliban have not resulted in any reduction in violence, said External Affairs Minister S. Jaishankar, pointing out that reports from the UN Assistance Mission in Afghanistan (UNAMA) showed a major increase in violence despite the talks and a U.S.-Taliban agreement last year. However, he said India is 'supportive' of the Intra-Afghan negotiations, and called for the United Nations to play a "leading role" in the reconciliation process.

"Violence has only increased, especially after May 1," Mr. Jaishankar told the UN Security Council at a special meeting on Tuesday, as he referred to the May deadline that had originally been agreed to as a date for the U.S. troops pull-out from Afghanistan. "The country has

been witnessing targeted attacks on religious and ethnic minorities, girl students, Afghan security forces, Ulemas [clerics], women occupying positions of responsibility, journalists, civil rights activists and youth," he said, calling for a "permanent and comprehensive ceasefire".

According to the UNAMA report that was detailed by U.N. Secretary General's Special Representative Deborah Lyons, civilian casualties have increased by 29% in the first quarter of 2021, compared to last year, and women casualties increased by 37% and child casualties by 23%. Ms. Lyons said not only has the Taliban captured more territory in the last few weeks but also seems poised to take over key cities once

American envoy to the U.N. Linda Thomas Greenfield defended the U.S. move to pull out troops as a care-

the foreign troops pull out.

fully considered decision, but warned the Taliban that taking the "military path" would not bring the group legitimacy.

Without making any direct references to Pakistan or any particular terror group, Mr. Jaishankar called for an end to "terrorist safe havens" and "terrorist supply chains" as well as crossborder terror, and said the international community must ensure that transit trade from Afghanistan to the "high seas" is allowed.

"It is equally important to ensure that the territory of Afghanistan is not used by terrorist groups to threaten or attack any other country." Afghanistan Foreign Mi-

nister Hanif Atmar, who attended the UNSC meeting, was more candid accusing the Taliban of keeping its links with the al-Qaeda and Pakistan-based terror groups including the Lashkar-e-Toi-

ba and the Tehreek-e-Taliban Pakistan.

He said as the withdrawal of the U.S.-NATO troops is completed, the international community would see that the Taliban has not kept any of its promises, including the promise to cut ties with international terrorism, to reduce violence and work towards a ceasefire and to reach a political settlement with the government of Afghanistan.

Arms bound for Myanmar seized, 2 held

In one of the major arms recoveries in recent times in Mizoram, the Assam Rifles on Tuesday seized a large haul of war-like stores being smuggled to Myanmar and apprehended two individuals.

"These explosives are believed to be transported from Mizoram to Myanmar for use by the Chin national Army against the Myanmar Army," an Assam Rifles official said on condition of anonymity. The recoveries included 3,000 special detonators in six cartons, 925 electric detonators in 37 packets, 2,000 metres of fuse in four boxes and 63 sacks of explosives substance, each sack containing 10 packets each of 2.08 kg of Class II Category - ZZ explosive powder weighing a total of 1.3 tonnes, a statement said.

Amid discussions to evolve a consensus on the creation of integrated theatre commands, it is expected that Prime Minister Narendra Modi will make an announcement on it soon and the four proposed commands are likely raised by year end, according to two official sources.

"The theatrisation process is going on well. It is making satisfactory progress. Amongst the three services, we have been able to resolve most of the issues," Chief of Defence Staff (CDS) Gen Bipin Rawat said on Tuesday. He chaired a meeting with the Vice Chiefs of the three services, Chief of Integrated Defence Staff and representatives from the Ministries of Defence, Home and Finance to iron out

differences.

"There is a better understanding that if the three services integrate, bring about jointness and carry out transformation, then I think, we will ensure better efficiency and utilisation of our existing services. I think we'll be better prepared for combat," Gen. Rawat said.

An air defence command. maritime theatre command,

integrated eastern theatre command and integrated western theatre command are on the anvil. "A maritime theatre commander will not be appointed right away. The command will be first raised and commander appointed later," a source said.

Several officials had said the IAF has major reservations over the creation of the commands.

There have also been questions on the naming of the commands. The IAF was for all commands to be rotational and so wanted the naming to be domain specific, one of the sources said. "It has been broadly agreed but initially they would be with respective service commander till the command stabilises," the source said.

Indian students unable to reach Australia due to travel restrictions

Very few of them were granted visas

When 19-year old Pranavi Jamwal got admission last year into one of the world's top 10 political science programmes at Australia's top university which has produced Nobel Laureates and Prime Ministers, she was thrilled.

The only problem? Rather than mingling with fellow students at The Australian National University's prestigious Canberra campus, she is stuck at home in New Delhi, waking up for 4 a.m. online classes.

"COVID has disrupted my plans, and the Australian government is unable to give any clear timeline when I will be allowed to enter the country, and it now looks that at least half my course will be online," she said.

Faced with closed borders, the number of Indian students heading to Australia has been sinking since the pandemic began.

According to IDP Education, which cited Australian government data, Indian students granted an Australian visa dropped from 21,433 in 2019-20 to 11,200 in 2020-21.

allow international students back into the country at the rate of about 800 per month. Australia's High Commissioner to India Brian O'Farrell admits that the scope of the problem is much larger, but says this is an important first step.

"We have over 4,70,000 people who are entitled to be in Australia, studying whether in postgraduate, research, undergraduate or other elements of education, and currently 1,50,000 of those are offshore," he told The Hindu in a recent interview.

"I'm not wishing to get their hopes up any higher. But what is positive is that two states, including Australia's largest State, only last week announced pilot programmes to demonstrate not just to the federal government, but to the Australian community, that international students can return to our shores without there being a community health problem," Mr. O'Farrell said.

International students may be able to return at the end of the first semester in

"I'm optimistic about next year. Do I think that's going to placate the students here in India who should have been in Australia? No, and I have great sympathy for them," Mr. O'Farrell said.







Daily vaccine average continues to improve steadily

SPECIAL CORRESPONDENT

Until 9 p.m. on Tuesday, over 52.8 lakh doses of CO-VID-19 vaccines were administered in India which is only the second instance when the number of doses in a single day crossed the 50 lakh mark. A day before, 87.3 lakh doses were administered, the highest-ever in a single day since the inoculation drive began.

Between June 1 and 21, 34.6 million doses were administered daily in India on an average. At the current rate, a total of 96 crore doses can be administered by December 31, 2021, which is just over half the doses required to fully vaccinate all adults (188 crore doses).

Lofty target

To fully inoculate all adults by the end of this year, 82 lakh doses need to be given daily on average in the country.

The seven-day rolling average of daily vaccinations in the country continues to increase. It stood at 42.5 lakh on June 21, which is more than the 32.6 lakh recorded a week before (June 14). It was also significantly higher than the average daily doses recorded a month before

(May 21) which was 18.5 lakh. About 25.5% of adults in **Keeping the pace** I On Tuesday, 5.28 million doses of COVID-19 vaccines were administered in India until 9 p.m.

India, 45.1% of those aged above 45 and 48.1% of people aged above 60, were administered with at least one dose of a COVID-19 vaccine, until 8 p.m. on Tuesday. While 17.5% of the country's population has received at least one dose, only 3.8% are fully vaccinated.

In comparison, 11.4% and 10.54% of people in Brazil and Russia are fully vaccinated, respectively. The figure for the U.K. and the U.S. stood at 46.33% and 44.86%, respectively.

After administering a recordbreaking 16.9 lakh vaccine doses on single day on Monday – the highest among all States - Madhya Pradesh plummeted to a record low of only 4,563 shots on Tuesday, according to data on the CoWin portal.

India posted an all-time high of 89 lakh doses on Monday, the first day of the new liberalised policy with the Centre procuring vaccines on behalf of the States. While many States had substantially increased the number of vaccines administered, M.P., Haryana and Karnataka had posted the

most significant increases when compared to the average daily doses per month.

Until its feat on Monday, M.P. had at most adminis-

tered five lakh doses per day in June.

While vaccination in most States dips around the weekend, it had plummeted to only 692 doses in the State on Sunday, a day before the drive. However, the daily doses in M.P. have remained above 5,000 in June.

Unless there is a revision to the data, Tuesday's figures is would be an all-time low in Madhya Pradesh barring the Sunday anomaly. There were 3,100 vaccination sessions in the State on Monday, which and that fell to 264 on Tuesday with capital Bhopal only recording 453 inoculations on Tuesday from 150,000 on

Media reports said that on Monday, which the Centre celebrates as International Yoga Day, Madhya Pradesh had a concerted vaccination

drive with Chief Minister, Shivraj Chouhan, personally visiting sites and monitoring progress.

Karnataka too posted a decline from the Monday's high with only 3.8 lakh shots on Tuesday evening compared to 11 lakh on Monday. However, the State has consistently administered over 3 lakh shots since June 5 and so the Tuesday's numbers aren't an aberration.

Haryana which administered 5 lakh doses on Monday fell to about 74,000 on Tuesday which again isn't too far outside its normal range. The peaks it has attained in June are a little over 1 lakh doses a day.

Delta plus, as the variant is sometimes referred to, is an informal name.

So far there are only four international VoC (alpha, be-

ta, gamma and delta) with the off-shoots, AY.1 and AY.2 classified as off-shoots of

"Delta variant is a Variant of Concern and has been found in 80 countries. Delta plus is in 9 countries and as of now is in the category of variant of interest and is not yet in the variant of concern categor," said Bhushan at the weekly press briefing on

However in a press statement, the Ministry first referred to it as a 'variant of concern' then issued a correction calling it a 'variant of interest' and then again reverted to calling it a 'variant of concern'.

A scientist connected with the consortium, INSA-COG, (Indian SarsCov2 Genomic Consortia) told The Hindu on condition of anonymity that AY.1 was "alwavs" a variant of concern but was wrongly classified by the Health Ministry as a

"We cherish freedom of cyberspace, not to be misused to subvert the constitutional values," he said.

Congress leader releases White Paper on Centre's handling of COVID-19

Former Congress president Rahul Gandhi on Tuesday claimed at a press meet that 90% of the deaths during the second wave of the COVID-19 pandemic were "needless" as lives could have been saved if oxygen and medicines were available.

Releasing a White Paper on the Union government's handling of the pandemic, he said it should now prepare for a third wave by ramping up health infrastructure and vaccinating citizens on a war footing so that the virus did not get a chance to mutate.

The White Paper suggests the creation of a COVID-19 compensation fund and a commission to find out "what went wrong" in the fight against the previous waves.

Dig at PM

Taking a dig at Prime Minister Narendra Modi for getting emotional in one of his virtual addresses, Mr. Gandhi said,"The Prime Minister's tears cannot wipe the tears of those who lost their loved

Discussions with experts The White Paper, he observed, was the result of extensive discussions held with experts and within the Congress structure and had four main pillars.

The first pillar talked about what went wrong and the Congress's suggestions, including one to have a commission to probe the shortcomings; the second one focussed on developing the critical infrastructure such as oxygen supply and hospital beds; the third one highlighted financial assistance to the poorest families and the final one was about creation of a COVID-19 fund to compensate the families that have lost the breadwinner.

The coronavirus was not just a biological phenomenon but also an economic and social phenomenon and that's why economic support must be given to the poorest people as well as small and medium businesses, Mr. Gandhi asserted.

"The Centre is making ₹4 lakh crore from taxes on diesel and petrol every year. It is taking money out of the pockets of people who have iost failing members, so, i don't understand why it can't put some money back into their pockets," he said.

The White Paper release coincided with Nationalist Congress Party chief Sharad Pawar hosting a section of Opposition leaders at his residence.

Asked to comment on the meeting, Mr. Gandhi said, "I am not going to distract you or myself by getting into what is going on in politics and what is going on here and there. There is a time and place to that discussion and I am happy to talk to you at that time".

Stop playing politics over pandemic, BJP tells Congress

Rahul making contradictory demands, alleges Sambit Patra

Hours after Congress leader Rahul Gandhi released a White Paper on the Union government's handling of COVID-19 crisis and termed it disastrous, the BJP accused him of playing politics over the pandemic and of the Congress-ruled States managing the pandemic

BJP national spokespera press conference at the party's headquarters in New Delhi to launch an attack on the Congress. "Since yesterday we have been fearing this. Whenever something good happens in our fight against coronavirus, the Congress and Rahul Gandhi specially do something to derail it," he said.

"Yesterday was a significant day when India became the first country in the world to administer 87 lakh vaccine doses in one day. People seemed excited and jubilant. There is a feeling that India is winning in its fight

against coronavirus, just White Paper and tried to derail it," he stated.

"Whenever we are at a crossroads in our fight, Rahul Gandhi and the Congress party have tried to derail the efforts by playing politics. In fact, the Congress has really worked tirelessly to create hurdles and obstacles in our path," he alleged.

Vaccine hesitancy

Mr. Patra accused the Congress-led States of mishandling the pandemic, even saying that the second wave began with a Congress-ruled State. The most number of

those infected were from the Congress-ruled States and so were the most number of deaths. The maximum vaccine hesitancy was seen in the Congress-ruled States and so was the highest CO-VID-19 positivity rate, he observed. "The demand for decentralisation of vaccines came from the Congressruled States and the U-turn demanding centralisation too came from them. Instead of virtual press cont rences and white papers, Rahul Gandhi should go to such States and give them this data," he said.

Mr. Patra called Mr. Gandhi "confused" and charged the Congress with making contradictory demands.

"First they called the lockdown 'Tughlaki', then they questioned why there was no lockdown.... They promoted vaccine hesitancy... I would like to ask Rahul Gandhi how long will he conduct just virtual press conferences? When will you do some real work?," he ad-



Press must not subvert government: Lam

Hong Kong leader says prosecution of Apple Daily was not an attack on 'normal journalistic work'

Media outlets in Hong Kong must not "subvert" the government, the city's leader said on Tuesday, rejecting U.S. criticism of recent action against a pro-democracy newspaper under a powerful new security law.

Hong Kong has long hosted a vibrant international and local media scene but press freedoms have slipped dramatically in recent years.

Last week, authorities froze the assets of Hong Kong's largest pro-democracy newspaper Apple Daily, using the national security law Beijing imposed on the city in 2020.

Two of the paper's executives were charged with "collusion", a national security crime, over what police said were articles calling for international sanctions against China and Hong

Kong's leaders.

"It's not a problem to criticise the Hong Kong government, but if there is an intent to organise activities to incite the subversion of the government then that is, of course, a different thing," Chief Executive Carrie Lam said when asked about Apple Daily and press freedom

"Media friends should have the ability to distinguish between them," she added during her weekly press conference.

The new security law has criminalised a host of political views and the action against Apple Daily has left the media wondering what opinions or reporting could trigger an investigation.

No military solution to Afghan situation, U.S. tells Taliban

The military path will not lead to legitimacy, says U.S. diplomat

SRIRAM LAKSHMAN WASHINGTON

The United States' UN Ambassador Linda Thomas-Greenfield told the Taliban that there is no "military solution" in Afghanistan, as American troops approach a September 11 deadline for complete withdrawal from the country after two decades there. Afghanistan has seen an increasing level of violence in recent months, as the Taliban makes territorial gains.

"To the Taliban, we reiterate that the military path will not lead to legitimacy. As many of us have stated, including my colleagues on this Council from Europe, Russia and China, there is no military solution in Afghanistan. The world would not recognise the establishment in Afghanistan of any government imposed by force, nor the restoration of the Islamic Emirate. There is only one way forward and negotiated and inclusive political settlement, through an Afghan-led and Afghan-owned process," Ms. Thomas Greenfield told the UN Security Council at a virtual meeting on Afghanistan, which included External Affairs Minister S. Jaishankar and Afghanistan's Foreign Affairs Minister Mohammed

"...The parties to this conflict must press forward on a peaceful resolution in Afghanistan which protects the gains of the last two decades...," Ms. Thomas-Greenfield said, adding that there was an "unacceptable" level of violence against women, girls and ethnic and religious minorities

"We will use our full diplomatic, economic and assistance toolkit to support the peaceful, stable future, the Afghan people want and deserve. And we will continue to support the Afghan National Defence and Security Forces in securing their country," Ms. Thomas-Greenfield said.

The U.S. intelligence and defence establishments are still working out how they will

gather intelligence and conduct counter-terrorism operations in Afghanistan after September 11 this year, the New York Times reported. Last week, NATO committed to training Afghan security forces after U.S. troops withdraw from the country.

"Everyone who can influence the parties involved, including Afghanistan's neighbours, should step up now to secure the region and promote peace and stability. Like us, Afghanistan's neighbours want to ensure terrorists can never use Afghanistan to threaten the security of any country. Six killed in Myanmar clashes

Four protesters and at least two officers were killed as Myanmar soldiers battled an anti-junta civilian militia with small arms and grenades in the country's second city Tuesday, authorities and military sources

Fighting has flared across Myanmar since the February coup as people form "defence forces" to battle a brutal military crackdown on dissent, but clashes have largely been restricted to rural areas.

Acting on a tip-off, security forces raided a house in Mandalay's Chan Mya Tharsi township on Tuesday morning, the junta's information team said in a statement, and were met with small arms fire and grenades.

Two officers were killed during the raid, military sources told AFP, and at least ten were wounded.

U.S. shares plan to allocate 55 mn vaccine doses globally

41 million shots will be shared through COVAX

The Biden administration, on Monday announced how it would allocate 55 million of the 80 million doses from its vaccine supply to other countries. It is unclear how many doses India will receive in this second allocation.

The administration al-

ready outlined its plans to share the first 25 million doses of its stockpile both bilaterally and via CO-VID-19 Vaccines Global Access, abbreviated as COVAX an international coalition to distribute vaccines globally. Three quarters of the 80 million are being shared via COVAX and one quarter directly. Of the 80 million, 60 million are AstraZeneca vaccines, not yet approved for use in the U.S.

Of the 55 million doses, 41 million will be shared via



COVAX. Of this, approximately 14 million will go to Asian countries, including India, some 10 million for Africa (coordinated by the African Union) and approximately 16 million for Latin American countries. Another 14 million doses will be shared "with regional priorities and other recipients", the White House statement said. This includes African, Asian, East-

ern European and South American countries as well as three South Asian countries - Afghanistan, Bangladesh and Pakistan. The specific number of vaccines will be determined and shared as the administration works through logistical and regulatory specifics for each region, the White House said.

At the G7 in the U.K. last week, President Joe Biden announced that the U.S. would purchase and donate 500 million doses of the Pfizer-BioNTech vaccine to low and middle-income countries. The G7 also committed to provide a total of 1 billion vaccine doses from this summer onwards.

The World Health Organisation (WHO) has estimated that the world needs 11 billion vaccines to respond to end the pandemic.

U.S. criticism of polls is meddling: Iran

Iran accused the U.S. on Tuesday of interference for saying its election was neither free nor fair as political factions traded blame for the record low turnout and high number of invalid ballots.

Ebrahim Raisi, a hardline judge who is under U.S. sanctions, secured victory in elections on Saturday.

A U.S. State Department spokesman said on Monday the U.S. viewed the process that made Mr. Raisi Iran's President-elect as "pretty manufactured", reiterating the U.S. view that thep oll was neither free nor fair.

Tehran rejected the criticism. "We consider this statement as interference in our domestic affairs, contrary to international law and reject it," Iranian government spokesman Ali Rabiei was quoted by state media as saying.

Why is China targeting cryptocurrencies?

Beijing seeks to strengthen its monetary hold and project its new official digital currency

SRIRAM SRINIVASAN

The price of the world's most prominent cryptocurrency Bitcoin has more than halved in the last two months after hitting a peak in mid-April. The secondmost valuable cryptocurrency, Ether, has seen a similar fall from its peak last month. China's crackdown against cryptocurrencies, which are those that aren't sanctioned by a centralised authority and are secured by cryptography, is said to have a lot to do with the crashing of the value of cryptocurrencies.

What has China done? In recent weeks, China has

reportedly cracked down on crypto mining operations. The country has over the years accounted for a large percentage of the total crypto mining activity that takes place. In purpose, Bitcoin miners play a similar role to gold miners – they bring new Bitcoins into circulation. They get these as a re-

ward for validating transactions, which require the successful computation of a mathematical puzzle. And these computations have become ever-increasingly complex, and therefore energy-intensive in recent years. Huge mining operations are now inevitable if one is to mine Bitcoins. Access to cheap electrici-

ty has made mining lucrative in China. According to the Cambridge Bitcoin Electricity Consumption Index, China accounted for nearly two-thirds of the total computational power last year. Xinjiang and Sichuan provinces accounted for nearly half of this. Now, provincial governments one by one have acted against these mining operations. The latest to do so is Sichuan, which was a hydroelectricbased crypto mining hub.

But that's not all. A few days back, the People's Bank of China directed banks and payment firms to pull the plug on cryptocurrency trading.



Actually, there is little change in the policy as far as China is concerned. It first imposed restrictions on cryptocurrencies way back in 2013. It then barred financial institutions from handling Bitcoin. Four years later, it barred what are called initial coin offerings, under which firms raise money by selling their own new cryptocurrencies. This is largely an unregulated market.

What China wants?

An inter-ministerial committee report in India two years ago noted that in 2017, the government of China also banned trading between RMB (China's currency renminbi) and cryptocurrencies. It said, "Before the

ban, RMB made up 90% of Bitcoin trades worldwide. In under a year, the trades between RMB and Bitcoin had of Bitcoin had brought many back into action.

The fact that cryptocurrencies bypass official institutions has been a reason for unease in many governments. Not just that. The anonymity that it offers aids in the flourishing of dark trades online. While many countries have opted to regulate the world of cryptocurrencies, China has taken the strictest of measures over the years. According to observers, the latest set of measures are to strengthen its monetary hold and also

'Tying reforms, incentives helped widen adoption'

PM cites States' extra FY21 borrowings

SPECIAL CORRESPONDENT NEW DELHI

India has moved from a model of 'reforms by stealth and compulsion' to a new model of 'reforms by conviction and incentives', Prime Minister Narendra Modi asserted on Tuesday, referring to States being granted additional borrowing limits last year under a reform-linked window.

Observing that raising adequate resources for public welfare while ensuring sustainability was proving to be one of the biggest challenges during the pandemic, the PM noted that States were able to borrow an extra ₹1.06 lakh crore in FY21.

"For a large nation with complex challenges as ours, this was a unique experience. We have often seen that for various reasons, schemes and reforms remain unoperational, often for years," he said in a post on the job search and social

networking portal LinkedIn. 'Officials who have been working on these reforms suggest that without this incentive of additional funds, enactment of these policies would have taken years. This was a pleasant departure from the past where the Centre & States came together to roll out publicfriendly reforms in a short span of time amidst the pandemic," Mr. Modi wrote.

'Four specified reforms' In May 2020, under the Aatmanirbhar Bharat package, the Centre had permitted States to borrow an additional 2% of Gross State Domestic Product (GSDP), but half of it was contingent on implementation of four specified reforms. Twentythree States availed of additional borrowings of ₹1.06

₹2.14 lakh crore.

"Each of the reforms was linked to improving the ease of living to the public and particularly the poor, the vulnerable, and the middle class. Secondly, they also promoted fiscal sustainability," Mr. Modi wrote.

Seventeen States that facilitated ration-card portability and installed electronic point-of-sale devices at fair price shops were granted additional borrowings amounting to ₹37,600 crore, the PM noted. Similarly, 20 States completed reforms to ease the red tape faced by businesses to avail borrowings of ₹39,521 crore.

"The third reform required States to notify floor rates of property tax and of water & sewerage charges, in consonance with stamp duty guideline values for property transactions and current costs respectively, in urban areas. 11 States completed these reforms and were granted additional borrowing of ₹15,957 crore," he added, stressing that the urban poor would benefit the most from this step.

The least traction was seen for the Centre's reform idea of replacing free electricity for farmers with a Direct Benefit Transfer.

A peep into the future as Gill, Shafali and 'DK' hint at greatness to come



Three relative newcomers from India impressed in England last week. In Southampton, opener Shubman Gill played his inaugural Test in England like a veteran of many innings there.

He was confident, untroubled, peaceful (a word not usually associated with sportsmen performing on the field).

And he pulled the short rising delivery from the New Zealand fast bowlers between mid-wicket and mid-on after getting on top of the bounce – there's class right there for you.

Gill made only 28 before he was caught behind; a pull off the front foot against Trent Boult vying with a straight drive off Kyle Jamieson for the best of his boundaries.

Watching Gill bat brings back memories of the early Sachin Tendulkar or Virat Kohli.

Not in the way he bats, although there are similarities in the way he brings his bottom hand into play, but in the way he promises to carry India's batting on his shoulders like them.

Every generation needs a player around whom the batting revolves; there is a straight line from Sunil Gavaskar to Tendulkar to Kohli, and Gill seems equipped to extend that line.

Early days yet

These are early days yet, and Gill will have to display both the responsibility and the longevity of the other three, but the signs are encouraging at this

Gill top-scored with 91 in India's memorable run chase in Brisbane earlier this year – it was only his third Test – having made 50 and 31 in Sydney in the previous Test and 45 and 35 not out in Melbourne on debut.

A first century might start a sequence and take him over the line that separates the good from the great. Tendulkar's first century came in his ninth Test, Kohli's in his eighth.

the England series following the final of the World Test Championship. The focus on India's bowling heroes

and the blossoming of Rishabh Pant among the batsman has allowed Gill to do his stuff quietly in the background without undue pressure.

High expectations

Expectations have always been high, though, after he made a triple century in an under-16 match and later 268 against Tamil Nadu in the Ranji Trophy as a 19-year-old. In between, he was player-of-the-tournament at the Under-19 World Cup, so there is an inevitability about his progress.

Beyond his game, Gill has, unusually for an international player and one so young, displayed a social consciousness in his tweets. A future India captain, perhaps?

A second newcomer in England caught the eye in Bristol. Shafali Verma said hello to Test cricket with innings of 96 and 63 as India drew the women's Test after following on.

The last time India played a Test, Shafali was 10 years old. Soon she was disguising herself as a boy to attend

Gill might be the batsman to watch in camps in Rohtak, Haryana, where girls were actively prevented from taking up sport. Luckily Shafali's father encouraged her, and at 15 she was good enough to play for India. That was two years ago, when she broke Tendulkar's record as the youngest Indian to score an international fifty.

It is not unusual for contemporary players to be compared with players of the past. It helps to understand the more recent performer.

In fact, it is a two-way street, allowing those of an earlier generation to fix a current talent in their minds while giving younger fans an insight into an earlier player.

Comparison

There is something about Gill that has already invited comparison with Barry Richards for his on-side play. A more accessible comparison might be with Dilip Vengsarkar, a stylish batsman, tall and elegant while driving.

Shafali's natural sense of timing and reliance on her eye rather than solely on footwork immediately brought to mind Virender Sehwag who could drive the ball through the narrowest of gaps in the field or send it racing with what looked like the gentlest of pushes. The third star to emerge is the commentator Dinesh Karthik, who has channelled his natural exuberance beautifully and has worked out the balance between the technical and the anecdotal, side-stepping cliche and platitude, and communicating his

sheer delight to the viewers. 'DK' is only 36, and as he pointed out, still an active player. But already he is the most promising commentator to emerge since Harsha Bhogle made his mark in Australia three decades ago. It's been a long wait!

Fit to be alongside the best

Television's insistence on appointing only internationals has given us some insufferable commentators names!), but here's an international fit to be compared with the best in the world.

There is a joy in discovering promising youngsters and then watching them live up to that promise. India have had great players, both men and women, but few great commentators.

It's all coming together in England this season. There's much to look forward to.
