Vaccination declines by 60% as States say they have no doses

Immunisation centres in several regions shut down after stocks run out

SPECIAL CORRESPONDENT NEW DELHI

The weekly pace of vaccination has declined to nearly 60% of what was seen in the week after June 21, when the Centre entirely took over vaccine procurement from the States. The slackening has resulted in several States complaining of a shortage and an inability to cater to demand.

On June 21, the first day of the new policy, nearly 91 lakh doses were administered and until June 27, about 4 crore were administered. While the subsequent week didn't match up, the period from July 5-11 has seen only 2.3 crore doses being dispensed. So far, about 38 crore vaccines have been administered since the drive commenced in January.


Behind target

In the week since June 21, 60 lakh vaccines a day were the norm. However, the last time India crossed that daily figure was July 3. In order to meet the Centre's commitment to fully vaccinate all adults by the year-end, at least 80 lakh doses have to be administered every day.

Several States have reported having to shut down vaccination centres due to the unavailability of stocks.

left in hand. This is definitely not enough... We need nearly 11.5 crore doses but have received only 1.67 crore doses. We require 10 crore more doses. The government is continuing its efforts to get more vaccines," said Ma. Subramanian, Tamil Nadu

On Tuesday, Tamil Nadu Chief Minister M.K. Stalin, in a letter to the Prime Minister, pointed out the imbalance in the allocation for Tamil Nadu and sought special allocation of one crore doses.

Vaccination centres re-

maining closed or people queuing up for vaccines for long hours have become a common sight in many places. Tamil Nadu has so far received 1.67 crore doses of the two vaccines, while 1.66 have administered.

Maharashtra's demands Maharashtra has adminis-

tered 3.7 crore doses thus far. The State government has claimed it has the capacity to administer 15 lakh doses a day. Health Minister Rajesh Tope said 70 lakh doses had arrived last week but they were exhausted in just three days. The State Assembly had recently passed a resolution demanding 3 crore doses per month from the Centre for the next three months.

Till date, around 47% of Mumbai's populace above 18 years has been administered the first dose while more than 25% has been given both doses. A total 60 lakh people (both first and second doses) have taken the vaccine.

Uttarakhand government suspends Kanwar Yatra

Uttarakhand has decided to suspend this year's Kanwar Yatra in view of the CO-VID-19 situation, "giving top priority to the protection of human life". The decision was taken by Chief Minister Pushkar Singh Dhami, following a meeting with senior State officials on Tuesday.

Monsoon arrives in Delhi, late by 2 weeks

The last time the rains arrived this late was in 2002 when it reached the Capital on July 19

The southwest monsoon finally advanced over the Capital on Tuesday after missing its normal onset date of June 27. The last time the monsoon arrived this late in the Capital was 19 years ago in 2002 when it reached the Capital on July 19.

With its advancement over Delhi, the monsoon has now covered the entire country, the India Meteorological Department (IMD) said. The normal date for the monsoon to cover the entire country is July 8.

Rain lashed several parts of the city early in the morning and continued in spurts throughout the day with the official weather reading recorded at the Safdarjung station showing that the Capital received 28.1 mm of rainfall between 8.30 a.m. and 5.30 p.m. on Tuesday.

The rain brought relief from the heat with the maximum temperature settling at

30.9 degrees Celsius, five notches below normal. The minimum settled at 23.5 degrees Celsius, which was four degrees below normal.

The delay in the monsoon had lead to a string of heatwaves in the Capital in the first week of July with the maximum temperature settling at 43.1 degrees Celsius on July 1 and at 42.6 degrees Celsius on July 7.

The IMD said the delay in advancement of the monsoon over the Capital was mainly due to no formation of low-pressure area over the Bay of Bengal, no presence of monsoon trough at mean sea level near Delhi and 5-6 western disturbances that moved west to east across north India, which dominated the monsoon easterlies.

The Met department got the prediction for the monsoon's onset over Delhi wrong this time as it had first said the monsoon would arrive early – by June 15.

It then changed its forecast on June 14 saying the monsoon would be delayed further and that it would advance into remaining parts of western Uttar Pradesh, some more parts of Punjab, Haryana and Rajasthan and Delhi around July 10. While the neighbouring areas received rain, the monsoon continued to elude the city till Tuesday morning.

"Such type of failure by numerical models in prediction of monsoon advance over Delhi is rare and uncommon. It is needless to mention that IMD has predicted with high accuracy about the advance of monsoon over Delhi in recent years and also the advance of monsoon over different parts of the country during the monsoon-2021 accurately about four to five days ahead," the IMD said.

More rain

The forecast for July 14 reads generally cloudy sky with rain/thundershowers. The maximum and minimum temperatures are likely to settle between 33 and 24 degrees respectively.

PWD gets 70 waterlogging complaints in 10 hours

Vehicular movement affected in various parts of the city

The Public Works Department (PWD), which has jurisdiction over the entire network of arterial road stretches in Delhi, received around seven waterlogging complaints every hour following the sudden downpour on Tuesday.

According to a PWD official, the department's control room received 70 calls about waterlogging during a ten-hour period starting around 9 a.m.

"There was some duplication in the complaints but, broadly, most of them pertained to around half a dozen locations and alleged waterlogging within an hour after the shower. The first call was logged around 8.50 a.m.," the PWD official said.

Waterlogging complaints were received in relation to

the Azadpur metro station, Majlis Park, Pul Prahladpur underpass, Mathura Road, Dhaula Kuan, Badarpur metro station and MB Road near the DM office.

Delhi traffic police said vehicular movement was affected and heavy traffic was observed at Dhaula Kuan and Azadpur in addition to Delhi Cantonment and Kalindi Kunj flyovers among other locations.

Meanwhile, Leader of the Opposition in Delhi Assembly, Ramvir Singh Bidhuri accused the Delhi government of indulging in a "sewer scam" by claiming that all PWD-owned sewers had been cleaned in the Capital. The season's first rainfall, he alleged, had clearly exposed the "fraud" perpetuated by the AAP Delhi government on citizens in this regard.

Teenager attacked by stalker succumbs during treatment, accused in custody

Alleged perpetrator a DU graduate, he hit her with an axe

The 16-year-old girl who was attacked by her alleged stalker with an axe in south-west Delhi's Moti Bagh died during treatment at Safdarjung Hospital on Tuesday morning, the police said.

The accused, Pradeep alias Praveen, a resident of a jhuggi in Shastri Park, South Campus, has been arrested, said DCP (South) Ingit Pratap Singh. Pradeep completed his graduation from Delhi University this year.

Mr. Singh said the accused, who had been stalking the girl for some months, attacked her to get revenge after her father had slapped him. The accused was arrested from his sister's house in Palwal in Haryana when he

was about to flee to Mumbai. He had bought the axe from R.K. Puram last month and attacked her with it on Monday. She sustained se-

rious injuries near her eyebrow. A case lodged under Section 307 (attempt to murder) has been changed to 302 (Murder) of the IPC following her death.

"We will add further IPC sections of stalking and sections of Protection of Children Against Sexual Offences Act against the accused. The axe has been recovered and the incident has been captured on a CCTV camera," said an officer.

'He threatened to kill her before her birthday and did it'

Teenager's father had slapped him for stalking her, says eyewitness

Nearly a fortnight ago, Pradeep had allegedly threatened the teenager that she won't survive to celebrate her seventeenth birthday.

As it turned out, he kept his word and attacked her on Monday – a day before her birthday. A few hours later, she succumbed to injuries.

According to an eyewitness, the girl had complained to her father about being stalked by the accused for the past few months. Next, her father confronted Pradeep in a nearby vegetable market and slapped him. The accused had then, in full public view, challenged to kill her before her birthday.

'No complaints lodged' "He did what he had threatened to do. We all thought he was making empty threats. Being a concerned

neighbour, we all had asked

the girl's father to file a pol-



ice complaint. But he did not want his daughter to get involved in all this and thought that things had settled down," said the eyewitness.

On the day of the incident, the eyewitness said, Pradeep was waiting for her outside

the society gate. When he saw her walking towards her house, he attacked her with the axe and ran away. The girl was bleeding profusely and screamed for help. Residents then informed the police about the incident. But by the time, the police arrived, she had fainted.

Concerns over security

"She was rushed to a hospital by a security guard in an autorickshaw. The police collected the murder weapon [axe] from the spot and CCTV footage of the entire incident. After the incident, residents have raised concerns over the security in the area," said the eyewitness.

The girl's father works as a housekeeping staff in an Embassy while her mother works as a maid. The victim was the eldest child and has two sisters and one brother.

"I am concerned over the security of the victim's two younger sisters. The victim was a brilliant student of Class XI and recently her father had brought her a mobile phone for online classes. Her father is numb while her mother is inconsolable," said a distant relative.

Man with criminal cases shot in lawyer's chamber _

A 42-year-old man was shot dead inside a lawyer's chamber in Dwarka Court Complex on Monday night. Police have registered a case and begun probe.

DCP (Dwarka) Santosh Kumar Meena said the victim has been identified as Swikar Luthra. A case under section 302 (punishment for murder) of the IPC has been registered and investigation is under way.

Police sources said the incident took place around 9 p.m. when Luthra, who has several criminal cases registered against him, was visiting lawyer Arun Sharma in his chamber.

Govt. should hold talks with farmers: BJP leader

Dhankar, Prof. Singh had said "he was unable to accept this responsibility because of the ongoing farmers' agitation in support of their demands, which I also supported from Day One".

'Losing patience'

On Tuesday, Prof. Singh, in a tweet from his handle, said the agitating farmers were losing patience time and again and that could happen during such a long movement. His tweet came in context of the farmers' clash with State Assembly Deputy Speaker Ranbir Gangwa in Sirsa on Sunday.

Prof. Singh said no political party has the capacity to run a movement for so long and the farmers alone could do so, demanding that the government open the avenues of dialogue with them. In an obvious reference to the cases registered against the farmers in Sirsa two days ago, Prof. Singh, with a folded hands emoji, said Mr. Gangwa and Sirsa MP Sunita Duggal show big heart and withdraw the cases.

Speaking to The Hindu over phone, Prof. Singh, said the government should show "large heart" to initiate dialogue with farmers without any "pre-conditions" and patiently listen to their grievances.

SC declines to revoke bail for 12 in gold smuggling case

The Supreme Court on Tuesday declined to revoke the bail granted to 12 accused in the high-profile Kerala gold smuggling case and agreed to examine whether the Unlawful Activities (Prevention) Act (UAPA) can be invoked in smuggling cases.

The question is whether the offence of gold smuggling is covered entirely under the Customs Act or would it fall within the definition of terrorist act under Section 15 (1) (a) (iiia) of the

A Bench led by Chief Justice of India N.V. Ramana issued notice to the 12 accused who were granted bail by the Kerala High Court on this limited question of law concerning the UAPA.

The Centre and the National Investigation Agency, which had moved the apex court against the High Court's categorical finding that the UAPA would not stand in smuggling cases, argued in the top court that the High Court's view was divergent with its Rajasthan counterpart, and the law needed to be finally clarified by the Supreme Court.

The Kerala High Court had maintained that the UAPA cannot be invoked in smuggling cases unless the crime was done with the intent to threaten the economic security of the country. The NIA had approached the High Court, invoking the UAPA, after the NIA court in Kochi gave the accused bail



An unproductive idea

Socio-economic empowerment is more effective than coercion in cutting fertility rates

Tncentives and penalties form an integral component of the measures to control population growth, an-▲ nounced by Uttar Pradesh Chief Minister Yogi Adityanath on Sunday. These steps are aimed at reducing U.P.'s total fertility rate (TFR), recorded as 2.7 by the National Family Health Survey-4 in 2016, a figure only lower than that of neighbouring Bihar (3.1 as of 2020 in NFHS-5). Aims in this direction – increasing the rate of modern contraceptive prevalence, male contraception, decreasing maternal mortality and infant mortality rates significantly by 2026 – are, on the face of it, in line with what was stressed at the Cairo International Conference on Population and Development in 1994. The Cairo Consensus called for a promotion of reproductive rights, empowering women, universal education, maternal and infant health to untangle the knotty issue of poverty and high fertility. But rather than taking steps in this direction, the Government seems to have taken the beaten path of a mixture of incentives and penalties to tackle what is a socio-economic issue as a demographic one. In a draft Uttar Pradesh Population (Control, Stabilisation and Welfare) Bill, 2021, the Government aims to incentivise one-child families and reward those with two children with perks in government schemes, rebates in taxes and loans, and cash awards if family planning is done among other sops. Disincentives for those with more than two children include denial of subsidies and welfare benefits, a bar on applying for government jobs and taking part in local elections. Assam, also led by the BJP, is mulling a similar policy.

The incentives/disincentives approach has been denounced in the past by the National Human Rights Commission after such measures were introduced by several States in the 1990s and 2000s, i.e., Haryana, undivided Andhra Pradesh, Madhya Pradesh, Rajasthan, Chhattisgarh and Odisha. The Supreme Court, in 2003, upheld a Haryana government law barring persons with more than two children from contesting local body polls, but the legal grounding of the moves impinging upon the informed choice of the individual remained questionable. Empirical studies of coercive measures have shown their discrimination against marginalised people in particular and with no discernible effect on population control, while more substantive poverty reduction schemes and economic reforms have raised labour productivity and employment opportunities, allowed families to empower women, and reduced fertility rates as rational choices. India's TFRs have been reducing substantially across most States, even in U.P. and Bihar with the highest TFRs. To hasten the drop to replacement levels of fertility, States should tackle the socio-economic issues confronting India's largely youthful demography rather than seeking neo-Malthusian approaches on population control.

Redemption road

Despite the violence of English fans. Euro

2020 will be remembered for good football nort is replete with redemption stories. Teams wrestling with their pasts before swimming towards the light make for compelling plotlines. But for giant footballing countries, success following failure is more of a sequence and less of a narrative. This millennium, Germany and France have plumbed the depths before rising to become world champions. But Italy's redemption story at Wembley on Sunday, a penalty shoot-out victory over England to secure only its second-ever European Championship, should not be seen through such a reductionist lens. The triumph represents the transformation of a proud, but dogmatic, footballing nation into a modern, forward-looking side, with the singular aim of coming out of one of its darkest chapters – of not qualifying for a World Cup (2018) for the first time since 1958. In the process, Roberto Mancini's outfit also cleared the fog that had settled over international football. Built around the midfield abilities of Jorginho, Marco Verratti and Lorenzo Insigne, and the pace and drive of Federico Chiesa and Leonardo Spinazzola, Italy played with verve. Veteran defenders Giorgio Chiellini and Leonardo Bonucci ensured it also displayed old-school nous. Together with the goal-keeping brilliance of Gianluigi Donnarumma – player of the tournament – the Azzurri beat No.1 ranked Belgium, No.6 Spain and No.4 England back-to-back to claim their first major trophy since the 2006 World Cup.

Italy, no doubt, had a generation of players schooled in progressive methods since their youth, but Mancini's tactical acumen stood out. The 56-year-old's handling of the loss of key personnel was smart, as was his role in shaping Italy's response after England went a goal ahead and threatened to end its own trophy drought of 55 years. In contrast, Germany suffered under outgoing coach Joachim Low's defunct ideas, while a complacent France blew a 3-1 lead against Switzerland and crashed out. Luis Enrique's Spain, though, impressed, despite falling to Italy over penalties in the last four. Barcelona's Pedri proved a gem and the 18-year-old midfielder was duly named the young player of the tournament. Cristiano Ronaldo won the Golden Boot (5 goals, 1 assist) but was far from the driving force he usually is for Portugal, the 2016 winner. Denmark, by reaching the semifinal despite the traumatic exit of Christian Eriksen, showcased its collective spirit. The only discordant notes in an otherwise excellent competition were English fans' violent behaviour on the final day and the racist attacks on players who erred in the penalty shootout. But in the long run, Euro 2020 will be remembered for restoring Italian football, reinvigorating international football and proving mildly therapeutic to fans worldwide amidst an unending, exhausting pandemic.

The upcoming crisis in Indian federalism

The national compact has to be reimagined so that post 2026, the most successful States are not punished politically

The Indian Constitution may face an unprecedented crisis in 2026 when there will be a dramatic change in the composition of the Lok Sabha. Since 1976, seats in the Lok Sabha have reflected the 1971 census and have not taken into account changes in the population. The primary reason for this has been unequal population growth among States. India's most highly developed and prosperous States have been successful at family planning, while the poorer States continue to expand. The freeze was thus a chance to ensure that India's most successful States are not punished politically for their success. Post 2026, when this compact ends, there will be a seismic shift in national power towards India's poorest and most populated States, which is sure to generate much resentment among the States that will lose political and economic power and influence. This calls for a realignment in the balance between the democratic principle and the federal principle in the Indian Constitution.

The essence of the Union

As Article 1 of the Indian Constitution says, India is a Union of States. The choice of words is deliberate: it is the several States that, together, make up the Indian Union. Admittedly, unlike in other federations, there is no separate State citizenship or State Constitutions. However, one need only study the history that led up to the linguistic reorganisation of States in 1956,

and to subsequent movements for Statehood afterwards, to understand that States are distinct associative communities, within the federal structure of the Indian Union. Indeed, in a polity as plural as ours - linguistically, culturally, and ethnically - it could not be any oth-

Big versus small States

Having established, thus, that States are important, self-contained units within the Indian constitutional scheme, we must turn to an inherent contradiction between the principles of democracy and federalism, when federal units are unequal in size, population and economics. This is easy to comprehend. In a democratic set up, all citizens are equal and are thus entitled to equal representation in governance. But this would imply that bigger States are likely to dominate the national conversation over smaller States. Small States fear that they would get a smaller share of the pie economically, a much reduced say in national issues, and be irrelevant in the political governance of the country.

In order to assuage this legitimate fear, federal democracies have incorporated into their governing structures various kinds of compromises to ensure a balance between democratic principles and federal ones.

For example, when the Americans adopted their Constitution, they protected smaller States in four ways. First, national powers over the States were limited. Second, each State regardless of size had two seats in the Senate, giving smaller States an outsized role in national governance. Third, Presidents are elected by electoral votes, which means they must win States rather than the total national population. Fourth, and deplorably, the slave-owning States

which did not confer citizenship on slaves were allowed to count the slaves for purposes of representation, with each slave being

counted as three-fifths of a person. This essential structure remains the bedrock of the American Constitution today, though the Americans have rid themselves of slavery (fortunately) and have dramatically increased the scope of federal intervention. This federal structure has led to the severing of causational links between the national vote and presidential elections. Presidents George W. Bush and Donald Trump won without winning the popular vote.

The current movement to remove the power of a minority to filibuster legislation is based on democratic principles seeking to mitigate the pathology of excessive federalism: indeed, the American structures of government go so far in the other direction, that they have been accused of essentially facilitating and entrenching minority rule through the Senate, which favours rural, sparsely populated States that are also predominantly white.

The Indian structure

Other federations (Switzerland and Belgium come to mind) have adopted other - less extreme forms of reconciliation. However, India's quasi-federal structure has always been sui generis. Our founders knew that India's diversity

made federalism inevitable, but, fearing fissiparous tendencies among States that had never been a single political unit, they also created a strong centre. While history has been chequered, the fears for Indian national unity simply on the basis of giving States greater powers have proven to be unfounded – and if at all, it has been the other way. The 1956 reorganisation of States on linguistic lines was a popular recognition of federal principles and yet did not result in separatist tendencies. Since then, new States within the Union have been created in response to the demands of people for greater autonomy.

In India, any clash between federal principles and democracy will inevitably also have linguistic, religious and cultural implications and may result in new forms of sub-regional chauvinism. Thus, there is an urgent need to reimagine our national compact another freeze will only kick this thorny issue down the road and will continue to perpetuate an increasingly undemocratic set up.

Fine-tune these elements

We have the components of such a new balance that need to be finetuned to Indian realities. First, the powers of States vis-à-vis the Centre contained in the Lists and in the provisions dealing with altering boundaries of States must be increased to assuage the fear of smaller States that they will be dominated by bigger ones. There is no reason to believe that empowering our States would cause national disintegration. On the conmore localised decision-making is bound to increase national prosperity. Indeed, this was the entire goal of the creation of Panchayat governance through the 73rd and 74th Amendments to the Constitution, Supreme Court of India. Gautam Bhatia is whose promise remains – unfortu-

nately - unrealised.

Second, the role and composition of the Rajya Sabha, our House of States, must be expanded. This would allow smaller States a kind of brake over national majoritarian politics that adversely impact them.

Third, constitutional change and the change in financial redistribution between the States must require the consent of all or nearly all States (the fate of the Goods and Services Tax, or GST, serves as a salutary warning in this regard). Constitutional provisions dealing with language and religion must also be inviolate. If India is a joint venture between majority and minority shareholders, the minority must be protected by a comprehensive list of "consensus items" that require unanimity - or at least, a super-majority - and not simple majority.

Fourth, serious thought must be given to breaking up the biggest States into smaller units that will not by themselves dominate the national conversation.

Competing claims

The unity of India is, of course, the fundamental premise underlying this discussion; but this unity does not depend on an overbearing Centre for its survival. National bonds of affection and patriotism will not be severed by devolution of powers though they will be at least severely strained when one part of the country is empowered over another. Lampedusa's Il Gattopardo contains the memorable quote, Everything must change for everything to remain the same. This includes the question of how we are to balance the competing claims of democracy and federalism, in the years to come.

Framing the legislation, forgetting the transparency

India, it appears, is charting a regulatory framework without discussion and openness, and with government overreach

was the June of 2002 and the Information and Broadcasting ▲ Ministry office on the fifth and the sixth floors of Shastri Bhavan, New Deini, was buzzing with activity. Cable operators referred to as "unsavoury characters" had taken over the conference room which was overflowing with pizza and soft drinks. Reporters could come and go and talk to officials; usually the Secretary and the Additional Secretary would come out to brief the reporters. There was a reason for this flurry of activity. The Cable Television Networks (Regulation) Amendment Bill, which had the potential of regulating the business of lakhs of cable operators, multi-system operators and broadcasters, was going to be debated in Parliament and it was the draft of the proposed Bill that was being discussed threadbare with stake-

Then and now The discussions spilled over months as reporters munched through the pizzas. The Ministry was careful to keep the stakeholders away from each other. Such was the unease between the stakeholders. It was evident to all of us that while Ministry officials were comfortable discussing the provision of the proposed Bill with broadcasters, cable operators were a different kettle of fish. So, while the broadcasters were invited at dusk, the cable operators

held sway during the day. The Atal Vajpayee government, much like the present Government, was clueless about the number of cable operators; many had sizeable stakes in the real estate business in the country and carried the channels for a price which was at the centre of animosity between the broadcasters and the ca-

Eventually passed by Parlianistry officials had no fix on the Networks Regulation (Amenament) Act was not a perfect Act, and would undergo many more amendments, but the changes were the outcome of intense discussions with all stakeholders. OTT in focus

But when the now former Ministry of Information and Broadcasting Minister Prakash Javadekar commented that the Mi-



ment in 2002, the Cable Television number of OTT platforms and users in the country, his concern was legitimate. After all, this is a business and along with the entertainment industry, had reached ₹1.82 trillion in 2019 and has been projected to cross ₹2.4 trillion by 2022 (FICCI report on media and entertainment; https://bit.ly/36xaDTJ). In fact, digital media overtook filmed entertainment in 2019. And to throw in some more figures, there are around 550 million television and smartphone consumers in the country. The figures are expected to double by 2025.

There are over 200 million OTT subscribers. The major draw of OTT is this: the content being served to you when you want it. You are free to watch what you wish to at a time chosen by you on a platform you are comfortable with. Your smartphone doubles up as the screen as you navigate your ride on the metro.

This is in danger now with the IT rules having come into effect on February 25 (https://bit.ly/3riYdZn and https://bit.ly/3i8KEHF) with the Government giving digital publishers three months to comply (https://bit.ly/3B1qQ1E). The Digital News Publishers Association – a 13-member collective of some of the leading news media companies, the Press Trust of India and now the News Broadcasters Asso-

ciation, have moved courts petitioning them to intervene and stop the code which not only restricts free speech but also far exceeds the mandate of the IT Act in empowering the executive from controlling online content.

Incidentally, while amending the Press and Registration of Books Act, 1867, to bring within its ambit digital news platforms two years ago, for good measure, the Ministry had put out the draft on its website (draft "Registration of Press and Periodicals Bill, 2019) indiscussions bit.ly/3AWRuZl). So, it is all the more surprising why the Ministry did not follow the same process while attempting to regulate OTT and digital news platforms. It could have got a fix on both.

Rules elsewhere

Since the best of rules and guidelines are often enriched by best practices around the world, here is a brief list of some of these. The EU Audiovisual Media Services Directive, updated three years ago, encourages self-regulation and coregulation among players, with specific focus on child safety and violence and hate speech. In the United Kingdom, programming on video-on-demand services, including TV and online film services, is regulated by Ofcom which not only provides editorial rules but also has specific provisions for protecting those under 18 and the prohibition of content inciting hatred. The United States, perhaps the most liberal of countries, expects Pay TV players to follow Federal Communications Commission (FCC) guidelines – OTT content remains unregulated. So, from a light touch to content governing children, most countries have set

up an enabling architecture for OTT platforms to grow. India, it appears, has not followed in their footsteps, instead, charting a regulatory framework which has been characterised by excessive government overreach.

Unease over free speech

More importantly, does the government of the day have the mandate to control and regulate digital news? And here the Government, many of whose Ministers had bur nished their reputation as champions of free speech during the Emergency, has floundered. Much like the Constitution makers who had decided to retain some of the most draconian provisions of laws controlling freedom of expression, the present government too appears to have followed the same path and has expressed its uneasiness over free speech on numerous occasions. The plate of newly minted Information and Broadcasting Minister Anurag Thakur is overflowing. For one, he can pose a question to himself: should the Government formulate a self-regulating code for digital media? Does

that even make sense? At the heart of content, both news and entertainment, is the freedom of expression - the lifegiving force behind content. Finally, discussions and transparency indicate trust in the people by an elected government. There is little evidence of that in the framing of the IT guidelines. Now, we even have the Government's draft on the proposed amendments to the Cinematograph Act of 1952, seeking to control the Central Board of Film Certification's power of

Growth matters but income levels matter more

India needs a sharp revival of demand for which higher per capita incomes are necessary

The provisional estimates of annual national income (2020-21), released on May 31 by the National Statistical Office, did not have any surprises, but for one, that is, there is nothing encouraging in the numbers.

The agriculture sector continued its impressive growth performance, reiterating that it still remains as the vital sector of the economy, especially at times of crisis. The manufacturing sector continued its subdued growth performance, failing to emerge as the growth driver, with production interruptions due to localised lockdowns to be blamed. The contraction in trade (-18.2%), construction (-8.6%), mining (-8.5%) and manufacturing (-7.2%) is a matter of concern as these sectors account for the bulk of low-skilled jobs. Gross Domestic Product (GDP) at Constant (2011-12) Prices in Q4 of 2020-21 is showing a growth of 1.6%, slightly better than expected, but for a period when the restrictions on mobility and economic activity witnessed reduction, this performance looks below par. Further, this growth, which is an improvement over the 0.5% rate of growth in the previous quarter, is a statistical artefact as it is not devoid of the base effect and seasonality which plagues quarterly estimates. The magnitude of contraction in the economy and the policy responses towards it raises an important issue, that is, the question of growth prospects for the next year.

Rising unemployment rate

Contextualising the current growth rates in terms of some other macroeconomic data would provide us a better perspective on growth recovery. First, the unemployment data released by the Centre for Monitoring Indian Economy (CMIE) which says, "In May 2021, India's labour participation rate at 40 per cent was the same as it was in April 2021. But, the unemployment rate shot up to 11.9 per cent from 8 per cent in April. A stable labour participation rate combined with a higher unemployment

the employment rate. The employment rate fell to 35.3 per cent in May 2021 from 36.8 per cent in April 2021. This is a very sharp fall for a single month... May 2021 was therefore a particularly stressful month on the jobs front". According to CMIE, over 15 million jobs were lost in May 2021, higher than the 12.3 million in November 2016, the month of demonetisation. May 2021 was also the fourth consecutive month of a fall in employment. The more worrying fact is that the cumulative fall in employment since January 2021 is 25.3 million of which 22.7 million were in the first quarter of FY 2021-2022, that is, during April and May. This shows that the second wave of the pandemic has already dented economic activities, postponing recovery further. The job losses also bring out the high informality and vulnerability of labour in India as of the total jobs lost during April-May, 17.2 million were of daily wage earners.

Elementary textbook economics tells us that employment and aggregate demand in an economy are related via the channel of disposable incomes of workers. We also know that aggregate demand and output growth have a positive correlation. Hence, the prospects of growth revival in the next year look bleak at the moment and from this perspective, it is worrying that in just April and May 2021, India lost 25 million non-farm

Low business confidence

This gets reflected in the business confidence of Indian companies, which is the second important data rate implies a loss of jobs and a fall in point that needs to examined. Busi-

ness confidence index (BCI), from the survey by the industry body FIC-CI, plummeted to 51.5 from 74.2 in the previous round. The survey also highlights the weak demand conditions in the economy. It says, "With household income being severely impacted and past savings being already drawn on during the first wave of infections, demand conditions can be expected to remain weak for longer." Compounding this is the uncertainty arising out of the imposition of localised curbs due to the second wave of infections and a muddled vaccine policy in the country.

Manufacturing Purchasing Managers' Index (PMI) also throws some light on the shape of things to come. PMI has slipped to a 10-month low indicating that the manufacturing sector is showing signs of strain with growth projections being revised lower. Both BCI and PMI slipping down indicates that the overall optimism towards 2021-22 is low, which could impact investments and cause further job losses.

Demand recovery

Growth recovery depends on demand recovery. External demand looks robust as India's exports touched \$32 billion in May 2021, 67% higher than in May 2020 and 8% more than in May 2019. The combined increase in exports of April and May 2021 is over 12% indicating that global demand rebound is much faster than the domestic demand. Stimulus programmes and a sharp decline in COVID-19 infections seem to be aiding these economies. What needs to be addressed immediately is the crisis of low domestic demand.

Since last year, the policy responses have been to rely on credit easing, focusing more on supply side measures, with more and more guarantees by the government to improve flow of credit to important sectors. There has been less direct action by the government to support the vulnerable to alleviate their hardships. There were some sector-specific measures to alleviate distress in certain sectors, which were timely. However, this policy stance is unlikely to prop up growth for three reasons. First, the bulk of the policy measures, including the most recent, are supply side measures and not on the demand side. In times of financial anxiety, what is needed is direct state spending for a quick demand boost. Second, large parts of all the stimulus packages announced till now would work only in the medium term. These include policies related to the external sector, infrastructure and manufacturing sector. In fact, some of the policies towards agriculture, such as productivity enhancement through the introduction of new varieties, will only work over years. Third, the use of credit backstops as the main plank of policy has limits compared to any direct measure on the demand side as this could result in poor growth performance if private investments do not pick up. Further, the credit easing approach would take a longer time to multiply incomes as lending involves a lender's discretion and borrower's obligation. Interestingly, a tight-fisted fiscal policy approach comes at a time when conventional fiscal stimulus packages might not be enough as supply side issues arising out of episodic lockdowns need to be ad-

dressed simultaneously. What is required now is a sharp revival in overall demand. Focusing on short-term magnified growth rates resting on low bases might be erroneous, as income levels matter more than growth rates at this juncture. Focusing on growth rates has its merits in the long term as achieving higher income levels require sustained growth for longer periods. Bangladesh seems to be doing this without much fanfare, but the quest for sustained higher growth has been elusive for India for the last five

Upholding trust in vaccination

Instead of regressing into 'target mode', involving the community and spreading positive messages could help



Not very long ago, family planning dominated health system allocations and priorities in India and resulted in much harassment for grassroots health workers and the rural folk. It turned into a target-chasing, at times compulsive, exercise. The corollary was the undermining of trust in the public health system, which would often lead to people avoiding contact with health facilities for routine health services.

Meeting targets

Such trust is indispensable for large public health programmes to function optimally, particularly in cases like COVID-19 vaccination. But the primeval tendencies of the Indian public health system often antagonise such trust. These tendencies entail that a public health problem is seen merely as a function of input deficiencies, which can be overcome by pouring in more resources, manpower, and policies. The rich processes involved in translating these inputs into outcomes, which are deeply entwined with local contexts, are largely dismissed. They also result in benevolent objectives turning into ruthless targets which are to be met at all costs and reduce subtle activities like community sensitisation into simplistic information-education-communication exercises.

There is every reason to expect these primeval tendencies to kick in and play foul in the COVID-19 vaccination drive. There are signs of vaccine hesitancy in India. Crucial junctures like a pandemic provide a window for communities to express distrust of otherwise long-established interventions like vaccines. For the government, failing to act with finesse in such situations could produce spillovers into the post-pandemic period and affect normal routine immunisation. More importantly, a desperate and overbearing approach to ensuring vaccination, coupled with deficient trust among communities, can lead to avoidance of public health facilities by many, which could be disastrous.

Further, there are certain factors that make us particularly vulnerable to the peril of vaccine hesitancy during the pandemic. While routine immunisation is well-entrenched, COVID-19 vaccines are prone to suspicion as they are new and abrupt entrants. The unprecedented scale and speed of their roll-out, and the media reporting of adverse events that are often spurious, add to the suspicion. One of the biggest neutralis-

ers of vaccine distrust are the visible improvements in disease prevention, and the equally visible damages when communities reject vaccines. These are unlikely to work substantially in the immediate term. The emergence of newer variants which predispose to vaccine failure and breakthrough infections can also endanger trust.

Such crises also provide opportunities for traditional and folk medical practitioners to reassert themselves by attempting to discredit modern medical principles. These practitioners constitute influential hubs within many communities that may make or break a public health programme. Further, certain factors could prompt our public health system to regress to an instinctive top-down approach driven by desperation, including an imminent third wave, an anticipated increase in vaccine supplies in the near term, and the pressure to vaccinate as many as possible in the shortest time. Vaccine hesitancy may not necessarily emanate from a distrust of science but from government motives which may be miscommunicated.

Acting prudently

Apart from community involvement, contextualised action, and transparency, eloquence and responsibility in public communication, the government should rein in an instinct of regressing into 'target mode' even at the highest moment of desperation. This is necessary, though not sufficient, to safeguard public trust and prevent community

There is a need of active thinking on avenues to incentivise vaccination beyond pecuniary subsidies, particularly for the rural sections. This would include removing disincentives that accompany reduced physical access, overenthusiastic drives on certain days that result in subsequent shortages, etc. Given that more than 38 crore vaccine doses have already been administered, there is a case for disseminating success stories through locally appropriate media, while not cutting back on honest, solemn and tactful reportage on adverse events.

Positive messages and reinforcements for vaccination have to be aired from the several quarters that command respect and trust of the community. In this regard, there is a strong case for engaging with members of traditional and folk systems despite any potential resistance from them. Lastly, there is a strong case for effectively utilising the services of social science professionals. They may have a pivotal role in navigating the many nuances involved in community mobilisation that are often invisible to medical professionals and other technocrats.

Disable unconstitutional sections

Several steps can be taken to ensure that people are not booked under laws held unconstitutional

Recently, while hearing an application filed by the People's Union for Civil Liberties (PUCL), the Supreme Court expressed shock that despite its declaration of Section 66A of the Information Technology (IT) Act, 2000 as being unconstitutional six years ago (Shreya Singhal vs. Union of India), criminal cases are still being registered by the police under this Section. The PUCL said that 1,307 cases had been registered since 2015 across States and therefore the Court must issue guidelines against the registering of FIRs by the police under this head.

In 2015, the Supreme Court had declared Section 66A of the IT Act, which made online posting of information considered as "grossly offensive" a crime punishable by jail, as being violative of Article 19(1)(a) of the Constitution and not saved under the ambit of reasonable restrictions defined in Article 19(2). It had also said that the expressions used in Section 66A were open-ended, undefined and therefore arbitrary.

In 1983, the Court had struck down Section 303 of the Indian Penal Code (IPC), which provided capital punishment for murder by a person serving a life term in another case, as being unconstitutional. In Mithu v. State of Punjab, it held that the punishment was not based on rational principle as no judicial discretion was available to a life convict. In 2018 (Navtej Singh Johar v. Union of India), the Court read down Section 377 of the IPC criminalising "unnatural sex" as being unconstitutional. Similarly, in Joseph Shine v. Union of India (2018), the Court held adultery as defined under Section 497 of the IPC as being manifestly arbitrary, discriminatory and violative of the dignity of a woman and therefore, unconstitutional.

Negligence by the police Undoubtedly, the registration of FIRs

by the police under these sections is illegal and violative of the Court's directions. Though such cases may not always be registered intentionally, negligence by Station House Officers (SHOs) must be nipped in the bud. The supervisory police officers at the sub-divisional level must ensure that such sections, if invoked due to lack of knowledge at the police station level, are removed at the earliest. The Superintendents of Police must fix responsibility on the erring officer and take corrective action. Everyone responsible for the negligence should not only be answerable to the courts for contempt but also be liable for departmental action. If the SHOs and others don't mend their ways despite reprimands, their annual confidential reports could be dented with adverse entries. Action can also be initiated under the new Section 166A of the IPC which provides punishment for up to two years for disobeying directions under the law.

Avoiding registration

The best way to avoid registration of offences under sections held unconstitutional is to educate police officers of all ranks about such provisions in basic training institutes. Second, as the Attorney General of India, K.K. Venugopal, had suggested, there could be a mention in brackets near the provision that the provision has been struck down, so that FIRs are not registered under those sections. Third, unconstitutional sections of the IPC can be disabled in the Crime and Criminal Tracking Network and Systems (CCTNS). Most States register FIRs in the CCTNS either on a realtime basis or in offline mode and synchronise this data with the State Data Centre as soon as connectivity is restored. In case police stations don't have connectivity, the data (i.e., FIR in electronic format) are taken to the nearest police station that has connectivity and uploaded. The CCTNS came in handy when the Supreme Court directed the States in 2016 to upload FIRs on official websites within 24 to 72 hours of registration. In Chhattisgarh, we have disabled these Sections in the system. Other States could follow suit.

The police must ensure that no FIR is registered under unconstitutional sections and no one is harassed for the negligent actions of SHOs.

While most States had an acceptable pupil-teacher ratio, the ratio was above the recommended value in some States, especially in higher education. 



FIFTY YEARS AGO JULY 14, 1971

Advice on Ganga-Cauvery link

The Union Irrigation and Power Minister, Dr. K.L. Rao, told the Lok Sabha to-day [New Delhi, July 13] that the Government had invited a team of United Nations experts to advise on the feasibility of undertaking the 2,000 mile long grand feeder canal from Patna to Tamil Nadu linking the Ganga and the Cauvery. Replying to Mr. N.K. Sanghi, the Minister said the Government's request had been registered with the U.N. and the expert team would commence its work in about three or four months' time. After the team's advice, the Government would make detailed investigations for determining the feasibility of the project. Preliminary studies, he said, indicated that monsoon water in the Ganga near Patna could be transferred to other areas in the country where there was great demand for additional irrigation, by a combination of pumped and gravity canals making use of natural water courses and existing or proposed reservoirs, whereever practicable.

A HUNDRED YEARS AGO JULY 14, 1921

The BMC officials have said while they have the capacity to administer 1,00,000 doses daily, the civic body is unable to fulfil even 50% of that quota due to paucity of vaccines.

Uttarakhand suspends Kanwar Yatra

The announcement came hours after Uttar Pradesh CM Yogi Adityanath reiterated that the traditional yatra would be held following CO-VID protocol, suggesting that a negative RT-PCR test report could be made mandatory for out-of-State participants.

A senior official in the Uttarakhand CM's office said the decision to suspend the yatra had been taken after consultations with the Central government, as well as with Chief Ministers of the surrounding States from where the pilgrims or Kanrakhand. "For all other States, the Kanwar Yatra is simply a movement of people who are passing through, and they are not congregating at a central point in their respective states. SII CEO Adar Poonawalla said, "We hope to make millions of doses in the coming months with trial batches starting in September. With high efficacy and a good safety profile, it is critical that the Sputnik vaccine is accessible in full measure for people across India and the

A team of the National Disaster Response Force rescued four people on Monday, and efforts are on to pull others out of the rubble, an official said on Tuesday.

Superintendent of Police Vimukt Ranjan said a woman died and nine were still feared trapped under the debris after their houses collapsed in the landslip triggered by heavy rain.

Official booked for issuing passports to Sri Lankans

He allegedly took bribes from agents

The Central Bureau of Investigation (CBI) has registered a case against an official of the Ministry of External Affairs on charges of issuing Indian passports to Sri Lankan nationals after allegedly taking bribes from travel agents. In one case, which the investigation agency has stated in the First Information Report, ₹45,000 was deposited into the official's bank account in three instalments by a travel agent.

The CBI's Anti-Corruption Branch received specific information that V. Veeraputhiran, Superintendent of Regional Passport Office, Madurai, had entered into a criminal conspiracy with travel agents for fraudulently issuing Indian passports to Sri Lankans and others who

were actually not eligible. The accused official, who knew that the applicants brought by the travel agents were not entitled to the is-

sue of Indian passports, took money and cleared the applications. In one instance while serving as Granting Officer, Passport Seva Kendra, Tirunelveli, in June-September 2019, he demanded ₹45,000 from one travel agent S. Ramesh which was deposited into his bank account in Madurai in three instalments.

PC Act invoked

After obtaining sanction from the Ministry of External Affairs to register a case and investigate against the official, the CBI's Anti-Corruption Branch, Madurai, booked Mr. Veeraputhiran, Mr. Ramesh and unknown others on charges of criminal conspiracy and invoked provisions under the Prevention of Corruption Act, 1988, against them. It is not clear how many such passports were fraudulently issued to foreign nationals and whether the beneficiaries are still living in Tamil Nadu or left the country.

HC orders removal of tweets

The Delhi High Court on Tuesday directed freelance journalist Saket Gokhale to immediately take down all his alleged defamatory tweets related to Union Minister Hardeep Puri's wife and former Indian diplomat Lakshmi Puri.

Mr. Gokhale had, in a series of tweets, questioned how Ms. Puri could have bought a house for 1.6 million Swiss Franc in Geneva in 2006 with her then income. Justice C. Hari Shankar restrained Mr. Gokhale from "posting any defamatory or scandalous or factually incorrect" tweets. If he refused to do so within 24 hours, Twitter must take them down.

'Mehul Choksi will return to Dominica when fit'



India to display relics of St. Ketevan

A part of them was gifted to Georgia on July 10; another part remains in Goa

Almost 400 years after she was murdered in present day Iran, relics of St. Queen Ketevan that were found in Goa in 2005 are likely to be put on display in India as well as her native Georgia, according to Archaeological Survey of India (ASI) offi-

On July 10, External Affairs Minister S. Jaishankar handed over one part of the relics to Georgia as a gift from India. According to senior ASI officials with knowledge of the matter, parts of the bone of the right arm were found at St. Augustine Church in Old Goa in 2005.

Queen Ketevan was killed in 1624 in Shiraz for not converting to Islam and parts of her remains were brought to Goa by Augustinian monks.

Revered as a martyr, her relics remained lost till 2005 as the St. Augustine Church collapsed in 1842, another official said. A DNA analysis by the CSIR-Centre for Cellular and Molecular Biology, Hyderabad, confirmed their authenticity in 2013.

The official said the larger

part of the relic remained with the ASI in Goa and would be publicly displayed for the first time. The smaller part had been handed over to Georgia, where it was likely to be displayed publicly with the citation that it was a "gift from people of India to people of Georgia". The larger part of the relic had been sent to Georgia for an exhibition for six months in 2017.

Shared past

When reached for his comment, Father Loiola Pereira, secretary to the Archbishop of Goa, said: "The relics of the martyred Queen Ketevan were found by the ASI in 2005 in the ruins of the Church of St. Augustine and have ever since been in the possession of the government. We are happy that at least 'part of the relics' were handed over by our government to the people of Georgia. St. Queen Ketevan belonged to Georgia and Georgia is where her relics should be."

In Georgia, Mr. Jaishankar said: "One part of the holy relic still remains in India as a reminder of our shared

Crackdown on Bangladeshi immigrants in T.N.

peddling, immoral traffick-

Hundreds settled across the State posing a 'serious threat' to internal security, say officials

The presence of a large number of Bangladeshi immigrants in different parts of Tamil Nadu has emerged as a "serious threat" to internal security, forcing the State police to launch an intensive crackdown to weed them

According to police sources, thousands of Bangladeshi nationals illegally entered India through the land borders in recent years and many families moved to Tamil Nadu posing as natives of West Bengal. With the help of some agents, they not only got employment in industries but also managed to get

Aadhaar cards.

Preliminary enquiries revealed that a large number of immigrants were settled in Tiruppur, Chengalpattu, Erode, Cuddalore and Kancheepuram districts posing as Indians who migrated from West Bengal for the purpose of employment. Even as the industry shut and a majority of the workforce returned to their respective home States during the COVID-19 lockdown, the Bangladeshi immigrants stayed on.

Drug peddling "It is during this period that

many of them indulged in illegal activities such as drug

ing etc. Though they do not have any valid documents, the immigrants have Aadhaar cards. It is not clear whether they furnished fake documents or availed the norm that even foreign nationals who continuously reside in India for over 182 days are entitled to get an Aadhaar card," a senior police official told *The Hindu*. Using the Aadhaar card,

the Bangladeshi immigrants got other documents which certify proof of identity or address which is required for opening a bank account, getting rental accommodation and applying for jobs. "Even if they are intercepted dur-

ing vehicle checks or surprise raids at vulnerable lothey produce original documents relating to proof of identity or address and hence leaving no scope for any suspicion," the official who preferred not to be quoted said.

The case was similar to Sri Lankan Tamil refugees who sailed to Tamil Nadu shores in boats years ago and settled in different districts. Their familiarity with the local language, culture and traditions made it easy for them to survive in the guise of local Tamils, the official said.

Foreigners' Act

five Bangladeshi immigrants were arrested in Reddychavadi police station limits in Cuddalore district under the provisions of the Immoral Trafficking (Prevention) Act, the Foreigners' Act and other Sections of the IPC. In June last week, three Bangladeshis were arrested in Tiruppur district and booked under the Foreigners' Act.

Similar arrests were made in the western districts where the foreigners were alleged to have indulged in drug peddling. Some of them were also accused of acting as agents who brought in more Bangladeshi immigrants and got them jobs in the hosiery industry.

'Centre is responsible for price rise'

Hitting out at the Narendra Modi government over price rise, former Finance Minister P. Chidambaram said on Tuesday that the "wrong policies of the Modi government and its inept management of the economy" are to blame for inflation.

Addressing a press conference at the All India Congress Committee headquarters, Mr. Chidambaram demanded that the price of petrol, diesel and LPG be brought down immediately, import duties reviewed and GST rates reduced on goods of mass consumption. "We hold the Central government under the leadership of Prime Minister Narendra Modi directly responsible for the high inflation," he said. "Let me caution the government: the issue of high inflation will not go away if you pretend it does not exist."

Kishor meets Rahul, Priyanka

Move comes ahead of Uttar Pradesh poll; Punjab not discussed, says Rawat

Election strategist Prashant Kishor on Tuesday called on former Congress president Rahul Gandhi amid speculation that he was involved in finalising a truce deal between Punjab Chief Minister Amarinder Singh and his arch rival, Navjot Singh Sidhu.

Though there was no confirmation from the Congress, reports suggested that Congress president Sonia Gandhi, too, met the poll strategist and the discussions were regarding the 2024 Lok Sabha election.

Sidhu's tweet

Mr. Gandhi's meeting with Mr. Kishor, who is an adviser to the Punjab Chief Minister, came on a day when Mr. Sidhu had left everyone guessing about his next move by saying on Twitter that Aam Admi Party (AAP) in Punjab understands his "vision and Puniab model".

"It is clear they know -

who is really fighting for Punjab," Mr. Sidhu had tweeted.

But the presence of the Congress general secretary for Uttar Pradesh, Priyanka Gandhi Vadra, also conveyed a sense that the meeting could be about other poll bound States like Uttar Pradesh and Uttarakhand that will vote along with Punjab early next year.

On June 16, Ms. Vadra will be making a trip to Lucknow and spend three days for an on-the-ground assessment of

the Congress's organisation ahead of the 2022 Assembly election in Uttar Pradesh.

The presence of former Uttarakhand Chief Minister Harish Rawat, who also is the Congress in-charge for Punjab, at Mr. Gandhi's house, along with general secretary (organisation) K.C. Venugopal, added to speculation that the party could be using Mr. Kishor's services in these poll-bound States.

Mr. Kishor has worked with the Congress previously in all these three States. "In the next three-four days, there will be good news for Punjab Congress," Mr. Rawat later told mediapersons outside Mr. Gandhi's house, adding, however, that Mr. Kishor had not discussed Punjab politics nor had Mr. Rawat joined the Gandhi-Kishor meeting

"Rahulji is a national leader. So many people meet him to discuss important issues.' added Mr. Rawat

Mr. Kishor's meeting with the Gandhi siblings also comes just weeks after he met Nationalist Congress Party chief Sharad Pawar twice regarding the formation of an opposition block to take on the Narendra Modi government.

When reports emerged that regional Opposition parties could be attempting to isolate the Congress before the 2024 election, Mr. Kishor commented that no Opposition front without the Congress could be effective against the Narendra Modiled BJP government.

'Anti-terror law must not be misused to harass people'

We must be mindful of systemic issues, says SC judge

Anti-terror law should not be misused to quell dissent or harass citizens, Supreme Court judge Justice D.Y. Chandrachud said in an address on Indo-U.S. legal ties.

"Criminal law, including anti-terror legislation, should not be misused for quelling dissent or harassment to citizens," he stated on Monday in a speech on the 'Role of the Supreme Court in protecting the fundamental rights in challenging times'.

The judiciary must remain the first line of defence against any move to deprive citizens of their liberty. "Our courts must ensure that they continue to remain the first line of defence against the deprivation of liberty of citizens. Deprivation of liberty for even a single day is one too many. We must always be mindful of the deeper sys-

temic issues of our decisions," he observed.

Justice Chandrachud said that some may dub the role of the court as "judicial activism" or "judicial overreach". "The Supreme Court is a counter-majoritarian institution sworn to protect the rights of socio-economic minorities," he highlighted.

"The actions of the government had far-reaching effects on the constitutional rights of people, which involved right to affordable healthcare, including vaccination; rights of labourers, including migrant labourers and factory workers; right to livelihood; and rights of prisoners. Many such cases of constitutional violations found their way to the Supreme Court," he pointed

As the "guardian of the Constitution", the Supreme Court had to put a break where executive or legislative actions infringed fundamental human rights, he asserted. He detailed the court's suo motu actions to ensure vaccination, improve COVID-19 management and decongestion of prisons to prevent the spread of the

Crackdown on GST evaders continues

In 2020-21, as many as 8,000 cases involving fake ITC detected, 426 held: Ministry

The Centre continues to tighten the noose around GST evaders, though its crackdown on fake invoices slowed down in recent months due to the COVID-19 resurgence, the Finance Ministry said on Tuesday.

Citing the misuse of Input Tax Credit (ITC) provisions as the most common modus of tax evasion under the Goods and Services Tax regime, the Directorate General of GST Intelligence (DGGI) and Central GST (CGST) formations also detected other tax fraud means such as evasion involving "misclassification, undervaluation and clandestine supplies goods and services".

About 8,000 cases involving fake Input Tax Credit of over ₹35,000 crore were detected during 2020-21, leading to the arrest of 426 per-

In 2021-22 so far, the DGGI and CGST Zones under the Central Board of Indirect Taxes and Customs (CBIC) have detected more than 500 cases involving 1,200 entities. Twenty-four persons have been arrested since April this year, with the Ministry stating that the arrests made by the CBIC officers are "one of the highest in recent times".

"CBIC officers are using the latest IT tools, digital evidence and also collecting information from other government departments to catch the fraudsters. Along with legislative and procedural changes in the law, the nationwide drive has contributed to better compliance and revenue collection. During the drive, cases of fake ITC availment against some well-known companies were also booked," said a statement.

"The enforcement drive against the fake invoice fraudsters and other GST evaders is likely to intensify with an objective to catch and book unscrupulous elements engaged in illegal activities to defraud the government exchequer," the Ministry said.

Mufti said, "Today on the occasion of 'Martyrs Day', the gates leading to their graveyards have locked up. Attempts to distort and rewrite Kashmir's history is being done only to create a sense of defeat and helplessness amongst Kashmiris..." Sajad Lone's Peoples Conference and J&K Apni Party also paid tributes to the anti-Dogra protesters.

Assam Bill bans sale of beef around temples

CM says it aims to check smuggling

Prior to tabling the Assam Cattle Preservation Bill, 2021, in the 126-member Assembly on July 12, Chief Minister Himanta Biswa Sarma said its primary objective was to check the smuggling of cows to Bangladesh.

It also seeks to restrict the sale of beef in areas dominated by non-beef consuming communities and within a 5-km radius of temples and 'satras' (Vaishnav monasteries) formed by the Srimanta saint-reformer Sankaradeva.

The Bill seeks to replace the Assam Cattle Preservation Act, 1950, which allows the slaughter of cattle above 14 years of age or those that have become permanently incapacitated due to work, breeding, accident or deformity after local veterinary officers certify that they are fit for slaughter. The Bill retains this provision while intending to regulate the slaughter, consumption and illegal transportation of cattle across Assam. It says the certified cattle can be slaughtered only in licensed and recognised slaughterhouses. "The State government may exempt certain places of worship, or certain occasions from the slaughter of cattle other than cow, heifer or calf, for religious

purposes," it says. The Bill says no one will be allowed to sell beef in any form except at places permitted by the government. Beef will not be allowed to be sold in areas predominantly inhabited by Hindus, Sikhs, Jains and other non-

Raw materials for test kits get duty waiver

SPECIAL CORRESPONDENT

The government has granted basic customs duty exemption on import of raw materials used to make CO-VID-19 test kits till September 30, and on import of certain active pharmaceutical ingredients used to manufacture Amphotericin-B, used to treat mucormycosis, till August 31.

Imports of high-purity cholesterol and egg lecithin, critical ingredients used in the pharmaceutical sector, have also been exempted from basic customs duty till August 31, as per a notification issued by the Customs Department on Monday.

"This is a well-considered exemption being granted by the government to fight the COVID-19 crisis and is a step to make the domestic industry self-reliant in fighting the pandemic," said Abhishek Jain, tax partner at EY India.

Modi alerts northeast States

Step up vaccination, do aggressive testing to rein in COVID-19, he tells eight CMs

SPECIAL CORRESPONDENT

Prime Minister Narendra Modi on Tuesday urged the Chief Ministers of eight northeastern States to ramp up vaccination rates, set up temporary hospitals and form micro containment zones with aggressive cluster testing and tracking to control the COVID-19 situation.

Mr. Modi addressed the Chief Ministers of Assam, Arunachal Pradesh, Sikkim, Tripura, Meghalaya, Nagaland, Mizoram and Manipur via videoconferencing, as according to the Union Health Ministry, 80% of cases were from 90 districts, of which 14 were in the northeast. It was also the first such interaction where new Health Minister Mansukhbhai Mandaviya was present.

Crowds at hill stations

Mr. Modi expressed concern over the teeming crowds of holiday-makers at hill stations, saying that while trade

and tourism were important, "the main question in everyone's mind should be on how to prevent a third wave of the COVID-19 pandemic".

The Union government's ₹23,000 crore package for COVID-19 infrastructure was for ramping up testing laboratories, setting up oxygen units in hospitals and paediatric intensive care units, he pointed out.

"Looking at the specific challenges thrown up by the terrain in the northeastern States, I would urge that temporary hospitals be set up with oxygen facilities and very importantly, training of manpower be done to handle oxygen related care and

ICU duties," he said.

Arunachal Pradesh Chief Minister Pema Khandu said his State was ensuring zero wastage of vaccine but raised the point about poor Internet connectivity. "Our data is being uploaded after four days, resulting in wrong conclusions by the ICMR (Indian Council of Medical Research), whose portal says Arunachal's positivity rate today is 16.2%. But our data show the average of last one week is 8%," he said.

The State had about 1,000

oxygen beds ready and the occupancy rate was only 8% as of now, he said.

Meghalaya situation

Meghalaya Chief Minister Conrad K. Sangma said the positivity rate in his State had not declined at the expected rate because of the scattered population, and two districts with a positivity rate of more than 10% were the biggest worries.

He admitted that the vaccination drive had been slow because of initial reluctance but the pace had picked up over the last couple of days because of the involvement of MLAs, MDCs (members of district council) and civil society groups. Assam Chief Minister Hi-

manta Biswa Sarma said his State had ensured medical oxygen production, ICU beds, oxygen beds and isolation wards. He requested the Prime Minister to increase the allotment of vaccines to the State.

Be vigilant to prevent a third wave: NITI Aayog member

'Irresponsible behaviour will cause COVID-19 surge again

A third wave of COVID-19 is being witnessed across the world and it is time to be very vigilant, NITI Aavog member (Health) V.K. Paul said on Tuesday.

"India needs to be responsible and not allow the COVID numbers to rise. The world is witnessing the third wave of COVID cases and we have to join hands to ensure that the third wave doesn't hit India. Prime Minister Na rendra Modi on Tuesday clearly said that we should focus on keeping the third wave at bay instead of discussing when it could come in India," Dr. Paul said at the Health Ministry press conference. He cautioned that irresponsible behaviour could cause the COVID-19 numbers to rise again in India.

Arunachal officials trek nine hours to vaccinate 16 grazers

Deputy Commissioner leads team to village at 14,000 ft

Away from home grazing their yaks, 16 residents of Luguthang village in Arunachal Pradesh's Tawang district could not make it to a COVID-19 vaccination camp organised on May 19 at Domstang, about a five-hour trek

However, the vaccines reached the homes of the grazers at 14,000 ft above mean sea level on July 12, brought in by a team that trekked for more than nine hours from the nearest motorable road at a place called Thingbu Hydel.

One of the farthest villages in Tawang district, Luguthang is close to the border with Tibet and is aerially 30 km from Tawang. All 10 families, comprising 65 people, in the village are yak

The district authorities organised a vaccination camp on May 19 at Domtsang, a village midway between Luguthang and Thingbu Hydel. The camp catered to Luguthang and other villages in the area. Officials said 33 residents of Luguthang in the eligible age groups got vaccinated on May 19.

Message relayed

"This is the time when grazers move out with their livestock to far-flung areas. We special messages through trekkers for 16 such grazers, who were left out of the camp, to return home within a specific time for

He and six others, including zilla parishad chairman Leki Gombu and health officials, started the trek from Thingbu Hydel at 7.15 a.m. on July 11. They reached Luguthang by 4.30 p.m. that evening after crossing two of the toughest peaks in the district - Nyukteng and Nahchhot.

The team held a short the next morning after a night's stay, before the 16 grazers were inoculated by district reproductive and child health officer Rinchin Neema. Senior veterinary officer Thutan Tashi gave free medicines for diarrhoea, deworming and other ailments

for the livestock. "Apart from COVID-19 vaccination, 19 patients were treated for different ailments," Mr. Phuntsok said after the team returned to Thingbu Hydel on July 13.

'The trip was worth it as all the eligible villagers have received their first dose of the vaccine," he added.

vaccines to complete the inoculation of its adult population, said its Prime Minister Lotay Tshering on Tuesday. He announced that the country would have more than a million doses by the yearend, including, in a first, donations from the United States and China, two nations Bhutan does not have diplomatic relations with.

As The Hindu had reported, the Himalayan nation, with a population of about 5,50,000 eligible for vaccination, is receiving its second dose of AstraZeneca vaccines from the European Union, after India failed to fulfil its promises due to the second wave of the pandemic.

"With more countries coming forward with similar commitments, Bhutan has

cine sufficiency for now...However, the request for the need for future booster doses has been conveyed," Mr. Tshering said in a statement released by the Royal Government of Bhutan's PMO.

The statement thanked Bhutan's partners, including multilateral agencies such as the U.N. and specifically the U.S., the European Union, India and China, for "demonstrating unconditional support and playing an important part in the lives of all Bhutanese."

17 nations contacted

Worried about the non-availability of vaccines for the second dose due in mid-July, Bhutan's Health Minister had told The Hindu that the government had reached out to 17 countries to complete its full vaccination schedule.

According to the PMO, Bhutan has now received, or is receiving, 5,00,000 doses of Moderna vaccines from the U.S., 3,50,000 doses of AstraZeneca from European countries, including Denmark, Croatia and Bulgaria, 50,000 doses of Sinopharm from the Chinese government and 5,850 through the international COVAX alliance facility. In addition, Bhutan has placed commercial orders for 2,00,000 doses of Pfizer, which will arrive in a few months.

Vaccine Maitri initiative

India had provided Bhutan with 5,50,000 doses of Covishield (AstraZeneca) under its Vaccine Maitri programme for its first round of vaccinations in March 2021, of which about 62,000 are still being administered, as Bhutan has crossed a record first-dose vaccinations.

"For the second dose, His Majesty [King Jigme Khesar Namgyal Wangchuk] had advised the government that sourcing vaccines from India once more would be inconsiderate given the shortage of vaccines and surge of cases in the country at the

New Delhi has suspended the Vaccine Maitri initiative since April, and the Ministry of External Affairs has repeatedly said that domestic production of vaccines would be used for "domestic vaccinations" for the present, with about 4 million being administered daily.

In his statement, Mr. Tshering disclosed that India had conveyed that it would "step in despite all the challenges" if Bhutan failed to get vaccines from elsewhere.

While Bhutan has close development partnerships with India and the EU, the government's decision to accept 2,50,000 doses of Moderna from Washington and 50,000 doses of Sinopharm from China is seen as a departure from the past, given + that Bhutan prefers not to maintain direct diplomatic relations with permanent members of the UNSC or P-5 countries.

India's first COVID patient tests positive for virus again

Third year medical student from Wuhan not vaccinated

A medical student at Wuhan University, China, who was the first Indian COVID-19 patient in the country, has tested positive for the virus again.

District Medical Officer K.J. Reena confirmed here on Tuedsay that the student, hailing from Mathilakam,

near Kodungalloor, tested

positive on Monday. The student did the screening test for travelling to Delhi for academic purposes. "Her RT-PCR test is positive. As the student is asymptomatic, she is under observation at home," the DMO said. She has not taken COVID-19 vaccine.

The third year medical

student in Wuhan university tested positive on January 30, 2020, becoming the first COVID-19 case in the country, when she returned for holidays. She was discharged from hospital on February 20, 2020, after she tested negative. The student was continuing her studies online at Wuhan University when she tested positive again.

Itihasas and Puranas are to be studied to understand the Vedas. Of the two Itihasas, Ramayana is more important, because it is entirely about the avatara of the Lord, said Akkarakkani Srinidhi in a discourse. The Mahabharata is referred to as equal to the Vedas – Bharatam panchamo Vedah. Then how does the Ramayana become superior to Mahabharata?

In the Rama avatara, the Lord hid His supremacy. But despite this, Mandodari identified Him as the Supreme One, and said Rama was none other than the four-handed Vishnu. So the Ramayana tells us about the Supreme One whom the Vedas talk about. The Supreme One took an avatara, which was written about in the first Itihasa, namely the Ramayana. The Vedas, which show us the Supreme One, took an avatara as the Mahabharata, the second of the two Itihasas. Later Acharyas like Nampillai, for instance, gave many references from the Ramayana, in their discourses. Among the Azhvars, Kulasekhara Azhvar was very fond of the Rama avatara. Whenever Kulasekhara Azhvar heard Rama's story, he would rush to fetch his army to help Rama, as if the event

was happening then! Kulasekhara Azhvar is known as Kulasekara Perumal. In Sri Vaishnava tradition the word 'Perumal' is used to refer to Rama. No wonder Kulasekhara Azhvar is known as Kulasekhara Perumal, given his adoration of Rama. The verses sung by him are given the title 'Perumal Thirumozhi.' His verses in praise of the deity of Thirukannapuram are in the form of a lullaby for Rama. There are verses which capture Dasaratha's anguish upon exiling Rama. So full of emotion are these verses that it seems as if Kulasekhara Azhvar has placed himself in the position of Dasaratha, and is crying out for Rama, as a father would weep for his beloved son.

NEW DELHI

Sher Bahadur Deuba, leader of the Nepali Congress, is the new Prime Minister of Nepal.

The 75-year old centrist politician was sworn to office by President Bidhya Devi Bhandari on Tuesday evening, a day after the Supreme Court of Nepal, in a dramatic verdict, said former Prime Minister K.P. Sharma Oli had violated constitutional principles.

The coalition government in Kathmandu will consist of Mr. Deuba's Nepali Congress, the Maoist Centre of Pushpa Kamal Dahal 'Prachanda' and the Janata Samajbadi Party, which is a conglomeration of former Maoists and the Madhesi leaders. Mr. Deuba was sworn in with a small Cabinet. Gyanendra

Karki was sworn in as the Minister of Law, Justice and Parliamentary Affairs and Bal Krishna Khand took oath as the Minister of Home Affairs. The Maoist Centre got two portfolios – Janardan Sharma got the Finance Ministry and Pampha Bhusal

will be in charge of Energy, Water Resources and Irrigation, an important Ministry of the Himalayan country.

The oath of office was administered by Ms. Bhandari, who was also subjected to criticism of the Supreme Court for her role in denying Mr. Deuba a chance to prove majority in Parliament in

This is the fifth time that Mr. Deuba is returning to power as the Prime Minister of Nepal. Bhesh Raj Adhikary, personal secretary of Ms. Bhandari, told reporters that "in line with the apex court's verdict, President Bhandari named Deuba as the Prime Minister".

Previously, Mr. Deuba served as Nepal's Prime Minister four times from June 2017-February 2018, June 2004-February 2005, July 2001-October 2002 and September 1995-March 1997.

Lasting impact

Earlier, Mr. Oli delivered a speech before stepping down, and said the verdict of the Supreme Court would have a lasting impact on Nepal. "The language used in the verdict has alarmed those who believe in multiparty democracy," said Mr. Oli, who was elected Prime Minister on October 11, 2015, following the adoption of the new Constitution. His second tenure began in 2018.

Throughout his tenure, Mr. Oli defended the Constitution against criticism from the Madhesis – people from Nepal's plains who said the document was partial to the established elite of Kathman-

"The Constitution is the document borne out of decades of struggle and sacrifice by the people of Nepal. We strengthened the political system of Nepal," Mr. Oli said in his farewell speech.

Supreme Court offers a way out of Kathmandu political impasse

Verdict is another rebuke of Oli's attempts at one-upmanship

The decision by a five-member Constitutional Bench of the Supreme Court of Nepal to vet again overturn Prime Minister Khadga Prasad Oli's dissolution of the House of Representatives was expected. Mr. Oli's decision, ratified by President Bidhya Devi Bhandari who repeated the action taken in December 2020, came about in controversial circumstances in late May.

After both Mr. Oli and the Nepali Congress's Sher Bahadur Deuba were unable to establish majority support in Parliament in trust votes, they presented claims to the President with signatures affirming support. Mr. Deuba's presented to Ms. Bhandari with signatures of 149 legislators was more valid than Mr. Oli's, whose claim of support from 153 lawmakers were based on signatures of the leaders of the parties rather than from each individual.

The discrepancy in Mr. Oli's claims was due to the fact that both the ruling Communist Party of Nepal (Unified Marxist-Leninist) (UML) and the Janata Samajbadi Party (JSP) in the Opposition were vertically split with rebel factions supporting Mr. Deuba's candidacy, even though the parliamentary leaders of the parties gave their signatures affirming support for Mr. Oli.

Right before the President's decision, Mr. Oli had asked her to invoke Article 76 (5), which allows the President to appoint a member with majority support of the House through representation. However, the clause clearly specifies that this is possible only if the Prime Minister goes through a trust

vote [Article 76 (3)], and Mr. Oli's ploy to seek the President's invocation of Article 76(5) raised the Opposition's hackles. Ms. Bhandari rejected both claims and decided to dissolve the House and called for general elections to be held in November.

New PM

The Supreme Court has now not only overruled Mr. Oli's decision to dissolve the House, but also said the rejection of Mr. Deuba's claim

with the support of 149 legislators of the 275-member House was unconstitutional as per Article 76(5). This led to Ms. Bhandari's appointment of Mr. Deuba as the new Prime Minister.

The 149 lawmakers supporting Mr. Deuba's candidacy included those from Pushpa Kamal Dahal-led Communist Party of Nepal (Maoist-Centre), the Baburam Bhattarai-Upendra Yadav-led faction of the JSP and the Madhav Nepal-Jhalanath Khanal-led faction in the ruling UML.

What's next

The court's ruling also offered a way out of the political impasse - the Bench has allowed lawmakers to utilise

their individual agency during the trust vote by making it clear that they are free to defy their parties' whips. But in a party system that thrives heavily on patronage, whether individual lawmakers will apply such an agency during the trust vote remains to be seen.

It is still not clear if Mr. Madhav Nepal's faction within the UML will decide to vote formally for Mr. Deuba in the trust vote. Already Mr. Oli has sought to avoid a split within his party by coming up with concessions to the Nepal-Khanal faction, and this could still throw a spanner in the works for Mr. Deuba. If Mr. Deuba fails again, the extended stalemate could only result in calling for fresh elections later this year.

President's role

Nevertheless, the Supreme Court's decision is yet another rebuke of Mr Oli's attempts at one-upmanship that set the stage for a constitutional breakdown.

The ruling also brings scrutiny on the role of Ms. Bhandari whose decisions to rubber-stamp her former party colleague, Mr. Oli, have now been overturned twice by the court.

The President's office had in fact argued in a petition to the court last month that her actions cannot be subject to a judicial review, but the verdict categorically rejected this view by saying, "The action taken by the President falls under the executive function. In such a situation, if the President's moves are kept out of the judicial review it will be an attack on the principle of the separation of power, control and balance", as reported in *The* Kathmandu Post.

Don't want to fight inside cities, say Taliban

They urge residents to reach out to them; warn Turkey against extending troop presence in Afghanistan

The Taliban do not want to battle government forces inside Afghanistan's cities and would rather see them surrender, a senior insurgent leader said on Tuesday, as the militants also warned Turkey against extending its troop presence.

Islamist The hardline group has swept through much of the north as foreign troops complete their withdrawal, and the Afghan government now holds little more than a constellation of provincial capitals that must largely be resupplied by air.

As security deteriorates, France on Tuesday became the latest country to call on its citizens to leave - offering them a last flight out of Kabul, free of charge.

Earlier, the head of a Taliban commission that oversees government forces who surrender urged residents of Afghanistan's cities to reach out to them.

"Now that the fighting from mountains and deserts has reached the doors of the cities, Mujahiddin (Taliban) don't want fighting inside the city," Amir Khan Muttagi said in a message tweeted by a Taliban spokesman. "It is better... to use any possible channel to get in touch with our invitation and guidance commission," he said, adding this would "prevent their cities from getting dam-

The strategy is one wellworn by the Taliban - particularly during their first rise to power in the 1990s - cutting off towns and district

centres and getting elders to negotiate a surrender. Hours after Muttaqi's message, a rush hour roadside bomb blast in the centre of the Afghan capital killed four civilians and wounded 11 others.

Muttaqi's comments came as the Defence Ministry said Afghan forces had cleared Qala-i-Naw city after days of fighting.

Commandos executed

The Badghis province capital saw sustained street fighting last week in the first assault by the Taliban on a major urban centre since foreign troops commenced their fi-

ter Ankara agreed with Washington to provide security for Kabul airport.

As foreign forces wind up their withdrawal - due to be completed by August 31- the situation on the ground is changing rapidly.

+ Death toll in S. Africa riots rises to 45

The death toll from rioting in South Africa rose to 45 on Tuesday as the police and the military tried to halt the unrest in poor areas of two provinces that began last week after the imprisonment of former President Jacob Zuma.

Many of the deaths in Gauteng and KwaZulu-Natal provinces occurred in stampedes as people stole food, electric appliances, liquor and clothing from stores, officials said.

Sporadic violence broke out after Mr. Zuma on Thursday began serving a 15-month sentence for contempt of court. He had refused to comply with a court order to testify at a state-backed inquiry investigating allegations of corruption while he was President from 2009 to 2018.

The unrest then spiralled into a spree of looting in township areas of the two provinces, witnesses said, although it has not spread to South Africa's other seven provinces. "Criminal element has hijacked the situation," said Premier David Makhura of Gauteng province, which includes Johannesburg.

in less than three months. Health officials said scores of others were injured in the blaze that erupted on Monday at al-Hussein Teaching Hospital in Nasiriyah. The tragedy cast a spotlight on what many have decried as widespread negligence and mismanagement in Iraq's hospitals after decades of war and sanctions.

In the holy city of Najaf, the dead from Nasiriyah were laid to rest. Families stood over the coffins to say one last prayer. Their tears were tinged with anger, with some saying the disaster could have been prevented. They blamed both the provincial government and the central government in Baghdad. "The whole state system has collapsed, and who paid the price? These people have paid the price," Haidar al-Askari seethed.

'High fuel prices threaten recovery'

SBI's economists flag rising household stress, urge cuts in oil taxes to ease burden on consumers

India's economic recovery could be delayed by rising financial stress on households, with inflation adding to their woes, State Bank of India's economics research team observed on Tuesday, urging that fuel taxes be cut to both cool inflationary pressures and ease the burden on consumers.

"In June... spend on health expenditure has substantially reduced but expenditure on oil has more than crowded out the spending on other non-discretionary items, like grocery and utility services that was the trend in earlier months which is worrisome," SBI group chief economic advisor Soumya Kanti Ghosh pointed out. "In fact, the share of non-discretionary spend has jumped to 75% in

June, from 62% in March," Mr. Ghosh said, citing an analysis of monthly credit card spending data.

"This demands urgent cut in oil prices through tax rationalisation, otherwise consumers' non-discretionary spending will continue to get

distorted and crowd out discretionary expenses. This will also impart an upward bias in inflation," emphasised.

Observing that rising transport costs would eventually push up food inflation even further, the researchers said

higher petrol and diesel prices and regional truck driver shortages were driving up road transport costs.

With every 10% increase in petrol pump prices in Mumbai estimated to lead to a 0.50% increase in the Consumer Price Index (CPI), the SBI economists said consumption trends in June indicated consumers were cutting back spending on other goods to be able to fork out the higher fuel costs.

Household distress rising The second COVID-19 wave, that began in March, coincided with a significant dip in bank deposits, the researchers observed, with the number of districts seeing outflows of deposits almost doubling from the first-wave period. Bank deposits in the first quarter had declined by

38% by June 18, compared

with a growth recorded in April to June period in 2020. Household debt had also

shot up, so the recovery would be delayed as there was an indication of debt financed consumption, Mr. Ghosh said. Household debt as a percentage of GDP had increased sharply to 37.3% or ₹73.6 lakh crore in 2020-21, from 32.5% of GDP or ₹66.1 lakh crore in 2019-20.

Asserting that the decline in financial savings reflected the household distress in India, SBI's economists noted, "the household financial savings rate in the third quarter of 2020-21 has come down to 8.2% of GDP from 21% and 10.4% in the previous two quarters".

"This indicates how delayed the recovery will be in India... as we are predominantly a domestic consump-

S&P keeps India rating at lowest investment grade

'Reform execution crucial for recovery'

S&P Global Ratings on Tuesday kept India's sovereign rating unchanged at the lowest investment grade of 'BBB-' for the 14th year in a row, and said the government's ability to execute additional economic reforms that spur investment and create jobs will be crucial for recovery from the current economic slowdown.

S&P projected a 9.5% GDP growth in the current fiscal year that began in April and a 7.8% expansion in the following year.

Stable outlook

Forecasting economic recovery to gain pace through the second half of 2021-22 fiscal, S&P kept the rating outlook at stable.

"The government's abili-

ty to deliver and execute additional economic reforms, especially those that spur investment and job creation, will be important for India's ability to recover from the economic slowdown.

"We expect economic activity in India to begin to normalise throughout the remainder of fiscal 2022, resulting in real GDP growth of about 9.5%," said S&P Global.

"The stable outlook reflects our expectation that India's economy will recover following the resolution of the COVID-19 pandemic, and that the country's strong external settings will act as a buffer against financial strains despite elevated government funding needs over the next 24 months." Funding gap may stump 'Housing for All' goal

₹1.24 lakh cr. needed in 1.5 years: ICRA

The government's promise to provide 'Housing for All' by 2022 faces a severe funding crunch even as implementation is running behind schedule. The Centre had promised

to build 50 million houses by 2022 under the PM Awas Yojana (PMAY) unveiled in 2015, but even a subsequently scaled down target of 32.6 million may be difficult to meet by next year, as there is a 'large' ₹1.24 lakh crore funding gap to be bridged in the next eighteen ratings agency months, ICRA said.

"With 1.5 years to go, against the revised targets, 19.55 million houses have



been sanctioned and 14.16 million have been completed through PMAY-Rural till April 2021, implying completion of 67% of the revised target and 72% of the sanctioned houses," said Kapil Banga, assistant vice-president and sector head, ICRA, adding that only 43% of the 11.2 million urban housing units had been built so far.

India's trade with China soared 62% in H1

Bilateral trade in first six months hits \$57.48 bn, surpasses pre-pandemic levels

India's trade with China in the first half of 2021 rose by a record 62.7% – the highest increase among China's major trade partners – with total two-way trade surpassing the pre-pandemic levels. Two-way trade after six

months was \$57.48 billion, the highest on record for the first half. Bilateral trade surged from the year-earlier period, when trade slumped amid the pandemic, and surpassed the \$44.72 billion pre-pandemic figure recorded in the first half of 2019, according to data released on Tuesday by China's General Administration of Customs.

India's imports, driven by record purchases of medical supplies, reached \$42.76 bil-

lion this year, up 60.4% and higher than the first-half 2019 figure of \$35.8 billion.

India's exports to China climbed 69.6% to \$14.72 billion, also the highest figure on record for the first half of any year. India's biggest exports to China annually are iron ore, cotton, and other raw material-based commodities. The trade deficit after the first six months stood at \$28.04 billion.

The 62.7% increase was the highest among China's major trading partners. Trade with ASEAN, China's

trade with South Africa surged 70%, the total bilateral trade figure of \$25.32 billion, less than half India's, does not place the African country among China's top 25 trading partners. Badminton Association of India president Himanta Biswa Sarma was confident that hosting the Worlds would help Indian badminton take bigger steps towards becoming a world powerhouse.

"We are thankful to BWF for considering India for badminton's most prestigious and premier tournament and I believe with world-class shuttlers coming to participate, it will be a great opportunity and motivation for the enthusiasts of the game and for the sport to see a huge growth across the country," said

"With a string of tournaments being cancelled due to the pandemic globally, BWF had reached out to us with an alternate proposal. We, at BAI, felt that this was a great opportunity for the country as well as for the badminton fraternity," said BAI general secretary Ajay K. Singhania.

India has so far won 10 World Championship medals with reigning champion P.V. Sindhu leading the chart with a gold, two silver, and two bronze. Prakash Padukone claimed India's first medal at the Worlds in 1983. The other winners have been Saina Nehwal (silver, 2015 & bronze, 2017), B. Sai Praneeth (bronze, 2019), and Ashwini Ponnappa & Gutta (doubles bronze, 2011).

Cricket on a knife-edge: learning to live with the virus

he trial is over, and we await the judgement. Last weekend saw one of the biggest experiments in recent sporting history at three venues across England: Wembley, Wimbledon and

It involved crowds of over 60,000 as Italy beat England in the Euro final, 15,000 as Novak Djokovic climbed into the record books with his 20th Grand Slam title (and Ashleigh Barty claimed her second), and some 20,000 who watched a hastily put together England beat Pakistan in a One-Day International.

That's nearly one lakh people whose immediate future will tell us something about our long-term future.

Brave or foolhardy

Cricket, sport, and indeed mankind will have to learn to live with the coronavirus. This much we have learnt. If sport, as we believe, is a reflection of society, then what happens at a sporting venue could reflect what might happen outside it. Whether the English authorities were being brave or foolhardy will be revealed too. That might act as the template for others to follow (or not) in the continuing battle against the virus.

England cricket captain Ben Stokes has said that he is reconciled to going back to life in a bio-secure bubble. He and his team might have to if the India series next month is to be played safely, with the players feeling secure. The result of the experiment will be known before the first ball is bowled on August 4.

Already England have had to field a new team after the coronavirus entered their camp ahead of the Pakistan series. If there is tension in and around a cricket team, that is only natural.

In Sri Lanka, the start of the whiteball series against India was postponed by five days after the hosts' batting coach and team analyst contracted covid. The sequence of testing-isolatingawaiting negative report-returning to competition has become as commonplace as wearing masks-social distancing-handwashing, and most importantly, vaccinating.

Ashley Giles, the managing director of England men's cricket summed it up when he said, "We are fully aware of the risks and we are aware of the knife-edge that we are working on all the time."

Cricket is being played around the world on a knife-edge; and only the absence of, or relative low numbers of casualties can be taken as an endorsement of the decision to play.

Efficacy of the bio-bubble

The efficacy of the 'secure' bio-bubble depends largely on the people inside it. Sri Lanka recently suspended three players for breaching it on their tour of England and ordered their return home. They were seen on the streets of Durham after a T20 International.

There are bio-bubbles and then there are bio-bubbles. The ones in England and Australia seem to have kept the players safe during internationals (played to empty stadiums) there this year. These didn't work quite so efficiently in India during the IPL when Wriddhiman Saha and Amit Mishra were among those who caught the vi-

The thumb rule seems to be: less travel, constant monitoring, common sense. And of course, discipline.

It is difficult not to sympathise with the players and support staff who are forced into the bubble in order to a) entertain us and b) prompt some cash flow into the sport and for themselves. It is tough. But, increasingly as we are learning, eternal vigilance is the price all of

us have to pay. Recently, county cricket in England was affected, with the Derbyshire v Essex match being called off after a positive test in the former's camp. England's new limited over franchise tournament, The Hundred, scheduled to commence on July 21, seems to be under some threat since the squads are unlikely to be in bubbles.

England cannot afford to have any national player (most of whom have had

at least one jab) affected since the series against India is set to bring in about a £100 million in broadcast revenues. The Indian squad have had both their jabs.

The domestic season in India is set to begin on September 21. There are 2127 matches to be played. Things like travel and accommodation and indeed the bubble (if necessary) will have to be worked out in the weeks to come, depending on how the anticipated third wave affects the population. It is a huge

That new expression in the language 'super-spreader' - is not one we should turn to regularly. Or ever. So if the experiment with crowds in England passes off without incident (something that will be known only in a fortnight), sport would have gained enormously. And the experiment would have been worth it. If not..

Yashpal Sharma, India's 1983 World Cup winner, passes away

The 66-year-old succumbs to a massive heart attack after returning from a morning walk on Tuesday

Best remembered for his exploits in the 1983 World Cup, Yashpal Sharma succumbed to a massive heart attack on Tuesday morning. He was

Known for his gritty batting, immaculate fielding and brisk running between the wickets, Yashpal returned home from his morning walk and collapsed. He is survived by wife, two daughters and a son.

During a career between 1973 and 1993, Yashpal played Ranji Trophy for Punjab (47 matches), Haryana (14) and Railways (6).

No duck in 42 ODIs

In an international career from 1978 to 1985, Yashpal was never out for a duck in 42 ODIs. During his 37-Test career that began at Lord's, Yashpal's 140 against England at Chennai in 1982 was the highpoint.

His top-score was part of a 316-run stand with wrist-artist G.R. Viswanath who scored a career-high 222. Yashpal "learnt by watching the master at work" as the duo batted throughout the second day.

Yashpal made up for limited strokes through sheer resolve. Perpetually battling the fear of being dropped, Yashpal turned circumspect. That perhaps explained his caution until the first 40-50 runs before shifting gears.

One such innings resulted in his maiden Test century, against Australia at Delhi's Ferozeshah Kotla, in 1979. Following a 'pair' in the previous Test at Kanpur, Yashpal was desperate.

For the better part of his half-century, Yashpal was booed for his defensive approach. He made up for lost time by going after Peter

Three consecutive sixes into the stands behind midwicket and, instantly, Yashpal was the darling of the

A similar approach in ODIs rescued India thrice during the historic 1983 World Cup triumph!

In the opener against twotime champion West Indies, Yashpal scored a 120-ball 89 in India's 262 for eight in 60

Reviving the innings

K. Srikkanth, Sunil Gavaskar, Mohinder Amarnath, Sandeep Patil and Kapil Dev fell with just 141 on the board, but Yashpal and Roger Binny resurrected the innings with a 73-run sixth-wicket stand against the likes of Michael Holding, Andy Roberts, Malcolm Marshall and Joel Gar-

The resultant 34-run defeat was the first for West Indies in the World Cup.

In a must-win game against Australia, Yashpal top-scored with 40 in India's 247 in 55.5 overs. Here, the attack he negotiated included Geoff Lawson, Rodney Hogg, Tom Hogan and the feared Ieff Thomson.

After Madan Lal and Binny took four wickets each in India's 118-run triumph, Yashpal's contribution stood pushed to the background. But skipper Kapil never missed an opportunity to underline Yashpal's role.

In the tense semifinal against England, Yashpal

once again delivered with a calculated 61 off 115 deliveries as India chased down 214 with six wickets to spare.

Fresh in memory



The Tokyo 2020 Olympic Village officially opened its doors on Tuesday and began welcoming the athletes ahead of this year's Games, which will take place between July 23 and August 8.

Over 11,000 athletes from 205 National Olympic Committees and the IOC Refugee Olympic Team will compete in the Games, with the majority staying in the Olympic Village situated in the picturesque Harumi waterfront district of Tokyo.

Bach's message

Speaking about the athletes arriving, IOC President Thomas Bach in a release said: "The athletes are grateful that these Olympic Games

These include common hygiene practices such as mask-wearing, hand sanitisation, and physical distancing, as well as details covering daily screening testing and limitations on athletes' movements.

Unique features

Whilst in the Olympic Village, the residents will experience a range of unique features which includes a dining hall, open 24/7, that will offer around 700 food options, catering to all dietary requirements.

A fitness centre will also be available, while those looking to relax between competitions can enjoy several recreation areas around the Village. In the residential facilities, the bed frames are made of cardboard and are 100% recyclable, while blackout curtains have been installed to allow sleep at any time during the day.

In its quest to make these the most innovative Olympic Games, Tokyo 2020 is operating several autonomous internal shuttle buses within the Village.

There will also, for the first time in the history of the Games, be a dedicated treatment programme that will comprehensive provide medical care for female athletes, at the Clinic Complex (Polyclinic).

Usha picks Neeraj to end India's medal drought

Feels young Sreeshankar can spring a big surprise; holds out hope for Kamalpreet and Annu Rani

Whenever P.T. Usha saw javelin thrower Neeraj Chopra at the 2016 under-20 Worlds in Poland, she was reminded of her running days.

"Even when he was just walking around, I remember, he used to keep trying out throws as if he carried an imaginary javelin," said Usha, who was in Poland then with her trainee Jisna Mathew, in a chat with The *Hindu* on Tuesday.

"I used to do that often when I was young... if I saw a hurdle anywhere or even a stone on the road, I would run and try to clear it.

"Neeraj looked so strong and confident then. And when he won the junior Worlds gold with a world record, I felt that he would go far," she

Usha, who narrowly missed winning an Olympic medal in the 400m hurdles in 1984 at Los Angeles, feels that Neeraj will end India's long wait for its first-ever

Olympic athletics medal.

"Neeraj did 88m earlier this year, he could probably go past 90m. I think he is capable of winning a medal," said Usha, now a prominent coach.

She also feels that long jumper M. Sreeshankar can produce a big surprise.

"He is the No. 2 in the team. Considering his age, Sreeshankar has produced some big jumps. He may not be very consistent and that could be because he has not had any international competition this year.

"But he is young and that

is why I feel he can surprise us all with a big show," said Usha. "But he should not be under any pressure. If he is bold and free, he can reach the final and do very well after that," she said.

Usha picked discus thrower Kamalpreet and javelin thrower Annu Rani as two other athletes capable of making their respective finals.

"Kamalpreet has broken Krishna Poona's national record and has done 66-plus and Annu Rani has been very consistent, so I think both will enter the final.

"Shot putter Tajinderpal Singh Toor could also make it if he repeats his big throws," she said. But she doesn't hold out

much hope for the 4x400m relay teams (mixed and men). "Amoj Jacob, Muhammed

Anas, Revathi and Subha will probably run the mixed relay but the two girls are not capable of going below 53s, so it will be very difficult.

"And some of our top men have not run many quartermile races this year. So you can't predict anything in the men's relay," she said.
