No COVID-19 death reported in the Capital

NEW DELHI The Capital on Sunday reported no COVID-related deaths, said a health bulletin released by the Delhi government. 31 killed as rain triggers mayhem in Mumbai

City records over 200 mm rainfall overnight; alert sounded

ALOK DESHPANDE

At least 31 persons, including eight minors, lost their lives as incessant rain, which began on Saturday night and continued throughout Sunday, pummelled Mumbai, triggering landslips, house collapse and electrocution.

The Regional Meteorological Centre predicted heavy to very heavy rainfall at a few places in the next 48 hours, with extremely heavy rainfall at isolated places.

The Brihanmumbai Municipal Corporation said more than 200 mm of rainfall was recorded between 11 p.m. on Saturday and 4 a.m. on Sun-

day. A BMC centre at Dahisar recorded the highest rainfall of 226.82 mm, followed by Chembur with 218.45 mm.

Landslips, wall collapse Nineteen persons were

killed and five injured at Vashi Naka in Chembur after a retaining wall collapsed on four or five huts due to the force of water and mud around 1 a.m. A landslip at Panchasheel chawl in Vikroli on six houses around 3 a.m. resulted in the death of 10 persons, while one person was injured. A teenager was killed after a wall of his house in the Bhandup area collapsed, while one person

was electrocuted at a shop in Andheri.

Five battalions of the National Disaster Response Force were deployed in Chembur and Vikroli to speed up rescue efforts. The search was on for two more missing individuals at the time of writing this report.

"I visited the 3 locations of landslips ... Relief work is going on and all necessary financial and medical assistance is being provided by the Govt of Maharashtra and BMC," Environment Minis-Aaditya Thackeray tweeted.

Govt. ready to discuss all issues in a constructive manner: Modi

Congress, Trinamool oppose proposal on PM's meeting on COVID outside House

A day before the monsoon session of Parliament gets under way, Prime Minister Narendra Modi on Sunday told an all-party meeting that his government is ready to discuss and debate all issues in a "constructive" manner.

However, differences surfaced at the meeting, convened by the government, when Parliamentary Affairs Minister Pralhad Joshi proposed that the Prime Minister would chair a meeting on the COVID-19 situation in the country at Parliament Annexe on Tuesday.

Strongly opposing it, Congress leader in the Lok Sabha Adhir Ranjan Chowdhury and Trinamool Congress Rajya Sabha member Derek O'Brien said the discussion should take place on the floor of the House.

"MPs do not want fancy PowerPoint presentations on #COVID19 from the PM or this Government in some conference room. #Parliament is in session. Come to the FLOOR OF THE HOUSE," Mr. O'Brien later tweeted.

The Opposition parties also differed among themselves on the issues to be taken up first. At a meeting of Opposition leaders, convened by the Leader of the

Opposition in the Rajya Sabha Mallikarjun Kharge, the Congress was keen to first take up the issue of the hike in the prices of petroleum products and other commodities, but the other Opposition parties expressed their intention to move an adjournment motion to discuss the ongoing farmers' agitation. Sources said disruptions were expected on the issue of price rise as well as the farmers' agitation.

At a separate meeting with all the floor leaders, Lok Sabha Speaker Om Birla urged them to "respect the sanctity and dignity of the House", and sought their cooperation for the smooth

conduct of the proceedings. The government plans to take up 31 Bills, including two financial Bills, during the session.

"Took part in the All-Party meeting before the start of Parliament's Monsoon Session. We look forward to a productive session where all issues can be debated as well as discussed in a constructive manner," Mr. Modi tweeted. Defence Minister Rajnath Singh and Union Minister and Leader of the House in the Rajya Sabha Piyush Goyal were present at the meeting.

"At the all-party meeting, Prime Minister Modi said healthy and fruitful debates should take place in Parliament. He said the government is ready to hold discussions on any subject if raised Stormy session expected

The monsoon session is expected to witness heated arguments, with the Congress and its allies set to target the government over price rise. Congress chief Sonia Gandhi held a meet with party MPs on Sunday. "There will be disruptions tomorrow as there has been consensus among Opposition parties about price rise," an MP said. ▶ PAGE 9



After U.P., Delhi calls off Kanwar Yatra

The Delhi Disaster Management Authority on Sunday issued an order that no celebrations, processions and gatherings would be allowed during the upcoming Kanwar Yatra in the Capital.

The order said the yatra is scheduled to commence from July 25 despite being banned/suspended by the Uttarakhand government. "In view of the persisting COVID-19 situation, it is decided that the Kanwar Yatra should not be permitted to prevent the spread of the virus in the territory of NCT of Delhi," the order read. The DDMA order came a day after the vatra was cancelled in Uttar Pradesh.

The order said in case of violation of instructions. the violator will be proceeded against as per the provisions of the DDMA Act, 2005, Section 188 of the IPC and other applicable laws.

Midday meals leave a long-lasting impact: study

Lower stunting among children with mothers who had access to school lunches



NEW DELHI Girls who had access to free lunches provided at government schools had children with a higher height-to-age ratio than those who did not, said a new study on the inter-generational benefits of the midday meal scheme, published in Nature Communications this week.

Using nationally representative data on cohorts of mothers and their children spanning 23 years, the paper showed that by 2016, the prevalence of stunting was significantly lower in areas where the scheme was implemented in 2005.

More than one in three Indian children are stunted, or too short for their age, which reflects chronic undernutri-

mented years before those girls and young women become mothers", the study has attempted a first-of-itskind inter-generational analysis of the impacts of a mass feeding programme.

The paper was authored by a researcher from the University of Washington and economists and nutrition experts at the International Food Policy Research Institute. It found that the midday meal scheme was associated with 13-32% of the improvement in the heightfor-age z-scores in India between 2006 and 2016.

The linkages between midday meals and lower stunting in the next generation were stronger in the lower socio-economic strata and likely work through women's education, fertility, and the use of health services, the paper said. The scheme was launched

in 1995 to provide children in government schools with a free cooked meal with a minimum energy content of

Transgender persons' bid to break new ground locality of Bhubaneswar.

Several members of the community have applied for the job of sub-inspector in Odisha

Not so long ago, Pratima Behera, a 22-year transgender, faced abuses and scurried for cover as baton-wielding policemen chased her at a railway station in Jamshedpur. Iharkhand, where she begged for survival. Kalpana Patra (name changed), who used to be a trans-sex worker, also experienced harassment and violence, often at the hands of police.

Both Pratima and Kalpana are set to turn their life around. They have filled out applications to become police officers in Odisha. From undertaking

They seem to be on a mission to prove themselves. When the Odisha

government came up with an advertisement last month to appoint transgender persons as sub-inspectors of police, the community considered it an opportunity to change the societal perception about them. For a total of 477 SI posts, 1,32,496 candidates have applied. Of them, 97,506 are males and 34,964 females while 26 belong to the transgender community.

"Not many in our community can plan their future on the basis of their qualifications. There are very few employers for us in the job market," said Kalpana.

Pratima said the prospect of joining the police force was a once-in-a-lifetime opportunity for her. especially after she was forced to flee home and beg for survival just to evade the mocking eyes of her own family members.

"This is a rare occasion when so many transgender candidates have applied for a government job. This is the first permanent, dignified job offered to transgender persons," said Meera Parida, a transgender activist who heads an NGO, Sakhaa, that works on mainstreaming the transgender community. She is mentoring the transgender candidates for cracking the police job.

Where honour matters more than life



he sun was peaking on a summer afternoon in Gopalpur village in Sonipat. A suffocating silence prevailed; most stayed indoors. A 12-yearold boy popped up. Asked about the house of a girl whose husband had recently been killed 'to save the honour', the boy directed promptly: "Everyone in the village knows both the houses, of the girl and the boy, and the whole story," he said with a rather stern face.

Past a bungalow was a double-storey house with cemented exterior. Two wooden cots and chairs were laid out inside the courtyard. Sheela Dahiya had just returned after buying groceries from a nearby shop.

As soon as she heard her daughter Kiran's name, she broke into tears. Her husband Jai Bhagwan - visibly drunk sat on a chair finding it tough to speak coherently. "I will approach Narendra Modi," he kept repeating.

Ms. Sheela complained that police are not letting her meet her daughter and that the family had visited the police station thrice in the hope that offic-



ers will take them to the hospital because that's the only way they know they'll be able to meet the daughter.

Futile visits

"I received a call from her from a police officer's number right after the incident. She asked me to take her home. We went to the hospital to meet her but we were not allowed. We haven't been able to since then," she said, adding that she, her husband, and two sisters-in-law had gone to Dwarka Sector 23 police station on July 12 and 13. They waited all day long at the police station but without any luck.

However, Deputy Commissioner of Police (Dwarka) Santosh Kumar Meena said that Kiran was discharged from the hospital and sent to a women's shelter to ensure her safety. She reportedly told officials that she wouldn't be safe at her maternal house

Kiran's brother Aman (21) and her cousin Vicky (22) have been arrested along with others for shooting her husband Vinay Dahiya dead at their rented accommodation in Ambrahai village on June 24. They fired bullets at both, but she survived.

Feuding families

Both families were against the relationship and marriage because they were from the same gotra. But now Ms. Sheela wants her back. "I can even die to keep my daughter safe here. I've never even laid a hand on her. I just want her back. Whatever happened was in the past," the mother cried with a passing

The father butted in: "Us ladke ka naam mat le... vo to marr gaya.. mujhe bas meri beti wapas chahiye [Don't take the boy's name... he is dead now... I just want my daughter back]". The mother promptly told him to shut up.

Long story

The shooting episode was not an on the spur of the moment incident. The antipathy had been brewing since the lovers fled their houses and got married in Chandigarh in August 2020. Their love story dates further back to 2013 when Kiran was in Class VIII.

Ms. Sheela remembered that Kiran used to go to school in the bus and Vinay used to follow her. The word spread in the village and the family members became aware of it. "Those were the last days when she physically attended the school. We made her drop out and sit at home. She took Class IX exams from home and wasn't allowed to study thereafter," the mother recounted.

She said they did everything they could to salvage their honour. "Sab kuch izzat bachaane ke liye kiya tha," she said.

With a tinge of regret, she says: "Police ko complaint dene ka socha tha us waqt bas izzat ke maare chhor diya. Agar us waqt bola hota to shayad aaj ye din na dekhna padta. [We wished to complain against Vinay but stopped because of honour. If we would have, then maybe we wouldn't have had to see this day]".

Deeper, stronger

The end of studies didn't mean the end of their relationship. Over the next few years, the two families met through mediators and both lovers were instructed not to see each other. But the more they tried to disunite them, the stronger their relationship grew.

Kiran's brother Aman, however, had a streak of violence. "Aman bhai was teased among his peers for didi's relationship. A few years ago, Vinay had told Aman bhai that he was his brotherin-law in front of 25 other boys. It hurt his pride. Vinay had also said that he would kill Aman," recalled Himanshu alias Sunny (15), Kiran's cousin and Vicky's brother.

Aman allegedly killed a friend of Vinay in 2017 when he refused to call Vinay to a place Aman wanted him to come. Aman was then 17 and spent a year in an observation home. But the panchayat intervened, and the issue was apparently resolved.

Two years later, on August 13, three months after Kiran has turned 18, she left the house when everyone was asleep. The same day, they got married in Chandigarh and sought protection from Kiran's family. The court, however, stated that they should seek protection ture. It's a sin," he said, assertively.

from local police.

A few days later after the marriage, the village panchayat ruled that the couple should stay out of the village following which both families reportedly snapped contact.

But Aman was still seething with anger. On June 24, he, Vicky and a few other youths entered the couple's house and shot multiple rounds at them, leaving Vinay dead.

"If I had any idea that Aman was going to do something like this, I would have beaten him black and blue myself. I have two children and none of them are with me now," cried Ms. Sheela.

A house in mourning

A few meters away from Kiran's house is Vinay's double-storey residence. His photograph, with a garland of yellow genda, hangs on the wall. His family is vehemently against bringing Kiran to the house and wants nothing to do with her anymore.

But just before his murder, they had begun talking with their son, and though reluctantly, accepted the marriage, "I had spoken to him the day he was killed. She was pregnant and she and Vinay had gone to a hospital for her abortion because of some complications. He had called me to ask for some home remedies and visit them to help the girl," claimed Vinay's mother, who didn't wish to be named.

Half an hour before the murder, Vinay's brother Deepak said they had spoken to him. Now, all that remains of him is a car – he used to drive while working as a driver at the IGI Airport -parked outside their residence. "Bohot samjhaya tha use. Maara bhi tha. Nahin maana. [We tried a lot to make him understand but he didn't. We beat him too]," said Mr. Deepak.

The villagers too were against the relationship, and they pinned the blame on city culture. All this happens in cities like Delhi, not here, said grocery store owner Rakesh.

"They were brother and sister. No girl and boy in this village can marry each other. It's against the rule of na-

A 35-year-old man allegedly killed his neighbour, beheaded the body, and disosed it in a canal in U.P.'s Muradnagar, the police said on Sunday.

Riyasat, a driver from Old Seemapuri and his 30year-old accomplice Javed from Garima Garden in Ghaziabad have been arrested, they said.

The case came to the fore when a missing report of a man named Shahjad (52) was registered at Seemapuri police station on

Tuesday. On Friday, the police

found a body in Khekra, U.P. The family members of Shahjad identified the body. Next, a post-mortem was conducted by the U.P. police.

"On the basis of technical surveillance and call details record, the police identified one of the accused persons. A raid was conducted, and the accused were nabbed," said DCP (Shahdara) R. Sathiyasundaram.

During interrogation, Riyasat said the victim had borrowed ₹25,000 from him before the lockdown. When he asked Shahjad to return the money, the latter abused and threatened

to take revenge and planned his murder for five days, the police said.

Court rejects petition of 93 CRPF jawans seeking deployment in UN Mission

The Delhi High Court has rejected the plea of 93 CRPF personnel seeking direction to the force to deploy them in the upcoming United Nations (UN) Mission. It noted that it is not for the court to interfere in administrative tasks such.

A Bench of Justice Rajiv Sahai Endlaw and Justice Amit Bansal further said CRPF personnel "merely by being empanelled, therefore, did not acquire any right to be posted at UN Mission, whensoever wheresoever".

The court said if the 93 CRPF personnel still meet the requirements set out in the new notices for empanelment, they can compete with the fresh applicants and if selected, would again be empanelled.

The direction came on a petition filed by the personnel challenging the decision of the CRPF inviting fresh applications for de-



ployment in the upcoming UN Mission in July, 2021.

The 93 personnel contended that pursuant to similar notices taken out by the CRPF in 2016, they had applied and participated in the selection process comprising written examination, physical standards, physical efficiency and medical tests and were selected. In June, 2017, they

cleared the Pre-Deployment Training and from time to time, till the year 2019, they were subjected to further training for deployment in the UN Mission. However, they were not deployed at any of the

Police's meet with farmers inconclusive

Protesters requested to reconsider planned march to Parliament; SKM leaders assure peaceful rally

Ahead of the march planned by farmers near Parliament during the monsoon session. the Delhi police's meeting with the farmer unions' remained inconclusive on Sun-

A senior police officer said they had requested the farmers to reconsider their protest call citing the DDMA guidelines and the outbreak of COVID-19 third wave.

Samyukt Kisan Morcha leaders have given assurances of "peaceful" protest.

No plans to gherao

"We laid out the plan. We don't plan to do any gherao [or laying siege], and the idea of trying to enter Parliament is ruled out. We have no intent whatsoever to disrupt the functioning of Parliament in any way," said SKM leader Yogendra Yadav, who was part of the farmers' delegation.

The monsoon session be-

gins on Monday, and the farmers intend to begin their daily protest from July 22.

"We told them [the police] we would not take unlimited crowds. We are only taking 200 select persons. To be and the list will be supplied

"We wanted to be extremely careful and ensure that no disruptionist uses this opportunity to do something that will bring a bad name to the movement," he added, noting that the Sikhs for Justice group, which was not part of the SKM, had already given a call for a siege

of Parliament.

The monsoon session of Parliament will start on Monday and is scheduled to conclude on August 13.

Every detail about each protester will be given to the police, including a demonstrator's Aadhaar card and the mobile phone number, said the farmers at the meet-

Farmers have been protesting against the Central laws since November last year at the Delhi border points of Singhu, Tikri and Ghazipur.

The Delhi police said they would consult and get back to the SKM, said Mr. Yadav, who added that the farm unions did not apply for permission to protest, and intend to continue their preparations.

'Equal share'

"All the 40 farm unions involved in the SKM will have an equal share in the protest, with five members from each

union participating each day," said Dharmendra Malik, spokesperson for the Bharatiya Kisan Union-Tikait. "Out of these five members, there will be a team leader who will be fully accountable for his team. The selection of the satyagrahis is being done after thorough scrutiny, with ID cards being issued on the basis of Aadhaar cards," he added.

Barricades set up

The police said multilayer barricades had been installed in the New Delhi area to avoid tresspassing during the monsoon session.

"A team also visited the Red Fort, Parliament and other locations to check preparedness. A bomb disposal squad and quick reaction teams have been deployed at key locations. The area around Parliament will remain under round-the-clock security till the monsoon session ends," said the senior police officer.

'Shut seven metro stations if required'

Prisoners, out on bail, arrested as they return to crime

SAURABH TRIVEDI NEW DELHI

Several inmates, released on emergency parole or interim bail from Delhi prisons to decongest jails amid the COVID-19 outbreak, have been arrested again for being allegedly involved in various criminal cases, said a Delhi police officer on Sunday.

The Supreme Court had on Friday ordered that prisoners, who were released by the high powered committees (HPCs) of States during the second wave of COVID-19 following its May 7 directions, will not be asked to surrender until further

Keeping a watch

The officer said that each police district has a separate jail-bail cell to keep track on criminals on bail. All police stations have been instructed to keep a watch on them. The inmates were lodged in the jails in West, South, Dwarka and Outer Delhi districts.

The North district police on July 5 this year, arrested a man released on bail after being allegedly involved in a murder case. Different picture

According to the police, at least 90 inmates of North West district and 95 of North East district jails were released. However, no one has been arrested again so far.

In Shahdara district, 104 undertrial prisoners were released from jail, but none of them have been found involved in any other criminal case so far, they said. A senior Delhi Prisons official said over 3,800 inmates were re-

leased from three jails. "This year,

the process of releasing inmates

started from the second week of

May. Around 3,000 undertrial pri-

soners and over 800 convicts were released from the prisons," the official said.

These include inmates who were released last year and then surrendered with no adverse report, and also new prisoners who were eligible for such interim bail or emergency parole in view of the pandemic, under the criteria laid down by a high powered committee in its meetings on May 4 and May 11.

Last year, over 5,500 undertrial prisoners and 1,184 convicts were released on interim bail and emergency parole from the three Delhi jails – Tihar, Rohini and Mandoli – during the COVID-19-induced lockdown. But over 2,400 undertrials and 90 convicts have not reported back to the jail. The district police have been informed about them.

Court direction

The Supreme Court has also directed the State governments and their high powered committees to file the norms or the guidelines being adopted by them in implementing the order on release of prisoners for decongesting jails during the second wave of the contagion.



Night curfew relaxed in Haryana, lockdown extended by one week

Now, restaurants and bars can remain open for an additional hour

The Haryana government on Sunday relaxed the night curfew in the State, allowing the restaurants, bars and gymnasiums to remain open for an additional hour but extended the COVID-induced lockdown for another week.

Announcing the extension of lockdown till July 26, the State government, in a detailed order, delayed the imposition of night curfew in the State for an hour, now from 11 p.m. to 5 a.m. on all days of the week.

With relaxation in the night curfew, the government allowed the restaurants, bars, and club houses to remain open from 10 a.m. to 11 p.m. with the seating capacity of 50% and adherence to requisite social distancing and other COVID-19 appropriate safe-

ty norms. The gyms are also allowed to open from 6 a.m. to 9 p.m. with 50% capacity.

However, despite a sharp decline in positivity rate and the number of new COVID-19 cases, the government decided "to con-

tinue the preventive and precautionary measures" to contain the pandemic and extended the lockdown till 5 a.m. on July 26.

The government had last week allowed the cinema halls, swimming pools and spas to open with certain restrictions in a major relaxation.

The Haryana government had first imposed a week-end lockdown in nine districts - Gurugram, Faridabad, Rohtak, Sonipat, Karnal, Panchkula, Hisar, Sirsa and Fatehabad – from 10 p.m. April 30 to 5 a.m. on May 3. The entire State was then brought under lockdown for a

week on May 3 and the restrictions are being extended on a weekly basis thereafter.

Decline in new cases

The number of fresh COVID cases in the State has declined by almost 71% from 146 on June 22 to 41 on July 17, said a press statement issued by the Haryana Public Relations Department.

The State's recovery rate has also improved by 0.15% from 98.50% on June 22 to 98.65% on

However, the fatality rate has increased by 0.04% from 1.21% on June 22 to 1.25% on July 17.

Kerala entry norms Fully vaccinated individuals entering Kerala were not required to produce RT-PCR negative certification. A CO-VID-19 vaccination-completed certificate would suffice.

The government allowed cinema and television serial shooting in localities where the average TPR was below 15%. Artists and crew should have received at least one COVID-19 vaccine dose.

The government also allowed engineering colleges and polytechnic hostels to admit students preparing for their semester examinations.

The Karnataka government on Sunday further pared down COVID-19 restrictions by keeping the curfew hours from 10 p.m to 5 a.m. besides allowing cinema theatres to open with 50% capacity.

Higher education courses

would commence from July 26, and students who had taken one vaccine dose could attend. The decisions were taken at a meeting chaired by Chief Minister B.S. Yediyu-

rappa. The teaching and nonteaching staff with at least one dose would be allowed. However, student attendance was optional.



Kerala keeping watch on reservoirs after rain alert

Low pressure area to form in Bay of Bengal by July 23: IMD

With the southwest monsoon turning active over Kerala, the Kerala State Electricity Board (KSEB) has been asked to keep a close watch on dam storage and increase hydel generation to maintain safe water levels.

The India Meteorological Department (IMD) said on Sunday that a low pressure area was likely to form in the Bay of Bengal only by July 23, two days later than earlier expected.

Rainfall-related alerts have been suitably modified. Kozhikode, Wayanad, Kannur and Kasaragod can expect heavy to very heavy rainfall and are on orange alert on July 21 and 22.

Minister for Electricity K. Krishnankutty said the combined storage in dams managed by the KSEB stood at 52.57% as of 7 a.m. on Sunday. While the storage in the big reservoirs was not an immediate cause for concern, the KSEB had nevertheless

been directed to increase hydropower generation to keep water at safe levels, Mr. Krishnankutty said.

The Kerala State Disaster Management Authority has directed district authorities to make preparations in view of the rain alert.

It allegedly talks of leadership change

Is there a connection between a chess grandmaster and a software developer? Any seasoned coder will tell you that there is and, as a matter of fact, a powerful one. For instance, both require analytical thinking, problem-solving, cognitive skills, and pattern recognition. They also have to think 10 steps ahead.

If playing chess is all about checkmating the opponent in as few moves as possible, then, programming is also about coding lean with proper logic. Attention plays a critical role; a single blunder in chess is as dangerous as leaving vulnerabilities in your programme. There are plenty of other correlations.

Know your tools first: Before you can start playing chess, you have to understand the board's layout. You must know the pieces, their names, and how they move. Understanding rank and file is also imperative. In coding, you will have to learn about different tools such as code editor, deploy code through GitHub, and run it through a terminal.

Get the basics right: It is not enough to know how to move or some game terms. You need to know how to play. You have to learn the opening principles and different techniques. Gradually, you understand piece

development, which openings lead to what kind of vulnerabilities, or opportunities, and so on. It is the same for coding. You need to grasp the basics such as arrays, objects, and functions, and also understand how each

works when you code, when used together, which of them will lead to what kind of output, or what type of functionality they can create. **Learn the syntax:**

Chess has precise notations to mark and record moves.

Therefore, it is essential to know the difference between QxH6 and QxH6#. This is a unique language specific to chess. Similarly, for coding, learning the syntax for functions, arrays, objects, and so on is critical. It is important to know the difference between = , == and ===. So, be it coding or chess, understand and know the language well to master it. **Understand advanced**

moves: Once you understand all this, you need to take your game to the next level. You learn more advanced moves such as Forks and Discovered Checks, to keep your opponents on their toes. In programming, you learn advanced concepts such as Object-Oriented Programming (OOP), Nested Functions and Classes, which help you create more nuanced programmes and keep your code clean.

Figure out your style: Once you have mastered the building blocks, start figuring your style. In chess, you could be aggressive like Carlsen, or persistent like Vidit. You do the same while programming. You could be innovative like Steve Wozniak, robust like Linus Strovald, or creative like Mark Zuckerberg. Your style differentiates you from the rest, and takes you from being proficient, to becoming a master.

Engineering a two-language system

An amalgamation of English and Tamil can produce better-equipped and qualified engineers, and bolster their employability

Mechanical and Civil engineering programmes in Tamil medium were introduced by Anna University over a decade ago. Currently, the College of Engineering, Guindy (CEG) and the university's constituent colleges offer one or both these programmes. The courses are not popular in other colleges despite 20% reservation in government jobs for the students.

In the 1970s, efforts were made to introduce Engineering courses in Tamil, and many textbooks were prepared in the language. However, the All India Council for Technical Education (AICTE) did not permit Engineering courses in Tamil as it had to evolve a national policy on the subject. In a recent survey, however, the AICTE discovered that 42% of the students surveyed nationally, favoured pursuing Engineering in regional languages. The Madras High Court's Madurai Bench recently reiterated the 20% reservation for Tamil-medi-

um candidates, in every stage

courses available in Tamil, textbooks are unavailable and capable faculty scarce. Material on advanced topics and research or postgraduate programmes are rarely available. PG/Research programmes Relevant PG and research programmes must also be designed and introduced, with proper study and reference material. Universities, the Tamil Nadu government, and educationists can help create/ translate quality research material into Tamil. Two decades ago, a Tamil Nadu Science Congress founded by Kunrakkudi Adigalaar, conducted an annual international congress in Science and Technology, where local and foreign researchers participated. Significantly, the proceedings were in Tamil. Revival of such an activity will help enrich research material in Tamil.

Leaving the past behind

Afghanistan's neighbours must help it protect the democratic gains of the last two decades

Two events in Central Asia last week, which India attended, saw Afghanistan's neighbours seeking solutions to the conflict there. The first was a meeting in Dushanbe, of the Contact group on Afghanistan of SCO Foreign Ministers, and the second, a Central and South Asia connectivity conference in Tashkent. The meetings also took on a special salience due to their timing. Just days after the U.S. and NATO completed their pullout from the Bagram air base, and most other key locations, it is clear that the Taliban are making advances to return to power, by force if necessary. Of particular concern are the Taliban's attacks on border posts, particularly the border with Central Asian countries, and the Spin Boldak-Chaman border with Pakistan, which are for territorial control and to cut off crucial supply chains to the government in Kabul. At such a time for the SCO Ministers' grouping that includes Russia and China, India and Pakistan, and four Central Asian countries to have issued a joint statement, albeit without naming the Taliban directly, that decried the violence by terrorist groups, was significant. At Tashkent, the host, Uzbek President Shavkat Mirziyoyev, also gave Afghanistan President Ashraf Ghani the opportunity to confront Pakistan Prime Minister Imran Khan for Pakistan's failure to keep its promises on stopping the Taliban from crossing over and ensuring the Taliban conduct peace negotiations in earnest. Despite Mr. Khan's protests, the message is that the region, and global players, will not support the Taliban to enforce its brutal regime in Afghanistan through violent means. For India and the Central Asian States, the worries are about the violence at the frontiers and the resultant refugee influx, extremism, and support to transnational groups such as al Qaeda, LeT, JeM, ETIM and IMU, as it happened earlier under Taliban rule.

As External Affairs Minister S. Jaishankar said, Afghanistan's past cannot be its future, and in an interview to The Hindu, Mr. Ghani made it clear that the Afghan forces will not simply crumble this time. The emergence of the regional consensus to shun any attempt to take power by force will also give the Taliban and its backers in Pakistan reason to pause, and the high-level intra-Afghan talks in Doha over the weekend, and the Taliban's Eid announcement that they will pursue a political solution "seriously" and to assure neighbours they will not allow Afghan territory to be "used against any other country" may be evidence that the message has been received. As the future of Afghanistan is decided in the weeks ahead, it is necessary for the neighbourhood's voice, Central and South Asia included, to emerge more united and determined to protect the gains the nation has made over two decades.

Sensitive and precise

Trafficking needs a wholesome approach that is cognisant of the causative factors

Indoubtedly, trafficking is a pernicious offence, one that societies and governments must have zero tolerance for, and yet, handling the offence of trafficking needs precision, not a sledgehammer. In its current form, the draft Trafficking in Persons (Prevention, Care and Rehabilitation) Bill, 2021 seems to be lacking in nuance, even if well intentioned, to stamp out exploitative trafficking. The Bill, which will shortly be introduced in Parliament, aims at preventing and countering trafficking in persons, particularly women and children, to provide for care, protection and rehabilitation to the victims, while respecting their rights, and creating a supportive legal, economic and social environment for them. This is the Bill's second iteration; the first was passed in the Lok Sabha, in 2018, but then meandered into nothingness as it was never introduced in the Upper House. Notably, the Bill has expanded the area under coverage to include offences taking place, not only within India but also outside it. It envisages the setting up of anti-trafficking committees at the State and national levels to implement the provisions, when passed. In the days the Bill was up in the public domain for comments, civil society activists and legal experts have criticised its various provisions, and submitted that an overzealous approach would blur the nuances and an understanding of the contributing factors, including vicious poverty, debt, lack of opportunity, and development schemes missing their mark.

Vociferous opposition has arisen over the key aspect of handing over investigation in trafficking crimes to the NIA both by those who believe that it would burden the already stretched unit further, and those arguing that this move would be an attack on federalism, by removing local enforcement agencies out of the picture. Another key criticism of the Bill has been its broad definitions of victims, smacking of refusal to consider consensual sexual activity for commerce. This would only land up criminalising sex work and victimisation of the exploited. Bringing pornography into the definition of sexual exploitation would not allow even for any adult consumption of non-exploitative, consensual material. Reporting of offences has been made mandatory with penalties for non-reporting, but those with an understanding of the tortuous processes, point to the fact that victims often do not want a complaint to be recorded. The mention of the death penalty for various forms of aggravated trafficking offences needs to be flagged too. The Government would do well to scan and incorporate the responses to its Bill in order to ensure that the fence does not eat the crop. While sexual exploitation and trafficking can be ghastly crimes invoking public horror, for the state to not employ a wholesome approach, cognisant of the causative factors, one that would be sensitive and precise, would be equally horrific.

A 'tolerant' India can be majoritarian

Mere toleration or empirical plurality of cultures is not the same as a conscious democratic project of multiculturalism

In a recent comprehensive faceto-face survey (of nearly 30,000 people) on religious identity, nationalism and tolerance in Indian society, and conducted in 17 languages between late 2019 and early 2020 by the reputed United States-based Pew Research Center (https://pewrsr.ch/3xQqlVQ), 85% of Hindus affirmed that "respecting all religions is very important to being truly Indian." But, paradoxically, 64% of Hindus think "it is very important to be Hindu to be 'truly' Indian". And 80% among them say, "it is very important to speak Hindi to be truly Indian", giving credence to the slogan of

Rather than celebrating toleration, or seeing the paradoxes as a peculiarity of the Indic mind, it is crucial to recognise that a virulent majoritarianism can coexist with the professions of tolerance. It is misreading to treat the latter as a paradox because mere toleration or an empirical plurality of cultures is not the same as a conscious democratic project of multiculturalism or composite culture.

Thus, in the last two Lok Sabha elections, not a single Muslim has been elected on a Bharatiya Janata Party ticket. This obliteration of political representation of a signif-

icant minority (numbering 200 million) - which arguably has no parallel in any established democracy in the world - has become completely normalised in India, and is not a matter of discussion at

Other findings and paradoxes

The Survey abounds in other paradoxes: 80% (across all religions, in almost same proportion) think that respecting other religions is a very important part of their own religious identity, 91% assert that they are free to practise their religion, 77% of Muslims believe in the Hindu notion of karma, but when it comes to inter-religious marriages, friendships and neighbours, there is a marked tendency to keep communities separate. Thus, 67% of Hindus and 80% of Muslims believe it is important to stop women of their communities from marrying outside; 86% of Hindus have their close friends come mainly or entirely from their religion.

Scholar Bhikhu Parekh argues that plural cultures have always existed in the past, but what marks out contemporary multi-cultural societies is the premise of equality of cultures, and not just self-contained co-existence. The key features of multi-culturalism/composite culture are, as Prof. Lord Parekh asserts, cultures beyond compartments, constant dialogue and mutual change, and a strong streak of interrogation of "settled beliefs" across all cultures, especially the dominant culture.

It is a mistake to see the electoral success of religious majoritarianism in recent years as constructed in a vacuum. Instead, it is precisely the decades-long compartmentalisation of different religious communities, and the ab-

society arrangements in educational pedagogy, personal relationships, workplace, to facilitate inter-cultural interaction, and based on equality and respect, even under supposedly secular regimes, that has made the soil politically fertile for the demonisation of the minority, especially the Muslim (and occasionally the Sikh, as in the recent farmer protests).

This is despite the Survey breaking the Hindutva appellation of the anti-national Muslim. In fact, 95% of Muslims (and Sikhs) declare that they "are very proud to

India's 'skyboxification'

The American philosopher Michael J. Sandel argued that under rising extreme inequalities of capitalism, there is a "skyboxification of American life", in which the affluent classes and people of poor means have no connection at all, and they "live and work and shop and play in different places" and their "children go to different schools". In India, this plays out differently not just in economic terms, but also in religion, and more starkly, caste, the fundamen-

Every religion is riven by caste. Like with religion, 64% say that it is

men from crossing caste boundaries in marriage, and 70% affirm that "most or all of their close friends share their caste". Again, the Survey brings to the fore the central contradiction of a democratic nation that is divided by compartmentalised hierarchies. Thus, it is vital to note that amidst the gathering clouds of majoritarianism, it is a minority of upper castes that holds the reins of power, across religions, and it is the lower castes among the religious minority that face the brunt of majoritarian attacks. Glossing over this reality, ironically, reinforces religious majoritarianism, and reduces conflicts to merely religion.

This can only be overcome by the unison of social groups, especially the oppressed, across, religious and caste boundaries. As B.R. Ambedkar recognised a long time ago, the central barrier to the making of a nation is "separation in social life". It cannot be eliminated simply by elements like, as the Survey shows, a quarter of Muslims and a third of Christians believing in the purifying power of the Ganga, or the same kind of numbers believing in reincarnation, etc.

The antidote to the fear of other social groups, especially minorities, often is increased interaction among them in a variety of public and private settings. This is demonstrated in earlier Pew surveys in India, and those elsewhere. In the United States and West Europe, there is a big difference in positive attitudes towards other social/religious groups when members of those groups are personally known. Despite anti-Muslim sentiments, much higher numbers than India are willing to accept Muslims as neighbours. In the Pew Survey on 11 Emerging

(https://pewrsr.ch/2VVyEBV), higher percentage of the majority community in countries such as Lebanon, Venezuela, and South Africa interact with the minorities than India.

Attitudes in South India

But contrary voices to the majoritarian and segregated vision can be seen within the present Survey too. In several aspects such as the superiority of one's own religion, having friends and neighbours from other religions, preventing inter-religious marriages, the importance of being a Hindu and speaking Hindi to be a true Indian, prohibition of beef, the attitudes in South India differ, not by a small, but a substantial margin to the rest of India, especially the North and the Central parts. This enhanced willingness to break differences permeates both Hindus and Muslims in the South, showing the wider reinforcing effects of increased mutual interaction. Since culture affects politics, Hindu nationalism has had much less electoral success in the South, at least

Social reality and complexity cannot be reduced to numbers. After all, one cannot compare attitudes of different social groups blandly without understanding power differences. But quantitative surveys are still necessary tools. Majoritarianism, accompanied by mere tolerant acceptance of minority communities as noninteracting enclaves, is the death knell of democracy. To the extent that the Pew Survey hints at majoritarian attitudes and compartmentalisation, it can only be ignored at our own peril.

A new chapter in Nepal's quest for political stability

The Supreme Court order offers some respite amidst the political uncertainty, with lessons for Indian diplomacy too



n July 12, 2021, the Supreme Court of Nepal handed over a 168-page verdict on a case filed by 149 lawmakers out of the 275 parliamentarians demanding that Sher Bahadur Deuba be made the Prime Minister. Although the parliamentarians had gone to the Supreme Court as Mr. Deuba had gathered enough support to become the Prime Minister of Nepal under Article 76(5) of the Constitution, President Bidhya Devi Bhandari refused to entertain it. Instead,the President re-appointed K.P. Sharma Oli as the caretaker Prime Minister till the elections that they decided to hold in October and November 2021 were concluded. This ends now.

Impact of court intervention

Amidst such circumstances, the Supreme Court verdict has ended the collusion between Mr. Oli and Ms. Bhandari to continuously take decisions that were against the provisions of the Constitution. In

December, when the President dissolved Parliament at the behest of Mr. Oli, the Supreme Court ruled against this order and reinstated Parliament. The Supreme Court even had a piece of warning for the President to remind her that the office of the President is also defined by the Constitution and hence, cannot be above it.

On Wednesday, July 14, 2021, Mr. Oli left his official residence at Baluwatar which, for the past three and half years, had become his office, party headquarters and the centre of power in Nepal comparable to Narayanhiti Palace during the direct rule of the Kings. He left his residence after addressing the nation in a manner similar to when King Gyanendra left the Narayanhiti Palace on June 11, 2008. His supporters had a procession.

The Oli years

In the past, Mr. Oli's popularity rose when he challenged India during the blockade in September 2015 and whipped up nationalism to emerge as the leader who could lead Nepal. For the 2017 Federal and Provincial elections, the two major communist parties, the Nepal Communist Party (Maoist) and the Communist Party of Nepal (United Marxist Leninist-UML), joined hands, and with a landslide

victory, were to provide a stable government in Nepal in three decades. This coalition between the two parties had laid out some conditions, one of which was that Pushpa Kamal Dahal Prachanda and Mr. Oli were supposed to rotate the prime ministership. Even amidst these conditions and party coalitions, for the general Nepali public, Mr. Oli came with many expectations. He appointed a technocrat Finance Minister, a former Governor of the central bank, and other team members who, in people's eyes, were perceived to deliver the goods. Prior to taking over, he held various consultations. In one of the long sessions, he gave the impression that he means bu-

siness. He had a slogan, 'Prosper-

ous Nepal-Happy Nepali', that ap-

pealed to Nepalis both in the

country and abroad, giving a feel-

ing that, perhaps, the great mo-

ment has arrived for Nepal's trans-

However, the infighting within the ruling party that united in May 2018 began to surface in December 2019. Mr. Oli had, in two years of his rule, ensured that his kitchen cabinet ran the country while his image and international relations were being handled by prominent citizens who kept defending him till the end. He unleashed crony capitalism. Many business groups gained from his rule.

International relations plummeted with Mr. Oil taking on India with an amended map of the country, which only affected bilateral relations. With the United States Millennium Challenge Corporation (MCC) grant not being ratified (https://bit.ly/3BhClSs), ties have been hit as far as U.S. investors are concerned. With China, while he hosted Chinese President Xi Jinping during a whirlwind transit stop, the agreements never saw the light of the day when it came to implementation. The complaints of Chinese investors in Nepal in terms of governance and bureaucracy have been no different than the complaints of others.

However, his handling of the novel coronavirus pandemic created a public outcry due to a lack of health-care facilities. He was per-

sonally dragged into the Nepal vaccine scam in the purchase of vaccines from the Serum Institute of India. In his swan song, he tried to take credit for the support that Nepal received, which was more +due to the goodwill Nepal has and the efforts of many known and unknown activists who ran from pillar to post in different countries to get support and vaccines for

Looking ahead

The newly appointed Prime Minister, Mr. Deuba, nas served as Prime Minister four times but does not have a great track record. He may have won the confidence vote of July 18 (picture). But in this, there is a great lesson for India to be learnt: on how not to push relationships through intelligence agencies and other tacit ways as it fails each time. This has been seen in earlier decades. India needs to continue to build on people-to-people relationships and engage through official channels of bilateral platforms and diplomacy. Let us not forget that geopolitics is changing as Nepal is now free from being 'India locked'.

Calculating the benefits of lockdowns

Lockdowns need to be guided by trade-offs between harsh and mild policies



Data show that as of now 26.2% of the world population has received at least one dose of a COVID-19 vaccine. Of them, only 1% live in low-income countries. By contrast, the richer nations, such as the U.S., Canada, Germany and Britain, registered above 50% vaccination by July 17. For India, the percentage of the adult population that has received at least one dose stands at 34.1% as of July 18. How long it will take to eliminate the inequality in the administration of vaccines is shrouded in mystery. Till that happens, long or short lockdowns from time to time will remain the only defence against the virus. Several researchers have studied the effectiveness of the lockdowns in economic terms. It is important, therefore, to take stock of the issues that have materialised in this context.

A trilemma

The Economist has come up with a paradox of sorts in an article concerning the trade-off between lives and livelihoods. The article is rooted in the COVID-19 disaster and questions the practicability or even desirability of simultaneously protecting lives and livelihoods with the aid of lockdowns. The discipline of economics, or its dominant school at least, is intimately linked to tradeoffs and its fundamental teaching is that one cannot have one's cake and eat it too. During pandemic-driven lockdowns, this boils down not to a dilemma but a trilemma perhaps. Draconian lockdowns help you to keep on living, but they prevent you from earning a living. With incomes drying up, essential expenditures such as those on food, health and education cannot be sustained, implying that life cannot be lived. Extreme lockdown policies imply that you cannot quite have your life and

live it too – at least not meaningfully. The vicious trilemma needs to be torn down if humanity is to be preserved. This calls for a careful assessment of the severity of lockdowns,



they hopefully lead to in terms of lives saved. If the expected benefit of a policy falls short of cost, economists will reject it and suggest the adoption of alternative policies, involving an excess of benefits over costs. In other words, one needs to understand the nature of the tradeoff. Is the suffering caused by a lockdown sufficiently compensated for in terms of lives saved?

The question is probably less simple than it appears to be at first sight. The New York Governor, Andrew Cuomo, said, "To me, I say the cost of a human life is priceless." In technical economic language, this amounts to asserting that the (monetary) price of a human life is infinitely high. If this be so, saving a life calls for endless sacrifice. If such sacrifice assumes the form of extreme lockdowns, then the line of argument precipitates the trilemma all over again. It is counterproductive to start off with infinity. Clearly, the Governor had failed to come up with a meaningful definition of the value of a human life.

Let us push aside this question for now and estimate instead the cost of a lockdown. Some researchers believe this can be measured by the value of lost GDP. The Economist quotes the case of two European their costs, and the resulting gains countries – France and Italy. Both

imposed heavy lockdowns and suffered 3% shrinkage in GDP. Not that people did not die, but the 3% shrinkage cost of keeping a number of people alive was not insignificant. Similarly, Finland, which experienced a negligible rise in the mortality rate, experienced a 1% fall in per capita GDP. On the other hand, Lithuania performed miserably on its death rate front, but its GDP per person is expected to rise by 2%. The Economist points out yet another horrifying estimate of the cost of saving CO-VID-19-infected lives. Research, it

says, has established that for every

worse than the trilemma scenario

outlined earlier. There are other costs too that should not be overlooked. The horrors faced by migrant labourers in India will continue to jolt our collective memory. One wonders also if life expectancy itself has not been adversely affected in poor as well as emerging economies. Children are held back from school. One cannot rule out the emergence of child labour either. If and when the pandemic takes leave, researchers will surely address the child labour question in India caught in the iron grip of

The benefits of a lockdown, seen in isolation, do not appear to be all that clear. Lockdowns - severe or mild – prevent the spread of the disease so long as they last. Mortality falls perhaps, only to resurface once the lockdown is lifted. For the U.S., a researcher has come up with the disappointing conclusion that there is no lifesaving impact of lockdowns at

How, then, should the benefit of a lockdown be computed? However absurd this may sound, the question takes us back to the value of a human life, which the New York Governor had calculated more emotionally than he should have only to end up in a paradox. Interestingly enough, a good deal of theoretical and empirical research has been done by economists on this issue for the past 50 years at least. The pandemic has merely generated new interest in the

The value of a human life

There are many different ways in which the value of a human life may be calculated. A straightforward method is to study the life insurance premiums people are willing to pay to ensure proper treatment if afflicted by fatal diseases. In rich societies, large amounts will be paid. This could well be used to compute the social benefits of lockdowns, which will probably have higher values in rich societies than in poor societies where few are covered by life insurance. Further, all lives cannot command the same value. It is not criminal to ask if an aged person's life has the same value as that of a younger person. This means that a person's own valuation of his life may well differ from the way policymakers are likely to value it. Consequently, the social benefit of lockdowns continues to be a puzzle.

This is not to suggest that lockdowns ought to be avoided. Quite clearly, they are unavoidable for now, but they need to be carefully designed, guided by trade-offs between harsh and mild policies. Or else, the damaged economies of the world will not revive too soon.

Humanity is the fulcrum of journalism

The core requirement for a media house is to foster humanity



Last Saturday, we had readers discuss various aspects of news coverage, editorial choices and visual elements at The Hindu's virtual Open House. One of the suggestions was to reimagine the newspaper for the next generation of readers. There were intense discussions about how to provide credible information and in-depth analysis for a small device such as a mobile phone.

As a news ombudsman, I have one nonnegotiable condition. Reaching out to newer generations is a logical necessity. According to the online reference section of Britannica, India's population is young: "Its birth and death rates are both near the global average. More than half the population is under age 30 and less than one-fourth is age 45 or older." Many newsrooms, The Hindu included, keep debating on what should be the right wordage and mix of visuals and words for various devices. In my view, these essential elements seem to be external factors. The core internal and intrinsic requirement for a news organisation is its ability to foster humanity.

Rise in online hate speech

The spread of social media has contributed to a substantial rise in hate speech-related violence. The Council on Foreign Relations (CFR) has documented the spike in violence that is directly attributed to online hate speech. It says users' experiences online were originally designed to maximise their engagement. However, with an increase in algorithm-mediated customisation, there is promotion of extreme content. An investigation in The Wall Street Journal, "How You-Tube Drives People to the Internet's Darkest Corners", was on how the site often recommends divisive or misleading material. A report in CFR recorded that in many ways, the debates in courts, legislatures, and among the public about how to reconcile the competing values of free expression and non-discrimination have been around for a century or longer.

It is this context that we need credible media outlets that can halt the spread of hate, vitriol and misogyny and once again work to-

wards an inclusive public sphere. Though no one has quantified the cost of hate that is generated by social media, we are able to sense its corrosive effect on social harmony. A credible news media has two major functions: bearing witness and making sense. The growth of toxicity on social media has delegitimised the act of bearing witness. The recording of pain, the poignancy of loss, and the space for democratic aspirations are filtered through a narrow partisan lens.

The photojournalist who bore witness Nothing illustrates this inhuman delegitimisation of bearing witness than the racist campaign on social media against photojournalist Danish Siddiqui who was killed while doing his job of documenting the newly emerging politico-military situation in Afghanistan. Siddiqui, a Pulitzer Prize-winning Indian photojournalist, was working for Reuters. According to the news agency, he was embedded with a convoy of Afghan forces that was ambushed by Taliban militants near a key border post with Pakistan. In 2018, he won the Pulitzer Prize in feature photography. He won it alongside colleague Adnan Abidi and five others for their work documenting the violence faced by Myanmar's minority, the Rohingya. Much has been written about the power of his images of the mass funerals held at the peak of India's devastating second wave of COVID-19. Empathy was central to his documentation process. "While I enjoy covering news stories – from business to politics to sports – what I enjoy most is capturing the human face of a breaking story," Siddiqui had told Reuters.

His untimely death also brought out the pitfalls of the amplification of partisan politics on social media. There were hate posts about Siddiqui; some celebrated his death. The Editor's Guild statement explained the significance of a photojournalist bearing witness to an event. After listing out some of the key assignments of Siddiqui - the 2019 Easter blasts in Sri Lanka, the riots in north-east Delhi in 2020, and the devastating human tragedy caused by the pandemic, the Editor's Guild observed: "His work was therefore a living testament to the axiom of photojournalism, 'if your pictures aren't good enough, you aren't close enough'." Hence, in our quest to reinvent journalism for the new age, we need to ensure that humanity remains the fulcrum of any public discourse.

Time to build a valuable economy

COVID-19 has brought home to us the absence from the economy of certain crucial services

This July marks the 30th anniversary of the economic reforms launched by the Narasimha Rao government in 1991. Evaluations, mainly celebratory, have appeared in the media. A dispassionate assessment would be appropriate as the economic policy changes of 1991 were the first major changes in the policy regime since the 1950s. The hallmarks of the reforms were lessening of government control and opening the economy to

international trade and capital flows. As the timing of the reforms was determined by a balance of payments crisis, it would be natural to assess the reforms in terms of their consequence for this aspect of the economy. In mid-1991, India had foreign exchange reserves that would barely finance three weeks' imports. In mid-2021, the import cover is estimated at well over 12 months. Furthermore, in the three decades since 1991 there has not been a balance of payments crisis. On the other hand, in the preceding three there had been several. This marks a significant

Financial inflows A disappointing feature, though, is that the foreign exchange reserves have accumulated as a result of financial inflows rather than export surpluses, as was expected. It is now apparent that competitiveness cannot be established by simply reducing government control over the private sector. The history of globally successful economies shows that publicly provided infrastructure, private R&D and a facilitating government machinery are crucial for a country's export competitiveness. Most of these ingredients have been present in the case of India's software services-exporters but are not equally available for exporters of goods. The occasions since 1991 when there has been a trade surplus have been rare. The balance of payments has been shored up by portfolio capital. Such capital can flow out just as easily, leaving reserves to deplete rapidly. The only guarantee against balance of payments stress is a consistently strong export performance. The reforms are yet to take us there.

The reforms were also meant to raise the rate of growth of the Indian economy, which they did. Though the acceleration took some time coming, the rate of growth of the Indian economy has been higher after 2001. However, it started slowing progressively after the demonetisation of 2016, dropping to less than pre-reform levels even before we were struck by the pandemic. Since then, output has actually contracted, and there is no certainty on how growth will play out in the immediate future. Much depends upon whether there will be a third COVID-19 wave, necessitating the shutting down of economic activity yet again. Returning to the question of long-term growth, it needs to be pointed out that its acceleration after the reforms of 1991 was not the first time it happened. Not only had this occurred before, in the early 1950s and the late 1970s, but also the degree of acceleration had been greater then.

In 1991, we were, in effect, dealing with a cash-flow problem, albeit in foreign exchange. Now COVID-19 has brought home to us something larger, the absence from the economy of certain crucial services and the underlying assets that enable their production. We realised how inadequate our health system is, as we watched helplessly the scramble for oxygen, the overflowing hospital wards and the overburdened crematoria. But our rickety healthcare infrastructure is merely a metaphor for the absent ecosystem for living in India. Sanitation, transportation, urban governance and the producer services, from power supply to waste management, needed to undertake economic activity, are all inadequately available. This deficit cannot be bridged by legislating changes to the policy regime as was done in 1991. The necessary infrastructure would have to be first created and then managed to supply the stream of services expected. We have learned the hard way that the value of an economy depends on the extent to which it serves our needs. The current crisis of lives and livelihood in India is the time to start building a valuable one.



FIFTY YEARS AGO JULY 19, 1971

Bangla mission staff refuse to go to Pak

All but one of the 65 staff members of the former Pakistan Deputy High Commission in Calcutta, who had switched over their allegiance to the Bangla Desh Government, stuck to their decision at their "screening" held to-day [Calcutta, July 18] at the instance of Dr. Bonard, Counsellor in the Swiss Embassy in Delhi. The interviews, which lasted about two and a half hours from 10-30 a.m. clears the way for the repatriation of Indian and Pakistani diplomats from Dacca and Calcutta, where the two countries closed their respective Deputy High Commissions in April. Mr. Ashok Roy, Joint Secretary in the Ministry of External Affairs, and Mr. Mehdi Masud, former Pakistani Deputy High Commissioner in Calcutta, were witnesses to the interview. Mr. Hossain Ali, head of the Bangla Desh Mission in Calcutta, who was not present at the interview held in a school in a posh locality of South Calcutta, met Dr. Bonard, Mr. Roy and Mr. Masud at a separate house. All the three officials later visited the Park Circus residence of Mr. Maksoud Ali, Assistant Press Attache to the Bangla Desh Mission, who could not attend the interview as he is down with chicken pox.

A HUNDRED YEARS AGO JULY 19, 1921

The East African Problem

The Joint Parliamentary Committee have not been able as yet to make up their minds about the future status of the Indians in East Africa. The matter has been very fully discussed in all its aspects at successive meetings. The opinions of the India Office and the Colonial Office have been heard "in extns." and the views of several persons who are supposed to have special acquaintance with the subject have been ascertained. Members of the Committee have been circulating memoranda to one another, adumbrating more or less contradictory recommendations, but the features of a satisfactory solution of the problem have not yet emerged. It may be stated, however, that generally speaking the prevailing view of the Committee is more favourable to the claims of the Indian community than to the pretensions of the white minority. This was to be expected of a body which is charged with the Parliamentary oversight of Indian affairs. But the official view is that this question involves Imperial issues which cannot be determined from a sectional standpoint.

Govt. ready to discuss all issues, says Modi

31 killed as rain triggers mayhem in Mumbai

President Ram Nath Kovind, Prime Minister Narendra Modi and Chief Minister Uddhav Thackeray expressed condolences at the loss of lives. "The next of kin of those who lost their lives in the mishap will receive ₹5 lakh each from the State and those injured will be provided free treatment," Mr. Thackeray said.

The Chief Minister directed all agencies to remain on high alert and launch immediate rescue and relief operations in case of any mishaps. "If the water levels in the Mithi river or other major nullahs rise above the danger level, those staying in nearby areas must be relocated to safer locations immediately," he said.

The rain also led to a disruption in water supply to the city as the Bhandup Water Purification Complex was inundated.

Heavy rain also resulted

in waterlogging at 31 locations across Mumbai, and 20 traffic diversions had to be announced. Several suburban local train services were also hit due waterlogging on the tracks.

The India Meteorological Department predicted heavy to very heavy rain in the next 48 hours. It also expressed the possibility of winds reaching speeds of 45-55 kmph to 65 kmph.

"In view of the likely formation of a low-pressure area over Northwest Bay of Bengal & neighbourhood around July 23 and associated strengthening of westerlies, parts of Konkan Goa and adjoining ghat areas of Madhya Maharashtra is very likely to experience an active rainfall spell during next 5-6 days with heavy to very heavy rainfall at a few places and extremely heavy rainfall at isolated places,"

Pre-Bakrid easing draws flak in Kerala

Pointing out that the average test positivity rate remained unyieldingly high at 10.76% and was worryingl above 15% in at least 205 LSGI limits, the IMA urged the government to withdraw the relaxations immediately as the spectre of a third wave loomed.

Sonia's move comes despite unease among Punjab MLAs

Officially the meeting was to formulate their position on the call given by the Samyukt Kisan Morcha to raise the farmers' issue and not allow any other business in the House during the Monsoon Session unless the farm laws are repealed.

In Punjab, earlier in the day, at least 10 MLAs came out openly in support of Chief Minister Amarinder Singh, urging the high command "not to let him down".

Senior MLA Sukhpal Singh Khaira, sharing a statement on behalf of MLAs, urged the high com-

"Since merely six months were left for the elections, pulling the party into the different directions will only harm its prospects in the 2022 polls," they said.

The MLAs also supported Capt. Singh's demand that Mr. Sidhu who had made numerous tweets against him and the government should tender a public apology so that the party and government could function in The MLAs offered a word

of caution to Mr. Sidhu, who they said was a celebrity and was no doubt an asset to the party but condemning and criticising his own party and government in the public has only created a rift in the cadres and weakened it.

Pegasus spyware used to 'snoop' on journalists

Surveillance via victims' phones

Telephone numbers of some 40 Indian journalists figure in a "leaked list of potential targets for surveillance", and forensic tests were said to have "confirmed that some of them were successfully snooped upon by an unidentified agency using Pegasus software", The Wire, an independent news website, reported on Sunday night.

Indian Ministers, government officials and Opposition leaders also figure in the list of people whose phones may have been compromised by the spyware, The Wire, which conducted the investigation along with international partners. claimed.

The leaked telephone numbers included correspondents and writers from the Hindustan Times, The Hindu, India Today, Indian Express and Network18. Vijaita Singh, who works for The Hindu's national bureau, also figures in the list, which includes journalists like Shishir Gupta, Siddharth Vardarajan, M.K. Ve-

nu, Sushant Singh, Rohini Singh, Muzamil Jaleel, Ritika Chopra and Swati Chaturve-

The spyware Pegasus is apparently sold to governments around the world by NSO group, an Israeli company. It can be used to snoop on phones that run on Android and iOS sys-

Seventeen international media groups, including The Guardian and The Washington Post, led the investigation into how Pegasus was used to allegedly exmessages information from the phones of journalists, politicians and activists.

Lokpal yet to get director of inquiry

More than two years after the Lokpal came into being, the Centre is yet to appoint a director of inquiry for conducting preliminary inquiry into graft complaints sent by the anti-corruption ombudsman, according to a Right to Information reply.

The Lokpal, the apex body to inquire and investigate graft complaints against public functionaries, came into being with the appointment of its chairperson and members in March 2019.

According to the Lokpal and Lokayuktas Act, 2013, there shall be a director of inquiry, not below the rank of Joint Secretary to the Government of India, who shall be appointed by the Central government for conducting preliminary inquiries referred to the Central Vigilance Commission (CVC) by the Lokpal.

Danish Siddiqui laid to rest in Delhi

Jamia Millia Islamia accepts family's request for burial in its graveyard

Slain photojournalist Danish Siddiqui, who was killed in Afghanistan, was on Sunday laid to rest at the Jamia Millia Islamia graveyard in Delhi, where a sea of mourners gathered to pay their last respects. The mortal remains of the

photojournalist arrived in the Capital on Sunday evening. Jamia Millia Islamia (JMI) Vice-Chancellor Najma Akhtar accepted the request of the family of Siddiqui to bury his body in the JMI graveyard that is meant exclusively for university employees, their spouses and minor children.

FATF review of India put off again

An evaluation by the global organisation Financial Action Task Force (FATF) to analyse the effectiveness of India's anti-money laundering and countering terrorist financing regime has been postponed for the second time in view of the pandemic and is now slated to be initiated next year, officials said.

The scheduled assess ment by the Paris-headquartered watchdog was slated for September-October, 2020.

These dates were postponed to February this year by the FATF secretariat. "The schedule for FATF mutual evaluation has again been postponed from February 2021 and it is tentatively expected to begin in September 2022 now," an officer told PTI. As per this rescheduled calendar, the technical evaluation would begin in September next year.

HAL plans medium lift chopper

'All three services are part of the project, Navy has given its requirements'

Hindustan Aeronautics Ltd. (HAL), which is planning to indigenously design and develop a medium lift helicopter, the Indian multirole helicopter (IMRH), is hopeful of finalising the detailed project report in the next few months and approach the Cabinet Committee on Security (CCS) by year-end for project sanction.

"All the three services are on board the project. The Navy has already given their requirements, and we are discussing them right now. It will be a second platform with two different versions. The Army and the Air Force have promised to give the Preliminary Services Quali-

tative Requirements (PSQR) within two months. After that, it will take another two months to make a detailed project report (DPR)," HAL Chairman and Managing Director R. Madhavan said.

Once the DPR is ready, the HAL will approach the CCS for project sanction after

which funds will be released.

The project is estimated at around ₹10,000 crore, including for the two different versions for the Navy, and will take seven years for design and development.

At a meeting two weeks ago with the Secretary, Defence Production, these issues were discussed with the three services and the Navy The Army and the Air Force were earlier expected to share the PSQRs by June which got delayed due to the second wave of the pandemic and have now sought two more months.

A HAL official said that hoping to secure the CCS sanction for the project in 2022, HAL in the meantime has put in its money for preliminary works. But major funding has to now come in because prototypes have to be made, detailed designs are to be done, which takes lot of money, and needs CCS sanction, the official stated.

326 sedition cases were filed during 2014-19

A total of 326 cases were registered in the country under the controversial colonial-era penal law on sedition between 2014 and 2019 in which just six persons were convicted.

The Supreme Court last week observed that Section 124A of the IPC - offence of sedition - has been enormously misused and asked the Centre why it was not repealing the provision used by the British to "silence" people like Mahatma Gandhi to suppress the freedom movement.

According to the Union Home Ministry data, a total of 326 cases were registered under the sedition law between 2014 and 2019, with the highest 54 cases in Assam.

Out of these cases, chargesheets were filed in 141

cases while just six people were convicted for the offence during the six-year period.

The data of 2020 had not been compiled by the Ministry yet, officials said.

In Assam, out of the 54 sedition cases registered, chargesheets were filed in 26 cases and trials were completed in 25 cases.

However, there has not been a single conviction in the State in any of the cases between 2014 and 2019, the data say

Jharkhand has registered 40 cases under Section 124A of the IPC during the six years. Chargesheets were filed in 29 cases and trial was completed in 16 cases in which just one person has been convicted.

In Haryana, 31 cases were registered under the sedition law in which chargesheets were filed in 19 cases.

Assembly poll: Mayawati tries to win over Brahmins

Bahujan Samaj Party president Mayawati is again trying to win the support of the dominant Brahmin community ahead of the Uttar Pradesh Assembly election in 2022 despite suffering repeated failures since 2012.

On Sunday, Ms. Mayawati appealed to the community to take 'inspiration' from the Dalits and remain 'firm' in not falling for any lure or gimmicks deployed by other parties especially the ruling BJP. She said she was 'proud' that the Dalit community, to which she belongs, did not fall for any amount of lure they were tempted with by other parties especially the BJP in the last few elections. She claimed that the Dalits voted one-way for her despite attempts to mislead them with money, visits to their homes by BJP leaders and khichdi (meal).

To attract the community to her party and build consensus among them that their interests were secure only under a BSP govern-

ment, Ms. Mayawati has deputed Satish Chandra Mishra, Rajya Sabha MP and Brahmin face of the BSP, to start a campaign with special meetings for the community. The campaign will start from Ayodhya.

In the 2017 Assembly polls, the BSP was reduced to 19 seats. It was a huge fall for the party since it came to power with a full majority in the 403-member Assembly in 2007.

Ms. Mayawati admitted that the BSP did not win many seats in 2017 but stressed that her vote percentage did not fall that drastically. "Our vote percentage was even more than the Samajwadi Party's," she said.

While the BSP secured over 22% votes, the SP, which contested less number of seats due to an alliance with the Congress, got around 21.8% though it won more than double the seats won by the BSP.

Ms. Mayawati said the "upper caste" communities especially Brahmins were in distress in U.P. under the BJP rule.

Open-minded on alliance in U.P.: Priyanka

SC mulls limit to role as policy watchdog

Division Bench remarks on judiciary's reach runs counter to earlier judgment that courts cannot be silent spectators

The resolve voiced by a Division Bench of the Supreme Court in July to "examine" the extent to which the judiciary can question the government's COVID-19 policies drifts from the court's three-judge Bench judgment in May, which held that courts cannot be "silent spectators when constitutional rights of citizens are infringed by executive policies".

The May 31 judgment by a Supreme Court Bench of Justices D.Y. Chandrachud, L. Nageswara Rao and S. Ravindra Bhat is associated with the Centre's reversal of its dual vaccine pricing policy.

On July 14, a Bench of Justices Vineet Saran and Di-Maheshwari said courts should not undermine the executive at a time when a "collective effort" was required to overcome the public health crisis.

"Can the court tell the Executive to get the formula

Constitutional mandate

Our Constitution does not envisage courts to be silent spectators when constitutional rights of citizens are infringed by executive policies. Judicial review and soliciting constitutional justifipolicies formulated by the executive is an essential function, which the courts are entrusted to perform," Justice Chandrachud had said.

Responding to the government's argument that it should have "room for free play in the joints" while dealing with the pandemic, Justice Chandrachud said the court had no intention to "second-guess the wisdom of the executive".

"However, it (judiciary) continues to exercise jurisdiction to determine if the chosen policy measure conforms to the standards of reasonableness, militates against manifest arbitrariness and protects the right to life of all persons. This Court is presently assuming a dialogic jurisdiction where various stakeholders are provided a forum to raise constitutional grievances with respect to the management of the pandemic," Justice Chandrachud had clarified.

The judgment highlighted that courts across the globe have responded to constitutional challenges to executive policies which violate rights and liberties of citi-

Justice Chandrachud took the example of the United States' Supreme Court, which said "a public health emergency does not give Governors and other public officials carte blanche to disregard the Constitution for as long as the medical problem persists".

2.57 crore jabs available with States, says Centre

'41.99 crore doses provided so far'

Over 41.99 crore COVID-19 vaccine doses have so far been provided to States and Union territories, and more than 2.56 crore jabs are available with them and private hospitals, the Health Ministry said on Sunday.

In a statement, the Ministry said 15,75,140 more doses are in the process of being supplied.

It said 41.99 crore (41,99,68,590) vaccine doses have been provided to States and Union Territories (UTs) so far through all sources.

39.42 cr. doses used

Of this, the total consumption, including wastage, is 39,42,97,344 doses, according to data available at 8 a.m. on Sunday.

The Ministry 2,56,71,246 Covid vaccine doses are still available with the governments of States and Union Territories and

Students unable to travel to Italy

Indian students who had rushed back home from Italy to be with their family members or take part in last rites of the loved ones at the peak of the second wave of COVID-19 are now stranded here as air travel remains banned to the European country.

Those who returned to India before April 28, when air travel to and from Italy was suspended, are now stuck in India even though their peers back in Italy have gone back to their

universities. Zeeshan Ahmed, a cyber security student at Sapienza University of Rome, arrived in India when he got news of his sister being ill due to COVID-19. He is now unable to go back.

Aligarh resident Owais R. Khan, who is pursuing an M.Sc. in Computer Science at the same univer sity in Rome, says he came back to India in February.

"We have been reaching out to the Embassy, sending emails to the Ministry to raise the issue with their counterparts in Italy but nothing has worked," Mr.

Khan said. While there is no official update on the expected timeline of the travel ban being eased, Indian Ambassador to Italy Neena Malhotra on July 9 had a virtual meeting with community representatives where she briefed them about the efforts on seeking relaxations.

Move to hold CUCET for all Central varsities postponed

Admissions to be done as in previous years, announces UGC will still be conducted by the

The Centre has postponed its proposal to introduce a common entrance test for admissions to all 45 Central universities to 2022-23. Given the situation caused by the pandemic, all admissions to Central universities for 2021-22 will be done as in previous years, the University Grants Commission announced on Sunday night.

This comes as a relief for a section of students, especially Delhi University aspirants, who had pleaded for the continued use of Class 12 marks as the basis of admission even in a year when Class 12 board examinations were not held.

As in previous years, the Central Universities Common Entrance Test (CUCET)

Civil services aspirants to be heard today

consortium of 14 newer Central universities who already use it for their admissions, **Higher Education Secretary** Amit Khare told The Hindu. However, the proposal for CUCET to be conducted by the National Testing Agency for all 45 central universities has been shelved until next year, he said.

"All admissions will be done as in previous years. Those [Central universities] who used CUCET will use CUCET. Those who used their own entrance exams will continue to do so. Those who did admissions directly on marks basis will still use that," said Mr. Khare. He added that the NTA also has a full plate at this time as it is yet to complete the premier engineering and medical entrance tests JEE and NEET, which were postponed due to the second wave of the pandemic.

In March, 45 Central universities were told that the NTA would conduct the CU-CET for admissions to their undergraduate and postgraduate programmes this

Some universities had welcomed the development, saying that independently conducting entrance tests would be a challenge during the pandemic. However, some of the older, more prestigious institutions including Jawaharlal Nehru University, Delhi University and Visva Bharati University preferred to use their own unique admission processes, according to attendees at the March consultation.

J&K colleges to reopen in phases

The J&K administration on Sunday decided to allow onsite re-opening of higher educational institutions and skill development centres for the vaccinated population from July 31, in the wake of a significant dip in the number of cases in the past two months.

"Higher educational institutes and skill development centres may be considered from phased re-opening for on-site learning after July 31, subject to the vaccination status of the students and staff. The public and private educational institutions are permitted to seek personal attendance of limited vaccinated staff for administrative purposes," a government order said.

The second group are aspirants who managed to take the exam on October 4. These applicants, who are last attempters, have requested a one-time age relaxation to appear this year.



Taliban leader seeks 'political settlement'

"In spite of the military gains and advances, the Islamic Emirate strenuously favours a political settlement in the country," Akhundzada said in a message released ahead of next week's Id-ul-Adah holiday.

"Every opportunity for the establishment of an Islamic system, peace and security that presents itself will be made use of by the Islamic Emirate," he added.

China denies politics behind **UNESCO** move on Barrier Reef

A top Chinese official said on Sunday that political tensions between Beijing and Australia were not behind a UNESCO recommendation to place the Great Barrier Reef on its endangered list.

Deputy Education Minister Tian Xuejun is chairing the meeting of the UN cultural agency's heritage committee, which comes amid worsening relations between China and Australia.

The Great Barrier Reef has been put on a list of World Heritage sites that could be put on the in-danger list after losing half of its corals since 1995.

Australia has assailed the move, blaming global warming for the loss, while UNES-CO experts argued that polrun-off lution contributed to the loss.

When asked about "Australian government allegations" that Beijing pressed to have the Barrier Reef listed as endangered, Mr. Tian said the decision was based "on reports and data provided by Australia itself." "Australia should fulfil its obligations to protect world heritage sites instead of making baseless accusations against other members" of UNES-CO, he added. Both China and Australia are among the 21 nations on heritage committee, which is evaluating nearly 50 sites that could be added to its more than 1,100 World Heritage list.

Nepal's new PM wins confidence vote Deuba says combatting COVID-19 will

be the government's first priority

Nepal's new Prime Minister Sher Bahadur Deuba won a vote of confidence in Parliament on Sunday, days after the Supreme Court reinstated the legislature that was dissolved in May.

The 75-year-old, who has held the office four times before, won 165 votes - exceeding the 136 required – with 83 votes against him, Speaker Agni Sapkota said.

He faces the immediate task of procuring vaccines and controlling the spread of COVID-19, which the government says has infected 6,67,109 people and killed 9,550. Public health experts say an under-reporting of cases in the country means the figures could be higher.

Fewer than 4% of the country's 30 million people have been fully vaccinated against COVID-19. More than 1.3 million people, who have

had a first dose of a vaccine, are awaiting a second as the government scrambles to procure shots.

"Combating COVID-19 will be the first priority of the new government," Mr. Deuba said in Parliament.

The new government has pledged to vaccinate a third of its people in the next three months and every Nepali by next April.

Last Monday, the Supreme Court ordered Mr. Deuba be appointed premier in place of K.P. Sharma Oli. It ruled that Mr. Oli, who had been in power for three years, had breached the Constitution by dissolving Parliament. Mr. Oli, 69, says he had been unfairly removed by the court and has vowed to "go to the people" to explain his position.

O. I am planning to start SIP in the NPS Tier 2 account instead of investing in mutual funds. On redemption, how will the capital gains be

KUMARAVEL K.S.

Aarati Krishnan answers: NPS Tier 2 account offers an opportunity to choose from among equity, corporate bond and government bond options and is a very low-cost vehicle like the Tier 1 account.

The corporate and government bond options have also tended to beat comparable options from mutual funds. The corporate bond option invests mainly in high-quality bonds rated AA and above. However, the equity option has not managed to consistently beat benchmarks like the Nifty50. Do look at index funds as an alternative before opting for equity under the Tier 2 account. The NPA Tier 2 account is not specifically mentioned in the Income Tax Act. But given that the account offers no tax benefits on your contributions, some tax experts believe that your redemption amount will not be subject to any special restrictions. NPS being a market-linked vehicle, its maturity proceeds should be subject to capital gains taxation.

As NPS units are not chargeable to securities transaction tax, long-term capital gains will apply if they are held for 3-years plus and short-term capital gains, if held for a shorter period. The long-term capital gains tax rate would be at 20% with indexation benefits. But this is just an interpretation of the tax rules and could be subject to debate.

Q. I am 25 and work in a PSU bank. Recently, I received salary arrears payment in one lump sum on which a greater portion was deducted under the head 'Income Tax'. I am of the view that the deducted tax amount will be refunded by ITR filing. I want to know how far it is correct and how and on what basis it will be refunded. Also, in the present monthly-salary sheet, after an increase in salary, a portion of salary credited is also being deducted as income tax. Will this deduction in monthly salary be nullified by any investments in tax-saving schemes? If so, how much do I have to invest in tax-saving schemes? Also, will the deducted tax amount be refunded; and by when?

N. Sree Kanth answers: Your employer, the PSU bank, is obligated to deduct tax (known as TDS) on its employee's total income if the total income exceeds the taxable limits (above ₹5 lakh where rebate u/s 87A of the Income Tax Act, 1961 cannot be claimed). Depending on your salary structure, your employer will compute your tax obligation based on the slab rates after considering all the components such as deductions, exemptions, other income, rental income, among others, and deduct the same over the year at the time of disbursement of salaries each month

In case of arrears of more than 12 months' salary, wherein the salaries are assessed at a otherwise have been assessed in the respective previous years, relief under Section 89 of the Income Tax Act, 1961 can be claimed, for which you are to file form

If the arrears are less than 12 months' salary, the same will be included in your total income and the corresponding additional tax will be deducted from that. Usually, you have to declare your investments/spending that qualify for tax deduction to your employer so that the TDS is deducted accordingly and no excess TDS is deducted. At the end of the year, your employer will provide you with Form 16 which contains the particulars of your salary, corresponding tax liability and the TDS deducted over the year. Post that, you as an income tax assessee are required to file your respective ITR by incorporating these details along with any other income which will not be covered in your Form 16 such as capital gains.

In case you have missed out any, you may include the same at the time of filing your ITR and avail of the corresponding refund if it applies. You will be entitled for refund only if your employer has deducted TDS more than your tax liability and not otherwise. This may be on account of non-consideration of your deductions/exemptions. A few examples of deductions that you may avail of are: payment of life insurance premium for self, spouse and children; investing in ELSS, ULIPs, PPF and NSC among others, payment

of tuition fee for children etc. You may refer Chapter VI-A of the Income Tax Act, 1961, to further know the various exemptions and deductions that may be suitable to you and the corresponding

Q. My husband is a senior citizen and a regular income tax payer. For the assessment year 2021-2022, he plans to opt for 'yes' with IT Sec.115 BAC . In case he opts for 'yes,' can he get the benefit of deduction of ₹50,000 u/s 80 TTB, an additional boon

for senior citizens? LAKSHMI VISHWANATH

A. Under Section 115BAC of the Income Tax Act, 1961, deductions under Chapter VI-A cannot be claimed except Section 80CCD(2) and 80JJAA. Deduction under Section 80TTB falls under Chapter VI-A, thereby opting to pay tax under the new tax regime will restrict the benefit of deduction in respect of

Beware of new low-risk, HIGH-RETURN PROMISE

Products such as perpetual bonds may carry an aura of safety but in reality there is little to cheer

Sellers of equity products never fail to tell you that their products are subject to market risks. It is a different matter that you understand those risks only with experience. But when it comes to debt, risk is not the key word. After all, your debt investment is supposed to hedge your other risks!

In the past couple of years, sellers of debt products have become better at a narrative of high returns with no or least risk. Yes, we are talking of products such as perpetual bonds, market-linked debentures/covered bonds, home loanbacked bonds and even some of your debt funds.

At a time when your bank FD rates are at a low, a promise of disproportionate returns for low risks can be an easy lure for you. But at such times, it is best to get back to basics of investing: when you have a product that delivers far higher returns than your FDs, where from and how does that return come? Let us take a few examples to highlight the risks in such products and why the doctrine of 'buyer beware' is more important now than ever before if you are a retail investor.

Perpetual attraction

In 2019 and early 2020, perpetual or Additional Tier I bonds (AT1 bonds) issued by banks were sold to retail investors by the banks issuing them. What was the selling proposition? That AT1 bonds are high-return substitutes to bank FDs or nonconvertible debentures. But this promise was far from the truth. First, these products are allowed to skip interest payouts are poorly traded, or the inter-

if their Tier I capital falls below a certain level or they suffer losses or have insufficient reserves. They have no obligation to pay you later nor can they be sued for it. If that isn't a significant variation from your hum-

ble FD, here's more.

Second, although there is no maturity date, perpetual bonds were often mis-sold as limitedperiod bonds. These bonds only have a 'call option' and not a maturity date. This gives the borrower the right to redeem the bond at the end of, say, 5 or 10 years. But this is an 'option' and not a mandate. So, if you need the money any time, you will need to sell in the market. This can also be at a loss if they

est rate cycle is adverse.

The final nail is that the RBI can direct a bank to fully write off this bond (remember Yes Bank's perpetual bonds?) liability if it thinks the bank is at a point of non-viability (PONV) or requires capital infusion by another public sector bank to prevent going defunct. Yes, your principal can be written off and you will have no recourse. Now, this is worse than holding equity, where you can at least get a market price for your assets.

Safety illusion

A more recent popular product among retail investors are covered bonds/market-linked debentures/structured products. These alternative investment products, earlier made available only for risk-taking HNIs, are now being made available to retail investors, seemingly to provide them with 'access to high returning products.' Let's take the case of the now-popular covered bonds. These bonds, which are nothing but a pool of loans, are sold with the safety of an asset backing, typically property or gold - two assets that immediately provide

But if these bonds are safe, why are they paying you 10-11% returns as opposed to 6% in banks? So, here's what you will not know unless you dig in. The loan pool that is packaged to give you this bond typically

you with an illusion of safety!

comes from an NBFC that is not top-notch. Why do they need this money at such a high rate? Likely because they are unable to source funding through the regular channels or they come at a high cost. Why so? Because, these NBFCs do not have a high credit standing - with an A-rating or even BBB rating.

And, as you can guess, a lower-rated NBFC's pool of assets is unlikely to be made up of quality borrowers! But how about the property backing? Yes, that can be liquidated if your due is not paid. But wait, don't banks do this for a living and struggle to sell and monetise these assets? Is it not time consuming? Does that really provide you with greater sense of safety? And remember, there is no debenture redemption reserve. There is no ₹5 lakh deposit insurance here as in the case of a bank. Besides, the RBI may come to the rescue of a sinking bank but hasn't done that for a sinking NBFC! In other words, there is much to uncover before you can even look at a covered bond.

Then there are the ultra-rich, fancied market-linked debentures or MLDs (covered bonds can also have this feature) which simply means, your returns promised is contingent upon a given benchmark index remaining at a certain level. In other words, you may not even be paid interest if the index goes below a certain level. Much of what we mentioned about covered bonds applies here too. But the lure is this – MLDs enjoy equity taxation, simply because they are (seemingly) linked to the market!

I could go on adding to this list as these products are now being innovated at a fast pace when all other fixed income options return poorly now. In your fear of missing out (FO-MO), do not break the cardinal rule: if an investment product comes with the promise of higher returns, it also comes with the baggage of higher risks. In debt, this risk can not only mean just zero returns but also zero capital!

Active or passive? Why investment grammar is important

Choosing the right fund for investment can be an uphill task as several factors are at play

Your decision to choose investment products depends on vour investment objectives. Are you, for instance, investing to achieve a life goal or are you investing your surplus cash? This is important because you can give up significant liquidity if you are investing surplus cash. Whereas, you need liquidity if you are saving to achieve a life goal.

This week, we focus on your goal-based investments and delve into a related question: what factors should you consider before investing in active funds for your goal-based portfolios?

Alpha trade-off

Dhanlaxmi Bank

All of us like more money than less. So, our default choice ought to be active funds. These are mutual funds that strive to beat the benchmark index. The excess return that these funds provide over their appropriate benchmark is referred to as the An active fund alpha. Positive alpha is good for us; for excess return translates into more cash flows to achieve our goals.

There is another positive aspect to alpha. Suppose, the benchmark index returns minus 10% in a year and your fund generates minus 7.5%. You save 2.5 percentage points of loss on your investment.

But there is a trade-off. A fund manager has to take active bets to generate alpha. In an attempt to generate positive alpha, the fund could generate negative alpha returns, lower than the benchmark index.


That would lead to lower returns, translating into a shortfall in the amount you want to accumulate to achieve your goal. Can you simply buy a fund that has generated positive alpha in, say, the past five years? That would be a meaningful decision only if a fund that generated positive alpha in the last five years is likely to continue

exposes you to both active risk and market risk. A passive product such as an exchange-traded fund exposes you to only market risk

generating alpha in the future. The point is that alpha generation is dependent on two factors viz. skill and luck. The problem is that you cannot differentiate luck from skill.

Choice regret

A good portfolio manager can generate negative alpha because of bad luck whereas a not-so-skilful manager can generate positive alpha because of good luck. So, looking at only the alpha returns for the past five or ten years may not suffice. You have to also analyse the fluctuation in the fund's alpha over the years. Typically, greater the fluctuation, lower the confidence that the fund

Now, statistical analysis can only reduce the error of picking a wrong fund because luck is a factor in alpha generation. Besides, will you be able to continually engage in rigorous analysis to take decisions?

So, you have to apply a rule to narrow your choice to three or four funds before doing any analysis. It is possible that several funds you did not choose could outperform the fund you invested in. Two years ago, Kamalpreet I Kaur was in the 60m range but this season the discus thrower has hit a heady high. The 25-year-old, who could manage just 55.59m at the 2019 Doha Asians, broke the National record and bettered her personal best by more than five metres! That 66.59m throw has placed her sixth in this year's world list.

Every time the Olympics come around, many Indian athletes raise their performance magically and become world class. This time too, despite COVID-19 messing up their foreign trips and much of training, the athletes have pleasantly surprised everybody by making the cut for Tokyo in a number of

Record-breaking deeds

When the entry standards for Tokyo were announced, many felt that very few would qualify as athletes needed to break National records in almost all events. Surprisingly, they did just that.

Nine of the 16 qualifiers in individual events have broken National records this year and while 12 achieved

Javelin thrower Neeraj Chopra could end indepen-

dent India's long wait and could even return with a silver if he is at his best. A shoulder sprain spoiled his hopes of making it to the last Olympics but a few days after the entry doors closed, Neeraj won the under-20 Worlds gold with a junior world record throw that would have

fetched him a bronze in Rio. He missed the 2019 Doha Worlds after an elbow surgery but early this year, Neeraj raised his National record to 88.07m which placed him fourth in the world list.

German Johannes Vetter, who produced a series of 90plus throws (season best 96.29m) but whose two recent meets ended meekly (85.25m and 86.48m), is the favourite for the gold while Marcin Krukowski (89.55m), 2012 Olympic champion Keshorn Walcott (89.55) and Gatis Cakss (89.12) will give the Indian a fight.

Other contenders

Long jumper M. Sreeshankar, shot putter Tajinderpal Singh Toor, steeplechaser Avinash Sable among men and javelin thrower Annu Rani and Kamalpreet should also make the final if they repeat their season's best.

Of the two 4x400m relays, the men have a better chance of entering the final than the mixed.

But then, though quartermiler Amoj Jacob improved stunningly with every meet, national record holder Muhammed Anas has run the individual 400m in just one meet while another star Noah Nirmal Tom has not run any. That makes predictions difficult. And the mixed team is without any of the leading girls.

There's a nice little aste-I risk every time Norman Pritchard's name is mentioned in Olympic record books that should make every Indian miss a heartbeat.

It's more than 120 years since Pritchard won two silver medals, in 200m and 200m hurdles, at the second Olympics in Paris in 1900 but nobody is sure whether the Calcutta-born Pritchard represented India or Great Britain.

little over a month ago, Fouaad Mirza was a relieved man. Fouaad had finally sealed India's lone equestrian Olympic berth, after overcoming several hurdles along the way.

Fouaad was affected by multiple lockdowns in his base at Germany, and was also forced to keep his horse Dajara 4 in quarantine after an outbreak of Equine Herpes Virus.

As the Olympic qualification deadline fast approached, Fouaad was desperate to gain the Minimum Requirement (MER) needed to book a Tokyo spot. That several qualifying events were cancelled due to the COVID-19 pandemic only made his task

The breakthrough came in May, when Fouaad achieved the necessary MER on both his horses, Seigneur Medicott and Dajara 4, in the CCI44*-Long eventing competition in Baborowko (Poland).

Verstappen crashes out after a first lap collision

Lewis Hamilton won his home British Grand Prix for a record-extending eighth time on Sunday despite a 10 second penalty for a first lap collision that sent Red Bull rival Max Verstappen crashing out of the race. The Dutchman was taken to hospital for precautionary tests.

The win was the 99th of seven-time World champion Hamilton's career.

The Mercedes driver, now only eight points behind Verstappen after 10 races, passed Ferrari's Charles Leclerc for the lead with two laps to go.


