9 killed as boulders hit vehicle following Himachal landslip

Bridge in Kinnaur district collapses due to impact

Nine tourists were killed after heavy boulders fell on their van following a landslip near Basteri in Kinnaur district of Himachal Pradesh on Sunday

Multiple landslips triggered by recent rain occurred near Basteri on the Sangla-Chitkul road at 1.25 p.m., resulting in a bridge collapse and damage to some vehicles, the police said. A video of the incident, which has gone viral on social media, shows several boulders rolling downhill and smashing into the bridge, causing it to collapse.

According to the police, nine persons died and two were injured after heavy boulders fell on the van. The passengers were going to Sangla from Chitkul.

In a similar incident, a pedestrian was injured in another landslip in Kinnaur district, they added.

President Ram Nath Kovind and Prime Minister Narendra Modi expressed condolences over the death of people due to the landslips in Kinnaur.

"Deeply saddened by the news of the death of many people in a landslip in Kin-

naur, Himachal Pradesh. Express my deepest condolences to the bereaved families and wish the injured people a speedy recovery," Mr. Kovind tweeted in Hindi.

Mr. Modi said all arrangements were being made for the treatment of those injured and announced an ex gratia of ₹2 lakh each for the next of kin of the deceased and ₹50,000 to the injured from the Prime Minister's National Relief Fund.

Chief Minister Jai Ram Thakur also expressed grief over the deaths, and asked the district administration to carry out immediate relief and rescue operations.

mated that the death toll in the State had risen to nearly 130 with the recovery of nine more bodies in Taliye village in Mahad (taking the toll there to 45) and seven more in Posare village of Ratnagiri district. Around 80-100 persons (including more than 30 in Taliye) are still believed to be missing in the flood-hit districts, including Raigad and Khed.

Excess deaths in West Bengal 11 times official COVID-19 tally

Difference in numbers seen in both first and second wave

The number of "excess deaths" registered by the Civil Registration System (CRS) in West Bengal ever since the COVID-19 pandemic hit (from April 2020 to May 2021) was an estimated 1,20,227, which is 11.1 times the official reported figure of 10,787 deaths for the same period.

Five districts - Darjeeling, Jhargram, Kalimpong, North 24 Parganas and Paschim Medinipur – were not considered for this analysis as either the online registration data was incomplete for all years (Darjeeling and Kalimpong) or for some years, 2018, in particular (Jhargram, North 24 Parganas and Paschim Medinipur).

The high multiple of excess deaths over the CO-VID-19 toll was a characteristic of both the first wave in 2020 and the more lethal second wave in 2021.

The "excess deaths" figure for April to December 2020 of 64,520 was 9.4 times the COVID-19 toll (6,833) while the same for 2021 (55,207) was 14.1 times the COVID-19 toll (10,787).

In April and May 2021 alone - a period that coincided with election in the State - there were 51,353 "excess deaths", 14.4 times the official COVID-19 death Missed count? Excess deaths, calculated as the difference between the registered deaths in the pandemic period (Apr 2020 to May 2021) and the average of those registered in 2018 and 2019 for the same months were 8.2 times the official COVID-19 tally for these eight States listed

The figures were arrived at from data on deaths registered month-wise in the online Civil Registration System from January 2018 to May 2021 in West Bengal and accessed by The Hindu. Data for Kolkata was added to the tally from the Kolkata Municipal Corporation figures.

As with other States, not all excess deaths could be related to COVID-19 but a bulk of them will be during the

pandemic period.

The estimated undercount factor of 11.1 for the State (without five districts in the analysis) is higher than the factor for States such as Haryana (7.3), Tamil Nadu (6.4 adjusted to 4.4 if CRS COVID-19 tally is considered), Karnataka (4.3) and Kerala (0.42 based on reconciled COVID-19 tally) but is lower than that for Madhya Pradesh (23.8) and Andhra Pradesh (17.9) if the same baseline is considered (deaths registered in 2018 and 2019).

CPI(M) MP moves SC for probe into snooping

Govt. response evasive, says Brittas

Rajya Sabha member John Brittas has moved the Supreme Court for a courtmonitored investigation into allegations of snooping on activists, politicians, journalists and constitutional functionaries using the Israeli spyware Pegasus.

The parliamentarian said the government's response in the House to the allegations was "evasive".

Mr. Brittas, a Communist Party of India (Marxist) MP, said allegations pointed to a "critical invasion into privacy". It actually amounted to a "cyberattack" on citizens. He termed Pegasus a "weapon" used to "hack" into private smartphones to cause a chilling effect on free speech and expression.

ly response from the Centre was a statement by IT Minister Ashwini Vaishnaw in the Rajya Sabha that "time-tested processes in our country are well-established to ensure that unauthorised surveillance does not occur". Mr. Brittas asked the

court whether the statement meant if the surveillance was authorised by the government. Telangana temple gets World Heritage tag

In a diplomatic triumph, 17 countries back India's proposal despite ICOMOS verdict

In a major diplomatic triumph, the 13th century Ramappa temple in Palampet, Telangana, was declared as a UNESCO World Heritage Site on Sunday. At the ongoing online meeting of the World Heritage Committee (WHC) in Fuzhou, China, the decision was reached after a consensus, with Norway opposing the inscription while Russia led an effort for the immediate inscription of the temple at 4.36 p.m. IST. A consensus with 17

countries backing the move ensured the inscription. The nomination for a

World Heritage Site for the Ramappa and Kakatiya temples was made in 2014. The site was in the reckoning for inscription in 2020 but the WHC meeting

Senapati Rudrayya, a general of Kakatiya king Ganapatideva, in the 13th century, the main temple is flanked by the collapsed structures of the Kateshwarayya and



Kameshwarayya temples in Palampet, about 220 km from Hyderabad.

The temple, known for its exquisite craftsmanship and delicate relief work, is a savvy blend of technical know-how and materials of its time. The foundation is built with the "sandbox

technique", the flooring is granite and the pillars are basalt. The lower part of the temple is red sandstone while the white gopuram is built with light bricks that reportedly float on water.

Earlier, the International Council on Monuments and Sites (ICOMOS) cited nine shortcomings at the site after an initial visit in 2019, but on Sunday a majority veered round to India's view about the site's outstanding universal value.

Norway was the only country which opposed the move citing ICOMOS's conclusion.

India mounted a diplomatic offensive to ensure the World Heritage Site status for the Ramappa temple by reaching out to other countries whose representatives were to vote on the proposal.

Metro, buses to allow only sitting travel DMRC issues clarification, says only 50 passengers will be allowed in each coach

The Delhi Metro and city buses will run at '100% seating capacity' from Monday, after the Delhi government eased some COVID-19 restrictions. However, long queues outside metro stations and bus stops during peak hours are likely to continue as passengers will not be permitted to stand inside buses or metro coaches.

Confusion over new rules The Delhi Metro on Sunday clarified that only 50 passengers will be allowed to sit in each coach and entry to stations would continue to be regulated. Several sections of the public are under the impression that the metro will be operating at 100% capacity - this is not the case, the Delhi Metro Rail Corporation said in a statement.

Te are not going to leave this place, not until the government makes an arrangement for us. We have lost all our savings and now have nowhere to go," says Vijay Prajapati, 35, a daily wager, staying at Khori Basti for over a decade.

The local municipal body, following the directions of the Supreme Court a month ago, has razed a majority of the houses in this 170-acre colony spread across Delhi and Haryana on the forest land. Most of its inhabitants – the migrants from across the country engaged in menial jobs – have covered the remnants of their partially demolished homes with plastic covers to continue to live in them and are reluctant to leave.

Families with elderly members, pregnant women and even newborns are determined to stay put under the open sky with the intermittent rain leaving their clothes and beddings drenched and power and water supply snapped for almost a month now.

"We have a little choice," says Raman Chaudhary, a native of Bihar, who too lost his home in the demolition drive four days ago, but decided to stay back with his family, including aged parents, wife and two children. He says he had bought the plot for ₹1.5 lakh more than two decades ago, and now staying in tents on the same plot.

Chander Shah, a painter, says that most of the people in this colony have been jobless for over a year due to the pandemic and are on the verge of starvation. "We would prefer to die here than to move out. Had we encroached upon the land, we would not have felt the pain. But we

had bought it with our hardhe adds.

Habiba Parvin, 27, alleges that the police did not even allow them enough time to remove their belongings and demolished their home and shop. She says that her husband, when protested, was arrested on charges of preventing the government officials from discharging their duty. Her family has been staying in the colony for two decades now and recently bought another 120 sq m plot for ₹5 lakh.

"My husband is in jail. I have all my belongings. I am the most unfortunate," says Habiba.

Many have rented rooms

their expensive belongings, such as television and refrigerators, but continue to stay in the colony with bare minimum essentials.

Sitting amid the rubble of her home with her belongings pushed under a plastic cover hung across a wooden plank to resemble an improvised tent, Bimlesh breaks down and says that the trees that they had planted and raised are their only companions in this time of adversity. "No one has come to help us. Neither the administration nor the netas [politicians]. These trees are our lone companions offering us shelter and shade," says the 48-year-old, adding that they had been surviving only on tea and bread for a couple of days.

Her husband Bhola Singh, a

private security guard, adds that at least one member of the family would continue to stay at the site of their demolished home even after they move to a rented room.

Rehabilitation policy

The couple had gone to the camp to apply for the government's rehabilitation policy for the Haryana residents but did not have the requisite documents. Bimlesh holds a voter identity card for Haryana, but her husband and son have identity proofs for

"The staff at the camp told us that the entire family should have the identity cards for Haryana. I don't think the government will find more than 700-800 people eligible for the policy after the scrutiny," says Bhola.

But not many seem enthusiastic about the government's rehabilitation policy for different reasons. Though Bimlesh and her husband went to apply for the flats offered under the policy, the couple said that it was difficult to find any work in its neighbour-

"The Dabua colony, where the flats are located, is around 15 km from here. There are no jobs for daily-wagers in that area. You need to have a two-wheeler to commute for work," says Bhola.

Chander says the rehabilitation policy is nothing but an attempt by the government to "loot" them by offering more than a decade old flats in ruins. He says the government is trying to "extort" money from the poor by selling off its flats in the name of rehabilitation and make them tenants for another 15 years.

"Instead of the flats, we would prefer the government to compensate us monetarily for our loss," suggests Bhola.

Dhansa metro station to adorn cultural artwork

The Delhi Metro on Sunday said the upcoming Dhansa Bus Stand Metro station on the Dwarka-Dhansa Bus Stand Grey Line corridor will be a reflection of south-west Delhi's "deep cultural roots". It said the station will be adorned with artworks and photographs displaying the rich heritage, culture, flora and fauna of the suburban locality.

The Najafgarh-Dhansa region of south-west Delhi is rich in historical content and is also home to a marshy ecosystem, which encourages the visit of migratory birds and flourishing of local wildlife. The artworks and photographic displays have tried to capture such unique characteristics of the area, the DMRC said. The decoration of the station has been done in line with DMRC's efforts to utilise its premises as a platform to showcase the rich heritage and culture of the nation.

The approximately 1km-long Najafgarh-Dhansa Bus Stand corridor is ready for operations after receiving the mandatory approval from the Commissioner of Metro Rail Safety. The DMRC said the exact date for the opening of the corridor shall be intimated shortly.

The artworks on display at the metro station will include photographs on printed glass panels, showcasing the rich biodiversity of the area and the various migratory birds that visit the jheel waterbody located bet-Najafgarh and Dhansa.

⁺ Nine held for looting man of ₹30 lakh

Nine people have been arrested for allegedly loot ing a businessman of ₹30 lakh in north-west Delhi's Pitampura, the police said on Sunday.

The five men involved in the dacoity - Rajat (21), Santosh (24), Deepak (23), Parvez Siddiqui (24) and Sameer (25) - have been arrested along with the four conspirators -Zafar (25), Rakesh (26), Vikas (26) and Sumit (21), they said.

The entire cash has been recovered.

The incident happened on July 5 when Parveen Jain and his two other staffers were present at their office. At 2.30 p.m., four unknown men entered his office on the pretext of checking rice samples and took cash and mobile phones from them at gunpoint. Next, they sped off on motorcycles.

CCTV footage

The incident was captured on CCTV camera. On analysing the CCTV cameras installed at the routes taken by them, the police said they found out that the accused had come from Kirari, Suleman Nagar side.

The police noted the registration numbers of the two motorcycles used in the commission of crime.

Deputy Commissioner of Police (North-West) Usha Rangnani said through local intelligence, accused Vikas and Sumit were arrested, and the two motorcycles were recovered. Next, the rest of the accused were held.

The police said four knives and a countrymade pistol along with two live cartridges were also recovered from their possession.

Ahead of I-Day, MHA orders strict vigilance to prevent drone attack

Order details set of preventive measures to be taken by all district DCPs

After a recent drone attack in Iammu and several other instances of drones entering prohibited zones, the Ministry of Home Affairs (MHA) instructed all security agencies to be extra vigilant about such flying objects ahead of Independence Day celebrations.

The MHA has ordered stricter adherence to the Standard Operating Procedure (SoP) that was framed to handle threats from Sub-Conventional Aerial Platforms like drones, paragliders, microlight aircraft, hot-air balloons etc. The order details a set of preventive measures to be taken by all district DCPs, precautions while shooting down any Sub-Conventional Aerial Platforms and if the flying object try to land near the rampart of Red Fort.

'We have identified the buildings near Red Fort where policemen with longrange weapons will be deployed to shoot down any flying object approaching restricted space," said a police

The SoP mentioned shooting the object if it tries to go near the sensitive area. It reads that if any object approaches the sensitive area, then wave a red flag to draw its attention and indicate it to land at a safe distance away from the vital installation or sensitive area. Shout on the loud hailer to draw its attention and instruct it to land immediately, failing which it will be shot down. The order states that if it does not follow the instructions, and there is no time to seek instructions from superior officers or seek clarification from the Indian Air Force agencies, the security personnel may shoot at it with the intention to de-capacitate the individual/aerial

vehicle. In the SoP, DCP of North

District - under whose jurisdiction Red Fort falls - may identify building's rooftops from where the entire aerial view of the district can be seen. Watchers should be deployed on these rooftops.

Trained manpower on rooftops around the sensitive locations and on the route of VVIP movements to prevent anybody from taking off from such platforms, read the order.

These personnel shall be equipped with wireless sets, binoculars, red flag mounted on a stick and a loud hailer. "Each identified roof-top watcher should be accompanied by well-trained police marksmen equipped with a long-range weapon to bring down the flying object, if required," it reads. The other district DCPs have been instructed for special patrolling particularly in the rural areas of Delhi, long stretches of lesser-used roads and bridges, large grounds to keep a watch on any such attempts of flying Para Motors.

IAF is responsible to identify between 'friendly' and 'unknown' airborne objects and initiate appropriate 'tactical action' to destroy the object, if it is declared 'hostile', the SOP reads.

It instructs district DCPs to activate human intelligence as it is the most reliable way to prevent such an attack. Beat constables should be trained to deal with such objects when they see it in the air or near vital installations/ sensitive areas.

Illegal call centre busted, 12 held +

They duped people on pretext of getting them jobs in airlines

A call centre racket was busted and 12 people were arrested for allegedly duping over 100 job seekers by promising them employment in a private airline, the police said on Sunday.

Surjeet (24) and his accomplice Sundaram Gupta (25) set up the illegal call centre on the third floor of a commercial building in Ghazipur village.

They also hired 10 employees on monthly salaries ₹6,000-₹9,000.

The police initiated a probe following a complaint from Indigo that stated many people were being cheated in the name of getting employed in their airline.

The police claimed the accused duped hundreds of people mainly from south India, Bihar, Uttar Pradesh and Uttrakhand. The accused also gave them forged appointment letters of Indigo Airlines and collected over ₹10

The Public Works Department (PWD) has been tasked with the project under which it will install the national flag on 100-feet high poles at 500 locations in the city.

The officials said initially they will install high-mast Tricolours at about five locations in as many constituencies as a sample exer-

HC to hear petition against Ramdev for 'spreading misinformation' amid COVID

The Delhi High Court will hear on Monday a plea by seven doctors' associations against Yoga guru Ramdev for allegedly spreading misinformation by his statements against allopathy amid the ongoing COVID-19

Being a highly influential person, it is apprehended that Ramdev's statements can influence lakhs of people and divert them from allopathic treatment which are prescribed as the standard form of care even by the government, the plea submitted.



HC relief to homebuyer from loan recovery

'Bank has disbursed amount to builder'

STAFF REPORTER NEW DELHI

The Delhi High Court has granted interim protection to a homebuyer of 'Shubhkamna City' residential project in Greater Noida West against a loan recovery proceedings initiated by a bank.

While staying the proceedings pending before the Debt Recovery Tribunal (DRT) in Delhi, initiated by Bank of Maharashtra, a Bench of Justice Vipin Sanghi and Justice Jasmeet Singh said: "In our view, prima facie, it appears that the petitioner [homerbuyer] has been taken for a ride by the builder and it is not the petitioner who has received the

loan amount." "The bank has disbursed the loan amount to the builder, and in these circumstances, it remains to be seen as to whether or not the petitioner is at all liable," the Bench said.

The court's direction

came on a plea by Hridesh Kumar Pathak, who booked a unit in the 'Shubhkamna City' project developed by Shubhkamna Buildtech Private Limited in 2016. As per the buyer builder agreement executed in October 2016, the possession of the flat was to be delivered within 45 months, including a grace period of six months, after commencement construction.

Flats not constructed

Advocate Anshul Gupta, representing Mr. Pathak, submitted that the homebuyer and the builder entered into and executed a tripartite agreement in January 2017 with Bank of Maharashtra for the sanction of loan amounting to ₹32.5 lakh in order to finance the purchase of the flat. The bank has disbursed a total amount of ₹27,63,000 towards the builder. However, the flats have not been constructed.

Justice Mukta Gupta gave the order while hearing ED's plea challenging a trial court's order directing it to supply a copy of the Enforcement Case Information Report (ECIR) to RJD Rajya Sabha MP Amarendra Dhari Singh, arrested in a money laundering case related to an alleged fertiliser scam.

The court also issued notice to Mr. Singh on ED's plea seeking to set aside the trial court's July 15 order.

Additional Solicitor General S.V. Raju, appearing for ED, argued that there is no specific power with the trial court to pass directions to the agency to supply the co-



py of the ECIR. The ASG stated that no prejudice has been caused to Mr. Singh by "non-supply of the ECIR, which is not like an FIR on the basis whereof investigation is started".

The court, however, directed the Director of ED to submit whether the ECIR "is merely a number or records some substantive information therein for the petitioner (ED) to start the investigation thereon prior to filing of the complaint case".

The case pertains to an alleged fertiliser scam linked to the IFFCO and India Potash Limited.

With Godavari in spate, A.P. issues first flood alert

10 lakh cusecs of water being discharged

The authorities issued the first flood warning for the Godavari in Andhra Pradesh on Sunday as the discharge of water reached about 10 lakh cusecs at the Sir Arthur Cotton Barrage in Dowleswaram by 7.30 p.m.

Issuing the warning, G. Srinivasa Rao, Godavari River Flood Conservator and Godavari Head Works Division executive engineer, said, "However, the forecast indicates a fall in flood level by Monday."

The first warning alert would enable district authorities to gear up for the flood mitigation exercise, particularly downstream Dowleswaram.



Haryana withdraws order on land consolidation in Kot village

It's for the 4th time in 9 years that consolidation orders were given, rolled back

More than two years after the Haryana government ordered the consolidation of 3,184 acres of land in Kot village in Faridabad amid strong opposition from the locals and the environmentalists, the controversial orders have now been withdrawn.

Those opposed to the consolidation then had argued that it was illegal and aimed at benefiting an influential yoga guru owning large chunks of "Gair Mumkin Pahaar" (non-cultivable land) in the village.

It is for the fourth time over the past nine years that the government ordered the consolidation of the Kot village land, but then withdrew the orders.

Withdrawing the latest orders for consolidation issued on February 1, 2019, the Director, Consolidation of Holdings, Haryana, said that "in case the consolidation exercise... is carried

Welcoming the withdrawal, Kot Sarpanch Mundresh Devi's husband Kesar, in the forefront of the fight against the consolidation process, said the villagers had written to the Prime Minister's Office, Union Home Minister and Chief Justice of India, among others, over the past two years seeking to stop the consolidation and were "happy" that they

were heard. "The consolidation was aimed at benefiting the yoga guru to usurp the forest land. Most of the villagers rear cattle and need forest land for the grazing of the animals. The consolidation would have hit us hard. Now we demand that the illegal structures and boundaries constructed in the forest land be demolished to free it from encroachment," said Mr. Kesar.

Chetan Agarwal, a forest analyst, said this was for the fourth time the consolidation process was stopped on grounds of misuse to create plots in the Aravalis and forests. He expressed hope that it was also for the "final time" that the orders were withdrawn.

Lt. Colonel (retd,) Sarvadaman Singh Oberoi, an environmentalist, said the consolidation process had been misused in Aravali villages like Mangar, Bandhwari, Ankhir, Mewla and Maharajpur etc. to create private plots and must be rolled back.

A climate risk

Only proper planning can insure against the inevitable extremities of nature

The monsoon is nearing its halfway mark and July, which is among the rainiest months, began with a rainfall deficit but has since seen a revival. For most of last week, all-India rainfall has been over 50% more than what is normal for this time of the year. Many regions in the Konkan coast and the southern peninsula have been seeing instances of extreme rainfall. According to India Meteorological Department (IMD) data on the regional distribution, the 'South Peninsula' has seen 29% more rain from June 1-July 25 than what is normal for this period. Rainfall in Mahabaleshwar, Maharashtra, was torrential enough to beat its all-time record, according to the IMD. The monsoon is characterised by unexpected variability that forecast models can capture only in a limited way. However, much evidence is accumulating that there is a distinctive change in climate patterns. The frequency and the strength of cyclones over the Arabian Sea have increased in the last two decades. There has been a 52% increase in the frequency of cyclones over the Arabian Sea from 2001-2019 and an 8% decrease over the Bay of Bengal compared to 1982-2002, when, historically, most cyclones have been in the Bay of Bengal, according to a new study in Climate Dynamics.

Even the duration of these cyclones has increased by 80%. More cyclones are bringing in more moisture from the Arabian Sea and contributing to extreme rainfall events over the western coast, the most recent example being cyclone Tauktae in May, which at 185 kilometres per hour was among the strongest cyclones to approach Mumbai. They drive storm surges that flood the coast. Studies show that a heating globe has increased atmospheric moisture levels, contributing to short, intense spells of rains. The interaction between warming, rainfall and temperature is complex and variables such as aerosol emissions, particulate matter pollution, agriculture and forestry patterns must be accounted for. However, the broader picture is that extreme events - bursts of torrential localised rainfall and prolonged droughts and heatwaves - are likely to increase, making the role of accurate forecasts that are able to warn of such events at least three to five days ahead even more important. But the bigger challenge is to undertake so-called climate-proofing of the most vulnerable regions and taking warnings of scientific risk assessment seriously. Evacuations ahead of a flood or a cyclone are not always effective and what is needed is limited construction in places that have been marked vulnerable. Just as it is possible to plan earthquake-resilient structures and site them scientifically, but hard to anticipate a major quake, similarly, proper planning can insure against the inevitable extremities of nature. International climate change agreements to limit greenhouse gas emissions will yield benefits only in the very long term but what is done in the near future will mean the difference between surviving and thriving.

Money changer

India needs to move forward on introducing an official digital currency

In contrast to India's continued ambiguity over the legality of cryptocurrencies, its stance on introducing **▲** an official digital currency has been reassuringly clear and consistent over time. And, four years after an inter-ministerial committee recommended that India launch fiat money in digital form, the Reserve Bank of India has indicated that pilot projects to figure out its viability are likely to be launched soon. In a speech a few days ago, T. Rabi Sankar, Deputy Governor, RBI, said, "RBI is currently working towards a phased implementation strategy and examining use cases which could be implemented with little or no disruption." The clarity is welcome, given that the much-awaited Cryptocurrency and Regulation of Official Digital Currency Bill, 2021, is yet to be introduced. In recent years, the significant rise of private cryptocurrencies such as Bitcoin and Ether has spooked central banks throughout the world, and pushed the case for official digital currencies. Mr. Rabi Sankar himself cited a 2021 BIS survey of central banks, which found that 86% were actively researching the potential for such currencies, 60% were experimenting with the technology, and 14% were deploying pilot projects. China, having already engaged in pilot projects for its digital RMB, is in fact planning a major roll-out soon. There has been little doubt, therefore, that India needs a digital rupee. The important questions are about the details and the timeline.

There are crucial decisions to be made about the design of the currency with regards to how it will be issued, the degree of anonymity it will have, the kind of technology that is to be used, and so on. It is possible that the question of the degree of anonymity, especially, will be quite a challenging one. While official digital currencies can borrow the underlying technology feature of private cryptocurrencies, they significantly differ from the latter in their philosophy and goals. Also to be considered are possible impacts of the introduction of an official digital currency on people, the monetary policy, and the banking system. There are risks to be considered as well, not the least of which will be those emerging from cyberattacks. What is more, many laws need to be amended to make the digital rupee a reality. So, while India might have done exceedingly well in digital payments in recent years – the Deputy Governor said they have grown at a compounded annual growth rate of 55% over the last five years – the digital rupee will be something else altogether. Notwithstanding all these challenges, it would seem that the answer to Mr. Rabi Sankar's speech title, 'Central Bank Digital Currency - Is This the Future of Money', is a yes.

Joining the dots in the second coming of Pegasus

This time, Pegasus shines a light on the Government for civil society to see it as a clear accountable entity

egasus is not a stranger to our shores. It first surfaced in our public discourse towards the end of 2019. Researchers from University of Toronto's Citizen Lab called up some telephone numbers in our country and informed them that their WhatsApp chats were compromised. There were some stirrings, but the controversy died out quietly and disappeared from our public discourse. The attention then was predominantly on the issue of how secure WhatsApp was and how weak its claims of end-to-end encryption were. WhatsApp's public relations exercise to reassure its customers of its safety and privacy grabbed disproportionate attention. All these deflected the puattention from Government's involvement in the ugly saga and the misuse of NSO of Israel's spyware to snoop on its own citizens. Parliament and civil society let the Government off easily. Perhaps, the impression that the surveillance then was largely confined to the Bhima-Koregaon happenings also contributed to its limited appeal.

Signs of a surveillance state

Most of us failed to connect the dots. The frequent and prolonged instances of Internet shutdowns; use of the sedition law on critics of the Government's policies; use of the Unlawful Activities (Prevention) Act (UAPA); rushing of crucial pieces of legislation affecting core sectors of our economy through the Houses of Parliament; consigning the data privacy Bill to a select committee; the framing of rules to rein in digital news platforms, and the demonic efficiency with which State governments were toppled appeared less dramatic and had no shock value as unconnected events. But if connected with each other, and the

background, they present a picture of India's descent into a surveillance state.

Treated separately, each one of those incidents, caused little more than a few days of screaming headlines, reprimanding editorials, raucous prime-time television debates, weak and short-lived protests by political parties and rights activists. The probability that the second coming of Pegasus into our political discourse will not be very different from its first appears very real, if this too is treated as a separate and isolated event. Fortunately, this time it came with two major differences.

The targets now

This time the attention is exclusively on the Government's role and there are no red herrings in the form of questions about the safety of encryptions offered by service providers. The people involved in the revelations are not just little known activists. They range from the Leader of the Opposition, a constitutional authority, a number of journalists, human rights activists, Ministers in the Government, ruling party leaders, several political leaders, serving or retired officers. The list also revealed that the government agencies made no distinction between state interests and the interests of the ruling party. The expansiveness of the global list of people named as intended targets of the spyware and the prestige of publications involved in cross-border collaboration are indeed arresting.

Pegasus's second coming has yet another distinction. It foregrounds the collusion between government and weapons grade surveillance tech that has no intermediary functions to confuse us. The episodes that were hitherto played out as government versus tech in our country allowed the combatants to compete for our support. The government and the tech companies claimed to fight one another on our behalf. However, they were actually fights between tech and government for possession and control of our data. Government sought its possession to control society, to elimi-



tried to portray to us that it sought to tame the tech companies to protect our interests, privacy, and the security of the realm. Tech companies sought to possess our data sets to make prediction products out of them and sell them to advertisers. Both the Government and tech companies vied for surveillance over us. One for control and the other for profits. However, there is always the undetected possibility of their interests coalescing. In the case of Pegasus the collusion is evident. The NSO Group does not compete with the Government for the possession of data surplus of its application. It is a pure and simple provider of surveillance-as-a-service to the Government. In the event, Pegasus this time shines a light on the Government for civil society to see it as a clear accountable entity.

Government stonewalling

It is evident that the Indian government till now is acting out of a standard play book. It is stonewalling. It has so far evaded the essential questions that are raised by the revelations. Ministers and representatives of the ruling party are questioning the credibility of claims made by the global consortium of media organisations that announced the startling revelations. They are accusing the publications of acting with ulterior motives to undermine India's democratic institutions. Supporters of the Government's narrative charge the publications with attempting to defame the country. The Government's, and its supporters', defence so far is essentially semantic quibble and based on raising doubts on the source of the telephone numbers that the media consortium says is from a leaked list accessed by media portal For-

The uncommonly cautious wording of the preface to the consortium's admittedly limited claims to their findings is sought to be used to undermine the extraordinary significance of its revelations. The consortium desisted from making sweeping claims. It said, the leaked list of 50,000 numbers "are believed to have been selected as those of people of interest by government clients of NSO Group". The consortium also said that the list "indicates the potential targets" identified in advance by the NSO's clients for "possible surveillance". The list is only "an indication of intent" and the appearance of a number in it does not reveal "whether there was an attempt to infect the phone" or "whether any attempt succeeded".

But amidst all this extraordinary caution is this devastating revelation which the Indian government chooses to deliberately ignore to indulge in semantic wrangling: "However, forensic examination of a small sample of mobile phones with numbers on the list found tight correlations between the time and date of a number in the data and the start of Pegasus activity - in some cases in as little as a few seconds." Amnesty International's forensic lab found that of the 67 phones examined, 23 were infected and 14 showed signs of attempts to penetrate. The rest were cases of possible change of devices or those using the Android operating system that did not keep record of logs needed for forensic work. By any standard this is considered an overwhelming basis for further investigation. It establishes an unquestionable basis for subjecting all the rest of the numbers from the list of 50,000 numbers for investigation. And in India's case, all the 300 numbers from the country that were found in the list. Already, over 10 of them were forensically examined and found to be either successfully infected by Pegasus or attempted to be penetrated. That is enough of a case for a comprehensive investigation into the claims of the media consortium. But the Government narrative

tive,' 'possible' and 'potential' as being too general and dismisses snooping charges.

The Indian government's defence that rests on questioning the source of the list has little merit. Investigative journalism is under no obligation to reveal its sources. In fact, it is ethically bound to not reveal in order to protect the identity of its sources.

As important as the questions that the Government forcefully articulates is its remorseless stonewalling of the most important question repeatedly asked of it. It does not tell us in unequivocal terms whether it has or has not purchased the Pegasus spyware. It did not answer that question during the country's first brush with the spyware in 2019 too. Even today it seems to be firm in its resolve not to answer. It hopes to wear down the political opposition, activists, human rights groups, and civil society. It evidently thinks that it can wait out the news cycles to run their course. It probably can. Civil society and the media, cannot, beyond a point, keep the pressure on. A government with brazen determination, brute majority in the legislature, and as yet unchallenged political capital, can afford to wait out the limited firepower of its political opponents' artillery.

Judiciary as bulwark The only institution in the present situation that can make the Government accountable is the judiciary. The track record of our top court on major issues of defining importance to our national life is at best mixed in the recent past. What it chooses to do or not do now can make a difference to India. The options before it are clear as they are stark. To allow the present government a free run in turning India into a surveillance state is one. The other is to stop the Government in its tracks, restore to its people the gift of a free and liberal state that the founding fathers of the Republic gave them. The country has very little time.

Getting India's military convergence formula right

For genuine military jointness, a blending of minds and tailor-made solutions are critical



The Chief of Defence Staff General Bipin Rawat's recent description of the Indian Air Force (IAF) as a supporting arm in an interview on July 2 – and the IAF chief Air Chief Marshal R.K.S. Bhadauria's rebuttal, is the newest bump in the turbulent journey marking the reorganisation process of the armed forces. Unfortunately, this bump, probably caused by misinterpretation of an oversimplification by the Chief of Defence Staff, comes just when the process appears to be touching down after being airborne for long. Whatever the cause, the differences do not speak well of the intellectual underpinnings of the reorganisation process. Is there a problem with air power? What about the IAF warning against splitting it into 'penny packets'? Is air power an adjunct?

Armies and navies will see air power as an adjunct, history being the reason. Analysing the experience of the United States, the greatest exponent of air power in history, the air power theorist Tami Davis Biddle wrote in 2019 that 'aerial bombing cannot control the ground. It is fundamentally a coercive activity in which an attacker seeks to structure the ene-

my's incentives - using threats and actions to shape and constrain the enemy's options, both perceived and real. It is an important ment for both deterrence and compellence. However, its ability to produce results varies, and students of strategy must understand the circumstances under which it is more or less likely to achieve particular results or political ends' (https://bit.ly/3iHHrza). Holding and controlling land or water is essential in conflict. From Vietnam to Afghanistan, air power failed to deliver the promised results to the U.S. But everyone acknowledges how greatly air power can aid victories though.

Issues before the IAF

Media reports suggest that counting even ageing aircraft, the IAF is 25% short on fighter squadrons. Greenert, Chief of Naval Operations told the Senate that '(if the budget gets cut) more ships and

Finding common ground

A common understanding of the nuances of military air power is the key. Towards this, it has to be accepted that others too understand air power. With the experience of operating almost every kind of aircraft the IAF operates, and with the benefits of the operational wisdom borne of the harsh integrity of the supremely tough aircraft carrier and other small deck operations, the naval leadership understands air power. Synergy and hurdles

With dwindling budgets, a steadily deteriorating security situation and the march of technology, the armed forces understand the need to synergise. But natural human faults interfere. For instance, different services do not co-exist well where they are colocated. Bitter fights over land, buildings, facilities, etc. mar optimal operational synergising. Then there is the issue of giving each other the best, or of wanting to be with each other. The Andaman and Nicobar Command suffered from the lack of a substantial operational charter, and the services not positioning appropriate personnel or resources there. Moreover, as a joint tenure did not benefit career, no one strove for it. The U.S., when faced with the same problem. made joint tenures mandatory for promotions. Steamrolling with decrees is useful in such areas.

Major reorganisations must strictly follow the sequence of written concepts, their refinement through consultation, simulation or table top war gaming, field evaluation and final analysis before implementation. This would help address command and control, asset adequacy, individual service roles, operational planning under new circumstances and the ade-

What is needed

As we hurtle towards inevitable reorganisation, some specifics are required. The first is the need for a comprehensive National Security Strategy to guide the services develop capacities required in their respective domains. The second is the need to transform professional education and inter-service employment to nurture genuine respect for others. The third is that the armed forces must resolve their differences among themselves, as the politicians or bureaucrats cannot do it. The fourth is to ensure good quality staff, in adequate numbers, at apex joint organisations, to reassure individual services and those in the field that they are in safe hands. The fifth is the acceptance of the fact that what works for other countries need not work for us. We may need tailor-made solutions which may need more genuine thinking. For genuine military jointness, a genuine convergence of minds is critical. Decrees have limitations.

Lessons from India's food security response

Government measures to tackle the food crisis during the COVID-19 pandemic were effective



With a reduction in COVID-19 infections as the second wave weakens in India, it is important to focus on the pandemic's disruptive impact on the food security and livelihoods of the poor and marginalised.

The deadly virus has been around for two years and it is not clear as to how and when it will end. However, we do have enough in terms of a hindsight analysis of policies and interventions that promise food and livelihood security, along with the strengthening of health support, for millions facing the wrath of the pandemic.

It is imperative to also note an alarming escalation in the global hunger that is unfolding right now. There was a 'dramatic worsening' of world hunger in 2020, much of it likely related to the fallout of CO-VID-19. While the pandemic's impact has yet to be fully mapped, a multiagency report, 'The State of Food Security and Nutrition in the World', estimates that around a tenth of the global population - up to 81.1 crore persons - were undernourished last

India has made enormous progress in food production over the years, with an inspiring journey towards self-sufficiency in food production marked by the Green Revolution. In 2020, India produced over 30 crore tonnes of cereals and had built up a food stock of 10 crore tonnes. The country has registered record harvests over the last few years. India exported a record 1.98 crore tonnes of rice and wheat in

Pivoting safety nets

Coming to the impact of COVID-19's fallout, vulnerable and marginalised families in India continued to be buffered against the food crisis by its robust Targeted Public Distribution System (TPDS).

of a surge in demand for foodgrains through the public distribution system. As data shows, there was an unprecedented spike in the uptake of subsidised and free foodgrains during the lockdown. The public distribution system became a lifeline for millions hit by the pandemic.

Increase entitlements

A dynamic analysis of the food security scenario and feedback from different stakeholders allowed the Government of India to increase entitlements given to National Food Safety Act (NFSA) beneficiaries in 2020. For instance, under the Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY), 81.3 crore NFSA beneficiaries received an additional 5 kg of foodgrains per person per month and 1 kg of pulses per family per month, free of cost, for eight months from April to November 2020. Under the Atmanirbhar Bharat package, 8 crore migrants were provided 5 kg of foodgrains per month, free of cost.

The government also allowed NGOs/civil society organisations to buy rice and wheat at subsidised prices directly from nearby Food Corporation of India (FCI) warehouses. Rice was sold at ₹22 per kg (market price is ₹35 per kg) and wheat at ₹21 per kg (market price is ₹27 per kg)

The PMGKAY was introduced in

2020 for eight months to provide relief to 80 crore beneficiaries covered under NFSA from COVID-induced economic hardships. The scheme was reintroduced this year for the third phase implementation for two months till June, and later extended till November under the fourth

During the third phase of PMGKAY, about 89% of the allocated foodgrains were distributed to beneficiaries. The distribution reached 94% in May. Implemented for eight months last year and for seven months this year, the PMGKAY outlay will add up to a total expenditure of ₹2,28,000 crore over 15 months.

Addressing challenges

The COVID-19 pandemic has once again drawn attention to addressing the aspects of access and portability of food entitlements. It is critical to leave no one behind in times such as these and crucial for states to find solutions so that no one goes hungry.

Ensuring that food support focuses on at-risk groups, including persons with disabilities, the elderly, sinwomen-led households, transgender persons, HIV-affected persons, displaced persons, refugees and orphan children, is at the heart of 'Leave No One Behind'.

The scale of India's public food distribution systems is immense and

has gone through constant navigation and improvement, which is commendable. But more needs to still be done to improve access and inclusion among the missing vulner-

able population.

First, the introduction of the One Nation One Ration Card (ONORC) scheme is an innovation that can be a game changer, allowing beneficiaries to access their food entitlements from anywhere in the country. This is especially important for a country like India with a massive mobile population and migration between States. The scheme takes the massive digitisation of the supply chain, distribution and access to the next step, ensuring anyone benefits from anywhere in India.

Second, climate change will continue to affect agriculture and food security, and the impact on the poor and vulnerable can be devastating. Massive efforts are needed towards programmes that focus on building resilient agriculture that is adaptive to changing weather and needs through the introduction of newer varieties of crops, efficient irrigation systems, and the promotion of crops as per the agro-climate zones.

Thirdly, a third of all food produced is wasted. There should be enhanced efforts to prevent losses. Lost or wasted energy used for food production accounts for about 10% of the world's total energy consumption, and annual greenhouse gas emissions associated with food losses and food waste reaches to around 3.5 gigatonnes of the CO2 equivalent.

Finally, 2021 offers a unique opportunity for advancing food security and nutrition through transforming food systems with the upcoming UN Food Systems Summit, the Nutrition for Growth Summit and the COP26 on climate change. The outcomes of these events will certainly shape the actions of the second half of the UN Decade of Action on Nutrition. India has a central role to play in this transformation and offering experiences and solutions to address the thought processes and models for a resilient, equitable, and foodsecure world.

Time to reflect

The role of an ombudsman is not only to identify what went wrong but also to work on a visible mending process

In less than two months, my tenure as the Readers' Editor will come to an end. After being a journalist for nearly four decades, which includes the past nine years as a news ombudsman, I am moving on to pursue research on a range of subjects that are close to my heart. I would like to use this interregnum to look at the changing nature of the news industry, and the challenges it poses to a news ombudsman. Along with my personal reflections, I would like to hear and share the views of the readers about how they assess this institution in general, and within *The* Hindu in particular.

First, we need to contextualise the role of a news ombudsman and how it is different from all other journalistic assignments. While every journalistic assignment goes on to create a body of public information, the evaluation by an ombudsman is clearly a post facto act.

Autopsies help to understand the factors that led to the death of an individual – which is a significant contribution. The role of an ombudsman is not only to identify what went wrong but also to work on a visible mending process. The idea of a visible mending process is to ensure that the society makes its choices based on right information rather than a faulty one.

'Required revolution'

Joshua Benton, founder of the Nieman Lab at Harvard University, in his article "From public to publics" has argued that "a strong, proactive public editor can be part of this current reckoning in journalism that is looking increasingly like a required revolution in iournalism culture".

Over the course of next few weeks, I will also be touching upon some of the crucial questions about the role of a news ombudsman raised by Kathy English, who was Toronto Star's public editor for thirteen long years and my fellow board member at the Organisation of News Ombudsmen and Standards Editor.

What is the need for this extended reflection and engagement? Is it an attempt to understand digital disruption? Is it an attempt to locate the elements of journalism within the changing contours of the news media industry? The answer is yes to all these questions and much more. I earnestly hope this extended engagement will deepen the compact between the newspaper and its readers.

Integral for self-regulation

A news ombudsman is an integral part of self-regulation for news media. According to a UNESCO framework, "Self-regulation is a combination of standards setting out the appropriate codes of behaviour for the media that are necessary to support freedom of expression, and process how those behaviours will be monitored or held to account."

The framework further states that "selfregulation preserves independence of the media and protects it from partisan government interference. It could be more efficient as a system of regulation as the media understand their own environment better than government". The framework also alerts citizens that this approach may be used by the news industry to further its "commercial interests rather than the public interest".

While the Terms of Reference that govern this office give general guiding principles, individual Readers' Editors evolve their own approach to effectively ensure that the newspaper does not stray from its core principles and editorial values. In my first column on September 24, 2012, I spelt out my approach: "The Terms of Reference defines my role and the Code of Editorial Values defines the role of the editorial team. Readers' concerns, complaints and suggestions shall not be evaluated in an arbitrary fashion, but within a rigorous framework set out in these two documents, as they provide for an institutional framework for a mutual dialogue between The Hindu and its millions of readers. My job is to see that this dialogue takes place for mutual benefit."

The fulcrum of my ombuds universe is a value system that is deeply embedded in the notion of the commons and common good, where the central concern is to effect course correction and not to be punitive.

I have both boundaries and possibilities, and I respect the prerogative of editorial freedom. The perimeter is set by the Terms of Reference and it would be unfair to breach this. Respecting the well-defined perimeter is an enabling quality as it opens up many avenues to look at the best practices of journalism. This debate is crucial to preserve public interest in journalism.

Are law and technology a solution to fake news?

Stakeholders are attempting to find a robust and effective solution to sift fact from fiction

Fake news and its associated social problems have been a major concern and the Indian government has been attempting to bring in several legal amendments to deal with its creation, propagation and effects. Social media companies, too, are investing billions of dollars into technological solutions such as Artificial Intelligence (AI) to identify fake news and its proliferation. Are these the best solutions to solve a problem as old as humanity or is there any other effective solution?

Looking at statistics on the justice delivery system in India, the legal system needs to become more robust before it can be considered an effective solution. Further, the formulation of laws in themself do not prevent a wrong action.

When Timnit Gebru, former colead of Google's ethical AI team, made an unceremonious exit, the MIT Technology Review identified the key aspects of her unpublished paper that had caused a stir within Google. In summary, to train large AI models, massive computing power and energy is required and this has been expanding since 2017, along with an ever-increasing carbon footprint. The Technology Review stated that the 'Transformer' model, as on January 2019, used 6,56,347 kilowatthour (kWh), producing a carbon footprint of 6,26,155 lbs of CO2 equivalent at a cloud computing cost between \$9,42,973 and \$32,01,722 for a single training of the AI model. Further, since the models tend to use text already present on the Internet, there is a tendency for the AI to reflect strong negative human biases.

Fake news is disinformation that has no basis in reality, but is presented as fact. Being designed to manipulate both the intellect and emotions of a person, it can evoke strong emotional reactions in its reader, which could sometimes result in violence.

In an experimental study conducted among first-year undergraduate History students, who were given some historical content, it was found that novice learners made claims that

did not have supporting evidence, were either inaccurate or unrelated.

India's diversity is its strength, but also the source for numerous conflicts that have persisted over the decades. These conflicts, being rooted in historical claims around politics, culture and religion, will intensify if the historical assumptions and data behind related fake news are not contextually analysed. The problem is aggravated with the decline in history learning programmes worldwide. While the National Council of Educational Research and Training (NCERT) curriculum has elements of historical thinking, State boards are primarily focused on the memorisation of content.

The Constitution of India provides a long-term solution under Article 51A (h), which says, "It shall be the duty of every citizen to develop the scientific temper, humanism and the spirit of inquiry and reform." While the National Education Policy, 2020, captures the needs of the nation, it misses out on historical thinking.


Historical thinking is the set of thinking skills required for learning history. It consists of concepts like points of view, evidence, validity and reliability of the source, contextualisation, and corroboration, apart from other skills. Historical thinking skills can also be applied to law, forensic science, politics and research, and dealing with 'fake news'.


In the case of fake news, a person would have to be able to read a piece of news, examine the source for bias and ascertain whether the claims being made are factual or whether they constitute deliberate misinformation. Since fake news is designed to appeal to emotion, it becomes all the more important that a person is skilled at interrogating evidence, contextualising the information and corroborating it with alternate sources. If historical thinking has such widespread application, why is it missing from active public discourse and in the education system?

FIFTY YEARS AGO JULY 26, 1971

A switch to save astronauts

For nearly 12 minutes after the Apollo 15 astronauts leave earth on their 12-day round trip to the moon, Major Kenneth Aisler will have his finger poised over a switch that could end it all abruptly. That finger against the Red "Destruct" switch would start a series of events resulting in the jettisoning of the command module containing the three Apollo 15 astronauts, the destruction of the Saturn 5 booster rocket, and the ultimate descent to earth of the Apollo spacecraft from its recovery parachutes. From that moment on, it would be up to "Beach Boss" Col. Robert A. Van Arsdall and his air, land and sea forces standing by for just such a disaster. These two Air Force officers have in their hands the fate of astronauts David R. Scott, James B. Irwin and Alfred M. Worden. They also are responsible for other life and property should the Saturn rocket stray from its programmed path. The weather is expected to be good for launch time. Scott and Irwin are scheduled to land on the moon at 3.45 I.S.T. on July 31 and return to earth, north of Hawaii, on August 8 at 2.16 I.S.T.

Rescue operations continued in full swing amid a brief respite in the rains. The Chief Minister, who toured rain-battered Chiplun on Sunday, said while the State government and local administration was currently focusing on providing immediate relief in form of food, clothes and medicines, he would officially announce a relief package once a comprehensive survey of all the affected districts in western Maharashtra and the Konkan was completed over the next few days.

"I am not announcing any package just to make people feel better. This is not merely limited to Chiplun, but Raigad and other parts of the State also. The estimates from Kolhapur, Sangli and Satara have yet to come in... The damage to property has been enormous with shops, establishments, infrastructure be they roads, bridges, power lines destroyed by the fury of the floodwaters... So, let the financial review be completed and only then will we be announcing a package," Mr. Thackeray said. Grief-stricken residents accosted Mr. Thackeray and his entourage the moment he entered Chiplun, pleading for provide immediate

Reassuring them of every aid possible, Mr. Thackeray said he would be touring western Maharashtra tomorrow to take stock of the destruction in Satara, Sangli and Kolhapur.

Responding to allegations that no help was given to stricken residents for more than 17 hours after the waters rose, Mr. Thackeray said the intensity of the rains had not left anybody with any chance to plan or warn of the dangers ahead.

"Hence, we will be requesting the Centre to keep an NDRF team in such districts. So, at least operations can commence at the earliest at local levels," he said.

"We have now started experiencing the effects of climate change...areas where villages had nestled comfortably in the mountains for years, unaffected by vagaries of nature, are now being buried by landslides in an instant. This is not merely excess rain, but a far more terrible phenomenon," he said. He informed that doctors from other civic bodies were being brought in the afflicted areas to help stave off any epidemic.

Rajasthan reshuffle put off as Congress stand-off continues

AICC members return to Delhi after CM refuses to act under pressure

The expectations of an early Cabinet reshuffle in Rajasthan turned out to be a damp squib with senior Congress leaders on Sunday leaving the decision to the party's central leadership. Two emissaries from New Delhi could not convince Chief Minister Ashok Gehlot in favour of making an immediate power sharing arrangement with the rival

AICC general secretaries Ajay Maken and K.C. Venugopal, who arrived here on Saturday to bring about a reconciliation within the ruling party, left on Sunday afternoon after meeting the Pradesh Congress Committee office-bearers. In their interaction with Mr. Gehlot earlier, the latter reportedly refused to act under any pressure while making the political appointments.

An uneasy Mr. Maken told presspersons outside the PCC headquarters that there was "no conflict" among the Congress leaders in the State and all of them had left the final decision about the Cabi-

net expansion to the party high command.

Mr. Maken is scheduled to return to Jaipur on July 28 for a two-day meeting with party MLAs on the functioning of the government as well as the party organisation.

Pilot's meeting

Former Deputy Chief Minister Sachin Pilot, who along with 18 MLAs staged a rebellion against Mr. Gehlot in July last year, was among the leaders who met the two AICC general secretaries at the PCC headquarters.

A large number of Mr. Pilot's supporters gathered outside the building and raised slogans in his support, besides demanding that the MLAs loyal to him be accommodated in the government.

The Pilot camp has been issuing statements demanding power sharing between Mr. Gehlot and the disgruntled group of MLAs.

According to Congress insiders, Mr. Gehlot suggested to the two emissaries that they seek the opinion of all MLAs through a "broad consultation" about new appointments to the Council of Ministers and nominations various boards and corporations.

Mr. Maken and Mr. Venugopal are members of a committee appointed by the

AICC last year to address the issues raised by Mr. Pilot and evolve a compromise in the party's State unit. Mr. Venugopal is also a Rajya Sabha member elected from Rajas-

Mr. Pilot left for his Assembly constituency, Tonk, after meeting the two leaders and met a cross section of people in the town, 100 km from Jaipur. He refused to comment on a possible Cabinet expansion.

Nine vacancies

Mr. Pilot, who was sacked both as the Deputy CM and the PCC president during the political crisis, had recently indicated that he was in touch with the central leadership and was hopeful that the Congress would shortly take steps to address the issues raised by him. The MLAs of his camp have also been demanding that the party fulfil the promises made to him.

The State can have a maximum of 30 Ministers. There are at present 21 members in the Council of Ministers, including the Chief Minister, and nine slots are vacant.

After Punjab, Congress to focus on Rajasthan

More organisational changes on anvil

The resolution of infighting in Punjab has not only prompted the Congress to address the issue of factionalism in Rajasthan but also resolve some of the longpending issues with regard to other States.

In Rajasthan, the peace formula to bring the warring factions of former Deputy Chief Minister Sachin Pilot and Chief Minister Ashok Gehlot is in its final stages. While some of Mr. Pilot's supporters will find a place in the Gehlot cabinet, Mr. Pilot himself is likely to be drafted as a general secretary in the All India Congress Committee (AICC).

Party president Sonia Gandhi is learnt to have spoken to Mr. Gehlot to speed up the process of expanding his Cabinet to accommodate the different sections.

Conveying a sense of urgency, the Congress president has also met senior leaders like Ghulam Nabi Azad, Kamal Nath and Anand Sharma to discuss or ganisational issues.

Gujarat is one State that is a priority for the high command as the Assembly elec-

tion is due in the latter part of 2022. The party needs to appoint a new State leadership as well as a new AICC in-charge. Feedback for the process is currently on, said a source.

While the former incharge Rajeev Satav passed away earlier this year, the Pradesh Congress Committee (PCC) chief had resigned last year after the party's rout in the byelections.

Another State where the Congress is keen to put up a united front is Karnataka amid reports of a leadership tussle between PCC chief D.K. Shivkumar and former Chief Minister Siddaramaiah, who is also leader of the party in the Assembly. "To ensure that the party

takes this up unitedly, Rahul ji had long deliberations with Shri Siddaramaiah and Shri D.K. Shivakumar. Let me assure the Congress party is united and there is no difference of leadership," AICC general secretary for Karnataka Randeep Surjewala said after the meeting last Tuesday. The party has revamped its unit in pollbound Uttarakhand and tried a course correction in Assam with a new team.

Suspense continues over Karnataka leadership

As the State was keenly watching the moves by the BJP high command, party national president J.P. Nadda, breaking his silence on the leadership issue, praised Mr. Yediyurappa, saying he had done "good work" and Karnataka was doing well. When quizzed about the leadership crisis in the State, he said, "That is what you feel. We don't feel so." He added that Mr. Yediyurappa was taking care of things in his own way.

'Spouses' presence not mandatory for OCI card

HC upholds separated woman's plea

The Delhi High Court has said that the Foreigners Regional Registration Office (FRRO) cannot insist on the physical or virtual presence of both the spouses for processing Overseas Citizenship of India (OCI) card applications for one of them.

The High Court's order came while asking the FRRO to accept the OCI card application of an Iranian woman, who has been living separately in Bengaluru after her relationship with her husband, an Indian citizen, turned sour.

The woman submitted that once her marriage with an Indian citizen since 2009 has been proved and is an undisputed fact, the same should be enough to merit grant of an OCI card in her

On the other hand, the Centre's counsel argued that unless her spouse comes forward at the time of making the OCI card application, the FRRO cannot even consider the same.

Justice Palli, however, pointed out that the provision in the Visa Manual "merely makes it requisite for all OCI applicants to be present for a personal interview, either physically or through conferencing".

"...Given that there is no rule or guideline which mandates the presence of both the spouses, it is surprising that the checklist was formulated in a manner to impose such a condition," Justice Palli observed.

Opposition to persist on Pegasus row

Congress leaders say the monsoon session could be their '2G moment'

On Friday, speaking to reporters, Rahul Gandhi said, "Pegasus is classified by the Israeli State as a weapon and that weapon is supposed to be used against terrorists.

The Prime Minister and the Home Minister have used this weapon against the Indian State.'

However, there is also a view among some parties that there should not be continued disruptions of the Parliament.

They argue that there should be a structured debate around "issues" such as fuel price hike, farm laws, pace of vaccination and preparedness for the COVID-19 third wave among others.

Excess deaths much higher in rural West Bengal

Public health experts point to lack of adequate testing facilities during the second wave, and post-COVID complications


A district-wise look at the excess deaths in West Bengal and their multiple over the COVID-19 toll showed that rural districts such as Purba Bardhaman (7,556 excess deaths – 60.4 times the official toll of 125), Puruliya (6,224 and a multiple of 58.7), Cooch Behar (4,429 and 52.7), Malda (5,859 and 32.7), Bankura (6,986 and 31.9) and Murshidabad (8,378 and 30.4) had high number of "excess deaths' and multiples.

Only Paschim Bardhaman (home to Asansol and Durgapur) with 9,652 deaths - 32.6 times the official COVID-19 toll of 296 - had a high multiple among urban districts in the State.

Kolkata had an estimated 12,708 excess deaths, but they were only 2.9 times the official toll of 4,456 which signified a relatively better monitoring of COVID-19 related deaths in the State capital relative to other parts of the largely rural and agrarian State.

The online data for the 18 districts showed that 3,68,477 and 4,10,503 deaths were registered in West Bengal in the CRS, which were close to 94.4% and 90% of the deaths reported by the Annual Report on Vital Statistics based on CRS 2019 for these years. Excess deaths were calculated as the diffe-



Sajal Biswas, general secretary of Service Doctors' Forum in West Bengal said the high excess deaths count was due to multiple reasons including deliberate suppression and inadequate testing facilities, resulting in a large number of deaths without diagnosis.

T.N. to create databank of migrant workers

S. VIJAY KUMAR

Tamil Nadu will soon create a digital databank of migrant workers employed in industries, particularly the Micro, Small & Medium Enterprises and hospitality sectors, Minister for Industries Thangam Thennarasu said on Sunday.

"There are a few lakhs of labourers from various States engaged in industries across Tamil Nadu. A majority of them went home during the peak of COVID-19. We need to have a clear record on how many returned to work, their vaccination status and other identification details," Mr. Thennarasu told The Hindu.

Major industries rely on a few labour contractors. Each contractor has about 50,000 workers from States such as Bihar, Jharkhand, Chhattisgarh, Odisha and West Bengal.

Deal on Gogra, Hot Springs likely soon

India, China could reach an agreement for disengagement at the next round of military talks, say officials

India and China are set to hold the 12th round of Corps Commander-level aimed at resolving the standoff in eastern Ladakh soon, and an agreement for disengagement at Gogra and Hot Springs is likely to be reached.

China had suggested July 26 as a possible date for the talks, but the Indian side conveyed that the day being Kargil Vijay Diwas, it would not be convenient. Fresh dates are expected to be agreed upon soon.

"The situation on the ground is stable. There have been no attempts to reoccupy the peaks vacated. The sense is they (China) are ready to disengage from all places. We got positive inputs and it will happen," a senior defence official said. "We continue to talk at all levels."

The two sides are also looking at a Major Generallevel talks to be held after the 12th round of talks, a second

official said. Since the standoff began, the two sides have held 10 Major General-level talks, 55 Brigadier-level talks and around 1,450 calls over the two hotlines. India and China have two hotlines for communication at Chushul and Daulat Beg Oldi.

Friction points

While disengagement was completed on both banks of Pangong Tso in February, the other friction points that

remain to be resolved are Gogra and Hot Springs, Demchok and Depsang. The buffer zones established in some places as part of earlier talks remain in place. "Buffer zone varies from place to place," the first official said.

In eastern Ladakh, India and China have two mutually agreed disputed areas - Trig Heights and Demchok – and 10 areas of differing perception. Officials said since the stand-off last year, additional five friction points have emerged. These are Km 120 in the Galwan area, Patrolling Points 15 and 17, and Rechin La and Rezang La on the south Bank of the Pangong Tso, the second official said.

"China wants de-escalation first and disengagement later which is not acceptable to India as they can bring back troops and equipment much faster then we can do," the second official said. Some of the People's Liberation Army's (PLA) peace locations are located as far as 3,000 km from the LAC, but they can mobilise much faster, the official said.

Access issues

For India, the area is cut off for several months a year which is not the case with China. Both the Zoji La and Rohtang passes were kept open longer than usual last year due to the stand-off and are available for seven or eight months. Construction work on several tunnels is

under way on a priority basis, including at Baralacha La and Tanglang La, among others, the officials said.

Stating that they have a clear picture of what the PLA is doing and they have vacated and gone back in some places, the official said China has not increased its troop levels since the stand-off began but has rotated its troops. The PLA, too, is closely watching the movements of the Indian military. "We have about 1,000 vehi cles going up and down the Rohtang axis everyday," the official added.

However, at least two officials said the Line of Actual Control (LAC) will not become like the Line of Control (LoC) with Pakistan with very close deployments by both sides. "The LAC will not become like the LoC. But the force levels have gone up as the trust is lost. All agreements are broken," the first official stated. New protocols have to be worked out, another official stated



Cautions on COVID

While greeting citizens on the upcoming festival season, he cautioned that the threat of COVID-19 still loomed large and that all precautions must be taken to prevent its spread.

Noting that on July 26 the nation would mark Kargil Vijay Diwas, the Prime Minister asked the people of the country to pay tributes to those who made the nation proud in 1999.

In the broadcast, he also cited a study done by MyGov to highlight that out of those sending messages and suggestions for Mann Ki Baat, close to 75% were below 35 years. 

Samyukt Kisan Morcha to launch 'Mission U.P.' in Lucknow

When farmers return to Jantar Mantar to continue their parallel parliament protest bourers are women, though on Monday, the participants will look different from their counterparts inside Parliament as well as the delegates of previous Kisan Sansads in one major way: they will all be women.

"The Mahila Kisan Sansad will reflect the key role that women play in Indian agriculture, and their critical role in the ongoing movement too. Convoys of women farmers from various districts are reaching the morchas for the Mahila Kisan Sansad," said a statement from the Samyukt Kisan Morcha (SKM) joint platform of farm unions

coordinating the protest.

According to Census data, 30% of all cultivators and 43% of all agricultural lafew of them have land rights in their own names. ganisations and supporters. However, few women have been in the leadership of the movement. None of the SKM's nine core committee members are women, nor are the leaders of the individual unions that make up the platform. Ms. Kuruganti herself was the only

woman among the 30-odd delegates sent by the farm unions to negotiate with the Central government earlier in the year. On July 22, the first day of the Kisan Sansad. only seven of the 200 protesters allowed each day were

As the women take over the stage at Jantar Mantar on Monday, most of the SKM leadership will head for Lucknow, where they will launch 'Mission U.P.' to outline their plans for next year's Assembly election. "In the panchayat elections held earlier this year, the farmers' movement left its mark, with the BJP candidates punished in many places and Independents gaining most number of seats," said the SKM

35% of govt. schools, anganwadis have no tap water

Jal Jeevan Mission fails to meet goals 10 months after 100-day campaign was launched

Over a third of government schools and anganwadis still do not have tap water access even 10 months after the Jal Ieevan Mission launched a 100-day campaign to provide the facility. There has been minimal progress since a Parliamentary Standing Committee pulled up the IIM in a March report. pointing out the importance of repeated washing of hands as part of COVID-19 safety protocols for schools to reopen.

However, the Jal Shakti Ministry considers the current progress an achievement. "Big boost to children's health & hygiene in the country!" said a tweet from Jal Shakti Minister Gajendra Singh Shekhawat on Sunday, linking to an official statement from the Ministry. "PM

In its report on the demand for grants submitted to the Lok Sabha in early March, the Parliamentary Standing Committee for Water Resources deplored the slow rate of progress, pointing out that "children are more susceptible to waterborne diseases, more so, when there is also a need for repeated washing of hands as a precautionary measure during the COVID-19 pandemic". The Jal Shakti Ministry told the panel that "some States/ UTs have indicated that they need more time to complete the task and sustain the efforts" and said the

campaign had been extended till March 31, 2021.

Almost four months after that extended deadline, the JJM is yet to achieve its goals. In fact, it has only added tap water access in about 50,000 schools and 40,000 anganwadis since that time. In its statement on Sunday, the Ministry said the progress came "despite Covid-19 pandemic and lockdown".

In fact, there is widespread disparity among States, with a few laggards pulling down the national average, despite the fact that nine States and Union Territories have already achieved 100% coverage. In Jharkhand and West Bengal, less than 15% of schools and less than 10% of anganwadis have tap water access. On the other hand, 80% of the schools in Uttar Pradesh have access to

Steps to realisation

Most of us who are involved in worldly concerns are said to be in Pravritti Marga. This kind of preoccupation ties us down to samsara, the cycle of birth. Vedanta vichara shows that there is also another marga, Nivritti, which leads us to release from this cycle. Tremendous effort is needed to travel in this path and realise the subtle self as the abode of everlasting peace and bliss.

In the Ashtavakra Gita, the preceptor Ashtavakra imparts to Janaka this highest knowledge of the self, praised in the Gita as Raja Vidya and Brahma Vidya, in clear cut terms, pointed out Sri R. Rajagopala Sarma in a discourse. At the outset itself, Janaka is taught to differentiate between the body and the self. Understanding this dichotomy can bring about equanimity in any individual, a most difficult ideal to attain even for realised souls. We can say and feel the self as distinct and as the essence of consciousness. But the bondage caused by the body is also very real and makes a great impact on us all the while. We are constantly aware of the limitations of the body, birth, old age, disease, death, and

we cannot escape all kinds of misery that life plunges us in. But once one is able to leave aside the bodily concerns, he can sense the freedom and joy of being only conscious of the self and not the body. The thought that 'I am the doer' is the greatest hurdle to be overcome in this quest. Instead one should repeatedly evoke the thought that 'I am the consciousness and the one and only self, existing eternally and always apart from the created universe.' Listening to such explanations of Ashtavakra, Janaka, the disciple, who is already well versed in Vedanta and is also a ruler par excellence, is overwhelmed with the awareness felt within and is grateful to his preceptor.

China's assertive new diplomatic approach in the Xi Jinping era has come to be dubbed "wolf warrior diplomacy", marked by a muscular posture in pursuing China's interests. Peter Martin, author of the new book "China's Civilian Army: The Making of Wolf Warrior Diplomacy" and previously a foreign correspondent in China, says the approach is not exactly new and is rooted in the Communist Party's history. The current state of relations with India, he says, is "the best example" of how it has often backfired although, he argues, wolf warrior diplomacy is likely here to stay. Excerpts from an interview:

Where does the idea of 'wolf warrior' diplomacy come

■ There was this blockbuster movie that came out in 2017 about this Chinese action hero fighting foreign bad guys on the continent of Africa and avenging China's enemies. It was this unexpected commercial success, the highest grossing movie ever at the Chinese box office. It came to symbolise this new mood in Beijing.

How much of this new approach is down to Xi Jinping, and how much is shaped by broader trends?

■ I think of Xi Jinping as both a cause and a consequence of changes that have taken place in China. The new assertive turn in Chinese diplomacy really started in 2008-09 in the wake of the global financial crisis. China had just hosted the Olympics. The West's response to the financial crisis was sluggish and China's was very, very decisive. In the ensuing years, China watched Western political systems deal with gridlock at home while its own economic growth continued. There are these trends taking place in China that are quite independent of Xi Jinping. But I think what Xi did was take a more confi-

dent and assertive tone, and accelerate it and make it more decisive and more

At the time of Xi taking over, there was a debate on whether China should continue with the Deng Xiaoping era approach of "hiding brightness, biding time". Has that debate been resolved now?

■ I think the debate is still ongoing beneath the surface, although, in public, Xi Jinping, and those who want to continue this very brash, assertive tone, have certainly won out. There are large parts of China's scholarly community on foreign affairs, and in fact some people in the Foreign Ministry, who would still like China to take a quieter, more humble approach to foreign policy. I don't know that those people

necessarily think that returning to the policy of the 1990s is realistic. There's a refrain I heard quite a lot in Beijing that you can't hide an elephant. The idea is China has gotten too big to really take that kind of low profile that it had in the past. But I think there are a lot of people who are very uncomfortable with this trend of picking apparently unnecessary fights and insulting counterparts.

How are domestic changes in China shaping its current diplomacy?

■ In Chinese diplomacy, domestic politics is always king. We look on with bewilderment sometimes and

think, why are they possibly doing this because these are the people who are charged with improving China's reputation? In truth, we're not the audience. They're doing this to signal to people in Beijing that they are loyal to the regime, they're loyal to Mao or Xi Jinping or whoever is in charge. Foreign audiences are really a kind of by-product there.

How successful has this approach been on the

■ In the grand scheme of things, I find it really hard to come up with any kind of net positive assessment of it. It's one of the factors which has contributed to this incredi-

ble decline in global perceptions of China in Pew polling that you'll have seen recently. In my mind, India is perhaps the best example of where this approach has kind of backfired. Wolf warrior tactics, combined with, of course, great military assertiveness on the China-India border, has ended up pushing India much closer to the U.S., and alienating a billion plus-person economy, an emerging power on the global stage with good relations with the United States, and that shares a border with China. China, Pak. outline 'joint action' to align Afghanistan strategies

Focus on preventing escalation of war, resolutely combating terrorist forces

China and Pakistan on Saturday said they would more closely cooperate and work together in Afghanistan amid the changing situation in the country, as their Foreign Ministers proposed building the China Pakistan Economic Corridor (CPEC) into "a hub of regional connectivity"

Meeting in the Chinese city of Chengdu at the third strategic dialogue, China's Foreign Minister Wang Yi and his counterpart Shah Mahmood Qureshi outlined a five-point joint plan on working in Afghanistan, the Chinese Foreign Ministry said in a statement.

Mr. Wang described the current situation as arriving "at an important juncture" as he criticised "the hasty U.S. withdrawal of troops' for having "neither fulfilled the purpose of fighting terrorism nor brought peace to Afghanistan but created a new security black hole," the statement said.

He said "both China and Pakistan are most directly affected by the situation in Afghanistan" as its neighbours and it was "necessary for both sides to strengthen cooperation to cope with the change", which he described as one of the focuses of the dialogue.

Mr. Wang outlined "joint actions" in five areas, starting with "the immediate priority of avoiding the expansion of war and preventing Afghanistan from falling into a full-scale civil war." The second focus would be to promote the intra-Afghan negotiations between Kabul and the Taliban and establish "a broad and inclusive political structure".

He said the third joint action would be "to resolutely combat terrorist forces". Mr.

Pelosi plans to appoint Trump critic to Capitol probe panel She had earlier rejected two of five Republican nominees

House Speaker Nancy Pelosi on Sunday said she plans to appoint additional Republicans, including a staunch Trump critic, to the committee probing the January 6 U.S. Capitol insurrection, amid a fierce partisan showdown over who will serve on the body.

Asked whether she would appoint a new set of Republicans, including lawmaker Adam Kinzinger, who voted to impeach former president Donald Trump, Ms. Pelosi told ABC "that would be my plan."

Earlier this week House Leader Kevin McCarthy withdrew the names of the five Republicans he had appointed to

serve on the select committee, after Ms. Pelosi took the rare step of rejecting two of them, congressmen Jim Jordan and Jim Banks, out of what she said was concern the investigation's integrity.

Hours after the Capitol insurrection, both among several Republicans who voted against certifying election results in some states. "The two that I would not appoint are people who would jeopardise the integrity of the investigation and there's no way I would tolerate their antics as we seek the truth," Ms. Pelosi said on Sunday.

The tit-for-tat moves represent the latest bickering over what many were hoping would be a united effort: investigating the riot in the citadel American democracy.

Ms. Pelosi's Democrats had sought to create a bipartisan, independent 9/11-style commission to investigate the Capitol insurrection.

Ms. Pelosi said that Republicans including Mr. Kinzinger, a strong Trump critic and six-term congressman from Illinois, "have expressed an interest to serve on the select committee."

Ms. Pelosi herself had already appointed to the committee Republican congresswoman Liz Cheney, who was also among the 10 Republicans who voted to impeach Mr. Trump in January.

Pak. bans domestic air travel for unvaccinated

COVID-19 cases cross 1 million mark

Pakistan has banned the domestic air travel for unvaccinated people as the COVID-19 cases crossed the 1 million-mark in the country on Sunday, according to officials.

The travel restriction, imposed by the National Command and Operation Centre, will be applicable from August 1 on unvaccinated people of over 18 years of age. "Restriction is for domestic air travel and people travelling from Pakistan to abroad or from abroad to Pakistan are exempted from restriction. It is also not applicable on link flights if these are within 72 hours of arrival or departure," according to an NCOC

document.

Partially vaccinated people, foreign nationals, Pakistani nationals having documentary proof vaccination abroad and patients with clinical conditions will be exempted from the restriction, it said.

Meanwhile, the Ministry of National Health Services said that 45 people died in the last 24 hours due to the COVID-19, taking the death toll to 23,016. It said that 2,819 new cas-

es were reported, taking the national tally to 10,04,694. positivity rate

reached 6.32% which is the highest during the fourth wave of the pandemic which hit the country this month.

Q. I am a central government pensioner aged 79. I have recently received ₹6,00,000 as part of a share (one among four surviving heirs) on sale of our old house. The house, as per records, was purchased by my deceased parents in 1937 for a sum of ₹2,650 only. I want to know the amount of tax with surcharge to be paid on this transaction. Secondly, in January, I also received a sum of ₹30,000 on account of sale of shares. Tax liability on this also may kindly be stated. K. NATARAJAN

A. Proceeds from sale of ancestral property (immovable in nature) is taxable and it falls under the head 'capital gains'. The amount of ₹6,00,000 received by you as part of your share will be considered the full value of consideration, you may deduct any directly related expenses to the transfer such as brokerage paid to this value. As the property was acquired by your parents prior to 2001, you can adopt the fair market value of the property as on 1.4.2001 as the cost of

You may enquire about the fair market value with the respective Registrar. The property being a long-term capital asset, you are to adjust the fair market value by using the cost inflation index (CII) to arrive at the indexed cost of acquisition. In case any capital expenditure was incurred post 1.4.2001, it will be considered as cost of improvement and will have to adjusted by using the CII if it is older than 2 years. The difference between the full value of consideration, expenses and indexed cost of acquisition, indexed cost/cost of improvement will either be the long term capital gains/loss.

In case of long term capital gains, 20% plus surcharge (surcharge depends on new and old tax regime) plus cess of 4% will be the tax liability.

In case of sale of shares, wherein the shares are listed and STT was paid both at the time of purchase and sale, long term capital gains (listed shares held for more than 1 year) under ₹1 lakh will not be taxed and in your case the receipt is ₹30,000 whereby the capital gains should be lower than that. In case of short term capital gains it will be taxed at 15% plus surcharge (surcharge depends on new and old tax regime) plus cess of 4%

Q. I am a retired bank employee aged 84 years. My wife and I are covered under a group medical insurance scheme of my bank. During [FY21], I had paid around ₹30,000 towards insurance premium. I had also spent around ₹10,000 for purchase of medicine and lab investigations. Kindly advise whether I can claim both the above amounts under section 80D.

A. For senior citizens, under Section 80D of the Income Tax Act, 1961, deduction can be claimed up to ₹50,000 for self and dependents towards payment of health insurance premium. Amounts paid towards preventive health check-ups can also be claimed up to ₹5,000 provided that the limit of ₹50,000 has not been exceeded.

In your case, the total deduction will be ₹30,000 towards health insurance premium and ₹5,000 (if the cost of preventive health check-ups are greater than ₹5,000 of the ₹10,000 spent by you) or if the amount pertaining to preventive health check-ups are less than ₹5.000 the actual amount spent towards preventive health check-ups can be

Q. I had opened a PPF account a couple of years ago for 80C tax savings. However, now I have got myself an LIC policy and the total annual premium of LIC policy and my EPF contribution together exceed ₹1.5 lakh. Should I continue to invest in PPF in FY21-22. given I would not be having any tax savings under 80C? If yes, any recommended percentage or amount? Do we have some better alternatives to PPF?

A. Deposit into PPF account is to be done every year for the first 15-year block. Minimum investment that is to be done into PPF is ₹500. By investing this amount, the PPF account will be active. Investment in PPF is to be looked beyond tax deductions as investing in PPF has multiple advantages such as interest rates being one of the highest risk-free returns that are available for investment in India, guaranteed by the Government of India and is free from attachment in case of default of any kind of loans borrowed.

Q. I'm working in BHEL, a central government undertaking. I have earned leave (EL) of 170 and half pay leave (HPL) of 260 and my basic pay plus dearness allowance will be ₹89,500 per month. I will be retiring in September 2021, I need to know how much I would get at the time of retirement and whether it is tax exempt or not. If not, what will be the tax amount?

A. Employees of Public Sector Undertakings cannot be treated on a par with government employees for the purposes of Section 10(10AA) of the Income Tax Act, 1961. In your case, the leave salary that would be paid to you at the time of your retirement will not be completely exempt. The exemption that will be available to you at the time of receipt of leave salary at your retirement will be the least of ₹3,00,000, leave salary actually received, 10 months' salary (basic plus DA), cash equivalent of leave to the credit of the

employee at the time of retirement. The cash equivalent of leave to the credit of the employee at the time of retirement is calculated in the following manner ((AxB)-C)xD where A is the number of completed years of service, B is the number of days' leave credited each year (maximum 30 per year), C is the number of days' leave taken or leave encashed during the period of employment and D is the average salary of

Inflation isn't in your control, SO WOITY 110 If prices are rising quickly, your investment should compensate for the trend; but that does not mean changing your portfolio allocation strategy If prices are rising quickly, your investments

These days, a lot of opinions are being voiced on how high inflation is eating into your returns on investments, and how net-of-inflation return, particularly from debt investments, is negative. Those arguments have merit. However, there is a counter to that, too.

The fact that you have a disease and medicines are available does not mean you take the medicines they should be appropriate for your symptoms and suitable for you.

How do you determine what is appropriate or suitable?

Investment objectives

The primary aspects on which your investment portfolio should be based are your investment objectives, financial goals, time horizon, risk appetite and the risk-return profile of the investments.

While your net-of-inflation real return ought to be positive, your portfolio allocation should not be distorted when inflation is high. As an illustration, if your appropriate portfolio allocation is 60% equity and 40% debt, it should not be 100% equity when inflation is high. If you

have the risk appetite for your RoI is 5% and infla-100% equity in your portfolio, it should have been 100% even when inflation was low. It is generally agreed that for retired senior citizens, equity allocation should be on the lower side. If that is dis-

torted when inflation is high, it means going against the grain.

When inflation rate is

high, the relevance for you is that prices of goods and services you consume are rising and that should be compensated for by your investments. If the return on investments (RoI) is lower than inflation, then at the end of the period, the worth of your principal will be less than earlier as it can help buy fewer goods and services than it could before. If your returns are higher than inflation, then it enhances value.

For example, if inflation is 5% and your RoI is 10%, you are well off. If your RoI is 5%, your investment is not making you any better off. Now, if

tion is 6%, your principal is worth less than earlier. In such a situation, what should you do? Nothing much. If you increase the equity allocation in your portfolio just to beat inflation, it may not suit your risk profile. If you take lower-credit-rated, higher-yielding debt, it would raise the credit risk in your portfolio and that al-

so may not be suitable. Pace of rising prices

Inflation is the pace of rising prices. Of what? If you are basing the allocation in your investment portfolio on inflation, it should be on the basket of goods and services you consume. But that is not the case. The inflation data we see monthly, announced by the Centre, is the inflation for a given basket of goods across the country. But every individual's lifestyle is different. Consumption baskets

vary across profession, age, location, gender, taste, preference and the like. Hence, the inflation number is at best an approximation of trends in the economy.

Then how would you know what part of the inflation number is re-

levant for you i.e. your consumption basket? Unfortunately, in a country of 138 crore people, it is not possible to measure as many unique inflation rates.

What does the consumer price inflation basket in India comprise? Almost half the basket constitutes food and food products.


While food is the major chunk of expenses for many people, it is not so for everybody, particularly in upper-income brackets.

Services are missing in the CPI basket, except for house rent and certain aspects of transport / communication. We consume services such as doctor consultation, dining at restaurants, haircuts at salons, app-based cab services, data/wi-fi, education/coaching, driver and domestic help. Net-net, if the headline inflation data your allocation, for the month, as we see in the media, is say, 5%, then the inflation for your unique individual consumption basket may be, say 7% or even 3%, which is not evident to us. So, it may not be appropriate to build your invest-

portfolio based on a varia- e.g. from debt ble that may not apply to you. What does it all boil down to? The issue at hand is negative real returns in debt investments. Inflation is high, but does not typically remain as high forever. In 2020, CPI

inflation averaged 6.6%. The forecast for FY22 from the RBI, in the last policy review on June 4, was 5.1%. The projection can go wrong as there are certain pressures on inflation such as high crude oil prices, high metal prices, money circulation in the economy being higher than earlier or lockdowninduced supply constraints. These pressures could mean that even if inflation is higher than 5.1%, it could be lower than 6.6%. If you change





Hafnaoui strikes gold

Australian women set world record in 4x100m freestyle

Tunisia and Japan celebrated unexpected golds on the opening day of swimming events before normal service was resumed with the Australian women's 4x100m freestyle relay team smashing its own world record on the way to the title in Tokyo.

Chase Kalisz settled American nerves by delivering the country's first gold of these Games, winning the men's 400m medley as part of a US one-two with Jay Litherland.

On a day of surprises, Tunisian teenager Ahmed Hafnaoui pulled off the biggest shock of all with a stunning victory in the men's 400m freestyle.

The 18-year-old, the slowest qualifier, produced a blistering finish to pip Australia's Jack McLoughlin to gold with a time of 3:43.36s, American Kieran Smith taking bronze. Hafnaoui's gold is only the fifth by a Tunisian athlete at the Olympics, but its third in swimming.

Japan's Yui Ohashi won the women's 400m medlev in 4:32.08s. American Emma Weyant took the silver 0.68s behind and compatriot Hali Flickinger took the

While it was a disappointing day for Australia in the men's events, the women set a world record of 3:29.69s in the 4x100m freestyle relay, with Canada taking silver, 3:09 behind the winners, and the United States in bronze position.

The quartet of sisters Bronte and Cate Campbell, Meg Harris and Emma McKeon ensured a third straight gold in the event for Australia, taking 0.36 off the previous record of 3:30.05.

Meanwhile, Indian swimmers Maana Patel and Srihari Nataraj made their debut in the 100m backstroke

heats. However, neither could progress to semifinals. Maana and Nataraj, together with Sajan Prakash in the 200m freestyle, 100m and 200m butterfly, make up the largest Indian swimming contingent since 2008, when four qualified.

Maana swam a time of 1:05.20 in the 100m backstroke. "I am pretty happy because it was my best time. Going into the heat I was really fidgety and shivering. All the emotions piled up and I was overwhelmed," the 21-year old said.

Srihari placed fifth in his heat in a time of 54.31s. "It was fine and not so great at the same time. I felt ready for the race but I didn't feel like it clicked. Maybe I let the pressure get to me. I am disappointed but I can live with it," he said after his race.

Norrie wins first ATP title

LOS CABOS (MEXICO): Cameron Norrie collected his first ATP tour title when he defeated American teenager Brandon Nakashima 6-2, 6-2 to win the Mifel Open on Saturday.

The 25-year-old Briton, ranked 30 in the world, did not drop a set en route to the trophy and lost just 10 games in his final three matches. But he still needed four championship points before he could secure the title.

"It was always a goal of mine to get my first title," said Norrie. "Obviously I'd lost three finals this year, so it was very nice to get over the line today." AFP

Ledecky, Titmus to face off in 400m freestyle

Adam Peaty on course to defend 100m breaststroke title

Katie Ledecky can become a six-times Olympic gold medallist on Monday if the American wins her longawaited 400m freestyle showdown with Australia's World champion Ariarne Titmus.

The big duel of the Tokyo pool will be one highlight of a morning that is also likely to see Adam Peaty take the 100m breaststroke gold and make history as the first British swimmer to defend an Olympic title.

"It's going to be a great race with Ariarne. I'm really excited to be in that first final tomorrow," said Ledecky, who won four of her golds in Rio in 2016 and the other in London in 2012. The American is the defending 400m champion and world record holder and goes into the final with the fastest time from the heats.

Ready for challenge

Titmus, 20, also won her heat comfortably enough and said: "I'd like to think I've got a bit more in the tank for the final."

Ledecky would once have been the day's nailed-on certainty for gold but that role has been taken by world record holder Peaty,

whose times so far have been faster than any other swimmer has ever managed in the event.

USA will again be in the medal hunt later in the morning after qualifying second fastest behind Italy for the 4x100 freestyle relay, with Australia third.

The women's 100m butterfly could be a big moment for China's top medal hope Zhang Yufei, fastest in the semifinals, but France's Marie Wattel and Australian Emma McKeon will be pushing hard.

Test for Sjostrom

Sweden's world record holder and reigning champion Sarah Sjostrom, American Torri Huske and Canadian Maggie MacNeil are also very much in contention.

Sjostrom had surgery for a broken elbow after slipping on ice in February and a medal would be a remarkable turnaround in her fourth Games.

"When I started swimming again after my surgery, I was like, 'I'm never, ever going to be able to swim again.' I couldn't physically take a stroke in the water," she said after Saturday's heats. "I couldn't do anything. So, I am super proud to do this comeback."

Biles makes a flawed entrance

Veteran Chusovitina departs after a remarkable career

American gymnastics superstar Simone Biles got off to a shaky start in her quest for five gold medals and Olympic history in Tokyo on Sunday, as an Uzbeki mother-ofone bid a poignant farewell after a remarkable career spanning eight Games.

At 46 years old, Oksana Chusovitina, gold medallist at her debut Olympics in Barcelona in 1992, has earned the right to occupy her time in more sedate ways than exploding up a 25 metre runway and somersaulting backwards over a vault against competitors younger than her son.

She received a hugely affectionate ovation from her team, rivals, media and photographers when she narrowly failed to qualify for the vault at her eighth and last Olympics. Born in 1976, Chusoviti-

na's Olympic odyssey began in Barcelona in 1992, where she won team gold, adding silver in the vault in Beijing 2008.

Biles, who kept the wheels on her bid to level

Soviet great Larisa Latynina's record of nine gymnastics gold medals, but her qualifying performances were peppered with rare imperfections.

On the floor, Biles over-rotated after one series of mesmerising tumbles and went off the mat, drawing a gasp from at least one onlooker in the near-deserted Ariake

She rolled her eyes after another unsteady landing over on the vault, and her performance director Tom Forster expressed disbelief

beam routine. Biles qualified top in the all-around and vault, and was second on the floor, with the USA occupying the same position behind the Russians for Tuesday's team final.

But in the beam standings she paid for her flawed ending to lie sixth of the eight progressing. Biles also booked a place for the uneven bars final, though, which the 19-time World champion missed at Rio 2016, as the eighth qualifier. Another gold medallist,


Half-centuries from Nicholas Pooran and Jason Holder guided the West Indies to a series-levelling four-wicket win in the second ODI against Australia on Saturday.
