The Cairn Energy dispute with India over the settlement of a \$1.2 billion award from The Hague took a dramatic turn on Thursday, with the company saying it had secured a French court order allowing it to freeze at least 20 Indian properties in central Paris.

The Government of India, however, denied all knowledge of the latest order. It said it had filed an appeal against the tribunal decision of the Permanent Court at The Hague delivered in December 2020.

SC backs summons to FB by Delhi govt. riots panel

Social media can influence vast sections, says order

The Supreme Court on Thursday upheld the authority of Delhi Assembly's Peace and Harmony Committee to summon Facebook India's senior official Ajit Mohan in connection with the February 2020 communal violence, saying the Capital can ill-afford another riot, and the role of Facebook "must be looked into" in this context.

"It is difficult to accept the simplistic approach adopted by Facebook – that it is merely a platform posting third-party information and has no role in generating, controlling or modulating that information," a threejudge Bench, led by Justice Sanjay Kishan observed.

The 188-page judgment referred to how Facebook itself claimed to be the most popular social media plat-

form in India, with 270 million registered users. Social media platforms such as Facebook have become "power centres" with the ability to influence vast sections of public opinions, the court noted. These platforms are by no means altruistic in character. They employ business models that can be highly privacy intrusive. It compared Facebook to a "mass circulation media" with no or little editorial

responsibility. "Facebook has acknowledged in their reply that they removed 22.5 million pieces of hate speech content in the second quarter of 2020 itself," Justice Kaul, who authored the judgment,

observed. Facebook cannot claim any "exceptional privilege" to abstain from appearing before the Peace and Harmony Committee. The court termed Mr. Mohan's appeal "premature", saving no coercive action was taken or intended.

Will your officers follow law, HC asks Twitter

Centre free to take action in case of breach, says court

The Delhi High Court on Thursday directed Twitter to submit in an affidavit that its "interim" resident grievance officer, chief compliance officer and nodal contact officer will be fully responsible for its conduct under the IT Rules, 2021.

Justice Rekha Palli also clarified that "no protection is granted to Twitter from any action from the government in case of any breach of the IT rules".



The direction came after the court questioned a short note submitted by Twitter detailing the appointment of its interim officers in compliance with the new Information Technology (Intermediary Guidelines and Digital Ethics Code) Rules, 2021. "Where do you say that these interim officers are going to take all the responsibility of whatever is there under the IT rules? Tomorrow, you may take the benefit of the word 'interim'," Justice Palli said.

Senior advocate Sajjan Poovayya, representing Twitter, said the officers were bound to comply with the rules. Mr. Poovayya sought two weeks to get notarised affidavits from the U.S. regarding their appointment. Additional Solicitor General Chetan Sharma highlighted Twitter's short note, where the microblogging site said it had engaged the services of the interim CCO as a contingent worker via a third party contractor.

the State, where many prisoners "continued to languish in jail" despite proving their claim of juvenility.

An accused can raise a claim of juvenility at any stage of a criminal trial or even any time after his conviction and sentence of a crime. If the claim is found

true, the court should maintain the conviction, but set aside the sentence and forward the case to the Juvenile **Justice Board.**

A juvenile can be punished only for a maximum period of three years.

Arunachal to allow entry only to vaccinated people

State also providing incentives to residents who are reluctant to take the jab

The Arunachal Pradesh government has decided to allow only vaccinated people

into the State. The government has also gone in for aggressive testing for COVID-19 and inoculation, with 68% of the people aged 18 and above having received their first dose of

"We are ensuring that if anyone wishes to visit Arunachal Pradesh, he or she has to be vaccinated prior to entry," Chief Secretary Naresh Kumar told Union Home Secretary Ajay Kumar Bhalla during an online meeting on July 7.

Mr. Kumar said the State had adopted a threepronged strategy to stop the spread of the coronavirus. These were extensive tracking and testing, enforcement of pandemic-appropriate behaviour and vaccination.

"Arunachal Pradesh needs an additional three lakh COVID-19 vaccines to achieve 100% coverage of beneficiaries in the 18-plus and 45-plus age groups," he said.

Vaccination as a condition for entry follows the State's bid to provide incentives to tant to take the jab. Officials in the Yazali circle of the State's Lower Subansiri district were one of the first to offer 20 kg of rice free to the 45-plus for taking the jab.


Cash awards

Some districts of Manipur and Meghalaya also offered cash awards to maximise vaccination coverage. Assam, Meghalaya and

Manipur linked business and salaries of employees to vaccination. While traders and commercial vehicle operators were asked to operate after vaccination or display their vaccination status for

customers and passengers to decide whether or not to use their services, some frontline workers were told that their vaccination status would be ascertained before payment of salary or wage. In Meghalaya's capital

Shillong, some NGOs and a local MLA were panned for leaving out the non-vaccinated people while distributing food items to people without ration cards on July 6. The organisers of a COVID-19 relief camp in the city's Happy Valley-Madanriting had announced that rice and other essentials would be given only to vaccinated people.

Third accused in Kitty murder case on the run

House help undergoing treatment

A day after police arrested two persons in connection with the murder of Kitty Kumaramangalam – lawyer and wife of former Union Minister P. Rangarajan Kumaramangalam - at her Vasant Vihar residence, the police said they are yet to arrest the third accused.

A senior officer said three teams are working round the clock to nab the third accused. Surai Rajasthan.

"Surveillance has been mounted and we are aware of his suspected hideouts. Raids are being conducted," the officer said.

'Fled to Rajasthan'

Suraj is suspected to have fled to Rajasthan and is in possession of gold robbed from Kitty's house.

Two persons - the victim's washerman, Raju, and his friend Rakesh Raj – have been arrested for the

The Delhi Police Cyber Cell registered an FIR against the "Sulli Deals" app where photos of Muslim women were being displayed without their consent, a senior police officer said on Thursday.

The Delhi Commission for Women (DCW) had issued a notice to the police regarding the same and sought a detailed action ta ken report.

Delhi Police PRO Chinmoy Biswal, said: "Acting on a complaint received on the National Cybercrime Reporting Portal regarding 'Sulli Deals' mobile application, a case under Section 354-A of the IPC has been registered on Wednesday and investigation taken up."

He said notices have been sent to "GitHub" app to share the relevant details.

According to media reports, the app came to notice when people started sharing their pictures with the term "sulli deal of the day" on Twitter, the panel had said. "Subsequently, many women had to leave social media platforms after their images got circulated. This is a very serious matter and constitutes crime," the DCW had said.

Telephone exchange racket busted in city

Main accused absconding, identified

In a joint operation, Delhi police and telecom department busted a racket, which allegedly converted international calls into local ones, posing threat to national security, said a senior officer on Thursday.

"We have identified the people operating the exchange. They will soon be arrested. The illegal telephone exchange converted international calls into local calls, causing revenue loss to the government," said the officer.

He said after getting tipoff regarding illegal telephone exchange operating in Central Delhi's Daryaganj, a raid was conducted along with officials of telecom department.

In the raid, they seized large numbers of routers, servers, SIP trunk, fake identities (for buying mobile phones) and other illegal equipment from the spot.

Experts warn as govt. reduces number of beds

Hospitals, COVID Care Centres set up during the second wave will not be dismantled immediately this time, say authorities

SPECIAL CORRESPONDENT NEW DELHI

As the number of active virus cases in the Capital dip below the 1,000 mark, the Delhi government has started to deescalate the number of CO-VID-19 beds at private hospitals and at COVID Care Centres across the Capital.

Facilities at the Yamuna Sports Complex and Sardar Patel Covid Care Centre at Chhatarpur, that came up in April to tackle the second wave, have been reduced to 50 and 200 beds respectively. Four COVID Care Centres have also been closed.

The Delhi government said that with the cases declining, there are a large number of vacant beds that are required by patients suffering from non-COVID-19 ailments. Those private hospitals that were asked to reserve 80% of their bed capacity for COVID-19 patients have now been asked to reserve 30% of their total bed capacity.

However, it added that in case there is a rise in the number of COVID cases, the number of beds shall be immediately augmented. "Present available beds are sufficient to handle the active cases and COVID Care Centres can be started very soon if there is a requirement," a government spokesperson said.

The health bulletin released on Wednesday showed that out of 14,478 hospital beds available for COVID-19 patients, 13,989 were vacant and of the 3,871 beds available at COVID care centres, 10 were occupied.

More cautious approach

After the previous wave in November 2020, most of the temporary facilities set up to augment the number of beds to deal with the surge of CO-VID-19 cases were dismantled. This time, however, authorities are taking a more cautious approach as the threat of a third wave looms.

A source in the defence services said that hospitals set up during the second wave will not be dismantled

and will be continued for so-

"We will hand over the hospitals set up by the DRDO to local authorities for keeping it safe without operation if the hospital is not required but we will not be dismantling them," said a defence source about the DRDO setup hospital.

Several health professionals warn against completely dismantling augmented facilities and felt that the COVID Care Centres by the Delhi gofunctional for a longer time as the infection spreads through periodic waves.

H.K. Mahajan, chief of anaesthesia, Indian Spinal Injuries Centre said that there was a need to wait for some more time before dismantling facilities.

'There was a shortage of beds, oxygen and medicines during the second wave. It is the right time to review the past mistakes and prepare for the future. There is a need of plenty of medicines, oxygen and beds so that the country can deal with a possible third wave successfully," Mr. Mahanjan said.

Invest in infrastructure

Siddharth Rastogi, executive director, MVS Engineering Pvt. Ltd. that provides on-site oxygen generators says that the government was caught off guard in the second wave due to the rapid spread and inadequate infrastructure.

"It will be advisable to mothball the infrastructure rather than dismantle it. Now, that the second wave seems to be ebbing, we are seeing many hospitals once again putting their decision to instal an on-site generation system for oxygen on the backburner as their delivered oxygen supplies have normalised. However, hospitals should not let their guard down and continue with their plans on investing in the infrastructure for oxygen independence immediately," Mr. Rastogi said.

He added that the ongoing closing of COVID centres in Delhi and elsewhere must not be pursued in the immediate term because the virus has still not gone away. The spectre of the third and a potentially more damaging wave still hovers over us. And so, preparing for the worst, hospitals must go ahead full throttle with their plans of installation of on-site oxygen

'Still not serious'

generation plants.

A.K. Jhingan, diabetologist, Delhi Diabetes Research Centre, says that the second wave may be over, however, by September-end, the third wave may hit the Capital and will be potentially as severe as the second wave according to the modelling study by the team of scientists.

"The attitude of the government is still not serious. We have witnessed chaos and very high mortality during the second wave as we were not prepared to handle it. The lessons should not be forgotten and we should be well prepared to handle such a situation if it arises," Dr.

93 fresh cases and three deaths in city

A total of 22,350 people were administered the vaccine on Wednesday, taking the total number of vaccinated people to 85,20,756, as per data provided by the Delhi government's vaccination bulletin.

According to it, 11,789 beneficiaries were administered first doses while 10,561 received the second dose. The bulletin also stated that the city currently has two days' stock of vaccine with 3,16,000 doses available for inoculation.

SC rues daily tussle between Centre, Delhi govt.

Lack of maturity responsible for inability to work in tandem, says apex court

A lack of maturity by both the Centre and the Delhi government has led to governance tussles on a daily basis between the two on every aspect, the Supreme Court said in a judgment on Thursday.

A Bench led by Justice S.K. Kaul said the "unique" interrelationship between different political dispensations in the Centre and Delhi had worked well for years until

"The last few years have seen an unfortunate tussle on every aspect with the State government seeking to exercise powers as any other Assembly and the Central government unwilling to let them do so... it is almost a daily governance tussle," Justice Kaul noted.

The court addressed the Arvind Kejriwal government in Delhi directly in its judgment, saying "the political dispensation which is in power in the State has to recognise the constitutional scheme of division of powers in Delhi which circumscribes their ability to work only within those powers. When they got elected, they knew what they were getting elected for – not what they thought should be the division of powers".

Now, turning to the Narendra Modi government in the Centre, the apex court observed that "the Central government is required to work in tandem, albeit with a different political dispensation". "Maturity is required from both sides and we have to reluctantly note the absence of such maturity in this important interrelationship," Justice Kaul wrote.

The court said the inability of the Centre and Delhi government to see eve-to-eve on governance issues in the Capital has been responsible for a spate of litigation. "Repeated judicial counsel to work in tandem has not been successful," the court noted.

Assembly panel hails SC order on FB plea

'Top court recognised privileges and power of Delhi Assembly's committees'

The Delhi Assembly's Peace and Harmony Committee chairman Raghav Chadha welcomed the judgment passed by the Supreme Court refusing to quash summons to Facebook India's vice-president Ajit Mohan.

The committe was formed after the Delhi riots last year.

Mr. Chadha said, "While dismissing the petition filed by the three petitioners -Ajit Mohan, VP and MD of Facebook India, Facebook India itself and Facebook Inc. – the apex court recognised the privileges and power of the Delhi Legislative Assembly's Committees on par with parliamentary privileges and those of other Legislative Assemblies.

"Significantly, the court has also reaffirmed that as part of these privileges, the Committee of Peace and Harmony is entitled to summon 'non-members' to appear before itself in order to nance that lie within its remit and terms of reference," Mr. Chadha stated.

Pertinently, Mr. Chadha also stated that the court had held that since no coercive action had been taken against Mr. Mohan and the notice issued to him was to seek his assistance in examining larger social issues concerning the well-being of citizens, any representative of Facebook India must appear before the committee.

"While a full copy of the judgment is awaited, it is clear that the court has reaffirmed and acknowledged the important role of the Committee of Peace and Harmony," Mr. Chadha stated.

"The panel, like other legislative committees of the Assembly, is keen on continuing a genuine deliberative process on issues of concern in the NCT of Delhi with full participation of all concerned," he said.

Will fight for Khori Basti ⁺ residents till my last breath'

Ex-MP Udit Raj among those detained during protest

Former Lok Sabha MP and Congress national spokesperson Udit Raj along with several others, mostly residents of Khori Basti in Faridabad, were detained by the Delhi police on Thursday for allegedly trying to gherao the Prime Minister's office seeking repeal of the Supreme Court order for demolition of the 170-acre colony on forest land.

Those detained were let off later in the evening.

The Khori Basti residents had earlier demonstrated at Jantar Mantar on June 29 and also marched towards the PMO's office two days ago.

Addressing the protesters, Dr. Raj said his "arrest was the beginning of the war against the dictator Modi government". He said that this was a war between the rich and the poor. "I will fight the battle of Khori Basti till my last breath," said Dr. Raj, national chairman, All India Confederation of Scheduled Caste and Scheduled Tribes organisations.

Leaders yet to respond

Confederation's leader Sanjay Raj, who was also detained, said they had been seeking an appointment with Prime Minister Narendra Modi for several days, but there was no response. "Neither Haryana Chief Minister Manohar Lal nor Mr. Modi have heard the complaints of thousands of innocent





villagers. The residents of Khori Basti have been requesting the PM to cancel the order of the Supreme Court so that the lives of lakhs of people and their houses can be saved in these times of pandemic," said Mr. Raj.

Social activist Meenu Verma said it was inhumane to render thousands of children homeless when the danger of a possible third COVID-19 wave of was looming large. "If the houses of these people are illegal then why were votes taken from them by making false promises," asked Ms. Verma.

Meanwhile, Faridabad district administration has offered free-of-cost transportation service to the Khori Basti residents ahead of a massive demolition drive expected to be kicked off in the next few days.

They claim the syllabus is focusing excessively on 'Hindu and Hindi'

The University Grants Commission's new curriculum framework for history in undergraduate classes has come under criticism from teachers in West Bengal for being excessively "Hindu and

"The emphasis is on what is known as the Indic culture,

which is their way of saying that India is home to Hinduism, Buddhism and Jainism and therefore implying - though not saying so in as many words – that Islam is alien," Prof. Kingshuk Chatterjee, who teaches history in the University of Calcutta, told The Hindu.

No mention of Akbar

The proposed syllabus, to the surprise and amusement of many teachers, makes no mention of Emperor Akbar and largely depicts Mughals as people resisted by the Rajputs and the Marathas. It uses the term "Indus Saraswati

Civilisation", in place of Indus Valley Civilisation; emphasises on the Vedas and seeks to educate students on, among other things, "Indian perception of Dharma and Darshan" and "Science and Technology in Ancient India". The module on the 'Glory of Indian Literature', they pointed out, makes no mention of the Arthashastra or Charaka Samhita while the module on the 'History of Communication in India' recommends the examples of "Narada, Krishna, Buddha, Shankar, Vivekananda and Gandhi".

"When the BJP came to

power the first time (under Prime Minister Atal Bihari Vajpayee), there was an attempt to tinker with the school syllabus. This is the first time there is an attempt to saffronise college textbooks," said Prof. Chatterjee, adding that it was not mandatory for States to accept this syllabus. The biggest irritant for

teachers in West Bengal is the inclusion of a large number of Hindi books in the lists of 'suggested readings' for each paper. Books by well-known historians such as Irfan Habib and R.S. Sharma are conspicuous by their absence.

Cabinet shuffle aims to improve governance while keeping in mind political considerations

The reconstitution of the Union Council of Ministers on Wednesday was guided by both political and administrative considerations. As many as 36 new faces were inducted and 12 dropped from the council, which now has 78 members, just three shy of the upper limit of 81. In 2014, the Bharatiya Janata Party (BJP) began its rule advertising its 45-member Council of Ministers as an attempt at minimum government, but the restraint was quietly abandoned in the following years. The political aspirations of communities and regions are difficult to satiate in a country as vast and diverse as India. Prime Minister Narendra Modi has made an attempt to make his Council more diverse and representative, in a manner that fits his political priorities. The new composition of the Council is in step with the BJP's relentless efforts to rope in OBC groups, Dalits and tribes people under its Hindutva umbrella politics. This accommodation is crucial for the BJP to continue its dominance in Uttar Pradesh, Bihar and other Hindi-speaking regions, where caste tensions are simmering. New inductions and elevations also signal a continued effort by the BJP to expand its influence to new areas such as West Bengal and the northeastern States. Barring the continuing under-representation of Muslims, the council is impressively representative of Indian diversity.

Governance issues might have been a factor in the axing of some of the Ministers. Harsh Vardhan, Ravi Shankar Prasad and Prakash Javadekar were among those who got the marching orders, apparently for mishandling the pandemic, relations with global IT giants and governmental communication, respectively. New inductees such as Ashwini Vaishnaw and Jyotiraditya Scindia have administrative skills that could prove valuable in crucial ministries that they now head. Individual talent and accountability both can only be contextual, and in a highly centralised system they become immaterial. The Ministers must be empowered to plan and take decisions in their respective areas. The notion of collective responsibility of the cabinet must be infused with meaning. Discussions in the cabinet must be open. Proposals that come for the cabinet's consideration must go through rigorous technical vetting and wide political consultations. The recomposition was intended to enhance governance, rev up the economy and fuel the BJP's political march ahead of crucial State elections and the 2024 Lok Sabha elections. All these would be possible only if all hands are on the deck. Assembling a team is indeed a crucial task of a captain; allowing them to flourish as individuals while playing as a team is equally critical.

This year's restrictions by States have inflicted less economic costs than the 2020 lockdown

ntering its fifth year, India's Goods and Services ≺ Tax (GST) system reported a blip in revenue col-✓ lections for June, breaking an eight-month streak of over ₹1-lakh crore in tax receipts. GST revenues tanked to a tad less than ₹93,000 crore last month – the lowest in 10 months – after a record ₹1.41-lakh crore in April and a relatively tepid ₹1.02-lakh crore in May. Generally, the June revenue reflects transactions that occurred in May. With the second wave of the pandemic in full flourish and States enforcing rigorous restrictions on most activities in May, the numbers are not really surprising. However, as May GST compliance dates for smaller taxpayers were extended till early July, some of this revenue also reflects April's sales. Thus, the actual GST income attributable to May's economic activity would be lower than June's gross GST kitty. This is also reflected in the generation of e-way bills, which fell by a sharp 30% in May compared to April, while the sequential decline in revenues was not as steep. With caseloads declining over June and restrictions being pulled back gradually, revenues should pick up next month with 5.5 crore e-way bills generated in June from 3.99 crore in May. Despite the slowdown in May-June, GST collections in the Q1 of 2021-22 have been healthier than prepandemic levels, confirming that this year's restrictions driven by States have inflicted less economic costs than the national lockdown at a few hours' notice, in 2020.

While the second wave setbacks have shaken up business and consumer sentiment, average monthly revenues of over ₹1-lakh crore – which Finance Minister Nirmala Sitharaman has termed the 'new normal' for GST - could perhaps sustain through the year, if there is no dramatic resurgence of the pandemic and vaccinations are ramped up as promised. This should give some fiscal breathing room for the Centre and States, but neither can afford to sit back. Structural corrections in the GST regime and the inclusion of petroleum and electricity may take longer, but there is enough that needs immediate attention. Industry has sought temporary rate cuts on some sectors to spur demand. It is plausible that a volume pick-up could make up for resultant revenue losses, just as an uptick in petrol consumption creates room for a revenue-neutral duty cut on fuels. The GST Council must be reconvened soon to take up such ideas to prod the economy's rebound, apart from holding the promised special session to discuss all the brewing concerns related to States' compensation. Delaying this will not only foster greater misgivings between the Centre and the States but also make it tough for States to plan their borrowings for the rest of the year. Clarity is also needed urgently on when the ₹1.58lakh crore of back-to-back borrowings for States in lieu of compensation dues will begin. If the Centre plans to raise ₹5,000 crore a week, like it did last year, it will take roughly 32 weeks to complete such borrowings; so, any delay beyond early August may not be viable.

Troubling prospects in Afghanistan

As the reality of the U.S. withdrawal takes hold, the future will depend on Taliban-Kabul dynamics and Pakistan's role

ast week, on Friday, the United States handed over the Bagram airbase to the Afghan authorities, marking a symbolic end to its military presence, as U.S. forces complete their withdrawal well ahead of the September 11 deadline, announced by American President Joe Biden on April 14. A familiar air of uncertainty surrounds Kabul as the Afghans ponder over the future of their land, ravaged by conflict for nearly 50 years. Afghanistan's immediate neighbours are now faced with a new challenge – how to persuade the Taliban against overplaying their military hand?

A costly misadventure

Could anyone have predicted when the U.S. commenced its military intervention in Afghanistan in October 2001 that it would get embroiled in an endless war for 20 years and to exit safely, it would have to negotiate with the Taliban, the same entity that it went in to

It has been a costly lesson. The war effort has cost \$980 billion, over 2,400 U.S. soldiers (plus 1,144 allied troops) and 388 private military contractors have lost their lives. It also spent \$143 billion on reconstruction; about \$90 billion went for the Afghan army, police and other security forces, \$36 billion for governance and economic development activities (the rest of the international community contributed an equivalent amount) and the balance on counter-narcotics and humanitarian relief works (https://bit.ly/3ADTcP7).

Yet, the real price has been paid by the Afghans. The 20-year war has claimed the lives of nearly 50,000 Afghan civilians and nearly 70,000 Afghan security forces (a majority during the last seven years); add to it another 60,000 Afghan Taliban, and the scale of the Afghan human loss becomes evident.

There have been gains too. In 2001, there were 9,00,000 boys in school. Today, eight million children attend school and a third are girls. Literacy is up from 12% in 2002 to 35%; life expectancy from 40 to 63 years. Urbanisation is 26% and 70% of the population watch TV. From 320 miles of paved roads in 2002, today, tarred roads cover 10,000 miles. Infant mortality rates are down from 20% by over half. With a median age of 18.5 years, a majority of Afghans have grown up in a post-Taliban era. Today, they bear the brunt of 130 daily Taliban/IS Khorasan (IS-K) attacks, the highest since the U.S. ended combat operations in end-2014. Tomorrow, even these limited gains are at risk.

Taliban gains legitimacy

For U.S. President Bush, the objective was "to build a stable, strong, effectively governed Afghanistan that won't degenerate into chaos". As the U.S. shifted from counterterrorism to counter-insurgency, shades of Vietnam began to emerge. To Hamid Karzai's credit, he saw the writing on the wall when he protested about the night-raids and warned the Americans "to either take the fight to the safe havens and sanctuaries across the Durand Line or make peace with the Taliban" but it only soured his relations with the U.S.

Eventually, U.S. President Barack Obama diluted the objective to "preventing Afghanistan from becoming a safe haven for global terrorism". He oversaw a success-



ful operation to eliminate Osama bin Laden in 2011, implemented an unsuccessful military surge concluding with an end to combat operations in end-2014 and Taliban opened the Doha office in

U.S. President Donald Trump saw himself as a deal-maker and in 2018, initiated direct negotiations with the Taliban. Ambassador Zalmay Khalilzad (U.S. Special Representative for Afghanistan Reconciliation) began by setting out four elements – a ceasefire, cutting ties with al Qaeda and other terrorist groups, intra-Afghan peace talks, and, a withdrawal of all foreign military forces, declaring that "nothing is agreed till everything is agreed". Within months, the Taliban had whittled down the U.S. demands till it got what it wanted – a withdrawal timeline not linked to the other factors. In addition, the Taliban managed to get the U.S. to push the Kabul government to release over 5,000 Taliban cadres in custody. In short, the U.S. ended up legitimising the Taliban at the expense of the government in Kabul that they had worked to create and support.

U.S. President Joe Biden was no stranger to the Afghan dossier. He was convinced that the U.S. had to exit from its quagmire of "forever wars". The U.S. may have decided that it had no military options but the Taliban are still pushing ahead militarily.

From less than a fifth, today, over a third of Afghanistan's over 400 districts are under Taliban

control. The day after the exit from Bagram, 13 districts, in Badakhshan, Takhar, Paktia and Kandahar fell to the Taliban, adding to the 50 that have fallen since May. In many cases, the locals manning the security posts and checkpoints have just surrendered. From villages and towns, there is already a move towards the cities. Intra-Afghan talks in Doha have been in limbo for months.

Questions about the future

Gen. Austin S. Miller, the U.S. commander in Afghanistan, indicated in a recent press conference, "Civil war is certainly a path that can be visualised if it continues on this trajectory."Dr. Abdullah Abdullah, Chairman of the High Council for National Reconciliation, warned on June 30, "The truth is, today the survival, security and unity of Afghanistan is in danger...."

Ironically, the most vocal critics of the U.S. overstaying in Afghanistan and hinting that the U.S. would never leave are the ones now blaming the U.S. for a hasty and irresponsible withdrawal.

In coming months, as uncertainties mount, there will be increasing Taliban presence in the countryside as the Kabul government concentrates on ensuring security in urban areas and of the road networks. The Taliban military strategy has been to target districts that enable them to surround provincial capitals. The clutch in the northeast including Badakhshan, Takhar, Kunduz and Baghlan enable them to control the Afghanistan-Tajikistan border and the Wakhan corridor that links to China. In the east, they exert control in Ghazni, Zabul and Paktia while the Haqqani network is active in Khost and Paktika, and the IS-K in Nangarhar, Kunar and Laghman. Further south, the Taliban control large parts of Kandahar, Helmand and Farah (border-

As the reality of the U.S. withdrawal takes hold, how events unfold by end-2021 depends on three factors. First, have the Taliban changed their ideological colours? The U.S. in recent years, and Pakistan for much longer, have been pushing this line but the Taliban leadership have given no clues about it. Related to this is the question of Taliban unity. Distances have grown between the Quetta shura, the Doha negotiators and the fighters who want to guard their individual preserves. This works as long as everyone is pursuing the military option, but when it comes to power sharing, who calls the shots? Or, does it lead to no power sharing?

Second, can the Kabul regime present a unified front? If the leaders in Kabul and the government continue sniping at each other, it will adversely impact the integrity of the chain of command of the Afghan security forces. If opportunistic leaders are tempted to strike their own deals with the Taliban, it will only hasten the collapse, and even western funding will dry up.

The Pakistan factor

Finally, is Pakistan still seeking strategic depth in Afghanistan or has it realised that a Taliban-dominated Kabul will be a magnet for its own home-grown extremists as well as those from the neighbourhood? Can it persuade the Taliban that its legitimacy will be at risk unless it shares power? Pakistan's influence will weaken once the Rehbari Shura decides to move back from Quetta to Afghanistan.

History tells us that in Afghanistan, there have only been winners and losers, seldom any lasting compromises.

In a passing, the larger picture of dispossession

Blaming 'the system' alone for Father Stan Swamy's death obscures how India's political economy is linked to deprival

Then an officer from the National Investigation Agency (NIA) came to interrogate Father Stan Swamy last on the Iesuit sociol then 83, in turn asked him about police integrity, and why a fatherson duo (P. Jayaraj and Bennicks) should die of custodial torture in a Tamil Nadu police lock-up. It was quintessential Fr. Swamy: unafraid, outspoken, and questioning injustice.

Fr. Swamy was sent to Taloja Jail in October 2020 in the Bhima Koregaon case, where some of his coaccused have now spent more than three years without bail or trial. All have been charged under the Unlawful Activities (Prevention) Act (UAPA), a widely misused tool for governments to criminalise lawful dissent and hold ideological opponents in prolonged incarceration. For all the talk by authorities of a terrorist conspiracy, Fr. Swamy was never interrogated in nine months of custody. His arrest in the middle of the pandemic, over two years after the first raid on his spartan one-room residence, seems like targeted viciousness

All Indians have dignity, not just the wealthy and the privileged. This belief guided Fr. Swamy's lifelong concern for justice, as I saw in my interactions with him over the years as a journalist.

Adivasis and loss

When he first came to West Singhbhum from his native Tiruchirappalli in Tamil Nadu in the 1970s, living among the Adivasi communities profoundly shaped him. He had told me in an inter view, "I underwent an awakening, looking at Adivasi values of equality, community, and decision-making by consensus." His work firmly rejected the prejudice of Adivasi 'backwardness', and tirelessly pointed out how violence and dispossession was pushed down their throats and called development: "Adivasis lived on lands full of minerals. Others took these out and enriched themselves, but Adivasis did not get anything.'

In a decade-long tenure as Director of Bengaluru's Indian Social Institute, he trained countless grass-roots activists. He continued this work when he co-founded the Ranchi-based Bagaicha in 2006 – a centre for research, training and social action dedicated to working with Adivasi and other marginalised communities and legally empowering their struggles for justice and dignity. As long-time friends and colleagues testify, Fr. Swamy wanted it to be a place which the marginalised felt was



and a megalith with the names of those killed in anti-displacement protests marked Bagaicha's central ground. Its one room library contained reports, studies and files of newspaper cuttings on issues such as forced displacement, hunger deaths, extra-judicial killings and grassroots protests - a buried history of India's democracy.

Helping hand for undertrials

When I first met Fr. Swamy in 2013, his team was immersed in efforts for poor undertrials in prisons across Jharkhand against a raging armed conflict. After three years of painstaking research based on prison visits, meeting police officials and villagers, and Right to Information Act requests, his team released a report that included the case studies of over 100 UAPA undertrials. Overwhelmingly, they were Adivasis and Dalits, and in some cases they had languished in the criminal justice system for up to 10 years. About 59% of the households of undertrials, the report found, earned under ₹3,000 per month and were forced to sell assets such as goats to meet bail conditions or legal expenses. Fr. Swamy also filed a public interest litigation on the basis of his team's findings, which is still being heard in the Jharkhand High Court. As he publicly stated before his arrest, he believed that such efforts to challenge an unjust status quo led the state to target him.

Fr. Swamy's demise has led to a iblic outpouring of sadness ar anger at the cruelty of our criminal justice system. Ever self-effacing, he would have wanted this attention not on him but on the resource grabs that continue to inflict staggering violence against Adivasis and other marginalised groups, fill our prisons with people with little access to justice, and necessitate draconian laws such as the UAPA. To blame 'the system' or 'the government' for his death is to overlook how we are implicated in this political economy founded on dispossession, and the everexpanding criminalisation of defor social environmental justice as conspiracies against the state.

The human rights activist, K. Balagopal, had argued that an abiding legacy of liberalisation is the deleg-

Liberalisation, the oppressed itimisation of concern for the oppressed. This is why a man who strove all his life for solidarity, fraternity and justice in real terms

stands accused by our government of promoting enmity. And why his death, while foretold, transcends textual analyses of the UAPA, courtroom proceedings and prison reforms.

Fr. Swamy had one chance to appear in court, when a Bombay High Court Bench asked for him to be presented via video-conferencing from Taloja jail on the afternoon of May 21. Battling multiple ailments including Parkinson's disease, diminished hearing, and by then COVID-19 contracted in prison, he was visibly ailing, but as always full of self-respect.

He told the court that prison conditions were steadily destroying his abilities to read, write and walk, and that he be granted bail to return to Ranchi to be with his own. In rejecting the judges' suggestion that they send him to hospital for a few days, Fr. Swamy asserted his dignity and innocence, and registered a moral protest against being effectively made to serve a death sentence, as an indefinitely imprisoned undertrial.

As now well known, a dying man's final wish to return to Jharkhand, to the people he loved and with whose struggles he had become one for over five decades, went unheard. These struggles will keep Father Stan Swamy's quest for a more democratic India




Should only elected legislators be eligible for chief ministership?

The option provided in the Constitution should be used with honesty, not just to tinker with politics

The sudden exit of Tirath Singh Rawat as Chief Minister of Uttarakhand, a development the Bharatiya Janata Party sought to explain in terms of a constitutional roadblock to being elected as a legislator within six months, has led to thickening speculation about the fate of West Bengal's Mamata Banerjee, another unelected Chief Minister. In a conversation moderated by Abdus Salam, M.R. Madhavan and S.Y. Quraishi thread through precedents and procedures as all eyes are firmly fixed on the Election Commission of India (ECI)'s next moves. Edited

Should Chief Ministers be mandatorily picked from the pool of elected MLAs? Or at the very least, should a Member of Parliament resign immediately from the House if picked to lead a State?



whole concept of the person being the popular choice of the elected people. So, the Chief Minister is an indirectly elected person by the directly elected members. But now the Chief Minister dictates how each of those persons will vote, because with the anti-defection law, we have weakened that accountability mechanism drastically. What is the way out? Not very clear.

The second part of your question

is much clearer. If you look at various other parts of the Constitution, it's clear that the Constitution expects a person not to hold more than one constitutional position at a time. If you look at Article 101, it says that if a person is a member of both Houses of Parliament, he or she loses membership of one; if a person is an MP and gets elected as an MLA, or vice versa, he or she has about 14 days to resign from one.

When you are an MP and become the Chief Minister, you are the head of the executive of that State. So, what is your primary role? Is it to vote as a Member of Parliament? Or is it to be in the State and attend the State's legislature and be accountable to it? In that at least, we should definitely amend the Constitution to say that if you are going to be the Chief Minister or a Minister of a State, you should resign your membership of another House before taking up the role. That is, one should not occupy two constitutional offices concurrently.

S.Y. Quraishi: Whether it's a good thing or a bad thing is not the issue for us to decide, because the framers of the Constitution provided for this fresh air coming from outside, if need be, with the condition that within six months they need to get elected. It's a good provision and I feel we don't need to tinker with it because it does restrict options. Of course, this option should be used intelligently and with full honesty, and not just to tinker with politics. And it should be used sparingly.

So, you want the door to remain open for lateral entry. Coming specifically to Tirath Singh Rawat's case, was his election as MLA a constitutional impossibility?

the election. Didn't he anticipate that he would have to get elected in the thick of COVID-19? To say that in the time of COVID-19 it will not be advisable to conduct elections and therefore I'm resigning is a very flimsy excuse. It is some kind of a deeper political calculation. It's a build-up for something more serious, to create the precedent for West Bengal [bypolls] whereas the entire West Bengal [Assembly] election was held during COVID-19. And the Bihar election was held during COVID-19, and it was very well done. The ECI issued guidelines for CO-VID-19 before the Bihar election, which were beautiful. By then, it had the global experience of 70 countries which had conducted elections in the thick of COVID-19 and done them very well, [to learn from]. India learnt a lot from all of them, and then formulated its own guidelines. Having conducted a bigger election, what stopped the ECI from conducting a by-election in Uttarakhand? My feeling is that a scene may be created where byelections won't be held. This should not create a precedent - that it would be dangerous to hold a

MRM: The constitutional position is clear, right? If she doesn't get elected, she can't be the Chief Minister. It is the job of the ECI, and not of anyone else, to ensure that there is

that is the only security risk of CO-VID-19. Nobody has any reason to complain because the rules apply to all parties.

Given the extraordinary circumstances of a pandemic raging since early 2020, should we as a polity be flexible on constitutional and legislative deadlines?

MRM: I would say that you cannot defer the elections; you'll have to pull them off in some manner. The U.S. did that. If you say that under extraordinary circumstances, the constitutional requirement of parliamentary elections in five years could be deferred, then you will find people figuring out ways to create extraordinary situations more and more often, and these situations will become ordinary.

The ECI has the choice, because if an election is not held, it leads to a constitutional crisis. And the ECI's job is to ensure that there is no constitutional crisis instead of creating one. Under Section 151 of the Representation of the People Act, it is provided that if only one year is left of a House, a by-election will not be held. But it is actually at the discretion of the ECI to make an exception. And it has been making an exception only for the Chief Minister. Because in a House of 200-300, about three-four vacancies are always there. The government being allowed to fall because the ECI says it cannot hold an election... that would be the very unbecoming of the Commission. Now, in Section 151, a subsection provides that the ECI in consultation with the Central government certify that it is difficult to hold the by-election within the set period. I hope we don't read into

There's also the question of institutional resilience. What more can be done to insulate bodies such as the ECI from being seen as susceptible to external pressures?

MRM: There's a legitimacy of a government being formed in a free and fair election, and everybody subscribes to that. If that legitimacy is undermined, we are in deep crisis. What does the legitimacy rest on? It rests on public belief and public trust in the ECI holding free and

fair elections. The ECI has been a very trusted institution for a fairly long time now. Is that public trust getting bigger or not? That's a big question.

SYQ: The ECI has a constitution designed for it to be insulated from the government. Which is why once appointed, the Chief Election Commissioner cannot be removed except through impeachment. Now, there are two reforms that we have been shouting for. The Commission is appointed by the government of the day without consulting the Opposition. It is a different matter that all the Election Commissioners appointed through this route performed very well. And we hope that it will continue to happen. But hope is not a strategy, a system has to be in place. Nowhere in the world does such a situation exist. In some countries, there is scrutiny by Parliament. In some cases, the candidates are interviewed by Parliament. The systemic change we are pleading for is that appointments should be through a collegium. And promotions should be automatic, on the basis of seniority. Second, the removal procedure of the two Election Commissioners. They are not protected, so they feel they are on probation. They're always looking over their shoulder to see if the government is happy with them or not. That fear is absolutely dangerous and disastrous. So, that protection has to be provided. Government after government has not paid any heed to this extremely important and critical issue. And even the Supreme Court has not claimed the issue, despite its grave importance.


MRM: Today, the CBI [Central Bureau of Investigation] Director is appointed by a committee which includes the Chief Justice of India, the Prime Minister and the Leader of the Opposition. Is the ECI far more fundamental and important an institution than the head of the CBI? Obviously, yes. This would also provide greater authority to the Commission because appointments would be made after an agreement across political lines. The Central Information Commission is not a constitutional body, it is a statutory body, but appointments are through a collegium. The CBI is not even a constitutional or statutory body. Why do we have our priorities upside down?

Tracking fugitives everywhere

In the absence of a coordinated database, criminals can go undetected

Indian law on extradition is spread across the Indian Penal Code as well as various laws pertaining to narcotic drugs, Information Technology, hijacking, and so on. Procedural laws have the Code of Criminal Procedure as their backbone but there are other laws too, such as the Extradition Act, the Narcotic Drugs and Psychotropic Substances Act, the Prevention of Corruption Act, the Prevention of Money Laundering, and so on.

Investigation and prosecutionThe bulk of the investigation and pro-

secution work happens at police stations in the States, while Central agencies take up the important cases. Central agencies have developed reasonable expertise because they are focussed only on investigation and prosecution work, whereas State police forces (except specialised wings) are engaged in law-and-order work as well as investigations. There is a tendency to close investigations once the accused have absconded, and an overwhelming tendency to bank on statements obtained from the accused or during interrogation before closing investigations. It would be interesting to know what proportion of arrest warrants obtained by investigation agencies of States pertain to persons who have absconded or are 'wanted', whether within India or abroad. Some police stations do initiate proceedings for attachment of property and declaration of the accused as proclaimed offenders, but the number of cases where coordinated efforts are made to pursue fugitives - domestically or internationally - are hardly documented. If the number of Red Corner Notices issued are of any indication, only about 750 such criminals are wanted by Indian agencies. The number of Blue Corner Notices issued is about 300.

Theoretically there exists a system of tracking criminals worldwide - through Interpol Notices and the sharing of immigration databases of different countries - but there is no coordinated system or database for tracking criminals or wanted persons domestically. In the absence of such a system, it is relatively easy for cri-

minals from one police station/jurisdiction to melt into the population in any other area, almost undetected.

Requirements

The creation of a nationwide database of wanted persons, which could be accessible for police agencies, the public and others (like passport and immigration authorities), is imperative. The Crime and Criminal Tracking Network and Systems and the National Intelligence Grid are efforts in the right direction, but more integration is desirable. Perhaps a nationwide system of 'Wanted Persons Notices', similar to Interpol Notices, is required, to help track fugitives domestically. Countries like the U.S. have functional inter-State extradition and fugitive tracking systems; India needs to set up such dedicated 'fugitive tracking units'. There needs to be enhanced integration between immigration agencies, State police agen-Interpol-New Delhi, the External Affairs Ministry and Home Ministry and central investigation agencies. Intelligence agencies also need to pool in.

What may also help India plug loopholes is sharing its 'wanted' database or providing access to it to foreign embassies on a reciprocal basis or through treaties or arrangements. All this will help detect possible plans of criminals to abscond abroad.

Signing of more bilateral and multilateral conventions on criminal matters would help plug legal infirmities. Signing bilateral agreements on cooperation in policing matters would also help. All relevant legal processes and requirements should be incorporated into one consolidated law on international cooperation.

The entire gamut of activities pertaining to fugitives, from investigation to extradition, needs to be incorporated into a specialised set-up with an Integrated International Cooperation Division (IICD) at the top. The IICD should have linkages with proposed fugitive tracking units at the State level. This would ensure that requisite expertise and forward-and-backward linkages are created. Making systems watertight would deter criminals from hoodwinking the law.

How qualified are teachers in India?

In India, a significant share of teachers in the pre-primary, primary and upper primary levels neither possess an academic degree* from a college (a graduate or a post-graduate degree) nor a professional degree^ (such as B.Ed. or a certificate in basic teachers training). While the share of such underqualified teachers was lower in the secondary and higher secondary levels, in some States there were quite a few underqualified teachers at these levels. For instance, in Andhra Pradesh, 10% of upper primary and 8% of secondary level teachers were underqualified. The problem is more acute at the lower levels, especially across most north-eastern States. Most such teachers are concentrated in private unaided schools and institutions managed by the Department of Education. The data are sourced from the latest UDISE report for 2019-20. By Jasmin Nihalani and Vignesh Radhakrishnan

FIFTY YEARS AGO JULY 9, 1971

Big newspaper ownership

The Minister of State for Information and Broadcasting, Mrs. Nandini Satpathi, informed the Lok Sabha to-day [New Delhi, July 6] that the Government was considering bringing forward suitable legislation to secure a broader base of ownership of newspapers having a circulation above a specific minimum. Replying to the debate on the demands for grants of her Ministry, she said that was one of the steps contemplated by the Government to ensure freedom of the press and end monopolistic ownership of newspapers. The intention was that newspapers with a larger circulation should be owned by a comparatively larger number of people. This indeed had been recommended by the Press Commission more than 15 years ago. The proposed legislation, she said, might also provide for full disclosure of the financial interest and transactions of larger newspapers. She reiterated that the Government believed in complete and full freedom of the press.

A HUNDRED YEARS AGO JULY 9, 1921

The Viceroy's Speech

There is little in Lord Reading's speech on the Indian situation, which we published yesterday, to indicate either that His Excellency has appreciated the Indian point of view or that he is prepared to recognise that a bold stroke of statesmanship is necessary to ease the Indian situation. A repetition, for a third time or more, of age-long and empty platitudes is calculated only further to deepen the wounds and we are unable to see in the Viceroy's speech anything more than a repetition of his favourite platitudes. The Punjab wrong, His Excellency still thinks, is to be a closed chapter not to be reopened. Sir William Vincent's references in a dark corner of his speech to "official excesses" whose effects he cleverly extenuated by drawing a lurid picture of the disturbances are considered by the Viceroy as sufficient apology for the great wrong. Such an attitude on the part of the Viceroy is not calculated to enhance his reputation for taking a "sternly just" view of things. It is an abuse of language to state that the butchery at Jallianwalla and the subsequent barbarity which left wounded men in the field to the passersby, if there were any, were mere "excesses," comparable to the isolated excesses of the mob. It is deliberate callousness to the loss of Indian lives for which the Government have yet to answer to the people of India.

Cairn says it has court nod to attach assets

While the Paris properties are estimated to yield about \$23 million, Cairn sources had told The Hindu that they have identified assets worth about \$70 billion in several jurisdictions that they could potentially attach through court orders.

Cairn lawyers have registered The Hague award in courts in at least 10 jurisdictions including the U.S., the U.K., Netherlands, Canada, France, Singapore, Japan, the UAE and even the Cayman Islands.

In New York court

In June, Cairn lawyers approached the court in the Southern District of New York, making the plea that Air India should be made liable for the outstanding settlement, and stating that other state-owned corporations could be targeted as

Last month, some foreign investors in Devas Multimedia filed a similar plea in the same court, seeking to declare Air India as the Indian government's "alter ego" and recover a \$160 million compensation awarded to the firm after an international arbitration over its scrapped deal with ISRO's commercial arm, Antrix Corporation.

The government has until next week to file its challenge to the Cairn Energy plea in the New York court. Even as the tax dispute has snowballed into a tussle in international courts, both the Indian government and Cairn Energy said they were open to continuing talks over the issue.

"Government has already filed an application on March 22, 2021 to set aside the December 2020 international arbitral award in The Hague Court of Appeal. Government of India will vigorously defend its case in Set Aside proceedings at The Hague," the Finance Ministry asserted on Thursday.

In December, the threemember tribunal in the Permanent Court of Arbitration at The Hague ruled unanimously against the retrospective tax levied by India on Cairn in 2015. It ruled that the tax fell afoul of the bilateral investment pact between India and the U.K.

The day before Prime Minister Narendra Modi rejigged the Union Council of Ministers, there was another major reshuffle under the administrative watch of the outgoing Minister Santosh Gangwar – in a statutory body tasked with managing lakhs of crores of rupees.

Nearly 120 top officials in the Employees' Provident Fund Organisation (EPFO), which oversees the retirement savings of India's formal workforce, were transferred in an unprecedented en masse mid-year transfer on July 6 through two separate orders.

Moreover, before the oath-taking ceremony of the new ministerial council at the Rashtrapati Bhavan on

Wednesday evening, these officers in the rank of Additional Central PF Commissioner and Regional PF Commissioner - 1 (RPFC-1), were also relieved of their duties so they could take charge of their new assignments.

As many as 12 Additional Central PF Commissioners were transferred, while 105 RPFC-1 rank officers (almost half of the sanctioned cadre strength) were shifted to new postings as per the transfer orders reviewed by The Hin-

"The officers shall be relieved with immediate effect and shall join their new place of posting within three days without availing joining time," the order said, sparking concerns among several officers about making such a swift move amid the CO-VID-19 pandemic.

Sources said the process for effecting the transfer orders was hurried through so as to complete it before Mr. Gangwar demitted office, and a new Minister assumed charge. Mr. Gangwar resigned as

Minister of State with Independent Charge of the Labour and Employment Ministry on Wednesday and his successor Bhupendra Yadav assumed charge on Thursday afternoon.

'There are several officers who have been transferred out prior to completion of their term and some officers

have been transferred to far off places against the options exercised by them," the EPF Officers' Association pointed out in a missive to CPFC Sunil Barthwal on Thursday.

Detailed queries on the transfer orders 'issued with the approval of the competent authority' sent to the Union Labour and Employment Secretary Apurva Chandra and CPFC Sunil Barthwal didn't elicit a response. The new Minister Mr Yadav did not respond to queries on whether he will review the orders. Veteran EPF officers said the latest transfer orders are not compliant with the policy laid down in 2016 for EPFO, after a Supreme Court judgment in 2013 directed the government to improve transparency in postings and transfers.

ED questions Khadse for nine hours

Ten of the 30 members of the committee had moved amendments against a provision (Clause 35) in the legislation giving power to the Central government to exempt any agency of government from application of the Act. The members have said that this clause makes the entire Act infructuous. The 10 members are Mr. Chandrashekhar, Congress MPs Jairam Ramesh, Manish Tewari, and Gaurav Gogoi, Trinamool Congress MPs Derek O'Brien and Mahua Moitra along with Biju Janta Dal MPs Bharatuhari Mahtab and Amar Patnaik, BSP's Ritesh Pandey, and Shiv Sena MP Shrikant Eknath Shinde. The *Hindu* has accessed a copy of the amendments moved by the members.

Invoking "sovereignty and integrity of India", "public order", "friendly relations with foreign states" and "security of the state", the legislation gives powers to the Central government to suspend all or any of the provisions of this Act for government agencies.

In his amendment, Mr. Chandrashekhar had sought further tightening of the existing clause, adding "health emergencies", "public safety emergencies" as the other scenarios allowing the Centre to step in to provide exemptions. He and other members also demanded that the Bill revise the definition of a 'child'. Presently as per the Act, anyone below 18 years of age has been described as a 'child'.

"For six months, I have been requesting a draft report of the Joint Committee on Personal Data Protection Bill be circulated to its members. Now the Chairperson has become a Minister along with 3 members. What happens now to the Committee & draft report? The new Ministers had much to say on the Bill," Committee member Jairam Ramesh tweeted.

The Select Committee so far has held 66 meetings and its last sitting was on December 29 last year. The members were told that a draft report was ready and would soon be circulated.

No place for complacency in COVID-19 fight: Modi

Learn from predecessors, he tells new team

He said India's vaccination and testing rates were high but the surge in infections in many European countries should instil caution in India too and urged the Ministers to stress CO-VID-appropriate behaviour. He expressed concern at the rising cases of COVID-19 in

Kerala and Maharashtra in the past few days. He also asked the Ministers to learn from their predecessors, even those who were dropped in Wednesday's re-

"He told the new Ministers that those no longer part of the government have made contributions and newcomers can learn from them," a source present at the meeting said. He said they should reach office on time and channel their energies to ministerial work and the focus should be to reach out to the last person standing in the queue. The focus should be to reach out to the last person in the queue. He cautioned them against going after publicity and media visibility at the cost of work, saving "unnecessary statements should be avoided".

A journey from the IAS and corporate world to Cabinet

Vaishnaw has the reputation of being a silent, astute worker

Ashwini Vaishnaw, who took over as the new Minister of Railways, Communications and Electronics and Information Technology, was anonymous in political spheres just two years ago.

His ascent to crucial Ministries previously held by political bigwigs such as Piyush Goyal and Ravi Shankar Prasad was dramatic and meteoric in equal measure.

The search for a person to fulfil Prime Minister Narendra Modi's vision for Indian Railways as a key factor in driving the nation's economy stopped at a man considered a political novice. But, those who take a look

at 50-year-old Mr. Vaishnaw's career graph will see that he has a varied and vast experience in bureaucracy and corporate world, besides the reputation of being a silent and astute worker.

IIT alumnus

The Jodhpur-born Mr. Vaishnaw did his M.Tech. from IIT-Kanpur and later cracked the Civil Services exam with an all-India rank of 27 in

1994. During his short stint in the Odisha bureaucracy, he worked as District Collector of Balasore and Cuttack, earning the reputation of an efficient administrator while being low profile. In 1999, when access to

the Internet was limited, the tech-savvy Collector monitored the U.S. Navy prediction for the Super Cyclone and alerted the top administration about its intensity.

"I remember him as a bright and meticulous officer," said Sahdeb Sahu, former Chief Secretary of Odisha.

In 2003, Mr. Vaishnaw moved to New Delhi to work as a Deputy Secretary in the Prime Minister's Office during the Atal Bihari Vajpayee regime. When Vajpayee lost the general election in 2004, he became his private secretary. This was the period when Mr. Vaishnaw came into contact with many BIP leaders who are at the helm of affairs now, Mr. Modi being one of them.

He later left for the U.S. to pursue an MBA course from the Wharton School of Business, Pennsylvania. He was quoted saying that since he was in debt following his MBA course, he had to quit the IAS job. Subsequently, he worked for multinational companies such as General Electric and Siemens.

His dramatic entry into politics came in 2019 when he was named as a Biju Janata Dal (BJD) candidate for the Rajya Sabha polls by Odisha Chief Minister Naveen Patnaik. However, half an hour later, a clarification came. Mr. Vaishnaw filed nomination as a BJP candidate. Mr. Modi had apparently made a call seeking BJD's support for his new Cabinet colleague. The BJD extended its support and ensured his election to the Upper House.

Vaccine candidate to be tested for ability to fight variants

Sanofi and GSK said they have received approval for their phase 3 clinical study in India, to assess the safety, efficacy and immunogenicity of their COVID-19 vaccine candidate.

The global, randomised, double-blind phase 3 study will include more than 35,000 volunteers aged 18 and older across sites in the U.S., Asia, Africa, and Latin America.

As part of the study design, all participants, including the control group, will be offered the study vaccine as soon as it is determined to be safe and effective, Sanofi said.

"India is participating in Sanofi Pasteur's pivotal phase 3 study, and subject to subsequent approvals, we should soon begin enrolment of study participants in the country," said Annapurna Das, country head, Sanofi Pasteur India.

"As the virus continues to evolve, we are anticipating what will be needed in the coming months and years, and accordingly, have adapted our vaccine development

company said. In this partnership, Sanofi provides its recombinant antigen and GSK contributes the adjuvant, both established vaccine platforms that have proven successful against influenza.

The recombinant technology combined with GSK's adjuvant is designed to offer the advantages of stability at temperatures used for routine vaccines, making it easily implementable and easier to distribute at a global scale through existing infrastructures where vaccines are stored at normal refrigeration temperatures, the company said.

It is also designed to offer the potential to generate high and sustained immune responses, and the potential to prevent virus transmission, it added.

Sanofi, GSK get nod for Cabinet okays ₹23,123 cr. aid package

Funding will help set up 20,000 additional ICU beds, paediatric units in districts

The Union Cabinet on Thursday approved a ₹23,123 crore package to boost emergency response and healthcare systems, including funding for 20,000 additional ICU (intensive care unit) beds and the setting up of paediatric units in all districts, ahead of a potential third wave of CO-VID-19 in the country.

At a meeting chaired by Prime Minister Narendra Modi a day after the expansion and reshuffle of portfolios, the Cabinet approved the second phase of the package. Health Minister Mansukh Mandaviya said the second phase of the package included funding for paediatric units in all 736 districts,

and the setting up of 20,000 ICU beds, 20% of which would be "hybrid", that is, for adults as well as children.

Mr. Mandaviya said the package was aimed at preventing the problems observed during the second wave, including lack of transport facilities for oxygen and shortage of medicines, from happening again.

The package would be implemented from July 1, 2021 to March 31, 2022, with the Centre's share being ₹15,000

The Centre would provide support to its hospitals, the All India Institutes of Medical Sciences, and other institutes of national importance, for repurposing 6,688 beds for COVID-19 management, it said. Genome sequencing machines would be provided to the National Centre for Disease Control, it added. The package would also provide for the expansion of the national telemedicine platform, eSanjeevani, by increasing daily consultations from 50,000 at present to 5 lakh. States would be "supported" to carry out at least 21.5 lakh tests a day and add 8,800 ambulances.

End NSA 'misuse' in U.P.: former top officials

The Chenab Valley should be seen as per the watershed of the river Chenab and accordingly new constituencies should be identified," Mr. Sharma said.

PM stresses local language education

"PM added that we need to develop an ecosystem of technological education in Indian languages and translate global iournals into regional languages," said a Ministry statement.

This has been a key recommendation of the National Education Policy and the Education Ministry had set up a panel headed by Higher Education Secretary Amit Khare to explore ways to begin offering technical education in Indian languages at the highest level. According to the statement, the Prime Minister said "there is a need to adapt higher education and technical education to keep in tune with the changing environment".

Farmers' stir draws smaller crowds

Strategic decision to spread protest in many locations, says union leader

PRISCILLA JEBARAJ

Farmers from various States who responded to the Samyukt Kisan Morcha's call to protest against fuel price hikes and the rising costs of essential commodities, showed up in much smaller numbers on Thursday than at the peak of the agitation, which has now completed seven months.

Some farmer leaders admit that there are challenges in sustaining the attention of the protesters, the public and the policy makers over such a long period of time.

The SKM said there were reports of protests from locations in at least 13 States.

At some locations in Punjab, tractors lined the sides of the road. In most States, protestors carried empty gas cylinders and banners.

Though this is an issue af-

fecting common citizens as well as farmers, the number of people at each protest was relatively small, nowhere near the thousands who joined rallies during the heady winter days when the agitation was at its peak. 'This is a strategic deci-

sion. Rather than giving one location for a mass rally, we asked people to gather at any location on a State or Highway, though the numbers at each location may have been smaller, there were many more locations of protest," said Abhimanyu Kohar, an SKM leader and spokesperson for the Rashtriya Kisan Mahasangh.

Mr. Kohar also pointed out that with the ongoing paddy cultivation, which is labour intensive, many farmers are not able to join the protest sites daily.

'Muslim, Yadav combine will not work in U.P.

Cabinet extends Agri Infra Fund loans to APMCs

The Centre has decided to allow state-run market yards to access financing facilities through its Agricultural Infrastructure Fund to calm the fears of protesting farmers that such market yards

are being weakened. On Friday, at its first meeting after the reshuffle, the Union Cabinet decided to extend the Central Sector

Scheme of financing facility under the Agriculture Infrastructure Fund to State agencies and Agricultural Produce Marketing Committees (APMCs), as well as federations of cooperative organisations, Farmers Producers Organizations and self help groups, according to an official statement.

They will now be eligible for interest subvention for loans up to ₹2 crore, with

APMCs allowed to access separate loans for different kinds of infrastructure projects to build cold storage, silos, sorting, grading and assaying units in their market

Multiplier effect

The period of the financial facility has been extended by two additional years up to 2025-26, while the overall period of the scheme has

been extended to 2032-33. "The modifications in the Scheme will help to achieve a multiplier effect in generating investments while ensuring that the benefits reach small and marginal farmers. The APMC markets are set up to provide market linkages and create an ecosystem of post-harvest public infrastructure open to all farmers," said the statement.

Briefing journalists on the

Cabinet decision, Agriculture Minister Narendra Singh Tomar said this was proof that "APMC will not end". The Central government was committed to making APMC more powerful and useful for farmers, he said.

Thousands of protesting farmers have been calling for a repeal of three farm reform laws passed by Parliament last year.



Janaka asks the sage to explain how one can attain jnana and get liberated. There is no other option in this pursuit, except to give up the longing for sense objects, is the very first instruction which is also very difficult to follow. For, in creation, the senses are poised to look outwards and there is constant exposure to the objects, places and people of the world. Naturally, the senses are drawn to them. This situation has to be broken and the senses are to be turned to

look at the atma within. To help us in this endeavour, it is advised that we learn to consider sense objects as poison and shun them totally. We have to understand how sense objects poison the mind. The moment there is an emotional reaction in the mind to any sense object, a strong desire to possess it arises. Then one goes to any extent to possess it. He only brings forth on himself more attachments and worries in the process. The wise instead consciously control the mind and direct it to seek the valuable nectar derived by the practice of moral virtues such as forgiveness, kindness and contentment. These make one self-dependent rather than sense-dependent.

Fourth Rajapaksa brother joins Cabinet President's killing pushes

Basil Rajapaksa sworn in as Finance Minister

MEERA SRINIVASAN

Basil Rajapaksa, brother of President Gotabaya Rajapaksa and Prime Minister Mahinda Rajapaksa, was on Thursday sworn in as Sri Lanka's Minister of Finance, becoming the fourth Rajapaksa brother and fifth member of the family to enter the Cabinet. The eldest of the brothers, Chamal Rajapaksa, is a Cabinet Minister, as is Namal Rajapaksa, son of PM Mahinda Rajapaksa. Mr. Chamal Rajapaksa's son Shasheendra Rajapaksa is a non-Cabinet minister.

Mr. Basil Rajapaksa's appointment, enabled by the resignation of a government MP and Sri Lanka's national

list system, through which political parties get extra seats to Parliament based on their vote share, comes at a crucial time for the Rajapaksa administration, which is facing an unprecedented economic challenge that is compounded by the CO-VID-19 pandemic. His entry was also made possible by the government removing a constitutional provision barring dual citizens - Mr. Basil

Rajapaksa is also an American citizen - from entering Parliament.

New portfolio

Mr. Basil Rajapaksa took charge of the Finance Ministry, helmed until now by Mr. Mahinda Rajapaksa, who was on Thursday allocated the newly-created portfolio of Economic Policies and Planning. Mr. Basil Rajapaksa, who served as a Presiden-

tial Adviser and Minister for Economic Development in the former Mahinda Rajapaksa administrations, was arrested in 2015 following allegations of corruption, but was later released on bail. In November 2020, he was acquitted in the case

Mr. Basil Rajapaksa is credited with building the ruling Sri Lanka Podujana Peramuna (SLPP or People's Front), the new political vehicle for the Rajapaksas' return to power in 2019. As chief strategist, it was Mr. Basil Rajapaksa who crafted President Gotabaya Rajapaksa's campaign in the presidential poll of 2019 and ensured the party's landslide victory in the August 2020 general elections.

For observers in Sri Lanka, Mr. Basil Rajapaksa's entry into government is no surprise. "This was expect-

ed, it was only a matter of time," said political scientist Jayadeva Uyangoda. "He was anyway one of the major powers behind the scenes for the last two years."

The government has a "triple crisis" to manage, he said, pointing to the "economic, public health and governance crises". "If you look at the drama and media hype created around his entry, Mr. Basil Rajapaksa is projected as a saviour, a sort of miracle man. Just like they did when they put forward Mr. Gotabaya Rajapaksa as the presidential candidate," Prof. Uyangoda said. In his view, although Mr. Basil Rajapaksa has a reputation of being an "economic and political dealmaker", the current crisis defies those skills. "This crisis is so profound that it is beyond the capacity of a skilful dealmaker."

Who was Jovenel Moïse? Moïse, a former banana plantation manager who called himself "Banana Man", rose to political fame when he contested the 2016 presidential election. He came to Port-au-Prince, the capital of the Caribbean country, from the countryside and presented himself as an outsider who could fix the nation's politics and economy. Haiti, the world's first independent Black-led republic, after slaves successfully revolted against Napoleon Bonaparte's forces in 1803, has a long, painful history of foreign interventions, coups, dictatorships and not-so-suc-

ments. In 2010, the country was battered by a devastating earthquake that killed at least 300,000 people. Moïse promised a new beginning by strengthening institutions and ending corruption, and won the 2016 election in the first round itself. But under his administration, the political and economic situation in Haiti deteriorated further.

Why was Moïse targeted? While the motive of the assassination is not clear yet, Moïse was at the centre of a turmoil that had engulfed Haiti over the past many years. Moïse was elected President in November 2016. The presidential election was scheduled to be held in 2015, but was postponed several times amid unrest. Former President Michel Martelly, whose term expired on February 7, 2016, stepped down without a

clear successor.

Moïse could not take office until February 7, 2017, as his 2016 election was marred by allegations of fraud and protests. According to Haitian Constitution (Article 134-1), "The duration of the presidential mandate is five years. This period begins and ends on February 7, following the date of elections". Opposition leaders claimed that Moïse's fiveyear term ended on February 7, 2021, as Mr. Martelly stepped down on February 7, 2016. But Moïse said he has one more year in office as he officially took over on February 7, 2017. This was

the crux of the crisis. As Moïse refused to step down on February 7, the Opposition called for countrywide protests. They also appointed government with Joseph Mécène Jean-Louis, a Supreme Court Judge, being the interim President. Moise called folding in the country

He was largely ruling by decree as his government failed to conduct legislative elections in 2019. As Haiti fell into chaos, violence by armed gangs spread across the country. Moïse promised that he would hold legislative and presidential elections within a year, but also took steps to rewrite the country's Constitution. Moïse said the post of Prime Minister, which is not an elected one, wielded enormous powers, which he wanted to clip. Opposition leaders said he was also looking for removing a clause in the Constitution that bars Presidents from seeking reelection, so that he could contest again. The political crisis was worsened by an economic contraction and the spread of COVID-19.

Who is in charge now? According to the Haitian

Constitution, the head of the Supreme Court should temporarily take over the government if the President departs abruptly. But Supreme Court President Rene Sylvestre died last month of COVID-19 and that position is still vacant. In the wake of a power vacuum, the National Assembly could select a new leader. But there is no National Assembly as elections have not been held after the last Parliament's term expired. That leaves Mr. Joseph in charge. But there's a problem - the late President had announced on Monday that he was replacing Mr. Joseph with Ariel Henry, a neurosurgeon with close ties to the Opposition. Mr. Henry was expected to take over as Prime Minister on Thursday. However, it is not clear whether the transition would happen amid the cur-

rent crisis Mr. Ioseph has already taken control of the government, declared a state of siege, put the military in charge of security and restricted media coverage of the incident. He says the authorities are in control. But most Haitians, including its leaders, are still in shock. The crisis has just started un-

Low base helps hoist June retail vehicle sales by 22.6%

FADA says pent-up demand spurs deliveries to 12 lakh units

SPECIAL CORRESPONDENT

Fuelled by pent-up demand and aided by a low base, total retail sales of vehicles rose 22.6% from a year earlier to more than 12.1 lakh units in June 2021, the Federation of Automobile Dealers Associations (FADA) said. However, registrations were still about 28% lower when compared with the pre-pandemic June 2019 figure of more than 16.98 lakh units.

On a year-on-year basis, all vehicle categories saw growth in sales last month led by commercial vehicles (CVs), which more than tripled to 35,700 units. The non-availability of BS-6 vehicles, combined with the pan-



demic impact, had to extremely low deliveries in June 2020. Passenger vehicle (PV) sales jumped 43.5% to about 1.84 lakh units. three-wheelers increased almost 22% to 14,732 units, two-wheeler registrations rose almost 17% to 9.3 lakh units and tractor deliveries were 14.3% higher at 52,261.

"The month of June witnessed reopening for most of the States except the ones in the South... the industry witnessed a high pent up demand," said FADA President Vinkesh Gulati. "Two-wheel ers, though in green, have witnessed a softer recovery as rural market is taking time to get back from post-COVID stress," he added.

The industry was, however er, still not out of the woods with tractors the only category that had posted growth over June 2019, he noted.

The auto dealers' body said it expects positive momentum to continue in July and demand to further pick up, especially as markets in southern India open up.

Equity MFs' inflows slid 40% to ₹5,988 cr. in June

Profit booking by investors slows flows

Inflows into equity mutual funds (MFs) dropped sharply by 40% to ₹5,988 crore in June on profit booking by investors as stock markets witnessed sharp rallies in recent times.

In comparison, the equity MFs had seen net inflows to the tune of ₹10,083 crore in May, the highest fund infusion in 14 months, data from the Association of Mutual Funds in India (AMFI) showed on Thursday.

Equity schemes saw a net inflow of ₹3,437 crore in April and ₹9,115 crore in March. Prior to this, equity schemes had consistently witnessed outflows for 8 months from July 2020 to February 2021.

Barty's craft and Pliskova's power light up semifinal day

Top-seeded Aussie ruthlessly ends Kerber's best Slam run since the 2018 edition while the Czech outguns Sabalenka in a battle of big servers

WIMBLEDON

AGENCE FRANCE-PRESSE LONDON

Ashleigh Barty is one victory away from realising her dream of winning the Wimbledon title on the 50th anniversary of fellow indigenous Australian Evonne Goolagong Cawley's first triumph.

The 25-year-old World No. 1 produced her best performance of The Championships so far to beat 2018 champion Angelique Kerber 6-3, 7-6(3). Barty will play former World No. 1 Karolina Pliskova of the Czech Republic in Saturday's final.

Eighth-seeded Pliskova reached her second Grand Slam final after rallying to beat No. 2 Aryna Sabalenka in three sets. In a match-up of two big servers playing in their first Wimbledon semifinal, Pliskova won 5-7, 6-4,

Sabalenka saved all eight break points she faced in the first set – including four at 5-5 – and then converted her first when Pliskova doublefaulted on set point.

Taking control

But Pliskova finally broke for a 3-2 lead in the second set and again in the opening game of the third to take control.

Pliskova had not dropped a set in the tournament going into the match. She was the US Open runner-up in 2016.

Barty had never progressed further than the fourth round at Wimbledon despite being good on grass; she was the junior champion

However, she took the first set with just the one break of serve and then showed real

Fans have been banned from the pandemic-postponed Tokyo Olympics which will open in two weeks, following the announcement of a state of emergency on Thursday, Olympic Minister Tamayo Marukawa told Japanese news agency *Kyodo*.

The ban was announced by the International Olympic Committee and Japanese organisers, reducing the games to a made-for-TV event. The no-fan atmosphere will include the opening ceremony at the \$1.4 billion National Stadium, which is

traditionally the most watched event during the Olympics. It's unclear how the Olympic Torch will enter the stadium for the opening

Rude welcome

The emergency declaration made for a rude arrival in Japan for IOC president Thomas Bach, who landed in Tokyo on Thursday just hours before the new measures were announced. He was to spend three days in self-isolation at the hotel that lodges IOC members.

The Japanese Prime Minister Yoshihide Suga said the state of emergency would go into effect on Monday and last through Aug. 22. This means the Olympics, opening on July 23 and running through Aug. 8, will be held entirely under emergency measures. The Paralympics open on Aug. 24.

About 11,000 Olympians and 4,400 Paralympians are expected to enter Japan, with tens of thousands of officials, judges, administrators, sponsors, broadcasand media also entering. The IOC says more than 80% of the residents of the Olympic Village will be vaccinated.
