Every section of society must join in the awareness programme for population control, Uttar Pradesh Chief Minister Yogi Adityanath said on Sunday as he launched the State's population policy for 2021-2030.

Mr. Adityanath said rising population was the root of major problems and prevailing inequality in society. "Increasing population can be an obstacle to development," he said here, stating that the new policy was drafted keeping in mind all sections of society.

If there is no gap between the birth of two children, it will naturally affect their nutrition, he said, explaining the need for spacing and control in population.

'Hurdle to development' "Across the world, concerns

have been raised from time to time about increasing population being a hurdle in development. Discussions on it have been going on for four decades... The countries and States which have made efforts in this direction have seen positive results. However, more efforts are needed."

The new policy aims at decreasing the total fertility rate from 2.7 to 2.1 by 2026 total fertility rate (number of children per woman) from 2.7 to **2.1 by 2026** and **1.7 by 2030**

Targeting stabilisation, the draft of the policy also said the State would attempt to maintain a balance of population among the various communities. "Awareness and extensive programmes would be held among those communities, cadres and geographical areas that have a higher fertility rate," the policy read.

Addressing a function at his official residence here, the Chief Minister said efforts to control population were linked to comprehensive awareness in society.

"We should not forget that the increase in population contributes to poverty in society. Hence, until all sections of society are made comprehensively there will be a delay in fulfilling various goals. Every section of society has to be associated with the awareness campaign," Mr. Adityanath said. The health of a mother and her child have to be linked with this, the CM said.

# <sup>+</sup> Dhami holds off on Kanwar yatra decision

'We will consult neighbouring States'

Any decision on allowing the Kanwar Yatra this year will be taken after discussions with neighbouring States, Uttarakhand's new Chief Minister Pushkar Singh Dhami said, after weekend consultations with Prime Minister Narendra Modi and Home Minister Amit Shah. A senior official in the CM's office confirmed that he has also held consultations with Yogi Adityanath, his counterpart in Uttar Pradesh.

Among medical officers on the ground in Uttarakhand, however, there is a recognition that allowing the Kanwar Yatra could lead to an increased spread of COVID-19 cases and heightened challenges in

managing the pandemic. Uttarakhand is reviewing its earlier decision to cancel the yatra. This fol-

lows the U.P. government's announcement that the pilgrimage will begin from July 25, despite concerns that it could become another COVID super spreader event like the Kumbh Mela earlier this year.

Given the religious sentiments and health concerns involved, the decision on whether to cancel the yatra again has political ramifications, especially given that both Uttar Pradesh and Uttarakhand are headed to the polls next year. Mr. Dhami tweeted a link

to his interview with the Aaj Tak news channel in which he said, "It is a matter of the faith of millions. However, people's lives should not be threatened. Saving lives is our first priority. God would not like it if people lost their lives to COVID due to the yatra."

# 'High command will decide on CM change'

But no reason for it now, says Baghel

Chhattisgarh Chief Minister Bhupesh Baghel on Sunday said he was asked to take oath as the Chief Minister by the Congress high command, and it was for them to decide whether or not there should be a change of guard. He added that "such arrangements take place while running coalition governments".

Minister's demands

Mr. Baghel's comments are significant in the wake of reports that Health Minister T.S. Singh Deo wants the high command to "honour" the rotation formula of changing the CM after two and a half years that was supposed to have been agreed to in December 2018.

Mr. Baghel was speaking after meeting Congress general secretary Priyanka Gandhi Vadra at 10 Janpath, the official residence of Con-

gress president Sonia Gandhi, where the leaders are said to have discussed next year's Assembly election in Uttar Pradesh.

"The high command instructed me to take the oath [as Chief Minister], so I took the oath. When they say someone else will be the Chief Minister, then it will be so," he said, adding, "Such agreements happen in a coalition government but Congress has three-fourths majority in Chhattisgarh."

# First report on compliance from Twitter

Twitter has appointed Vinav Prakash as its resident grievance officer for India, according to its website. The micro-blogging site also published its first compliance report, which is mandatory under the new digital rules.

"In compliance with Rule 4(1)(d) of the Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules, 2021, we have published our inaugural report on July 11, 2021, for the reporting period from May 26. 2021, through to June 25, 2021," Twitter said on its website.

As per the new digital media rules, significant social media intermediaries are required to appoint a grievance officer, a nodal officer and a chief compliance officer.

# Mobile theatre groups in Assam face a bleak future

### Experts look at ways to revive the sector

The majority of the 30 mobile theatre groups in Assam may find it difficult to stage a comeback after almost two years of closure due to the two phases of the COVID-19 lockdown preceded by the unrest associated with the anti-Citizenship (Amendment) Act protests.

The Krishna Kanta Handique State Open University on July 9 organised a virtual meeting of Bhramyoman (travelling theatre) producers, directors and cultural

economy experts, to find a way forward for the mobile theatre groups crippled by months of inactivity. The meeting coincided

with the birthday of Achyut Lahkar, who started the mobile theatre revolution by forming the Nataraj Theatre group in 1963. "The Bhramyoman

suffered a bit towards the end of 2019-2020, before COVID-19 struck, to keep those associated with the industry virtually unemployed. The situation does not look like it is improving soon, and because the investment is huge for a theatre group, 99% may not survive this

Awahan theatre group, said. "Given the popularity of mobile theatres across Assam's rural landscape and the demand, we have to think of ways to stage plays while coexisting with COVID-19. Maybe we can cut down the audience size of 1,500-2,000 during normal times to 700-800, and increase the number of shows per day," said playwright-director Abhijit Bhattacharya, who has been associated with the Bhramyoman for 25 years. Suresh Ranjan Goduka, a

mass communication design researcher at the Indian Institute of Technology (IIT), Guwahati, said the annual turnover of the mobile theatre groups was ₹25 crore. "Mobile theatre owners said materials such as bamboo, iron poles and fittings, timber and tarpaulin have been damaged or are unusable because of almost two years of inactivity. They will need to pump in ₹40 lakh-₹45

lakh more to be back on the road," he said.


No workers

The toughest challenge for the mobile theatre groups is to find technicians who handle a range of activities from setting up the stage and theatre halls to cooking for the unit and transporting them from place to place.

"Each theatre group involves 120-150 people who get paid on the condition of no-work-no-pay. The challenge for the theatre groups is that many workers have either moved out in search of jobs or are selling perishables for a living," Jayanta Kumar Sarma, professor of the university's Mass Communication Department, said.

It has been nearly a year since Ghaziabad resident Anshika Singh enrolled at the Delhi University (DU) for under-graduation. However, with online classes continuing to be the norm due to the COVID-19 pandemic, it has been difficult for her to gauge how college functions or access the facilities on campus.

For several first-year students like Ms. Singh, who are set to appear for their second-semester examinations next month, a lack of interaction with professors and peers, sans the computer screen, has meant that the "college life" they expected was in dissonance with the reality.

Ms. Singh, a student of Miranda House, said: "After boards, we thought we'll get to go out, explore an independent life which DU offers and meet people coming from different parts of the country. But we lost out on the chance. The exposure that DU offers, including extracurricular activities, is also why you want to join the university. But due to the pandemic, interactions got restricted."

The BA (Programme) student added: "At times attending online classes feel like listening to podcasts. Interaction with teachers

Attending online classes was not equivalent to the "human connect" that you would expect on campus, others added

pus college you have expectations. Initially, I adapted to the life of online classes but eventually, the enthusiasm faded away. Online lectures are difficult to focus on at times. Even though I was able to make a few friends and meet them online, the human connect is missing. I am missing out on a very important thing."

It was more stressful during the onslaught of the second wave. "During the second wave, it was even more stressful when professors were also unwell. Everything around us was distraught and gradually the pace of classes was also reduced as several students and teachers were infected. The motivation is slightly slipping away but we don't really have an alternative at the moment," said the Kolkata resident.

### Stifled dreams

Stating that the current batch was "extremely unfortunate" due to curtailed dreams of independence and self-discovery, Dhruv Garg, a student of Kirori Mal College (KMC) said, "In order to have bonds one has to step out and college is essentially the first time people travel and live by themselves. That is something we missed out on. I have been able to make friends online but for a lot of people it is difficult."

"Last week I met a few of my

online friends for the first time and it did not really feel overwhelming. It was quite normal. I think the transition from online to offline will be okay for me," said Garg, a student of Economics.

Professors at the university also said that the current structure of teaching-learning, brought in due to the ongoing pandemic had an adverse impact on the

### **Practical hurdles**

Tanvir Aeijaz, professor at Ramjas College, said: "Students have been impacted both academically and socially. Academically a lot of things we do in the classroom like impromptu discussions are missing in online classes. The liveliness and experience of the classroom are not there. This makes a huge difference. A majority of the students often do not have their videos on for several reasons which also make it difficult for the teacher to know if the student is even present."

There are manifold hindrances, he said. "Communication gets distorted online. University is a space that once students enter, they are in a different mind space altogether and there is some purpose. The academic charm is missing in online classes. Teaching-learning within a structured environment is not there and if that ecology is missing then the factors that determine learning also changes. Online students are getting impoverished in terms of learning and knowledge and it is a huge loss for them," said Mr. Aeijaz.

### **Dystopic reality**

Speaking of a "dystopic reality" that professors and students are currently experiencing, St. Stephens College professor Nandita Narain said: "There is no sense of a community, class or college. This is not even a pale shadow of what is actually experienced in a college, mostly from each other and to a large extent from teachers. In this virtual reality, most people do not even switch on their videos so one doesn't even know who they are speaking to." "It is to be seen how the current batch copes in the second year as their first year foundation will be shaky," lamented

# Woman strangulates infant son

A 26-year-old woman was arrested for strangulating her 11-month-old infant to death following a quarrel with her husband in south Delhi's Fatehpur Beri, police said on Sunday.

Accused Jyoti, who hails from Ritoz village in Gurugram, got married in 2011 when she was 16years-old but did not share cordial relations with her husband, they

She told the police that her 11-month-old son was suffering from fever and her husband Satveer Tanwar refused to take him to a doctor, police said.

The woman used dupatta to strangulate her infant following the quarrel. The child was then taken to Apex Hospital, Chhatarpur by his father and other relatives where he was declared brought dead, a senior police officer said.

A case of murder was registered and during investigation, both parents allegations against each other for killing the infant. CCTV footage from the village, call records, and statements of witnesses were taken which revealed that Jyoti had committed the murder, the officer said.

"Jyoti has been arrested and the dupatta was also recovered," he said.

"During interrogation, the accused disclosed that she had a quarrel with her husband, Satveer, on July 9 at around 3.30 p.m. as he didn't like her since their marriage. They argued on many things and never shared a cordial relationship. She also stated that her son was suffering from fever and Satveer refused to take him to doc-

# 3 held for 'honeytrapping' businessman HC rejects plea of overweight

Techie, his aides demanded ₹1 crore and threatened to upload morphed pictures

A software engineer and his two associates have been arrested for allegedly honeytrapping a businessman and demanding ₹1 crore from him after threatening to upload his morphed pictures on social media platforms, police said on

The main accused, Raj Kishor Singh, a software engineer based in Gurugram, fell into bad company due to lavish lifestyle, they said.

He opened a spa and recruited women for call girl services. To meet his expenses, he used them to honeytrap rich and wealthy businessmen, shoot intimate pictures or videos and demanded money from them after threatening to upload them if they failed to pay up,

# candidate in IAF recruitment

Court says it cannot dilute the rule by permitting its violation

The Delhi High Court has rejected the plea of an overweight candidate seeking recruitment as airman in the Indian Air Force (IAF), noting that he could end up being a liability for the force rather than being of any help in the defence of the country.

A Bench of Justice Rajiv Sahai Endlaw and Justice Amit Bansal remarked once there is a rule specifying the weight for the particular height, it "has to be abided by and a slight variation even therein cannot be tolerated".

"The court cannot dilute the said rule by permitting violation of the rule, in the name of being miniscule. To direct such a person to be re-



cruited, would amount to burdening the respondents – Indian Air Force – with an overweight airman who would be unfit to do the duties required from him and would end up being a liability for the respondents rather than being of any help in the defence of the country," the Bench remarked.

The High Court's direction came on a plea by one Shivam Kumar, who had ap-

plied for recruitment as airman in IAF. During the medical examination conducted as part of the recruitment process, he was found medically unfit on the ground of being overweight by 2 kg.

# Easily manageable

Mr. Kumar challenged the finding of medical unfitness and sought a direction to IAF to conduct re-examination of his medical fitness. In the alternative, he sought a direction for his appointment as an airman on the basis of the medical certificate of fitness issued by a private hospital.

Mr. Kumar argued he was overweight by 2 kg only, "which is nothing and which is easily manageable".

The High Court, however, denied his plea

# A year after deluge, slum victims wait for rehabilitation

Anna Nagar JJ cluster residents, whose houses were swept away in the rain last July, live on rent and struggle to make ends meet as multiple visits to govt. offices fail to bear fruit

avitri has not been able to pay house rent – ₹8,000 – for the last two months. She is worried as she doesn't know how she'll manage this month's as well.

A year ago, Savitri and nine other families lost their homes to a natural calamity. A heavy downpour swept away 10 houses in Anna Nagar slums, leaving their lives uprooted in a day.

Nearly a year after, the affected families are now scattered across East and Central Delhi and are living on rent. *The Hindu* met a bunch of families who had to move to VinodNagar and are now struggling to make ends meet while waiting for rehabilitation.

### Lived in tents

Along with her two children, Ms. Savitri recalls living in a tent for nearly 15 days, the Delhi government had set up right after the incident. They stayed there opposite to their damaged houses, close to Indraprastha metro station. "It was raining for days even after the incident and we used to lie wet under

the tent. Sometimes, we took refuge at the metro station," she said. With a permanent solution not in hand, the authorities asked the families to move to a school where they lived for a month and a half.

"When the school had to open for an examination, the officials again asked us to move to a rain shelter house at Sarai Kale Khan. It was so dirty, we refused. We were then asked to live with our relatives for a few days and were promised that we'll be allotted houses. However, days passed by and no one even came to look for us," said Janki who lives with her three children, husband and parents in-law in a house where she has to pay ₹4,500 as rent every month.

### Space constraint

Of the four families, presently living in VinodNagar, one is 60-year-old Jhima Devi. In a single-room accommodation, she lives with her husband and her 100-year-old mother-in-law. Her two sons and their families who used to live together with them in Anna Nagar, now live in separate rented accommodations because of space constrains.

I haven't paid rent for four months, said Ms. Devi. The CO-VID-19 induced lockdown only added to her woes

Ms. Devi's husband, Nand Kishore, works at a hotel in Connaught Place and while he didn't lose his job during the lockdown, he was paid nothing for two months. He was asked to join work only a week ago.

"We have not paid rent for four months. Thankfully, one of my sons who works at a government school has been getting his salary. He helped us with money for food and other essentials," she said, adding that her 100-year-old mother-in-law fell while walking and broke a bone and was had to be hospitalised. "Though the treatment was free of cost, we had to bear the cost of some medicines".

### Adding to the woes

Ms. Devi has been getting calls from the landlord to pay up the rent which is now long overdue. "I told him that my husband has just resumed work and will pay up soon".

Adding to the miseries, Ms. Devi's daughter, Manju, also lost her job six months ago due to the pan-

demic. The family faced the same problem during the lockdown last year but they didn't have to bear the rent as they were at their own home last year.

Kamla Devi (58) and her husband Pan Singh are also struggling to make ends meet as their sons who used to previously stay with them now live separately on rent. "We need money. My husband can't walk properly. He works as a security guard outside an ATM," she said. "I hope we don't die waiting for the house".

It's Ms. Savitri daughter's fifth birthday next month and the mother is disheartened because due to financial crisis she won't be able to celebrate it the way her daughter is expecting. She started working as a house help in AshokaNiketan is East Delhi. "I need to first take an erickshaw and then a bus to reach the house. Sometimes, I walk the path instead of taking an e-rickshaw to save some money".

### **Dodged by officials**

Her husband Kuber Chand Kotiyal works as a security guard in Old Delhi and rides a cycle to work. He has been to goversnment offices a multiple times to get updates about their house but has been dodged every time.

"In the last one year, I have tried to meet several officials in municipal department and the Delhi Urban Shelter Improvement Board [DUSIB] but they keep telling me that our work will be done. On July 5, along with a member from each affected family, I visited the DUSIB office in West Delhi. They told me to come next month. I told them that if nothing happens till next month, then all the families will come here and stay outside the offer."

It has been learnt that survey of this JJ cluster has been conducted by the DUSIB for rehabilitation.

DUSIB member Bipin Rai said that the government body has completed the formalities for rehabilitation of these families. "However, the Central government is intervening and asking the DUSIB to allot houses on rent. The discussion over the matter is ongoing," he said.

# Halls, auditoriums to reopen in educational institutions, says DDMA

Only 50% seating capacity allowed

The Delhi Disaster Management Authority on Sunday permitted the use of auditoriums and assembly halls in schools and educational institutions for meeting and training purposes with up to 50% seating capacity.

The DDMA said the move was taken owing to the considerable decline in COVID cases in Delhi. It said there will be strict adherence to standard operating procedures and other guidelines of the government and compliance with COVID-appropriate behaviour.

The government said the notification by the DDMA provides an opportunity to the educational institutions to resume their academic preparation, including training, meetings for reopening

whenever the situation improves further. However, schools and other educational institutions shall, however, remain closed and the teaching-learning activities shall continue online.

This decision will give a boost to ongoing education projects of the Delhi government like teacher training in offline mode also in a phased manner, the government said.

Parent-teacher meeting

It is preparing to host a parent-teacher meetings for all government schools between July 19 and July 31.

"These meetings can now provide an opportunity to the schools to get the views of parents on schools reopening and will be conducted using staggered timings," the government said.

# 'Water shortage in Delhi due to mismanagement'

Haryana says full share given to Capital

Haryana government on Sunday said the State was facing acute water shortage due to delayed monsoon but was still maintaining water supply to Delhi without any reduction.

'Delay in monsoon'

The people of Delhi were facing water scarcity because of delays in monsoon and poor water management, said a press statement issued by the Haryana Public Relations Department attributing it to an official spokesperson.

It further accused the Delhi government of making false political rhetoric to hide its failure, adding the national Capital was being given its full share of water despite 40% less water in the Yamuna.

The official spokesperson said according to the report of the Economic Survey 2017 of the Delhi government, 20% of the

drinking water in Delhi was wasted due to mismanagement. According to experts, the amount of drinking water that is wasted is more than 30%.

It is a matter of great re-

gret that the Haryana government was facing criticism of the Delhi government despite making positive efforts and following the orders of the Supreme Court.

He said Delhi has a share

of 719 cusecs of water at Munak from Yamuna and Ravi Beas waters. In addition to it, 330 cusecs extra Yamuna water is being released by Haryana at Munak, as per compliance of Supreme Court orders pronounced on February 29, 1996.

He said the Upper Yamuna River Board in its 52nd and 54th meetings has already verified this position.

He said Haryana had no role in the water shortage in Delhi.

# Court seeks Centre's reply on M.P. lawyers' body petition

The Delhi High Court has directed the Centre to respond to a petition by a Madhya Pradesh lawyers' body challenging the transfer of the presiding officer of the Debt Recovery Tribunal (DRT), Jabalpur to DRT Lucknow.

A Bench of Chief Justice D.N. Patel and Justice Jyoti Singh issued the notice on the petition by the State Bar Council of Madhya Pradesh.

The Council, in its plea, said shifting DRT to a place 600 km away "ruptures and disturbs the convenience, affording capacity, reach of the litigants". It said shifting DRT Jabalpur to other states is clearly arbitrary, dehors the provisions of the Recovery of Debts Due to Banks and Financial Institutions Act (RDDBFI Act).

The Council has also sought the appointment of a regular full-time incumbent presiding officer for DRT Jabalpur.





# Assam-Mizoram border row flares again

Two blasts reported on Mizoram side on Sunday after a blast in Assam a day earlier

A day after a suspected IED blast was carried out inside Cachar district of Assam allegedly by miscreants from Mizoram during an eviction drive, two back to back explosions took place on Sunday along the inter-State border on the side of the neighbouring State, a police source said.

Tension is running high in Khulicherra area of the district, where people from Mizoram have reportedly entered up to 6.5 kilometres inside Assam land a few days ago, following which the Assam Police along with civil administration carried out an eviction drive.

"Two blast sounds were heard coming from the Mizoram side at 2.40 am and 2.43 am. The CRPF, which is a neutral force deployed at Khulicherra Point-II, has been asked to enquire into the suspected blasts on the Mizoram side," an Assam Police source said.

The situation is at present normal although tension still prevails and Assam Police personnel are on alert in the entire border area, he

On Saturday, an explosion took place targeting a delegation of Assam government

officials, including senior police officials, who were on a visit to oversee the construction of a road along the border, but no casualty was reported in the incident.

'Miscreants used IED'

Initially it was believed to be a grenade attack but the police later suspected that the miscreants used IED, the source said. Additional Director General of Police (Border) Harmeet Singh is camping at the spot and monitoring the situation.

Meanwhile, Assam Chief Minister Himanta Biswa Sarma said that he has written to his Mizoram counterpart Zoramthanga to settle the border dispute by using satellite mapping of the actual border locations.

"For complete peace, we should hand over the inter-State border to Central police forces after we fix the border issue. We are building roads within the Constitutional boundary of Assam. We will not take an inch of land from Mizoram," he added.

There has been a long border dispute between Assam and Mizoram in that area along with other locations in Cachar, Hailakandi and Karimganj districts of the Barak




With both Class 10 and Class 12 board exams being cancelled, there is grave concern about students' future plans. The Class 12 board exams have a huge impact on the choice of colleges for undergraduate courses. Apart from merit-based admissions, more than 50% students appear for common entrance exams such as NEET, CLAT and IIT-JEE. Class 12 marks simply become an eligibility criterion here, and admissions are strictly based on entrance exam scores.

### Varied skillsets

In such a context, a large percentage of Class 12 students tend to prepare for two types of high-stakes assessments: the school exit exams and college entrance exams. Currently, there is an outcome-based assessment for school exit exams to certify students at the end of 14 years of schooling. The question paper has a combination of MCQ and open-ended questions, and students must exhibit both knowledge and understanding of the topic. The exam has been criticised for its vast portions, tendency to promote rote learning and predictable paper

In comparison, the skillsets to be demonstrated and the nature of preparation required for entrance examinations tend to vary dramatically. The question papers mostly include many MCQs that require students to be quick in selecting the right answer. The construct for assessment is derived from the objectives of future academic stream that a student is aspiring

For example, while the focus of the CLAT is to assess reading comprehension along with critical thinking and analytical



skills, IIT-JEE assesses problem-solving abilities based on quantitative problems. Though the scope of the question paper remains within the prescribed syllabus, the complexity of the questions is higher than that of the board exam. This leads to enormous pressure among students, as both require a different kind of preparation.

# External help

Since the entrance exams act as a gateway to students' dream stream, coaching centres step in, offering help to decipher, drill in and practice these papers. Ideally, the preparation for their school exit exams should make

Ideally, the preparation for their school exit exams should make students competent enough to crack the specialised entrance exams with minimal additional prep

students competent enough to crack the specialised entrance exams with minimal additional prep. However, this is not the case, primarily due to a lack of alignment between what is tested and how it is tested in both exams.

The National Education Policy 2020 (NEP 2020) also recognises the need to design high-quality common as well as

subject-specific entrance exams in such a way that it does not require students to go through any additional coaching. School education should be such that students are not just prepared to perform in one exam designed in a specific way. They should be equipped to critically apply their subject knowledge, as required, irrespective of the exam format. In fact, the higher secondary education curriculum should be well-rounded enough to provide scope for smooth transitioning of students from school to higher education without the need for 'additional coaching' of any kind.

I have selected commerce stream for Class 11. I have to choose either Computer Applications, Psychology or Maths as an optional subject. I want to pursue Psychology, but my parents insist I take Maths. I want to be in government service. Which is a better option? -Simran

Dear Simran,

I would agree with your parents that you take either Maths or Computer Application, as these will help for the entrance exams after Class 12 You can always read Psychology side by side now, and engage in short-term courses online to know more about the subject

My son is in Class 12. He is not interested in academics but scores slightly above average in his exams. However, he does not finish his revision or paper or tasks on time. He doesn't seem to have found a passion or career that will motivate him or drive him to excel. What can we do? -

He sounds just like any other teenager, but it is time he starts to think seriously about what's next. Talk to him about meeting a career counsellor at the earliest to help him identify his likes, dislikes, interests, aptitudes, skill sets, and his inherent personality type. This will give him clarity and help him step up.

I am doing LLB from Delhi University, but also want to do a diploma/degree in Yoga. Is it possible to do this simultaneously? - Nikhil Mishra

Dear Nikhil,

Of course, you can do a course in Yoga as well. Many institutions offer part-time/diploma/certification. Depending upon your LLB course work, you can choose what works for you. Alternatively, if it is not the diploma/degree that is the motivation, but the art and the knowledge, experience a particular form from a registered school nearby, till you have the luxury of joining a full-time programme.

I am studying in Class 8. I want

to be in the Army, but my parents want me to prepare for the IAS. What do I do and for which do I start preparing? - Aditya Prakash

Dear Aditya,

I would like you to do a small experiment. Ask your father to help you meet three Army officers and three IAS officers. Speak to both sets and find out what work they do and what about it interests you more and why. Make notes and write down your observations and then have a final conversation with your parents. # Cooperative spirit

The new Ministry should seek to be a catalyst, and not the command centre, of the sector

longside the state and the market, cooperatives play a vital role in the country's development but are seldom the focus of policy planning. The creation of a new Union Ministry to oversee the cooperatives sector will redeem it from negligence, according to the Government. Critics fear that this Ministry is purposed to concentrate even more powers in the hands of the Centre. Cooperatives are dominant in agriculture, credit and marketing, but not limited to those. Some are big – IFFCO has around a third of the market share in fertilizers. In milk, cotton, handlooms, housing, edible oils, sugar and fisheries, they are formidable. As market conditions are evolving, cooperatives in States such as Kerala have got into complex operations: running IT parks and medical colleges. More avenues for expansion, such as insurance, remain untapped and the regulatory regime must evolve in step. The legal architecture of the sector began evolving since 1904 under colonial rule, and in 2002, the Multi State Cooperative Societies Act was passed, taking into account the challenges arising out of liberalisation. Considering the fact that cooperatives fall in the State list of the Constitution, the Centre will have to innovate to provide legal sanctity for the new Ministry. A separate Ministry can marshal the diffused capacity of the sector, however.

That said, this move will turn disastrous if the attempt is to appropriate the political capital of the sector, which is significant. Cooperatives are not meant to operate by the market logic of maximising profits but to share the benefits to all stakeholders equitably. Though not uniform across India, cooperatives have made significant contributions in poverty alleviation, food security, management of natural resources and the environment. True, the sector has become an instrument of patronage and pilferage. Mismanagement and corruption destroyed the sector in some States. The potency of cooperatives as an apparatus of political control is personally known to Minister-in-charge Amit Shah, once president of a district cooperative bank. Besides serving localities and segments that markets might ignore, cooperatives are also effective in mediating politics at the local level, outside of the parliamentary system. Despite regulatory oversight by the RBI and States, there is considerable autonomy for the sector which is often misused. The remedy is not an overarching Ministry and diktats from Delhi. The premise of a cooperative is that decisions are made by those affected by them. The case for transparency and efficiency in the sector is strong; that goal must be pursued not by scaring the very soul of the sector but by advancing the cooperative spirit. The new Ministry could indeed be a catalyst, but it must not fashion itself as a command authority.

# Silver win

Messi needed the Copa America more than the rest of Argentina

port is a distillation of micro-tragedies and megastasies enmeshed with whirring limbs, glistening sweat, unabashed tears and booming laughter. And football presents a wider canvas for all these attributes, which were exhibited at Rio de Janeiro's Maracana Stadium late on Saturday night. When the Copa America final that pitted eternal rivals Argentina and Brazil wound to a close, it primarily offered redemption to Lionel Messi, of the phlegmatic smile and magical feet fame. One of the greatest ever footballers and fit to join a pantheon headlined by Pele and Diego Maradona, until now Messi had one missing link - a cup triumph for Argentina. After his 34 summers, that aberration was finally erased once his team defeated Brazil 1-0 in a scrappy contest with the odd streaks of brilliance. Messi, miracle-dispenser with FC Barcelona, was seen by his countrymen as the prodigal son, who never delivered, and they embalmed for posterity their affection towards the late Maradona. Messi and his fellow Argentines constituted a dysfunctional family of unspoken hurts. All that anguish could dissipate thanks to the latest victory which came after a 28-year title drought for the Albiceleste. Their 15th Copa America trophy put them on a par with toppers Uruguay, well ahead of Brazil with nine. Incidentally, Copa America with its 1916 inception even predates the FIFA World Cup, which commenced in 1930.

Argentina and Brazil have embellished the championship's storied history and in South America with its seize-the-day spirit, novels infused with magical realism and samba dance, football is seen as an extension of aesthetic joy. The final though did not live up to that esoteric aim. There were sparks marred by some rough tackles. Messi was not in his elements, marked tightly and weighed down by expectations, he even missed scoring his team's second goal in the closing minutes. But having drawn the Brazilian defenders towards him all through the game, Messi created spaces that his team-mates could exploit. Even in that missed goalscoring opportunity, Messi seemed keen on doing an assist rather than performing the deed and this is the mark of a man desperate for affection from his squad and country. The match was by then firmly in Argentina's grip thanks to the 22nd minute goal slotted by Angel Di Maria, who capitalised on a long-pass from Rodrigo De Paul. A stung Brazil, especially Neymar, mounted rapid sorties on either side of half-time. Two attempts were adroitly foisted by Argentina goalkeeper Emiliano Martinez and when the Selecao seemingly breached the citadel, it was deemed off-side. Argentina and Messi were destined for their shot at glory in a 10-team intracontinental tournament, which despite other simultaneous global attractions like the Euro and Wimbledon, had its own effervescent charms.

# A Kerala model for an anti-discrimination law

If enacted this law will be the largest expansion of civil rights in the State, and can be emulated by the rest of India

couple turned down for a home they wish to rent, because they are Muslim. A qualified professional rejected for a job because he uses a wheelchair. A pair of students denied facilities on campus because of their caste or ethnicity. An air hostess dismissed for being above the weight deemed desirable, even though male stewards/pursers of that weight continue in their jobs.

### Forms of discrimination

Such incidents are all too common in our society."Silent segregation" on the grounds of marital status, gender, sexual orientation or eating preferences are followed in several housing societies and residents' associations. The Housing Discrimination Project (https:// bit.ly/3wvGQFC) at Jindal Global Law School has shown how extensive housing discrimination is across the country. The recent Pew Research Center Report (https://pewrsr.ch/2TOZF9v) has confirmed that a substantial number of Indians prefer not to have a person from a different religious community as their neighbour. The absence of a proper legal recourse for those who suffer from housing discrimination makes matters worse.

Even though Section 377 of the Indian Penal Code was read down by the Supreme Court of India to exclude consensual relations between adults of the same sex, social prejudice against members of the LGBTQIA+ community in the country remains strong. Article 15 (1) of the Constitution of India pro-

hibits the state from discriminating against individuals on basis of certain protected characteristics such as religion, race, caste, sex and place of birth. But it does not bar private individuals or institutions from doing what the state is not permitted to. Nor does it expressly list ethnicity, linguistic identity, nationality, marital status, sexual orientation, disability, physical appearance and other personal characteristics as prohibited grounds of discrimination.

The understanding of discrimination has also evolved over the years. It does not operate along a single axis; it can take the form of combined discrimination which is a combination of discrimination on two or more grounds. Last April, the Supreme Court, in Patan Jamal Vali vs State of Andhra Pradesh, recognised intersectional discrimination – discrimination on the basis of the intersection of personal characteristics, such as that faced by Dalit women as Dalits, as women and in the unique category of Dalit women. Discriminatory practices may also be indirect in nature, whereby policies that seem neutral and not expressly targeted at a particular group, still cause a disproportional adverse impact on disadvantaged sections of society.

### Legal remedies are needed

Since discrimination thus operates on a wide variety of grounds, legal remedies are needed for its victims, whether direct, indirect or intersectional. A comprehensive anti-discrimination legal framework is required to fill the existing legal lacunae. India is one of the few liberal democracies without such a framework. The Sachar Committee, in 2006, recognised the need for an anti-discrimination law. This was further reiterated by the Expert Group on Equal Opportunity Commission headed by Prof. N.R. Madhava Menon.

Though the proposal for an antidiscrimination law was approved by the United Progressive Alliance Cabinet, it was put on the backburner after the government changed in 2014.

### When a Bill lapsed

One of us (Tharoor) tried to revive the idea by introducing the Anti-Discrimination and Equality Bill, 2016 (https://bit.ly/3k5KoMf) in the Lok Sabha. Perhaps predictably, the Treasury Benches were not interested to take it forward and the Bill lapsed in 2019 with the dissolution of the Lok Sabha. It seems clear to us that the only way progressive legislation of this nature can be passed in the present climate would be if the States lead the way, by enacting anti-discrimination laws in their respective jurisdictions. States have a vital role in strengthening our right to equality. A central Bill cannot, at any rate, cover subjects that are under the exclusive jurisdiction of State governments. And if States take the initiative, the demand for a national anti-discrimination law to cover services and institutions under the domain of the Union government will be reignited.

Kerala is one the best placed States to take this proposal forward, especially since both the major political fronts in the State have previously committed them-

(M) in its 2019 manifesto (https:// bit.ly/3hVjEet) and the United Democratic Front (UDF) in its 2021 State Assembly manifesto (https:// bit.ly/2UGXFjn) have both promised to enact an anti-discrimination law which covers the private and the public sectors. The State legislature can use its powers under Entry 8 of List III in the Seventh Schedule to the Constitution to enact an anti-discrimination law that attracts civil penalties for those who engage in discriminatory practices.

### **Crafted for Kerala** With the invaluable assistance of

Professor Tarunabh Khaitan of Oxford University, we have drafted an anti-discrimination Bill for the Kerala government to consider introducing in the State Legislative Assembly. The Bill prohibits employers, landlords, traders, service providers, private persons performing public functions, and public authorities, from discriminating on grounds of caste, race, ethnicity, descent, sex, gender identity, gender expression, pregnancy, sexual orientation, religious identity, tribe, disability, linguistic identity, HIV-status, nationality, marital status, dietary preference, skin tone, physical appearance, place of residence, place of birth, age or analogous characteristics which are beyond the control of an individual or those that constitute a fundamental choice

At the same time, the Bill balances the anti-discrimination mandate with other rights guaranteed by the Constitution. The antidiscrimination mandate can be restricted in pursuance of a legitimate objective:for instance, a drama company putting up a production of the Ramayana can insist on only male applicants for the role of Ram. That would not be discrimination in the terms covered by the

The Bill also introduces affirmative-action provisions whereby public authorities are obliged to progressively realise diversification of their workforces by recruiting members of disadvantaged sections excluded from society, such as transgender persons or persons with disabilities. Given the backlogs in our judicial system, the Bill establishes a 'Kerala Equality Commission' to adjudicate complaints and to provide policy recommendations to the State government. Given that the proliferation of post-retirement public offices for judges does not augur well for judicial independence, the proposed commission does not follow the tried and tested model of former judges presiding over statutory bodies. Rather, appointments to the Commission are left to the political process, with substantial weightage given to the largest parties in the State, both in the Treasury and Opposition benches, to ensure bipartisan buy-in to the process.

The Bill has been forwarded both to the Law Minister of Kerala and the Leader of the Opposition with the suggestion that it should be subjected to a pre-legislative consultation process, so that democratic participation in enacting this historic law is encouraged (https://bit.ly/3reY74Z). If this Bill is enacted, it will be the largest expansion of civil rights in the State since the commencement of the Constitution, and it can be a model for other States to follow. We recognise that an anti-discrimination law is not a panacea for the problems of inequality and social prejudice that are deeply rooted in our society. Nevertheless, it is a necessary step - an idea whose time has come.

# Shaping a trilateral as Rome looks to the Indo-Pacific

In the pushback against China, strategic cooperation between India, Italy and Japan can ensure a free Indo-Pacific

ne of the signs of India's growing centrality in the Indo-Pacine strategie archi tecture is its burgeoning engagement with key western nations. Even countries which have been lackadaisical in their regional outreach so far have begun to approach the Indo-Pacific with a new seriousness and have been reach-

ing out to New Delhi The growth of India's weight in Indo-Pacific affairs comes at a time when it is becoming clearer that complex regional geopolitical problems cannot be addressed adequately by rigid and structured traditional alliance frameworks. This aspect is even more evident in the context of the Indo-Pacific, where the geographical vastness of the area and the criticality of the challenges posed by China's assertive initiatives clash with a region lacking multilateral organisations capsolving problems effectively.

But as a new pushback against China takes shape and as Indian foreign policy becomes strategically clearer, there is a new momentum to initiatives such as the

Quad. Countries that share similar values and face similar challenges are coming together to create purpose-oriented partnerships. In doing so, they are making it possible for participating nations to address specific common challenges, from maritime security to a coordinated pandemic response, including consolidating and further developing strong reciprocal trade relationships, without comproeach participant.

# Italy's outreach

Recently, Italy has also begun to signal its intention to enter the Indo-Pacific geography. It has done so by seeking to join India and Japan in a trilateral partnership. This initiative comes after years of Rome's relative absence from the geopolitical affairs of the region as it sought to concentrate more on the Atlantic and European dimensions while maintaining good, albeit well below potential, bilateral relations with India.

The Italian government headed by Prime Minister Mario Draghi has started to pay attention outside its immediate neighbourhood again. At the same time, Italy has become more vocal on the risks emanating from China's strategic competitive initiatives. Recently, Mr. Draghi described Chinese competitive practices as "unfair" and invited the European Union (EU) to be franker and more courageous in confronting Beijing on

its violations of human rights, reit-"the reciprocal visions of the world are very different".

On the Indian side, there is great interest in forging new partnerships with like-minded countries interested in preserving peace and stability in the Indo-Pacific. During a recent India-Italy-Japan trilateral, organised by the Italian embassies in India and Japan, Riva Ganguly Das, Secretary (East) of the Ministry of External Affairs, reiterated that the responsibility of keeping the Indo-Pacific free and open, and working for the welfare of its inhabitants falls on like-minded countries within and

beyond the region.

With the expression of interest on the Italian side, the first step towards this trilateral has been taken, vet it needs to evolve into something more significant. The Italian government must formulate a clear Indo-Pacific strategy that must indicate its objectives and, above all, the means and initiatives it is willing to implement to define a common economic and on its own and in cooperation with its partners. Italy's tendency to diplomatic action through the mechanisms of the EU can be a resource for consolidating the EU-India strategic relationship. But Rome must go beyond that in defining and implementing, at the margins of the EU's common initiatives, its own policy with respect to the Indo-Pacific.

# Trilateral cooperation is key

The India, Italy and Japan trilateral initiative can, and should, be a forum to foster and consolidate a strategic relationship between these three countries, and specifically expand India-Italy bilateral relations. As it stands, relations between Rome and Tokyo are historically strong, and those between New Delhi and Tokyo are a strategic pillar of the free and open Indo-Pacific. A trilateral cooperation can be the right forum for India and Italy to learn more from each other's practices and interests and consolidate a strategic dialogue that should include the economic, the security and the political dimensions. The next G20 leaders' summit in Rome, in October, before the presidency handover to India in 2023, should be the right opportunity for further trilateral coordination on economic and political issues at an institutional level. To consolidate the trilateral cooperation in this field, the three countries need strategic agenda. A strategic trilateral between In-

dia, Italy and Japan has, in the medium to long term, a lot of potential. Their compatible economic systems can create a virtuous and mutually beneficial contribution to the reorganisation of the global supply chains that is now being reviewed by many players as a natural result of the Chinese mismanthe pandemic. At the security level, the well-defined India-Japan Indo-Pacific partnership can easily be complemented by Italy, already present in the western Indian Ocean where it is engaged in antipiracy operations off the coast of Somalia. At the multilateral level. the three countries share the same values and the same rules-based world view. Despite these fundamental convergences, the risk inherent in missing this opportunity also exists. For this reason, a clear political will is needed from all sides, and Italy, in particular, should recognise its interests in playing a larger role towards the maintenance of a free and open Indo-Pacific. Robust India-Italy strategic ties can be the first step towards the realisation of this goal.

# Tapping on the potential of the youth

It is critical that we safeguard young people's well-being because India's welfare hinges on them

World Population Day is marked on July 11 every year to focus attention on the importance of population-related issues. It was first observed by the United Nations Development Programme (UNDP) in 1989 and aims to raise the discourse on sustainable ways to safeguard each life that adds up to a population.

As flagged by a UNDP report last year, and subsequently in a global study by The Lancet, India will stabilise its population 12 years earlier than expected. Therefore, the window India has to leverage its 'demographic dividend' is narrower than we had thought. Fears of a 'population explosion' are misplaced; instead, it is critical that we focus our attention on safeguarding young people's well-being because India's welfare hinges on them.

### Impact of the pandemic

At 253 million, India's adolescent population is among the largest. Over 62% of India is aged between 15 and 59 years, and the median age of the population is less than 30 years. India's 'demographic dividend' represents the potential for economic growth based on the age structure of the population. However, transforming this potential into reality requires adolescents and the youth to be healthy and well-educated.

Even before COVID-19 caused country-wide school closures, India's underfunded education system was inadequately equipped to provide the skills young people need to take advantage of emerging employment opportunities. According to the World Bank, public expenditure on education constituted 4.4% of GDP in 2019 and only 3.4% of GDP in 2020. Another report revealed that India stands 62nd in terms of public expenditure per student, and fares badly in quality of education measures such as student-teacher ratios. Coupled with the impact of CO-VID-19, this paints a bleak picture of the state of education today.



In India, more than 32 crore students have been affected by the nationwide lockdown due to COVID-19. Of these, about 15.8 crore are female. The number of schoolgirls who are impacted is 158 million and many of those who have dropped out are unlikely to go back to school. Schools have remained closed even in remote areas where the effect of the pandemic has been minimal. Studies show that school closures have a serious impact on the lives and mental well-being of children.

The impact of the pandemic on adolescents has been severe. A survey by the International Labour Organization reveals that 65% of adolescents worldwide reported having learnt less during the pandemic, and 51% felt that their learning would be further delayed. It also highlighted that adolescent mental well-being has taken a big blow, with 17% of young people likely to be suffering from anxiety and depression.

It is important, therefore, for policymakers to balance the risks of transmission through children with the harm of prolonged school closures. By prioritising the vaccination of teachers and school support staff and also allowing a decentralised approach where district-level officials may reopen schools based on local COVID-19 transmission rates, schools could be opened in a safe and phased manner. In Odisha, for example, community schools have re-opened in some areas. Students wear face masks and sit physically distanced from each other outdoors under sheds or tents. With some innovation and creativity, opening schools with a mix of online and offline options

could be an important step to addressing the learning needs and mental well-being of adolescents.

Increased poverty levels during the pandemic may well have led to a worrying spurt in early marriages of girls in India. As demographers like Shireen Jejeebhoy note, while child marriage as a strategy to address household poverty has been noted in India in general, it has registered an alarming rise during the pandemic. This is linked with increases in gender-based violence. Adolescent girls are at high risk during times like these, given their vulnerability to abuse and trafficking, especially if primary caregivers fall ill or die. Restricted mobility due to lockdowns puts girls at risk of violence at home at the hands of caregivers or partners. The impact of the crisis on adolescents, especially girls, is of gigantic proportions, but the problem is not irredeemable, provided we display firm commitment to implementing quick and effective strategies to overcome the challenges.

### The way forward

We are living through a global crisis and the road ahead is uncertain. This will have long-standing effects on adolescents and youth. Recognising that COVID-19 has affected all dimensions of the lives of youth, collaborative actions by key ministries, government agencies, and civil society will be central to developing a holistic and meaningful solution. It is imperative that we have in place mechanisms for better inter-sectoral collaboration as we move to safeguard the futures of our adolescents. School mid-day meals, for example,

exemplify how improved nutrition benefits learning. Not only do they provide an incentive for parents to send their children to school on the assurance of one nutritious meal; they also provide the calorie intake required to stay alert in the classroom. Studies have established strong links between nutrition and cognitive scores among teenagers. Coordination across departments can enable better solutions and greater efficiencies in tackling the crisis that our adolescents face.

Much could be gained if the Ministry of Education took steps to ensure that adolescents, especially girls, continue their education during the pandemic. Simultaneously, the Ministry of Health and Family Welfare must collaborate with the Education Ministry to disseminate key information to help adolescents safeguard their health and ability to learn.

Given that school closures have impacted access to schemes such as the delivery of menstrual hygiene products to adolescents, teachers can work as volunteers for collaborating with frontline health workers to distribute sanitary napkins to girls. To address the mental health of adolescents, the Health and Education Ministries should strengthen outreach via existing helplines and by enabling conversations on critical issues regarding their reproductive

and sexual health. There is enough academic research to demonstrate how the demographic dividend contributed to growth in other countries, especially during East Asia's economic miracle of 1965-1990. During that period, East Asia's working age population grew at a faster rate than its dependent population, thereby expanding the per capita productivity of these economies. This occurred because East Asian countries developed social, economic, and political institutions and policies that allowed them to realise the growth potential created by the transition.

Improving the lives of our adolescents in mission mode would lift their lives, but also generate a virtuous cycle with healthier and educated young adults contributing substantially to securing India's future.

# Secrecy is a weapon

Journalists are forced to rely on sources and form an opinion based on conjectures

In 2014, when writer Perumal Murugan was forced to go silent for a period due to the excesses of a caste-based vigilante group with the backing of the district administration, there was justifiable outrage among writers and artists. There were protest meetings across Tamil Nadu. In one such meeting, a group of young artists came up with numerous posters that demanded that the freedom of expression be upheld. After the meeting, I was presented with a set of posters which were based on the poems by the modern Tamil poet, Atmanam. These posters adorn my office and constantly remind me not to take free speech for granted.

### Right to free speech

In journalism, we talk about two forms of censorship: one imposed by external forces and the other imposed by us on ourselves due to fear. Though Mr. Murugan was granted relief by the High Court, legal scholar Gautam Bhatia, in his article "The fault in our speech" (July 7, 2016), pointed out the limitations in the court's approach. The judgment was based on three rather restrictive arguments: "First, that the book has won many prizes, and has gained critical acclaim; second, that Indian culture had always celebrated sexuality until the Victorian British suppressed it; and third, that read as a whole, the book is not intended to titillate or eroticise, but instead, to make a broader point about how social pressures can impact individual lives."

Mr. Bhatia rightly argued that "for speech to be truly free, the judiciary must stop asking literature to justify its aesthetic or its politics before the Bar, whether mediated by an awards jury or not". Throughout South Asia, writers, poets and journalists often invoke the legendary Faiz Ahmad Faiz to defend our right to express ourselves fully. His poetry 'Bol (Speak)' galvanised many for decades to fight for the fundamental right to free speech. He wrote: "Speak, for your lips are free; speak, for your tongue is still yours. Your upright body belongs to you; speak, for your soul still is yours".

What unites a legal mind like Mr. Bhatia and a cultural icon like Mr. Faiz is their unending quest to secure rights for everyone. Mr. Faiz wrote the Report of the 1968 Standing Committee on Art and Culture, which was forgotten not only in Pakistan but across South Asia. It is important for courts and the governments to listen to Mr. Faiz. He wrote: "Culture is lived and evolved by the whole community... The arts are not a luxury. They are an important factor in a nation's mental and moral health and productive efficiency."

There is a body of literature about freedom of expression and freedom of the press. Such works talk about the excesses of governments and the legal recourse. But there are no clues in literature on how to deal with a government which makes its decisions in total secrecy. James Madison, author of the Bill of Rights in the U.S., once said that "a popular government without popular information or the means of acquiring it is but a prologue to farce or a tragedy or perhaps both". In India, now there is very little credible popular information. Journalists are forced to rely on sources and form an opinion based on conjectures.

### Official silence

On July 7, Prime Minister Narendra Modi effected a major reshuffle in his Cabinet. Beyond headline management by the government, citizens know very little about the factors that led to this change. The strap line that accompanied the reshuffle story on the front page of this newspaper read: "Move aimed at bringing in qualified professionals and balancing regional and community aspirations in the run-up to upcoming elections".

I was intrigued by two sentences in the story. One read: "Government sources termed it an effort by Mr. Modi to strike a balance between political messaging of including MPs from various regional centres as well as from marginalised communities and beefing up the skill set of the ministries with professionally and educationally qualified additions." And the other said: "Several ministries have been clubbed together, sources say, to increase synergy." Why should journalists rely on sources for such perfectly legitimate and democratically valid reasons? Why was there no official briefing? Journalists are forced to cite sources because of the official silence. How do we address this important democratic deficit? The government is aware that secrecy is a potent weapon. It is no longer a prologue to farce or tragedy. It is tragedy.

# A ride to safety

Uber and UNESCO are coming together to offer a 'Free rides for teachers' vaccination' campaign

The world is not yet out of the CO-VID-19 pandemic, which continues to take a high toll on populations and economies. This unprecedented health crisis has also severely impacted the gains made in the education sector over the last few years. In India alone, 1.5 million schools shut down in 2020, affecting 320 million learners and impacting their education, protection and well-being.

Throughout this pandemic, the exceptional effort undertaken by teachers must be highlighted. Using the resources available to them, Indian teachers mobilised as one and have remained on the front-lines of education to ensure continuity of learning, often against formidable odds, even though the pandemic claimed the lives of many of them.

As the country steps up its efforts to tackle the devastating effects of the second wave of COVID-19, the national vaccination campaign has assumed greater importance than ever before, so that we can finally move to a 'new normal'. There is an urgent need to better recognise teachers as front-line workers and prioritise them in the vaccination campaign.

While this has already been done by many State governments, the model should be replicated nationwide. This will not only speed up the reopening of schools so that students can get back to 'in person' learning, but will also provide safety.

### **Barriers to vaccination**

Mass vaccination campaigns do not solely depend on the availability of vaccines. Such efforts are always hindered by a lack of suitable transport facilities, and difficult or prolonged travel time to the vaccination sites.

Teachers, like anyone else, may be worried about travelling long distances to the vaccination centres for fear of contracting the virus on public transport and may not be able to access other means of conveyance.

Keeping these limitations in mind and to support the process of swift vaccination for teachers initiated by the government, the ride-sharing company Uber and UNESCO are coming together to offer a 'Free rides for teachers' vaccination' campaign

to provide teachers with the means to travel to the vaccination centres in a safe manner while offsetting the costs of traveling long distances.

The initiative offers 1,00,000 rides to 25,000 teachers to and from vaccination centres to get the two vaccine doses. The offer will be implemented in Chennai, Coimbatore and Tiruchirapalli in Tamil Nadu. The rides will be made available via a promotional code communicated to the teachers with a detailed pictorial brochure to help them download the application and use the code.

# **Global partnerships**

The impact of the pandemic across the globe necessitates a coordinated response. Last year, UNESCO launched the Global Education Coalition (GEC), a platform for collaboration to protect the right to education during the pandemic and beyond.

The coalition brings together more than 175 members from the UN family, civil society, academia, and the private sector focusing on three key issues, namely connectivity, teachers, and gender to ensure continuous

access to education for all. As we now begin to re-imagine education in a post-COVID-19 world, we must remember that renewed cooperation between governments and the private sector can go a long way in combating this crisis. Through our partnership with Uber, we wish to acknowledge the continued commitment of teachers to their students and their critical role in contributing to the achievement of the 2030 targets under Sustainable Development

In this crisis, teachers have shown great leadership and innovation in ensuring that #LearningNeverStops, and that no learner is left behind. They have also helped in communicating measures that prevent the spread of the virus and providing assistance to ensure the mental wellbeing of all children. An accelerated vaccination process will enable them to stand fully ready when schools



FIFTY YEARS AGO JULY 12, 1971

Struggle for Bangla Desh (From an Editorial)

Mr. Jaya Prakash Narayan, Mr. Sadaq Ali, President of the Congress (O), Mr. Krishna Menen and other leading politicians continue to call for the immediate recognition of Bangla Desh. The demand has also been pressed by some members in the Lok Sabha and the Jan Sangh plans to take the issue to the streets next month. Though the Government's sympathies are fully with the Bangla Desh movement there are good reasons for not according diplomatic recognition at this stage. There would be little point in that recognition unless it can be followed up with massive supply of arms to the freedom fighters. This would be treated as an act of war by Pakistan and provide grist for Pakistan's propaganda mill which has been trying to tell the world that India promoted a seccessionist movement in East Pakistan and that the Awami League is a pro-Indian party.

Pakistan would probably welcome any sign of Indian intervention in the east, and if black-out exercises are being held in New Delhi and troops put on the alert in Kashmir, it is because India fears that Islamabad may provoke a war at any moment, just to make it appear that India has engineered the Bangla Desh struggle to weaken Pakistan.

# Boycott campaign

Calcutta, July 11:- Enquiries made by an Associated Press representative in the Calcutta piece-goods market with regard to Mr. Gandhi's movement for the total boycott of foreign cloth by August next show that a feeling of uncertainty and hestitancy prevails among the merchants and that no further orders are likely to be placed, at any rate, for the present, especially as the market is well supplied, but the opinion is held that the movement is almost bound to fail in its object because the Indian mills will be unable to manufacture more than about half the quantity of cloth India requires and the output of Khadi is not expected to supply the deficiency. One leading merchant pointed out that the normal annual Indian demand was over 3,600 million yards of which the Indian mills supplied about 1,800 million and he did not think their production could be materially increased owing to shortage of looms. He doubted if the educated class would take to Khadi spinning and weaving, but he said it was almost certain that the price of Indian cloth would increase if the foreign article was exluded.

"We don't understand Mandarin. They had scribbled something on the banner. They stood there for about half an hour," Mr. Tsewang told The Hindu.

"The land where they stood and protested on the Dalai Lama's birthday is our land. It belongs to India," he

Videos shared by Mr. Tsewang showed a group of men holding a long banner in red with words on it. They are also seen carrying the Chinese flag.

When contacted, Army authorities chose not to comment on the Chinese action. Mr. Tsewang stated that 10 days ago, the Chinese also protested when the locals were setting up a solar pump.

Last Tuesday, Prime Minister Narendra Modi greeted the Dalai Lama in a phone call on the occasion on his 86th birthday.

This is the first time Mr. Modi has publicly confirmed speaking with the Dalai Lama since he took over as PM in 2014.

The developments come against the backdrop of a continuing deadlock in the talks at various levels to resolve the ongoing military stand-off in eastern Ladakh.

Twitter also processed 56 grievances appealing for suspension of user accounts, of which seven were overturned and remaining suspended.

The social media giant has also said that proactive monitoring of user content led to suspension of 18,385 accounts for child sexual exploitation and 4,179 accounts for terrorism related activities globally.

The big social media companies are mandated to appoint a chief compliance officer, a nodal contact person and a resident grievance of-

All of them should be resi-

dents of India.

However, Facebookowned Whatsapp has challenged the new IT rules for social media intermediaries requiring the messaging app to trace chats and make provisions to identify the first originator of information, saying they violate the right to privacy and are unconstitutional.

WhatsApp further alleged the requirement of intermediaries enabling the identification of the first originator of information in India upon government or court order puts end-to-end encryption and its benefits "at risk".

Some of the media houses have also challenged the new IT rules and the matter is sub judice.

# Psychoanalysis test done on blast accused

Police say two are telling 'partial truth'

Results of the psychoanalysis test of four students arrested from Ladakh in connection with a blast near the Israel Embassy in New Delhi in January found that two of them were telling "partial truth", a senior police officer said on Sunday.

The police said that Nazir Hussain, 26, Zulfikar Ali Wazir, 25, Aiaz Hussain, 28 and Muzammil Hussain, 25, all from Thang village in Kargil district of Ladakh, were arrested from Kargil and brought to Delhi on transit remand on June 24.

After detailed investigation, they were taken to the All India Institute of Medical Sciences for a psychoanalysis test by a panel of expert

"The test result shared by doctors mentioned that two of them were telling 'partial truth' regarding their role in the blast outside the Israel Embassy," the officer said.

"We are going through the test report to find out what's the 'partial truth' the accused are hiding from the police. If required, we will take the help of experts and question them again," the officer added.

The police said all four accused had been in Delhi on the day of the blast and their phones were found to have been switched off. Five mobile phones had been recovered from them.

A minor IED (improvised explosive device) blast took place outside the embassy on January 29. There were no casualties.

# Naqvi slams critics of U.P.'s population policy



# HAL set to deliver first batch of 3 LCH

These are part of 15 Limited Series Production copters approved for Army, IAF

Hindustan Aeronautics Limited (HAL) is gearing up to deliver the first batch of three Light Combat Helicop ters (LCH) to the Indian Air Force (IAF) once acceptance tests are completed. These are part of the 15 Limited Series Production (LSP) helicopters approved for the Army and the IAF.

"HAL has received Letter of Intent for five Air Force and five Army LCH for delivery pending contract finalisation of 15 Limited Series Production (LSP) LCH. HAL has produced and signalled out three LSP LCH for the IAF. Same will be subjected to customer acceptance and training shortly," a HAL

On the remaining helicopters of the LSP series, the source added, "In the current year we are producing four LCH for Army and two for the Air Force. Remaining six LCH will be produced

The deal for the 15 LCH was expected to have been signed in the first quarter of 2021 but has been delayed due to the second wave of the pandemic. The IAF has put forward a

requirement for 65 LCH and the Army for 114 helicopters. Of the 15 LSP helicopters, 10 are for the IAF and five for the Army. The LCH, the lightest attack helicopter in the world weighing 5.5 tonnes, has been designed and developed by the HAL to meet

the specific and unique requirements of the Indian armed forces and can operate at heights of 12,000 feet.

The Army Aviation operates smaller utility helicopters but does not have attack helicopters in its fleet and has for sometime pitched for attack helicopters of its own to operate with its strike Corps. The attack helicopter fleet is operated by the Air Force which provides close air support to the Army.

The IAF operates the older Mi-25 and Mi-35 Russian attack helicopters which are in the process of being phased out and has inducted 22 AH-64E Apache attack helicopters from the U.S. The Army will also start re ceiving the Apache attack helicopters from early 2023 onwards, six of which have been contracted under an estimated \$800-mn deal from the U.S. in February 2020.

Presently, the Army has 90 Advanced Light Helicopters (ALH) and 75 Rudra, weaponised ALH, helicopters in service which are indigenously designed and developed by the HAL in addition to around 160 older Cheetah and Chetak utility helicopters which are in need of urgent replacement.

Last August, amid the ongoing standoff with China in Eastern Ladakh, two LCH were deployed for operations at high altitude in Leh at short notice to support IAF missions, validating their capability.

# Prisoners wait for SC's bail order to arrive by post

Convicts have spent 14-20 years in jail

It has been three days since the Supreme Court granted immediate interim bail to 13 convicts lodged in the Agra Central Jail but the inmates are yet to walk free as jail authorities are waiting to receive the order by post. The convicts have spent between 14 and 20 years in prison despite being juveniles at the time of committing the crime.

V.K. Singh, Senior Supe-

rintendent of Agra Central Jail, said they were waiting for the certified copy of the SC's order. "We will follow the due process. After the top court's order, they will surely be released but only after receiving the physical copy of the order," Mr. Singh told *The Hindu*. "It has been dispatched and it should reach us any time." A source in the prison said the order was expected to reach them on Monday. "The SC took only a week to pass the order in favour of the petitioners but it seems it will take another week to get them released from a Central Jail in Uttar Pradesh," said lawyer Rishi Malhotra, who represented the convicts.

He asked why the orders were being sent by post when the courts had moved online in the pandemic. "Why can't the jail authorities check the orders online and take necessary action? In the digital age, the cumbersome process of waiting for physical copies could be

done away with," Mr. Malhotra said.

He said the convicts had spent a good part of their lives behind bars because of ignorance and a lack of good

legal aid at the trial stage. "The 13 prisoners had not taken the defence of juvenility during the trial stage," he

In 2012, the Allahabad High Court directed the Juvenile Justice Board to determine the ages of prisoners, following which 13 were found to be juvenile offenders. "All of them were convicted for murder and were given life terms," said Mr. Malhotra.

According to the Juvenile Justice Act 2000, the maximum sentence for juvenile offenders is three years in a juvenile correction home.

"On one hand, jail authorities complain that the jails are overpopulated and on the other, they perpetuate red-tapism," Mr. Malhotra said.

India has evacuated personnel from the Consulate-General in Kandahar as a temporary measure in view of the fighting between the Taliban and Afghan security forces, said the Ministry of External Affairs on Sunday. Official spokesperson Arindam Bagchi said the mission is "not closed" and the visarelated work has been shifted to the Indian Embassy in

"The Consulate-General of India in Kandahar has not been closed. However, due to the intense fighting near Kandahar city, India-based personnel have been brought back for the time being," said Mr. Bagchi, emphasising that the evacuation "is a purely temporary measure"

The reiteration of the "temporary" nature of the closure came a day after The

Afghan security personnel on duty in Kandahar amid growing fighting.

Hindu reported that India has closed diplomatic operations at Kandahar temporarily. The Indian personnel were seen on Saturday leaving the premises of the mission in a cavalcade of official vehicles.

"The Consulate continues to operate through our local staff members. Arrangements are being made to ensure continued delivery of visa and consular services through our Embassy in Kabul," said Mr. Bagchi. The diplomatic mission in Kandahar serves as an important coordinating centre for the large number of medical tourists who seek treatment in India and obstructions and delays in visa acquisition can create challenges for Afghan citizens intending to visit Indian hospitals.

The security situation in Kandahar continues to remain grim with fierce fighting going on in the suburbs and in nearby areas that have been taken over by the Taliban fighters. Taliban fighters on Friday attacked the jail in Kandahar that holds a large number of veterans of the movement.

Indian missions in Afghanistan were targeted by terrorists in the past and Saturday's evacuation is, therefore, being interpreted as a measure to ensure the safety and security of the people employed at the Indian Consulate-General.

# 'Pressure fuse points to Pakistani hand'

Sources say LeT may have got help from the ISI or the Army in fabricating IEDs

The "pressure fuse" used in the bombs dropped on the Indian Air Force (IAF) station in Jammu through drones in a first-of-its-kind attack in India indicates that some elements of the Pakistan Army or the ISI helped terror group Lashkar-e-Taiba in fabricating the IEDs, according to security sources.

The improvised explosive device (IED) that pierced the rooftop of one of the IAF buildings at the Jammu airport carried less than 1 kg of RDX and a cocktail of other chemicals, whereas the one that was dropped on the ground contained a little over 1 kg of the deadly explosives along with some ball bearings, they said. The sources said the IED used in the June 27 attack "definitely" contained the technical expertise of the Pakistani military. The 'pressure fuse' used is similar to the ones used by the Pakistani Army.

A 'pressure fuse' is generally used in minefields, anti-

tank mines and those dropped by the air force in the fuselage between the explosive and main detonator of a shell or an IED. The explosive devices are activated by the pressure of either falling on the ground with force or some individual or vehicle passing over it.

However, in these sophisticated IEDs, the 'pressure fuse' had been deployed at the nose of the bombs so that they trigger with a force after falling on the ground, the sources said. Most of the artillery shells and mortar bombs have this type of fuse,

and that is why they do not explode in the air but on impact, they explained.

Director-General of Jammu and Kashmir Police Dilbag Singh had said earlier that Pakistan-based terrorists of Lashkar-e-Taiba were suspected to be behind the bombing of the IAF station.

Two IAF personnel were injured in the explosions that took place within six minutes of each other. The first blast ripped off the roof of a single-storey building in the technical area of the airport manned by the IAF in Satwari on the outskirts of Jammu.

The second one was on the ground. Notably, of late, Pakistan has been procuring armed drones from China and Turkey.

The sources said drones could fly up to three hours and could be monitored and manoeuvred through the Global Positioning System (GPS) technology. The aerial distance from the Jammu airport to the International Border is 14 km.

In September last year, five Lok Sabha members from the YSR Congress had asked whether the government had issued any guidelines in light of the possibility of drones being used as weapons of attack on highsecurity installations.

Public must follow COVID-appropriate behaviour: doctors

BINDU SHAJAN PERAPPADAN

The lingering second CO-VID-19 wave and the current weather - a combination of high heat and humidity prevailing across some parts of India - have prompted doctors to caution the general public to strictly follow CO-VID-appropriate behaviour to ensure that places with common air conditioning and poor ventilation do not prove to be superspreader zones.

The effect of worsened weather on an ongoing illness contributed in terms of aggravated symptoms, said Anurag Aggarwal, associate consultant, internal medicine, QRG Health City, Faridabad, who added that there was no proven research on how the virus responded to weather conditions.

Bhagwan Mantri, consultant, pulmonology, Moolchand Hospital, noted that lower relative humidity aided airborne transmission of water droplets and aerosols.

"When we cough, sneeze, talk or sing, water droplets and smaller water particles [aerosols] containing living viruses disperse into the air. Droplets and aerosols tend to stay afloat longer and travel farther in the air with lower relative humidity. Virus-containing aerosols, in particular, can penetrate more deeply into the lungs to increase the possibility of transmission," he said.

"When moisture levels are insufficient, viral particles have a greater 'docking' potential at airway receptor

sites, which can lead to an increased risk of infection. Low relative humidity has a drying effect on the cells and mucous linings of our airways. These cells act as a defence against viral particles and other invading foreign substances. Drying out airway linings impairs their ability to function properly," Mr. Mantri added.

However, he said adherence to COVID-appropriate behaviour was the only way to reduce the transmission risk in any atmospheric

# Four minors rescued in Bhubaneswar

Four children, all below the age of 10, sitting helplessly and seeking food under a tree on the outskirts of Bhubaneswar in Odisha after being abandoned by their parents, were rescued on Saturday.

Childline, an NGO working with disadvantaged children, said their mother had left them to fend for themselves eight months ago. The father, a laterite stonecutter, used to get food for the three girls and a boy. However, three days ago, the father disappeared.

The rescued children were put up in childcare institutions after the Child Welfare Committee saw them videoconferencing.

With sources of income for people in the low-income groups drying up due to the COVID-19 pandemic, the vulnerability of children has been further exacerbated. Children are exposed to hunger and are becoming malnourished," said Benudhar Senapati, Director of the Childline facility, on Sunday.

In 2020-21, Childline intervened for 758 children in Bhubaneswar alone.

In past three months since April, Childline has intervened for 196 children, and 51 children had to be rescued.





# Advent of Alavandar

It was indicated through divine will to Nathamuni that his grandson would preserve and propagate the Vaishnava tradition that was entrusted in his custody. At the time of his death, Nathamuni asked disciples to bequeath this inheritance to his grandson and name him Yamunai Thuraivar. The term 'Alavandar' means 'One who has come to reign,' and his advent is seen as a landmark event in Vaishnava tradition, pointed out Asuri Sri Madhavachariar in a discourse.

Born as a precocious child, he gained extraordinary proficiency in the sastras at a young age. An event in his early life proved his ability to engage in intellectual debates with felicity. Once Akki Azhwan, the court scholar, presuming himself to be the greatest scholar, insisted that all other scholars should pay him tribute in the form of dues. When this demand was sent to Alavandar's preceptor Maha Bashya Bhatta, the disciple asked his preceptor to ignore it. Learning that a young boy had dared to defy the royal scholar, the king was curious to meet him. So he invited him to the court.

Much impressed by his effulgence and demeanour, the king promised him a share in the kingdom if he won in the debate with Akki Azhwan. The queen was sure that the boy would win. Alavandar humbled the conceited scholar by posing three statements and challenged him to negate these. 'Your mother is not a barren woman, the king is paramount and the queen is a good wife.' Akki Azhwan had to accept defeat. The queen greeted the boy thus, 'you who have come to rule us all in spiritual matters.' and the king gifted him a small country to rule. Alavandar, owing to the efforts of Nathamuni's disciples, soon took charge of the legacy of the rich tradition that would instil intense faith and devotion to God in people's heart and soul.

# Kabul airport gets anti-missile system

Amid Taliban onslaught, NATO keen to secure vital exit route for foreign diplomats and aid workers

Afghan authorities said on Sunday they have installed an anti-missile system at Kabul airport to counter incoming rockets, as the Taliban pressed on with a blistering offensive across the country.

Washington and its allies are due to end their military mission in Afghanistan at the end of August, even as the insurgents say they now control 85% of the country - a claim that could not be independently verified and is disputed by the government.

The Islamic fundamentalist group's rapid gains in recent weeks have raised fears about the security of the capital and its airport, with NA-TO keen to secure a vital exit route to the outside world for foreign diplomats and aid workers.

"The newly installed air defence system has been operational in Kabul since 2

a.m. on Sunday," the Interior Ministry said in a statement. "The system has proven useful in the world in repelling rocket and missile attacks."

Security forces spokesman Ajmal Omar Shinwari said the system was given by 'our foreign friends".

"It has very complicated technology. For now our foreign friends are operating it while we are trying to build the capacity to use it," Mr. Shinwari said, adding that in the past week 1,177 Taliban fighters were killed in fighting with government forces.

# HK pro-democracy group downsizes over safety fears

The Hong Kong Alliance in Support of Patriotic Democratic Movements of China is best known for organising an annual rally and candlelight vigil remembering those killed in the bloody 1989 crackdown on prodemocracy protests in Beijing's Tiananmen Square.

The group said in a statement on Saturday that seven of its 14 remaining steering committee members had decided to step down in the face of "growing political and legal risks".

Of the seven members remaining, three are currently in jail for protest-related activities.

While the 32-year-old group said the changes would affect its operations, it vowed that "regardless of whatever difficulties or challenges we face, the alliance will continue to grit our teeth and move onwards one step at a time".

Swashbuckling entrepreneur Richard Branson hurtled into space aboard his own winged rocket ship on Sunday in his boldest adventure yet, beating out fellow billionaire Jeff Bezos.

The nearly 71-year-old Mr. Branson and five crewmates from his Virgin Galactic space tourism company, including Indian-origin aeronautical engineer Sirisha Bandla, reached an altitude of about 88 kilometres over the New Mexico desert enough to experience three to four minutes of weightlessness and see the curvature of the earth - and then safely glided back home to a runway landing.

"Seventeen years of hard work to get us this far," a jubilant Mr. Branson said as he congratulated his team on the trip back aboard the sleek white space plane, named Unity.

Ms. Bandla became the third Indian-origin woman to fly into space after Kalpana Chawla and Sunita Williams. Wing Commander Rakesh Sharma is the only Indian citizen to travel in

The brief, up-and-down flight - the rocket ship's portion took only about 15 minutes, or about as long as Alan Shepard's first U.S. spaceflight in 1961 - was intended as a confidence-boosting plug for Virgin Galactic, which plans to start taking paying customers on joyrides next year.

Mr. Branson became the first person to blast off in his own spaceship, beating Mr. Bezos by nine days. He also became only the second septuagenarian to depart for space. (Astronaut John Glenn flew on the shuttle at



Q. I am 28 years old, working in the private sector, and want to start planning for my retirement. Assuming I want to retire at the age of 60, and want to have a corpus of ₹2 crore, what is the amount I should have after 32 years that will be equivalent to ₹2 crore considering all factors like inflation, etc. Besides that, I would also like to have a fixed monthly income equivalent to 1 lakh in value today. What are the best suited options/ financial instruments I should start investing in to ensure this? Are NPS and PPF better since they come with sovereign guarantee? Also, which instrument is wise considering tax implications, both today as well as at the time of withdrawal. KARAN SHARMA

A. It is not clear whether you want ₹1 lakh per month post retirement or right away. We will assume if it is post retirement. When you plan for your retirement, it is best you decide how much monthly income you want then, rather than fixing a lumpsum you wish to have, without knowing if that lumpsum will last. If ₹2 crore is the amount you want after 32 years, then ₹10,000 per month if it earns 9% on an average for the next 32 years, should comfortably take you there.

However, if you wish to have ₹1 lakh per month of income starting retirement (in today's value) then it will be ₹3.5 lakh per month 32 years hence, assuming inflation at just 4%. That means your corpus requirement will jump to ₹6.9 crore to be built in these 32 years. That also means you will need about ₹31,000 pf savings per month generating at least 9% per annum for foe the next 32 years. You can use a combination of NPS, PPF and equity index funds to invest for your retirement. You could consider using NS more for your debt allocation and use the equity index funds for equity exposure. Of course, NPS is not fully tax-free on retirement as the pension is taxable. You will seldom get options which are tax-free at all stages. So, instead of focusing on tax efficiency, please focus on what will lead you to your goal. (Vidya Bala is co-founder, primeinvestor.in)

Q. Can you suggest some good mutual fund companies because these days it's hard to distinguish between the fake and genuine company. Please suggest the procedure for investing through mutual funds, the minimum investment, the average rate of return and the risks involved. I can search for these things on the Internet or YouTube, but I cannot trust everything I read or see there, that's why I am asking you.

Aarati Krishnan replies: It is good that you are keen to identify regulated investment options and to invest in them after seeking detailed information, instead of simply going by what you read online. All mutual funds are required to register with SEBI before launching products for investors. You can check the list of registered mutual funds at the SEBI website here:

https://www.sebi.gov.in/sebiweb/other /OtherAction.do?doRecognisedFpi=

There are four key routes for investing in mutual funds. You can invest through mutual fund distributors who are registered with the Association of Mutual Funds of India, who will facilitate your transaction. To check if the distributor is registered, you can ask for his or her ARN (AMFI registration number). You can invest through brokerages and platforms offered by banks and brokers, in the 'regular' plans of mutual funds. When you use these routes, you incur commission to compensate these intermediaries, which is included in your fund's costs. You can also invest in mutual funds through their 'direct' plans where you save on this commission. This can be done by either directly registering on each fund's website and investing online or through platforms offering direct investments such as Kuvera, Groww and Zerodha Coin. While you save on costs with direct investments, you will need to select your asset classes and funds on your own. You can also engage the services of a registered investment adviser who can advise you what funds to buy for a flat fee. Mutual funds allow minimum investments as low as ₹500. You usually get to choose between lumpsum investments (investing a sum at one go) and Systematic Investment Plans (SIPs), where you can set up auto-debits to invest a regular amount every month in chosen mutual funds. This allows you to build a sizeable corpus over time. Mutual funds are market-linked products and there are many types of mutual funds. There are mutual funds which invest in company shares, in company bonds, government bonds, money market instruments and even gold. There are also funds that combine one or two of these assets. So it is difficult to tell vou what the average rate of return would be across all these types. Generally, you should choose a mutual fund category based on your investment horizon, your ability to handle risks (volatility in your capital value and returns) and your return expectations. It would be good to engage the services of a qualified investment adviser or financial planner who can help you map out your financial goals and start you on your investing journey. # Understanding INVESTMENT RISKS

Systematic and unsystematic risks are part and parcel of the system and there is no way an investor could avoid them

GAURAV MASHRUWALA

Inflation, taxes, government policies, geo-political situations and economic cycles affect all investments. These risks exist in the system. There is no way we can avoid them. Inflation will reduce the real (actual) rate of return from all forms of investment, be it debt or equity or property.

Similarly, taxes eat into the final returns in the hands of an investor. We have touched upon the kinds of risks earlier in this space but here is a detailed look at the hard realities.

In a Communist economy, wealth creation is difficult, irrespective of the risk-taking abilities of an individual. Likewise, if a local currency is revalued, all forms of investments will get impacted. The risk that exists in the system is called 'systematic risk'.

There is absolutely no way to avoid systematic risk. However, by adopting time averaging (popularly known as systematic investment plans) one can re-

duce the impact of systematic risk. The impact of risk is averaged out by investing fixed amounts at fixed intervals.

Since more investment units will be bought at a lower cost and less investment units at a higher cost, over a prolonged period, averaging will start working in the investor's fa-

vour. Please note that these investments could be in any class

It could be in debt, equity or property. Another strategy, which is superior to time averaging is value averaging. However, due to its complexity, it is usually not only recommended. The recurring bank deposit is also an example of a systematic investment plan.

Another category of risk is 'unsystematic risk'. Risk which does not exist in the system as a whole but which is specific to a particular asset class or particular investment product is called unsystematic risk. Another name for unsystematic risk is 'specific risk'.

Crashing of property prices in Mumbai due to an unfavourable court judgment on a development near the Arabian Sea is an example of unsystematic risk. This will only affect property prices in Mumbai, and no other form of investment in Mumbai or any other part of the world will be affected. Similarly, if the CEO of a company resigns, causing the stock price to tumble, then it is called an unsystematic risk.

This will have no impact on the prices of other stocks or any other investments. Another example could be of gold prices crashing due to government control.

Diversification is the best solution for controlling unsystematic risks. Diversification has different meanings to different investors. There are some who



Shopping is fun. Research, budgets, recommendations, comparisons and a little bit of dreaming about how happy we will be once we own it.

Selling can be interesting too. In addition to the age-old Indian tradition of bargaining, some aspects require extra care and involvement when you sell your old vehicle.

Praise it to the skies, haggle for the best price, and be sure you know what to do with its insurance policy as well.

Vehicle insurance, as you would have read in this column, is of two kinds – Third-party liability and Own Damage. When you sell a vehicle, you may be in the middle of your policy period. That is, the policy is still valid and the renewal is a way off. When you sell your car, you

sign some Road Transport Authority (RTO) forms (Form 29 and 30) favouring the buyer. In addition, you have to give the buyer a letter addressed to your insurance company quoting your policy details and the buyer's details, stating that you have sold the vehicle to a specified person and that the policy may be transferred in his favour.

By the way, you should consider the cost of the unused portion of the policy that you are transferring to your buyer and build it into your selling price. For example, if you have just renewed your insurance, we are speaking of almost a year's insurance premium. Once sold, send a copy of the insurance no objection letter and photocopies of the dated, filled in and signed

RTO forms to your insurance company and ensure you get acknowledgement. erage to be valid. Another set should go to your RTO as well for prudence. As for the buyer, he will

present these forms and your letter to the insurance company and transfer the vehicle ownership so that the registration certificate (RC) would bear his name. Once this is done, he can approach your insurance company and, on the basis of your letter to your insurer, get the policv also transferred to his name. Why the fuss? Aren't you done

When you sell the vehicle, the TP liability cover is valid for an interim period of 15 days under the Motor Vehicles Act, 1988, to tide over the time needed for the actual transfer. After this, the policy has to be formally transferred to the new owner for cov-

A vehicle and its insurance papers should reflect the same

name and address. If not, you can be held liable for any accidents that the vehicle may be involved in since the insurance policy records show your name and that will be used for official communication in case of any legal proceedings. Let us cycle back and look at

the name transfer of the vehicle itself. If your buyer does not transfer the vehicle to his name and continues to use it, any liability will be squarely on your shoulders. One way to lock the buyer into transferring the vehicle to his name is to date the Forms 29 and 30 as their validity is only for 15 days from that date. In addition, you are going to send copies to the KTO and the insurance company, remember? I have known buyers and intermediaries who stiffly object to dating the RTO forms 'for convenience' and also cases of buyers who use the vehicle for a few years and sell it on further to others - still in the seller's name.

The chilling thing is liability can be related not only to accidents, but also to any nefarious use the vehicle is put to!

I know that takes some fun out of selling and getting money, but you would sleep better at night, right?

# Don't let go of your no-claim bonus

When you transfer your vehicle insurance to the buyer, you get to keep the best part of it for yourself no-claim bonus your (NCB). This is the accumulated reward for your claim-free record.

This can go up to 40% and you get to encash it at renewal as a discount on Own Damage premium. When you sell your car,

the NCB stays with you as it is attached to you, and not the vehicle. But it is not automatic. You have to make a re-

quest in writing and get a letter confirming it.

When you write to your insurance company stating you have sold your car and they may transfer your insurance policy to the buyer, write another letter asking that your NCB be re-

tained with you. They will write back confirming the percentage

of your NCB. When you buy another

car, you can give this letter to the insurance company and request that the NCB discount be applied to the premium.

This works in practice only if your old and new insurer are the same.

The good news though is that it applies even if your NCB was earned on a smaller car and the new car is a pricey one, with a heftier premium!

# Argentina buries ghosts of the past

Beats Brazil to end a 28-year title drought; Di Maria strike proves the difference

Two long droughts ended on Saturday at the Copa America final: Argentina won its first major title since 1993 after a 1-0 win against Brazil. And Lionel Messi finally lifted his first major trophy for the national team.

Argentina's winning goal at the Maracana Stadium came in the 22nd minute after Rodrigo de Paul made a long pass to Angel di Maria. The 33-year-old veteran striker counted on some sloppy defending from leftback Renan Lodi to take control and lob it past goalkeeper Ederson.

When the match ended, a tearful Messi knelt down and put his hands on his face. Then most of his teammates ran in his direction to celebrate and threw him into the air. Once criticised by Argentina fans for his quietness, he went to the few hundred guests chanting his name at the Maracana and chanted with them. Messi kissed the trophy before lifting it into air during presentations.

Argentina coach Lionel Scaloni made five changes from the starting lineup that beat Colombia on penalties in the semifinal, while Brazil did not make any.

### **Neymar** isolated

The teams were cautious early in the match, barely offering chances. When Argentina opened the scoring in a

Argentina finally made Lionel Messi cry with joy.

After losing four times in finals, early exits in major tournaments and even a decision to retire from the national team, the superstar celebrated a much-awaited title with Argentina on Saturday.

"I needed to remove from myself the thorn of achieving something with the national team," Messi said after celebrating with

When Uruguayan referee Esteban Ostojich blew the final whistle, Messi knelt down on the pitch and covered his face with his hands.

After he lifted the Copa America trophy, Messi spoke to his family on the phone. He flicked the golden medal around his neck and shouted "I won, I won!"

The next challenge is to win the World Cup in Qatar next year, which would be the first since Maradona took the team to the title in 1986.

Until Saturday, Messi's titles with Argentina were only the U-20 World Cup title in 2005 and a gold medal at the Beijing Olympics in 2008.

Gap closed

On Saturday, Messi kissed the Copa America trophy and lifted it at age 34. The biggest gap in his decorated career is now closed.

His first public words after the title showed how thrilled and relieved he felt.

Novak Diokovic had the weight of tennis history on his shoulders and an Italian with dynamite on his racket strings to contend with, but emerged victorious to earn a sixth Wimbledon and a record-levelling 20th Grand Slam title on Sunday.

Matteo Berrettini, playing inspired tennis in his first Major final, unleashed everything in his formidable arsenal. But it was not enough, as the Serb pulled through 6-7(4), 6-4, 6-4, 6-3 on what might prove to be a momentous day in the raging argument about the greatest men's player of all time.

"That was more than a battle. He has a true hammer, an Italian hammer and I felt that today," Djokovic, 34, said.

Djokovic is now tied with Roger Federer and Rafael Nadal on 20 singles Majors and the World No. 1 can become the first man since Rod Laver in 1969 to complete the calendar-year Grand Slam, at the US Open.

"I have to pay a tribute to Rafa and Roger. They are the two most important players I've ever faced and the reason I am where I am today." Djokovic said.

He is now working on his technique. "I was giving more height in my throws, I want to reduce it a bit so that I'll get longer throws... and I'm improving," he said.

With expectations on him huge, is Chopra under pressure?

"There was more pressure during the Commonwealth Games and Asian Games, I have learned to handle the pressure of the Olympic Games," he said.

He listens to music, virtually working out the competition in Tokyo in his head, and does a bit of meditation to stay cool.
