




Ever wondered why CEOs, leaders and recruiters talk endlessly about soft skills? Find out in Skill It, Kill It, a new book in which entrepreneur Ronnie Screwvala shares personal stories and observations from his failures and successes, to give you an insider's view of the 'invisible' skills that can cut years off your learning curve. Excerpts from an interview:

We all know Ronnie Screwvala, the businessman. Tell us more about the writer. What prompted you to write this book?

I am an accidental author. The inspiration for this book stemmed from the interactions with learners. I think lifelong learning is an integral element for growth in this era's hyper-competitive environment. Today, to make a mark, you need to have a strong element of focus. If you want to be in the top 20-25 percentile of your organisation, you have to come out of your comfort zone, upgrade again, specialise and continue this cycle till you have achieved your goal. While talking to students, I saw a serious gap in their soft skills. Now while 'skill' means lots of things to a lot of people, it cannot be restricted to a degree, diploma or even certifications. I believe that equipping yourself with the right communication skills is important and, without it, people are often left behind, despite having the right hard skills for the job.

What skills do students need today?

Through school, we tend to focus on our grades and rank and do not invest any effort in acquiring soft skills like communicating effectively or inculcating the art of storytelling. Communication is a severely underrated skill, especially in this digital remote work era. Most people assume that communication is tethered on oratory skills or

command of the language. Actually it is so many things, including listening, absorbing and knowing when to stop. If you acquire the art of communicating through storytelling, you will be able to influence and impact people by shaping their minds. Stories help us connect with the audience and foster empathy. Storytelling is a lifelong skill that ought to be honed.

You've coined some new words. Tell us about the new LOL.

This comes from my own experience as a young professional. I would be so excited about putting a point across that I would not allow the person before me to finish what he/she was saying. Not only was it rude but also wrong.

Listening is a skill I have worked very hard to improve through my career. It requires focused thoughts, attention to detail, feedback, and the ability absorb what another person is speaking in order to decode what they are really saying.

So, for me Listen, Observe, Learn is the new LOL. To truly listen and then act on feedback from others will help us avoid repeating mistakes and accelerate professional growth and change. Moreover, even great ideas and teams can be aligned if you follow the new LOL.

Why is upgrading and future-proofing one's career important?

This is where the concept of Lifelong Learning comes into play. If you were to believe that your greatest learning and great-

est failure are yet to transpire, then you are allowing yourself to keep an

open mind. This, in turn, opens your mind to learning and upgrading your skills because it reminds you that you have still got so much to learn.

Why do you debunk the idea of multitasking and emphasise the importance of saying no?

My dog taught me that multitasking is overrated and often counterproductive! To put it simply, multitasking leads to distraction, which leads to all kinds of hazards. Multitasking fosters the habit of distraction from the task at hand, leads to a decline in the quality of your work, and to an eventual decline in productivity overall. Eventually it leads to feeling overwhelmed and disconnected on a daily basis.

Dear Souray,

I understand your dilemma on having to balance all of this. If you are going to get distressed, overwhelmed and not enjoy these activities, it is pointless. Make a list of one or two from all these that you love, makes you feel great about yourself, are passionate about, helps you earn, you are exceptional at, and is also a hobby and a passion. Do a course in Mass Communication and equip yourself. Education is never wasted; you will learn the tips and tricks that will always come handy. Today, technology is a great boon to youngsters, and your podcast is testimony to it. However, should you want to work for a media conglomerate in the future, your education should be able to open doors. Also, keep working on commissioned projects and content creation on Instagram. It is a matter of time before you can monetise your podcast.

Focus on topics that are important from the point of judicial services exam. Cultivate a rational and reasonable world view and

Assam, Mizoram agree to ease border tension

Will approach SC for amicable solution, says Assam CM

The Chief Ministers of Assam and Mizoram have sought to ease tensions along their troubled inter-State border following a discussion with Union Home Minister Amit Shah.

An exchange of fire between the police forces of both States on July 26 left six Assam policemen and a civilian dead and 60 others, including Superintendent of Police of Cachar district Nimbalkar Vaibhav Chandrakant, injured. Assam claimed the firing was onesided and unprovoked, while Mizoram said they retaliated to the aggression by the Assam police.

Mizoram Chief Minister Zoramthanga on Sunday took to Twitter to say that he had a telephonic discussion with Mr. Shah and his Assam counterpart, Himanta Biswa Sarma. "We agreed to resolve the border issue amicably through meaningful dialogue," he tweeted.

He also asked the people of Mizoram to "avoid posting sensitive messages and Our main focus is on keeping the spirit of northeast alive. What happened along the Assam-Mizoram border is unacceptable to the people of both States.. Border disputes can only be resolved through discussion

Sindhu bags bronze, scripts history

Badminton ace becomes the first Indian woman to win two Olympics medals

P.V. Sindhu wrote her name into the history books with a bronze at the Tokyo Olympics on Sunday.

The badminton star became the first Indian woman to win two Olympics medals, with her latest effort being a follow-up to the silver at the previous Games in Rio de Janeiro in 2016. In the thirdplace play-off, the 26-yearold defeated He Bingjiao of China 21-13, 21-15.

It was a clash that the Hyderbadi pocketed with ease. Sindhu set the tempo, dictated the angles and toyed with her rival. And during those brief moments when she seemed over-eager, her coach Park Tae-Sang hinted to her that she should calm down.


Having lost to Tai Tzu-Ying of Chinese Taipei in the semifinal on Saturday, Sindhu was even more driven to seize the one medal at stake. And it showed as she crafted the contest's template, a trait that she maintained right through her Olympics' campaign except in the semifinals against a splendid Tzu-Ying.

Sindhu's Olympic encore, even if the medal shades are different, has ensured that she would be considered one of the greatest ever Indian sportspersons.

COVID spikes again

The number of COVID-19 cases in India is on the rise again. After about three months of a consistent decline, the seven-day average number of infections increased to nearly 40,500 from 38,000 in the previous week. Kerala and Maharashtra reported a sharp rise in the share of new cases. Kerala's share in total cases iumped to 38% in July

GST revenues hit ₹1.16 lakh crore in July

Rise in collections a sign of economic rebound: FinMin

SPECIAL CORRESPONDENT NEW DELHI

The gross Goods and Services Tax (GST) revenues in July recovered sharply ₹1,16,393 crore, after slipping below the ₹1 lakh crore mark for the first time in eight months in June.

The Union government called the collections a sign of a rapid economic recovery from the second wave of the COVID-19 pandemic, though economists said they indicated an "incomplete" rebound.

"With the easing out of COVID restrictions, GST collection for July 2021 has again crossed ₹1 lakh crore, which clearly indicates that the economy is recovering at a fast pace. The robust GST revenues are likely to continue in the coming months too," the Finance Ministry said in a statement on Sunday.

Trending upwards

GST revenue collected for July 2021 increased by 33% compared with the corresponding month in 2020 TOTAL COLLECTIONS (₹ CRORE) 1,50,000 1,00,000 50,000 2020 2021

The July numbers include returns filed between July 1 and 5, amounting to ₹4,937 crore, as taxpayers were given relief on delayed return filing for June in the wake of the second wave.

The July collections were 33% higher than a year ago, with the GST collected on the import of goods rising 36% and domestic transactions, including import of services, growing by 32%.

"There is a heartening sequential increase, as well as

a substantial year-on-year growth, but GST collections remain well below the alltime high recorded in April of ₹1.41 lakh crore. In our view, this is further evidence that the graduated unlocking in June 2021 has triggered an incomplete recovery that is expected to strengthen in July," said Aditi Nayar, chief economist at ICRA.

Significant variations While most States reported positive growth in tax collec-


tions compared with July 2020, there were significant variations - Odisha and Jharkhand reported a 54% uptick, followed by Haryana (53%) and Maharashtra (51%), while Tamil Nadu and Gujarat clocked 36% growth.

Kerala reported a 27% surge in GST revenues, despite having stricter COVID-19 restrictions in place than States such as Uttar Pradesh, West Bengal and Rajasthan, which recorded a growth of 18%, 15% respectively.

"The pace of growth across the States was highly uneven in July 2021, with some industrial heavyweights recording a sharp expansion," Ms. Nayar said.

The Ministry attributed June's blip in GST revenues at ₹92,849 crore, after posting above the ₹1 lakh crore mark for eight successive months, to the complete or partial lockdowns in most States and Union territories in May.

t is often remarked that history repeats itself.

In Gurugram, it repeats itself every monsoon in the form of waterlogged roads.

A heavy spell of rain around 160 mm in a span of less than 36 hours on July 18-19 left the city inundated.

Water gushed into houses and roads virtually turned into rivers. Underpasses on the national highway running through the city were also flooded, and a body was retrieved from one underpass.

All major roads and intersections in the city were waterlogged. Sheetla Mata Mandir Road, a perennial waterlogging point, was the worst affected.

Videos of devotees, including women and children, wading through waist-high water went viral on social media.

But despite the heavy rain for more than a day, the situation on Raghvendra Road, also known as Golf Course Road, was remarkably better than the previous year with none of the underpasses on the road being inundated and the rainwater getting drained just a few hours after the downpour.

In 2020, three underpasses on Raghvendra Road, a signalfree stretch through DLF area from Shankar Chowk to AIT Chowk, were inundated and had to be shut for traffic.

The longest underpass, near DLF Phase-I Rapid Metro station, was filled to the top.

Activists fume over 'mindless digging' to combat flooding

Ahead of monsoon, the Gurugram civic body decided to clean, widen and connect the four creeks along Golf Course Road. Environmentalists have panned the approach as 'unscientific'

Mr. Tushar said a huge quantity of waste, mostly construction and demolition waste, was cleared from the creeks, which were then also widened. The pipes from under the roads connecting them to the drain along the Chakkarpur-Wazirabad Bandh were also de-silted.

Several environmentalists, however, are fuming at what they call the "unscientific", "short-term" and "quick-fix" approach of the government agencies to solve ecological issues. The environmentalists pointed out that the water bodies dug up in the creeks had left several trees uprooted and roots of many other exposed and caused the soil around them to erode, causing more harm than good.

"It seems that no calculations were done for the dimensions of the pit before digging it. After rains are over, these huge pits can be great dumping areas for construction and demolition waste and other wastes," said Hemani Pundir Rawat, a volunteer for Clean Air, in a tweet about the pit dug in Creek-1 along Sunset Boulevard Road.

Unwanted construction

A few others have also objected to the construction of the "unwanted" cement chutes despite hume pipes along the road, and the "mindless" digging of the forest to create contour trenches and the setting up of avoidable check dams.

Saurav Bandhan, an environmentalist, said the government agencies must take "appropriate scientific measures" to collect and harvest the rainwater flowing down the creeks, ridges, natural drains of the Aravalis without displacing any trees and soil.

care, and appropriate soil erosion prevention measures. Depending on the average annual rainfall, contour bunds or graded bunds could be constructed of proper structural design and construction material. Boulders, stones and rubble should be used. No cemented structures should be permitted in the Aravalis. The rainwater runoff on the roads should be channelised into the natural drains, depressions, creeks etc. with the help of hume pipes fitted with trash screens," said Mr. Bandhan.

He added that loose sandy soil of the Aravalis, if compacted properly with vegetation to prevent erosion, could be used for constructing the bunds or barriers but only with proper understanding of the slope, flow rate, volume of rainwater, and other factors.

Hydro-geological experts, geologists, structural engineers, etc. must be consulted and such projects should be implemented under their supervision, he added.

"The Aravali mountain range is ecologically fragile. Destroying the Aravalis will destroy the ecosystem of Gurgaon," warned Mr. Bandhan.





Delhi zoo reopens after over 3 months

The Delhi zoo was reopened to the public on Sunday, three and a half months after it was temporarily shut due to a surge in COVID-19 cases during the second wave.

The facility had earlier remained closed for over a year due to the pandemic and bird flu and was reopened on April 1.

"Rain could not deter the spirit and enthusiasm of the people, especially the young ones. We are trying our best to make their visit worthwhile," Zoo Director Ramesh Pandey said.

The zoo will operate in two shifts - from 8 a.m. to noon, and 1 p.m. to 5 p.m.

Visitors are required to buy tickets online on the zoo's website or at the entry gates using QR codes. The administration has also introduced cycles for its staff in a bid to minimise noise pollution due to vehicles and reduce carbon footprint

According to Mr. Pandey, the zoo had recorded only 124 animal deaths, the lowest in the last three years, while it remained closed to the public in 2020-21. There are 94 species and 1,162 animals in the zoo at present.

egistrations to various undergraduate courses in Delhi University (DU) are set to begin from Monday. The online registration portal will be open till August 31 for aspirants to complete the application process.

According to DU officials, the university will permit candidates applying under the ECA (extra-curricular activities) and sports categories to upload certificates from the last four years instead of the usual three, as an exception due to the pandemic. Like last year, no trials will be held and admissions under these categories will be based on certificates submitted by the candidates.

Rajeev Gupta, Chairperson of DU Admissions, had earlier said: "All trial-based admissions including sports and ECA quota will be completely based on certificates this year. Students can upload certificates from last four years. This is a modification to what was done last year. For this year's admission process, candidates can pick the three best certificates from the last four years and upload."

Yet another year of admissions

Mr. Gupta said that this modification was brought in to ensure that students who had missed out on participating in events last year due to the pandemic can also apply by choosing their three best certificates.

Same procedure

According to the university, the entire admission process will be held online and aspirants are not required to visit colleges and departments for any purpose. The admission criteria have also remained unchanged for this year, according to officials.

"The admission committee has taken a conscious call to not change any eligibility criteria. Considering the unprecedented situation, the fee structure, registration and cancellation charges have also been kept the same. Colleges will also not be asking students to fill additional forms. However,

HC seeks CBSE stand on plea on assessment of private Class X students

Board's counsel sought 10 days' time

The Delhi High Court has granted time to the Central Board of Secondary Education to respond to a plea concerning the methodology of assessment of private Class X students after the examination was cancelled on account of the pandemic earlier this

Justice Prateek Jalan, hearing a petition moved by the mother of a private Class X student, passed the order after time was sought by the counsel for the Central Board of Secondary Education (CBSE).


"Rupesh Kumar, learned counsel for the Central Board of Secondary Education, seeks ten days' further time to take instructions on the methodology for assessment of private candidates for the Class X examinations," the judge recorded in the order dated July 29 as he listed the

matter for further hearing on August 23.

The notice to CBSE in the petition was issued in June when the court granted six weeks' time to the education body to clarify its stand.

In her petition, Payal Bahl has submitted that while students have been declared as "pass" after the announcement of cancellation of examinations, CBSE has not issued any notification regarding its policy on how marks are to be awarded to private students.

CBSE's attitude towards the students who are privately enrolled in Class X examination is "prima facie violative of the Article 14 of the Constitution of India" and takes away "their equal opportunity of proceeding with further education", she contended. It is highlighted that CBSE has already notified that assessment of regular Class X students was to be based on internal assessment.



Capital sees 85 more COVID-19 cases, 1 death

The Capital recorded 85 new COVID-19 cases and one death, according to a health bulletin released by the Delhi government on Sunday. The bulletin added that 72,447 tests have been conducted with a positivity rate

There are 582 active cases in the city out of which 172 are under home isolation. The total number of cases since the pandemic began has now gone to 14,36,350 along with 25,054 deaths.

On Saturday, the city had reported 58 COVID-19 cases with a positivity rate of 0.08% and one death due to the infection. Sharing details about the

vaccination drive, the bulle-

tin said that 83.049 people had been vaccinated in the past 24-hours out of which 20,179 got their first dose. The total number of people vaccinated has reached 1,00,32,817 out of which 26,65,152 have received both doses.

Vaccine stock

The vaccination bulletin showed that as of August 1 morning, 3,56,130 doses of Covaxin was available as 1,18,490 doses were added to the stock on July 31. For Covishield, 4.76.610 doses remain.

The government has 909 centres at 401 locations with a capacity to vaccinate 1,58,502 people in a day. The total number of days for which the stock remains is 5.

Ration distribution picks up pace after server glitches



Shops distributed 87.8% of their target for July since ONORC scheme implementation: govt. data

fter a bumpy start to the roll-out of the 'One Nation One Ration Card' scheme (ONORC) in Delhi, fair price shops (FPS) have distributed 87.8% of their target for July in the last 12 days, according to government da-

Owners of fair price shops said that initially there were glitches in the online system, which the e-PoS (electronic point of sale) machines use, leading to queues at shops, but the system is working better now

Distribution of ration started only from July 20, as the Delhi government decided to implement the ONORC scheme a day before it.

"Last week, the system was not working for a few hours for three days at a stretch leading to long queues of people waiting to get ra-



tion. However, for the past twothree days we have not faced any major problem," said Satvir Singh, 61, who runs a shop at Matia Ma-

Mr. Singh showed a WhatsApp group, "Circle 21 Matia Mahal', in which government officials were also present, and other FPS owners had also posted photos of their e-PoS machines, which could not retrieve data of people, after entering their ration card number.

Govt. lacks preparedness Anjali Bhardwaj of the Delhi Rozi

Roti Adhikar Abhiyaan said that the government should have learnt from its past mistakes and should have been prepared this time.

In 2018, the government had started distributing ration through e-PoS, but had to stop and go back to the manual system due to problems with the online process.

"With the pandemic, PDS [public distribution system] has become the lifeline for people. When there are disruptions in the distribution, many won't be able to feed their children," Ms. Bhardwaj said. She said that the government should have an alternative method to distributeration if the online system is not working or biometrics are not being detected by the machine.

'There is an uneven burden on the vulnerable people when it comes to the e-PoS system. People who do manual labour and old people are the ones, whose biometrics do not match with the system in most cases. And they are the most vulnerable too," she added.

Farmers growing grains and vegetables in their fields in western Rajasthan are now sorting and grading their processed agricultural products with machines. Taking advantage of subsidies, incentives and land conversion offered by government agencies during the pandemic, cultivators in the State are fast turning into entrepreneurs.

With the agro-industry setting its firm foot in nondescript rural areas, mainly in Jodhpur district, chains of warehouses, cold storage facilities and food processing units have been established on agricultural land in a big way. Despite the adverse circumstances of the COVID-19 pandemic, as many as 617 agro-projects are in the pipeline with an estimated investment of ₹1,255 crore.

Farmers have evinced a keen interest in setting up units for oilseeds, pulses, spices, cotton, milk and grain processing along with warehouses and cattle feed enterprises. While becoming financially self-sufficient, farmers are al-

so providing employment to the village youths.

Support for entrepreneurship in the farmer community came through the State government's agro-processing, agri-business and agri-export promotion policy adopted in 2019. The ambitious scheme gives subsidy on capital investment and interest to farmers and entrepreneurs for setting up agro-processing industries and developing infrastructure.

Mohan Ram Chaudhary, who established an agro-industry at Mathania village in Jodhpur's Osian tehsil, told The Hindu that the decreasafter value addition. Farmers were also getting fair prices for their produce through Shiv Ram Parihar of Balar-

wa village, who has set up a spice processing enterprise, said farmers could store their commodities with the creation of warehouses and get loans to meet their immediate needs without the compulsion to sell the produce immediately after harvesting.

50% grant for project

As part of the policy, farmers and their organisations are given a 50% grant, or a maximum of ₹1 crore, of the project cost, while other eligible entrepreneurs get the grant of 25%, or a maximum of ₹50 lakh. Over 700 Halam people return to Tripura

They had fled after clashes with Bru refugees

Repatriation of several hundred people who had taken shelter in Assam's Karimganj district following clashes with Bru refugees in north Tripura began on Sunday. The exodus occurred last week after local indigenous residents and Mizoram Bru refugees of a makeshift camp clashed over alleged encroachment of farmland. At least 700 people of Ha-

lam sub-tribes were displaced after rioters torched several houses at Damcherra area of north Tripura district. A number of people sustained injuries, but none was seriously hurt.

The displaced people crossed the Longai river to reach Karimganj of Assam. Karimganj district administration provided them shelter and distributed relief materials.

North Tripura district administration sent vehicles to Karimganj on Sunday to bring back the displaced pe-

District officials said they have arranged temporary stay of the returnees at a school building in Damcherra before they would return to their respective hamlets.

Administration issues tender for 370 structures on beaches, lagoons despite warning from experts

Ignoring what marine biologists have warned of as a serious "developmental misstep", the Lakshadweep administration is pressing ahead with plans to construct beach and lagoon villas on three islands of the Union Territory with its fragile coral ecosystem.

A tender notice inviting proposals from developers for building 370 villas using the design, build, finance, operate and transfer (DBFOT) model on publicprivate partnership (PPP) basis on Minicoy, Kadmat and Suheli islands was issued by District Collector S. Asker Ali, in his capacity as managing director of the Society for Promotion of Nature Tourism and Sports (SPORTS), on July 31. September 2 is the last date for submission of

Long overdue

OBC reservation in All-India Quota medical seats puts an end to a discriminatory policy

eservation for students from Backward Classes in seats surrendered by States to an 'All-India Quota' (AIQ) in medical colleges run by State governments was long overdue. The Centre's decision to extend its 27% reservation for 'other backward classes' to all seats under the AIQ is a belated, but welcome development, as Other Backward Class (OBC) candidates have been denied their due for years. And in concord with its keenness to balance OBC interests with those of the socially advanced sections, the Union government has also decided to provide 10% of the AIQ seats to those from the Economically Weaker Sections (EWS). This is almost entirely the outcome of a Madras High Court verdict and the efforts of the Dravida Munnetra Kazhagam, which approached the court with the demand. The AIO is a category created by the Supreme Court to free up some seats from residential or domicile requirements in some States for admissions to their medical colleges. Introduced in 1986, the AIQ comprised 15% of undergraduate medical and dental seats and 50% of post-graduate seats surrendered by the States for admission through a central pool. There was no reservation in the AIQ, and, once in the past, the Supreme Court set aside a Madras High Court order directing the Centre to implement Scheduled Castes/ Scheduled Tribes quota in the category.

In 2007, the Supreme Court allowed 15% Scheduled Caste reservation and a 7.5% Scheduled Tribe quota under the AIQ. Meanwhile, based on a central law favouring Backward Class reservation in educational institutions, the Union's 27% OBC quota was introduced in central educational institutions. There was no move to implement OBC reservation in the category. In the courts, the Medical Council of India argued against OBC reservation, but the Union government said it was not averse to the reservation, subject to an overall 50% limit. The omission of OBC reservation in the AIQ seats was obviously discriminatory. There were OBC seats in medical institutions run by the Centre, as well as Statespecific quotas in those run by the States. It was incongruous that seats given up by the States to help the Centre redistribute medical education opportunities across the country were kept out of the ambit of affirmative action. There was even a case to argue that, as AIQ seats originally belonged to the States, the quota policy applicable to the respective States ought to be applied to them. The Madras High Court, in July 2020, held that there was no legal impediment to OBC reservation, but, given that the policy varied from State to State, it left it to the Centre to decide the modalities for quotas from this academic year. The Centre has now decided on the 27% OBC quota, but not before the High Court termed the delay in doing so "contumacious".

Elusive gold

India is still searching for a gold medal as the Olympic Games enter the second week

India at the Olympics has always been about feverish hopes, bruising anguish and a few medals. Since its debut at the Games in 1900, the world's second most populous nation has ended up with either a single-digit tally or none at all. That familiar tale is being repeated a week after the Tokyo Olympics commenced and India is currently assured of three medals. One, a silver claimed by weight-lifter Mirabai Chanu in the 49kg category. And second, a minimum of a bronze guaranteed as boxer Lovlina Borgohain qualified for the semifinal in the welter-weight segment. The bout will be held on Wednesday. Badminton star P.V. Sindhu too joined the party, seizing her bronze after defeating China's He Bingjiao 21-13, 21-15 during Sunday's third-place playoff. Through their exploits Mirabai and Lovlina, hailing from Manipur and Assam, respectively, have revealed the rich sporting ability shimmering in the North-eastern States linked to the mainland through the chicken's neck above Bangladesh. Mirabai and Lovlina owe their triumphs to their innate strength and hard work besides the obvious support from family and the Sports Authority of India. With Sindhu, they have also reiterated women-power. Sindhu, who won the silver at the previous Olympics at Rio de Janeiro, had an exceptional run till she ran into Chinese Taipei's Tai Tzu-Ying in the semifinal and then made amends with a bronze.

India had a moment to savour when its women's hockey team entered the quarterfinals. While a strong Australian outfit awaits in the knockout on Monday, the women will add to India's evergreen hockey-hopes that gained a fillip after the men defeated Great Britain 3-1 during Sunday's quarterfinal. After the 1980 gold, the men's quest to win another Olympic medal has gained impetus and the road ahead is tough but interesting. In the limited chronicle of good tidings, Kamalpreet Kaur's excellent throw of 64 metres in the discus throw event was a spark. Kamalpreet qualified for Monday's final and a lot is resting on her shoulders. While these stirring events kept India afloat, there is also the litany of heart-breaks that included Mary Kom's loss in boxing, a fact the 38-year-old failed to initially admit following her adrenaline rush. The travails in shooting and archery did not add up to the original template of good form and resultant expectations. Shooters Saurabh Chaudhary and Manu Bhaker had their moments but they were not enough. The Games exert immense pressure as it is always about the athlete combining individual excellence with national pride. Tennis champion Novak Djokovic failed to even win a bronze while gymnast Simone Biles withdrew from events citing mental fatigue. It is never easy and the Indian contingent

would vouch for that going into the second week.

The draw of space and nuclear technologies

It remains to be seen whether the new ventures of Jeff Bezos and Bill Gates will strike a chord and benefit mankind

¬ ven as billionaire Jeff Bezos was preparing to blast off in-billionaire, Bill Gates, took an equally momentous decision to launch his own nuclear reactor with an eye on the possibility of exporting fast breeder reactors to power hungry nations (https:// reut.rs/3ylFSgW). Both of them characterised their initiatives as essentially aimed at the environment to reverse climate change. Answering criticism on his expensive and wasteful adventure, Bezos insisted that he had an environmental vision: "We need to take all heavy industry, all polluting industry and move it into space, and keep Earth as this beautiful gem of a planet that it is," he said. Mr. Gates stressed the importance of nuclear power as the clean energy required to meet the requirements of the world, even though the safety of nuclear reactors and the risk of proliferation of nuclear weapons are a growing concern.

The future of atomic energy

Back in 2007-08, the then Director General of the International Atomic Energy Agency (IAEA), Mohamed ElBaradei, had established a Committee of Eminent Persons to look at the future of nuclear power in 2020 and beyond. As an Executive Director of the Commission, I had helped to produce a report, which asserted that "the international community has both auspicious opportunities and significant challenges to tackle as the world moves into its seventh nuclear decade. Expanded use of nuclear technologies offered impotential to meet important development needs. In fact, to satisfy energy demands and to mitigate the threat of cli-

mate change - two of the 21st century's greatest challenges - there are major opportunities for expansion of nuclear energy". The report predicted that a "nuclear renaissance" will solve not only the world's energy problems, but also alleviate climate change.

Fukushima and after

But the expectation was shortlived because the Fukushima Daiichi accident in Japan on March 11, 2011 completely transformed the nuclear power situation beyond recognition and dealt a blow to plans for swiftly scaling up nuclear power to address not only climate change but also energy poverty and economic development. An IAEA article, "Nuclear power 10 years after Fukushima: the long road back", says, as the global community turned its attention to strengthening nuclear safety, several countries opted to phase out nuclear power. The nuclear industry was at a standstill except in Russia, China and India. Even in India, the expected installation of imported reactors did not materialise because of our liability law and the anti-nuclear protests in proposed locations. India had to go in for more indigenous reactors to increase the nuclear component of its energy mix. More than 50 nations, which were knocking at the door of the IAEA for nuclear energy for peaceful purposes, quietly withdrew their requests.

After intensive efforts to strengthen nuclear safety, as said in this article, and with global warming becoming ever more apparent, nuclear power is regaining a place in global debates as a climate-friendly energy option once again. Countries such as Japan and Germany reopened their reactors to produce energy. But even as organisations such as the Intergovernmental Panel on Climate Change (IPCC) and the International Energy Agency (IEA) recognise the ability of nuclear power to address major global challenges, it remains uncertain whether the value of this clean, reliable and sustainable

source of energy will achieve its

full potential any time soon. The Fukushima Daiichi accident, adds the article, continues to cast a shadow over the prospects of nuclear power. Furthermore, in some major markets, nuclear power lacks a favourable policy and financing framework that recognise its contributions to climate change mitigation and sustainable development. Without such a framework, nuclear power will struggle to deliver on its full potential, even as the world remains as dependent on fossil fuels as it was three decades ago.

The Gates plan

Even when the uncertainty continues and the anti-nuclear lobby is gaining momentum, TerraPower, the nuclear company founded by Mr. Gates, has just announced an agreement with private funders, including Warren Buffett, and the State of Wyoming, U.S. to site its Natrium fast reactor demonstration project there. Moreover, since it falls within the "advanced" small modular reactor project of the U.S. Department of Energy (DOE), the Department will subsidise the project of one of the richest men in the world to the extent of \$80 million this year.

As an article by the non-proliferation sentinels in the U.S, Henry Sokolski and Victor Gilinsky, titled "Bill Gates' Fast Nuclear Reactor: It Bomb?" (https:// bit.ly/3fjM1Tc) says, Mr. Gates believes that the fast breeder reactors will replace the current reactors. The DOE and other nuclear

enthusiasts also believe that small, factory-built, modular reactors will be cheaper and safer, and will be so attractive to foreign buyers that they will revive America's nuclear industry and enable the United States to compete in an international market now dominated by China and Russia. Another benefit envisaged is that fast breeder reactors will provide a solid nuclear industrial base for meeting U.S. military nuclear requirements. DOE has found bipartisan Congressional support for funding the project.

Mr. Sokolski and Mr. Gilinsky have challenged the move on several grounds such as the failure of earlier efforts to develop such reactors, and the risk of the turning of inert uranium to plutonium, and then using the plutonium as fuel. They have argued in their article that it can even "breed" excess plutonium to fuel new fast reactors. What concerns them most is that plutonium is a nuclear explosive which can be used for developing a bomb. They are afraid that the availability of plutonium through commercial channels would be fraught with

dangers. As their article says, TerraPower announced in March that Natrium would be fuelled with uranium enriched to 20% U-235 rather than explosive plutonium. But the question being asked is if Natrium reactor takes off and is offered for export, will the same restraint apply. Currently, only a handful of nations can make 20% enriched uranium. The critics believe that there will be a rush to make 20% enriched uranium world wide. The main objection to nuclear enrichment beyond a point in Iran arises from the fact that it would lead to weapon grade uranium being available for them.

The other objection being raised against the Gates project, as cited in the article, is that the principal reason for preferring fast reactors is to gain the ability to breed plutonium. That is surely what foreign customers will want. The way it is configured, the reactor would make and reuse massive quantities of material that could also be used as nuclear explosives in warheads.

Focus on India and China

India's fast breeder reactor, which is not subject to international inspections, is seen as capable of feeding the nuclear weapons capability of India. And the recent reports that China is building two more fast reactors have immediately provoked international concerns about China's possible weapons plutonium production. The opponents of TerraPower believe that India and China will be encouraged in their efforts to develop fast breeder reactors and may even want to buy them from Mr. Gates. They also think that the characterisation of TerraPower as small is a gimmick and they will have to be made big to make them economical. The claim that fast reactors are safer than light water reactors has also been called into

It has been pointed out that U.S. Presidents Gerald Ford and Jimmy Carter made it U.S. policy to discourage the commercialising of plutonium-fuelled reactors. President Ford had announced that the U.S. would not support reliance on plutonium fuel and associated reprocessing of spent fuel until "the world community can effectively overcome the associated risks of proliferation." bit.ly/3fii71N). The critics do not think that the world has reached such a stage.

No one can predict whether the space adventure of Mr. Bezos or the nuclear venture of Mr. Gates will benefit the U.S. and the wider world. But billionaires have the sixth sense to know how to multiply their own billions.

A cycle of low growth, higher inflation

Unless policy action ensures higher demand and growth, India will continue on the path of a K-shaped recovery

n recent times, right-leaning economists have been arguing that the Government does not need to do anything with the economy and that it will revive by itself. They call those who disagree with them, doomsday merchants. These economists reason that, like after the Great Depression, the economy rebounded worldwide. and so will it with us. The argument is fallacious on four accounts:

The first factor, demand. In the case of the Great Depression, demand was created by the Second World War effort. Especially in the United States, which was largely spared of the destruction, its industrial capabilities could be used as a supply base for the entire Allied effort. In the current scenario, there is no war to create demand. On top of it, the COVID-19 pandemic has resulted in demand destruction. This is because many jobs have been lost, and even where jobs were retained, there have been pay cuts. Both of these trends were confirmed in the Centre for Monitoring Indian Economy and other surveys. The only bright spot in this dismal scenario is that the western world has spent a lot of money stimulating the economy. From the point of view of the Indian exporter, rising freight costs and non-availability of containers is a significant impediment along with structural issues such as a strong rupee relative to major competitors. Only the Indian IT sector is placed well to capitalise on rising demand in the world

Next is inflation. India is suffering from stagnant growth to low growth in the last two quarters. At best, any growth in the current it comes on top of substantial negative growth in the first quarter of last year, perpetuating a statistical phenomenon known as the "low base effect". The base effect states that when measuring YoY, or yearover-year growth, we take the previous year's numbers as the base and measure the growth as a percentage. As in the low initial base set by last year, almost any growth this year is seen as a significant growth percentage. In comparison, the absolute growth figure is negligible. This scenario is eerily similar to the early 1970s in the United Kingdom and the United States, where low growth was combined with rising inflation.

Causes in India Inflation in India is being imported through a combination of high commodity prices and high asset price inflation caused by ultraloose monetary policy followed across the globe. Foreign portfolio investors have directed a portion of the liquidity towards our markets. Compared to a developed capital market such as that of the U.S., India has a relatively low market capitalisation. It, therefore, cannot absorb the enormous capital inflow without asset prices inflating. This might be seen as a welcome move, but it is to be noted that most of India's population do not own equity or bonds, which means that they cannot

cash in on asset inflation. The



due to access to financial assets. The middle and lower-middleclass get destitute due to regressive indirect taxes and high inflation, with their wealth eroding due to said inflation. Especially in the case of the lower middle class, inflation is lethal as they do not have access to any hard assets, including the most fundamental hard asset, gold.

Fuel prices

Additionally, supply chain bottlenecks have contributed to the inflation we see in India today. Essential goods have increased in cost due to scarce supply because of these bottlenecks caused by CO-VID-19 and its reactionary measures enforced. India's usurious taxation policy on fuel has made things worse. Rising fuel prices percolate into the economy by increasing costs for transport. Furthermore, the increase in fuel prices will also lead to a rise in wages demanded as the monthly expense of the general public increases. This leads to the dangerous cycle of inflation and depleting growth.

The Reserve Bank of India (RBI) has chosen to look the other way, claiming that this inflation is transitory in nature while inflationary expenses are entrenched. Inflation is here to stay because the RBI

is infusing massive liquidity into the system by following an expansionary monetary policy through the G-SAP, or Government Securities Acquisition Programme. This is designed to keep the interest rates of government bonds at 6.0% and thereabouts. An added threat of rising rates is the crowding out of the private sector, which corporates are threatening to do by deleveraging their balance sheets and not investing.

The third is interest rates. The only solution for any central banker once he realises that inflation is entrenched is tightening liquidity and further pushing the cost of money. If this does not dampen inflation, repo rates will need to go up later this year or early next year. Tightening the money supply is a painful act that will threaten to decimate what is left of our economy. Rising interest rates lead to a decrease in aggregate demand in a country, which affects the GDP. There is less spending by consumand investments corporates.

Finally, rising non performing assets, or NPAs. Rising interest rates, lack of liquidity, and offering credit to leveraged companies instead of direct subsidies to support small and medium-sized enterprises (SMEs) and micro, small and medium enterprises (MSMEs) to counter the COVID-19 pandemic and its effects will result in NPAs of public sector banks climbing faster. Our small and medium scale sector is facing a Minsky moment. The Minsky moment, coined by the economist Hyman Minsky. states that every credit cycle has three distinct stages. The first stage is that of cautious lending

and risk aversion by the bankers. The second stage is lending to trustworthy debtors who can pay the principal and its interest. The third stage is a state of euphoria caused by rising asset prices where bankers lend to debtors regardless of their ability to pay back

Minsky moment

The Minsky moment marks the decline of asset prices, causing mass panic and the inability of debtors to pay their interest and principal. India has reached its Minsky moment. This means that the public sector unit and several other banks will need capital in copious amounts to make up for bad debt. Several banks and financial institutions have collapsed in the last 18 months in India. The Union government's Budget is in no position to infuse large amounts of capital. At best, we can expect a piecemeal effort as in the past seven years. As a result of the above causes, credit growth is at a multiyear low of 5.6%. Banks do not want to risk any more loans on their books. This will further dampen demand for real estate and automobiles once the pent-up demand is over. The Indian economy is in a vicious cycle of low growth and higher inflation unless policy action ensures higher demand and growth. In the absence of policy interventions, India will continue on the path of a K-shaped recovery where large corporates with low debt will prosper at the cost of small and medium sectors. This means lower employment as most of the jobs are created by the lat-

Border tensions

Pegasus, a blemish on democracy

The hour has come to oppose excessive oppression through serious political action

Pegasus, the mythical winged horse from Greek mythology, is known to have allowed Bellerophon, the Corinthian hero, to ride him in order to defeat the monstrous Chimera before flying off to the heavens where he was turned by Zeus into an eponymous constellation. He has now returned to earth in the guise of a malware designed to fight terrorism, criminality and national insecurity. Though interpreted as an allegory of soul's immortality in modern times, Pegasus becomes a symbol of poetic inspiration, only to be turned into a reprehensible cyber weapon in the hands of dictators and bigots with the purpose of putting down dissent and killing critical thought. The constellation still glows in the heavens, but no longer evokes the age-old mythical sensations for humanity.

Where science has brought us

How science has aided in the inadvertent political game of demolishing basic human rights has finally fructified in the production of a technology that infiltrates human privacy right up to the bedrooms of its targets. When C.P. Snow walked into the Senate House at Cambridge in 1959 to deliver his Rede lecture, 'The Two Cultures', he sparked a global debate that would put a nail in the coffin of humanities, giving a boost to the study of science for the advancement of humanity. The two distinct cultures that emerged led to the confrontation between the technocrats and 'literary intellectuals'. While the former stood in favour of social reform and progress through technology and industry, the latter, who Snow disparagingly called "natural Luddites", had insignificant consideration for progress through industrialisation. We now know where science has finally brought us. The shadowing of our every move in a cyber-savvy world has resulted in escalating military and police repression. Mounting security concerns have been met with mounting technological responses. It is a world ridden with tensions between security and



freedom, secrecy and transparency. Democratic structures along with fundamental liberties stand eroded in the face of unrestrained free market economics that exists only to direct every facet of life. This is a system of the Panopticon, an architectural edifice where the warden in a central tower can monitor the prisoners in their cells without the prisoners seeing the warden.

The use of Pegasus, therefore, poses a stark danger to democracy and freedom, particularly in 10 governments believed to be the customers of NSO Group: Azerbaijan, Bahrain, Kazakhstan, Mexico, Morocco, Rwanda, Hungary, India and the UAE, all believed to have a dismal record in the protection of human rights. The obsession with power through surveillance has brought in its wake not just the blitzkrieg of information, but also given rise to political systems that aim at behaviour control, destroying the sanctity of the individual's privacy and thereby threatening democracies with serious consequences. We are caught in a world where the harsh reality of power and its exercise takes predominance over the constitutionally guaranteed right of self-determination and freedom of expression. The central motive, however, remains political domination through the control of any dissent or ideological

variance with the state. The security agencies of democracies and dictatorships are engaged in gathering the phone 'data' of citizens who show any signs of opposition, heaping it all away for any contingency that might arise in the future. Working against all norms of jurisprudence, the national security state remains 'legitimately' above board, blatantly pursuing acts of social control through surveillance on the basis

drown the world of freedom. This is at the heart of the contemporary debate on the use of Pegasus, a battle between the totalitarian state and dissidence. In such circumstances, living in confrontation with the state apparatus is tantamount to being labelled as "anti-national". There are many incarcerated without a trial for years. True to the concept of fascism, the interrogation of state policy becomes a betrayal in the Orwellian sense, where free thought and

debate are an anathema. The utopia promised by the government of Oceania in George Orwell's 1984 is an illustration of the logic of totalitarianism. Such an overorganised system represents the purging of history and free human thought for the smooth and peaceful running of the state apparatus. Criticism is not permitted by a management that has at its disposal highly developed surveillance technology, the 'thought police' that incarcerates or eliminates any 'thought criminal'.

As Hannah Arendt argues, the state ensures not just the transformation of the outside world but also the very dysfunctionality of the unpredictable nature of human creativity and its spontaneity. In Orwell's novel, O'Brien, an agent of the thought police, owing complete allegiance to the Party, explains to Winston, the central character, the unending process of persecution that can appease the ruling class so as to give it an assurance of its immortality. The state manipulates the rebirth of Winston, turning his rebellious old self into a faceless believer. Similarly, in his classic, Brave New World, Aldous Huxley envisages material progress all right, but with enormous dangers to human creativity. In such a world, no prodigies or rebels can be born. It is a world of the "hatchery" in which "hobbits" are "manufactured" at various stages of arrested physical and mental development whose strength lies only in falling into line.

The Pegasus upheaval finds a parallel in Orwell's 'Big Brother' symbolising the modern state and its authoritarian apparatus. Governments have lied about intelligence operations, illegally spied on millions of innocent people, and collected data from every conceivable electronic source to be potentially used to censor dissent, blackmail people or just intimidate those who struggle to make corporate and state power accountable. The post-Snowden years have seen new technologies like Pegasus enhancing surveillance to the point of exposing us to the danger of losing our very grip over our day-to-day private affairs.

Expansive interrogation

The ills of the modern state emerging from the culture of secrecy is therefore apparent. There would probably be a world of feasible peace and openness if there were no classified documents. One thing has become clear after the revelation of many governments illegitimately engaging in spying on their citizens: the hour has come to oppose all such excessive oppression through serious political action. Like Edward Snowden, we all live online and indeed, there really is no place to hide. However, the future is not foreclosed, and as long as there is critical inquiry, there is hope. As Howard Zinn, the historian, once said: "We are supposed to be thinking people. We are supposed to be able to question everything."

A more expansive interrogation of the treachery inherent in the return of the Pegasus affair and its fallout for rights activists, investigative journalists and writers calls for a serious probe. Or else, the gradual diminishing of our individual right to free speech and the dismantling of democratic institutions would culminate in the return of Orwell's Oceania.

What makes a reader keep reading

In long-form journalism, engaging writing matters



Among the multiple challenges a journalist has to confront is the quality of writing that sustains the readers' interest. Elegant writing is neither a legal requirement nor a regulatory prescription. It is an earnest invitation for an exchange of ideas without taxing the reader. One of the instructions Vinod Mehta gave me when I became an editor 20 years ago was to ensure that my journalism is not boring. "Boredom kills journalism," he asserted.

It is trite to say journalism is not fiction. Good, reliable journalism has to adhere to strict factual accuracy. The rules of attribution cannot be compromised. The act of verification is an integral element of journalism. In short reports, these three elements suffice. A talented desk will ensure that no meaning is lost and hence, no reader is lost. However, in long-form journalism, engaging

Concerns in narrative journalism

The year I became an editor was the year the Nieman Foundation at Harvard University established a programme on Narrative Journalism. Nieman Curator Bob Giles said, "Narrative journalism builds a newspaper's franchise for the long term. It plays to the strengths of print journalism - space and considered reporting – adding value that no other medium can duplicate." The programme underscored that the values of journalism and creative approaches to prose can easily coexist without the core tenets of good reporting being eroded.

Russel Frank, who worked as a journalist for decades before becoming a journalism teacher, flagged a major concern of editors towards certain aspects of long-form journalism. He wrote: "When reporters write sto $ries\,that\,read\,like\,good\,fiction\,they\,inevitably$ arouse suspicions. Reality is messy. Speech is messy. If a story is tidy – if the plot is too seamless or the quotes are too eloquent the reporter probably juiced it a little. Reconstructed scenes are particularly suspect. Instead of relying on tape recordings or notes of their own observations, reporters rely on the memories of the people who were there." Mr. Frank also pointed out that "the surge of interest in narrative journalism has coincided with a surge of scepticism among newspaper readers." Journalists add notes for their print version and give hyperlinks for the web version to ensure that the rules of attribution are not lost in writing a report.

Fog everywhere

Literature teaches us how to work with words in a manner that the reader doesn't get bored. Much has been written about the journalistic quality of Charles Dickens's writing. What we learned from him is the art of description, which is different from the act of deception. For instance, in Bleak House, he wrote: "Fog everywhere. Fog up the river, where it flows among green aits and meadows; fog down the river, where it rolls defiled among the tiers of shipping and the waterside pollutions of a great (and dirty) city. Fog on the Essex marshes, fog on the Kentish heights. Fog creeping into the cabooses of collier-brigs; fog lying out on the yards and hovering in the rigging of great ships; fog drooping on the gunwales of barges and small boats. Fog in the eyes and throats of ancient Greenwich pensioners, wheezing by the firesides of their wards; fog in the stem and bowl of the afternoon pipe of the wrathful skipper, down in his close cabin; fog cruelly pinching the toes and fingers of his shivering little 'prentice boy on deck."

This is a wonderful example of how fragments and extremely long sentences coexist to make reading a worthwhile experience. The fine editor, Harold Evans, in his book, Do I Make Myself Clear? Why Writing Well Matters, refers to Dickens to explain the new language of obfuscation that is creeping into our public sphere. He wrote: "Fog everywhere. Fog online and in print, fog exhaled in television studios where time is anyway too short for truth. Fog in the Wall Street executive suites. Fog in the regulating agencies that couldn't see the signals flashing danger in shadow banking." His antidote was: "But never come there fog too thick, never come there mud and mire too deep, never come there bureaucratic waffle so gross as to withstand the clean invigorating wind of a sound English sentence." This, indeed, shall be the governing creed of both the reporters and the desk as they put out their stories.

The benefits of breastfeeding

The promotion of breastfeeding should be a continuous process, not an event restricted to a week

UNICEF states that "breastfeeding is among the most effective ways to protect maternal and child health and promote healthy growth and optimal development in early childhood." Infants should be breastfed within one hour of birth, breastfed exclusively for the first six months of their lives, and be breastfed after six months in combination with solid, semi-solid and soft food until they are about two years old.

Many advantages

Breastfeeding provides greater immunity for children against infection, allergies, cancers and obesity; and improves brain maturation. It is also beneficial for the mother: it promotes faster weight loss after birth, reduces postpartum bleeding, and protects her against breast cancer, ovarian cancer, and osteoporosis. Data from The Lancet show that more investment in breastfeeding could add \$300 billion to the global economy and prevent about 8,20,000 child deaths every year.

The advantages of breast milk are evidence-based, yet globally only 25%-40% of babies are breastfed. Breastfeeding and later wet nursing were the norm for millions of years. During the Renaissance period, breastfeeding came to be seen as unfashionable. Feeding bottles and formula milk were aggressively advertised leading to a reduction in breastfeeding between the 17th and 19th century. However, during the late 19th century, an increase in infant mortality rate and rise in noncommunicable diseases during adulthood were attributed to bottle feeding. This prompted experts and leaders everywhere to push for breastfeeding across the world.

The World Alliance for Breastfeeding Action (WABA) was established in 1991 to create awareness about the importance of breastfeeding. In 1992, WABA in coordination with UNICEF introduced World Breastfeeding Week during the first week of August every year. India enacted the Infant Milk Substitutes, Feeding Bottles and Infant Foods Act in 1992 with stringent regulations. However, the National Family Health Survey-5 data

show that there has been a decline in early breastfeeding in as many as 12 of the 22 surveyed States and Union Territories while the share of institutional births has increased.

Maternity and paternity leave

The Dravida Munnetra Kazhagam (DMK) has promised in its manifesto that maternity leave in Tamil Nadu would be extended to 12 months. This is essential as women are entering the workforce in large numbers while society has shifted to a nuclear family system. Such a move will ensure uninterrupted breastfeeding. Nevertheless, counselling and educating the parents, establishing breast milk banks, providing lactating mothers with subsidised breast milk pump equipment, and setting up exclusive facilities to breastfeed will prove to be beneficial for mothers to provide exclusive breastmilk for children up to six months.


The inclusion of husbands in this conversation is incumbent. Both the mother and newborn are vulnerable for the first 12 weeks. Getting used to breastfeeding takes at least 14 days. Therefore, assistance from the partner is indispensable during this time. However, Indian law only allows for 15 days of paternity leave. It is imperative to extend this to 12-16 weeks.

India is a low-middle-income country with a meagre allocation of the GDP towards health. Communicable and non-communicable diseases hamper our economic growth. The theme for World Breastfeeding Week this year is 'Protect Breastfeeding: A Shared Responsibility'. With a change in social, cultural and environmental factors, breastfeeding is no longer mother-centric. Governments must allocate specific funds, rigorously implement the law, invest in educating parents and health workers and involve civil society organisations and the media in spreading awareness. Breastfeeding has decreased during the COVID-19 pandemic. Therefore, it is important that the promotion of breastfeeding should be a continuous process, not an event restricted to a week.

Electoral rolls being made fool-proof

New Delhi, Aug. 1: The Chief Election Commissioner, Mr. S.P. Sen Varma, said here yesterday that the bogus inclusion and wrongful exclusion of names would be eliminated altogether in the new electoral rolls to be finalised in October. He told newsmen that this was possible with the introduction of the electoral card system, unprecedented in the history of election anywhere in the world. He said that about 125 officers and employees of the Election Commission in 35 batches were checking and supervising the revision of electoral rolls in the Union Territory of Delhi. The two Deputy Election Commissioners and the three Secretaries were daily making random checks both in the rural and urban areas. The last date for completing the enumeration work originally fixed for July 31 had been extended to August 15. Supervision by the Election Commission staff had instilled great enthusiasm among the enumerators and the voters, especially in the rural areas. In a particular area which the Chief Election Commissioner did not want to disclose, there were 2,000 bogus names, and in another there was large-scale exclusion of names.

Satellite maps to be used to resolve row

Two top officials, however, told The Hindu that the government had no plans to hold a "neutral probe" into the July 26 firing incident.

little scope for discrepancy and there shall be better acceptability of the boundary solutions by the States," one of the officials said.

However, an Assam government official, who didn't want to come on record, contested such a claim. "Disputes arise mainly because there is a difference in perception regarding what constitutes our area and what constitutes their area. For example, Mizoram wants to follow the 1875 notification regarding Lushai Hills but it's not acceptable to us," the official

The Mizoram government claimed that a 509 square-mile stretch of the inner-line reserve forest notified in 1875 – under the Bengal Eastern Frontier Regulation of 1873 - belongs to it. The Assam government, on the other hand, maintained that the constitutional map and boundary drawn by Survey of India in 1933 was acceptable to it.

GST collections recover to ₹1.16 lakh cr. in July

"The improvement in GST collections both on domestic transactions and imports, accompanied by the fact that major producing States have shown significant increases, would indicate that the economic activities have resumed across the country," said M.S. Mani, senior director at Deloitte India

July's collections include central GST revenue of ₹22,197 crore, State GST of ₹28,541 crore and Integrated GST of ₹47,865 crore, of which nearly ₹28,000 crore

Compensation Cess collections, used to recompense States for adopting the GST regime, stood at ₹7,790 crore, including ₹815 crore collected on import of goods. "The government has settled ₹28,087 crore to CGST and ₹ 24,100 crore to SGST from IGST as regular settlement. The total revenue of Centre and the States after regular settlement in the month of July 2021 is ₹50,284 crore for CGST and ₹ 52,641 crore for the SGST," the Ministry said.

As monsoon recovers, Kharif sowing lag drops below 5%

Three-week break hits acreage under oilseeds, pulses and millets

With the monsoon picking up pace again and covering the whole country, sowing of Kharif crops is also showing signs of recovery. The lag in the sown crop area is now less than 5% in comparison with last year's, an improvement from almost 12% two weeks ago.

The biggest continuing lags are in Rajasthan, Madhya Pradesh and Maharashtra, where the three-week hiatus in the rains has resulted in lower sown area for rain-fed crops such as coarse cereals, oilseeds and pulses. This gains importance in view of the fact that rising prices of edible oils and pulses have been major contributors to recent inflation trends.

Uneven spread

Though the monsoon rainfall is now just 2% below normal, the overall figures hide both geographical and temporal unevenness. In the third week of June, the mon-

soon halted its progress across central India, resulting in a three-week delay in rain during a crucial sowing

According to the India Meteorological Department, Madhya Pradesh, parts of Maharashtra, interior Karnataka and Telangana received excess rainfall in the last week of July, bringing their cumulative rainfall for the season up to normal. Gujarat, however, remains in the deficient category, along with eastern Rajasthan. Overall, a third of the districts across the country have seen deficits so far.

According to Agriculture Ministry data, the total sown area across all crops as of July 30 was 848 lakh hectares, 4.7% lower than the 890 lakh hectares sown at the same time last year. A week ago, the lag was almost 9%. In mid July, the lag was 11.6%.

The main Kharif crop is paddy, which is seeing a 4% drop in acreage in comparison with last year's, mostly from eastern India where the sowing window is still open.

Millet area down

Coarse cereals and oilseeds are both showing a lag of about 5.6% with shortfalls in Rajasthan, Maharashtra, Madhya Pradesh and Andhra Pradesh. Ragi sowing is down by a third, with a 31% fall in crop area from last year's. The area sown with jowar is down by 11%, bajra 9% and small millets 81%.

Maize is the only cereal which is holding steady with no difference from last year's. Groundnut coverage is down by 10% and soybean

Among pulses, the area sown with moong dal is 10% lower than last year's, while urad lags 9%. Arhar dal sowing, on the other hand, is proceeding briskly, with a 4% gain in crop area so far.

India, China establish hotline in north Sikkim

Army says it will further spirit of trust

A hotline was established between the Indian Army at Kongra La in north Sikkim and the People's Liberation Army (PLA) at Khamba Dzong in the Tibet Autonomous Region to further the spirit of trust and cordial relations along the border, the Army said on Sunday.

"The inauguration was attended by ground commanders of the respective Armies and a message of friendship and harmony was exchanged through the hotline," the Army said in a statement. The event coincided with PLA Day on August 1, it stated.

Peace measure

Stating that the armed forces of the two countries had well-established mechanisms for communication at the ground commanders' level, the Army said these hotlines in various sectors went a long way in enhancing the same, and in maintaining peace and tranquillity on the borders.

India and China have two military hotlines in eastern Ladakh, among others at Chushul and Daulat Beg

The two sides held the 12th round of Corps Commander talks on Saturday at Moldo on the Chinese side. The details of the outcome are awaited.

As reported by The Hindu earlier, since the stand-off began in eastern Ladakh in May 2020, in addition to the Corps Commander-level talks, the two sides have also held ten Major Generallevel talks, 55 Brigadier-level talks, and 1,450 calls over the two hotlines.

In February, during a telephonic conversation, the Foreign Ministers of India and China agreed to establish a new hotline between the Foreign Ministries as a step to ensure "timely communication" against the backdrop of the Ladakh stand-off.

This will be in addition to the long-delayed hotline between the Indian Army's Director-General of Military Operations and China's Western Theatre Command, which is expected to be established soon.

Dhoot moves NCLAT to set aside Videocon order

Venugopal Dhoot, former promoter and chairman of the Videocon Group, has moved the National Company Law Appellate Tribunal (NCLAT) against the June 8, 2021 order of the National Company Law Tribunal (NCLT), Mumbai, approving the bid of Vedanta Group company Twinstar Technologies Ltd. to acquire the bankrupt Videocon Industries Ltd. for ₹2,962 crore.

Mr. Dhoot has petitioned NCLAT to set aside the 'Resolution Plan' approved by the NCLT and to direct the Committee of Creditors to consider the 'Resolution Plan' submitted by him under Section 12A of the Insolvency and Bankruptcy Code (IBC) that entails a "zero haircut" (involving no loss to the banks or creditors).

Adverse police report to cause hurdles in J&K

Move likely to affect hundreds as obtaining a passport or government job will become impossible

PEERZADA ASHIQ SRINAGAR

The J&K police move to deny security clearance to those "involved in crimes prejudicial to the security of the State, including stone-pelting" is likely to affect hundreds of families in Kashmir, where the official list of street protesters swelled significantly between 2008 and 2017 to nearly 20,000.

"All the field units of the CID SB-Kashmir are hereby directed to ensure that during verification related to passport service and any other verification related to government services, schemes, the subject's involvement in law and order, stone pelting cases and other crime prejudicial to the security of the State be specifically looked into and same must be corroborated from local police station records,"

the fresh order reads.

It called for collecting digital evidence such as CCTV footage, photographs, videos, audio clips and quadcopter images available in the records of the police, security forces and agencies as references. "Any subject found involved in any such cases must be denied the security clearances," it said.

Top sources said the list of

persons - including lawyers, journalists, politicians, civil society members – with "adverse background reports" had been growing longer in the past one year. Many mainstream leaders, even from the National Conference and the Peoples Democratic Party, were denied passport and travel documents.

Former Chief Minister and

Peoples Democratic Party (PDP) president Mehbooba Mufti was denied a passport in March after an "adverse" report by the CID. She approached the High Court but the judge observed that "the scope of this court in the matter of grant or otherwise of passport in favour of an individual is very limited".

Cycles of protests

The fresh order is likely to leave hundreds of local people ineligible for passport and jobs in the Valley, which saw major upheavals and prolonged cycles of street protests and civilian killings during the 2008 Amarnath land row, the 2009 Shopian "murder" case, the 2013 hanging of Parliament attack convict Afzal Guru, the 2016 Burhan Wani killing and the protests after the Centre's move to end J&K's special

status on August 5, 2019.

According to the official figures, 3,773 cases of law and order were registered in 2016 and 2017, and resulted in the arrest of 11,290 people. As many as 9,730 people faced charges between 2008 and 2017 for participating in the protests. The Omar Abdullah and the Mehbooba Mufti governments announced amnesty.

Official figures suggest that between 2016 and 2017, 2,330 people were arrested in Srinagar, 2,046 in Baramulla, 1,385 in Pulwama, 1,123 in Kupwara, 1,118 in Anantnag, 783 in Budgam, 714 in Ganderbal, 694 in Shopian, 548 in Bandipora, 547 in Kulgam and two in Doda districts during 2016 and 2017. Around 56 government employees were among the 4,949 found involved in stone-pelting incidents

Justice Lalit, who is the Executive Chairman, National Legal Services Authority (NALSA), made the statement during the release of posters containing information about the right to legal aid and availability of the free legal aid services. The posters will be installed at police stations across Haryana.

Such boards/posters are the first step in the direction to ensure that no accused remains unrepresented during investigation and trial, the judge said.

Exercise held to fine-tune integrated theatre commands

All scenarios, including a collusive threat of a two-front war from China and Pakistan, played out, says Defence official

As part of the process of evolving a consensus among the three services on the reorganisation of the forces inintegrated tri-service theatre commands and finetune the model, a table-top war-gaming exercise was held on July 22 for the first time, in which all scenarios, including a collusive threat of a two-front war from China and Pakistan, were wargamed, according to a Defence official.

"At the meeting held on July 22, for the first time ever, a table-top exercise was war-gamed with operational settings, which was played across all theatres simultaneously, multi-domain and cross theatre. This was large in extent from the Northern Command to the Andaman and Nicobar islands, and catered to the collusive threat we expect from two of our neighbours," the official

This was played for a full day and was attended by

around 40 officers, including the Chief of the Defence Staff (CDS), General Bipin Rawat, three Service Chiefs, Vice-Chiefs and Director-General of Military Operations equivalent from the three services.

'Frank exchange' There was a frank and free-

wheeling exchange to evolve the best process on theatrisation and many of the concerns put forward by various sides over the creation of the commands were addressed, including that of the Air Force, the official said.

Explaining the consultations, the official said when Defence Minister Rajnath Singh was briefed in June, he had advised two things – to form a consultative committee to address the concerns of the stakeholders outside the services and hold consultations to resolve service issues one more time.

The committee headed by the CDS, with the three Vice-Chiefs and representatives from other Ministries concerned, had met and resolved most of the issues related to the functions, rotational nature of all commanders, need for a unified maritime structure, including the Coast Guard, and having the paramilitary in border commands, the official said. Broad consensus emerged on the need to take forward the theatrisation process expeditiously and the Air Force, too, is on board, the official said. "Various views were heard and

would be taken on board. It

was made aware that sufficient time would be given for the structures to be formed. reviewed and stabilised."

"The creation of integrated theatre commands West, East, Maritime Theatre Command [MTC] and Integrated Air Defence Command are accordingly being progressed," officials said. As stated by Gen. Rawat earlier, the Northern Command would be left out of the ambit of the process for now and integrated at a later

States and their agencies share an "equal responsibility" to ensure that people are not booked under Section 66A of the Information Technology Act for expressing themselves freely on social media, the Centre has submitted in an affidavit to the Supreme Court... Section 66A was declared

unconstitutional by the Supreme Court in a judgment in 2015. On July 5 this year, an apex court Bench led by Justice Rohinton F. Nariman said it was "distressing," "shocking" and "terrible" that people are still booked and tried under Section 66A even six years after the apex court struck down the provision as unconstitutional and a violation of free speech.

The People's Union of Civil Liberties (PUCL), an NGO represented by senior advocate Sanjay Parikh and advocate Aparna Bhat, had drawn the court's attention to the violations.

Justice Nariman had authored the judgment trashing Section 66A in a petition filed by law student Shreya Singhal, who highlighted cases of young people being arrested and charged under the ambiguous provision for their social media posts.

In its response, the Centre said the police and public order were "State subjects" under Constitution.

"Prevention, detection, investigation and prosecution of crimes and capacitybuilding of the police are primarily the responsibility of the States," the Centre submitted in the affidavit.

It said law enforcement agencies share equal responsibility to comply with



the apex court judgment. They take action against cyber crime offenders as per the law.

The Centre said the Ministries of Information and Technology and Home Affairs had done their best to disseminate about the Supreme Court judgment in Shreya Singhal case. Section 66A had prescribed three years' imprisonment if a social media message caused noyance" or was found "grossly offensive".

The Supreme Court had concluded the provision to be vague and worded arbitrarily. Justice Nariman had agreed with Mr. Parikh on July 7 that the "state of affairs is shocking".

Mr. Parikh had urged the court to intervene and work out a mechanism to disseminate the Shreya Singhal judgment to every police station and trial court in the country.

"Section 66A of the IT Act has continued to be in use not only within police stations but also in cases before trial courts across India," the PUCL submitted.

The NGO has urged the apex court to direct the government to collect all the data/information regarding investigations under Section 66A and pending cases in district and High Courts.

The Central Information Commission (CIC) slammed the Union government's blanket denial of information related to a committee overseeing medical oxygen supplies during the pandemic, stating that its rationale was "far-fetched" and "unjustified". In its order on Saturday, Information Commissioner Vanaja Sarna directed the government to respond to the Right to Information (RTI) request within 10 days.

The RTI request, filed by activist and freelance journalist Saurav Das in April 2021, sought information on a nine-member Empowered Group set up a year earlier under the Chairmanship of the Secretary, Department for Promotion of Industry and Internal Trade. When the first wave of the pandemic began, it was responsible for coordinating the supply of PPE kits, RT-PCR test kits, N-95 masks and gloves. It subsequently became responsible for the

CIC flays govt.'s denial of Clinical trials of 'Ashwagandha' soon

The trials will be conducted on 2,000 participants in three U.K. cities, says govt.

The Ministry of Ayush has collaborated with the U.K.'s London School of Hygiene and Tropical Medicine (LSHTM) to conduct a study on 'Ashwagandha' for prorecovery from moting COVID-19.

A Ministry release said the All India Institute of Ayurveda (AIIA), an autonomous body under the Ministry of Ayush, and the LSHTM recently signed a Memorandum of Understanding (MoU) to conduct clinical trials of 'Ashwagandha' on 2,000 participants in three U.K. cities - Leicester, Birmingham and London (Southall and Wembley).

'Indian winter cherry'

'Ashwagandha' (Withania somnifera), commonly known as 'Indian winter cherry', is a traditional Indian herb that boosts energy, reduces stress and makes the immune system stronger. It is an easily accessible, over-the-counter nutritional supplement in the U.K. and has a proven safety profile. The positive effects of 'Ashwagandha' have been observed in long COVID-19,

which is a multi-system disease with no evidence of its effective treatment or management. It added that the successful completion of the trial could be a major breakthrough and could give scientific validity to India's traditional medicinal system.

"While there have been several studies on 'Ashwagandha' to understand its benefits in various ailments, this is the first time the Ministry of Ayush has collaborated with a foreign institution to investigate its efficacy on COVID-19 patients," the Ministry said.

According to AIIA director Tanuja Manoj Nesari, who is also a co-investigator in the project along with Rajgopalan, coordinator (international projects), the participants have been randomly selected. Sanjay Kinra of the LSHTM is the principal investigator of the study.

"For three months, one group of 1,000 participants will be administered 'Ashwagandha' [AG] tablets, while the second group of 1,000 participants will be assigned a placebo, which is indistinguishable from AG in looks and taste. Both patients and the doctors will be unaware of the group's treatment in a double-blind trial," Dr. Nesari said.

The participants would have to take the 500 mg tablets twice a day. A monthly follow-up of self-reported quality of life, impairment to activities of daily living, mental and physical health symptoms, supplement use and adverse events would be carried out.

It took over 100 meetings spanning about 16 months through both diplomatic as well as regulatory channels to sign the MoU, Dr. Nesari said. She added that the study had been approved by the Medicines and Healthcare Products Regulatory Agency (MHRA) and certified by the World Health Organizartion-Good Manufacturing Practices (WHO-GMP).

Reducing anxiety

Recently, a number of randomised placebo-controlled trials of AG in humans in India had demonstrated its efficacy in reducing anxiety and stress, improving muscle strength and reducing symptoms of fatigue in patients treated for chronic conditions.

"After the trial's success, 'Ashwagandha' will be a proven medicinal treatment to prevent infection and be recognised by the scientific community worldwide," the Ministry noted.

Goa misses deadline to give first jab

The July 31 deadline to complete administering the first COVID-19 vaccine dose to all eligible beneficiaries in Goa has been missed as only 87% of the target has been met, a senior official said on Sunday.

The July 31 deadline was set by Chief Minister Pramod Sawant with the aim of getting the State prepared to tackle a possible third wave of the infection.

"Now, 87% of the eligible population of Goa has been given the first dose of the COVID-19 vaccine. Currently, 23% of beneficiaries have got both doses," State Vaccination Officer Dr. Rajendra Borkar said.

Independent MLA Rohan Khaunte attacked the government for missing the deadline and said the Bharatiya Janata Party was more interested in "trampling democracy" than fighting the pandemic.

Goa on Sunday reported 59 fresh cases and one death, taking the tally to 1,71,205 and the toll to 3,148. With 105 patients being discharged, total recoveries rose to 1,67,046.

Give details of vacancies for disabled in CSE: HC

Submit this before Aug. 2, it tells govt.

NEW DELHI

The Delhi High Court has asked the Department of Personnel and Training (DoPT) to give the details of the total number of vacancies notified and reservations given in accordance with the Right of Persons with Disabilities Act for the Civil Services Exam (CSE),

A Bench of Chief Justice D.N. Patel and Justice Jyoti Singh gave the direction while hearing two petitions, which alleged that seats for the visually challenged and persons with multiple disabilities had not been reserved in accordance with the Rights of Persons with Disabilities (RPWD) Act of 2016. The High Court asked the DoPT to submit an additional affidavit before August 2, the next date of the hearing. "The DoPT will clearly highlight in the affidavit the total number of vacancies notified and the reservations given accordance with Section 34 (1) of the Right of Persons with Disabilities Act, 2016 as also the details of 251 vacancies for which it is stated that no reservations can be made," the court ordered.

The Union government's standing counsel submitted that the final vacancies notified for the CSE, 2020, were

836, out of which there could be no reservation for 251 vacancies. The counsel said as against the remaining 585 vacancies, 24 had been reserved and the reservation was in accordance with the mandate of Section 34(1) of the Act, that is, 4%.

The High Court was dealing with two petitions - one filed by the Evara Foundation and other by NGO Sambhavanam. It had earlier sought responses of the government, the Union Public Service Commission (UPSC) and the DoPT on the petitions seeking quashing of the notice announcing the civil services preliminary and an interim stay on the declaration of the results on the ground that an inadequate number of seats had been reserved for persons with visual and multiple disabilities.

The Evara Foundation contended that due to an inadequate number of vacancies for the visually challenged and those with multiple disabilities, fewer candidates belonging to these two categories would qualify for the main examination.

NGO Sambhavana said the UPSC had reserved only 24 vacancies for persons with disabilities out of a total 796 "expected approximate vacancies".

Punjab paddy farmers taking to new technique

'DSR technique saves groundwater, is cheaper and yield and quality are good'

Punjab Agricultural University's (PAU) upgraded technology for the direct seeding of rice (DSR), the 'tar wattar' (good soil moisture) DSR, seems to have caught the fancy of paddy farmers in the State.

A rise in the area planted under the novel DSR technique indicate that farmers are moving away from the traditional practice of puddle transplanting.

Improved version The Ludhiana-based Univer-

sity introduced the DSR technique in 2020, an improved version of earlier DSR (dry) technique.

In the new technique, presowing irrigation is applied in a levelled field and the primed seed immediately.

"Last year, the COVID-19 outbreak and the subse-

quent lockdown had led to an exodus of labour. There was concern among farmers on the timely completion of planting due to a shortage of labour. However, availability of the DSR technology came to their rescue. Rice was di-

rectly seeded on about onefifth of the area in the State. The successful adoption of the technology has even found an echo in Harvana. In 2020, rice was sown through DSR in about five lakh hectares in Punjab, against just 23,450 hectares in 2019," Makhan Singh Bhullar, principal agronomist at PAU, told The Hindu. "This year, rice cultivation

area under DSR has touched about five lakh hectares. We are hopeful that this may increase after the final data is compiled," he said.

Mr. Bhullar said yield levels after a large-scale adoption of the DSR technique in 2020 had convinced farmers about its viability.

"The DSR method saves a lot of groundwater because the crop does not need frequent irrigation as in the case of a puddled paddy field. The method is also pocket-friendly as manual transplanting is getting costlier with each passing season. This method also addresses the shortage of farm labour," Amreet Inder Dhillon from Mehtabgarh in Ludtechnique, said.

Mantra to protect children

Kamsa sends Putana to kill the baby Krishna, growing up in Gokula. Srimad Bhagavatam says she went as a lovely lady. Why did Putana have to adorn herself and look good? It was the norm in the past for a mother to dress up well and look pleasant, when she picked up her child to feed it, so that the child looking at her would be happy. Nampillai says this practice was observed widely. The importance of breastfeeding is stressed thus, elaborated V.S. Karunakarachariar in a mantra. Also, the first time a mother feeds her child, the father has to utter a mantra. Apsatambha sutra says that soon after the child is born, the mother must feed it from her right breast, while the father recites the mantra. The mantra goes thus: "Let no demons hurt your child. Let there be no danger to this child from ghosts. Let milk yielding cows not hurt this child. Let this child have a lot of affection for you. This child will drink up your old age. This child should get strength through your milk." So, the mantra says that neither harmful beings like demons, nor harmless ones like cows should hurt the child in any way. The phrase used in the mantra for the child is "dhanasya priyaa," meaning the dear child is the mother's wealth. Thus breastfeeding was given great importance, with a ritual and a mantra dedicated to it. When Putana puts Krishna to her breast, he sucks not only her milk, but her life as well.

Later, Krishna recalling the incident, praises Vasudeva's adherence to prescribed practices as having protected Him. He is referring here to the fact that when He was born, Devaki breastfed Him, and that Vasudeva recited the mantra for His protection at that time. The Lord showed the world the importance of this ritual and how the mantra serves to protect the baby.

Afghan forces digging in to defend cities

At least two rockets hit Kandahar airport, disrupting flights; residents flee amid airstrikes, street battles

Afghan forces fought fierce street battles and bombed Taliban positions on Sunday while insurgents swarmed major cities as they stepped nationwide their offensive.

Hundreds of commandos were deployed to the western city of Herat while authorities in the southern city of Lashkar Gah called for more troops to rein in the assaults even as Afghan air strikes left scores dead on the streets, residents said.

Fighting has surged across Afghanistan since early May when U.S.-led foreign forces began a final withdrawal that is now almost complete.

After seizing large tracts of rural territory and capturing key border crossings, the Taliban have started assaulting provincial capitals.

Myanmar junta ruler takes PM role

He pledges to hold elections by 2023

Myanmar's military ruler Min Aung Hlaing has taken on the role of Prime Minister in a newly formed caretaker government, state media reported on Sunday, six months after the Army seized power from a civilian government

In a speech on Sunday, Gen. Min Aung Hlaing repeated a pledge to hold elections by 2023 and said his administration was ready to work with a future regional envoy on Myanmar.

The announcement and speech came exactly six months after the Army seized power on February 1 from a civilian government following elections that were won by Aung San Suu Kyi's ruling party but that the military said had been fraudulent.

Gen. Min Aung Hlaing has chaired the State Administration Council (SAC) that was formed just after the coup and that has run Myanmar since then, and the caretaker government will replace it.

"In order to perform the country's duties fast, easily and effectively, the state administration council has been re-formed as caretaker government of Myanmar," a newsreader on state Myawaddy television said.

In his speech, Gen. Min Aung Hlaing repeated a pledge to restore democracy, saying, "We will accomplish the provisions of the state of emergency by August 2023"

He added: "I guarantee the establishment of a union based on democracy and federalism." Shortly after the coup,

junta leaders promised new elections within two years. The reference on Sunday to

August 2023 was interpreted by some local media as extending that time frame by six months.

Gen. Min Aung Hlaing also said his administration would work with any special envoy named by the Association of Southeast Asian Nations (ASEAN).

ASEAN meet

ASEAN Foreign Ministers are to meet on Monday, when diplomats say they aim to finalise a special envoy tasked with ending violence and promoting dialogue between the junta and its opponents.

The military authorities have faced months of protests, strikes that have paralysed public and private sectors, and a resurgence of armed conflicts in the borderlands.

The authorities have branded their opponents as terrorists. "At present, the whole country is stable except for some terrorist attacks," Mr. Min Aung Hlaing

The Assistance Association for Political Prisoners activist group has accused the armed forces of killing 939 people since the coup and said at least 6,990 military opponents have been arrested.

The military said the number of protesters killed is far lower.

Kim's sister warns against S.Korea-U.S. military drill

'Move could affect recent thaw in ties'

Dawn newspaper reported that under the proposed law by the Ministry of Law and Justice, the Supreme Appellate Court (SAC) of Gilgit-Baltistan may be abolished and the region's election commission is likely to be merged with the Election Commission of Pakistan

Sources in the Law Ministry told the newspaper that the draft of the Bill titled '26th Constitutional Amendment Bill' had been prepared and submitted to Prime Minister Imran Khan. According to the sources,

the draft Bill has been prepared after careful reading of the Constitution of Pakistan, international laws, the UN resolutions especially those related to a plebiscite on Kashmir, comparative constitutional laws and local legislation.

The stakeholders, including the governments of Gilgit-Baltistan and Pakistanoccupied Kashmir, had been consulted on the proposed constitutional amendment, the report quoted sources.

Q. I am a 21-year-old medical student. I have started a recurring deposit (RD) with the ₹1,000 that I save every month. Now, I want to start investing. What options would you suggest? Am I eligible to invest in stocks and mutual funds (MFs)? Since investment gains are subject to taxation, what rules will I be subjected to if I start investing at this age?

A. As you are 21 and a major, you can certainly invest in any instrument of your choice, including shares and mutual funds, irrespective of whether you are employed or not. You will, of course, need to meet the KYC requirement specified for each type of investment. Usually, if you have a PAN card and an Aadhaar for proof of address, this should suffice for most investments, along with the account opening form.

Apart from bank RDs, you can consider small savings schemes operated by India Post. These are absolutely safe investments backed by the Government of India. India Post offers 1-, 2-, 3- and 5-year fixed deposits, a recurring deposit account, a 5-year monthly income account, a 5-year National Savings Certificate where your interest compounds until maturity, a 15-year Public Provident Fund and many other options that offer a guaranteed return.

There are also deposit products from Non-Banking Financial Companies such as HDFC and Sundaram Finance that offer fixed returns if you lock in for 1,2,3 or 5 years. The interest you earn on both post office schemes and NBFC deposits are treated as your income and taxed at the income tax slab rate applicable to you each year.

MFs are riskier investment vehicles that deliver returns based on movements in market prices of the assets they invest in. You can invest either through monthly instalments (called Systematic Investment Plans or SIPs) or through one-time investments. There are different types of MFs carrying differing risk profiles, from those that invest in large-, mid- and small-cap stocks to those that invest in safer options such as bonds. The key advantage of open-end MFs is that they offer anytime liquidity as you can sell your units to the MF whenever you need to exit. The dividends received from MFs are taxed in your hands at your I-T slab rate. The capital gains are taxed as short-term or long-term capital gains, based on how long you hold the fund.

When you buy shares, you get to own a share of the business which entitles you to dividends from the company and share price appreciation, if any, when you sell the shares. Dividends are taxable in your hands as income and capital appreciation as short term or long-term capital gains (after one year of holding)

As you have no income from an occupation, you will need to add up all your incomes from stipend, dividends from MFs and shares, interest from deposits and short-term capital gains from any sale of MFs and shares to arrive at your gross taxable income. If your taxable income is up to ₹2.5 lakh in a year, you are not liable to pay any I-T. For income beyond ₹2.5 lakh up to ₹5 lakh, you pay tax at 5%. For income beyond ₹5 lakh and up to ₹10 lakh, you pay tax at a 20% rate. To save tax, you can also invest in instruments under section 80C of the I-T, which allow you to claim up to ₹1.5 lakh in annual deduction from your gross taxable income. Certain post office schemes and ELSS MFs are eligible for this deduction. In effect, up to ₹4 lakh of your income can be exempt from I-T in a year provided you are able to use 80C effectively.

However, tax savings should not be your only objective while choosing investments. Before choosing them, you need to be clear on three things - the financial goals towards which you are investing, the time horizons you have to achieve them and your risk appetite which is your ability to take losses or volatility in your returns. For holding periods of 7 years or less, you must consider deposit products, post office schemes and debt MFs. You should venture into shares or equity MFs only if you have a 7-year-plus horizon. Finally, tax can be levied on your MF or stock market investments once you become a taxpayer, as and when you sell units or shares and make capital gains.

Q. I am a senior citizen (81). I redeemed MFs in January this year. The total capital gain received was ₹13.30 lakh. My annual income is ₹17 lakh, from other sources. Can I get tax exemption for capital gains u/s 54 EC?

A.P. CHARI

N. Sree Kanth answers: With effect from April 1, 2019, capital gains arising from sale of land, building or both only are eligible for exemption under Section 54EC of the I-T Act, 1961. The capital gains in your case are arising from the redemption of MFs due to which they are not eligible for exemption under Section 54EC of the I-T Act. Depending on the nature of the MF redeemed, the tax treatment will vary and accordingly, will have to be included in your total income.

Q. Please clarify whether total income (taxable income) or gross total income is to be taken into consideration for filing I-T. returns. Also, is TDS applicable to each branch for bank deposit interest?

A.R.K. SUNDARAM

A. For filing returns for individuals under Sec. 139 of the I-T Act, total taxable income will be considered to determine it exceeds the maximum amount not chargeable to I-T.

Under Section 194A of the Act, the words 'a banking company' is used, due to which the limits for non-deduction applies to each banking company and not branch wise.

Let your life cover strategy age well

A term insurance plan needs to be reviewed and added to at different stages in life

We all will agree with the premise that our financial goals and needs keep changing at different phases of our lives. To stay financially secure during all these phases, it is important to have a term life insurance plan. Term insurance that provides a huge life cover at a very small premium (For example ₹1 crore life cover for next 30 years at ₹500 per month) is a critical tool that provides a safety net to ensure the financial stability of the family. To keep pace with changing financial needs, it is also important to keep reviewing insurance plans

Term insurance is never a one-time decision and it is important to review the coverage as you age. This is important to make sure that the future needs of the dependents are met adequately. Here is a quick look at the stages of your life when you should review term-insurance cover.

Young and single

Your career has probably just begun. While you may feel that you do not have any dependents unless your parents have already retired or you have a sibling who is dependent on you, this is the right time to start insurance planning from multiple perspectives. A very simple and fundamental aspect that many do not realise is that you can get insured easily when the per-

ceived risk is low but the aspect is ignored by most. Also, when the risk is higher, everyone tends to run towards insurance but it gets tougher to get co-

At a young and healthy age, you can get a term insurance very easily with very few checks. Even the premium will be very low. As you grow older, there is an inherent risk of health-related issues and any external accidents that may make it tough to get cover at a later stage at a good price. Take advantage of the younger age and health condition and purchase a plan that can cover yourself and an education loan, if any. In addition, while your parents may not be dependent on you at this stage, you would have, for sure, wanted them to live their retired life without a tight financial budget or live in a much better financial position than your income would have ensured. A term insurance policy that you take at such an age

can take care of this aspect in case of any unforeseen event.

Marriage, children

When you turn about 30, chances are quite high that you are married and have very young children. Salaried professionals would have reached mid-managerial level and selfemployed individuals would be enjoying a stable income inflow. On the personal front, you may also have retired and dependent parents. At this point, you would be surrounded by multiple liabilities and it is important to have adequate cover-

age to pay for all such liabilities. It is important to have a significant cover to pay for all possible expenses of your family. Get your coverage enhanced to ₹1 crore for overall protection and coverage up to your retirement age or your earning capacity.

Late 40s, early 50s When an individual reaches

late forties and early fifties, he or she is likely in a senior managerial role while business owners are potentially looking to expand their businesses. At such an age, the income of an individual increases significantly and there is a proportionate rise in expenses as well. This is mostly because the children are grown up and are at the stage of incurring major, one-time expenses such as their weddings or considering higher education. In addition, it might be possible that you take a loan for such expenses or buy a home for your family. All these expenses make it essential that you enhance the sum assured of your term cover so that all expenses are met comfortably even in your absence. At this stage of life, the average person is best advised to get term cover worth at least ₹1.5 crore.

The right cover

Ideally, when buying a term insurance plan, it is always advisable to buy a policy with a coverage amount/sum assured up to 12 - 15 times of your annual income. Apart from this, there are other factors that must be given due consideration when deciding on the coverage amount. Forgetting to factor in loan outstanding is common as the EMI is automatically debited monthly but the outstanding loan may still be significant. Retirement planning for the spouse, medical emergencies and everyday expenses all need to be thought through. It is important to know all your liabilities while planning to buy a term insurance plan.

The need for term-insurance coverage usually peaks when you are in the middle of your career and have liabilities to pay. It is therefore advised to buy a plan as early as possible so that you can lock in the highest coverage possible at minimum prices. Waiting to buy term insurance till liabilities add up on your shoulders may sometimes prove costly.

THINK INVESTOR: GOVT. BONDS

Do you want to bond with the best?

An investor must mull finer points before choosing government bonds over bank FDs

The RBI recently released the features of Retail Direct Gilt Account as part of its (and the government's) initiative to encourage retail participation in government bonds.

The question is: should you invest in government bonds? In this article, we discuss the benefits and the issues associated with such investments. For the purpose of our discussion, we will assume that you are investing to achieve a life goal. We alyour preferred choice for bond investment is bank deposits.

Interest-rate risk

You are exposed to interest-rate risk when you invest in bond mutual funds or any bond investment that generates capital appreciation. The risk is that bond prices typically decline when interest rate rises (or in anticipation of rates going up). You are not exposed to this risk if you invest in bank deposits because you earn only interest

Now, direct investment in government bonds also protects you from interest rate risk. How? True, government bonds trade in the market and offer opportunities for capital appreciation. But you can choose to earn only interest income by keeping these bonds till maturity and receive the par value from the government. It

is possible that you may have to pay a premium to buy these bonds. The point, however, is that you need not bother about prices going down during the life of the bonds. And, of course, government bonds do not have credit risk. So, you can be confident of getting back the par value at maturity.

The upshot? Government bonds offer stable income, just as bank deposits do, and typically without credit risk. But before you do decide to invest, consider an important risk associated with such investments.

Reinvestment risk

Suppose you want to accumulate ₹15 lakh in 10 years. Assuming you have ₹10 lakh today, you must invest in a product earning 4% per annum to accumulate ₹15 lakh in 10 years. Suppose, you invest in a 10-

year government bond offering 4% post-tax interest income. It seems that you are all set to achieve your goal. But unwittingly, you have exposed yourself to reinvestment risk. To accumulate ₹15 lakh in 10

years, you need to earn 4% on a compounded annual basis. So. the interest income you earn every year must be reinvested at 4% till the tenth year. The issue is that RBI could lower the interest rate in any of the intermediate years. And, that would mean you cannot reinvest at 4%. Referred to as reinvestment risk, this risk, if not managed well, can set you on a path to failure to meet a life goal,

Suffice it to understand that the more frequent the interest payments, the greater the rein-

vestment risk. Now, government bonds pay every halfyear. So, this risk could be greater with government bonds than comparable bonds paying interest rate annually.

Conclusion

You should directly invest in government bonds if you are excited about the newer investment avenue. But, you should consider the following points if your objective is to invest in government bonds for achieving a life goal:

government bonds (if held till maturity) and bank deposits do not carry interest rate risk

Second, government bonds expose you to reinvestment risk. Bank deposits do not, if vou invest in cumulative fixed deposits (for lump sum money) and recurring deposits (for savings from monthly income).

Third, you can invest anytime in deposits and match the maturity of your deposits with the time horizon for your life goal. With government bonds, vour primary investment is dependent on when RBI holds auctions, and the bond maturity offered in each auction.

Finally, bank deposits expose you to small credit risk whereas government bonds are typically credit-risk free. (The author offers training

TECH TRAIL: PRECIOUS METALS

Gold gleams, silver struggles

Precious metals remained broadly range bound in July. After a distinctly weak performance in June, Comex gold managed to close in the green.

The U.S. Federal Reserve's dovish stance on interest rates and the soft trend in the U.S. dollar helped gold prices recover in July. Comex gold gained 2.6% to close at \$1,817.2 an ounce. But Comex silver lost 2.5% to \$25.45 an ounce.

Mirroring the global trend, MCX gold futures gained 1.9% to close at ₹48,001 per 10 gm. MCX silver futures closed 1.8% lower at ₹67,847 per kg

The short-term outlook for Comex gold is positive. The price may rise to the immediate target range of \$1,870-1,880. A move past \$1,837 would confirm the positive outlook. This outlook would be under threat if the price closes below the immediate support at \$1,740-1,750. Until this is breached, there would be a case for a move to \$1,880 and higher. A drop below \$1,740 may impart weakness and the price could then slide to \$1,650-1,660.

The price of Comex silver has been confined to a range and the near-term outlook depends on the direction of the breakout from this range. A move above \$26.8 would be a sign of strength and may propel silver price to the next target of \$27.5-28. However, a fall below \$24 would be a sign of weakness and it could then slip to the downside target of \$22-22.5.



Though MCX gold closed on a positive note in July, the price is still confined to a range. The short-term outlook hinges on the direction of the breakout from this range. A move above ₹49,000 would be a sign of strength and it could then rise to the major target at ₹51,250-51,300. A close below ₹47,300 would be a sign of weakness and could push the price to ₹43,500-44,000.

The near-term outlook for MCX silver is negative. It could slide to the immediate target range of ₹63,000-63,500. This view would be invalidated if the price moves above ₹70,00-70,500. A close below ₹65,900 would strengthen the case for a slide to ₹63,500 and lower.

To summarise, the shortterm outlook for precious metals is unclear. A breakout from the levels mentioned would influence the direction of the short-term move.

Sindhu stamps her class, adds another feather to her cap

The shuttler becomes the first Indian woman to secure back-to-back medals at the Olympics

P.V. Sindhu fixed her hair, shuffled her feet thrice, leaned forward and muttered "come on." She took a deep breath before letting the shuttle sail over the net. The point ended with a thunderous cross-court smash, and she let out a scream. She had scaled the mountain of expectations, beating China's He Bingjiao 21-13, 21-15 to secure an Olympic bronze medal.

She is now the first Indian woman to have back-to-back medals at the Olympics.

Emotional conflict

Sindhu, however, had walked into the court with a myriad of thoughts. "I had emotional conflict, whether to be sad that I had lost a chance to make it to the final or find happiness that I had another shot at winning a medal," she said.

none of those thoughts mattered once the contest began on centre court at the Musashino Forest Plaza.

Bingjiao, much like Tai Tzu-ying on Friday, tried to restrict play close to the net but Sindhu countered. The Chinese kept the shuttle low but whenever she offered Sindhu even an inch of flight, she was greeted by a pointkilling smash.

The Indian led 11-8 and a streak of Bingjiao unforced errors saw her cruise ahead. There came a time when the Chinese shuttler looked exasperated - she had done re-

markably well to cover the court and return a Sindhu smash but the 26-year-old from Hyderabad smashed the return to the other end of the court. She pocketed the first game 21-13.

Longer rallies

Bingjiao tried to engage Sindhu in longer rallies in the second game in a bid to control the tempo of the game, but the Indian was prepared. She finished points early and derived great success from her ferocious forehand cross-court smashes.

The duo was tied 11-11, before Sindhu switched gears to take off. She toyed with Bingjiao to surge ahead 19-15. A minute later, she embraced her coach Park Tesang, with another Olympic medal in her bag.

"I'm super happy to be the first Indian woman athlete to win back-to-back medals," she said, noting that this medal was a lot more difficult to achieve compared to the silver in Rio 2016, where she had little expectations or pressure. "It hasn't sunk in yet! I just want to be in the moment and I'm going to enjoy this," said the reigning World champion, who made it a memorable Sunday for

Now she feels that Indians can use her achievement as a springboard for more bad-

"I'm sure a lot of youngsters and others will get motivated to work hard and come up," she said. "I'm sure we can do this. If I can do it, anybody can do it."

Sindhu was aiming to become only the second Indian to win an individual Olympic gold, but had lost to Chinese Taipei's Tai Tzu-ying in the semifinals.

She said she was "sad" at not being able to go one better than at Rio. However, Sindhu was able to put the disappointment behind her.

"I had to close out all my emotions for this one match and give it my all," she said. "I'm very happy and I think I've done really well. Getting a medal for the country is definitely a proud moment for me and the people out

Sindhu followed up her 2016 Olympics silver by winning the World title in 2019.

Gunning for Paris

She said she would "definitely" look to challenge for Ólympic gold again at the 2024 Paris Games, and backed herself to continue improving.

"Every time I win, it's a stepping stone," said the 26year-old. "It builds my motivation. I can do much better and I can work harder.

"I think that's my passion towards the sport - once you achieve something, you want to achieve more and

It was certainly a dramatic day and a wonderful Italian night, for the men's high







Caeleb Dressel won two more titles on Sunday to end his Tokyo campaign with five golds, as Australia's Emma McKeon became the first woman swimmer to win seven medals at a single Olympics.

Fantastic efforts

Dressel earned the title of world's fastest swimmer with a lightning 21.07 seconds in the 50m freestyle before helping the US men shatter their own world record in the 4x100m medley

McKeon was just as im-

pressive, blasting through the 50m in 23.81s then spearheading Australia to the medlev relav honours on the final day of action. It boosted her medal tally to seven four gold and three bronze surpassing the six won by East German Kristin Otto (1952) and American Natalie Coughlin (2008).

McKeon also matched the

SWIMMING

record for the most decorated female athlete at a single Games ever, tied with Russian gymnast Maria Gorokhovskaya (1952).

Like McKeon, Dressel took the 50-100 freestyle double. but also powered to the 100m butterfly title in worldrecord time, while adding 4x100m free and medley relays to thrust himself into rarified company.

He joins Americans Michael Phelps, Mark Spitz and Matt Biondi, and Otto, as the only swimmers to win five or more golds at one Games.

While the US again topped the medals table with 30, including 11 gold, secondplaced Australia had 20 medals, nine of them gold.

Dressel and McKeon returned for the event-closing relays with Dressel delivering a storming butterfly leg to steer the US to a world-record 3:26.78s. That shattered US's own global mark of 3:27.28s set at the 2009 World Championships, with Adam Peaty's Britain taking silver ahead of Italy.

In the women's relay, McKeon swam the fly for Australia, which came home an Olympic-record 3:51.60s to upset two-time defending champion USA. Canada was third.


