Second COVID wave still raging in country: govt. NEW DELHI

The second wave of COVID-19 is "still raging" in the country, said Lav Aggarwal, Joint Secretary, Union Health Ministry. Not asked to move to Delhi: Yogi

Chief Minister puts to rest speculation over leadership change in Uttar Pradesh

Uttar Pradesh Chief Minister Yogi Adityanath has put to rest speculation that he was asked to shift to Delhi, and thereby settled the question of leadership, for now, in the State BJP and the government as he heads into the 2022 Assembly election.

Amid questions over his future after the image of the State government received a blow during the questionable handling of the COVID-19 second wave and the difference of opinion over the 'CM face' from some of his own colleagues, Mr. Adityanath met Prime Minister Na-

rendra Modi in Delhi in July. Since then, the top BJP leadership, including Mr. Modi, has publicly praised the Chief Minister and his

work ethic. In an interview to The Hindu, Mr. Adityanath said he was not offered a role in Delhi during his visit

"We met over issues related to the State. I met him (Modi) earlier too and frequently seek his advice on governance issues," he said.

Mr. Adityanath also dismissed the electoral challenges posed to his party's social arithmetic by the ongoing farmer agitation in western Uttar Pradesh along

with the alliance of the Samajwadi Party and the Rashtriya Lok Dal. He listed out the schemes implemented by the BJP government for farmers in the past seven years and labelled the farmers' protest as politically motivated. "If this kisan andolan was connected to the interests of farmers, then possibly they could have had the support. This is politically motivated. And any such

politically motivated cam-

paign will not receive sup-

port of people and annadata kisan," he said.

He also dismissed the credentials of the Opposition, in particular the BSP, in wooing the dominant Brahmin community. The BSP and the SP have constantly accused the BJP government, headed by Mr. Adityanath, a born-Thakur, of targeting the Brahmins.

"Since when is the BSP a champion of Brahmin samai (community)? Their old slogans reflect their attitudes," Mr. Adityanath said. "Neither SP or BSP has the right to speak about social cohesion as they have advocated conflict between communities," he said, adding that the two parties were trying to hunt for their lost social base, which has come to the BJP.

Let's unite voice of people, Rahul tells Oppn. leaders

He rides a cycle to Parliament to protest against fuel price rise

Former Congress president Rahul Gandhi on Tuesday gave a call to Opposition leaders to "unite the majority voice of the people of India" that is represented by their parties.

Accompanied by his party colleagues and Opposition leaders, Mr. Gandhi rode a bicycle to Parliament to protest against the rise in the prices of petrol, diesel and cooking gas.

Earlier, he hosted a breakfast meet for the leaders of 15 Opposition parties at the Constitution Club, close to Parliament.

"We [the Opposition parties] represent 60% of the people, the majority of the people. When the govern-

ment shuts us up, they are not humiliating us as members of Parliament but the majority voice of the people of India. The single most important thing in my view is: let's unite this voice," he told the Opposition MPs.

"The more this voice unites, the more powerful it will become, more difficult it will become for the BJP and RSS to suppress this voice," he asserted.

The principles for the foundation of such unity should be worked out now, Mr. Gandhi added

The number of "excess deaths" registered by the Civil Registration System (CRS) in Maharashtra ever since the COVID-19 pandemic hit (from April 2020 to May 2021) was an estimated 2,12,589, which is 2.8 times the official reported figure of 75,877 COVID-19

deaths for the same period. The figures were arrived at from data on deaths registered month-wise in the on-

line CRS from January 2018 to May 2021 in Maharashtra and accessed by The Hindu. As with the other States, not all excess deaths could be related to COVID-19, but a bulk of them will be, during the pandemic period. The online death registrations data showed a total of 6,67,900

and 6,93,800 deaths in 2018

Bariatric surgery on two-year-old weighing 45 kg

A two-year-old girl who weighed 45 kg has undergone successful bariatric surgery and is recovering well, said a private hospital in the city. Normally, a child of that age weighs around 12-15 kg.

The two-year-old had a Body Mass Index of 41.5 normal BMI is between 23.5 to 25.

"The child was normal at the time of birth and weighed 2.5 kg. However, she started gaining weight rapidly soon after birth and weighed 14 kg at six months. She reached 45 kg at two years and three months," said Manpreet Sethi, consultant, paediatric endocrinology, at Max Hospital.

He said the child's condition had worsened to the point where she had trouble breathing and was unable to sleep on her back. She was wheelchairbound for six months before the surgery.

"We finally decided to go ahead with the bariatric surgery as it seemed the only way to save her life," Dr. Sethi said, adding that the child is undergoing rehabilitation.

Kejriwal seeks capital punishment for culprits

Police officers told to appear before DCW

Chief Minister Arvind Kejriwal on Tuesday condemned the rape and murder of a nine-year-old girl in the city and demanded capital punishment for the culprits. Besides, he said there is a need to improve the law and order situation in the national

"Going to meet the victim's family on Wednesday, will do everything possible to help the family in this fight for justice," Kejriwal tweeted.

The Delhi Commission for Women (DCW) issued notice to Delhi Police and sought a detailed action taken report in the matter and details of the accused.

"The DCW has instituted

an enquiry into the matter of the death of a nine-yearold in Delhi Cant. The commission had received a call on its 181 women helpline number on the night of August 1 regarding the death of the girl. The commission immediately sent a team to the police station and assisted the family in filing an FIR in the matter wherein they alleged that their daughter had gone out and was brought home dead by a local "pujari" [priest]," a DCW official said.

The women's panel asked senior police officers to be present before the commission on August 5.

Cong. expresses concern Meanwhile, Delhi Congress chief Ch. Anil Kumar visited the girl's family on Tuesday morning and alleged that the police made the family wait at the station for several hours and were reluctant to file an FIR for rape and murder. Moreover, they put pressure on them to compromise, but only when Congress workers strongly took up the case that they

filed a strong FIR. Mr. Kumar expressed concern at the rising crimes against women and girls in the Capital and said that the incident has once again exposed the reality that Delhi has become unsafe for women. He also demanded protection for the girl's family as they face threats from criminals and said that the Delhi Congress' Legal Cell will provide free legal aid to the family.

Nangal fumes after 'rape, murder' of child

Protests demanding hanging of the accused continue; locals say they don't want to politicise incident

Two days after a nine-yearold girl was allegedly cremated against her parents' consent inside a cremation ground - and a priest and three others were arrested on charges of rape and murder of the girl - protests demanding the hanging of the accused continued in southwest Delhi's Nangal on

Tuesday. As the road in cantonment area from both sides towards Nangal village was blocked by protesters, the girl's mother lay semi-conscious while the father sat amid the crowd. Both were clearly overwhelmed by situation.

Nearby, on a stage, locals kept shouting that "this is not a political incident... we just want justice for our daughter... those who have come here for political gains should refrain from being part of the protest"

Among the political figures who visited the parents to express solidarity were Bhim Army chief Chandra Shekhar Azad and his party members.

Recalling the incident, the mother, who is a ragpicker, said that the girl was

dropped at the cremation ground by her father as he went to buy vegetables, and the mother had gone home

from nearby mazaar. "Jaise meri bacchi jalayi hai... vaise hi fansi chahiye unke liye [The way they have burnt my daughter... I want them to hang]," she said.

Rattled mother

"A person came searching for me and said the priest is calling me. When I reached the cremation ground, he told me that my daughter is dead. I kept asking for proof if she died of electrocution. But he never gave any. There

were bruises on her hand, her skin was peeling off. Her tongue was black and lips were blue," she said.

She told the priest that she wanted to call the police but she didn't have a phone so she thought of going to the village, which is walking distance from the crime scene. "But he forced me inside the premises and locked the gate," she claimed.

The mother said that she believed that her daughter had been raped because of the rushed cremation. "The priest didn't ask for any documents, which he asks from others. He told me that I The priest told me that I should not call the police because police matters go on for longer periods

should not call the police because police matters go on for longer periods," she said.

One of the four accused went on a scooty and brought the father from a nearby market. Both parents reportedly refused to sign any cremation document, and the girl was already being cremated when the father reached the place, the family said.

As the word spread, locals reached the crematorium, broke open the gate, poured water on the body and told the parents that it may be a case of rape after which police were called.

Police harassment

The father claimed that he was beaten up by the police inside the station on Sunday night. "They said I had taken money," he said.

"I told the priest that I would have taken my daughter to hospital if she was electrocuted... why did he burn her? He asked me to

come the next day and take her ashes," the father said.

Senior officers of Delhi Police, including Joint Commissioner of Police Jaspal Singh and Deputy Commissioner of Police (South-West) Ingit Pratap Singh reached the protest site on Tuesday and tried to defuse the situation. They asked the crowd to submit their grievances in written form so that action can be taken.

Sources said that medical examination of the accused was conducted and it was found that they were not drunk at the time of the incident. No CCTV footage has been found either, they said, although videos of the girl's remains being pulled out of the pyre have been obtained.

Chandra Shekhar Azad demanded justice for the child. "If our girls here are not safe, then one can only imagine what the situation would be like in villages. I haven't seen the FIR yet. I want to see it so that I can help the family with legal discourse,"

Sharing a news piece on the incident, Congress leader Rahul Gandhi wrote "Dalit ki heti hhi desh ki heti hai [A Dalit's daughter is also daughter of the country]."

CBSE Class X results: Delhi, Noida regions get bottom positions

Pass percentage for govt. schools 97.52

The Central Board of Secondary Education (CBSE) Class X results, using a modified assessment policy that took into consideration marks obtained in unit tests, mid-vear exams and pre-board exams, were announced on Tuesday.

The pass percentage of Delhi West and Delhi East regions was 98.74 and 97.80 respectively, putting it in the 14th and 15th position out of the 16 regions across the country. The All India pass percentage was 91.46.

Last year also, Delhi West and Delhi East regions were placed in the same positions with a pass percentage of 85.96 and 85.97.

The Noida region placed 13th with 98.78 pass percentage. The CBSE did not issue a merit list for the results this year.

Pass percentage for Delhi government schools for 2021 was 97.52, which is an

82.61 achieved in 2020, said the Delhi government.

In 2019, which was the last time the board exams was not disrupted due to COVID-19, the pass percentage was 71.58.

100% pass result

The number of government schools that secured a 100% pass result has gone up from 147 in 2020 to 750 this year, it added. A total of 186 Delhi government school students scored above 95%.

The board has announced the results on the basis of an alternative assessment policy after the exams were cancelled in view of the aggressive second wave of COVID-19.

According to the policy, while 20 marks for each subject were for internal assessment as every year, 80 marks were calculated on basis of the students' performance in various tests throughout the year.

nior national wrestling champion was the result of a conspiracy hatched by Olympic medallist wrestler Sushil Kumar, who wanted to re-establish his supremacy among younger wrestlers, the Delhi police +has said in its chargesheet filed in the murder case.

Sagar and his four friends were allegedly assaulted by Sushil and others at the stadium on the intervening night of May 4 and 5 over a property dispute. Sagar succumbed to injuries later.

The Crime Branch, which is tasked with investigating the case, said Sushil wanted to teach a lesson to Sagar and Sonu and reestablish his supremacy in the stadium through muscle power. It also listed reasons why Sushil and his associates took revenge.

The police investigation established that it was due to the initial reluctance shown by Sagar and Sonu to vacate Sushil's flat and "murmurs" in the stadium that the Olympic wrestler was scared of the duo and couldn't withstand them. The chargesheet names 13 accused, including Sushil.

Cabinet approves salary hike for MLAs, sticks to cap set by Centre

BJP claims AAP govt. sought '400% increase', which MHA reduced to around 70%

The Delhi Cabinet, in a meeting chaired by Chief Minister Arvind Kejriwal, on Tuesday approved a salary hike for MLAs as per the cap fixed by the Centre.

The city's legislators will now get a salary of ₹30,000, besides other allowances, the government stated. The move comes after the Ministry of Home Affairs (MHA) "restricted" the Delhi government's proposal to hike legislators' salaries and chose to cap it at ₹30,000.

The said proposal had been pending for the last five months, said the Delhi government. The BIP opposition alleged the proposal was a veiled attempt by the Delhi government to affect a "400% increase" in MLAs' salaries, which had been struck down by the MHA as it was "unjustified".

The Salaries and Allowances of Ministers of Government of National Capital Territory of Delhi, (Amendment) Bill, 2021, MLAs/Speaker-Dy Speaker/Chief Whip/Leader

of Opposition of Legislative Assembly of Delhi (Amendment) Bills, 2021, were approved recently, the government stated. The proposal and the draft Bills will be sent for the MHA's approval before being placed in the Delhi Assembly.

'Lowest earning MLAs' As the cost of living in the Capital had risen substantially, the restriction imposed by the Centre had forced Delhi's MLAs to be amongst the lowest earning MLAs in the country, the city government argued,

The Delhi government said the salary of Delhi's wance, office rent and staff expenses, allowance for buying office equipment, vehicle, driver allowance."

BJP MLA Vijender Gupta said the Delhi government had passed a Bill increasing MLAs' salary and other allowances from ₹53,000 to ₹2,10,000 in 2015 and sent the proposal to the Centre for approval. But this was not granted as the Bill was passed in "an unconstitutional manner", he added.

He also said in 2020, the Delhi government sent a new proposal to the MHA in which it once again demanded salary and other allowances to be increased to ₹2,10,000 per month. However, the Centre amended the proposal in January 2021 with an increase in salary and other allowances to ₹90,000 from ₹53,000 and sent it back to the Delhi government.

"The Delhi government's proposal for a 400% hike in salary and other allowances was not justified, therefore, the Central government approved only 70% increase," Mr. Gupta said.

Nod for policy to promote production of medical oxygen in the Capital

Govt.'s free Wi-Fi scheme to continue

The Delhi Cabinet, in a meeting chaired by Chief Minister Arvind Kejriwal, on Tuesday approved the Medical Oxygen Production Promotion Policy, 2021.

The policy includes the provision for incentives for medical oxygen production and storage.

"Medical Oxygen Production Promotion Policy 2021 has been approved. It provides several incentives to the private sector to set up oxygen production plants, invest in oxygen tankers, and set up oxygen storage facilities. This will help improve oxygen availability in Delhi, which became a huge bottleneck in handling the last COVID wave," Mr. Kejriwal tweeted.

To become self-reliant

The objectives of the policy include making Delhi selfreliant in terms of medical oxygen production and supply. It seeks to do so by increasing the production of oxygen in Delhi through setting up either new manufacturing enterprises or expanding the production capacity of existing units.

The objective of the policy is to ensure time-bound fulfilment of the setting up of Liquid Oxygen manufacturing facilities of minimum 50 MT capacity up to a total of 100 MT. It also seeks the setting up of non-captive oxygen generation plants (PSA/Air Separation Unit technology) of minimum 10 MT and maximum 50 MT capacity up to a total of 100 MT, the government said.

Target of 11,000 hotspots In another decision. the Cabinet granted approval for the continuation of free Wi-Fi facility in Delhi. Mr. Kejriwal had launched the free Wi-Fi scheme from the ITO bus stop in December 2019.

Initially, the government had targeted the setting up of 11,000 hotspots to provide free Wi-Fi across Delhi.

So far, the government stated, free Wi-Fi hotspots had been installed at 10,561 places: 2,208 hotspots at bus stops and 8,353 at other locations.

Vaccination picks up pace; 50 new cases

The number of daily CO-VID-19 vaccine doses administered in the city has increased, the government said on Tuesday.

A total of 91,100 doses of vaccine were administered on Monday, compared to 83,042 doses on Saturday. But it is far less than figures towards the end of June when 1.5-2 lakh people were being vaccinated daily. The vaccine stock of the city will last for four days and there are 4,15,990 doses of Covishield and 3,81,560 doses of Covaxin, as per government data.

Till now, 1,01,98,723 doses of vaccines have been administered in the city.

According to Tuesday's bulletin, the city reported 50 new COVID-19 cases in 24 hours, taking the total to 14,36,451. There were four deaths pushing the toll to 25,058. A total of 64,276 tests were done in a day and that test positivity rate was 0.08%. Of the total cases, 14,10,874 people have recovered and there are only 519 active cases.

No COVID-19 bulletin was released by the government on Monday.

No oxygen-scarcity death at Jaipur Golden: police PRESS TRUST OF INDIA

The Delhi Police told a court here on Tuesday that the death of 21 COVID-19 patients in Jaipur Golden Hospital in April was not caused due to oxygen shortage, a claim which contradicts the hospital's stand.

In the same status filed by the police before the court, the hospital had said there No oxygen was supplied for 30 hours despite several alerts

JAIPUR GOLDEN HOSPITAL

was a link between inadequate oxygen supply and deaths of the patients as no oxygen was supplied to them for 30 hours despite several alerts. Twenty-one in-patients died at the hospital on the intervening night of April 23-24 allegedly due to lack of oxygen. "On scrutiny of death sum-

maries of all deceased persons, it revealed that no death of any patient caused due to shortage of oxygen," the police stated in the status report on a plea seeking FIR against the hospital for deaths.

DCP Pranav Tayal told Metropolitan Magistrate Vivek Beniwal that as the allegations are against doctors and medical staff, the opinion regarding any medical negligence has been sought from Delhi Medical Council.

However, the hospital said: "INOX supplied oxygen 3.8 MT on 22 April at 5:30 pm. There was no refill by INOX at the scheduled time of 5:30 pm on 23 April. This resulted in a crisis situation".



Domestic violence plaint against Yo Yo **Honey Singh**

A Delhi court on Tuesday issued notice to singer Hirdesh Singh, alias Yo Yo Honey Singh, on a domestic violence complaint filed by his wife. Chief Metropolitan Magistrate Tania Singh directed Mr. Singh to respond to the plea filed under the Protection of Women from Domestic Violence Act, and posted it for hearing on August 28.

Shalini Talwar, in her plea, accused Mr. Singh of physical, mental, and verbal abuse. She said they had gotten married in 2011, around the time the singer was gaining more popularity. "With the incoming success, Mr. Singh's attitude changed towards Ms. Talwar and he became rude, brash, aggressive, contemptuous, and disrespectful towards her," the plea said.

Advocates Sandeep Kapur, Apoorva Pandey and G.G. Kashyap represented Ms. Talwar during the proceeding. Ms. Talwar also accused Mr. Singh of cheating on her, becoming an alcoholic and a drug addict.

Clear Aravali forest land encroachments by Aug. 23: SC

The Supreme Court on Tuesday said the Faridabad Municipal Corporation is expected to complete the removal of unauthorised structures on Aravali forest land in Khori Gaon before August 23 while reiterating that all unauthorised structures, including illegal farmhouses, will face the axe. "If structures are in forest land. they will face action," a Special Bench of Justices A.M. Khanwilkar and Dinesh Maheshwari clarified.

The court asked the municipal authorities to file a status report by August 25 on the demolition. The court-ordered demo-

lition covers about 10,000 unauthorised residential constructions encroaching into the forest land.

The court also asked the State of Harvana to expedite and finalise the rehabilitation policy for residents, preferably before the next date of court hearing.

Now, Gurugram to demolish all illegal buildings on PLPA land

SPECIAL CORRESPONDENT GURUGRAM

In view of the Supreme Court direction in a case pertaining to Khori Basti this past month, the Gurugram district administration has decided to identify illegal structures on land notified under the Punjab Land Preservation Act, 1900 and remove them. Around 6,800 hectares

of land in the district across 33 revenues estates is notified under the PLPA. The Faridabad district

administration too had on July 28 said all illegal structures, including farmhouses and educational institutes, on the land notified under the PLPA would be demolished to clear encroachment on forest land. The Faridabad district has around 130 illegal structures spread across 500 acres of notified land.

The Supreme Court had, in a matter pertaining to Khori Basti demolition, observed on July 23 that "the direction to remove all unauthorised structures standing on forest land applies to 'all' unauthorised structures".

Gurugram Deputy Commissioner Yash Garg has ordered a survey of the land notified under PLPA.

Yediyurappa, son

The High Court of Karnataka on Tuesday ordered issue of notice to former Chief Minister B.S. Yediyurappa, his son B.Y. Vijayendra, and others on a petition questioning the order of a special court declining to order an investigation against them for want of sanction for prosecution on a complaint of alleged receipt of bribe.

CBI arrests key witness in Viveka murder case

Sunil Yadav and family had reportedly gone underground

In a major breakthrough in the sensational former Member of Parliament Y.S. Vivekananda Reddy murder case, the Central Bureau of Investigation apprehended an important witness, Sunil Yadav, in Goa on Monday night. Mr. Yadav, who is learnt to

have had a long-term association with the Viveka family, was grilled a number of times by the CBI team that had camped in Kadapa district for over a month. After this, he had approached the Andhra Pradesh High Court and sought protection from arrest by the CBI. The CBI also filed a counter in the High Court stating that the investigation was progressing in tune with the norms, and

held that the petitioner was trying to mislead the officials. The CBI also reportedly submitted to the court that there was enough evidence against Mr. Yadav.

After moving court, Mr. Yadav and his family members reportedly went undergound and remained inaccessible to the police.

Vivekananda Reddy, paternal uncle of Chief Minister Y.S. Jagan Mohan Reddy, was found dead in the bathroom of his Pulivendula house on March 15, 2019, just ahead of the general elections. Though initially believed to be death caused by heart attack, the police later recognised it as a case of

There was little breakthrough over the years in spite of a lot of action by the CBI. The probe picked up momentum over the last few weeks after the officials started questioning Mr. Reddy's former driver Dastagiri.

Police produced Mr. Yaday and his family members in a local court in Goa and obtained a transit warrant to bring them to Kadapa. He is expected to be produced in a Kadapa court on Wednes-

No more statues, say authorities

With the Kadapa district administration deciding not to allow the installation of any more statues, the furore over the move to build a statue of Tipu Sultan in Proddatur is expected to die down.


It all started with the Proddatur YSRCP MLA Rachamallu Sivaprasad Reddy volunteering to install a statue of Tipu Sultan on a main road junction and even performing 'Bhumi Puja' for the same, allegedly without getting a nod from the district statues committee.

The Bharatiya Janata Party leadership, led by Somu Veerraju and S. Vishnuvardhan Reddy, visited Kadapa and submitted representations to officials against the move, describing it as "unconstitutional" and "an attempt to appease the minor-Welcoming

government's decision, the BJP on Tuesday demanded Mr. Reddy's arrest for "going against the Constitution".

Meanwhile, Hakkula Parirakshana Samithi State president Farooq Shibli has accused the YSRCP government of playing with public sentiments. "Muslims never asked for a Tipu Sultan statue. It was the MLA who insisted on installing a statue, but the Uturn is indicative of tacit support to the BJP's divideand-rule politics," he said.

Hyderabad encounter: SC gives six more months to probe panel

Four men, accused of gang-rape, were killed on Dec. 6, 2019

The Supreme Court on Tuesday gave the Justice V.S. Sirpurkar Commission another six months to complete the probe ordered by it into the death of four men, accused of gang-rape and murder of a veterinarian, in an alleged encounter with the Hyderabad police on December 6,

A Bench led by Chief Justice of India (CJI) N.V. Ramana, however, asked the Commission's lawyer, advocate Parameshwar, why it needed so much time to complete the inquiry.

In July last year, the Commission had taken a similar extension of six months. A second extension was given in January last.

Mr. Parameshwar cited delays caused by the pandemic and a new list of another 130 witnesses.

The Commission had said that despite the pandemic restrictions they received a whopping 1,365 affidavits from the Hyderabad police officers allegedly involved and the families of the accused. It had also collected the reports of the National Human Rights Commission, the Special Investigation Team, post-mortem reports, etc, in the case. The four accused - Mo-



"If it has gone over 1, it shows it is a significant problem and some States have registered an increasing trend of over 1," Mr. Aggarwal said. Only Andhra Pradesh and Maharashtra are showing a declining trend and in States such as Bengal, Nagaland, Haryana, Goa, Delhi and Jharkhand, the R-

factor is at 1.

The Ministry said 44 districts had reported a high case positivity and 18 districts had shown an increasing new cases trend in the past four weeks. "Currently, we have Kerala (10 districts), Manipur (9), Mizoram (6), Nagaland, Arunachal Pradesh and Meghalaya (4 each), among others that remain a cause for concern."

Parts of Manipur and Nagaland shut down on Tuesday to protest against the lack of progress in the Naga peace process. The Isak-Muivah faction

Circumscription

Circular on using past protest record to deny jobs, passports risks further alienation in J&K olice verification and security clearances for passport or government job applicants are a matter of routine in most parts of the country. In Kashmir, where the police have now issued a circular aimed at gathering details and denying security clearance to those involved in throwing stones and joining street protests in the past, the exercise may not be out of the ordinary, but it could result in serious prejudice to the aspirations of many young men and women. The circular, which asks CID Special Branch field units to ensure that any subject's involvement in law-and-order incidents and related crimes be specifically looked into, and also to collect digital evidence from the records of police and security forces, suggests that the administration is quite serious about preventing those with a likely link to protests in the past from either entering government service or travelling abroad. Reports suggest that the official list of street protesters swelled between 2008 and 2017 to include nearly 20,000 people. On the face of it, the decision to subject applicants for passports and jobs to scrutiny is not illegal. Under Section 6(2) of the Passports Act, 1967, passports can be denied to applicants for various reasons, including their likelihood of engaging in activities prejudicial to the country's sovereignty and integrity, or detrimental to its security. Further, those convicted in the preceding five years, or against whom proceedings are pending before any criminal court, are also candidates for refusal.

In the backdrop of the Union government's outreach to revive political activity preparatory to elections, it is quite incongruous that such a far-reaching measure that would dampen the hopes and aspirations of thousands of people is being pursued. The Government's position is that the alteration of the status of J&K in August 2019 has ushered in a new era of development and prosperity, and that it is time to strengthen grassroots democracy. It was as a part of this process that Prime Minister Narendra Modi invited leaders of the Union Territory's political parties in June for a discussion. Despite their obvious disappointment that the restoration of statehood is likely to be considered only after polls to the Legislative Assembly, the parley did create some cautious optimism about a fresh political process. Were the administration to pursue this circular zealously, there is a danger that it may revive the sort of alienation among the youth that led to the stone-pelting incidents in 2008 and 2010, and the wave of disaffection following the killing of militant leader Burhan Wani. When all efforts should be directed towards building on current gains, nothing ought to be done to make those still harbouring, for whatever reason, a sense of betrayal feel that some fresh collective punishment is in the offing.

Time and patience

India seems ready for England in cricket's longest format after extended waiting period

Tust as Indian hockey's Olympic tryst draws rightful attention in Tokyo, Virat Kohli's men will don whites and play their Test series in England. The first Test commencing at Nottingham's Trent Bridge on Wednesday will kick-start a five-match joust stretching all the way to September 14. Due to bio-bubble protocols and the World Test Championship final that India lost to New Zealand at Southampton on June 23, Kohli and company have been in England since June first week. Perhaps, this is the longest an Indian squad has stayed overseas prior to an opening Test and there was adequate time to get acclimatised. After the contest involving New Zealand, the players took a break, savoured the countryside, Euro and Wimbledon, and added zest to their Instagram accounts. They then reverted to the bubble and had a warm-up fixture against a County Select XI. Meanwhile, Rishabh Pant recovered from COVID-19, an injured Shubman Gill returned home, and Mayank Agarwal suffered a concussion and was ruled out of the first Test. Even so, India is seemingly in a better head-space, an important attribute while countering England in its backyard. Ever since its maiden tour of England in 1932, India has won only three series - 1971, 1986 and 2007 - at the Old Blighty. Having ambushed Australia, India wants to replicate that feat in cricket's birthplace.

With its whimsical skies torn between the sun and feathery rain, and pitches favouring the sultans of pace, England is a hard testing ground. A cautionary fact is that India lost all its three previous tours during 2011, 2014 and 2018. It would be interesting to see who walks out along with Rohit Sharma as his fellow-opener. K.L. Rahul has a chance while Cheteshwar Pujara, Kohli and Ajinkya Rahane would constitute the middle-order. Hanuma Vihari is part of the mix with Pant lending matchaltering flair. A pace-attack headlined by Jasprit Bumrah along with R. Ashwin lending his spin, augurs well and seemingly India have the right men. Yet, there are worry-lines. By their exalted standards, Kohli, Pujara and Rahane have had a lean patch, and Bumrah was not on fire against New Zealand. However, the team-management sees this as an aberration. Facing off against India, England has skipper Joe Root and the pace-combine of James Anderson and Stuart Broad to fall back upon. But there is no Jofra Archer and the exit of all-rounder Ben Stokes citing mental issues and the need for rest, is a blow to the host. Exactly 50 years after registering its maiden series victory in England, India is back for another tilt. With just the walking-wounded and its bench-strength, India stunned Australia. Kohli is banking on that memory to turn the tide.

Poverty in India is on the rise again

In the absence of CES data, the Periodic Labour Force Survey shows a rise in the absolute number of the poor

India has not released its Consumption Expenditure Survey (CES) data since 2011-12. Normally a CES is conducted by the National Sample Survey Office (NSO) every five years. But the CES of 2017-18 (already conducted a year late) was not made public by the Government of India. Now, we hear that a new CES is likely to be conducted in 2021-22, the data from which will probably not be available before end-2022.

Meanwhile, we know that the economy has been slowing for nine quarters prior to the outbreak of the novel coronavirus pandemic. Unemployment had reached a 45-year high in 2017-18, as revealed by NSO's Periodic Labour Force Survey (PLFS).

Sufficient to estimate change

India's labour force surveys, including the five-yearly Employment-Unemployment Rounds from 1973-4 to 2011-12, have also collected consumption expenditure of households. The PLFS has maintained that tradition. While the PLFS's questions on consumption expenditure are not as detailed as those of the CES, they are sufficient for us to estimate changes in consumption on a consistent basis across time. It enables any careful researcher to estimate the incidence of poverty (i.e., the share in the total population of those below the poverty line), as well as the total number of persons below poverty. That is exactly what we do in the table.

There is a clear trajectory of the incidence of poverty falling from 1973 to 2012. In fact, since India

began collecting data on poverty, the incidence of poverty has always fallen, consistently. It was 54.9% in 1973-4; 44.5% in 1983-84; 36% in 1993-94 and 27.5% in 2004-05. This was in accordance with the Lakdawala poverty line (which was lower than the Tendulkar poverty line), named after a distinguished economist, then a member of the Planning Commission.

Methodology

In 2011, it was decided in the Planning Commission, that the national poverty line will be raised in accordance with recommendations of an expert group chaired by the late Suresh Tendulkar (then professor of Economics at the Delhi School of Economics). That is the poverty line we use in estimating poverty in the table. As it happens, this poverty line was comparable at the time to the international poverty line (estimated by the World Bank), of \$1.09 (now raised to \$1.90 to account for inflation) person per

Based on the Tendulkar poverty line, the poverty estimates for 2004-05 and 2011-12 are to be found in the Planning Commission's own estimates using the CES of those years. Hence, we have extended the 2011-12 poverty line for each State and used the consumption expenditure reported by the PLFS to estimate a consistent poverty head count ratio (i.e., incidence of poverty in the population) as well as the absolute number of the poor. We feel confident about using the PLFS, because in the absence of CES data, the PLFS can be used to estimate the incidence of poverty. It also collects the household monthly per capita consumption expenditure data based on the Mixed Recall Period methodology. Similar to the CES, the PLFS (PLFS annual report, 2019-20, page 6) also asks the household questions about expenses on health, clothing and **Relative and absolute** poverty rose after 2012



bedding, education, footwear and consumer durables for a 365 day recall period – prior to the day of the survey; but for non-durable consumption goods/services - including expenses on food, housing and conveyance, etc. - its question expects a recall period of 30 days prior to the day of survey. We naturally updated the Tendulkar poverty line, using the Consumer Price Index for each State to 2019-20, to arrive at the estimate for the last year before COVID-19.

An urban and rural rise

What is stunning is that for the first time in India's history of estimating poverty, there is a rise in the incidence of poverty since 2011-12. The important point is that this is consistent with the NSO's CES data for 2017-18 that was leaked data. The leaked data showed that rural consumption between 2012 and 2018 had fallen by 8%, while urban consumption had risen by barely 2%. Since the majority of India's population (certainly over 65%) is rural, poverty in India is also predominantly rural. Remarkably, by 2019-20, poverty had increased significantly in both the rural and urban areas, but much more so in rural areas (from 25% to 30%).

It is also for the first time since

the estimation of poverty began in India on a consistent basis, that the absolute number of poor has risen: from 217 million in 2012 to 270 million in 2019-20 in rural areas; and from 53 million to 71 million in the urban areas; or a total increase of the absolute poor of

It is important here to recall two facts: between 1973 and 1993, the absolute number of poor had remained constant (at about 320 million poor), despite a significant increase in India's total population. Between 1993 and 2004, the absolute number of poor fell by a marginal number (18 million) from 320 million to 302 million, during a period when the GDP growth rate had picked up after the economic

It is for the first time in India's history since the CES began that we have seen an increase in the absolute numbers of the poor, between 2012-13 and 2019-20.

The second fact is that for the first time ever, between 2004-05 and 2011-12, the number of the poor fell, and that too by a staggering 133 million, or by over 19 million per year. This was accounted for by what has come to be called India's 'dream run' of growth: over a 10-year run that was not sustained thereafter. By contrast, not only has the incidence of poverty increased since then, but the absolute increase in poverty is totally unprecedented.

The contributory factors

The reasons for increased poverty since 2013 are not far to seek. While the economy maintained some growth momentum till 2015, the monumental blunder of demonetisation followed by a poorly planned and hurriedly introduced Goods and Services Tax, both delivered body blows to the unorganised sector and Micro, Small and Medium Enterprises. The economic slowdown followed. None of the four engines of growth was firing after that. Private investment fell from 31% inherited by the new government, to 28% of GDP by 2019-20. Public expenditure was constrained by a silent fiscal crisis. Exports, which had never fallen in absolute dollar terms for a quarter century since 1991, actually fell below the 2013-14 level (\$315 billion) for five years. Consumption stagnated and household savings rates fell. Joblessness increased to a 45-year high by 2017-18 (by the usual status), and youth (15-29 years of age) saw unemployment triple from 6% to 18% between 2012 and 2018. Real wages did not increase for casual or regular workers over the same period, hardly surprising when job seekers were increasing but jobs were not at anywhere close to that rate. Hence, consumer expenditure fell, and poverty increased.

Poverty is expected to rise further during the COVID-19 pandemic after the economy has contracted.

Getting back in business in the Indo-Pacific

The choreographed visits of three senior U.S. officials are a part of the Biden administration's deliberate strategic refocus

Tnited States President Joe Biden executed a bold di-Indo-Pacific region last month through carefully choreographed visits of his three top officials - Deputy Secretary of State Wendy R. Sherman, Secretary of Defense Lloyd J. Austin III, and Secretary of State Antony J. Blinken. This is part of a deliberate strategic re-focus, away from the 20 years of Afghanistan and Iraq and towards maritime Asia, where COVID-19, climate change and China are the compelling challenges

Assessing what the three American dignitaries sought and actually achieved is instructive in order to appreciate the impressive sweep of diplomacy and military strength of the world's top power, the United States. Their discussions would surely mould the geopolitical equations in the region.

In East Asia and Oman

Ms. Sherman's visit (July 19-27) was probably the most complex since it covered not only Japan, South Korea and Mongolia but also China. Throughout her trip, she reaffirmed the U.S. commitment to working with allies and partners for the promotion of peace and prosperity and upholding a 'rulesbased order', the code word criti-

cal of China's behaviour. Her discussions with Japanese Vice Fo-Minister Mori Takeo, covered not only the present state of the Japan-U.S. alliance but also other issues including Myanmar and COVID-19. In addition, she participated in a trilateral meeting involving Japan and South Korea, perhaps in a bid to smoothen tensions afflicting the two east Asian

By visiting Ulaanbaatar, Ms. Sherman became the highest U.S. dignitary to visit Mongolia since 2016. Despite its close relationship with Beijing, Mongolia looks for devices to assert its independence. So, the opportunity to discuss its needs and concerns with the new administration was valuable. In Tianjin, China, she held discussions with Vice Foreign Minister Le Yucheng, her counterpart, and was also received by Foreign Minister Wang Yi. Her main mission was to convey that the U.S. welcomed competition but did not seek confrontation with China. She also discussed forthrightly the dismal human rights situation in Xinjiang and logistics for a possible Biden-Xi Jinping meeting at the G20 summit in Rome in October.

Southeast Asian dynamics

The visit by Mr. Austin (July 23-30) covering three important ASEAN member-states - Singapore, Vietnam and the Philippines – turned out to be the most productive in that it reiterated the necessity for a U.S. military presence in the region. As the Pentagon chief, Mr. Austin is heard with attention, particularly when he speaks with the candour of a veteran general.

Beiling's ciaini to the vast majority of the South China Sea has no basis in international law," he aptly asserted, while delivering the Fullerton Lecture on July 27 (https:// bit.ly/3CkTeMT). He listed China's other objectionable actions, including "aggression against India". And then he sent out the key signal to Beijing: "We will not flinch when our interests are threatened. Yet we do not seek confrontation." This seems to have resonated,

as Mr. Austin's discussions with leaders of the three countries went off exceptionally well. In a joint statement, Singapore and the U.S. agreed that America's presence in the region is "vital for its peace, prosperity and stability". The U.S. side appreciated Singapore's logistical support to U.S. military aircraft and vessels (https://bit.ly/3xmjPW7), while Singapore benefits from the arrangement of an air force fighter training detachment hosted in Guam as well as new training facilities inside the U.S. Singapore could modulate its current inclination to move closer to China.

Mr. Austin encouraged Vietnam to develop closer defence cooperation with the U.S. A new memo-

randum of understanding was signed to resolve the war legacy issues by creating a database to accelerate the search for those still missing in action (MIA). Mr. Austin's visits to Singapore and Vietnam will be followed shortly by U.S. Vice President Kamala Harris. The Philippines leg produced a notable result as Manila agreed to full restoration of the Visiting Forces Agreement which provides the legal foundation for the U.S. military presence in that country.

In South Asia and Kuwait

Mr. Blinken's trip to Delhi and Ku-(July 26-29; https:// bit.ly/3yq8Yvt) drew attention for its positive outcomes. The India visit was more in the nature of a consultative, confirmatory dialogue rather than one that results in signing of new agreements. His discussions with the Prime Minister, the National Security Adviser and the External Affairs Minister brought out clearly that the areas of convergence between the two nations are expanding and the areas of divergence are shrinking. His repeated observation that the friendship with India is one of the closest that the U.S. has, was music to Indian

On Afghanistan, the proximity of perceptions was emphasised, although this did not conceal the differences in their perspectives. On the Indo-Pacific, however, the convergence was clear, with the two Foreign Ministers agreeing to cooperate on a range of geopolitical and geo-economic issues without uttering the "C" word even once in their smoothly-managed

joint press conference. By clarifying that the Quad was not "a military alliance", Mr. Blinken spoke the truth, tipping his hat to India's strategic autonomy. He defined the Quad as four like-minded countries "coming together to work collectively ... on regional challenges, while reinforcing international rules and values".

The takeaways

Together, what do the three visits signal? First, that America's China policy and the Rest of the Indo-Pacific policy will run in tandem, with inner consistency ensured by Mr. Biden. Second, Washington maintains a tough attitude towards Beijing, but it desires to keep the doors open for dialogue. The relationship with China is marked by three characteristics - adversarial, competitive and cooperative - and is likely to stay that way. Third, the U.S. is willing to resist and counter China firmly, but with the full engagement of and contribution by the like-minded states of the region. Therefore, Mr. Austin's exposition of "integrated deterrence", defined as "using every military and non-military tool in our toolbox, in lock-step with our allies partners....",

significance. In short, the U.S. is back and is willing to lead - but the region will have to seriously step up too and participate actively to maintain peace and prosperity. Asia can illafford to be a reticent bystander.

Providing horizontal quota: the Bihar way

The case for reservations for women and transgender persons in State jobs and higher education



The Bihar government recently announced 33% horizontal reservation for women in State engineering and medical colleges. While reservation for Scheduled Castes (SCs), Scheduled Tribes (STs), Other Backward Classes (OBCs) and Economically Weaker Sections (EWS) is referred to as vertical reservation, horizontal reservation refers to the equal opportunity provided to other categories of beneficiaries, such as women, veterans, the transgender community, and individuals with disabilities, cutting through the vertical categories.

Bihar at present has 60% reservation in the State higher educational institutions along the six vertical categories (SCs, STs, EWS and so on). The newly announced reservation for women in engineering and medical seats will not be in addition to this; it will instead be distributed across all the vertical categories, including the non-reserved 40% seats open to all. For example, if an engineering college has 100 reserved seats for STs, 33 of those seats will have to be filled with ST women. Article 15(3) of the Constitution allows governments to make special provisions for women and children.

Dropping out of the workforce

This initiative should be welcomed and adopted across sectors, departments, and States given that India's female labour force participation (FLFP) rate is consistently declining and is worryingly low. World Bank data show that the FLFP came down to 21% in 2019 from 31.79% in 2005.

As per the Bihar Economic Survey 2019-20, the State's FLFP rate was abysmal compared to the all-India average. Only 6.4% and 3.9% women were employed in the urban and rural areas of Bihar compared to the all-India figures of 20.4% and 24.6% respectively. The FLFP rate needs to be treated cautiously though as it doesn't take into account unpaid work (majorly performed by women) or the role played by social barriers like caste in blocking employment came into force in 1993, mandated opportunities for women like owning

Patriarchal control of women and systemic gender discrimination cannot be defeated by government intervention alone; State welfare schemes can go a long way in challenging them. The Bihar government needs to work towards reducing the female and male school dropout rate and ensure quality education at the primary and secondary level. In addition, initiatives like reservation of seats, when implemented properly, could become an important driver for improving the FLFP.

Improving representation

In the last three decades, Bihar has implemented various initiatives to empower women and improve their representation in various fields. When Lalu Prasad was the Chief Minister in 1992, Bihar had announced two consecutive days of menstrual leave for women employees in government services. In 2006, under Nitish Kumar, Bihar became the first State to reserve 50% seats for women in Panchayati Raj institutions even though the 73rd and 74th amendments to the Constitution, which only one-third seats for them. This

was later imitated by several other States such as Madhya Pradesh, Andhra Pradesh, Maharashtra, Gujarat, and Chhattisgarh.

In 2013, the Bihar government made a provision for 50% reservation for women in cooperative societies and reserved 35% seats for them in police recruitment. The second initiative led to a swift jump in the number of women officers in the police department to 25.3% in 2020, more than double the national average of 10.3%, from 3.3% in 2015. In 2016, the government extended the 35% reservation for women to all government jobs in Bihar for which direct recruitment is made

In 2006, a scheme called the Mukhyamantri Balika Cycle Yojana was launched for Class 9 and 10 girl students. This was India's first scaled up conditional cash transfer programme for secondary education of girls. The enrolment of girl students went up after this scheme. The Bihar government also provides ₹50,000 in installments to girl students to support their studies and other needs till graduation under the Mukhvamantri Kanva Utthan Yojana. This is an incentive-based scheme to encourage girls to complete education and delay marriage. According to the National Family Health Survey-5, the State's literacy rate among girl children rose to 61.1% in 2019-20 from 56.9% in 2015-16.

More jobs for women

While the Bihar government has taken some laudable steps for the empowerment of women, the low female literacy rate and FLFP rate are of concern. One of the important factors for the low FLFP rate is the lack of employment opportunities for women after matriculation and graduation. The India Human Development Survey-II found that women with low levels of education and from rural areas are relatively more active in the labour market compared to women with middle or high school education. Therefore, the Bihar government needs to ensure that women don't fall out of the labour market as they become more educationally qualified.

One way this can be done is by filling up pending vacancies in the health sector, police force, teaching and other government departments as at least 35% of these posts will go to women. The government should also do away with hiring workers on contract and make all the current contractual workers permanent.

Evidence points out that increasing women's participation in the workforce to the level of men boosts the economy. In light of this, it is important for the government to make more and more jobs available for women. The Bihar government should also extend the engineering and medical quota for women to all institutions of higher education, including private colleges and universities. Further, the quota allotted to them can be increased to 40-45%, if not 50%, and the category can be renamed as 'women and transgender persons'. Other State governments and the Union government should follow the Bihar government's lead and introduce horizontal quota for women (and in addition, for transgender persons) in higher educational institutions as well as State employment as these measures will go a long way in reducing gender disparity in the country.

The problems of prediction

Why most COVID-19 forecasting has gone wrong



As the pandemic broke, in a Harvard Business Review article of April 2020, Julie Shah, an AI researcher and a roboticist at MIT, and Neel Shah, a physician at a major hospital and a public health researcher at Harvard, perceived that this would be our most meaningful Big Data and analytics challenge yet. "We have the people. We have the data. We have the computational force. We need to deploy them now," they wrote. In terms of the volume of data, COVID-19 is something like Alibaba's cave. Many data scientists, statisticians, computer analysts, and epidemiologists got engaged in the fashionable exercise of predicting the trajectories of the number of cases and deaths, different waves of the pandemic and their peaks. Many of the predictions were contradictory in nature and were proved to be misleading eventually, although they were mostly done by academics of reputed universities and institutes. But why did such predictions fail?

A dubious track record

In a paper in the International Journal of Forecasting in August 2020, John P.A. Ioannidis, Sally Cripps, and Martin A. Tanner recalled that epidemic forecasting has a dubious track record. The failures became more prominent with COVID-19. They pointed out several important causes of the failure of such forecasting: poor data input, wrong modelling assumptions, high sensitivity of estimates, lack of incorporation of epidemiological features, poor past evidence on effects of available interventions, lack of transparency, errors, lack of determinacy, looking at only one or a few dimensions of the problem at hand, lack of expertise in crucial disciplines, selective reporting, etc.

The models used in most COVID-19 predictions were simple statistical models like regression or time series models, or standard epidemiological models such as SIR, SEIR, or their simple variants. These are well-studied and are also included in standard software packages. Thus, most COVID-19 data analysts didn't do much beyond feeding the classified data on daily cases and deaths into the computer. Software immediately provided forecasts along with fancy graphs.

Each of these models depends on some underlying assumptions on the nature of the disease and the behaviour of the concerned community. The dynamics of a new and unknown disease, however, maybe far more

complicated and unpredictable. And if the assumptions are not satisfied in reality, the predictions might become weird. The nature of COVID-19 was unknown from the beginning. Even now, there are many unknowns concerning the disease. New variants of the virus, effectiveness and coverage of the vaccines, etc. play important roles. So, which of the existing models is really 'suitable' for predicting COVID-19? It's difficult to answer.

Quality of data

Although waves of data are available, official death tolls from COVID-19 are likely to be a "significant undercount", the World Health Organization (WHO) said in May, estimating that the true figure of direct and indirect deaths in many countries "would truly be two to three times higher". The WHO estimated double the reported COVID-19 deaths in the European region, having relatively reliable reporting systems, during 2020. An unknown but huge number of asymptomatic cases, inadequate and inefficient testing facilities, overwhelmed hospital infrastructure, social stigma, etc. may be some of the reasons. The Centers for Disease Control and Prevention (CDC) in the U.S. even issued an official warning about the quality of data: "Counting exact numbers of COVID-19 cases is not possible because COVID-19 can cause mild illness, symptoms might not appear immediately, there are delays in reporting and testing, not everyone who is infected gets tested or seeks medical care, and there are differences in how completely states and territories report their cases." CDC even uses an 'ensemble' forecast which combines many independently developed forecasts into one to improve prediction.

Thus, almost everywhere, the reality of COVID-19 predictions is restricted to forecasting official figures based on official data, using some possible wrong model. The dimensions of errors are unknown both in the model and data. Policymakers may still need some such predictions to plan for healthcare infrastructure. But it's unclear why many academics, who should understand that they're engaged in useless exercises, are busy in the prediction business. The horror or false sense of security caused through these wrong predictions is undesirable.

In their 2020 paper, Ioannidis, Cripps, and Tanner opined that some, but not all, of the problems of epidemiological forecasting can be fixed. Careful modelling of predictive distributions rather than focusing on point estimates, considering multiple dimensions of impact, and continuously reappraising models based on their validated performance may help.

Contrary to popular belief, the U.S. is not getting out of Afghanistan a defeated nation. It stayed there as long as it needed to, as President Joe Biden stated, achieving its objective "to degrade the terrorist threat to keep Afghanistan from becoming a base

The U.S.'s exit from Afghanistan represents a fundamental shift in its strategic objectives. As Vanda Felbab-Brown observes in her blog dated April 15,

2021 in Brookings Institution, the U.S.'s decision is the right one. It is time for it to move on and focus on more important strategic priorities such as "threats from China, an aggressive Russia, North Korea, and Iran – as well as zoonotic pandemics".

Stopping spread of communism

By exiting Afghanistan, the U.S. has left the problem of containing what remains of the Taliban's brand of Islamic fundamentalism to its concerned neighbours. The most aggrieved by this exit will be the Afghans who, after enduring 20 years of conflict, were looking forward to better times, but are instead being abandoned by the U.S. This is what happened to the South Vietnamese when the U.S. withdrew from the Vietnam war in 1973. The U.S.'s seemingly messy exit then concealed a vic-

tory against global communism that

two shrewd and ruthless men - Pre-

sident Richard Nixon and Henry Kiss-

inger – conjured in just under four

years between 1969 and 1973. At the start of the big U.S. engagement in Vietnam following the Gulf of Tonkin Resolution passed by the U.S. Congress in August 1964, which authorised the President to deploy armed forces in Southeast Asia, there was a real fear among Americans that revolutionary communism, spearheaded by the Soviet Union and China, would take over one country after another in Asia and that Vietnam would be one more country to fall if not checked.

Fortunately for Nixon, soon after becoming the American President in 1969, the ideological differences between the Soviet Union and China came out in the open and led to a border dispute. It is here that Nixon saw his chance to drive them further

apart by reaching out to China through Romania and Pakistan.

In her 2005 paper, 'Nixon, Kissinger, and the "Soviet Card" in the U.S. Opening to China, 1971-1974,' Evelyn Goh, citing declassified documents, wrote about how the U.S. Secretary of State and National

Security Adviser, Henry Kissinger, in his first secret trip to Beijing in July 1971, assured Premier Zhou Enlai that the U.S. government "would gradually withdraw U.S. troops as the war in Vietnam ended and as relations with China improved". The paper was published in the official journal of Societv for Historians of American Foreign

Relations, Diplomatic History. Following up on Kissinger's secret visit to China, Nixon went there in 1972 on his much publicised 'the week that changed the world' tour paving the way for a 'safe' U.S. exit from Vietnam in 1973. This was no small victory for Nixon. With China almost wholly on his side, the U.S.'s principal enemy, the Soviet Union, stood alone. This practically eliminated American fears of communism overrunning the world.

Drawing parallels

Something similar has happened in Afghanistan. With the kind of surveillance that the U.S. and its allies are able to mount on countries and individuals today, it is unlikely that the Taliban will, even if they wrest control of Afghanistan, be in a position to nurture another terrorist like Osama Bin Laden, as they have been accused of doing. It is this confidence, not frustration, that has enabled Mr. Biden to announce American military disengagement in Afghanistan.





No assurance on Mujib's life: Yahya

The President of Pakistan, Gen. Yahya Khan, has refused to give an assurance that the Awami League leader, Sheikh Mujibur Rehman, would not be executed after he has been tried by a military court for "high treason" [New Delhi, August 3]. He told the Teheran daily, Kyhan International, in an interview last week that Mr. Rehman "would be court-martialled and I cannot say whether or not he would be alive when the (National) Assembly meets." Mr. Amir Taheri, who interviewed Gen. Yahya Khan in Rawalpindi, had asked him whether Sheikh Mujib would be "tried and possibly executed before the National Assembly is convened." Although Gen. Yahya Khan would not give any exact date for the trail, Mr. Rehman would be tried before October, according to the time-table set for the implementation of the proposed constitutional measures in Pakistan. Gen. Yahya Khan only said: "The matter is in the hands of military justice." He hoped that there would be a civilian government in Pakistan before the 2,500th anniversary of the Iranian monarchy, falling in October, "and in any case before the end of the current

London, August 1: The Committee of Leading Manufacturers which has been formed to protest against the increased import duties on cotton goods into India, has sent letters to Members of Parliament, urging them to use their influence to secure full and immediate opportunity for an examination in Parliament of all the facts of the case. The signatories state that Indian markets in normal times have taken forty per cent of whole of Britain's cotton exports but it will be impossible to preserve more than a fraction of this great business, under the oppression of these duties. With regard to the statement that the decision of these financial questions lies with India alone, the signatories declare, that constitutionally Mr. Montagu is responsible first and last and Mr. Montagu is answerable to Parliament with regard to the statement that the reforms established India as a Democratic Self-Governing country. The Signatories declare that the electors have no initiative in financial matters. Out of a population of some 250,000,000 only 900,000 are entitled to vote and at the last election only 197, 518 votes were recorded.

Mr. O'Brien gave a detailed chart of the Bills passed up to July 30. He said, "In the first 10 days, Modi-Shah rushed through and passed 12 Bills at an average time of UN-DER SEVEN MINUTES per Bill. Passing legislation or making papri chaat!"

Even on Tuesday, the Bills were hurried through. In the Lok Sabha, the Essential Defence Services Bill, Bahujan Samaj Party (BSP) MP Danish Ali said. was passed in less than 10 minutes. "What is painful is that they are passing Bills that have wider implications without pausing to hear the objections," Mr. Ali said. Trinamool MP Kakoli Ghosh Dastidar pointed out that the Opposition demand on the Tribunal Reforms Bill, 2021, was similarly ignored. The Deputy Leader of the Congress in the Lok Sabha, Gaurav Gogoi, said the government was treating Parliament like a Cabinet meeting. "The BJP should not mistake Parliament for a Cabinet meeting of this government. When they are not allowing the Opposition to speak on the Bill, they are not allowing 60% of the voters who voted for these parties," he said.

Neither the speeches by the members nor the statement made by Ms. Sitharaman was clearly audible due to protests from the Opposi-

tion parties. "You may have a disagreement, you may protest. However, to disrupt a member who is speaking and surround him in a threatening fashion is absolutely unacceptable," Ms. Sitharaman said.

The Essential Defence Services Bill, 2021 and The Tribunals Reforms Bill, 2021 were passed separately by voice vote before the House was adjourned for the day as Opposition continued with their sloganeering.

When the proceedings started at 11 a.m., Speaker Om Birla pointed out that important issues related to the farmers were being discussed and urged the protesting members to go back to their seats.

Question Hour went on for nearly 40 minutes. Expressing his displeasure at the members "insulting" parliamentary traditions, Mr. Birla then adjourned the House until noon.

The House was adjourned one more time when it reassembled at

noon as members did not heed the request of Biju Janata Dal (BJD) member Bhartruhari Mahtab, who was in the Chair.

As the House reconvened at 2 p.m., Mr. Birla asked Minister of State for Defence Ajay Bhatt to move the Essential Defence Services Bill, 2021, which seeks to prohibit any agitation and strike by anyone engaged in essential defence services.

Once the Defence Services Bill was passed, the House was adjourned until 4 On reconvening, Finance

Minister Nirmala Sitharaman moved the Tribunals Reforms Bill, 2021 for passage. The Bill seeks to abolish tribunals or authorities under various laws by amending the Cinematograph Act, 1952; the Copyrights Act, 1957; the Customs Act, 1962; the Patents Act, 1970; the Airport Authority of India Act, 1994; the Trade Marks Act, 1999; and the Geographical Indications of Goods (Registration and Protection) Act.

Bihar Chief Minister Nitish Kumar, who this week joined the Opposition in demanding a probe into the Pegasus snooping row and a castebased census in the State, has appeared combative against the BJP, an alliance partner at the Centre and in the State.

While Mr. Kumar's demands have led to raised eyebrows and some consternation in the BJP, political observers trace the change to recent developments in his party, the Janata Dal (United). They point out that soon after his former party president and close aide,

R.C.P. Singh, took oath as the Minister of Steel after the reshuffle of the Union Council of Ministers, Mr. Kumar replaced Mr. Singh from the party post and started making statements on issues challenging the Centre. Political sources in Bihar

In the Cabinet reshuffle this year again, Mr. Kumar wanted at least two of his close aides – Mr. R.C.P. Singh and Rajiv Ranjan Singh alias

Lalan Singh – included in the Cabinet, said party sources. But only Mr. R.C.P. Singh was offered a berth and he readily accepted the offer, which apparently did not go down well with Mr. Kumar.

"R.C.P. Singh is the party's national president and it is his decision to join the Cabinet. In 2019, Chief Minister Nitish Kumar was party president and it was his decision at that time not to join the Union Cabinet," said Mr. Lalan Singh, who is the party's MP from Munger. Soon after the Cabinet reshuffle, he replaced Mr. R.C.P. Singh as party's president.

Excess deaths in 29 Maharashtra districts could be 2.8 to 4.1 times official COVID-19 toll

Excess deaths lower in urban districts; Mumbai's only 2.54 times COVID-19 toll

A district-wise look at excess deaths registered by the Civil Registration System (CRS) in Maharashtra ever since the COVID-19 pandemic hit (adjusted figures for districts with inconsistent data) showed that their multiples over the COVID-19 toll were fairly low in urban (2.54) as compared to semi-urban (4.02), semi-rural (4.61) and rural districts (4.63).

Mumbai (37,260), Thane (33,944), Nashik (30,563) and Nagpur (25,664) had the highest number of estimated excess deaths (adjusted for data coverage), but Mumbai's excess deaths were only 2.54 times the official CO-VID-19 toll. On the other hand, the rural districts of Dhule (20.14), Hingoli (11) highest excess deaths' multi-


and Buldana (10.2) had the

Conservative estimate

Considering only close to 60% of deaths were available in the online data for the baseline years 2018 and 2019 for calculating excess deaths, the estimate of 2,12,589 is a conservative one. Deaths registered for districts such as Mumbai, Thane, Akola, Amravati and Nandurbar were more than 90% of those recorded in the annual report. while those for Ratnagiri, Raigarh, Kolhapur, Hingoli, Buldana and Washim were less than 40%.

If the excess deaths calculated were adjusted based on the percentage availability of data for 2018 and 2019 (by dividing them by the average of

the percentage availability for these years) and re-calculated for the State (without the six omitted districts), the increased to 3,10,727 deaths corresponding to a multiple of 4.1 over the official death toll of

In sum, the estimated excess deaths in the pandemic period for 29 districts in Maharashtra could be in a range of 2.8 to 4.1 times the official COVID-19 death toll in the State. The overall CO-VID-19 death toll for all 35 districts as of May 31, 2021 was 95,344, which has since increased to 1,32,948 as of August 1. Similar to what was ob-

served in other States, the excess deaths multiple (unadjusted) was 2.4 times between April and December 2020, and this went up to 3.42 times in 2021. This was largely due to a spurt in mortality in the month of April

2021, when a high of 1,17,723 deaths were registered online. Unlike other States, deaths peaked in April rather than in May 2021 for Maharashtra, indicating the fact that the second wave raged early in the State. That Maharashtra was the

epicentre of the second wave, largely characterised by the spread of the highly infectious Delta variant of the novel coronavirus, according to an INSACOG report in May 2021, is also borne out by the fact that deaths in April and May 2021 were three times the average number of deaths registered in these months in 2018 and 2019 (the pre-pandemic period). Only Haryana (2.65 times) came close as the multiple was higher than M.P. and Punjab (1.97 times), Himachal Pradesh (1.8), Karnataka (1.69), Tamil Nadu (1.65), West Bengal (1.51), Kerala (1.21), among States that

The Hindu has analysed so

The excess deaths' multiple over COVID-19 death toll between 2.8 to 4.1 times for the State (without six districts in the analysis) is comparable to those for southern States such as Karnataka (4.3), Tamil Nadu (6.4 adjusted to 4.4 if CRS COVID-19 tally is considered), besides the northern State of Punjab (3.3), but is lower than that for Madhya Pradesh (23.8) and Andhra Pradesh (17.9), West Bengal (11.1 without five districts) and Haryana (7.3) if the same baseline is considered (deaths registered in 2018 and 2019). Only Himachal Pradesh (1.9) and Kerala (0.42 based on the reconciled COVID-19 tally) had much lower multiples.

The total number of excess deaths for these States (using the same baseline) for the period April 2020 to May 2021 was 12,21,049, which is 6.27 times the official CO-VID-19 tally for the same period (1,94,818 deaths). Note, we took the higher end multiple of 4.1 for Maharashtra

Murad Banaji, a mathematician who has been tracking COVID-19 numbers and has analysed excess deaths for Mumbai, told *The Hindu*, "The data confirms that Maharashtra has been hit badly by the pandemic. But there are no major surprises. The scale of excess mortality is roughly as expected from the level of spread of the virus and COVID-19 fatality rates. And this is precisely the story coming out of civil registration data from many other

"The data suggests that differences between States' official COVID-19 death counts often reflect better or worse surveillance as much as the epidemic itself. In fact, Maharashtra has probably

tracked its COVID-19 deaths better than many States. Although excess deaths could be three to four times the recorded COVID-19 deaths, this is much better than the national average. Interestingly, district-level data shows that there are no major differences in rural and urban death surveillance," he added. Pradeep Awate, Maharash-

tra's State Surveillance Officer, said Maharashtra has always followed the principle of transparency in case of collecting data regarding CO-VID-19 deaths. "If we undermine or hide the real numbers, we will fail to prepare for and counter the pandemic," said Dr. Awate, while speaking to *The Hindu*. (Data compiled and

Our work is to govern and provide welfare goods to everyone without any discrimination and to get everyone treated equal before law, says Uttar Pradesh Chief Minister

As Uttar Pradesh heads to an Assembly election in 2022, Chief Minister Yogi Adityanath details his government's achievements in social welfare as well as improved law and order, insisting that controversial laws were necessary for good governance. Excerpts:

What are the achievements that you want to mark out as we near the end of your

■ Today Uttar Pradesh is among the States aspiring to reach high levels of development. Otherwise one would hear only of riots, law and order problems, corruption the perception was such that no good person wanted to come here. Under earlier governments, there was no coordination between the Centre and the State over welfare programmes, especially after 2014. The Swachch Bharat Mission saw only 44 lakh toilets being built in its first 2.5 years; in the next 1.5 years, we built 2.61 crore toilets. The result was that we found in 38 janpads, there was a dip in the incidence of encephalitis.

What you call law and order

involved encounters, that have led to communities such as Brahmins and Muslims feeling targeted... Also, the indiscriminate use of laws that have led to incarceration of journalists

First of all let's differentiate between all the things you have just said. State police have taken steps according to the law to establish or-The Deputy Superintendent of Police who died in Kanpur, was he not a Brahmin? The other policemen in that team in Kanpur who were killed, do they not have children who grieve for their fathers? Justice has to be equal for all and we cannot look at it in the prism of caste, community. When we are in government, we must be ready to do justice for the law abiding citizen. We haven't imposed NSA in wrong cases, and we have provided the basis why we have done so in certain cases, both in the courts and in the advisory boards. In most cases, these have been upheld.

And you made contentious laws like the one on attachment of property in case of damage to public property... These have been challenged for violation of fundamental rights...

■ Every person has the right to go to court, I cannot stop them. The thinking behind these acts, however, has been justified, that there should be rule of law and it is important that every citizen respects the law. In the name of the Citizenship Amendment Act (CAA) when there was a conspiracy to riot in the State, we had to bring the ordinance on property damage and take action.

ryone without any discrimination and to get everyone treated equal before the law. If anyone has broken the law, then the government has come down heavily on them, and the common man has seen action against law breakers. Under the Gangsters Act, we have confiscated property up to ₹1,600 crore of big mafia members. This is necessary to rein in those who think they can break the law with impunity.

 One should not exaggerate something unless they have authentic information. From day 1, I have been involved with the COVID management. On a normal day, in a 500-bed hospital, the persons getting oxygen would be barely 10-12. In the second wave, the spread was so sudden, that a situation of panic was created. In many places, people reserved beds for themselves in hospitals, making their staff occupy the beds. Those people who created panic are no less responsible.

But your own MLAs raised an alarm...

■ When you create a panic situation among the public, and the public starts making noise, these people (MLAs) are under compulsion to speak in the same tone. The fact is that patients from one half of Delhi were in hospitals here (in Uttar Pradesh). The oxygen of Uttar Pradesh in G.B. Nagar and Ghaziabad was diverted to Delhi on the direction of the Delhi High Court. Even then we did not deny them. The Central government provided us oxygen from other places.

Were you offered a position in Delhi when you met Prime Minister Modi recently?

■ No. I was not. We met over issues related to the State. I met him earlier too and frequently seek his advice on governance issues.

The BSP is telling Brahmins that you are against them...

■ Since when is the BSP a champion of Brahmins? Their old slogans reflect their attitudes. Neither SP or BSP has the right to speak about social cohesion as they have advocated conflict between communities. They are trying to hunt for their lost social base, which has come to the BJP.

The protesting farmers in west Uttar Pradesh might be threatening your Hindu unity plank...

■ The work done by the Cen-

tral government led by Modiji in the last seven years for farmers was not been done after Independence. Be it crop insurance, irrigation works, real Minimum Support Price or the Kisan Samman Nidhi.

Before 2017, there was no procurement in Uttar Pradesh. From 2007-2017, sugarcane payouts were only ₹95,000 crore. After our government came, we have made payments of ₹1.4 lakh crore. If this kisan andolan was connected to the interests of farmers, then possibly they could have had the support. This is a politically motivated campaign that will not succeed. In the recent panchayat elections, barring Baghpat, the BJP won all seats in west Uttar Pradesh.

Are you primarily religious or political?

■ The first part of my personality is dharm, which for me is not worship and rituals but also a duty. It inspires me to work in the interest of the country and society.

Editors Guild moves SC for probe into snooping

'Press freedom must be safeguarded'

The Editors Guild of India on Tuesday moved the Supreme Court seeking a special investigation team (SIT) probe into the Union government's role in the Pegasus snooping row. It has stated that the "indiscriminate use" of top-end surveillance technology against journalists destroys free speech and "poisons the heart of democracy".

The Guild pointed out that freedom of the Press is a hard-won right essential to democracy.

"Freedom of the Press relies on non-interference by the government and its agencies in the reporting of journalists, including their ability to securely and confidentially speaking with sources, investigate abuse of power and corruption, expose governmental incompetence, and speak with those in the Opposition," the petition, filed through advocate Lzafeer Ahamed

The petition follows the one filed by senior journalists N. Ram and Sashi Kumar, challenging the government to come clean about the Pegasus allegations. Rajya Sabha member John Brittas and Supreme Court lawyer M.L. Sharma have

separately moved the court. Journalists Paranjoy Guha Thakurta, SNM Abdi, Prem Shankar Jha, Rupesh Kumar Singh and Ipsa Shataksi, reported to be victims of Pegasus surveillance, had also moved the court, saying they were subjected to "deeply intrusive surveillance". A Bench, led by Chief Justice of India N.V. Ramana, is scheduled to hear the Pegasus row petitions

on August 5. On Tuesday, the Guild said a court-monitored probe should look into "every aspect of the use of Pegasus by the government against Indian citizens, especially journalists".

Questions and attempts to garner the truth from the government have reached a dead-end. In fact, the government had "stonewalled" efforts to seek accountability, the petition said. The government had "deliberately avoided" public debate on the issue. It had only provided some "obfuscated answers" to straight questions about its alleged role in the snooping,

vernor on his own. 'The advice of the appropriate government binds the Head of the State," Justice Gupta observed in the judgment which referred to the Supreme Court's Constitution Bench judgment in the Rajiv Gandhi assassination case on the power of remission. "The action of commuta-

tion and release can thus be pursuant to a governmental decision and the order may be issued even without the Governor's approval. However, under the Rules of Business and as a matter of constitutional courtesy, it may seek approval of the Governor, if such release is under Article 161 of the Constitution," the court noted.

'Improve social security for workers'

Pandemic has made matters worse for women, the young, self-employed, and migrants: panel

SPECIAL CORRESPONDENT

Direct transfer of money into bank accounts of informal workers and an urban employment guarantee scheme were among the recommendations of the Parliamentary Standing Committee on Labour in its report on the impact of the pandemic on rising unemployment.

The report, which was presented in the Lok Sabha and tabled in the Rajya Sabha on Tuesday, said, "The pandemic has devastated the labour market, denting the employment scenario and threatening the survival of millions of workers and their families." The panel, which is chaired by Bhartruhari Mahtab, called on the government to improve social security measures for workers.

Citing the Periodic Labour Force Survey (PLFS), the report said 90% of workers were in the informal sector, which is 419 million of the 465 million workers. The PLFS quarterly bulletin for April-June 2020 showed the unemployment rate in urban

areas for those above 15 years at 20.8%, an increase from 9.1% in January-March

The committee noted that the PLFS data for years prior to the pandemic were available and the real impact of COVID-19 would only be seen when the PLFS for 2019-2020 and 2020-2021 are available.

"Although no survey data are available as vet on the impact of the second wave which has undisputedly been more severe than the first, anecdotal evidence as well as the situation experienced during the first wave suggest that there would have been significant income losses particularly in the informal sector, pushing the vulnerables deeper into crisis," the report said.

The panel said it was of the "studied opinion that the COVID-19 crisis in India has come in the backdrop of preexisting high and rising unemployment".

'COVID-19 in children occurs mostly for a short duration'

Headache, fatigue are most common symptoms, says study

Most children who develop symptoms of COVID-19 get better after six days and the number who experience symptoms beyond four weeks is low, according to a new study conducted in the U.K. and published on Tuesday in The Lancet Child and Adolescent Health.

The study was carried out by researchers from King's College, London; University College, London; Newcastle University; and the London School of Hygiene and Tropical Medicine, among others. The researchers used data collected through a mobile application, which includes information from more than 2,50,000 U.K. children aged five to 17 years. The team focused on 1,734 children whose reports were collected between September 1, 2020 and February 22, 2021.

The study found that most children were ill for an average of six days. The

most common symptoms were headache (62.2%) and fatigue (55%).

Most children recovered within four weeks, with a minority (4.4% or 77 out of 1,734) experiencing symptoms after a month.

Those who took longer than a month to recover showed up to six symptoms during the first week of illness. The median symptom burden in these children was six symptoms during the first week of illness. However, after day 28, the median symptom burden was low, at two symptoms. The most common symptoms experienced by these 77 children over their entire illness were fatigue, headache, loss of smell and sore throat. However, headache was more common early in illness, while loss of sense of smell tended to occur later and to persist longer.

Of the 1,379 children who developed symptoms at least two months before the end of the study period, fewer than 2% experienced symptoms for longer than eight weeks (1.8%, 25/1,379).

Locals in southern Assam's Barak Valley have indefinitely blocked the roads leading to Mizoram following the July 26 border clash in which six Assam policemen and a civilian were gunned down allegedly by Mizoram police and armed civilians. The department has issued an appeal that read: "If we curtail our consumption by a bit, there will be enough for all for a longer time."

For doctors, no work should go unpaid: SC

'State cannot plead financial stress'

The Supreme Court on Tuesday held that the government cannot plead financial stress to avoid paying doctors their salaries or arrears. The State's credo towards its doctors should be "no work should go unpaid" and not "no work, no pay", a Bench of Justices L. Nageswara Rao and Hrishikesh Roy said in a judgment. The case concerned

North Delhi Municipal Corporation's reluctance to pay salary arrears to AYUSH doctors after their superannuation age was enhanced from 60 to 65 years. "These doctors have been providing service to countless patients, without remuneration or benefits. Their services are utilised by the employer in government establishments, without de mur... The State cannot be allowed to plead financial burden to deny salary for the legally serving doctors," Justice Roy, who authored the verdict, observed.

Any discrimination between AYUSH doctors and their allopathic counterparts would be violative of the former's fundamental rights to equality and dignity. The remarks came after the Corporation argued that the enhancement in service age was applicable to only allopathic medicine practitioners under the Central Health Scheme (CHS) and

not doctors who treat with alternative medicine.

But the court disagreed. The mode of treatment by itself under the prevalent scheme of things does not qualify as an intelligible differentia, it noted. Justice Roy said distinguishing doctors because of their fields of medicine amounted to unreasonable classin and discrimination".

The court also highlighted an order of AYUSH Ministry of November 2017 which had extended the age of superannuation to 65 years. "We have no hesitation in holding that the respondent - doctors [AYUSH doctors] are entitled to their full salary arrears and the same is ordered to be disbursed, within eight weeks from today. Belated payment beyond the stipulated period will carry interest, at the rate of 6% from the date of this order until the date of payment," it ordered.

'Steep decline in cross-border firing'

Only 664 cases of ceasefire violations till June, says MHA

A steep decline in cross-border firing by Pakistan was recorded in Jammu and Kashmir till June, compared to the number of ceasefire violations reported in 2020, according to the Ministry of Home Affairs (MHA).

In a written reply to questions from Lok Sabha members Asaduddin Owaisi and Krishna Pal Singh Yadav, Minister of State for Home Affairs Nityanand Rai said 664 ceasefire violations were re-

Agency and enjoyment

Sastras are meant to benefit the jivatmas caught in samsara. In every birth the jivatma is compelled to act and this entails his experiencing the fruits of his action. So whatever birth the jivatma takes, he automatically becomes the doer and the enjoyer.

Among the many sutras in the Brahmasutra that discuss the identity of the soul, the sutra 'Karta Sastrarthavatvat,' establishes that agency and enjoyment are for the soul, though this is not its nature, pointed out Sri Mani Dravid Sastrigal in a discourse. All the Vedic injunctions and dharmas prescribed for the jivatma are for the individual deha dharma. These instil the knowledge to do certain acts and refrain from certain others. If the jivatma has to experience karma phala, he needs the sarira, indriyas and manas. Sarira means the sthula and the sukshma sarira with which the jivatma interacts with the external world. The actions are done by the sthula and sukshma sarira, or by the mind or by using the sense organs. For instance when one speaks he uses the organ of speech. All punya and papa are owing to these sadanas. With all these he is the karta.

According to Sankhya theory, doership rests only with the Buddhi and not the soul. This is opposed by Vedanta theorists who point out that Buddhi belongs to the inanimate category. The soul, in association with the body, brings about the possibility of action and also the enjoyment thereof. But the soul remains unaffected, though it becomes both the agent and enjoyer owing to association with the body. The famous verse in Katopanishad compares the senses to horses; the objects of enjoyment to the paths they range over, while the Self associated with the body comprising the senses and the mind is shown to be the enjoyer.

Raisi inaugurated as President of Iran

He says he will seek to 'lift oppressive sanctions, but won't tie Iran's well-being to the will of foreigners'

Ebrahim Raisi was on Tuesday inaugurated as President of Iran, a country whose hopes of shaking off a dire economic crisis hinge on reviving a nuclear deal with world powers.

"Following the people's choice, I task the wise, indefatigable, experienced and popular Hojatoleslam Ebrahim Raisi as President of the Islamic Republic of Iran," Iran's Supreme Leader Ayatollah Ali Khamenei wrote in a decree read out by his chief

Mr. Raisi, a conservative, replaces moderate President Rouhani, whose landmark achievement was the 2015 nuclear agreement between Iran and six major powers.

From the outset, Mr. Raisi will have to tackle negotiations aimed at reviving the

nuclear deal from which the US unilaterally withdrew imposing sweeping sanctions.

New York Governor sexually harassed multiple women: A-G 'Cuomo's office a toxic workplace that enabled harassment'

A five-month investigation has found that New York Governor Andrew Cuomo sexually harassed multiple women in violation of federal and state law, creating a "climate of fear" within his office, State Attorney General Letitia James said Tuesday.

The independent inquiry showed that Mr. Cuomo engaged in unwanted groping, kissing and hugging, and made inappropriate comments, Ms. James told a press briefing, adding that the Democratic Governor's office had become a "toxic workplace" that enabled "harassment to occur".

The findings, detailed in a scathing 168-page report, could deal a devastating blow to Mr. Cuomo's political future and hinder his administration, although the probe was civil in nature and will not directly lead to criminal charges against him.

"Specifically, the investigation found that Governor

Andrew Cuomo sexually harassed current and former New York State employees by engaging in unwelcome and non-consensual touching and making numerous offensive comments," said Ms. James, a Democrat.

There was no immediate comment from the Governor's office. Mr. Cuomo, 63, has denied wrongdoing.

There was also no immediate comment from Carl Heastie, the Speaker of the Democratic-controlled New York Assembly, who had authorised an impeachment investigation into Mr. Cuomo. Mr. Heastie has previously said that lawmakers

incorporate Ms. James' findings into their impeachment probe.

Investigators spoke to 179 people, including complainants and current and former members of the executive chamber, Ms. James said. She said the probe resulted in a "deeply disturbing yet clear picture" of what she called a "climate of fear", in which Mr. Cuomo sexually harassed multiple women, many of them young.

Ms. James launched her investigation into the allegations after receiving a formal request from Mr. Cuomo's office on March 1 to do so as the number of publicly reported allegations mounted.

The report shows that investigators did not find Mr. Cuomo's explanations about his encounters to be credible. It said Mr. Cuomo's "blanket denials and lack of recollection as to specific incidents stood in stark contrast to the strength, specificity, and corroboration of complainants'

Army urges Afghans to evacuate city

As fighting rages in Lashkar Gah, UN says at least 40 civilians killed in 24 hours

Residents were urged on Tuesday to evacuate a besieged Afghan city as the Army prepared a major offenagainst insurgents after three days of heavy fighting.

The Taliban have seized control of much of rural Afghanistan since foreign forces began the last stage of their withdrawal in May, but are now focused on capturing provincial capitals, where they are meeting stiffer resistance.

Fighting is raging for Lashkar Gah, the capital of southern Helmand province, with the United Nations saying at least 40 civilians were killed in the last 24 hours.

Israeli SC offers compromise to avoid Palestinian evictions

Families reject proposal granting them 'protected' status

Israel's Supreme Court has floated compromises that would block the evictions of dozens of Palestinians in the east Jerusalem town of Sheikh Jarrah, where attempts by Jewish settlers to expel them from their homes sparked an 11day war between Israel and Gaza militants in May.

The cases examined on Monday involve four Palestinian families, numbering a total of about 70 people.

The settlers have been waging a decades-long campaign to evict the families from densely populated Palestinian neighbourhoods just outside the walls of the Old City, in one of the most sensitive parts of east Jerusalem.

Jews prior to the 1948 war surrounding Israel's creation. Israeli law allows Jews to reclaim such property, a right denied to Palestinians who lost lands and homes in the same conflict. The Palestinians say they have owned the properties for decades.

During Monday's hearing, the Supreme Court proposed a pair of compromises, according to Ir Amim, a human rights group that supports the Palestinians and which sat in on the hearing.

It said the first proposal offered the residents "protected" status, meaning they would be protected from eviction for years in exchange for recognising the settlers' ownership over the land. This offer would allow the four families the right to pass down their properties for two generations.

But after the four families rejected the proposition, the court proposed an alternative settlement where the four families would receive protected status while instead acknowledging that Israel once registered the properties with previous Jewish owners, according to Ir Amim.

It said the settlers rejected that proposal, while the families asked for more time to consider it.

The death of a 20-year-old Indian student in China's Tianjin city was a homicide and a foreigner has been arrested in connection with the murder, the Chinese Foreign Ministry said here on Tuesday.

The suspect's nationality has not been disclosed, officials said.

Aman Nagsen, who hailed from Bihar's Gaya, was a student of Business Administration at the Tianjin Foreign Studies University. He was found dead on July 29.

The Chinese Foreign Ministry, in a written response to PTI, said that around 8 p.m., Tianjin police received a call that an "Indian student was lying on the floor of the dormitory with no sign of life".

'The initial investigation of the public security organ found it to be a case of homicide and the suspect is another foreign student of the university. Compulsory measures

have been taken on the suspect and the case is still under further investigation.

"Relevant Chinese competent authorities have notified the Indian Embassy in Beijing of the situation of the case on July 30 and 31 respectively and maintained communication with the Embassy," it said.

The Chinese side will handle the case in accordance with law and offer assistance in follow-up matters, it said, adding that an autopsy was conducted on Tuesday.

The issuance of the death certificate is expected to take a few days as it is a case of homicide, the officials said.

Nagsen was one of the few Indian students who remained in China through the coronavirus pandemic while most of the 23,000 odd Indian students, who left for home, were stuck in India, unable to return due to Beijing's reluctance to lift visa restrictions.

Insolvency code has strayed from intent: Parliament panel

Committee seeks IBC review; flags low recovery rates, delays, vacancies in NCLTs

The Parliament's Standing Committee on Finance has sought a review of the design and implementation of the Insolvency and Bankruptcy Code (IBC) as it has deviated from the original intent and questioned the low recovery rates, long delays in the resolution process and the high number of vacancies in the National Company Law Tribunals (NCLTs).

The panel, chaired by the BJP's Jayant Sinha, stressed that the low recovery rates under the IBC 'with haircuts as much as 95% and the delay in resolution process with more than 71% cases pending with NCLT for more

than 180 days, clearly point towards a deviation from the original objectives of the Code'. In a report tabled on Tuesday on the 'Implementation of IBC - pitfalls and solutions', the Committee noted that the Code had un-

dergone six amendments since its introduction in 2016, but the operationalisation of these changes 'may have altered or even digressed from the basic design of the statute'. Calling for a thorough evaluation of the extent of fulfilment of the Code's original aims, the panel said the fundamental aim of the statute was to secure creditor rights so as to reduce borrowing costs with the reduction of risks. It also suggested a benchmark be put in place for the quantum of "haircuts" to be taken by creditors. It expressed apprehensions over fresh graduates appointed as Resolution Professionals (RPs).

Disciplinary action had been taken in the case of 123 RPs out of 203 inspections conducted so far, it pointed out. It said it was concerned over the NCLT functioning without a President, and 34 members short of its sanctioned strength of 62.

Nifty scales 16,000 on hopes of faster economic recovery

Titan, HDFC lead gains as GST, export data buoy sentiment

The Sensex and Nifty rose to record closing highs on Tuesday, with the NSE's 50company benchmark closing above the 16,000 level amid renewed investor interest in stocks on bets that the economy may recover faster than anticipated earlier.

The S&P BSE Sensex gained 872.73 points, or 1.65%, to 53,823.36 while the NSE Nifty 50 added 245.60, or 1.55%, to end at 16,130.75.

On the BSE, the top gainers included Titan, which rose 3.89%, HDFC, up 3,72%, Nestle, IndusInd Bank and UltraTech Cement. Majority of the sectoral indices reported gains except for media and metals.



"Volumes on Nifty were higher than average which indicates strength," said Gaurav Udani, CEO & Founder, ThincRedBlu Securities. "We can expect Nifty to touch 16,250 and 16,400 in the coming days. On the lower side 15,950 and 15,880 will act as strong support,"

"The journey 16,000... quite clearly has been led by the retail investors who have allocated more into equities," said Mr. Ranganathan.

"The present rally is all the more significant since it provides enough opportunities to the new investor coming in now as several pockets of the economy still offer value going forward," he added.

Domestic funds had invested ₹28,000 crore into stocks in the first four months of the current fiscal, Mr. Ranganathan noted.

No error of judgment in HFC deal: PNB MD

'SAT order to set future course of action'

Asserting that there was no error of judgment with regard to the fund-infusion decision of PNB Housing Finance Company (PNB HFC), Punjab National Bank MD S. S. Mallikarjuna said the future course of action would depend on SAT's order.

The Securities Appellate Tribunal (SAT), after hearing all parties related to PNB Housing Finance-Carlyle deal, has reserved its orders. PNB currently holds a 32.6% stake in PNB HFC.

Under the deal announced on May 31, the U.S.-based Carlyle, alongside other investors, is slated to infuse ₹4,000 crore



capital into PNB HFC through the issue of preference shares and warrants.

However, the deal has come under the scanner of capital markets regulator SEBI. The firm was told to carry out the share-valuation process as per legal provisions. PNB HFC contended it had followed SEBI norms in deciding the issue price at ₹390 apiece.

PepsiCo to sell juice brands in North America

PepsiCo Inc unveiled a \$3.3 billion sale of its Tropicana and other juice brands in North America to French private equity firm PAI Partners on Tuesday, as it looks to simplify its product range and move away from high-sugar drinks. The company, which

bought the orange juice maker in 1998 for roughly \$3.3 billion and U.S.-based Naked Juice for \$150 million, will keep a 39% stake in the new JV and have exclusive U.S. distribution rights for the brands. The sale will give PepsiCo funds to develop its portfolio of health-focused snacks and CEO Ramon Laguarta said.

Bharti Q1 revenue climbs 15% as data, subscriber additions buoy

Telco adds 46.1 million 4G customers, ARPU rises to ₹146

Telecom services major Bharti Airtel Ltd. posted a 15% rise in first-quarter revenue on Tuesday, helped by higher data usage during CO-VID-19 restrictions and by subscriber additions.

The company reported a consolidated revenue of ₹268.54 billion for the quarter ended June 30, compared with ₹232.90 billion a year earlier.

Adds 4G users Bharti said the number of 4G

customers increased by 46.1 million from a year earlier, reaching 184.4 million users.



The telecom industry, now dominated by Reliance Jio and with some major players like Bharti battling a court case over dues owed to the government, has benefitted from increased data usage during the COVID-19 pandemic due to remoteworking trends. Bharti's quarterly mobile

average revenue per user (ARPU), a key metric for telecom companies, increased to ₹146, from ₹138 a year earlier. In the previous quarter, ARPU was ₹145.

Turns a profit

Net profit came in at ₹2.84 billion, compared with a loss of ₹159.33 billion in the yearearlier quarter, when it accounted for exceptional charges of ₹117.46 billion including provisions for li-

Floor prices for data are critical: COAI

Industry association COAI on Tuesday contended that fixing floor prices was 'absolutely critical' and the need of the hour, given the 'major financial stress' in the telecom industry.

The association said floor prices needed to be fixed for data only for an interim period, say two years, and that voice calls could be excluded. "Telcos have incurred losses because of the downward pricing trend of data tariffs... revenue generation is now essential," S.P. Kochhar, director-general of Cellular Operators' Association of India (COAI), said in a statement.

Net non-performing assets (NPA) decreased 6.4% to ₹12,424 crore, while gross NPA was down 3.02% to ₹56,042 crore

Total provisioning for the quarter was ₹2,086 crore, a 4.26% increase. Out of this, provisioning for NPA was ₹873 crore, up

Provision Coverage Ratio (PCR) at 86.17% improved by 130 bps y-o-y, the bank said in a filing.

'Asset quality pressure to persist for NBFCs'

'Collection efficiency hit, rising now'

The pressure on quality of assets for non-banking fi nancial companies (NBFCs) would persist in the near term and the risk to this sector would remain elevated due to the impact of the CO-VID-19 second wave, ICRA said in a report.

Stating that large housing finance companies had seen relatively limited impact on collection efficiency (CE) during the second wave, the ratings agency said other NBFCs with exposure to the likes of vehicle finance, business loans and microfinance saw CEs decline 20-25% in May 2021 vis-a-vis the average Q4 FY21, when lockdowns imposed by various States were stringent and widespread. The CE improved marginally (rising



3-5%) in June compared with May, with States relaxing restrictions, it added.

"Headline asset quality numbers for June 2021 would be significantly elevated vis-a-vis March 2021, but the same is expected to subside over a couple of quarters if the CEs continue to trend upwards," said A.M. Karthik, V-P, Financial Sector Ratings. With credit costs expected to remain elevated in FY22, earnings may stay subdued, it said.

Roll out flexible fuel vehicles in a year's time'

Union Minister of Road Transport and Highways Nitin Gadkari urged auto makers to roll out flex-fuel vehicles capable of running on 100% ethanol in the Indian market within a vear's time.

Flexible fuel vehicles are designed to run on petrol or petrol-ethanol blends. India plans to achieve 20% ethanol blending by 2025.

He also appealed to all private vehicle makers to compulsorily provide a minimum of six airbags in all vehicles in the interest of passenger safety.

CEOs from the Society of India Automobile Manufacturers have, however, reiterated demand for deferment of fuel efficiency and second stage of Bharat Stage VI emission norms.

It is possible that the most farreaching result at the Tokyo Olympics might have been achieved by gymnast Simone Biles. After all the celebrations are done, and the national revelries completed, one fact will remain: a top athlete, the face of the Olympics, pulled out from the early competition citing mental issues.

One whispers this quietly during the Olympics: sport is not just about taking part, it is about winning. And the pressures are enormous. Living up to expectations can be draining.

In recent years, both public and professional reactions to athletes who recognise a problem and take a break from the sport have become increasingly sympathetic. As India prepare to take on England in a five-Test series, the opposition will be without their most iconic player. Ben Stokes, the extraordinary

all-rounder will miss the series as he takes time off "to prioritise his mental well-being." Even a generation back, top players who had an issue, like Marcus Trescothick, had to face the criticism and confusion of those who didn't under-

Affecting in differnt ways

The pandemic has affected people in different ways. For a sportsman, life in the 'bubble', with movements restricted, distanced from family and friends has increased the pressure.

England played 14 Tests in the past year, beating the West Indies, Sri Lanka and Pakistan while losing to New Zealand and India. In the same period India played nine, winning dramatically in Australia and losing to New Zealand while beating England at

It will not be surprising if more players around the world take breaks to prioritise their mental well-being. Skipper Joe Root has told Stokes that he can take as much time as he needs. Those who are troubled know they will be treated with compassion and that is crucial. Trescothick has written about a teammate "taking my mickey big time". That is unlikely to happen now.

Living up to expectations is an occupational hazard for Indian teams. On the last three tours of England, they were favourites but lost the series each time, 0-4, 1-3,

1-4. That is a sobering thought, even if that last series could have gone 3-2 either way.

Starting issues

A lot will depend on the start. Teams, especially those uncertain of their batting strength tend to carry the extra batter when they go into the first Test of a five-Test series. India's problem is that they are uncertain of their batting, starting with the question of who will accompany Rohit Sharma as opener.


They will have to plump for experience rather than recent performance since none of Cheteswar Pujara, Kohli or Ajinkya Rahane has scored heavily of late, although Rahane did have a century in Melbourne. That will probably give Rahul another chance.

India's golden dreams shattered

Puts up a gallant fight before losing 2-5 to Belgium, meets Germany in bronze medal match

India's quest for an Olympics gold medal in men's hockey after Moscow 1980 ended after it lost to Belgium in the semifinal clash on Tuesday. Belgium's 5-2 win, however, masked how competitive the game was.

Hendrickx Alexander took his tournament tally to 14 goals as he struck a hattrick for the World champion and Rio 2016 silver medallist Belgium.

Early strike

The Belgians got off to a screamer as Loick Luypaert scored with only 70 seconds played. The second-minute goal was the fastest India had conceded this campaign.

However, Graham Reid's team made a comeback as Harmanpreet Singh struck in

India looked good in the scorching conditions before Hendrickx turned on the heat. He scored the equaliser in the 19th minute - a goal that came after Belgium dictated play early in the second

Things unravelled in an engrossing final quarter, fuelled by skipper Manpreet Singh's green card in the 48th minute.

Belgium won three successive penalty corners and Hendrickx came back to haunt the Indian defence as he scored with a drag-flick in the 49th minute.

The 27-year-old completed a hat-trick, his third of the competition, four minutes later as he converted a penalty stroke.

With options and time running out , the Indian camp decided to gamble. Goalkeeper Sreejesh made way for an outfield player. However, it did not change the course of the game as John-John Dohmen scored in the 60th minute to round off a thumping win.

Belgium will take on Australia, a 3-1 winner over Germany in the other semifinal. The Indians will play the Germans in the bronze medal match on Thursday.





The toughest four months of Virat Kohli's eventful leadership career start here on Wednesday when his strategic acumen will be tested while selecting a perfect Indian combination to take on a good England side in the first Test of a five-match series.

Kohli will have to think overtime about the balance of his squad with a long tail, often bushy with runs, and just two openers - Rohit Sharma and K.L. Rahul.

Logical choice

Rahul, with 2000-plus Test runs, looks a logical choice to partner Rohit.

Bengal's Abhimanyu Easwaran had last played a First Class game in March 2020 and, that too, after enduring a horrendous season. Will the team risk him? It would be a huge call.

That brings into the equation Hanuma Vihari, the team's 'all-purpose player', who had once faced the new ball in Australia.

His handy off-spin, along with that of automatic choice R. Ashwin, could also pave the way for Shardul Thakur's entry as the bowling all-rounder in place of an experienced Ravindra Jadeja.

Mohammed Shami is a wily customer and Ishant Sharma still possesses a big heart but they are ageing. Jasprit Bumrah, since his lowerback stress fracture in 2019, is hardly the Test bowler one has come to know but his success in the last series may ensure a start for him.

But where does it leave India's fastest and most in-form bowler Mohammed Siraj, whose raw pace ousted a concussed Agarwal from this Test match?

Kohli's team selections in England last time left a lot to be desired as Kuldeep Yadav was picked to play on a Lord's green top where he looked like a lamb for slaughter. Similarly baffling was his decision to ignore a pacer in overcast conditions in his bid to shore up the batting with Jadeja's presence even though he had to be under-bowled.

Adequate preparation

Rahul's hundred in the last First Class game and adequate preparation time would keep him in good head space

Kohli was a part of the 2014 team when it lost 1-3 and the then vice-captain had a torrid time with the bat. He came back determined in 2018, scored truckloads of runs but a poor team choice at Lord's and one bad batting session in Southampton meant that under him, India lost 1-4.

The Indian captain would walk out with his band of men against a side that has two artists of red Dukes at work in James Anderson and Stuart Broad.

The veterans will be complemented by one of the world's fastest bowlers in Mark Wood and a smart apprentice in Ollie Robinson.
