# Post talks, India, China pull back troops from Gogra

#### Second such disengagement after February

India and China have undertaken disengagement from Gogra area of eastern Ladakh following an agreement at the 12th round of Corps Commander talks, the

Army said on Friday. This is the second friction area from which disengagement has been carried out after Pangong Tso in February as part of efforts for overall disengagement and deescalation along the Line of Actual Control in eastern Ladakh to end the standoff that

# SC backs Amazon plea against Future-Reliance merger plan

Court upholds the validity of a Singapore-based arbitrator's award

The Supreme Court on Friday ruled in favour of e-commerce giant Amazon against the proposed ₹24,713 crore merger deal between Future Retail Limited (FRL) and Re-

liance Retail. A Bench of Justices Rohinton F. Nariman and B.R. Gavai upheld the validity and enforceability of a Singapore-based Emergency Arbitrator (EA) award, which restrained FRL, India's second largest offline retailer, from going ahead with the disput-

# Delhi govt. bats for reopening

of schools SPECIAL CORRESPONDENT

NEW DELHI The Delhi government on Friday made a pitch for reopening educational institutions in the Capital at a meeting of the Delhi Disaster Management Authority (DDMA) to review the CO-

VID-19 situation in the city. Sources in the Delhi government said that during the meeting, Deputy Chief Minister Manish Sisodia contended that the closure of schools had led to major loss of learning and it was

time to reopen them. He submitted that out of eight lakh parents who attended parent-teacher meetings, held over two weeks at Delhi government schools, 90% wanted schools to reopen.

The Minister had invited students, parents and teachers to submit suggestions on whether schools should reopen. Sources in the Delhi government said that 33,000 people sent their suggestions out of which 58% want educational institutions to reopen. Out of the people who want reopening of institutions, 68% want schools and 83% want colleges to reopen.

Sources said that it was decided in the DDMA meeting that an SOP should be prepared and given to an expert committee so that schools could reopen. Experts have stressed that schoolteachers and employees should be vaccinated before any reopening.

#### Mahapanchayat held for aborting construction of Haj House

STAFF REPORTER

Scores of people gathered in Dwarka sector 22, where the government has allotted land for the proposed construction of Haj House, demanding its cancellation. Calling the event a 'Mahapanchayat', protesters chanted slogans during the two-hour agitation.

Ajit Swami, president of All Dwarka Residents' Federation - which along with neighbouring villages and right wing outfits - said the allotment should be cancelled because they don't want the government to spend money only on one religion. "There are so many communities in Dwarka and Muslim population is the least. Why should the government spend crores on building for members of one community? They should build something that can be used by all - like a hospital or a school," he said, adding that the government will spend money on maintaining the place as well "which is not right".

The body had earlier sent a letter to Lt. Governor Anil Baijal. "There is a strong apprehension that brotherhood, harmony and peace in the society, apart from law and order, will be disturbed if the Haj House is allowed to be constructed in Dwarka," it stated.

DCP (Dwarka) Santosh Kumar Meena said that an FIR has been registered under relevant Sections as DDMA guidelines on CO-VID-19 were flouted.

# Kejriwal, Puri flag off services on 'missing link' of Delhi Metro

Mayur Vihar Pocket 1-Trilokpuri Sanjay Lake stretch makes Pink Line longest corridor

Union Minister Hardeep Singh Puri and Chief Minister Arvind Kejriwal on Friday flagged off metro services on the Mayur Vihar Pocket 1-Trilokpuri-Sanjay Lake stretch of the Pink

With passenger operations commencing on this section, the Pink Line is now 59 km long with the corridor linking the northern and eastern parts of the Capital with markets, transport hubs and hospitals in south and central Delhi.

Mr. Puri said, "The Delhi Metro rail system has delivered a world-class transportation system to our citizens. This expansion has taken place with the least possible disruptions. While the stretch might look small in terms of network length but connectivity will play an extremely crucial link.

Thereafter, trains will move with regular speed on this stretch too, eliminating the need for speed restriction," the DMRC said. Commuters on this line will be able to access transit hubs like Nizamuddin Railway Station, Sarai Kale Khan ISBT, Anand Vihar Railway Station and ISBT and markets like Dilli Haat- INA, Sarojini Nagar and Lajpat Nagar.

The Delhi Metro network now spans across 390 km with 285 stations, including the Noida-Greater Noida Agua Line and Rapid Metro Gurugram.

### SCERT adopts framework of Deshbhakti Curriculum

Aim is to instil pride for India: Delhi govt.

The governing council of State Council of Educational Research and Training (SCERT) on Friday adopted the framework of the new 'Deshbhakti' curriculum, which the Delhi government is planning to introduce this academic year.

The government said the primary aim of the curriculum is to instil "love and pride" for India, build awareness of one's responsibilities and duties towards the country, and commitment to make sacrifices for India.

The government said the details on the curriculum would be released in a few days. It added that the curriculum is proposed to be transacted through discussions, reflections and activities facilitated by the teachers.

Deputy Chief Minister Manish Sisodia said: "It is imperative that we bridge the gap between values and actions and ensure that constitutional ideals of equality, fraternity and justice are practiced by children in their everyday lives."

During the 2021 Delhi Budget, Mr. Sisodia had announced the introduction of the 'Deshbhakti Curriculum'

to instil the spirit of patriotism and nationhood among every child studying in Delhi government schools.

The government said the Deshbhakti Curriculum Framework was presented by the SCERT Director Rajanish Kumar Singh, based on the recommendations of the Deshbhakti Curriculum Committee along with its aims, objectives and pedagogical process.

Speaking about its connection with the National Education Policy 2020, Chairperson of the Committee Renu Bhatia, Principal, Sarvodaya Kanya Vidhyalaya Moti Bagh, said: "The curriculum aims to develop a deep sense of respect towards the Fundamental Duties and Constitutional values, bonding with one's country, and a conscious awareness of one's roles and responsibilities, as highlighted in the NEP"

The pedagogical discourse of the curriculum has been based on the guiding principles of the National Curriculum Framework 2005, and follows child-centric and critical pedagogies.

It focuses on connecting to children's lives outside of school as well.

#### Make sure citizens get 24x7 water supply: CM

"The Delhi government will not make any false promises to the people of Delhi. Officers should have a complete understanding of the on-ground reality and what we can deliver," Mr. Kejriwal said.

## 4 persons held for heroin supply across NCR, U.P.

Drugs worth ₹48 cr. recovered from them

The police arrested four persons for allegedly supplying heroin, said officials on Friday. They recovered heroin worth ₹48 crore in the international market from the accused. DCP (Special Cell) San-

jeev Kumar Yadav said the accused have been identified as Shahnawaz Hussain (25), resident of Bareilly in Uttar Pradesh, Sachin (32) from Delhi, Abdul Razzak (44) and Mohammad Idrish (50) both residents of Manipur.

A total of 12kg contraband has been recovered from their possession, he said.

"On Thursday, the police got information that Hussain will come to Rajapuri, Delhi in a truck to supply heroin to Sachin. Thereafter, a raid was conducted and the accused were nabbed at around

8.50 a.m.," Mr. Yadav said. Later, information was received that Razzak and his accomplice would come near Netaji Subhas Marg to supply heroin. The police then nabbed

Razzak and Idrish.

Sachin said he used to procure heroin from Razzak through his carrier Hussain and further supplied it to various peddlers drug

Delhi-NCR. Razzak said he has established links with drug suppliers in Myanmar and peddlers operating in U.P. and Delhi.

He used to receive huge consignments of crude heroin from Myanmar after which they used to process it to make fine quality heroin, the police added.

# Two held for cheating people on the pretext of food and liquor delivery

Before pandemic, accused used to dupe customers on OLX

Two Mewat-based persons have been arrested for allegedly cheating people on the pretext of delivering liquor and food, the police said on Friday. Deputy Commissioner

of Police (North) Anto Alphonse said the accused have been identified as Tarif Khan and Taufiq, both residents of Rajasthan's Bharatpur.

Cheated of over ₹80K

The police said one Amit Saini complained to them that he was cheated by a person of ₹82,500 in the name of providing food packets.

The complainant was looking for food delivery for a retirement programme in his office when he contacted a number mentioned that he found on Google for home deliv-

ery.
"The accused introduced himself as employee of the food joint [a sweet shop] and sent a bar code to the complainant for advance payment. Af-

ter scanning the code, the complainant saw that ₹82,500 was deducted from his account in four different transactions." Mr. Alphonse said.

During technical investigation, it was found that money was transferred from a UPI ID into the Bank Accounts of Mewat.

Fake mobile numbers

Technical investigation of the mobile phones revealed that fake numbers of Odisha were used in the offence, which was having locations of Mewat, Haryana, Bharatpur Rajasthan and Khamman Telangana. During probe, the ac-

cused were nabbed from near Agra when they were driving in a car they had bought using the cheated amount. The accused told the

police that several persons in their village are involved in such crimes. Earlier, they used cheat people on OLX but during the lockdown, they came to know that people are looking for liquor as shops are closed.

Next, he uploaded fake mobile numbers on various websites for home delivery of liquor to cheat people. Accused also disclosed that he has purchased a JCB Machine in Telangana.

# DU defers decision to begin physical classes

The Delhi University (DU) on Friday deferred its decision to begin physical classes for science courses following opposition from several quarters.

The university had on Thursday issued a notice stating that classes for postgraduate and undergraduate science courses would begin from August

In the revised notification issued, DU said, "...the instructions issued for the conduct of classes for PG and UG programmes in respect of science courses in the university and its colleges in physical mode with effect from August 16 has been deferred."

Rest remains unchanged The notice added that the other guidelines mentioned in the first notification remained unchanged.

The August 5 dated notification, issued by DU had stated that departments and colleges will be fully functional with immediate effect. "...It is notified that all

# Man arrested for duping over 60 farmers of ₹3.5 crore

A non-bailable warrant was issued against the accused, who was hiding in Faridabad

STAFF REPORTER NEW DELHI

The Economic Offences Wing arrested a 60-year-old man from Faridabad on August 3 for allegedly duping over 60 farmers on the pretext of giving them higher returns, the police said on Friday.

Prem Chand duped around 64 farmers of approximately ₹3.5 crores, they said. These

farmers sold their crops and grains to his shop in Narela market and since he was in debt due to business losses, he started retaining the proceeds of their crops by inducing them with an assurance of higher returns and issued receipts for the same, they said.

But when farmers started asking for their investments, he fled to Faridabad in Haryana.

An enquiry was initiated against Chand based on a complaint filed by a group of farmers.

Additional Commissioner of Police (Economic Offences Wing) R.K. Singh, said: "Chand had committed the crime in 2017-18. He had assured the farmers that his Narela mandi shop and residence is worth crores of rupees."

"But when the farmers de-

vestment back, he fled the mandi. Subsequently, the farmers came to know that the shopcum-residence of Narela mandi was mortgaged. It was auctioned by the bank. During the course of the investigation, a Non-Bailable Warrant was is-

# L-G takes stock of city's strategies to curb COVID

CM attends meeting; targeted surveillance, testing planned

Lieutenant Governor Anil Baijal on Friday chaired a meeting of the Delhi Disaster Authority Management (DDMA) with Chief Minister Arvind Kejriwal to review the COVID-19 situation in Delhi and the city's preparedness for the coming months.

According to sources present at the meeting, after detailed discussions and deliberations with experts, it was decided to undertake aggressive and targeted surveillance and testing in areas, locations and specific activities to ascertain and address any trends of concern.

Friday's meeting came a day after Mr. Baijal had chaired a similar one with government officials following which Mr. Kejriwal had accused him of holding the meeting "behind the back of the elected government."

perts stressed upon continued vigil and caution while appreciating the efforts undertaken to achieve and maintain the current status. # Tug of war between AAP govt. and BJP may spill beyond vicinity

BJP seeks time from President to discuss functioning of House

The tug of war between the Aam Aadmi Party (AAP) government and the Opposition BJP, so far confined to the Delhi Legislative Assembly, could spill beyond its vicinity over the coming

Delhi Assembly Speaker Ram Niwas Goel on Friday announced that he would approach the Supreme Court to challenge the BJPled Centre's alleged bid to make House Committees through the toothless amended GNCTD Act 2021.

BJP sources said senior leaders from the party's State unit were preparing to throw their weight behind the formation of an expert committee to examine the functioning of the Delhi Assembly - especially the alleged stifling of the Opposition's voice in the House by ruling AAP MLAs - and seeking the framing of "lasting solutions" regarding its functioning in future.

The senior leadership of the BJP's State unit has sought time from President

Ram Nath Kovind and is awaiting the conclusion of the ongoing monsoon session of Parliament to call on Lok Sabha Speaker Om Birla to discuss alleged "irregularities" and "procedural discrepancies" in the functioning of the Delhi Assembly, sources said.

"The Speaker is well within his rights to approach the judiciary on any matter of his choice and so are we; we have sought time from the President and Lok Sabha Speaker to discuss major issues related to the functioning of the Delhi Assembly. No rights of the existing House Committees have been taken away due to the amended GNCTD Act 2021," Leader of Opposition in the Delhi Assembly Ramvir Singh Bidhuri said when asked for

Done away with norms "The only rights which are being trampled upon are those of the elected representatives of the people of Delhi whose representatives, that is the MLAs, are not allowed to raise issues concerning them in the House. This applies as much to ruling AAP MLAs as it does to us," Mr. Bidhuri

From not holding a meeting of the Business Advisory Committee (BAC) prior to a session to not sending Bills scheduled for discussion in the House well in advance to legislators, "significant procedural norms" had been done away with since the AAP government was formed, the LOP alleged.

Opposition MLAs, Mr. Bidhuri further said, were not even allowed to speak or debate issues in the House where a time limit of just 20 minutes had recently been allotted to the LOP to speak. Some Opposition MLAs were told that they would be barred from at tending future sessions for a whole year.

"They have snatched the rights of the Opposition to even speak in the House and then claim that their democratic rights have been trampled upon," he added.

### New excise policy to take revenue up to ₹10K crore'

Govt. has already earned ₹5,300 cr.

Terming it a "smashing success", the Delhi government on Friday claimed its recently-announced excise policy had broken all estimates and targets of revenue generation from the bidding process and is set to take excise revenue figures up to ₹10,000 crore.

According to the government, it has already earned around ₹5,300 crore in the initial rounds where licenses in 20 zones were awarded. A zone-wise revenue of around ₹265 crore is further expected to be received from the bidding of the remaining 12 zones.

**Ending monopoly** 

"Beating all estimates and targets, the 20 zones that have been awarded have already generated around ₹5,300 crore in revenue in

According to the government, the tender process forbids a bidder from bidding in more than two zones, which will bring in more players into the market preventing instances of monopoly. Under the previous excise

policy regime, the yearly growth rates in revenue were limited to 5 to 7% but under the new policy a growth of around 35% is expected and is well on track to achieve, the government stated.

regime, the government said, a total of ₹6,358 crore was collected in the fiscal year 2019-2020 after collection of excise from Indian and foreign liquor, VAT collected from wholesale and retail sales, HCR excise, and retail licensing fees.

Under the new policy in addition to the ₹8,800 crore expected from the auctions, the additional projected revenue after collecting excise, VAT, import fees, CSDN, HCR Licenses, Wholesale Licenses, and HCR VAT will be approximately ₹650 crore, taking the total projected revenue close to ₹9,500

# Goel to move SC against 'snatching' power


Will challenge only portion of GNCTD Act on powers of House panel: Speaker

NEW DELHI Delhi Assembly Speaker Ram Niwas Goel on Friday announced that he would approach the Supreme Court against the BJP-led Centre for allegedly "snatching" the powers of House Committees through the amended GNCTD Act 2021.

A senior Delhi Assembly official said Mr. Goel was scheduled to move the apex court over the issue in his capacity as the Speaker over the coming days after the notification of the Act which gives the Lieutenant Governor more teeth to the city's administration.

"We will approach the Supreme Court on this matter. We will challenge only that portion of the GNCTD Act which is regarding snatching away the powers of the Assembly Committees. We are taking legal opinion on the matter," Mr. Goel said at a

media briefing. The GNCTD Act passed by

the Centre on April 27 this year, which the Speaker termed "a black day", was "unconstitutional" as well as in violation of the July 4, 2018, Supreme Court Constitutional Bench judgment.

Mr. Goel said that the Supreme Court had in July this year given a verdict in favour of the Assembly Committee on Peace and Harmony, which is examining the role of social media platform Facebook in the north-east Delhi riots of February, 2020. Facebook had approached court after the Assembly Committee had summoned its executives in connection with the probe.

"This verdict came after Centre's notification of the GNCTD (Amendment) Act 2021. In the order the court had clearly said that the Assembly and its committees have the power to conduct inquiries and issue summons in this connection," the Speaker said.

Mr. Goel also criticised L-G's alleged directives to government officials to not provide answers to questions on reserved subjects that include land, police and public order. On March 29, 2018, the Speaker said, the L-G wrote to the then Law Secretary who in turn wrote to the Assembly that questions on any reserved subject will not be accepted.

"This was unconstitutional. We know that the House cannot make laws on reserved subjects; but from 1993 to 2018, the Assembly held discussions on such subjects. There are 34 questions which were asked by MLAs on reserved subjects but their answers were never provided," Mr. Goel said.

Two such questions on matters related to services and police were asked by legislators Somnath Bharti and Bandana Kumari in the recently-concluded monsoon session but answers were not provided and this matter, Mr. Goel said, will be sent to the Privilege Committee of the Assembly. He added that the Assembly will make "the act of not answering such questions" as the base and approach of the top court against those provisions of the GNCTD Act which "curtailed" the powers of the Assembly panels.

- (iv) The occupier who intends to get its hazardous and other wastes treated and disposed of by the operator of treatment, storage and disposal facility shall give to the operator of that facility, such specific information as may be needed for safe storage and disposal.
- As per the provisions under Rule 6 of the said HOWM&TBM Rules, 2016, every occupier of the facility who is engaged in handling, generation, collection, storage, packaging, transportation, use, treatment, processing, recycling, recovery, pre-processing, co-processing, utilisation, offering for sale, transfer or disposal of the hazardous and other wastes is required to make an Application in Form 1 for obtaining Authorisation from Delhi Pollution Control Committee (DPCC).

# ED conducts raids in fake COVID testing case during Kumbh Mela

The agency has initiated money laundering probe on the basis of an FIR by police

The Enforcement Directorate has conducted searches at multiple locations in connection with fake entries of COVID testing during the Kumbh Mela in Uttarakhand's Haridwar earlier this

The agency searched the office premises of Novus Path Labs, DNA Labs, Max Corporate Services, Dr. Lal Chandani Labs Private Limited and Nalwa Laboratories Private Limited.

The residential premises of their directors were also searched in Dehradun, Haridwar, Delhi, Noida and Hisar.

The ED has initiated money laundering investigation on the basis of a First Infor-



mation Report registered by Uttarakhand police.

"During the money laundering investigation, it was revealed that the said laboratories were given the contract by the Uttarakhand government for conducting Rapid Antigen Test/RT-PCR tests for COVID during the Kumbh Mela this year," said the agency.

It is alleged that these laboratories barely carried out any tests. They made fake entries and raised bogus bills in order to earn illegal financial gains, as alleged.

"An amount of ₹3.40 crore has already been received by them from the Uttarakhand government as part payment," said the ED.

The accused made multiple entries against mobile numbers and addresses to inflate the data. The tests were shown to have been conducted on persons who had never visited the Kumbh Mela.

Mr. Chhabra was the Congress' city unit president till February this year. He was replaced by Subhash Chawla.

"An upright man shall never tolerate indignation & lies. Knowing when to walk away is #Wisdom, being able to is #Courage, Walking away with your head held high is #Dignity...," Mr. Chhabra wrote on Twitter.

In the past few weeks, Mr. Chhabra had been attacking Mr. Chawla. He also attacked former Union Minister and ex-MP Pawan Kumar Bansal alleging he treated him as a "puppet".

In his resignation letter addressed to Congress chief Sonia Gandhi, Mr. Chhabra said he was resigning from all posts and primary membership of the party.

# Slogans like 'BJMool' created confusion, says CPI(M) note

'It did not benefit the party in West Bengal Assembly poll'

The Communist Party of India (Marxist), in an internal party note, has said slogans such as "BJMool' describing the Trinamool Congress and the Bharatiya Janata party (BJP) as two sides of the same coin have created confusion among the people and did not work for the party in the recent West Bengal Assembly elections.

"The understanding of the CPI(M) is that the BJP is not like any other political party, since the BJP is governed by fascist RSS. This is party's understanding. But during the election some confusion was created that BJP and the TMC were alike. Slogans like BJPMool and calling BJP and TMC two sides of the same coin gave rise to confusion," an internal note circulated by the party earlier this month

The document says the internal assessment of the party is "the BJP and the TMC are never the same. But something that needs to be kept in mind is that from the very start of Trinamool, its registration and the symbol, everything has been done as per instructions of the RSS. One of the characteristics of the BJP is that the party which takes its support it wants to gobble it. In the 2019 Lok Sabha polls, the contest between the two parties is not fixed,"

the statement said.

During the run-up to the 2021 Assembly polls in West Bengal, not only the senior CPI(M) leadership was heard raising slogans like BJMool during the Assembly polls but described the political contest between the BJP and the TMC as "shadow boxing".

**Ideological question** The note titled "Circumstanc-

es during elections and our work" tries to resolve the ideological question which not only the CPI(M) but most of the Left parties in the State are grappling with – who is their bigger enemy in West Bengal, the BJP or the TMC. Political observers feel that several years after the former Chief Minister and veteran communist leader Buddhadeb Bhattacharjee gave the slogan "BJP Hatao Desh Bachao, TMC hatao Rajya Bachao [Defeat BJP to save country, Remove TMC to save State"], the party has not been able to give a new clear message to its supporters.

It has taken two humiliating defeats for the CPI(M) to address the question who their bigger political opponent in the State is. In 2019, the CPI(M)-led Left Front failed to win a single seat of the 42 Lok Sabha seats and in the 2021 Assembly polls also, it failed to win a single Assembly seat.

Many psephologists and

political leaders believe that committed cadres of the Left voted for the TMC to keep the BJP out of power in the State. The 2021 Assembly polls saw a complete decimation of the Left Front with its vote share plunging to a meagre 4.73% and the Left failing to elect any member to the Assembly almost after five decades.

The issue was also discussed by the party leaders in Kolkata on Thursday, the occasion of 133th birth anniversary of Muzaffar Ahmad, one of the pioneering figures of the communist movement in the country. Senior CPI(M) leaders, including State Secretary Surjya Kanta Mishra and Polit Bureau member Md. Salim argued that slogans +such as 'BJMool' were never meant to give the impression that the BJP and the TMC were the same.

'Congshal' terminology

Mr. Salim referred to a terminology "Congshal" used by the Left parties in the 1970s to refer to the Congress and Naxals, who were political opponents of the Left parties.

"Did we not refer to the Congress and the Naxals as Congshal in 1970s? But did it mean they were one? They are two different parties," Mr. Salim said. He argued that such coupling meant that the two political forces complement each other and serve each other's purpose.



#### Rewind to fast forward

Delayed reset on retrospective tax is only the first step to regaining investor confidence

tortuous taxation tale that began with global telecom major Vodafone's \$11 billion entry into In-▲dia, is nearing its climax 14 years on, with the company having frozen fresh investments for a few years and its Indian operations now on the brink of collapse. On Thursday, Finance Minister Nirmala Sitharaman introduced tax law changes to scrap the retrospective provisions brought in by the late Pranab Mukherjee in the Union Budget 2012-13. I-T demands have been made in 17 cases, including from Vodafone and Cairn, using those retro-active clauses in the I-T law. That this government took so long to undo Mr. Mukherjee's gambit after losing a tax pursuit against Vodafone is disappointing. Even before 2014, the BJP had called the retrospective provisions 'tax terrorism'. Yet, it did not walk the talk despite a resounding parliamentary majority, while promising global investors that it does not approve of such measures. Whether this was a result of political dithering, bureaucratic bungling or ill-informed legal advice, the 'sore point for potential investors' remained on the statute. This should now lead to a formal burial of a matter that has cost India dear.

In Cairn's case, the tax department began action in January 2014, but the assessment orders were passed, and its shares sold off to recover 'retrospective' tax dues under this regime's watch, pending international arbitration. By December 2020, the Vodafone and Cairn arbitration cases had been lost and investors hoped the Government would abide by the legal process and close this sordid chapter. Instead, appeals were filed, with the Government asserting as recently as May that it will 'vigorously defend' its sovereign right to tax and had 'never agreed to arbitrate a national tax dispute'. On Friday, Ms. Sitharaman said the Government was waiting for those cases to 'reach their logical conclusion'; now that they have, the BJP is fulfilling its commitment that it does not believe in retrospective taxation. If that were indeed the case, the Government could have introduced these changes in the Budget instead of wasting more legal resources on filing appeals. It is quite clear the U-turn has been prompted by Cairn Energy's relentless pursuit to enforce the arbitration award. That it has sought to get Air India labelled as the Government's 'alter ego', creating fresh doubts for the airline's potential buyers, and a French court has permitted it to freeze Indian assets in Paris, must be significant triggers. Whether Cairn will back down from those claims or forfeit the interest and damages, as offered by the Government to close the chapter, will likely depend on its institutional shareholders. Irrespective of the outcome, global capital is unlikely to immediately forget the 'ad-hoc' approach to this critical policy issue and rush in. Be it fluctuating trade tariffs or shifting GST rates and rules, India needs to demonstrate greater clarity and consistency in policy across the board to fix its broken credibility.

### It's hockey

As the men's and the women's teams excel at the Olympics, hockey is again looking ahead

splendid fortnight in Tokyo has steered Indian hockey back to the limelight tinged with an ▲Olympic halo. Before this, for years the sport, much akin to the West Indies in cricket, had only the good-old-days cliché to fall back upon. Champions of the distant past but plagued by middling results, was the standard template. There was the odd flicker and the nostalgically inclined with their fond remembrance of legends such as Dhyan Chand, Mohammed Shahid and Dhanraj Pillay, would hope for a sunrise. It often proved to be a mirage while cricket, football, tennis and Formula One lured the fans. That India had to wait for 41 years for its next Olympic hockey medal tells a long tale of diminishing hope. Thankfully an upward graph has been finally etched due to the grit and skill-sets of Manpreet Singh's men, who despite an early 1-7 loss to Australia held their own and winged into the semifinals where they ran into eventual champion Belgium. The soul-numbing defeat was quickly cast aside and India prospered to wrest the bronze with a 5-4 triumph against Germany during Thursday's third-place playoff. Mentored by coach Graham Reid, India had turned a corner and hockey was the flavour of the season. The ancient game which melded magical wrists, sprinting feet, sticks and a speeding ball, has seemingly reclaimed its Indian heart.

If men as diverse as Manpreet and goal-keeper P.R. Sreejesh showed that India was at home in modern hockey, their female counterparts showed they are equal to the very best. Rani Rampal's unit had a dream run but a bronze was missed by a whisker. It is one of the greatest fourth-place results in Indian sporting history and on a par with where Milkha Singh and P.T. Usha finished in their respective 400m and 400m hurdles finals during the 1960 Rome and 1984 Los Angeles Games. If the men revived an old romance with hockey, the women stole hearts with a riveting performance. A semifinal berth followed by a 3-4 loss to Great Britain during Friday's third-place play-off, left the nation with a lump in its throat as the women gave it their all on the ground. Rani, goal-keeper Savita Punia, Salima Tete and other stars showed that India has its heroes on either side of the gender-divide. To battle past stereotypes, misogyny, poverty and casteist boundaries, demands a bigger heart. The women's hockey team had it in abundance and credit is also due to coach Sjoerd Marijne, who ended his tenure on a high. The effort put in by SAI and the sponsorship from the Odisha Government, played a big part too. Indian hockey has found its feet and this is a redemption song of the finest kind.

# India's schoolchildren need their childhood back

The country needs to stop asking whether schools are safe and start acknowledging that in-person school is essential

The economy is open. Malls, bars, restaurants, and some offices are open, but schools have been closed for 16 months and counting. They have sporadically opened for the higher grade students, and the Board examinations have been a key discussion point. There is indeed some basis to the old joke that Indian parents have a razor-sharp focus on academics and want their children to be a doctor or an engineer. This focus is not entirely misplaced, for academic results in the higher grades are important to determine colleges and professions, and for many Indians, a chance at a better

#### The wide-ranging impact

However, let us not forget our youngest children. Six year olds who have spent more time outside the classroom than inside. Five year olds who have never been inside school nor ever met their teachers or classmates. Let us not lose sight of the importance of education in the younger years as well as the overall purpose of education. In-person school education teaches children to share, wait for their turn, negotiate, and compromise; by depriving them of social contact, we are depriving them of essential learning and development. For children from economically weak backgrounds, schools are a key source of nutrition. For some, schools serve as safe spaces from the chaos of their homes. For many children, partic-

ularly those who do not have educated parents or cannot afford home tutors, the denial of education results in learning losses and, ultimately, denial of a chance to earn a livelihood. For parents, school closures have added to childcare and teaching duties. Household incomes are reducing amidst rising inflation as parents, mainly mothers, have quit their

The Indian Council of Medical Research (ICMR) recently stated that "once India starts considering, it will be wise to open primary schools first and then secondary schools. Also, we have to ensure that all support staff[,] whether it be school bus drivers, teachers and other staff in the school[,] need to be vaccinated" (https:// bit.ly/3AhqX7T). Researchers do agree, however, that children are at low risk of developing severe COVID-19 compared to adults.

#### **Expert opinion**

In June 2021, commenting on the World Health Organization-All India Institute of Medical Sciences (AIIMS) serosurvey, AIIMS Director, Dr. Randeep Guleria said, "This study also looked at sero surveillance among children. In the less than 18 years of age group, it was found that more than 50 per cent of children and in some areas, more than 80 per cent of children from both urban and rural areas had antibodies. This means they were already infected and developed antibodies." The ICMR recently released results of the Fourth National Sero-Prevalence Survey which showed that more than half of the children (6-17 years) were seropositive and sero-prevalence was similar in rural and urban areas. Given the above, it is possible to think about starting schools in areas where the community level of infection is

low. A one-size-fits-all approach across India will not work. This means that in some States such as Kerala or Maharashtra, where CO-VID-19 cases could be surging again, students should stay home, while their counterparts in other States where positivity rates are lower, can start going to school.

There are a host of recommendations on how to open schools safely, including by the World Bank, SRCC Children's Hospital, Mumbai and the Lancet COVID-19 Commission India Task Force (https://bit.ly/37o7Exl). Schools cannot be opened overnight. There is a large amount of preparation required, and the longer we wait to begin planning, the longer

it will take to implement. As immediate measures, governments should: call for lists of school staff and procure full vaccination for them. Scientists should confirm if the gap between doses can be made shorter akin to health-care workers; engage relevant experts to undertake public campaigns to make school staff and parents aware of the low risk of transmission in schools and low severity in children, urge them to understand the science and encourage them to commit to a social contract to be ever-vigilant and keep a sick or exposed child home; issue guidance for staggered re-opening of primary schools – e.g., 50% attendance or

smaller groups of students on alternate days or weeks; upgrade school infrastructure to facilitate a hybrid system of learning where parents who do not wish to send their children to school have the choice to continue with online learning; train school teachers in hybrid learning; formulate and issue guidance on COVID-19 protocols to be adopted by schools distancing to the extent possible, outdoor classes weather-permitting, masking, hand hygiene, and proper ventilation (scientists have indicated that even the humble pedestal fan can do wonders for ventilation); finalise logistics such as packed meals and transport; and ensure availability of medical consultation so that staff and parents need not scramble for assis-

Other required long-term measures, which will also require funding, time, and effort, include greater investment in health-care facilities, particularly paediatric facilities, and implementation of systems to track local level of infections.

#### **Managing the risks**

As parents, we must recognise the costs of isolation and online learning for our young children. We cannot wait for children to get vaccinated because this may take years. According to a media report, Britain has said that "it has decided against giving mass CO-VID-19 vaccinations to all children and they would only be offered in certain situations such as when young people have underlying health conditions". We cannot expect schools to provide a 100% guarantee that our children will be safe. Nothing is risk-free; risk must be managed with mitigation strategies. Instead, we must build mutual trust among governments, schools, and citizens. Each of us

must implement and adhere to COVID-19 safety protocols recommended by scientists. Each of us must be vigilant and responsible, ensure all adults in our households are fully vaccinated and ensure children stay home if sick or exposed. Until a greater proportion of the population is vaccinated, we should endeavour to curtail unnecessary travel or exposure because we know from serosurveys that adults are bringing infections home. Parents' groups on social media

are abuzz with requests for 'pods' of students and home tutors. Education, like oxygen and medicines during the second novel coronavirus wave, is becoming the responsibility but also a privilege of private citizens. We cannot let status quo continue any longer - we need to stop asking whether schools are safe and start acknowledging that in-person school is essential. Extensive literature based on studies on transmission in schools is clear – children are not super-spreaders, schools are not hotspots or driving viral spread. For young children, even a few hours of interaction per week with their teachers and other children would be an excellent starting point. As Robert Jenkins, Global Director of Education for UNICEF, said, "There are many countries in which parents can go out and have a nice steak dinner, but their seven-year-old is not going to school. That's a problem (https://go.nature.com/3rVrzND)." We need to come together to fix that problem and give our young children their childhood back.

# South Asia's emerging digital transformation

There is evidence that the region's post-pandemic adoption to digital life will shape its future prosperity

OVID-19 has forced South Asia to take a quantum leap in digitalisation. The shift to remote work and education has propelled an unprecedented spike in Internet penetration, with even smaller nations such as Nepal recording almost an 11% increase in broadband Internet users. For a region with threadbare public health infrastructure, the digitisation of health-care services was a watershed moment, providing novel solutions to the public health

In India, COVID-19 accelerated the launch of the National Digital Health Mission, enhancing the accessibility and the efficiency of health-care services by creating a unique health ID for every citizen. The pandemic-induced suspension of bricks-and-mortar businesses spurred South Asia's embrace of e-commerce, boosted by digital payment systems. Bangladesh alone witnessed an increase of 70-80% in online sales in 2020, generating \$708.46 million in revenues (https://bit.ly/3CpGy79)

#### The yawning divide

As one of the world's poorest regions, a wide digital divide persists in access and affordability, between and within the countries of South Asia. Despite having the world's second largest online market, 50% of India's population are without Internet with 59% for Bangladesh and 65% for Pakistan (https://bit.ly/3itJUOQ).

With monetary and health assistance schemes distributed online. 51% of South Asian women were excluded from social protection measures during the pandemic (https://bit.ly/3xoe7ml). Children too were at the receiving end, with 88% lacking access to Internet powered home schooling (https:// uni.cf/2TYn5cp). This disruption could permanently put children out of school, place girls at risk of early marriage, and push poor children into child labour costing economies billions of dollars in future earnings.

Businesses too have paid a heavy price for the gap in digital solutions, whereby many South Asian firms failing to embrace e-commerce or other cloud-based technologies to survive the financial chaos of the novel coronavirus pandemic. The region recorded a 64% decline in sales, with small and women-led firms faring the (https://bit.ly/3lE2HbR). With COVID-19 transforming work life, the acute skills gap among youth will continue, creating unemployment.

#### Digital inevitability, dividend Digital transformation is a global imperative with adoption of ad-

vanced technologies such as cloud computing, artificial intelligence, the Internet of things, Big Data, etc., key to success. From banking to manufacturing and retails, the role of digital technology is too important to be overlooked as countries embrace the digital revolution to drive their development agenda.

At the forefront of Asian digitalisation are countries such as Singa-



pore, Japan, and South Korea recognised as global technological hubs. Owing to increased smartphone and Internet penetration, coupled with the availability of trusted digital payment platforms, China's e-commerce industry is said to reach \$3 trillion in 2024 (https://bit.ly/37qITjW). The digital boom in the Association of Southeast Asian Nations (ASEAN) economies is pushing a "common market" initiative, fostering regional economic integration and enhancing global competitiveness.

South Asia has also made significant strides in the adoption of digital technologies. The Digital Bangladesh Vision 2021 envisages transforming Bangladesh into a prosperous, digital society, whereas India's biometric identification systems intend to improve the efficiency of welfare programmes through digital innovation. However, the region still has a long way to go.

E-commerce could drive the post-pandemic growth in South Asia, providing new business opportunities and access to larger markets. In India, e-commerce could create a million jobs by 2030 and be worth \$200 billion by 2026. Fintech could drive significant growth and reduce poverty by building financial inclusion. For

instance, Pakistan's digital financial sector could boost GDP by 7%, if faster payment gateway, lower costs and fast track licensing are put in place. A timely, inclusive, and sustainable digital transformation can not only bolster productivity and growth but also serve as a panacea for some of the region's socio-economic divides.

#### A checklist for change

To reap the dividends of digital transformation, South Asia needs to address legal, regulatory and policy gaps as well as boost digital skills. A robust digital infrastructure is a sine qua non and there exists a huge financing gap. India alone needs an annual investment of \$35 billion to be in the top five global digital economy and publicprivate partnership needs to be leveraged for the region's digital infrastructure financing.

Regulatory roadblocks need to be addressed as e-commerce regulations are weak in South Asia. For the sector to drive growth, issues such as customer protection, digital and market access regulation, etc. need to be addressed. There would be no digital revolution without universal digital literacy. Governments and businesses need to come together to revamp the education system to meet the demand for digital skills and online platforms. The crossflow of data and personal information calls for stringent cybersecurity measures as many have experienced painful lessons in data privacy during the pandemic.

In South Asia, only a third of the inter-regional trade potential has been exploited, losing out on \$23 billion in revenues (https:// bit.ly/37ohgIr). By addressing issues such as regulatory barriers on currency flows inhibiting online payment to transport-related constraints for cross-border e-commerce activities, South Asia can emulate the European Union's Digital Single Market Proposal.

During the pandemic, South Asian nations joined hands to collectively battle the crises by contributing towards a COVID-19 emergency fund, exchanging data and information on health surveillance, sharing research findings, and developing an online learning platform for health workers. If the eight nations (Afghanistan, Bangladesh, Bhutan, India, Nepal, Maldives, Pakistan and Sri Lanka) can start walking the talk, partnership for a successful digital revolution is plausible. It will need vision, wisdom, and commitment at the highest level of the region's political leadership.

#### Collaboration needed

COVID-19 has rendered old ways of operating redundant. Concerted collaboration at all levels is needed to push South Asia out of stagnancy and towards a digital future of shared prosperity. The right concoction of regulatory and physical infrastructure, skill sets and regional cooperation can lead toward a digital utopia whereas, the lack of which can breed a dystopian tomorrow. Adequate support is needed for those who risk falling through the net of digital progress. A shared "digital vision" could place the region on the right track towards the Fourth Industrial Revolution.

# The complex story of rising cases in Kerala

Malappuram, the most densely populated district of Kerala, epitomises the challenges the State faces in controlling the rising number of COVID-19 infections. **Abdul Latheef Naha** and **C. Maya** explain how the State, which seemed to have a grip on the pandemic, has been faltering

"Two people have died. Please come and pack the bodies," a nurse tells the cleaning staff who are on a break. Within a few minutes, cleaning assistants Asokan M. and Dileep Kumar and a few others begin to prepare the bodies. It is August 3 and two elderly men have succumbed to COVID-19 at the Government Medical College Hospital in Manjeri. The relatives of the dead request the staff to dress the bodies in new clothes one last time. The hospital staff, witness to four-five deaths every day on average since April, are used to the routine. They clean the bodies and pack them in specially designated body bags.

The Manjeri Medical College is the biggest referral hospital for COVID-19 in Malappuram, the most densely populated district in Kerala (1,265 persons per square kilometre). It has 344 beds dedicated to COVID-19 cases and 203 beds dedicated to non-COVID-19 cases. The second wave may be on the wane in most places in India, but here things are hectic. The hospital staff are under great pressure. No one here contests the fact that the Medical College Hospital, which admits only C-category patients (those whose recovery is impossible without proper medical intervention), is not adequately equipped to treat the many patients coming from a district of 48 lakh people. Malappuram is currently the worst-hit district in the State, reporting the maximum number of daily new cases (3,645 new cases on August 5). While many are wondering why Kerala, which seemed to have a grip of the pandemic at one point, seems to be floundering now, Malappuram is often cited as a case in point.

#### Chinks in Kerala's armour

Until a while ago, Kerala seemed like it had an exceptional pandemic story to narrate to the world, but today, the chinks in its armour are beginning to show. The State has seen a steady rise in cases since the second week of July. Over the past eight days, Kerala has recorded 20,000-22,000 new cases daily. Between July 29 and August 4, it recorded nearly 1.45 lakh new cases and 754 deaths and accounted for 43% of the nation's active case pool.

Following the first wave, Kerala's epidemic curve plateaued out but never hit the baseline as rallies were held before the Assembly elections and people gathered in large numbers everywhere. In January-February this year, it reported 1,500-3,000 cases daily, accounting for 45%-50% of India's active case load.

Then the Delta variant struck. By the second week of April, when the second wave was ferociously sweeping across the nation, cases began to go up in Kerala. By mid-May, the State was in the grip of a crisis, reporting over 42,000 44,000 cases daily. When a total 15-day lockdown was imposed, the case graph again hit a plateau and 10,000-15,000 new cases were reported daily. This, however, was in stark contrast to other States where new cases and hospitalisations began to slide rapidly.

Public health experts in the State say that the second wave began a month later in Kerala than the rest of the country. Kerala's strategy, they say, has been to spread out the curve, keep a tight hold on disease transmission, and restrict activities, so that the virus doesn't go on a rampage and overwhelm the health system. The strategy worked well because even at the peak of the second wave, intensive care unit (ICU) occupancy in the State was just 67%

However, Kerala is now being forced to take a re-look at its containment strategies and the socio-economic aspects of the pandemic, which are threatening to overshadow its successes. It is also being compelled to re-examine the quality of care delivered. While it encouraged home care and isolation for patients who had mild COVID-19, it is doubtful whether the health workers were properly trained to diligently follow up with the patients because the ill began to reach hospitals at a later stage of the disease – after hypoxia had set in - and many could not be saved.

#### High pressure, few precautions

One COVID-19 patient reached the Manjeri Medical College every 10-15 minutes on August 2. Most of them were in the age group of 50-70 years. All of them had been referred to the Medical College by other COVID-19 hospitals in the district through the COVID-19 war room. Although there are 5,093 beds earmarked for COVID-19 treatment across the district in seven government hospitals, 69 private hospitals, 12 second line treatment centres, and 10 first line treatment centres, the 547 beds at Manjeri Medical College remain crucial in the fight against COVID-19.

"The signs are ominous, yet people are oblivious to the dangers of CO-VID-19," says Hari Prasad, an ambulance driver who has brought an 85-year-old woman from the Government Taluk Hospital, Tirurangadi, 30 km away from Manjeri. Two volunteers of a community youth organisation come forward to help the woman get on a stretcher. As

the stretcher is taken, she gasps for breath in spite of having an oxygen mask on her face. The volunteers wear no protective gear other than two masks. Many people walk busily through the hospital veranda taking little precaution against COVID-19. Two casualty wards - one for COVID-19 patients and the other for non-COVID-19 patients – function side by side. Security guards on duty seem to be able to do little to restrict the movement of patients and those accompanying them. One security guard looks worried. Five of his co-workers have been infected; they all contracted the virus on the same day. Of the 43 security staff, 10 have been isolated after testing positive for COVID-19.

Doctors in the casualty wards face tremendous pressure as patients, mostly from the lower middle class, stream in. "We have 56 doctors at the hospital apart from doctors from the medical college. The delay in the arrival of the house surgeons of the 2016 MBBS batch has begun to affect us," says Sheena Lal, Deputy Superintendent. Lal is in charge of the hospital as Superintendent K.V. Nandakumar is in quarantine after testing positive along with the resident medical officer. Lal is, however, confident that the pressure on doctors handling the casualty and COVID-19 wards and ICUs will ease with the arrival of the house surgeons in a couple of weeks.

The high patient load compels junior resident doctor Mohammed Shareef to take the risk of alternating between the two casualty wards. He admits that the

pressure is so high that precautions often go for a toss in the COVID-19 zone. Shareef says the hospital is facing space constraints and staff shortage. But the the district lacks sufficient health staff hospital has more than tripled the number of ventilators and vastly enhanced its oxygen capacity since it reported its first COVID-19 case on March 16, 2020. The number of non-invasive ventilators (NIVs) has gone up from 21 to 73, including 10 portable and four neonatal ventilators. There is centralised oxygen supply in all the wards following the setting up of a liquid oxygen plant. An oxygen generator is also ready at the hospital. "This was done in recent months," says Lal. Signs of a third wave are clear and present, she says.

#### A poorly performing district

Malappuram breathed easy during the first wave of the pandemic as many patients did not require NIV support. But during the second wave, it fell miserably short of NIVs. Manjeri Medical College witnessed 15 deaths on a single day, May 27, during the peak of the second wave. Nearly 10 were on account of oxygen failure. This happened despite Chief Minister Pinarayi Vijayan's assurance that Kerala had adequate oxygen supply. The government joined hands with philanthropists and enhanced the facilities. Although the hospitals in the district have 162 ventilators today, several of them are not working.

According to the Kerala Government Medical Officers' Association (KGMOA), and infrastructure. Population-wise, Malappuram is five times the size of Wayanad and four times the size of Pathanamthitta. When the State has an average of one hospital bed for 879 people, the bed ratio in Malappuram is 1:1,643. Malappuram's lone Government Medical College with 547 beds is spread across 23 acres, while the Government Medical College in Alappuzha, a district with only half of Malappuram's population, is spread across 145 acres and has more than 1,100 beds. A KGMOA study before the COVID-19 outbreak found that Malappuram was responsible for one-fifth of the State's infant mortality and one-fourth of maternal mortality. Government hospital facility for delivery is available only for 16.64% of pregnant women in Malappuram. Prior to COVID-19, the district had stood behind others in immunisation and topped in dengue deaths, lifestyle diseases and road accidents.

The strain posed on the health staff in Malappuram district is much higher than what their counterparts in other districts face. If a junior public health nurse serves 5,000 people in other parts of Kerala, she serves 15,000 people in Malappuram. health centre (PHC) for every 39,000 people elsewhere in the State, in Malappuram there is one PHC for every 53,500 people. If there is a community health centre for every 1.4 lakh people elsewhere in Kerala, in Malappuram there is one for every 2.4 lakh people.

Because the General Hospital was upgraded to a Medical College eight years ago, Malappuram lost super-specialty wings such as cardiology, nephrology, urology, and neurology. It also lost the General Hospital and the Woman and Children Hospital.

A week ago, a Central team led by P. Raveendran from the Ministry of Health and Family Welfare visited the district. Blaming the district officials for the shortcomings, Raveendran's team suggested tighter measures for Malappuram to address the pandemic. District Medical Officer Sakeena K. says that despite the constraints, they were able to restrict COVID-19 deaths to well below 1%. The number of COVID-19 deaths reported in Malappuram is 1,638. "This number against a population of 48 lakh is only 0.03%. In fact, that tells us how hard the medical team in the district fought COVID-19," Sakeena says.

Measures taken by Sakeena and her team, such as traveller surveillance, contact tracing, telemedicine facilities, the triage system at the block level, and prevention of cluster formations won the State's approval in the initial phase of the pandemic. Now the team is setting up 326 additional oxygen beds at seven government hospitals in the district and strengthening the paediatric wards in anticipation of a third wave.

#### Vaccination on the rise

In spite of the initial reluctance of the people towards COVID-19 vaccines, the district is now witnessing a heavy rush for inoculation. According to health officials, it was the second wave that changed the people's mindset towards vaccines. While 39% of the population have taken at least one dose of a vaccine, 16% have been given two doses.

However, the district with 106 civic bodies, including 12 municipalities, finds it tough to plan any massive vaccination campaign because the vaccines allocated for Malappuram are distribut-

ed through 116 health centres. The State seems to be doing very well on the vaccination front with 42.81% having received the first dose and 17.86% both the doses. In the 45-plus age group, 83% have been administered the first dose while 43% have received both the doses. The current predicament of rising cases in the State should be weighed against the unique situation created by the circulation of the Delta variant, which has been leading to re-infections as well as breakthrough infections in fully vaccinated individuals, says a public health professional. "It is high time the State paid attention to the disaggregated data of new infections because the proportion of re-infections and breakthrough infections among new cases will help the State identify pockets where active transmission is on. The false sense of security among vaccinated individuals might keep the Delta transmission chains alive for a long time as it is now established (by the Centers for Disease Control and Prevention) that vaccinated persons have viral loads similar to that of unvaccinated persons, which helps them transmit the infection easily," a senior public health professional says.

The State has the lowest seroprevalence rate in India. According to the Indian Council of Medical Research's fourth round of seroprevalence study in June, only about 44% of the State's 3.5 crore population had developed antibodies to the virus. Since mid-May, the Delta virus variant has been driving up cases, causing a prolonged epidemic.

People's behaviour in Malappuram has always been a subject of criticism. When shops opened, crowds thronged the stores. Marriages took place and the police turned a blind eye to the numbers attending the wedding celebrations. Traffic jams were common in several of Malappuram's towns during the lockdown. "Usually it takes 38 minutes for us to cover 46 km to reach Kozhikode Medical College from Manjeri Medical College. But there were days when it took nearly one and half hours on emergency trips during the lockdown," says Pavin A.R., an ambulance

Rakhal Gaitonde, public health expert and Professor, Sree Chitra Tirunal Institute for Medical Sciences and Technology, says, "It is ironic that while the government was clamping down on public life and movement, the business community and markets as part of its containment measures, congregations and celebrations were going on uninterrupted in private spaces, potentially sustaining disease transmission."

#### Pandemic fatigue

But while this is just disease epidemiology that one cannot alter, a team from the National Centre for Disease Control has come down heavily on the State for its failure to implement home isolation and care effectively, for poor and inadequate contact tracing and containment measures, and for a low proportion of RT-PCR tests, which it says have led to the current surge in infections. Kerala's testing levels have been consistent throughout the pandemic. Tests were increased when the second wave hit - an average of 1.5 lakh tests were done daily - but a large proportion of them were Rapid Antigen Tests. While officials refused to comment on this, health officials admit that the diligence and thoroughness with which the State used to do contact tracing, isolation and follow-up is no longer possible. The same goes for home care and follow-up too, which has been faltering. With patients coming to hospital at a later stage of the disease, mortality is going up.

"Earlier, health workers were supported by the local bodies, volunteer groups, police and teachers. One and a half years later, we are on our own. We are acutely short-staffed, overworked and tired. The same group is being roped in for all COVID-19-related activities: from testing to vaccination, apart from mmunisation and vector control," a field worker says.

"Pandemic fatigue has affected eve ryone and communities and health workers need more support and incentives from the government. Districts need to be supported with strategies that have a more local context," says Gaitonde. Mortality reduction is another area where public health experts feel that the State can do more. There were wide fluctuations in the mortality rate, from 0.2% to 1.2%, between April and July, 2021, and also between districts.

Health Minister Veena George said in the Assembly this week that disease severity seemed to have reduced due to rising vaccination numbers. Even when cases were rising, hospitalisation and ICU occupancy seemed to remain stable, she said. The re-infection rate has come down but breakthrough infections are now being reported, she said.

On Thursday, the government announced in the Assembly that it was replacing its Test Positivity Rate (TPR)based containment strategy, which it had been following for the past six weeks, with a micro-containment strategy wherein only specific localities wards in rural areas and streets in urban areas - will be under lockdown, depending on the number of new infections in a locality. The TPR-based strategy had been widely criticised as unscientific and counter-productive because TPR can be easily manipulated. TPR is the proportion of positive cases from the total tests done and therefore, large-scale testing amongst people who are unlikely to be infected can artificially bring down the TPR. But the government had refused to listen to the criticism. With the lockdown affecting the live-

lihood and freedom of people, it became important for the local bodies to reduce the TPR so they could maintain their political image and local popularity. A high TPR and a lockdown was projected as being a measure of their inefficiency. Thus, all local bodies were competing with each other to reduce the TPR somehow by herding in everyone to test, rather than testing appropriate groups. This had seriously affected actual disease containment.

Clearly, Kerala is facing its toughest challenge yet. If, till now, it was a struggle to save lives, a rising case graph and pandemic fatigue is forcing the government to gear up to the bigger challenge of striking a balance between saving lives and protecting livelihoods.

### SC backs Amazon against Future-Reliance merger

Senior advocate Harish Salve had argued that the EA, which functions under the Arbitration Rules of the Singapore International Arbitration Centre, is "'a foreigner to the Indian Arbitration Act". He contended that Amazon, represented by senior advocate Gopal Subramanium, by urging to enforce the EA award, was trying to "fit a square peg in a round hole".

Mr. Subramaniam, on the other hand, had argued that the EA award can never be characterised as a nullity and ignored. It must be obeyed, he had contended.

Justice Nariman upheld the validity of the EA award. The judgment laid down that the award is "exactly like an order of an arbitral tribunal" contemplated under Section 17 of the 1996 Act. Hence, an award by the EA was like an order under Section 17(1) (interim measures ordered by an arbitral tribunal) of the Act.

Besides, Justice Nariman observed that a party (FRL) "cannot be heard to say, after it participates in an Emergency Award proceeding, that it will not be bound by an Emergency Arbitra-

The Narendra Modi government has disallowed a question posed by Communist Party of India (CPI) MP Binoy Viswam seeking details on a possible Memorandum of Understanding (MoU) between the government and Israeli cybersecurity firm NSO Group to deal with terrorist activity, citing that the matter is *sub judice*.

Reports by the Pegasus Project, an international consortium of media organisations, have revealed that phones of politicians, journalists, activists and Su-Court officials, preme among others, were infected with the Pegasus spyware, a military-grade software that is sold by the NSO Group to governments.

So far, the Union government has neither denied nor confirmed purchasing the software. Mr. Viswam said, "I had

asked three questions to the Ministry of External Affairs - the number of MoUs the government has entered into with foreign companies,

the details sector-wise; (b) whether any of these MoU's with foreign companies has been in order to curb terror activities through cybersecurity, the details of the same; and (c) whether the government has entered into an MoU with NSO Group in order to curb terror activities through cybersecurity across the nation, if so, provide details thereof."

He said the question was filed two weeks back and was listed for August 12. He was informed that the question would not be admitted since the matter was already

MPs from the Congress, the Left parties, the Dravida Munnetra Kazhagam (DMK), and the Aam Aadmi Party (AAP) were also in the well, but no one else was suspended except for us. In fact, the Congress and the AAP MPs tore papers too, but no action was taken against them. On Wednesday, when six of us were suspended, like the other days, most of the Opposition members were holding posters. But Trinamool was singled out. We

don't care; it is a matter of pride for us.

Hours after your suspension on Wednesday, it was reported that you and your colleagues tried to storm into the Rajya Sabha chamber, injuring a female security officer. What exactly transpired?

■ It is unfortunate that the

# Assam, Meghalaya to form regional panels

Will approach the issues phase-wise, says Meghalaya CM

The Assam and Meghalaya governments on Friday decided to start settling the "less complicated" areas of the dispute along the 884.9 km border between them before moving on to the more complicated ones. They also decided to form three regional committees each to first get the views of the people living in the disputed areas and prepare a recommendation within 30 days for a decision at the level of the Chief Ministers.

The decisions were taken at a meeting between Assam Chief Minister Himanta Biswa Sarma and his Meghalaya counterpart Conrad K. Sangma in Guwahati.

"Today's [Friday's] meeting was a follow-up of the July 23 meeting we had in [Meghalaya capital] Shillong. We agreed that the disputes have carried on for far too long and things need to be settled amicably and res-

pectfully," Mr. Sangma said after the meeting.

These areas are Upper Tarabari, Gazang Reserve Forest, Hahim, Boklapara, Khanapara-Pilangkata and Ratacherra involving West Khasi Hills, Ri-Bhoi and East Jaintia Hills districts of Meghalaya, and Kamrup, Kamrup (Metropolitan) and Cachar districts of Assam.

The more complicated areas of dispute are Langpih, Borduar, Nongwah, Matamur, Deshdemoreah Block I and Block II. and Khanduli.

# 'Iran, India can play a useful role'

Jaishankar discusses Afghanistan situation with Iran's President Ebrahim Raisi

Iran would welcome an Indian role in stabilising Afghanistan, said Iran's new President Ebrahim Raisi, during a meeting with External Affairs Minister S. Jaishankar in Tehran, where the Minister attended Mr. Raisi's swearing-in ceremony.

Mr. Jaishankar will meet Qatar's special envoy on Afghanistan on Saturday, adding to a series of meetings on the deteriorating situation in Afghanistan.

"Iran and India can play a constructive and useful role in ensuring security in the region, especially Afghanistan, and Tehran welcomes New Delhi's role in establishment of security in Afghanistan," a statement from the Iranian President's office said after the meeting on Friday. "The fate of Afghanistan must be decided by the Afghans themselves, and we believe that if the Americans do not sabotage the situation, this issue will be resolved quickly," Dr. Raisi

#### ISIS module case: 1 more suspect held

The National Investigation Agency (NIA) has arrested one more person for his alleged links with an Islamic State-inspired module.

The accused has been identified as Zufri Jawhar Damudi, a resident of Bhatkal in Karnataka.

Earlier this week, the agency had arrested four persons associated with the module from Karnataka and Jammu & Kashmir. They were identified as Obaid Hamid, a resident of Srinagar; Muzammil Hassan Bhat, a resident of Bandipora; Ammar Abdul Rahman from Mangalore and Shankar Venkatesh Perumal alias Ali Muaviya, a resident of Bengaluru.

The NIA has accused them of their role in raising funds, radicalising and motivating more people to join ISIS. In March, the agency had arrested the module's alleged head, Mohammed Ameen (Malappuram), along with Mushab Anuvar (Kannur), and Rahees Rashid (Kollam).

Two unidentified militants have been killed in an operation by security forces in the Pir Panjal valley's Rajouri district on Friday.

"A joint operation was launched on Thursday night in a forest area of Thanamandi, Rajouri. It was launched after the inputs were established by the police. In the firefight, two terrorists have been neutralised so far," officials said.

The operation was on to trace any other militants hid-

ing in the area, they added. The police said they were keeping a tab on the movement of militants for around 20 days.

Preliminary reports suggested that the militants may have crossed into J&K from Pakistan occupied Kashmir last month. Rajouri is a frontier district and is close to the Line of Control.

The identity and the affiliation of the slain militants could not be established immediately.

#### **Ammunition seized**

In a separate incident, Security forces recovered two pistols and ammunition in Sarthian village of Samba district along the International Border on Friday.

The arms and ammunition, recovered around 7:30 a.m. from a bag, were suspected to be airdropped by a drone, officials said. "An investigation is on to trace the trail of weapons," a police officer said.

# SC asks govt. if it wants tribunals closed

Chief Justice of India reads out in open court details of over 200 vacancies

KRISHNADAS RAJAGOPAL

The Supreme Court on Friday asked the Central government point-blank to come clean on whether it intends to "close" tribunals across the country by not filling up vacancies that have been pending for years.

"The question here is whether you really want these tribunals to continue or do you intend to close them... Is it that the bureaucracy does not want these tribunals?" Chief Justice of India (CJI) N.V. Ramana asked Solicitor General Tushar

Justice Surya Kant, on the Bench, pointed out that with tribunals defunct and High Courts having no jurisdiction over the areas of law wielded by tribunals, litigants have nowhere to go for justice.

Chief Justice Ramana read out in open court the details of over 240 vacancies in key tribunals, making them redundant in their slow death. The court said certain tribunals do not even have presiding officers. Recommendations of names by the selection committees led by sitting Supreme Court judges to fill up the vacancies have been largely ignored by the government.

The CJI, accompanied by Justice Surya Kant, read out the exact vacancies in each tribunal, including the National Green Tribunal, Income Tax Appellate Tribunal, Central Administrative Tribunal, only to name a few.

The Solicitor General said he "genuinely shared the Lordships' concerns". He assured the court that he would inform the govern-



ment. Justice Kant observed. 'If you don't want these tribunals, allow us to restore their jurisdictions to the High Courts. On the other hand, if you want these tribunals to continue, fill up the vacancies... You can't take

The committee visit is in connection with a 2019 report of the Comptroller and Auditor General (CAG) on "high altitude clothing, equipment, ration and housing" for the Army personnel.

The CAG report had pointed out delays in the procurement of high altitude clothing and equipment items of up to four years, leading to acute shortage of essential clothing and equipment.

It further noted that there was a critical shortage of snow goggles ranging from 62% to 98%. "The troops were not issued 'multi-purpose boots' from November 2015 to September 2016 and had to resort to recycling of available boots," the report said.

# Railways to ensure calls on landline phones are attended

The CIC had directed Railway Board to look into the matter

CHENNAI

The Ministry of Railways has directed General Managers of all Zonal Railways, Production Units and other establishments across the country to update the online telephone directory regularly and make sure that calls made to landline numbers are attended properly.

The advisory issued a couple of days ago follows an order of the Central Information Commission directing the Railway Board that landline numbers provided in the public domain should be attended properly.

The case arises out of a petition filed by Anil Kumar Jain, who wrote to the Director (Telecom), Ministry of Railways, seeking to know under the Right to Information Act whether the Closed User Group (CUG) bills of mobile phone numbers used by the Chairman, Railway Board; Personal Assistant (PA) to the Minister for Rail-

ways; PA to the Minister of State for Railways; Member, Traffic; Director, Coaching; and others, were paid from the public account, and also called for details of the numbers.

#### **CUG bills**

Responding to his plea, the Public Information Officer, Railway Board, replied that CUG bills were being paid from the public account of the Ministry of Railways.

He said that Section 4(1) (b)(ix) of the Act required every public authority to publish a directory of its officers and employees.

In compliance with this provision, the Ministry had displayed contact details of the Chairman, Railway Board, and others, on the online telephone directory at http://dir.railnet.gov.in.

#### Appeal filed

However, not satisfied with the reply, Mr. Jain filed an appeal saying that he was not provided with complete information and the updated online telephone directory only displayed landline numbers and not the CUG numbers.

The Central Information Commission noted that an appropriate reply had been provided to the petitioner and advised the Railways to make sure that the landline telephone numbers in the public domain were attended to properly.

His unique interpretation of swadeshi themes created a new awakening and heralded a revival of Indian art," Jayanta Sengupta, secretary and curator of Victoria Memorial Hall, told *The* Hindu.





### Karma phala data

In the Devi Bhagavata Purana, Vyasa further explains about the workings of karma to Janamejaya, and says that none but the omniscient Lord can officiate as a judge in the lives of all mortal beings as He is the sole 'karma phala data.' It is shown that the prime effect of karma is janma by which the jiva exhausts past karma, and since karma is not easily exhausted, the jiva is born repeatedly in samsara, pointed out Sri K. Srinivasan in a discourse.

Sometimes a single birth or many births would be needed to exhaust even a single karma, for it depends on the type of karma and the corresponding fruits. Also, it is not that karma phala is experienced in accordance to the chronological order in which the karmas are done and these experiences may pertain to this world or to other lokas also. Some are born rich while some are poor; while some are born with congenital defects, and so on. One may have a sound mind, intellect and well-functioning sense organs but yet cannot know what karma is responsible for his present state. These disparities are all owing to the jiva's past karma about which only God is aware. Based on all these factors God decides

the kind of birth for every jiva. Even at the laukika level, the judge dealing with offence and punishment is bound with a certain amount of freedom and responsibility. He does not allot punishment purely on the basis of the code of laws. He evaluates the crime and the offender from various angles. Is it a first time offence? What was the motive? Does the person need time for reforming? At the spiritual level, God, as the 'karma phala data' for all mortals, meticulously allots the reward and punishment for each one's merits without prejudice in this never ending cycle of samsara.

Thousands of cheers over thousands of years echoed through the Panathenaic stadium as I pumped my fist in victory on the medal podium, the sun glinting off my gold. Merely visiting the first stadium of the 'modern' Olympics in 1896 had me seeing stars (even without a knock from a shot put) – especially since my personal best in weightlifting was hoisting a wriggling 6 kg baby.

The Olympics, of course, had flagged off centuries earlier. Men chased one another around a track,

Chanu and Rani Rampal whose stories of grit and passion are making a billion eyes tear up, to Valerie Adams who won the bronze 17 years after she'd first won an Olympic medal, and held up a picture of her two kids who she'd had in between. I've been posting pics of my two kids, too. (As I said, I have all

the makings of an Olympian). Alongside the gut-wrenching victories are other stories that we won't forget. Siblings Hifumi and Uta Abe winning their judo competitions on the same day (parents

stop your kids from pulping each other over one Lego block). Tajay Gayle, the long jump champ who twisted his knee, but continued to finish. through the pain. The one that had our hearts was Qatar's Barshim who, having worked all his life towards this point, opted to share his gold with Italy's Tamberi. Inspired, women are insisting their men do the dishes and the cooking. After all, the men are glued to the Olympics all day. Surely they've learnt to

# A zero-waste gown made with Tencel

Sanah Sharma Mehra, the Red Carpet Green Dress Design Contest's first winner from India, on creating an outfit that has multiple possibilities

Chennai-based Sanah Sharma Mehra, 28, has just bagged the Red Carpet Green Dress (RCGD) award for 2020. The zero-waste gown designed with Tencel (a sustainable rayon fabric made from wood pulp), a first for Mehra, has

been made keeping circularity mind. "More search-based, innovationdriven fashion brands can collectively change the narrative for the better," believes Mehra.

Conceived of by actor Suzy Amis Cameron during the press tour for husband James Cameron's film Avatar over a decade ago, RCGD 'challenges designers to create an Oscarworthy dress made entirely of sustainable materials'. The contest guidelines reflect this: using certified eco-friendly, organic and/or recycled materials is mandaas adopting initia-

tives to reduce

textile waste.

In addition to a cash prize and mentoring, winners will 'see their designs worn by contest ambassadors'.

The Pearl Academy graduate, who developed Planar Flux – a sustainable cutting technique that halves the amount of material used back in 2015, says the idea to apply for the contest came about thanks to influencer Kestrel Jenkins' podcast, Conscious Chatter. After she was interviewed by Jenkins last year, Mehra had listened to an episode featuring RCGD's CEO, Samata Pattinson. Curiosity piqued, the designer (who runs her own label, sanahsharma.com) researched the organisation and submitted her application for their Design Contest in July 2020. Excerpts from an interview:

How long did the ideation and making process take? ■ This gown is special because of the design process behind it. Usually designers make a sketch of a finished product and work backwards, but my approach is different. I like to design the patterns, and then watch a silhouette develop.

There's a lot of risk involved

because one can't really predict the appearance of the end



#### How is this outfit different from your earlier designs?

■ The gown uses a special cutting technique of its own that amalgamates a concept in physics with garment making. It's zero-waste and also has embellishments that are representative of the story behind the design. Additionally, it was designed with circularity in mind. So, later in the life of the gown, it can easily be converted into handbags, table linen, perhaps another dress too.

#### You're said to have an 'academic approach' to fashion.

■ While researching, I was shocked to learn that we were making clothes the same way we did in the Middle Ages. The average cutting waste is about 15%. I wanted to change that and created my own cutting technique. I was inspired by



#### What are you working on now?

■ We retail on digital marketplaces like Etsy, and our gender-neutral pret collection [to be launched this Diwali] is going to feature Oeko-Tex certified and GRS certified fabrics in very transitional silhouettes. We're also working on a line made entirely with recycled handloom fabrics in easy, comfortable silhouettes [a September launch].

# **Breaking tradition** this Onam

Sreejith Jeevan has kasavu saris with nautical stripes and in orange (you read that right!)

For Sreejith Jeevan, this Onam is about relevance. About weaves that are traditional vet contemporary enough to be used beyond the festival that falls on August 21.

So while his new range features Kerala's signature ivory gold kasavu saris, they come with contemporary tweaking. "It's not a mood board driven line. Rather, it uses the age-old techniques such as plain weave, kattikara and extra weft patterning, but combined with different layouts," says the founder-designer of Kochibased brand Rouka. "Some

saris are reversible. Others come in pastel palettes. We've also added modern stripes to the traditional vocabulary - such as nautical stripes. In fact, one of the saris just has straight lines across the warp," he says.


With the last year spotlighting sustainability more than ever, Jeevan says they have been looking at how to get "more wears" from a single design. One of the experiments created along with his cluster of weavers at Chendamangalam in Ernakulam and Kuthampully near Palakkad is the *mundum* neriyathum (the traditional two-piece set).



'In ours, the neriyathu [the upper part] can also be used as a *dupatta*. So customers can buy it as a 'separate' and team it with something they already own."

The colour palettes are innovative, too. A gorgeous series of pastel oranges is finding fans. As is a bold red in kasavu. "Onam has broken out of its traditional connotations. Now there's events with just friends, or with younger cousins, or at work. So people want to have different versions of the kasavu for every context." And Rouka is delivering. The saris are priced

between ₹2,800 and ₹10,500, on shoprouka.com



#### Back to **roots**

We use a story format with a youthful visual language to take the audience on a journey of making of the clothes, starting from sensitising them about the weavers and their communities. Our shoots also make people understand that investing in handloom is supporting the craft.

#### Change the **Context**

It is a design challenge, where we have to see what we can make for which market. Bringing in modern tweaks is a good idea. Like our *mundum neriyathum* – where the *neriyathu* can also be used as a *dupatta* – or the *kasavu* sari in pastel shades. Handloom can make a lot of sense by changing the context. Indu Menon is doing this with Kara Weaves. By reimagining the thorthu [thin cotton towel] as cocktail napkins, aprons, bathrobes, resort wear and beach cover-ups, it's become more valuable. It's also more sustainable for the weaver because they get another market.

Fashion is handloom's hope

It is a misconception that tailoring doesn't work with handloom. Take my debut collection in 2006, when I used cotton handloom (excess stock of the Kerala handloom fabric) as part of my diploma project... it was all tailored. Fashion has been the enemy to the craft, but is also its hope. Handloom is a local industry and therefore the solutions are available locally, be it in Kerala's Chendamangalam town or Telangana's Pochampally. This season, I worked on a pilot project with Save the Loom (the nonprofit community group) to prove that weaving must be a full-time job. The idea that starts in my studio in Delhi is implemented at the local level in Chendamangalam. We will train tailors there on everything from pattern cutting to even marketing and social media. (Mishra spent several months in Kerala for his college project back in 2006, and with this Save The Loom initiative, the designer comes full circle.)

There must be adaptability

> We have to accept that true handloom will

always be expensive and almost impossible to scale up to an extent that it becomes 'affordable for all'. But there must be adaptability. I have many clients who understand Indian culture and ethos. So, if they cannot wear a kurta/pyjama, I sometimes make trench coats in Banarasi brocade for them, so that they can still sport Indian fabrics and craftsmanship and feel closer to their roots. There needs to be more awareness in people at large about the Indian traditions of weaving, dyeing, printing. If designers work directly with the artisans without a middleman, it would help

I believe the young generation is a very kind generation and they will be happy to wear handlooms if that can bring about change.

# Begin with the textile people

Most of our weaving traditions - and therefore the techniques, looms and yarns used - were intended for draped rather than cut and stitched wearing styles. The fabric therefore often doesn't fall well when tailored in western styles. It bags and pulls, and the seams give way because it is fine and loosely woven. We need textile people to work on the construction of the fabric and develop varieties that work appropriately before we let the fashion designers loose!



#### Creating producer clusters

For hundreds of years, Indian fabrics have been draped unstitched as saris, dhotis or scarves. It is not built to make structured garments, but that does not mean it cannot be done. Khadi Gramodyog is doing some interesting work. But such initiatives are being done in isolation. It is important that we safeguard against exploitation, and dilution of age-old techniques. We as a brand are working directly with 400 artisans and very few middlemen. We are in the process of preparing a producer cluster in Kutch where 300 of our dyers, weavers, etc, will work together and be co-owners of the company. But just having one or two such set-ups will not work. We need to replicate these models across the country for it to make a difference. Design education also needs to be reinvented.

ast year saw the government scrapping the Handloom ⊿and Handicrafts Boards ahead of National Handloom Day. Then came the usual hashtagstudded selfies from celebrities and politicians indicating that handloom had finally gone mainstream. But has it really? Have we given the power back to our weavers?

2021 is seeing everyone from high-end designers to craft-led NGOs putting the spotlight on the faces behind our many weaves. Ramesh Menon of Kerala's Save The Loom is working on a scholarship programme for artisan families alongside a live museum that will bring visitors face-to-face with artisans. Designer Rahul Mishra, who recently had his fourth showing at the Paris Haute Couture Week, is working with Save The Loom on a pilot project to help

Chendamangalam weavers. At Craft Council of India, their #CCIDirectWeaver initiative is putting clients directly in touch with artisans to make a purchase, and Chhoti Si Asha in Chandigarh has been working on design portfolios for their women-led clusters. It is also heartening to note that e-commerce giants like Amazon are stepping up. Earlier this year, Amazon India Karigar launched 'Handcrafted, With Love' that onboarded artisans and government organisations.

While the hashtags will continue to generate the expected buzz the Prime Minister's hashtag for this year is #MvHandloomMv-Pride – we asked designers and industry experts how handloom can compete with fast fashion's price points and contemporary styling to interest younger buyers.

# The TASTE and SMELL of gondhoraj lebu

The gondhoraj lebu is an incredible lemon. Add a bit of its fragrant juice - or even the leaves – to your dal or your fish curry, and the dish will taste like heaven. My in-laws had a fruit-laden plant in their garden, and we used the lemon and its juice for a host of dishes.

But I'd never had gondhoraj lebu in mutton curry, and was absolutely floored when I did, some days ago. The dish, sent over by my brother-in-law, had been prepared and delivered by Sanhita Sensarma, a corporate lawver who is now rustling up all kinds of exotic dishes. The gondhoraj mutton had the most sublime aroma of the lime, and the eggs and potatoes in the meat curry made it a memorable dish indeed.

The pandemic has introduced us to a range of home chefs – from those offering basic food to restaurant-style dishes. Sanhita's food stands out because it is, in a word, different. Just like I had never had gondhoraj mutton curry earlier, I had not eaten Jaffna meat curry

She sent us this dark curry prepared with 15 roasted ground spices and roasted red rice. It had a lingering taste of coconut, cardamom and cinnamon. We also had

her Wattala black pork curry succulent fatty pieces of pork in a peppery and tart gravy. We enjoyed it all immensely.

Last week, I asked for two dishes - pork Ularthiyathu and Kundapur seafood ghee roast. The pork, lined with fat, truly melted in the mouth. The meat was cooked sous vide (vacuum packed, then cooked in a water bath) for several hours at a low temperature with spices, and then slow pan roasted with coconut pieces and shallots.

I enjoyed the Bunt prawn and squid dish, too, though I was initially taken aback by the oil. But then this was ghee roast, and the dish had been cooked in Udupi ghee, known for its fragrance. The

ghee did give it a gentle kick, while the Byadgi chillies of Karnataka added to its sharp taste, as did the crunchy cashew nuts the dish had been topped with.

Sanhita, who has been studying food for over 23 years, says food obsession is a gene she's inherited. Her mother, she jokes, holds a PhD in Fish Physiology, while her daughter is set to do her MA in

food studies at NYU. Sanhita tells me that she picked up the skill watching her mother in the kitchen.

Every Wednesday, she publishes on Instagram (@gustobysanhita; WhatsApp: 9810427956) her new delivery menu for the weekend ahead. All nonveg dishes cost ₹750 and vegetarian dishes are priced at ₹550. A portion is enough for two.

She usually doesn't repeat her dishes, but clients often ask for traditional Bengali sweets seldom found in sweet shops. Her menu in recent times included gosht kala bhuna, pulled pork crepes, khow suey, a vegetarian platter for Rath Yatra, dal Moradabadi, and kechki maacher jhal chorchori sprats cooked with brinjals, spring onions, garlic greens, green chilies, and coriander roots.

How did she get the gondhoraj flavour in the mutton curry? She put some zest into the mutton marinade, leaves in the curry, and then finally a dash of lemon juice when it was done.

She adds a Bengali version of the phrase bon appetit with the food she delivers: Kobji dubiye *hok*, or let's indulge.

The watch face has always been where heritage brands tout their credentials. Pilot watches have bold, easy to see displays while diving watches have chronographs and timers to ensure dives are timed precisely.

Jiten Thukral and Sumir Tagra's design for Rado, True Square 'Over the Abyss', eschews all of that. Instead, the dial showcases firework-like hands – 18 spokes for the hour hand and 19 for the minutes. Taken together, the 37 spokes represent the number of time zones in the world, and, according to the New Delhi-based artists, is a way to depict human

munities cannot operate in isolation, and we empathise with this valuable insight. We wanted to connect the wearer with others," says Tagra. A goal that takes on new urgency in the throes of a global pandemic.

#### Tech to last

The watch has been in the works for two years and, in the meantime, the world changed. "This comes at a time when we are all experiencing isolation, and a representation of the reunions with loved ones that we all fervently hope may soon be possible." As the ability to move about became constrained, the duo embodied time zones, travel and migration in an object. The unique world-timer inspired display superimposes local time over the different time

"It's quite high tech, as one can imagine. Each material is tested to last for life. So the inks [and everything we used] had to be durable enough to be approved by the Rado standard," says Tagra. For 'Over the Abyss', that meant achieving a new matte blue colour for the monobloc ceramic case and using cutting-edge robotics and nanotechnology to apply the vivid pink and blue gradient paint on to the delicate

# Taliban capture first provincial capital

Insurgents also claim responsibility for killing the government's media department head

The Taliban have captured their first provincial capital since launching an offensive to coincide with the departure of foreign troops, a senior official confirmed on Friday, a significant psychological blow to a government desperately defending a string of cities against the insurgents.

"The city of Zaranj, provincial capital of Nimroz, has fallen to the Taliban," Roh Gul Khairzad, the Deputy Governor, said.

She said the city - in southwest Afghanistan near the Iranian border – had fal-len "without a fight", and social media showed clips of insurgents roaming the streets, being cheered by residents.

The veracity of the videos could not immediately be confirmed.

The fall of Zaranj comes the same day the Taliban claimed responsibility for killing the head of the Afghan government's media information department.

The insurgents warned just days earlier they would target senior administration figures in retaliation for increased air strikes.

The assassination of Dawa Khan Menapal, one of the go-

vernment's leading voices, followed another bloody day of fighting as the war increasingly spills into Kabul.

The news from southwestern Afghanistan also comes as the UN Security Council meets in New York to discuss the conflict.

'Cowardly act'

"Unfortunately, the savage terrorists have committed a cowardly act once again and martyred a patriotic Afghan," Interior Ministry spokesman Mirwais Stanikzai said of the death of Menapal.

Menapal was popular in Kabul's tight-knit media community, and known for pillorying the Taliban on social media – even jokingly at times. The Taliban claimed responsibility for the death, with spokesman Zabihullah Mujahid sending a message

to media saying "he was

killed in a special attack car-

# Biden govt. non-committal on support for India's UNSC bid

Administration says it does not support expansion of veto

While the U.S. has in the past backed India's bid for a permanent seat at the United Nations Security Council (UNSC), the Biden administration has continued to remain non-committal on the issue.

"Well, we value working with India at the United Nations, including in the context this month of the Security Council. We believe that a reformed Security Council that is representative, that is effective, and that is relevant is in the best interest of the United States and all of the UN member states. And we look forward to the opportunity to working very closely with India in the context of the Security Council in the coming weeks," State Department Spokesperson Ned Price said in response to a question on the U.S. position.

The Obama and Trump administrations had supported a permanent seat for India on the Security

largement of the UNSC – in terms of permanent and non-permanent members. However, the U.S. would not support an expansion of the veto – given to the P-5, the current five permanent members: China, France, Russia, the U.K and the U.S.

"Well, we support building a consensus for modest enlargement of the Security Council for both permanent and non-permanent members, provided it does not diminish its effectiveness or its efficacy and does not alter or expand the veto," he said.

At her Senate confirmation in January, the U.S.'s U.N Ambassador, Linda Thomas Greenfield, had also refrained from saying the U.S. supported India and other members of the G4 (Japan, Germany and Brazil) for a permanent UNSC seat, citing regional disagreements on who should get the seat.

Ms. Thomas-Greenfield was possibly alluding to the Uniting for Consensus (UFC) group – Pakistan, South Korea, Italy and Argentina which opposes the G4 plan. China also opposes the bids of India and Japan.

India is currently (in 2021 and 2022) a non-permanent member of the UNSC and is president for the month of

Following up on that, the Deputy NSA-level meeting this week identified "four pillars" of cooperation in Marine Safety and Security, Terrorism and Radicalisation, Trafficking and Organised Crime, and Cyber security, a press release from the Indian High Commission here said on Friday, adding "specific proposals" for cooperation in each area, including joint exercises and training were discussed.

The 'Colombo Security Conclave' among the three neighbouring countries seeks to "further promote" maritime security in the Indian Ocean Region, and was initiated by President Gotabaya Rajapaksa in 2011, when he was Secretary to the Ministry of Defence, according to a media release

from the Sri Lankan Army. The initiative, grounded in military and security collaboration, assumes significance in the region, in the wake of the current geostrategic dynamic that India shares with Sri Lanka and the Maldives. Earlier this year, India aired security concerns over China being awarded development projects in an island off Sri Lannorthern province, close to India's southern border.

**Engagement with Quad** On the other hand, the Maldives's engagement with members of the India-Unit-States-Japan-Australia grouping, known as the 'Quad', has been growing over the last year, especially in the area of defence cooperation. The Ibrahim Mohamed Solih government signed a 'Framework for a Defence and Security Relationship' agreement with the United States last year, an initiative that India welcomed.

In November 2020, the Maldives received a Japanese grant of \$7.6 million for the Maldivian Coast Guard and a Maritime Rescue and Coordination Center. Meanwhile, Male's foreign policy choices are increasingly being challenged by sections, mostly opposition groups, wary of "Indian boots on the ground".

### Nigeria bombs bandit camp, kills 78: military

They had recently stepped up attacks

Nigerian forces have killed 78 gunmen, known locally as bandits, during military operations including air strikes in northwestern Zamfara State, the Air Force said in a statement.

Heavily-armed bandits have wracked northwest and central Nigeria for years, but the groups have recently stepped up attacks on schools, kidnapping hundreds of students for ransom and prompting a mili-

tary response. "On 2 August 2021, Nigerian Air Force... locked on armed bandits on bikes moving into Kwiambana Forest Reserves (in Zamfara State)... over 78 bandits were neutralised, and their camps destroyed," Air Force

spokesman Edward Gabk-

wet said in the statement late on Thursday.

The bandits were tracked to "extensive and well concealed camps with numerous huts" that were destroyed by the Air Force "in liaison with ground troops forming blocking forces around the targeted areas of the forest", it added. It said surviving bandits escaped and abandoned the camp.

The Nigerian military first deployed to the area in 2016 and a peace deal with bandits was signed in 2019 but attacks have continued. Violence linked to these groups is just one of the challenges facing President Muhammadu Buhari's security forces, who are also battling a more than decade-long jihadist insurgency in the northeast and separatist agitation in the southeast.

# Terrorist safe havens must be dismantled immediately: India 'UNSC must decide on actions to ensure Afghan peace'

Asserting that "the future of Afghanistan cannot be its past," India on Friday said terrorist safe havens in the region must be dismantled immediately and terrorist supply chains disrupted, stressing that it is time for the UN Security Council to decide on actions to ensure immediate cessation of violence in the country.

"As a neighbour of Af-

ghanistan, the current situation prevailing in the country is of great concern to us. The violence shows no sign of abating," India's Permanent Representative to the UN, T.S. Tirumurti said at a Security Council meeting on Afghanistan. The Council, under the current Presidency of India, held a meeting to discuss the situation in Afghanistan amid increasing military offensives by the Taliban as the U.S. forces withdrew from the country.

President of the Security Council, Mr. Tirumurti, making a statement in his national capacity, said the international community cannot afford to set the clock back. "It needs to be ensured that Afghanistan's neighbours and the region are not threatened by terrorism, separatism and extremism. There needs to be zero tolerance for terrorism in all its forms," he said.

# Hezbollah retaliates, fires rockets at Israel

The militant Hezbollah group fired a barrage of rockets at Israel on Friday, and Israel hit back with artillery in a significant escalation between the two sides.

It was the third day of attacks along the volatile border with Lebanon, a major Middle East flashpoint where tensions between Israel and Iran, which backs Hezbollah, occasionally play out. But comments by Israeli officials and Hezbollah's actions suggested the two were seeking to avoid a major conflict at this time.

Israel prepared for war Israel said it fired back after 19 rockets were launched from Lebanon, and Prime Minister Naftali Bennett swiftly convened a meeting

with the country's top de-

fense officials. No casualties

were reported. "We do not wish to escalate to a full war, yet of course we are very prepared for that," said Lt. Col. Amnon Shefler, spokesman for the Israel Defense Forces.



# RBI holds rates, MPC splits on stance

One member votes against staying 'accommodative' for as long as necessary to support growth

MUMBAI

The Reserve Bank of India's Monetary Policy Committee (MPC) on Friday voted unanimously to keep the reporate unchanged at 4% as part of the RBI's sustained effort to help the economy recover from the shock of the CO-VID-19 pandemic.

One member, however, voted against the MPC's majority decision to retain the 'accommodative stance as long as necessary to revive and sustain growth on a durable basis', while ensuring that 'inflation remains within the target going forward', Governor Shaktikanta Das said in a statement.

The central bank retained its projection for real GDP growth in the current fiscal year at 9.5% as it pegged Q1 growth at 21.4% followed by

7.3% in Q2, 6.3% in Q3 and 6.1% in Q4.

The MPC, however, raised its forecast for retail inflation for the year to 5.7%, from the 5.1% pace it had projected in June as the faster-than-expected CPI inflation readings in the first quarter and continuing price pressures forced

it to recalibrate projections for the next three quarters: "5.9% in Q2; 5.3% in Q3; and 5.8% in Q4 of 2021-22, with risks broadly balanced".

"Going forward, the revival of south-west monsoon and the pick-up in kharif sowing, buffered by adequate food stocks should help

to control cereal price pressures," the MPC said in its statement.

"Input prices are rising across manufacturing and services sectors, but weak demand and efforts towards cost cutting are tempering the pass-through to output prices. With crude oil prices at elevated levels, a calibrated reduction of the indirect tax component of pump prices by the Centre and States can help to substantially lessen cost pressures," it added, reiterating an exhortation it has been repeatedly making to governments.

"We are in a much better position than at the time of the MPC's meeting in June 2021," Mr. Das said, announcing the policy decision. "As the second wave of the pandemic ebbs, contain-

ment eases and we slowly build back, vaccine manufacturing and administration are steadily rising.

"Yet the need of the hour is not to drop our guard and to remain vigilant against any possibility of a third wave, especially in the background of rising infections in certain parts of the country," he added.

#### 'Conditions still weak'

Mr. Das said the outlook for aggregate demand was improving, but the underlying conditions were still weak. "Aggregate supply is also

lagging below pre-pandemic levels. While several steps have been taken to ease supply constraints, more needs to be done to restore supply-demand balance in a number of sectors of the economy," he stressed.

# 'IBC better than earlier debt recovery methods'

Process needs tweaks, govt. on it: Das

Reserve Bank of India Governor Shaktikanta Das on Friday said recoveries under the IBC process had been 'far greater' than via other debt resolution mechanisms. His comments come in the wake of criticism that banks were taking steep haircuts in large Insolvency and Bankruptcy Code (IBC) cases.

"The total recovery in the Lok Adalat regime was about 5%," Mr. Das said in a post-policy media interaction. "Under the Debt Recovery Tribunal framework it was 6%. Under the SAR-FAESI Act, recovery was 20%," he said. "Under the IBC, it is 39-40%.... Till the onset of the pandemic, the recovery was 45%. It is only

during the pandemic year that the recovery has slightly come down," he stressed.

However, there was room to improve. "The implementation of IBC, of course, requires [changes], the time taken needs to be reviewed and the government has undertaken further legislative actions to streamline the process and rationalise the system," he added.

# M&M profit surges to ₹934 cr. on higher sales, cost control

Frist-quarter revenue more than doubles to ₹11,763 crore

The Reserve Bank expects to come out with a model for operations of fiat digital currencies (DC) by the end of the year, Deputy Governor T. Rabi Sankar said.

He reiterated that the RBI is internally evaluating the possibility of introducing a fiat digital currency, going into a slew of aspects like its scope, technology, distribution mechanism and validation mechanism.

"It will be difficult to pin a date on it (introducing DC). We should be able to come out with a model in the near future, probably by the end of this year," Sankar told reporters at a press conference.

# SEBI tells AMCs to invest in schemes based on risk

Amends rules to ensure 'skin in the game'

Capital markets regulator SEBI has amended mutual fund rules, requiring fund houses to invest in their own schemes depending on the risk level to ensure 'skin in the game'.

The current rule requires an investment of 1% of the amount raised in a New Fund Offer (NFO) or an amount of ₹50 lakh, whichever is less.

In a notification, SEBI said asset management companies (AMCs) will have to invest in their own schemes based on risk level. "The asset management company shall invest such amounts in such schemes of



the mutual fund, based on the risks associated with the schemes, as may be specified by the Board from time to time," SEBI said. However, the regulator did not quantify the minimum amount. According to market experts, fund houses will have to invest more in riskier schemes like equity funds compared with less risky offers like debt funds.

# CUB Q1 net profit rises 12% to ₹173 crore

City Union Bank Ltd. has reported a 12% increase in standalone net profit to ₹173 crore for the first quarter of FY22.

# U.S. job growth solid in July; unemployment falls

'Hiring surges on pent-up demand'

U.S. job growth rose solidly in July amid demand for workers in the labour-intensive services industry, suggesting the economy maintained its strong momentum at the start of the second half.

Non-farm payrolls rose by 9,43,000 jobs last month after rising 9,38,000 in June, the Labor Department said in its closely watched employment report on Friday. Economists polled by Reuters had forecast payrolls increasing by 8,70,000 jobs.

Job gains were, however, flattered by shifts in seasonal employment at schools caused by the pandemic. Es-



timates ranged from as low as 3.5 lakh to as high 1.6 million. Unemployment rate fell to 5.4% from 5.9%.

"Labour-market conditions appear to be healthy at the start of third quarter as labour-intensive service businesses continue to hire given strong pent-up demand," said Sam Bullard, senior economist, at Wells Fargo in Charlotte.

# India's history-making women fall agonisingly short

Great Britain takes bronze, bringing to an end a remarkable campaign by Rani's team; the Dutch beat Argentina for gold

It was heartbreak for the Indian women as they lost 3-4 to defending champion Great Britain in the bronze medal match at the Tokyo Olympics on Friday.

It was a cagey affair to begin with, but Great Britain which had beaten India 4-1 in the pool stage - soon looked threatening.

#### Testing the defence

Lily Owsley made a dizzying run down the right and won a penalty corner off Navjot Kaur in the ninth minute, and the Indian defence was tested again in the 11th. Goalkeeper Savita Punia denied Ellie Rayer and Sarah Jones from close range.

The second quarter witnessed a flurry of goals, with Britain storming ahead in the 16th minute. Rayer's cross into the circle hit Deep Grace Ekka's stick and went in. India's first shot at goal, an attempt by Lalremsiami in the 19th minute, was easily saved by goalkeeper Maddie Hinch. Nisha picked up a

ter and the Brits made the most of their numerical advantage, doubling the lead in the 24th minute. Shona McCallin fed the ball to Sarah Robertson, who scored with an exquisite reverse-

stick finish. The Indians reacted right away, as Gurjit Kaur slammed home a penalty corner in the 25th minute. Spurred on by the goal, Salima Tete made a mesmerising run the next minute

and won another penalty corner. It was almost a replay of the earlier goal as Gurjit again nestled the ball into the far-bottom corner.

India went ahead in the 29th minute through a goalmouth scramble. Shushila Chanu's cross deflected off Sharmila Devi's stick and fell to Navneet Kaur. Navneet attempted a flick but missed it completely and the British defence uncharacteristically

froze. Vandana pounced on the loose ball and caressed it home to give India a 3-2 lead.

Great Britain captain Hollie Pearne-Webb restored parity in the 36th minute. India 'keeper Savita produced a great save to deny Isabelle Petter. However, Sarah Jones chased the rebound and crossed it back to Petter, who padded it for Pearne-Webb to finish with a fierce strike.

#### Renewed vigour

Britain started the fourth quarter with renewed vigour, winning successive penalty corners and scoring off the fourth.

Grace Balsdon scored what proved the match-winner, her drag-flick beating Savita. Britain defended doggedly to prevent yet another Indian comeback.

India had started with three straight losses in the pool stage but displayed character and guts to stun Australia in the quarterfinals.

The Indian women may have lost out on a medal but won a billion hearts, having reached their first-ever Olympic semifinal. They had finished last (12th) in Rio.

The Netherlands defeated Argentina 3-1 to claim the gold medal. Caia van Maasakker scored two goals for the Dutch, who had won the silver in 2016

# Marijne leaves with his head held high

fter his final assignment with the Indian women's hockey team, chief coach Sjoerd Marijne was proud of the fourth-place finish in the Tokyo Olympics, and hoped that they would inspire a fresh generation of players in the country.

Marijne backed the Indian team after its defeat to Great Britain in the bronze medal match on Friday.

"We did not win a medal but we achieved something bigger to make the country proud," said Marijne at a virtual press conference.

Marijne highlighted the fact that the side believed in its ability and earned a creditable finish despite its low ranking (10th) ahead of the Olympics.

"We are among the best four and everybody is taking us seriously. That's a big

step." The Dutchman, who had taken over as the coach in February 2017, revealed that the Olympics bronze medal contest was his last match with the women's side and said more exposure, like the Hockey India League and Pro League, would help the team grow.

"I don't have any plans because this was my last match with the women. It's up to (analytical coach) Janneke (Schopman) now."

Marijne said the girls were emotional after the defeat.

"They are still emotional. They wanted to win. Only when they arrive in India will they see it's not so bad. It will take time.

"Every girl has a story and every story is amazing. The country I come from, the Netherlands, we don't have these kinds of stories. These stories inspire the new generation."





# Italy pulls off stunning win in the 4x100m relay

Indian men's 4x400m team sets Asian mark but misses final; Miller-Uibo delights

One stunning show after another. This has been a fantastic Olympics for Italy. After Lamont Jacobs shocked the world by emerging as the fastest man, Italy produced another breathtaking performance by grabbing the men's 4x100m men's relay gold on Friday.

It was Italy's first medal in the men's sprint relay since the bronze in 1948. This time, Jacobs' sterling second leg and a superb finish by Filipoo Tortu saw Italy edge out Great Britain by onehundredth of a second to win in 37.50s.

In the women's relay, the Jamaicans appeared anxious, worried whether they had messed up the first baton exchange after finishing first, till the official results announced them as winners in 41.02s.

Meanwhile, Shaunae Miller-Uibo, who was planning to skip the quarter-mile a month ago despite being the defending champion, was thrilled that she had changed her mind. The 27-year-old from the Bahamas had been

working on a 200-400m double at Tokyo but she was unhappy with the scheduling. Miller-Uibo had finished last in the 200m final earlier but she looked strong in the 400m on Friday and breezed to a comfortable victory in a personal best 48.36s.

#### Felix makes history

American Allyson Felix produced a brilliant finish to take bronze. It was her 10th medal, making her the mostdecorated female track Olympian. Felix joined Paavo Nurmi (12) and Carl Lewis (10) as the only track and

field athletes with 10 or more medals at the Olympics.

Kenya's Faith Kipyogen, who had been training with legends like marathon world record holder Eliud Kipchoge and listening to their inspiring tales, thwarted World champion's Sifan Hassan's plans of winning a distance treble by retaining the 1500m title. She pulled ahead after the bell, pushing Hassan to the bronze behind Britain's Laura Muir.

The Indian men's 4x400m team of Muhammed Anas, Noah Nirmal Tom, Arokia Rajiv and Amoj Jacob rew-

rote the Asian record, clocking 3:00.25s to finish fourth in the second heat. The team was ninth overall and narrowly missed the final.

#### Shiying's surprise win China's Shiying Liu won a

surprise gold in women's javelin with a 66.34m throw. In men's 5000m, Joshua Cheptegei, the world record

holder, ran a controlled race to take the gold in 12:58.15s. Indian women walkers, Priyanka Goswami (1:32.36s) and Bhawna Jat (1:37.38), finished 17th and 32nd in the





"Unfortunately, this move has also resulted in quite a few promising players, who on the verge of making a mark at international level, quitting the sport," Vishnu said. "And, it has become too

expensive for many of us to even play in Europe or the US. Unless a player has sponsorship to take care of his tour plans, it is almost impossible to play there to improve the rankings," he said. "Fortunately, I am grateful

to my employer ONGC for extending complete support. Yet I find it difficult to plan any tournament schedule because of the costs," he said.

"To compound to the misery, we are not paid the cash incentives by the government which were due to us, like after winning the SAF Games gold (he and Saketh Myneni were winners). We can't run around forever begging for these benefits,"

Mumbai Cricket Association (MCA) is likely to tour Muscat later this month for an exposure trip that is being initiated by Oman Cricket for a possible win-win for both the teams. While Oman has qualified for the T20 World Cup, to be played from October 17, it will also host the weeklong qualification stage before the marquee event moves to United Arab Emirates.

As a result, Oman cricketers are keen to compete against a seasoned outfit ahead of its litmus test. For MCA, with no off-season tournaments being planned anywhere in India ahead of a proposed full domestic season, the new head coach and a new-look selection committee can try out some of the fringe players during the

Confirming the proposed series, Oman Cricket president Pankaj Khimji said the

We have the World Cricket League coming up in September, so it will be good if we get to play against Mumbai.

It is understood that MCA secretary Sanjay Naik, after receiving a formal invitation letter from Oman Cricket on Friday, is set to deliberate the proposal with other officebearers, coach Amol Muzumdar and chief selector Salil Ankola before taking a call later this week.

With almost a dozen top Mumbai cricketers being involved either in England or for the IPL preparation, if Mumbai decides to accept the proposal, it will have to select a second-string outfit.

#### **Serie A: 50%** capacity for new season

The presidents of the Italian Football Federation and Serie A have welcomed the decision to allow vaccinated crowds of up to 50% capacity into stadiums when the seaon starts on August 21.

The Italian government has altered rules to allow a 'checkerboard' seating pattern at stadiums, with a one free seat between each spectator. Previously, regulations allowed 50% capacity crowds but enforced a one-metre distance between fans, which logistically meant that most stadiums could only be filled to around 30% capacity.

Only holders of the 'Green Pass', who are vaccinated against COVID-19, will be allowed to attend matches, while the maximum capacity allowed at indoor sporting venues has risen from 25 to 35%.
