## Covishield-Covaxin mix gives better protection, says ICMR

18 persons from U.P., who inadvertently got the combination, were studied

A combination of Covishield and Covaxin elicits better immunogenicity than two doses of the same vaccine, the Indian Council of Medical Research (ICMR) said on Sunday.

The council released its findings which suggest that immunisation with a combination of an adenovirus vector platform-based vaccine followed by an inactivated whole virus vaccine was not only safe but also elicited better immunogenicity.

The immunisation programme against COVID-19 in India started with two vaccines – AstraZeneca's ChAdOx1-nCov-19 (named Covishield in India) and inactivated whole virion BBV152 (Covaxin). A homologous prime-boost proach was followed.

#### **Pre-print report**

However, 18 individuals in Uttar Pradesh, under the national programme, inadvertently received Covishield as the first jab and Covaxin as the second. In its study, the ICMR compared the safety and immunogenicity profile of these persons against that of individuals receiving only one of the vaccines – either Covishield or Covaxin.

## Human rights at risk in police stations: CJI

Ramana flags routine custodial torture

Chief Justice of India N.V. Ramana on Sunday said police stations pose the "highest threat" to human rights and dignity, which are "sacrosanct".

"The threat to human rights and bodily integrity is the highest in police stations... Going by recent reports, even the privileged are not spared third-degree treatment," the Chief Justice said. Custodial torture and police atrocities still prevail despite constitutional guarantees, he said.

#### A word of advice

Lack of effective legal representation at police stations is a huge detriment to arrested or detained persons. The first hours of arrest or detention often decide the fate of the case for the accused, the CJI said. He was speaking at the release of the National Legal Services Authority's legal services app and vision highly privileged and the most vulnerable. The economic blockade of Mizoram was lifted late on Saturday after more than four hours of talks between the people of Lailapur, two Assam Ministers and offi-

Officials said nine goods trucks, stranded at Lailapur in southern Assam's Cachar district, proceeded to Mizoram on National Highway 306 after the locals were assured of justice for the death of six Assam policemen and a civilian killed in firing allegedly by Mizoram police personnel and armed civilians on July 26. Lailapur is the last Assam town near the border with Mizoram.

"The sentiment of the local people is very strong. They relented after a marathon 270 hours of discussion in the greater interest of relations between the two sister States and peace in the area," Assam's Urban Development Minister Ashok Singhal told The Hindu.

## Taliban seize three more Afghan cities

Lightning offensive appears to have overwhelmed government forces

The Taliban tightened the noose over northern Afghanistan on Sunday, capturing three more provincial capitals as they take their fight to the cities after seizing much of the countryside.

The militants snatched four provincial capitals in Afghanistan since Friday in a lightning offensive that appears to have overwhelmed government forces. Kunduz, Sar-e-Pul and Talogan in the north fell within hours of one another on Sunday, lawmakers and residents in the cities confirmed, but not without fierce fighting.

Pro-Taliban social media accounts claimed that the insurgents were also close to overrunning the provincial capital of Taloqan.

described the city as being enveloped in "total chaos". "After some fierce fighting, the mujahideen, with the grace of God, captured the capital of Kunduz," the Tali-

In Kunduz, one resident ban said in a statement.

"The mujahideen also captured Sar-e-Pul city, the government buildings and all the installations there," it said. The Taliban had the compound "surrounded", said Mohammad Hussein Mujahidzada, a member of the provincial council.

Perennial target

Kunduz is the most significant Taliban gain since the insurgents launched the offensive in May as foreign forces began the final stages of their withdrawal. It has been a perennial target for the Taliban, who briefly overran the city in 2015 and again in 2016 but never managed to hold it for long.

The Taliban captured Taloqan city in northeastern Takhar province on Sunday, a security source and residents told AFP.

A resident of the city said, "We saw the security forces and officials leaving the city in convoys of vehicles.'

n July 19, less than a week after monsoon hit the Capital, several parts of the city were heavily waterlogged. Like many others, 27year-old Ravi Chautala went to take photos of a waterlogged underpass in Pul Prahladpur. But he reportedly fell into the water and though fire brigade and divers were summoned to the spot, only his body could be retrieved from the waterlogged underpass. He left behind his wife and 10-month-old

Sadly, Chautala's is not a lone instance. On the same day last year, a 56year-old driver died in a waterlogged stretch under Minto Bridge where his van got stuck. These deaths have yet again exposed the national capital's dirty secret: urban flooding.

#### Lost in implementation

Despite the deaths, a Drainage Master Plan, commissioned nine years ago and largely seen as a solution, is yet to be implemented. It has now hit a roadblock of "data irregularities", officials said. The last Drainage Master Plan of the city was prepared in 1976.

"At a meeting of the Technical Expert Committee last week, various departments said that the data used for the master plan was found to have several irregularities. A decision has yet to be taken on how to go forward," a Delhi government official told The Hindu.

Experts said that while a range of problems with the storm water network is the major cause of the urban flooding, faulty sewage systems, rapid urbanisation, and climate change are intensifying Delhi's woes.

The Drainage Master Plan for NCT of Delhi was commissioned by the Congress-led Delhi government in 2012 and a final plan submitted to the AAP government in July 2018 by IIT-Delhi. "The Chief Minister has directed the departments concerned to take concrete steps for the implementation of the report, which mentions in detail the specific reasons for waterlogging and flooding during monsoon," an official statement issued by the Delhi government on August 1, 2018 on the master plan said.

It was then referred to a Technical Expert Committee, which is still going through the report. When contacted, R.K. Sinha, Member (River Management), Central Water Commission, who heads the committee, did not offer a comment

#### **Data irregularity**

A.K. Gosain, Professor Emeritus of IIT-Delhi, who headed the team which prepared the master plan confirmed that the committee has flagged irregularities in data. "We used data which was given to us by various government departments to create the master plan. Now the committee asked departments to cross check 10% of the data with ground reality and in a large number of cases, the data given to us is not matching with the ground reality. This is not our fault. We had asked the departments many times to validate the data, but they never did it," Prof. Gosain said.

The master plan submitted in 2018 had also warned of such a possible irregularity. "Since it is possible that many of the data elements that have not been independently validated by the respective departments may be different on ground than the digital reality captured and used in the model," reads the master plan.

The last master plan was prepared when the population of the city was 60 lakh. Since then the population of the city has increased about four times. In

The fact that drains in the city are controlled by multiple agencies, some by AAP and the others by BJP, makes the task more difficult.

#### Core problems

At the centre of the urban flooding problem is the state of both natural and engineered storm water drains. Storm water drains are supposed to carry the run off rainwater and empty into a waterbody, which in Delhi is river Yamuna.

Natural storm water drains are developed over the years as water naturally tries to find a way to flow and it depends on the terrain and slope of the land. In Delhi's instance, many natural drains originate from the Aravalis.

"When you take an area for development, you engineer street-level drains, which will join the roadside drain and it will join larger drains. Usually, all these

a natural drain. This will then drain out into a waterbody," Mr. Gosain said.

Apart from this, there is supposed to be a separate sewage network, which is not connected to the storm water drain, and the sewage treated at plants. But in Delhi, sewage flows into the storm water network at many points and water in storm water drains, including Najafgarh drain (the largest), is blackish in colour and extremely polluted. Near Signature Bridge, where the about 10-metre-wide Najafgarh drain empties into the Yamuna, it changes the river's colour to a darker shade and pollutes it.

Experts said the waste and sewage also reduces the water-carrying capacity of these drains. Adding to the problem, the rainfall has also become erratic. As global temperatures have soared, air has become warmer and it can hold more moisture, leading to more intense spells of rainfall.

"Studies have shown that in the last 3-4 years, Delhi has been getting intense rainfall in a short duration of

time, which was not the case before. This is due to climate change," said Kuldeep Srivastava, Head of the Regional Forecasting Centre of the India Meteorological Department.

For instance, between 6.30 p.m. on July 31 and the same time on August 1, the ridge monitoring station received 126.8 mm of rainfall. This is unusual for Delhi. "Though this is 24 hour data, most of this rainfall was received in a 3-4 hour window on July 31 night," Mr. Srivastava said.

To contextualise, Delhi normally gets only 210.6 mm of rainfall in July. So, the ridge area got more than half of a month's normal rainfall for the city in a matter of 3-4 hours in a day.

#### Stuck in paper

Mr. Gosain's team, which took the help of over 900 students, inspected drains and collected data ranging from soil type and land use to rainfall and existing drainage network to come up with solutions.

The master plan gives a set of recommendations such as 'no encroachment to be allowed on storm water drains', 'no sewage should be allowed to enter storm water network', 'design of new storm drains should not be done in isolation', among others.

More importantly, the master plan used all the data collected to create a mathematical model which generated solutions for waterlogging problems in identified spots. The model generated four solutions - adjusting slope of the existing drain, diverting water to existing waterbodies, using additional storages, and other development works.

These solutions considered the rainfall, slope of the drain, and many other factors and were done with the larger picture in mind to provide a comprehensive solution to the city, rather than isolated ones. But they still remain on paper. "I'm disappointed at how things have progressed. Nothing much has happened after we submitted the report," said Mr. Gosain.

"We will take a decision to reopen Terminal 1 (T1) once traffic reaches 1.20,000 mark per day," CEO of Delhi International Airport Limited, Videh Kumar Jaipuriar, told *The* 

Delhi's IGI Airport has three terminals, of which T1 is yet to reopen since the ban on flights last year in March because of low passenger volumes. While T2 also remained shut for a considerable amount of time, it was reopened in October last year – five months after flight operations resumed in May. However, T2 was shut down again on May 18 after a dip in passenger numbers during the second wave of COVID-19 and resumed operations on July 22.

Over the past 18 months, the airport has introduced several technologies to ensure disinfection of surfaces, circulation of clean air and to monitor that passengers comply with social

distancing norms.

#### Luminometer

Luminometer is used to clean high contact surfaces such as lifts, check-in counters and travelators. It ensures these are free from any living or dead bacteria, fungi and other microorganisms.

After a surface is cleaned, a test swab is taken and put in a Luminometer. It measures the intensity of the light emitted from a sample, and displays the test result in Relative Light Units (RLU), which is used to determine if the sample has passed or failed.

Delhi airport has also in-

stalled a UV tunnel at the baggage belt area of Terminal 3 that helps disinfect passengers' bags. A live CCTV feed of the UV scanning process mounted at baggage reclaim hall allows passengers to see the disinfection process, which involves high intensity UV lamps.

There are also mobile disinfecting towers that help to disinfect various locations of terminal buildings. disinfection is completed, UV power is switched off and these moveable towers are relocated to other areas for a similar exercise.

DIAL has installed a system

which replaces air inside the terminal buildings after every 10 minutes. The air inside the terminal is drawn into the AHU (Air Handling Unit), where it gets filtered after passing through UV light and HEPA filters, before being released again into the terminal building.

#### Tracking system

XOVIS Passenger Tracking System is used to manage passenger flow inside the airport and prevent crowding and long queues. The 3D sensors of the roof-mounted device record passenger coordinates as dots, based on which the software calculates and visualises passenger density index. If the index exceeds 1, this system generates auto-alerts and prompts airport officials to act swiftly and disperse the crowd.

#### Mobile application

The HOI mobile application helps passengers during different stages of their travel by providing them real-time alerts about gate change, weather forecast at their destination, indoor navigation with voice guidance as well as contactless ordering of foods and beverages as well as their delivery.

## Two arrested after video of celebratory firing surfaces

Taking cognisance of a purported video on the social media platform, in which a man was doing celebratory firing, Delhi Police has registered an FIR and arrested the man and his friend on Sunday.

It was shot on August 4 during a birthday celebration organised at the rooftop of a house in outer Delhi's Paschim Vihar East and the man seen firing rounds in the air was identified as Sumit Tanwar, they said.

Police said the alleged video showed the man engaged in celebratory firing on the rooftop of a house here.

Deputy Commissioner of Police (Outer) Parvinder Singh said: "A case under Section 336 [act endangering life or personal safety of others] of Indian Penal Code has been registered at Paschim Vihar East police station and the matter is being investigated."

#### **Identity revealed**

During enquiry, the rooftop was identified and it was revealed that on August 4, Sumit, who is a resident of Guru Harkishan Nagar, was celebrating his friend's birthday in Pushkar Enclave, Paschim Vihar, which is owned by his another friend Abhijeet Adana, the officer said.

"The investigation so far has revealed that the revolver used in the celebratory firing belongs to Sumit's friend Abhijeet, which is being verified. The two accused are being questioned for recovery of firearm," Mr. Singh said.

Police said Sumit's father owns a leather products factory at Jaipur and the accused is looking after the factory office in Delhi while Abhijeet is into property dealing business.

#### CIABC cautions against high liquor licence prices in city

## DDMA orders implementation of GRAP for COVID-19 management

The plan was approved last month at a meeting chaired by the Lieutenant-Governor

The Delhi Disaster Management Authority (DDMA) on Sunday issued an order to bring into force a Graded Response Action Plan (GRAP) for effective COVID-19 management.

The plan was devised by a State-Level Expert Committee and approved last month in a DDMA meeting chaired by the Lieutenant Governor.

#### Three parameters

The GRAP consists of three parameters - positivity rate, cumulative new positive cases and average oxygenated bed occupancy for lockdown/ unlock in the Capital.

The government has introduced four levels of colourcoded alerts to kick in when the parameters are met.

The Level 1 or yellow alert will come into force when the positivity rate is over 0.5% for two consecutive days or cumulative new positive cases for seven days is above 1,500 cases or the average occupancy

#### Class X to XII students can visit schools

## Delhi gets its first animal DNA lab set up in Rohini

SAURABH TRIVEDI NEW DELHI

In a first, the Capital on Sunday got an "Animal DNA Laboratory" set up at the Forensic Science Laboratory in Rohini. Before this, samples used to be sent to other States that have animal DNA testing facilities for the test results. Sometimes, the process delayed investigations.

It will be helpful for the Delhi Police for timely disposal of cases related to cow slaughter, illegal trade of animals and other animal-related cases.

Director Deepa Verma said, "The types of evidence analysed by our forensics lab include any part of an animal, including blood and tissue samples, carcasses, hair, teeth, bones contents."

She added: "Our experts shall analyses DNA to provide information about the identity of a sample. Some answers that DNA tests may provide identification, characterisation of the relationships between animals, and evaluation of two different samples in order to deter-

mine if they originated from the same individual."

Now, the laboratory can examine and identify the animal species of meat products, frozen meat packing, slaughter cases and more.

Asst. PRO, Dr. Rajnish Singh said: "The main challenge witnessed by a forensic scientist is identifying a particular species from crime scene evidence. It is very difficult for a scientist to distinguish if a piece of flesh is found at the scene of crime is from a protected animal like an elephant or tiger, etc. or if it comes from a non-protected animal. Now this new wing of Animal DNA shall address these requirements."

## Shelter home residents will get meals twice a day: CM


The Delhi High Court has asked the Delhi government and the Insurance Regulatory and Development Authority (IRDA) to respond to a plea of a woman challenging an insurance company's decision not to reimburse entire amounts spent on the treatment of her late husband for COVID. Justice Rekha Palli al-

so issued notice to the Nation-

al Insurance Company Limited and Fortis Hospital at Shalimar Bagh, where the woman's husband died during COVID treatment last year. Case posted for hearing on December 12.

The plea filed by Delhi resident Sunita Goel and her two minor children said her husband held a mediclaim policy, Parivar Mediclaim Policy, and the sum insured was ₹5 lakh. The petition said the woman's husband, Gulshan Kumar Goel, was hospitalised on June 30 at Fortis Hospital after he tested positive. He died on July 7, 2020.

The plea contended that the insurance company has not reimbursed the entire amount spent on the premise that once Delhi government had by its June 30, 2020 circular fixed the rates chargeable by hospitals in Delhi, only the said amount was payable.

## Haryana govt. extends lockdown

It, however, lifts restrictions on timings to run shops, malls, bars and restaurants

The Haryana government on Sunday extended the lockdown in the State for a fortnight and lifted the restrictions on the timings to run shops, shopping malls, bars, restaurants, gymnasiums and spas.

Extending the lockdown till August 23 morning, Chief Secretary Vijai Vardhan, in a four-page order, said the restrictions on the timings for the shops, shopping malls, restaurants, bars, gyms, spas, club houses, and swimming pools were being removed and these establishments could run with adherence to the COVID norms.

50% capacity cap

The maximum capacity for restaurants and bars, however, remains at 50%. The swimming pools are allowed to open after adopting requi-

site social distancing norms with all swimmers and visitors vaccinated with both doses of vaccine.

In indoor spaces, gatherings up to 50% of the hall capacity are allowed with a maximum of 100 guests. Similarly, in open spaces, 200 guests are allowed with adherence to COVID-appropriate behaviour.

The earlier relaxations on

conducting of exams, opening of universities for doubt classes, and opening of libraries, coaching institutes, training institutes and open training centres continue. Religious places are already allowed to open with maximum of 50 people inside the premises, but the corporate offices are permitted to open with full attendance. The sports complexes are also open for all outdoor sports activities, but the spectators are not allowed.

**Reopening of varsities** 

As per the earlier orders, the Vice-Chancellors are advised to plan the re-opening of the universities in the State from the next academic session and share the programme with the department concerned of the government.

The orders said that immediate action might be initiated by the university administration to vaccinate all the hostel students, day-scholars, faculty and staff, including those outsourced.

The order said that "No Mask-No Service" would be strictly observed in the State. As per the order, people will not be allowed to board public or private transport and enter any government and private establishments for any services without a mask.

## TMC workers get bail in Tripura

Two of three youth leaders from Bengal - Sudip Raha and Jaya Datta - had sustained injuries due to stone pelting on their vehicle at Ambassa in Dhalai district yesterday.



Presence of Mr. Banerjee triggered another phase of political tension in Khowai surrounding the local police station and the court complex. Protesters showed black flags and shouted 'go back'.

Paramilitary contingents of the Tripura State Rifles and the CRPF were deployed to maintain peace.

Mr. Banerjee reportedly had heated exchanges with senior officers. He argued that the detention was unlawful and made at the beh-

After the TMC workers were taken to a court in Khowai, not far away from the police station, vehicles of the State TMC leaders, including former MLA Subal Bhowmik who recently joined the TMC, and an advocate were vandalised near the court complex. Mr. Bhowmik received injuries on his arm. Mr. Banerjee cancelled his scheduled press conference here as his return from Khowai was delayed due to court proceedings. He, other leaders and the three youth activists from West Bengal returned

in the night. Meanwhile, Chief Minister Biplab Kumar Deb tweeted that a 'group' hatched a conspiracy to disturb the ongoing development activities and prevailing peace in the State to achieve political mileage.

## Odisha govt. go-ahead for coastal highway

It will not intersect any ecologically sensitive area, says senior NHAI official

The Naveen Patnaik Government has given its consent to the ambitious ₹8000-crore coastal highway project that would connect Odisha's Tangi with West Bengal's Digha, six years after mooting of the

If everything goes as planned, the first tender for laying a portion of road could be invited by March next.

"The State government has given consent for the coastal highway after much deliberation. We will go for different regulatory approvals required for the project as the proposed road will pass in the vicinity of various forests and Bay of Bengal and over rivers," said Ram Prasad Panda, Chief General Manager of National Highway Authority of

India (NHAI), Bhubaneswar.

Brushing aside environment concerns being raised over the project, Mr. Panda said the proposed highway would not intersect any ecologically sensitive areas.

"Due care has been taken to evade the forest and sanctuary areas in the plan. The coastal highway will prove a key infrastructure milestone

for transportation of port-related goods, boosting tourism and handling disaster crisis in the future," said the head of NHAI's Bhubaneswar office.

Major traffic on National Highway-16 is likely to shift to the new coastal highway upon its completion.

Ecologically sensitive Chilika, Balukhanda Konark Wildlife Sanctuary, Bhitarakanika Sanctuary Area and some of the important Olive Ridley turtle nesting sites were initially coming in way of the 382-km-long coastal highway.

The project was modified following reservations by environmentalists over a long bridge proposed over the Chi-The crucial road project

would originate from Tangi in Khordha district instead of Gopalpur in Ganjam district. As per road design, all major towns would be by-passed, said Mr. Panda.

Except a stretch of road outside Puri town, all roads would be laid anew. "The project would require close to 2,000 hectares of land while 15-20% of the project cost would be spent towards acquisition of land," he pointed

#### Many bridges

The coastal highway would cross 11 rivers and a number of water channels in six coastal districts for which the project would have large number of bridges and culverts than that of other road projects. From engineering point of view, special treatment of slushy areas would be required to take up the road project.

## Need to increase marriageable age of girls to 21 years stressed

It will help stop exploitation, say participants at meetings

Participating in a series of webinars and physical meetings – "Lado Panchayats" – under the aegis of "Selfie With Daughter Foundation", a non-government organisation working on gender issues, over the past few weeks, women, from across the country, have advocated the need to increase the minimum marriageable age of girls to 21 years from the pre-

"We have held a dozen webinars with participants from across the country and physical meetings with the women in different districts of Haryana to discuss the issue of marriageable age for the females. The participants have overwhelmingly supported that the marriageable age should be at par with the men," said Sunil Jaglan, founder, Selfie With Daughter Foundation.

**Meetings in Haryana** 

The foundation has held physical meetings in Haryana's Gurugram, Nuh, Jind, Hisar and Sonipat districts so far. Mr. Jaglan said that the participants in the webinars presented poems, and articles to articulate their views on the issue. Some of the participants had offered to help the campaign with a digital support.

In a recent webinar, the

men from the families of the women participants, including fathers and brothers, also took part in the discussion and pledged their support to the cause. He, however, added that some of the posts of the women participants on the social media seeking support for their campaign had evoked comments.

Seeking higher marriageable age, the women, in the Lado Panchayats, broadly argued that their studies were adversely impacted due to early marriage. Most of them were of the view that marriage at an early age also led to physical, mental and social exploitation.

## Three arrested for selling cars through forged papers





## Golden arm

Indian sportspersons showed self-belief at the Olympics to return with a record tally

ndia took on a golden glow at Tokyo on Saturday as Neeraj Chopra hurled the javelin to fetch the country Lits first Olympics gold in track and field. Neeraj's winning effort at 87.58m capped the finest ever performance by Indian sportspersons in the quadrennial global stage. India won seven medals – one gold, two silvers and four bronzes - and cumulatively edged past the previous best of six at the 2012 London Games. For a country resigned to a meagre yield or none at the Olympics since its debut in 1900, the latest edition was laden with riches. At 23, Neeraj has the world at his feet and the skies to aim for. The Indian Army man has grown in stature, and to supplant German Johannes Vetter, until now the world's best javelin thrower, was no mean task. Neeraj's golden tryst was special at many levels; it was India's maiden gold in athletics at the Olympics while Norman Pritchard had won two silvers in 1900. It was also India's second individual gold at the Games after shooter Abhinav Bindra hit bullseye at Beijing in 2008. That Neeraj had previously won golds in the Asian Games and Commonwealth Games are all pointers to a journey that is on cruise-mode while his coach Klaus Bartonietz keeps a close watch.

Neeraj's dash of magic seasoned in sweat and muscle, found mirror-images within the Indian contingent. Wrestler Bajrang Punia won bronze in the men's freestyle 65kg bout, pinning down Kazakhstan's Daulet Niyazbekov. It also bolstered India's medals' kitty that had prior contributions from Mirabai Chanu, Lovlina Borgohain, Ravi Kumar Dahiya, P.V. Sindhu and the men's hockey team. What stood out was the Indian contingent's belief that they can compete on level terms with their fancied rivals. It showed in Aditi Ashok's golfing endeavour as she came tantalisingly close to silver before a rain-marred day out at the greens undid her rhythm and the Bangalorean finished at the fourth spot. When the curtains were lowered on the latest Olympics on Sunday, the India-story was largely driven by Neeraj, hockey-renaissance and women-power while shooting proved under-whelming. Among the rest, it was status quo as the United States of America and China led the medals tally with host Japan and Great Britain following while India was placed 48th in the table. Usain Bolt's stardust was missed but Jamaica's Elaine Thompson-Herah added zest while setting a new Olympic record of 10.61 seconds in the women's 100m sprint. The pandemic delayed the Games by a year but it marches on unhindered while the fans look forward to the 2024 version at Paris.

## Tightrope walk

The RBI should not undermine its own credibility by delaying steps to rein in inflation

overnor Shaktikanta Das's statement accompanying the RBI's latest policy announcement highlights the bind that monetary authorities find themselves in. While the central bank's growth supportive actions – maintaining the benchmark interest rate at a decade low, ensuring ample liquidity and an accommodative policy stance - are yet to help engender a meaningful recovery, inflation continues to disquietingly hover around the 6% upper bound of its mandated target. Governor Das acknowledged the RBI's predicament when he said: "Before the onset of the pandemic, headline inflation and inflationary expectations were well anchored at 4%, the gains from which need to be consolidated and preserved. Stability in inflation rate fosters credibility of the monetary policy framework and augurs well for anchoring inflation expectations. This, in turn, reduces uncertainty for investors... increases external competitiveness and, thus, is growth-promoting." It is this vital inflation targeting remit that the Monetary Policy Committee has temporarily set aside in the wake of COVID-19 and its brutal impact, while the central bank focuses its efforts on using all available policy tools to simultaneously preserve financial stability and support a durable economic revival. Still, the central bank's outlook for growth and inflation shows it is cognisant of the ground realities and the limits to its policy options.

Asserting that domestic economic activity has started to recover with the 'ebbing of the second wave', the MPC is hopeful of a bounce back in rural demand on the back of agricultural output remaining resilient, coupled with urban consumption recovering as the manufacturing and service sectors rebound with a lag, and as increased vaccinations help release pent-up demand. However, given that underlying conditions are still weak and the Current Situation Index of consumer confidence in its own July survey is still stuck near the alltime low polled in May, the RBI has retained its full-year GDP growth forecast at 9.5%. The fact that it has at the same time lowered the Q2, Q3 and Q4 growth projections it made just two months ago, by between 0.5 and 0.9 percentage points, belies the uncertainty in its outlook. With the monsoon rainfall deficit once again widening to minus 4% as on August 8, latest kharif sowing estimates revealing an almost 23% shortfall and composite PMI data for July showing a persistent contraction in business activity and continuing job losses, it is hard to see either a near-term revival in demand or an easing in inflationary pressures from cereal and edible oil prices. Admitting the price pressures, the RBI has also raised its fiscal-year inflation projection by 60 basis points to 5.7%. Also, with one of the six members of the MPC dissenting and voting against the language of the policy stance, it seems clear the central bank may sooner than later have to bite the bullet and start normalising rates if it wants to avoid undermining its own credibility by delaying steps to rein in inflation.

## The looking glass of history in Afghanistan

The reason for the U.S.'s failure is no different from that of the Soviets; India too can hardly impact the ground situation

ikhail Gorbachev became General Secretary of the Communist Party of the Soviet Union in March 1985. By then Soviet forces had been in Afghanistan for over five years. They had failed to successfully combat the mujahideen groups, most of whom were based in Pakistan. The mujahideen received crucial support from the United States but the critical factor was their Pakistan base. Secure with the U.S. fully behind it, Pakistan knew that the Soviet Union would not risk crossing the Durand Line to take armed action on Pakistani territory.

In his insightful book, The Great Game in Afghanistan: Rajiv Gandhi, General Zia and the Unending War, Kallol Bhattacherjee records that immediately after becoming the Soviet Union's supreme leader, Mr. Gorbachev had met the Pakistani dictator in Moscow. He had warned him that "Moscow would ensure that Pakistan faces the consequences of backing the mujahideen". Zia was unfazed by the threat because he knew that the new Soviet leader was posturing.

#### From the USSR to the U.S.

Thirty-two years later, the wheel of history had turned. It was the United States which was bogged down in Afghanistan. For 16 years it had, despite a military surge, failed to quell the Taliban insurgency even though the group merely had the support of Pakistan. The reason for the U.S.'s failure was no different from that of the Soviets. It could not carry the war into the territory of Pakistan,

now armed with nuclear weapons; destabilising such a state would have incalculable consequences.

Now, a new U.S. leader, President Donald Trump announcing his Afghanistan policy in August 2017, said, "We can no longer be silent about Pakistan's safe havens for terrorist organizations, the Taliban, and other groups that pose a threat to the region and beyond. Pakistan has much to gain from partnering with our effort in Afghanistan. It has much to lose by continuing to harbo[u]r criminals and terrorists (https://bit.ly/3fIgiLP)." He followed this with a tweet on new year's day 2018 accusing Pakistan of "lies and deceit". For sometime, the Pakistani leadership was concerned by the mercurial Trump but then realised that his were empty threats, signs of the U.S.'s frustration. It continued with its Afghan policy as

#### A thread in these approaches

Within a year of taking over, Mr. Gorbachev was convinced that the Soviet Union's Afghan quest was futile. In February 1986 he told the Communist Party that Afghanistan had become a "bleeding wound". He now decided to prepare for the retreat of the Soviet forces. His aim was to have an orderly withdrawal. He also abandoned the idea of leaving behind a "socialist" government and sought to have a broad-based one which would include the mujahideen.

Fourteen months after warning Pakistan of serious consequences in his August 2017 policy announcement, Mr. Trump too caved in and authorised talks between U.S. diplomats and Taliban representatives in Doha. In these talks, the U.S.'s principal objective was to secure a Taliban guarantee that it would not harbour international terrorist groups in territories under its control. And, like the Soviet



U.S. too accepted the idea of an Afghan interim administration which included the Taliban. The February 2020 U.S.-Taliban agree-(https://bit.ly/3xw1yFG), which Mr. Trump's successor President Joe Biden has honoured, marked the strategic defeat of the world's pre-eminent global power. It was reminiscent of the Geneva Accords of 1988 which were a strategic defeat of a then superpower, the Soviet Union. They both paved the way for the safe withdrawal of foreign forces.

From 1986 to 1988, the Soviets tried hard to put in place an inclusive government in Afghanistan. Najibullah, a forceful if brutal Afghan leader of Pashtun ethnicity, became President in 1986. He virtually abandoned communist ideology for Afghan nationalism and stressed the country's Islamic heritage. He reached out to all sections of Afghan society. The U.S. and Pakistan seemed to go along with the idea of an inclusive government as long as the final assurance of Soviet withdrawal was not gained.

#### The Indian initiative

Significantly, India too advocated a broad-based government and Prime Minister Rajiv Gandhi was in the forefront in advocating it. India took active measures, including contacting the former King Zahir Shah, living in exile in Rome, to lead it. This annoved the U.S. and Pakistan. Both wanted India to assume a non-operational position on Afghan developments and restrict its role to pressing the Soviets to leave. Once it became clear that Pakistan wanted a mujahideen government without Najibullah's participation or Zahir Shah's leadership, India decided to fully support the Najibullah government. This even before the last Soviet soldier left Afghanistan in February 1989.

As part of its outreach to all Afghan parties in 1987 and 1988, India was also in contact with the mujahideen. In February 1988, Rajiv Gandhi met Peter Galbraith, a staffer with the U.S. Senate Committee on Foreign Relations, and whom he had known from his youth. Mr. Bhattacherjee records, "To Galbraith's surprise, Rajiv said that India had reached out to all sections, including the mujahideen inside Pakistan and Afghanistan and was now assessing the entire formula for a broad-based government in Kabul". This shows that Rajiv Gandhi pursued the requirements of realpolitik: even while firmly supporting Najibullah he was not averse to acknowledge, at the highest political level, that if Indian interests demanded so, India would not hesitate to do business with any Afghan group howsoever regressive its ideology.

India's 2021 Afghan dilemma mirrors, to an extent, the one it faced post the Soviet withdrawal in 1989. There is a major difference though. In 1989, Kabul was led by a strong Afghan leader, Najibullah, who had the capacity to hold the situation together with Soviet assistance. That was forthcoming, for while the Geneva Accords provided that neither side would help their protégés, they continued to do so. Thus, for three years, Najibullah kept the mujahideen at bay. It was with the collapse of the Soviet Union in 1991 that the political unity of Kabul frayed. With that the army fragmented, paving the way for the mujahideen to take over in April 1992. Soon enough, intra-mujahideen conflict resulted in complete instability in the country. That set the stage for the rise of the Taliban with Pakistani assistance. The internecine mujahideen hostilities, fortunately, provided India strategic opportunities to influence the ground situation in Afghanistan along with Iran and Russia. But fortune does not smile at all times.

#### Afghanistan today

Now, like Rajiv Gandhi in the 1986-1988 period, Indian foreign policy and security managers are advocating the formation of an inclusive government. So, ostensibly are the western powers including the U.S. The problem is that Afghanistan President Ashraf Ghani is no Najibullah. His capacity to hold Kabul together is questionable. Besides, the Kabul political elite is at odds with itself and if it frays, will the Afghan National Security Forces remain united? The extent to which the U.S. will be willing to support Kabul post August 31 (the date of complete withdrawal) remains to be seen. This situation of total flux could have been easily foreseen. Equally, the need for maintaining open and direct contacts with all Afghan political parties could also have been anticipated only if pragmatic and correct strategic attitudes had guided Indian policy.

Notwithstanding all the appropriate diplomatic noises India may make, it has now no real capacity to impact the ground situation in Afghanistan, And, even if the best option for India comes to pass the formation of an inclusive government - its absence of open contacts with the Taliban will place it at a great disadvantage.

## Revisit the idea of 'aging out' India's coal plants

A more nuanced analysis considering the various characteristics of individual plants would be appropriate

s part of the Union Budget address for 2020-21, the Fi-Sitharaman, said that the shutting down of old coal power plants, which are major contributors to emissions, will aid the achievement of India's Nationally Determined Contributions, an idea which has been endorsed by the Power Minister, R.K. (https://bit.ly/3jQnQxl).

#### Some studies cite advantages Some research studies have also argued in favour of it, citing the economic and the environmental

benefits of shutting down coal plants older than, say, 25 years. It is argued that the availability of under-utilised newer (and presumably more efficient) coalbased capacity means that shutting down older inefficient plants would lead to improved efficiencies, reduced coal usage, and hence, cost savings.

Further, it is argued that it would be uneconomical for old plants to install pollution control equipment required to meet the

emission standards announced by the Environment Ministry, and hence it would be better to retire them. The recent order from the Central Electricity Regulatory Commission (CERC) allowing Delhi's BSES distribution company to exit its concluded 25 year old power purchase agreement with the National Thermal Power Corporation Limited's Dadri-I generating station, also lends some credence to this (https://bit.ly/3lJymZQ).

Since plants older than 25 years make up around 20% of the total installed thermal capacity in the country and play a significant role in the country's power supply, decisions regarding their retirement merit finer scrutiny to see if the claimed benefits really accrue.

#### The benefits

How significant are the potential benefits?

While there are some old plants tied up in expensive power purchase agreements, as in the case of the CERC order, there are also several old plants, which generate at lower costs. For instance, plants such as Rihand, Singrauli (both Uttar Pradesh), and Vidhyanchal (Madhya Pradesh), are all over 30 years old and have very low generation costs of around ₹1.7/kWh, which is lower than the national average. This may be due to locational advantage rather than efficiency, as older plants are likely to be located closer to the coal



source, reducing coal transport costs. However, this just highlights the complexity of the issue, since efficiency does not naturally tran-

#### A savings analysis

Indeed, our analysis (https:// bit.ly/3jDat3a) suggests that the total savings in generation cost from shutting down plants older than 25 years would be less than ₹5,000 crore annually, which is just 2% of the total power generation cost. These savings may not be sufficient to even pay for the fixed costs (such as debt repayment) that would have to be paid anyway, even if the plants are prematurely retired. Similarly, savings in coal consumption by replacing generation from plants older than 25 years with newer coal plants are also likely to be only in the 1%-2% range.

The argument about older plants finding it uneconomical to install pollution control equipment to meet environmental norms is a stronger one, as all coal plants should indeed reduce emis-

sions. However, even here, the argument is not black-and-white. There are some old plants that may continue to be economically viable even if they install pollution control equipment as their current fixed costs (which would increase with pollution control equipment installation) are very low. Indeed. about half the coal capacity older than 25 years has already issued tenders for pollution control equipment installation.

#### **Risks with retirement**

The question then becomes whether these limited savings are worth the risks associated with early retirement of coal plants, especially given the current trends in the country's power sector. To support the growing intermittent renewable generation in the sector, there is an increasing need for capacity that can provide flexibility, balancing, and ancillary services. Old thermal capacity, with lower fixed costs, is a prime candidate to play this role until other technologies (such as storage) can replace them at scale. Further, the capacity value of the old capacity is critical to meet instantaneous peak load, and to meet load when

renewable energy is unavailable. There is also a political economy risk, as aggressive early retirement of coal-based capacity, without detailed analyses, could result in real or perceived electricity shortage in some States, leading to

calls for investments in coal-based base-load capacity by State-owned entities. About 65 gigawatts (GW) of thermal capacity is already in the pipeline, of which about 35 GW is in various stages of construction. This is likely in excess of what the country needs, and further addition to it, driven by State political economy considerations, will lead to stranded assets and locked-in resources.

This is not to say that no old blant should be retired. However, using age as the only lever to drive these decisions is too blunt an instrument, and can prove counterproductive. Instead, a more disaggregated and nuanced analysis, considering the various technical, economic and operating characteristics of individual plants and units, while also accounting for aspects such as intermittency of renewables, growing demand, and need to meet emission norms. would be appropriate to make retirement-related decisions. Hence, it may be prudent to let old capacity fade away in due course, while focusing on such detailed analysis and weeding out the needless capacity in the pipeline, to derive long-term economic and environmental benefits.

## The sovereign right to tax is not absolute

BIT provisions to challenge taxation measures include expropriation and fair and equitable treatment

An important bill introduced in Parliament last week aims to nullify the regressive 2012 amendment in the Income Tax Act. The 2012 amendment overturned the Supreme Court's decision in Vodafone International Holdings v. Union of India and made the income tax law retroactively applicable on indirect transfer of Indian assets. The retroactive amendment resulted in Vodafone and Cairn Energy suing India before Investor-State Dispute Settlement (ISDS) tribunals of India-Netherlands and India-U.K. bilateral investment treaties (BITs). Both the tribunals held that India's retroactive amendment of tax laws breached the fair and equitable treatment provision of the two BITs.

The proposed amendment, long overdue, is a welcome development. However, it is being presented as a domestic legal reform undoing a past mistake. It appears that this amendment hasn't been proposed to comply with the two adverse ISDS decisions rendered against India or to comply with India's international law obligations contained in BITs. This is because there is an erroneous belief in the bureaucratic and political circles that since taxation matters are part of sovereign measures, they cannot be challenged before ISDS tribunals.

#### Sovereign right to tax

Several ISDS tribunals have recognised the fundamental principle that taxation is an intrinsic element of the state's sovereign power. For instance, in a case known as Eiser v. Spain, where foreign investors challenged a tax imposed by Spain on electrical producers under the Energy Charter Treaty, the tribunal held that the power to tax is a core sovereign power of the state that should not be questioned lightly. Likewise, in El Paso v. Argentina, where the investors challenged several facets of Argentinian tax measures as breaching the United States-Argentina BIT, the tribunal held that the tax policy

of a country is a matter relating to the sovereign power of the state, and thus "the State has a sovereign right to enact the tax measures it deems appropriate at any particular time". Not just this, the ISDS tribunals have also held that whenever a foreign investor challenges states' taxation measures, there is a presumption that the taxation measures are valid and legal. For instance, an ISDS tribunal in Renta 4 v. Russia said that when it comes to examining taxation measures for BIT breaches, the starting point should be that the taxation measures are a bona fide exercise of the state's public powers.

#### Limits on the right

Notwithstanding the state's sovereign right to impose taxes and the presumption about the validity of taxation measures, there are certain limits on the exercise of this public power. The two most used BIT provisions to challenge a state's taxation measures are expropriation and the fair and equitable treatment provision. In the context of expropriation, one of the key ISDS cases that explained the limits on the state's right to tax is Burlington v. Ecuador. In this dispute, investors challenged Ecuador's windfall tax imposed on excess profits resulting from oil ex-

ploration under the United States Ecuador BIT. The tribunal held that under customary international law. there are two limits on the state's right to tax. First, the tax should not be discriminatory; second, it should not be confiscatory. In another ISDS case, EnCana v, Ecuador, a Canadian corporation sued Ecuador for value-added taxes under the Canada-Ecuador BIT. The tribunal held that a state's tax measures would amount to an expropriation of foreign investment if the tax law is extraordinary, punitive in amount, or arbitrary in incidence.

In the context of the fair and equitable treatment provision, foreign investors have often challenged taxation measures as breaching legal certainty, which is an element of the fair and equitable treatment provision. Although legal certainty does not mean immutability of legal framework, states are under an obligation to carry out legal changes such as amending their tax laws in a reasonable and proportionate manner.

The tribunal in Cairn Energy v. India said that taxing indirect transfers is India's sovereign power and the tribunal would not comment on it. However, such matters are not of "absolute, unquestioning deference and there are limits on it". Thus, India's right to tax in the public interest should be balanced with the investor's interest of legal certainty. In the context of amending tax laws retroactively, such an action should be justified by a specific purpose that could not be accomplished by applying taxes prospectively. The tribunal held that the public purpose that justifies the application of law prospectively will usually be insufficient to justify the retroactive application of the law. There must be an additional public purpose to justify the retroactive application of the law. For example, India argued that the 2012 amendment was to ensure that foreign corporations who use tax havens for the indirect transfers of underlying Indian assets pay taxes. However, the tribunal held that this objective could be achieved by amending the income tax law prospectively, not retroactively. It is critical to bear in mind that the tribunal did not rule against retroactivity of tax laws per se but against the retroactive application that lacked public policy justification.

#### Carving out taxation measures

India in its 2016 Model BIT carved out taxation measures completely from the scope of the investment treaty. Nonetheless, carving out taxation measures from the scope of the BIT does not mean that states are free to do as they please. As it was held in Yukos Universal v. Russia, if states act in bad faith towards foreign investors or abuse their right to tax or adopt mala fide taxation measures, they won't be able to take the benefit of the carve-out provision.

The biggest takeaway from this nine-year-long sordid episode of retrospective taxation is that India should exercise its right to regulate while being mindful of its international law obligations, acting in good faith and in a proportionate manner. ISDS tribunals do not interfere with such regulatory measures. In sum, the debate never was whether India has a sovereign right to tax, but whether this sovereign right is subject to certain limitations. The answer is an emphatic 'yes' because under international law the sovereign right to tax is not absolute.

## Recusal of a Readers' Editor

The line dividing the professional creed of a journalist from her anxieties as a citizen is getting blurred by executive excesses

In the judiciary, judges sometimes recuse themselves from hearing cases listed before them. The reason for their recusal is either conflict of interest or prior association with one of the parties involved in the case. It must be kept in mind that there are no written rules on the recusal of judges from hearing cases listed before them. Judges use their discretion in making the decision of whether or not to hear the case. As the Readers' Editor of this newspaper, I have often wondered what would be the case from which I would recuse myself.

#### The individual views of journalists

I have participated in protests defending freedom of expression and the rights of journalists to perform their work without fear of intimidation. I have been part of teams that defended democratic rights, raised voices against jingoism, and supported the idea of pluralism. I am aware of editors and media managers who are wary of journalists expressing their views publicly. On the other hand, there are also editors who have taken the view that individual views, as long as they conform to the foundations of ethical journalism, should not be curbed. The Society of Professional Journalists has distilled journalistic ethics to four operational principles: seek truth and report it, minimise harm, act independently, and be accountable and transparent.

In the case of public media organisations such as the NPR of the U.S. or the BBC of the U.K., the rules for public engagement and demonstrations are more stringent but layered. For instance, the BBC makes it clear that accuracy, evidence, facts, transparency and informed judgments are constituent parts of an impartial approach. The NPR, which started as a national radio but has now transformed into an important news media organisation across multiple platforms, tweaked its long-standing policy last month. Its new ethics policy, which was unveiled on July 7, has given more elbow room for journalists to express their personal opinions on a range of issues. The policy, in part, reads: "NPR editorial staff may express support for democratic, civic values that are core to NPR's work, such as, but not limited to: the

freedom and dignity of human beings, the rights of a free and independent press, the right to thrive in society without facing discrimination on the basis of race, ethnicity, gender, sexual identity, disability, or religion."

NPR's policy has already become a subject of debate. The public media organisation has been a witness to some of the defining developments in the U.S. such as the Black Lives Matter movement and the Pride parade. NPR's chief diversity officer Keith Woods explained the factors that led to the changes. While he agreed that it is important for journalists to keep many of their personal views private, he also argued that "there are things in the world where we are not torn about where we stand. We are against bigotry, we are against discrimination and unfairness.'

NPR Public Editor Kelly McBride said the recent policy "confronts the generations-old question in newsrooms: Where does the journalist end and the citizen begin?" NPR lists its guiding principles: "honesty, integrity, independence, accuracy, contextual truth, transparency, respect and fairness". It adds a new reference to its "democratic role as watchdogs". NPR also has a section on universal values such as human rights, a free press, anti-discrimination and anti-bigotry.

The question that haunts Ms. McBride is the one that forces me to retain my ambivalence. She asked: "What if a journalist wants to picket an abortion clinic or demonstrate in support of women's autonomy over their bodies? What about a journalist who wants to express her general support of the Second Amendment?" The Second Amendment to the U.S. Constitution provides "the right of the people to keep and bear Arms".

#### A blurred line

In the Indian context, the line that divides the professional creed of a journalist from her democratic anxiety as a citizen is getting blurred by the day due to executive excesses. When institutions that are supposed to provide checks and balances become an extension of the executive or an apology for it, is it fair to expect journalists not to express their anguish as citizens? When constitutionally guaranteed rights are abrogated, and bills are pushed through without any discussion in Parliament, silence becomes an unbearable burden.

As the Readers' Editor, I would recuse myself from hearing any case that asks me to draw the line that divides journalism from citizenry.

## The many hurdles for students

Indian students studying overseas and those seeking to go abroad face many COVID-related challenges

Students from China and India accounted for 47% of all active foreign students in the U.S. in 2020, as per the Student and Exchange Visitor Programme, part of U.S. Immigration and Customs Enforcement. Indian students comprised the second largest student community in the U.K. and Australia in 2019-2020.

In recent years, Canada has emerged as a sought-after destination for Indian students. One of the biggest beneficiaries of the Donald Trump administration's restrictive student visa policies was Canada. Indian

students are now the largest group within the international student community in Canada.

But in spite of their role in enhancing India's soft power internationally. through their excellent academic performance as well as seamless integration into these countries, Indian students face several problems. These are often overlooked. However, in recent years Indian student associations have been trying to draw attention to these concerns.

#### Three major challenges

Ever since the outbreak of the CO-VID-19 pandemic, Indian students already studying overseas as well as those seeking to go abroad have faced several challenges. First, most Indian students were forced to delay their plans in 2020 due to the imposition of lockdowns, disruption of flights, and embassies not issuing student visas. This led to a drop in the number of Indian students going abroad to study in 2020. According to the Ministry of External Affairs, while in 2019 nearly 5.9 lakh students went overseas for higher education, in 2020 only 2.6 lakh were able to go. While the first two months of 2021 saw 72,000 students going overseas, the devastating second wave impacted the career plans of students. This is not to say that the enthusiasm to go overseas has waned; embassies and high commissions are unable to deal with the backlog of applications.

Furthermore, many countries have closed their borders and/or restricted flights from India. As a result,

students have to look for circuitous routes and end up paying higher air fares. While students are able to make it to Canada through expensive and indirect routes right now, Australia is likely to keep its borders closed well into 2022 given the surge in cases there. The U.K. and the U.S. have tried to make exceptions to their rules for international students, but

there remain a number of rules and regulations which have made it very cumbersome to enter these countries, if not impossible.

The second problem is that of vaccination. As universities abroad open up

for international students and begin allowing in-person classes from fall 2021, many require students to get vaccinated before they go. Covaxin and Sputnik V are yet to be recognised by the World Health Organization. Countries like the U.S. do not accept students who have been inoculated with these vaccines and have told them to get re-vaccinated. Many students who have been vaccinated with Covishield are waiting for the 12week gap to pass in order to get their second dose. To help them, States which send a large number of students abroad have prioritised vaccines for international students.

Third, due to the disruption caused by COVID-19, students overseas are finding it difficult to get jobs.

#### **Addressing issues**

In a post-COVID-19 world, there are likely to be numerous disruptions, but it is important for officials and universities to work jointly to address the challenges which overseas Indian students face. It is impossible to predict when things will get back to normal and when logistical issues relating to Indian students seeking to study overseas will be addressed. While there are certain issues which specifically impact students, there are others such as policies pertaining to air travel and recognition of Covaxin which need to be addressed at the earliest to facilitate smooth travel for tourists seeking to go overseas.

#### Site where Socrates was sentenced

A team of American archaeologists has completed piecing together the site where Socrates stood trial and was sentenced to death in Athens 24 centuries ago [Athens, August 8]. The site is the royal stoa, or arcade, which according to ancient writers was Athens' seat of religious and judicial affairs. It was discovered and unearthed in the western corner of the agora (market) at the foothill of the Acropolis by a group of American archaeologists under Professor Theodore Shears Jr. of Princeton University. The stoa was a covered colonade, about 20 metres long. It was part of the marketplace and civic pulse of ancient Athenian life, a centre of public services, business establishments and gossip. In 399 B.C. it provided the site for the trial of the famous philosopher Socrates, found guilty of "corrupting youth and refusing to worship Gods." Socrates boldly reiterated his beliefs before his judges, and was sentenced to drink a cup of poisonous hemlock. His last hours were spent discussing the immortality of the soul with a group of his disciples. "It is thrilling for an archaeologist to sit on the benches near the north wall of the stoa – where the Athenian judges sat and where such well-known and notorious events have taken place," Prof.

## NIA searches houses of Jamaat leaders in 56 locations in J&K

Agency says funds raised by it being used for violent and secessionist activities

Eighteen months after the socio-religious group Ja-(JeI) was maat-e-Islami banned in J&K, the National Investigation Agency (NIA) Sunday conducted searches at 56 locations in 14 districts in the Union Territory (UT) in connection with a terror funding case in the wake of reports of regroupby the banned organisation.

Sources said NIA teams searched the residences of former JeI heads and incharge of its Falah-e-Aam Trust, a charity organisation that runs nearly 100 schools in the Union Territory, at Soura, Nowgam, Bemina, Harwan and Lal Bazaar in Srinagar.

The JeI had also been motivating the youth of Kashmir to recruit new members in J&K to participate in disruptive secessionist activities, the NIA added.

'No place for violence in land of Sufis'



## Putin to join Modi in UNSC debate today

India holds the Presidency of council for the month amid tensions in Afghanistan and Myanmar

Russian President Vladimir Putin will join the open debate on maritime security that Prime Minister Narendra Modi will preside over on Monday at the U.N. Security Council as India holds the Presidency for the month. The Embassy of India in Russia has announced that President Putin will participate in the event through video conference.

The participation of world leaders in the session is part of the broader global message about the consensus over India providing leadership of the UNSC as the world deals with conflicts in Afghanistan, Myanmar and Yemen among others...

The current stint is the eighth time that India has held the Presidency of the top U.N. body. Yet out of all the tenures, it is the first in 1950-51 that left lasting lessons about how difficult international affairs can be at the level of the chair of the President.

It was in 1950-51 that the issue of Kashmir took a critical turn at the Security Council which took the Indian delegation by surprise. India was still struggling with the initial phase of freedom and the Kashmir issue had opened up almost immediately with the war of 1947-48. The issue arrived at the UN on January 1, 1948 as India urged the UNSC to discuss the battle that began

with the invasion of tribal irregulars from Pakistan.

The Indian submission marked the origin of the "Jammu and Kashmir Question". The title of the dispute was changed on January 22, 1948 to "The India-Pakistan

Question".

The period from 1948 to 1951 was heated as far as the Kashmir issue was concerned as there was little flexibility on display by either India or Pakistan as the UN involvement through the UN Representative Owen Dixon failed to resolve

In this backdrop, on March 30, 1951, the UNSC took up an Anglo-American resolution on Kashmir and laid out a process of continuation that would give the Kashmir issue a long shelf formally taken up last time in 1971 before the August 2019 China in the backdrop of InPrime Minister Modi.

What was particularly embarrassing about the 1951 resolution was that the Kashmir issue concerned the President of the UNSC - India - and yet neither the U.S. nor the U.K. hesitated from going ahead with it. The Resolution 91 decided to replace the United Nations Commission for India and Pakistan (UNCIP) with UN-MOGIP (UN Military Observer Group in India and Pakistan). It also decided to appoint a UN Representative for India and Pakistan in continuation of the role of Sir Owen Dixon.

The second decision almost institutionalised the Kashmir issue in the U.N.

Parties release video on their attempts to speak on Pegasus snooping controversy and farm laws

NEW DELHI Ahead of the concluding week of the monsoon session, Opposition parties on Sunday released a video on social media platforms in which they highlighted their futile attempts to speak on the issues of the Pegasus snooping controversy and farm laws in Parliament, and urged Prime Minister Narendra Modi to "listen" to them.

## 2 more held for derogatory posts against judges

CBI took over the probe following direction from A.P. HC

NEW DELHI

The Central Bureau of Investigation has arrested two more persons in connection with derogatory social media posts against judges and the judiciary. The agency has so far arrested five persons in the case.

The accused Pattapu Aadarsh and Lavanuru Samba Siva Reddy were arrested by the agency on Saturday. "In order to investigate the larger conspiracy, the CBI has also examined certain persons, including Nandigam Suresh, MP, and former MLA Amanchi Krishna Mohan, not mentioned in the First Information Report (FIR),' said a CBI official.

In the same case, the CBI arrested Dhami Reddy Konda Reddy and Pamula Sudheer on July 28. While Mr. Dhami Reddy Konda Reddy is currently in judicial custody, Mr. Sudheer is in the agency's custody till August 10. Another accused named Lingareddy Rajasekhar Red-

dy, who earlier worked in Kuwait, was arrested on July 9. He is also in judicial custody.

#### FIR filed

The agency took over the probe on November 11, 2020, after registering the FIR against 16 accused and other unknown persons, following a direction from the Andhra Pradesh High Court. It was alleged that they deliberately targeted some judges of the Supreme Court and the Andhra Pradesh High Court through interviews in the media, abusive comments and threats on social media platforms.

During the investigation, the CBI traced 13 persons named in the FIR. Three of them were found to be living overseas.

The agency has examined 11 accused. The CBI is also trying to secure the presence of two other accused, said to be in the United States, for their questioning. While five have been arrested so far, evidence against the remaining six is being evaluated for further necessary legal action.

"Searches were also conducted on the premises of accused persons. One of them, Lingareddy Rajasekhar Reddy, had allegedly been using a passport issued in another name," the official said, adding that all the objectionable contents were removed from the Internet.

The agency has sought assistance from its counterparts in other countries, through the Interpol, to gather evidence abroad. It is alleged that the derogatory contents were posted last year after different Benches of the Andhra Pradesh High Court passed orders with regard to some petitions filed against the instructions and actions of the State government and its functionaries.

"Even the persons occupying high position gave interviews against judges," the Court said.

## VHP demands Central law against forced conversion

It accuses secular parties of supporting such activities

The Vishwa Hindu Parishad on Sunday demanded a Central law against forced religious conversion. #### Panel will take up Pegasus issue: Tharoor

Shashi Tharoor, Congress leader and chairman of the Parliamentary Standing Committee on Information Technology, on Sunday said the panel's last meeting on July 28 was "disrupted" by BJP members as they did not want the Pegasus-related allegations to be discussed.

In an interview with PTI, he also put the blame for the logjam in Parliament on the BJP and said it had reduced the "temple of democracy to a rubber stamp for its agenda or worse, a notice board to announce its unilateral decisions".

Asked if going forward the Standing Committee on IT would be able to take up the Pegasus snooping issue, Mr. Tharoor said that for two years now the IT committee had been conducting discussions on citizens' data privacy and security and cybersecurity, topics that also featured in its agenda under the previous chairman, BJP's Anurag Thakur. The Pegasus issue, therefore, clearly fell under the panel's purview. "It is no secret that the

committee's meeting [July 281 was disrupted by BJP members who did not want Pegasus to be discussed. It was unprecedented for 10 members to attend and to refuse to sign the register in order to deny the committee a quorum," the Thiruvananthapuram MP said.

## Adoption not limited by religion: Delhi HC

Judge reprimands U.S. citizens for trying to adopt Hindu child under a wrong law

The Delhi High Court has declared a Christian couple, both U.S. citizens, as 'adoptive parents' to a minor girl born out of Hindu parents while reprimanding them for trying to adopt the child under a wrong law.

The High Court reiterated that Christian and Muslim couples could not adopt a Hindu child under the Hindu Adoptions and Maintenance Act (HAMA), as was sought to be done in this case.

"The Adoption Deed

The family of 26-year-old Harpreet Singh at Mandi Gobindgarh in Punjab is vet to come to terms with what they describe as a "marriage fraud" allegedly played on them by their daughter-inlaw after she left for Canada two-and-a-half years ago.

"Our son [Harpreet] married in July 2018. In January 2019, my daughter-in-law, who had scored well in the **IELTS** [International English Language Testing System], went to Canada on a study visa. After reaching Canada, she conveyed to my son that she did not want to continue her relationship with him as she had plans to spend her life with another person," Manjeet Singh, Mr. Harpreet's father, told The Hindu. "It was a shock for the family. My son is in extreme distress. We have not yet come to terms with it. I

spent around ₹28 lakh on the wedding, paid for her air tickets, the institute's fees... We did not think such a fraud would be played on

Later, after pressuring the girl through mutual friends and relatives, the family was able to send Mr. Harpreet to Canada on a spouse visa. "But the girl then filed for divorce in Canada. After this, I filed a complaint here and a [FIR] was lodged for cheating under Section 420 of Indian Penal Code [IPC] and other sections against the girl and her family," Mr. Singh said.

Punjab has been witnessing an increasing number of "contract marriage frauds" carried out for securing the Canadian 'Permanent Resident' status required to migrate to that country.

The complaints were filed by both men and women. In 2020, the number of complaints stood at 3,829, while in 2021, so far, 2,248 complaints have been lodged.

A large number of peo-

ple, especially youth from Punjab, travel abroad in the hope of a better life. Marriages of convenience are known to facilitate these aspirations. To do this, the bride, the groom or their families enter into an informal contract in which the boy, or his family, is willing to pay for the girl's education and travel abroad, provided that once she completes her education and gets a Permanent Residency (PR) in the foreign country, she will apply immediately for

spouse visa. However, many young men find that "the women go abroad and dupe" them.

"It is basically an arrangement to facilitate the immigration of boys who are not scoring good grades in the IELTS. In certain countries, one can take spouses along, but in some others, it is not allowed. Canada has certain conditions and it is only after fulfilling those conditions that spouses are given a visa. Hence, the cases of cheating surrounding Canada are a tad higher," A.S. Rai, Additional Director-General of Police (NRI Affairs), told The Hindu.

Mr. Rai said it had been observed that the cases were not of matrimonial dispute, but instead that of cheating "where one party has entered into a contract with the other person, who has the promised delivery of some service, and one has paid a certain amount of money, but the person has rescinded on that contract".

"In such cases, we check the financial transactions. The finances have to be routed through legal channels, for instance, air tickets have been purchased, university fees paid, etc. We are then able to establish a case of cheating," he said.

"Around 2.5-3 lakh students move abroad annually from Punjab, apart from the 2 lakh who leave for jobs, etc. The trend of going abroad soon after passing Class 12 slowed down in 2020 because of the pandemic."

Mr. Rai added that the Punjab government was cognisant of such cases, and the 'Ghar Ghar Rozgar and Karobar Mission' provides free counselling for youth interested in foreign study. The initiative is beneficial for Punjabi youth, he said.

Parliamentary panel calls for accentuating vaccine programmes for all students, teachers, allied staff

The hazards of not reopening schools after prolonged closure due to the COVID-19 pandemic are "too serious to be ignored", according to a parliamentary panel.

The committee noted that the closure of schools had not only impacted the social fabric of families in a negative manner, but also increased the involvement of children in household chores.

"The closure of schools for over a year has had a deep impact on the well-being of students, especially their mental health... The confinement of young children within the four walls of the house, being unable to

attend school, has altered the relationship between the parent and the children adversely," the panel said.

"The closure of schools has impacted the social fabric of the family in negative manner leading to early/ child marriage and increased involvement of children in household chores. The present situation has exacerbated the learning crisis that existed even before the pandemic with the marginal and vulnerable children getting adversely affected. Keeping this situation in mind, it becomes all the more imperative to open the panel has schools," noted.

Mr. Gupta said he had "alerted" Union Civil Aviation Secretary P.S. Kharola about it. A senior DGCA official said on Sunday that the aviation regulator had asked the airlines that operate India-U.K. flights currently to submit fare details.

While there have been lower and upper limits on all domestic airfares in India since May 25 last year, no such limits had been imposed on international airfares.

Vistara said: "Pricing is always a function of supply and demand. There are only 15 flights a week allowed currently on the India-U.K. route for Indian carriers and when there is relaxation and more capacity allowed, it will automatically bring down prices."

## ITBP inducts first women officers on combat service

The Indo-Tibetan Border Police (ITBP) force, which guards the Line of Actual Control (LAC) along the India-China border, on Sunday commissioned its first two women officers in combat after they completed their training here.

A total of 53 officers passed out from the ITBP officers' training academy located in Mussoorie after a parade was held, with Uttarakhand Chief Minister Pushkar Singh Dhami officiating as the chief guest.

The first-ever History of ITBP, a 680-page book containing unknown facts and photographs of the border guarding force, was also released by Mr. Dhami and ITBP Director-General S.S. Deswal.

Mr. Dhami and Mr. Deswal put the rank of Assistant Commandant, an entry-level officer rank in the paramilitary, on the shoulders of two women officers – Prakriti and Deeksha – after the passing out parade and an attestation ceremony where they took their oaths to serve the country.

While Ms. Prakriti's father has retired from the Indian Air Force (IAF), Ms. Deeksha's father, Kamlesh Kumar, is an ITBP inspector. "My father is my role model. He never considered me lesser than anyone," Ms. Deeksha said.

Ms. Prakriti, who holds a degree in electrical engineering, said life in the force was "very tough, but it is also challenging and exciting".

The ITBP started recruiting women combat officers in its cadre from 2016 through an all-India examination conducted by the Union Public Service Commis-

sion (UPSC). Before this, it had combat women only in the constabulary ranks.

Out of the 53 officers, 42 officers are in the general duty combat cadre, while 11 are in the engineering cadre of the force. These officers will now be posted across ITBP formations in the country, including along the LAC with China and the anti-Naxal operations theatre Chhattisgarh.

Addressing the officers, Mr. Dhami said the commanders should "give their best" while performing their duties.







## Spirit of surrender

Alavandar, also known as Yamunacharya, is revered as the foremost of acharyas in the Vaishnava tradition as he has laid the foundation of the Visishtadvaita philosophy through his many excellent granthas. His direct disciples and other acharyas in this lineage have been quick to discern the salient features of this sampradaya from his works and have in turn further clarified, explained and propagated them through their works and teachings.

In this context, interpreters have highlighted the significance of his hymn, 'Stotra Ratna,' for the way in which Alavandar establishes the Supremacy of Sriman Narayana and the efficacy of the paths of bhakti and prapatti, pointed out Sri A. K. Sundararajan in a discourse. This hymn, held as a jewel among hymns, instils in the spiritual seeker the values and the inherent path of dharma shown in the Vedas. Alavandar draws much philosophical strength and conviction from the hymns of Azhwars who have shown the way to salvation by seeking God's feet. The bhava or spirit of utter humility and helplessness which is to be present in the seeker when he offers surrender to God is captured most effectively in one particular verse in this hymn.

The verse, roughly translated runs thus: "O Lord, You alone are to be sought as refuge by me, but I am not worthy as I am not established in dharma; nor do I have any atma jnana; my devotion is not in any way fervent or deep; but I am helpless and without any support; so, I seek you since you are the sole protector and support of all beings."

The prayer is applicable to all jivatmas who are aware that their practice of the paths of karma, bhakti or jnana is very limited and insufficient. The seeker accepts his inability to protect himself and is aware that he has no other refuge.

## Afghan forces fighting to retake cities: govt.

U.S. forces conducted several air strikes in defence of Afghan partners: Central Command spokesperson

The Afghan Ministry of Defence said on Monday that government forces were fighting to retake key installations after the Taliban captured three more provincial capital on Sunday in quick succession.

The insurgents have taken control of five provincial capitals in Afghanistan since Friday. Kunduz, Sar-e-Pul and Taloqan in the north fell within hours of each other on Sunday. On Friday, the militants captured Zaranj, and followed it up by taking Sheberghan the next day.

"The commando forces have launched a clearing operation. Some areas, including the national radio and TV buildings, have been cleared of the terrorist Taliban," the Ministry said.

Spokesman for the Interior Ministry, Mirwais Stanikzai, said later that reinforcements, including special forces, had been deployed to

## Myanmar protesters mark 1988 uprising anniversary

Flash mobs seek ouster of junta govt. in Yangon, Mandalay

Myanmar protesters on Sunday marked the anniversary of a 1988 pro-democracy uprising that brought Aung San Suu Kyi to prominence, with flash mobs and marches of defiance against the ruling junta.

The country has been in turmoil since the generals launched their February putsch and subsequent crackdown on dissent that has killed more than 900 people, according to a local monitoring group.

But protesters remain undeterred, taking to the streets daily in lightningquick rallies to demand the end to the State Administration Council – as the junta's so-called "caretaker" government has dubbed itself.

On Sunday, flash mobs popped up across Yangon and second city Mandalay to

commemorate the 1988 uprising – a pro-democracy movement which the military violently quelled by opening fire on protesters and jailing thousands.

Following the calls of an online campaign, red-clad protesters Sunday flashed an eight-finger salute and carried banners that read "Let's return the old blood debt of 1988 in 2021."

"In 1988, our country sacrificed a lot - many people lost their lives. But the dictatorship is still alive," said Ko Sai Win, in Mandalay.

"It is like a black shadow on our country."

The 1988 uprising heralded the rise of Ms. Suu Kyi, who had returned to Myanmar just before protests kicked off to care for her ailing mother.

Riyadh to reopen borders for vaccinated pilgrims

Saudi Arabia will begin accepting vaccinated foreigners wanting to make the umrah pilgrimage, authorities said on Sunday, a move that will boost an economy hit by the COVID-19 pandemic. Nearly 18 months after it closed its borders to battle coronavirus, Saudi Arabia will from Monday begin "gradually receiving umrah requests from various countries." Earlier, only immunised pilgrims residing in Saudi Arabia were eligible for umrah permits. AFP

#### Thai man arrested over murder of Swiss woman

A Thai man was arrested in connection with the suspected murder of a Swiss woman, whose body was found near a waterfall in Thailand's famed tourist island of Phuket, police said on Sunday. The body of the 57-year-old was found on Thursday lying face-down. She had travelled to Phuket under a so-called "sandbox" scheme, a pilot project allowing vaccinated tourists to enter the island without undergoing the usual two-week mandatory hotel quarantine. AFP

Iran's new President Ebrahim Raisi on Sunday named the chairman of a powerful state-owned foundation sanctioned by the U.S. as his first Vice-President, the President's official website said. Mohammad Mokhber, long rumoured by local media to be top pick for the position, has for years headed the foundation known as Setad, or the Execution of Imam Khomeini's order, in reference to the Islamic republic's founder Ruhollah

## Will respond to Israel strike: Hezbollah

Israel carried out air raids on Lebanon after many years, prompting return fire

The head of Lebanon's powerful Hezbollah movement, Hassan Nasrallah, has vowed a "suitable and proportionate" response to any Israeli air strikes on Lebanon after a flare-up at the border last week.

Israel carried out its first air raids on Lebanese soil in years on Thursday, prompting Hezbollah to fire rockets back at the Jewish state the following day.

"Our response was linked to the Israeli strikes that occurred in south Lebanon for the first time in 15 years," he

said in a televised speech ahead of the anniversary of the end of the last war with Israel in 2006.

"We wanted to tell the enemy... that any air strike by the Israeli air force on Lebanon will inevitably draw a response, though in a suitable and proportionate way, because we want to serve the purpose of protecting our country," he added.

Nasrallah described the air strikes this week as a "very dangerous development", but said Hezbollah did not

head towards war, but we are ready for it" if necessary, he said, echoing similar comments by the Jewish state this week.

Before Thursday, Israel's

last air strikes on Lebanon dated back to 2014, when warplanes struck territory near the Syrian border.

Hezbollah's volley of rockets at Israeli positions on Friday morning prompted retaliatory shelling from Israel, prompting UN peacekeepers to warn of "a very dangerous situation".

U.S. on Friday urged Lebanon's government to prevent Hezbollah from firing rockets into Israel.

The 33-day conflict in the summer of 2006 killed 1,200 people in Lebanon, mostly civilians, and 160 Israelis, mostly soldiers.

## North Korea's Kim calls for relief in rain-hit areas

1,170 homes destroyed, 5,000 evacuated

North Korean leader Kim Jong-un has mobilised the military to carry out relief work in areas recently hit by heavy rains, state media said on Sunday, amid concerns over an economic crisis and food shortage.

The ruling Worker's Party's Central Military Commission held a meeting in the eastern province of South Hamgyong to discuss damage and recovery from the downpour, the official KCNA news agency said.

An early monsoon season arrived on the Korean peninsula last month, with torrential rains also inflicting damage in some southern regions.

North Korean state TV released footage this week showing submerged houses and destroyed bridges and railroads in Hamgyong, saying some 1,170 homes were devastated and 5,000 people evacuated.



Mr. Kim did not attend the meeting but party officials conveyed his message that the military should kick off a relief campaign and provide necessary supplies in the region, KCNA said.

"It was also emphasised that he called for awakening and arousing the (party) officials...into waging the recovery campaign skilfully and unyieldingly," KCNA

#### Chibok girl freed after seven years

One abducted girl from the ligerian town of Chibok has been freed and reunited with her parents seven years after Boko Haram militants kidnapped her and more than 200 of her classmates, Borno State's Governor said on Saturday.

The raid on the school one night in April 2014 sparked a global outcry and a viral campaign on social media with the hashtag #bringbackourgirls.

Governor Babagana Zulum said the girl and someone she said she married during her captivity surrendered themselves to the military 10 days ago. Mr. Zulum said government officials had used the time since to identify her and

contact her parents. Some 270 girls were abducted by the Islamist group but 82 were freed in 2017 after mediation, adding to 24 who were released or found.

## UN slams child marriages after Zimbabwean teen dies in labour

day, the United Nations said it "notes with deep concern and condemns strongly the surrounding circumstances leading to the untimely death of 14-year-old Memory Machaya... who died while giving birth at an apostolic sect shrine.

"Sadly, disturbing reports of the sexual exploitation of underage girls, including early forced marriages, continue to surface and this is indeed another sad case,"

The UN said the trend of

cases of violence perpetrated against women and girls in Zimbabwe, "including marriages of minors, cannot continue with impunity." Official statistics show

that one in three Zimbabwean girls are married off before the age of 18. Nyaradzayi Gumbonzvanda, head of Rozaria Memo-

Q. I am a software engineer, aged 29. My monthly salary is ₹1 lakh. Currently, I invest in EPF and in an LIC policy. I am not sure where else to invest to get financial relief after 15 years. Please give me suggestions.

A. There are a number of investment options that you can consider beyond your EPF and LIC policy. If you are considering investments for a 15-year horizon, you can either invest in instruments with a shorter term and reinvest the proceeds on maturity or choose vehicles that you can hold for 15 years.

If you prefer a safe investment with fixed returns, the Public Provident Fund, which is a retirement savings vehicle with a 15-year term, may be your ideal choice. You can open a PPF account with any post office branch or leading bank and make regular investments in the account. The interest on the PPF, which is declared every quarter, usually tends to be much higher than that on bank deposits and is also tax-free. The interest is credited to your balance every year and compounds until you seek to withdraw the money. You can also open an NPS account where you can make monthly investments towards retirement in market-linked instruments such as shares and bonds.

For shorter horizons, you can consider the 5-year National Savings Certificate (NSC) where your interest compounds until maturity, or the Kisan Vikas Patra which doubles your money in 10 years and four months, too. You can also consider parking your periodic surpluses in the Government of India's 7-year floating rate savings bonds where the interest rate offered is 35 basis points above the NSC and is announced every half year. The only 'minus' for these bonds is that the interest is paid out to you, requiring you to reinvest it. Cumulative term deposits with banks or leading NBFCs, which accrue fixed interest every year, is another option, though less safe than post office schemes.

If you don't mind volatility in your returns in the short run and are sure you won't be needing your money within the next 5-7 years, you can invest in hybrid or index equity funds through monthly instalments (called Systematic Investment Plans or SIPs). While such funds offer anytime liquidity, their returns can be quite volatile depending on how bond and stock markets move. This entitles you to dividends from the company and share-price appreciation, if any, when you sell the share. With both mutual funds and shares, you can hold on for as long as you like, but also exit if you should need the money at any time. You face the risk of loss in your capital over shorter time frames, but if you hold on for more than 7 years, they can generate inflation-beating returns that are better than fixed deposits or bonds.

Before making a start on these investments which require you to lock in your money for long periods though, do build up a bank deposit equal to about 6-9 months' worth of your living expenses, as an emergency fund. Do buy a health insurance plan, so that your savings aren't dented badly by a medical emergency.

A. There are three things to keep in mind as you begin your investing journey. One, to invest effectively and to stick to your planned course on investments, it would be good to write down your key financial goals and the timelines over which you would like to achieve them. For example, you may plan to travel, buy a vehicle or pursue higher education within the next three years, marry or buy a home over 5 to 7 years, nurture dreams of becoming wealthy or retiring early 10-20 years hence. If you have family members for whom you'd like to do something, include those objectives in your goals too. Mapping out your goals is important because they lend purpose to your savings and investments and helps you to choose investment vehicles that fit your goal and investment horizon.

For goals up to 5 years, bank and NBFC deposits can be a good option. So can short-term debt, PSU and banking debt mutual funds. For 5 to 7-year goals, small savings schemes like NSC and GOI floating rate savings bonds would be a good bet.

You can also consider hybrid mutual funds. For goals that are 7 years plus, Public Provident Fund, NPS and index mutual funds playing on the Nifty50 or Nifty Next50

would make for good choices. Two, before you start making the above investments, estimate your likely monthly living expenses and build a fund equal to 6-9 months' worth of those expenses from your initial savings. It can help you tide over illness, job loss or other emergencies that

In addition, do buy a health insurance policy of ₹5-10 lakh to cover hospitalisation expenses. If you have parents or siblings dependent on you, get a term- insurance policy so that their financial interests are taken care of in the event of an unfortunate event happening to you.

Three, get into the habit of saving before spending each month. Signing up for investment products that put your investments on autopilot, by channelling money out of your salary account at the beginning of each month, can help you get into a regular savings habit. Recurring deposits and Systematic Investment Plans of mutual funds are two good ways to do this. Strive to save a minimum 15-20% of your monthly pay towards investments.

Seven months, 25 issues. 80, 100, 120% in listing-day returns. IPOs this year are a starry lot! If you were among those that received allotments in IPO applications and made good money, you'd be sitting happy. But if you didn't apply or weren't allotted any shares, don't bemoan the missed opportunities. Here is what you should know about IPOs.

No sure-shot returns

IPOs are sought after in the belief that they serve up return opportunities that you won't find in 'older' or existing stocks. But does that pan out in reality? Not quite. Let's take it from two perspectives.

First, the purely fundamental perspective - that is, looking at an IPO based on its business strength and growth prospects for long-term holding. On this count, long-term returns for IPOs do not boast of anything special, with most of them putting up mediocre performance. Those that have delivered multifold are few. Over the past 15 years, there have been roughly about 325 IPOs. Of these, almosty half are below issue price i.e, in the long term, they have been poor performers.

Prospects always depend on the business itself and the valuations at the time of the issue. For a stock to be a good long-

term investment. it needs have a strong business and you need to buy it at reasonable valuations; this means you also need the freedom to wait for business prospects to improve or the right valuation to come

aspect. It's logical that the company will try to maximise issue proceeds and will price it accordingly - and IPOs that come in bull markets, such as now, can get away with pricey earnings multiples. Therefore, many IPOs slip post listing because their pricing left little on the table for long-term investors.

Second is the listing-gains perspective. Recent IPOs such as those of Tatva Chintan Pharma, GR Infraprojects or Zomato have seen exuberant listing, with listing day gains of close to or over 100%

Listing gains, though, are a factor of the market scenario. how fancied the IPO is in context of the market scenario and more than a little luck.

post-listing returns, it is hard to say beforehand what a stock does on listing day. Oversubscription, institutional interest or even grey-market premiums are not sure-fire ways to gauge what listing returns can be. A turn of market mood between the IPO launch and its listing, for example, can dampen even fancied themes.

Finally, there's no way to know if and how many shares you will receive in IPO allotments. Small allotments will have no meaningful impact on your wealth creation.

But if you're looking for IPOs where the business strength is sound and which can be part of your stock portfolio, then all you need to do is bide your

Second chances

IPOs that have made good money for investors haven't always been on an upward trend. Consider V-Mart Retail, which today has delivered a 41% CAGR from its issue in 2013. That stock had almost halved from its issue price just six months after listing. The post-listing period, therefore, offered plenty of buying opportunities. The com-

pany was also able to showcase its ability to keep revenue growth up and skirt around the troubles that dogged other retail players.

Post-IPO periods help give a deeper understanding of how a company performs across business cycles - something that is hard to gauge from an IPO prospectus that gives limited data on historical performance. Several other IPOs that have gone on to create wealth such as Galaxy Surfactants, Rail Vikas Nigam, Aavas Financiers, Fine Organics and Mishra Dhatu

Nigam, all dropped post listing. But even if IPOs don't correct, that does not mean there are no investment opportunities. Companies with sound businesses can be buys, and valuations buttressed by steady earnings accretion, even if prices don't correct after listing. Take Jubilant FoodWorks. This stock hasn't dipped below its 2013 issue price - but it has made money even for those who got in much later. Other examples include Dr. Lalpath Labs, HDFC AMC, or Sheela Foam.

The more recent crop of IPOs - those that have come over the past couple of years have certainly offered slightly more differentiated opportunities. IPOs of AMCs, small finance banks, retail and consumption and so on, for instance. But when business strength is sound, the secondary market still offers the grounds to pick these up.

Put simply, IPOs offer no special opportunities. Stocks that shoot through the roof on listing are more an exception than the norm. So, if you identify a good business in an IPO, go right ahead and subscribe. But should allotments be low or nil, don't sweat it. Add these stocks to your watchlist and bide your time to enter.

## Let not the small print surprise you

Claims payment is a sticky point for any policyholder, but is the insurer to blame?

K. NITYA KALYANI

It's cliché that insurance companies 'find' a way not to pay your claim. However, when the way' had already been spelt out in your policy, it was up to you to be aware.

'The large print giveth and the small print taketh away' is exactly how my friend felt about the hospitalisation policy for her mother.

The policy was taken when her mother was well over 70 and the insurance company would offer only ₹2 lakh as sum assured to start with. As is usual, plans of enhancing the sum assured at subsequent renewals were forgotten.

When she required an operation, reality dawned that the daily room rent allowed under the policy was limited to 1% of the sum assured, that is, ₹2,000 per day.

However, the rate for the category of room that my friend's family preferred cost four to five times as much.

This was not the only setback. In many hospitals, most other treatment costs including medical practitioners' fees and ICU charges are pegged to the category of room you are in. That is, if you are in a semi-priv-

ate room costing ₹8,000, your surgeon's fee would be ₹X. If you were in a private room costing ₹12,000, it would be 1.5 times ₹X. There is some logic in there somewhere, but it was a total let-down for my friend who thought that she would be able to claim ₹2 lakh.

Sub-limits are only one type of small print that you have to become familiar with. If you had been aware of this, you may have been focussed on increasing your sum assured or taking an additional policy. Or, maybe, you would have had a rethink about a policy at all.

Other 'small-print' clauses in your hospitalisation policy, which, by regulation cannot be in actual small print, include standard exclusions, timebound exclusions and specified limits for certain treatments.

**Policy exclusions** 

Standard exclusions would include treatment outside India, treatment for self-inflicted injuries and cosmetic surgery except if necessitated due to an

Time-bound exclusion refers to the waiting period - usually about 3 to 4 years after taking the policy - when pre-existing diseases are not covered. Some procedures are covered only after a 2-year waiting period and they will be listed on your policy document.

Some treatments, such as cataract surgery, have specified claim limits. Usually, you can enhance these limits by paying an extra premium.

Read in depth

So, it pays to read through what each policy offers and excludes and to spend quality time comparing the offerings of different companies before you sign up. Hospitalisation insurance is an enduring requirement and you are assured of lifelong renewal from your insurance company as per regulations.

Though you have the comfort of portability, which means you can change your policy from one insurance company to another, making the correct decision on the right fit the first time around is a prudent way to spend your premium money.

## When expectation does not match reality

The policy schedule sets out clauses

Many disappointments with insurance policies are a result of expectation and reality. But here's the thing. All the clauses, the ifs and buts, in your policy are available for you to read before you buy. You just have to ask your agent for a policy schedule and see what clauses apply to you depending on the options you choose.

In a typical motor insurance claim, for example, your cost of repairs/ spares/ replacement will not be given in full.

The cost of plastic and fibre-glass parts will be adjusted for depreciation, and these rates will be stated right there in your policy.

Depreciation will also apply on the entire claim depending on the age of the vehicle and can go up to 50%. You can usually purchase additional cover for the depreciation.

Compulsory excess

These days most policies come with a compulsory excess, also called a compulsory deductible. This is a specified flat amount, the first

part of the claim that you have to bear yourself. In ad-

dition to this, you can opt for a voluntary excess or voluntary deductible and you will get a discount in your premium.

In health insurance, there can be an excess and there can also be a co-pay. This will be a percentage of each claim that you have to bear, as different from a flat sum. Considering that the larger your claim, the larger your co-pay, it is worth being aware of this well ahead of time, before you sign up.

Once you know you have to to look for these so-called small-print clauses, you can shop around for your policy with other insurance providers whose terms suit you better. Or, at the least, you will go in with your eyes

## An unblemished show amidst intense scrutiny and raging pandemic

After successfully organising the delayed sporting extravaganza, the Japanese capital officially hands over the baton to Paris, the 2024 host

...and scene! The Tokyo Olympics, held during a raging pandemic, drew the curtains down on Sunday. The host nation finished third with 27 golds and a total of 58 medals, a vast improvement from its 12 golds and 41 medals in 2016. But it will take greater pride that its biobubble largely were intact.

The Games were held under intense scrutiny and amid constant pressure from locals, but the organisers managed to pull off a clean

Scores of people gathered around the Tokyo Olympic

Among the horde of people gathered in the narrow by-lane outside the stadium was Santosh from Pune, who has lived in Tokyo for three

He brought his wife, and his child on a stroller, to watch the fireworks. But they were not able to catch a glimpse of Olympic medallist Bajrang Punia who carried the Indian flag for the closing ceremony.

It was a carnival on the streets. People turned up in cosplay suits, one came in a Wonderwoman costume and was accompanied by an elderly citizen donning a Superman T-shirt.

They were ready for a party but were confined to a morose evening on the sidewalks. The entry to the stadium was restricted to athletes, officials, VIP guests and members of the media.

The policemen circling the stadium were watchful to sniff out any untoward incident. A group of stray cyclists

took a wrong turn, and they were onto them in a split-second to redirect them. A few hundred protesters turned up with placards that read "Abolish Olympics" and "#GetOutBach", but it ended peacefully. On the other side

of the road, under the magnificent wooden roof of the stadium, International Olympic Committee president

Thomas Bach thanked the Japanese authorities for their support.

"These were unprece-

dented Olympic Games. It took us, the IOC and our Japanese partners and friends, an equally unprecedented effort to make them happen. This is why I would like to thank the Japanese authorities at all levels, in particular Prime Minister Suga Yoshihide and Governor Koike Yuriko, for their steadfast commitment. Thank you for staying with us on the side of the athletes, who were longing so much for these Olvmpic Games," he said.

#### Appreciation

"Our deep gratitude and appreciation go to the organising committee. Nobody has ever organised a postponed Olympic Games before."

Tokyo, which will now host the Paralympic Games from August 24, officially handed the baton to Paris. And now we wait for three more years, in the hope that India, which won an unprecedented seven medals here, can script history yet again.

## How Neeraj struck gold

The 23-year-old practised the art of visualisation

Neeraj Chopra sits in a quiet space, imagines he's walking into the Tokyo Olympics Stadium. He gets ready, makes his approach run and lets the javelin soar. The 23-yearold practised the art of visualisation and played this scenario in his mind for months leading up to the Tokyo Olympics.

His focus in these sessions was purely on technique and not the outcome. On August 7, the outcome was an Olympics gold medal.

He could barely sleep the night before the event. "I wanted to sleep early but couldn't. I managed to sleep around 12:30 a.m. and I was wide awake by 5.30 a.m. I tried to sleep again because rest is essential for recovery, but I wasn't able to. I had breakfast and tried again, but I was wide awake in an hour. Aisa lag raha tha ki mere shareer se aag nikal raha tha, aisa garam tha. Josh bahut tha (It felt like my body was radiating fire. #### Challenges aplenty

There were challenges aplenty in the final stretch. For instance, getting the body and mind used to the seven-hour time difference between Tokyo and Sweden, where he trained for more than a month before the Olympics.

"It took some time to get used to the time difference. I would sleep a little late, so, I was hoping to sleep longer in the mornings. But the doping control officers showed up at 5.45 a.m. or 6 a.m. for the past two days and whisked me away. Par



The effects of climate change will force sports bodies to rethink their calendar of events, World Athletics president Sebastian Coe said on Sunday.

Coe, a two-time Olympic champion, was speaking on the final day of the Tokyo Games. The extreme heat and humidity in Japan forced changes to the track schedule, as well as tennis and women's soccer.

"You don't have to be a devotee of climate change or a denier to know the world is getting hotter," Coe said.

"It probably will mean a global discussion around the calendar and how we stage events."

Coe noted the stress on his staff of "having to create

In July 2022, the track world championships will be held in Eugene, Oregon, where a record heatwave raised temperatures to 108 degrees Fahrenheit (42 degrees Celsius) at the U.S. trials in Iune. Morning sessions were suspended.

#### New norm

"The new norm is, particularly in dealing with endurance events, really harsh climatic conditions," Coe said.

"The reality of it is, I think this a challenge we are all going to confront now," said Coe, who is an IOC member.

"If you are going to be intellectually coherent here, we are going to have to have that debate," Coe said, predicting sports bodies will be "revisiting what is possible and probably having to be more adaptable in future."

Indian boxer Vikas Krishan. whose Olympic campaign ended abruptly after a dislocated right shoulder caused an opening-round loss, has undergone a surgery to fix the injury which will keep him out of action for the next three months.

The 29-year-old, who was competing in his third Olympics, was forced out early after "fighting with one hand" in the opening clash against Japan's Sewon Okazawa.

The surgery on his dislocated shoulder was performed at Mumbai's Kokilaben Hospital by renowned surgeon Dr. Dinshaw Pardiwala, who operated and

fixed a career-threatening shoulder injury that newlycrowned Olympic gold-winner Neeraj Chopra had suffered in 2019.

Dr. Pardiwala has also operated top cricketers like Jasprit Bumrah and Shreyas Iyer along with shuttler Saina Nehwal, among others.

"I will be back in three months, I have been assured by Dr. Pardiwala. My shoulder had dislocated and a crucial muscle, called Subscapularis, and a ligament had been torn," the decorated boxer said after his surgery that took place on Thursday.

Vikas picked up the injury during the training trip to Italy before the Olympics. Unaware of the severity of the damage, he competed in the Olympics after taking painkilling injections.

Dr. Pardiwala said given the scale of the injury, painkillers were never going to be enough. "It was quite valiant of him to have gone ahead and fought the bout," Dr Pardiwala said.

"He told me that he experienced a dead arm during the bout. It will take three weeks for the healing to be completed and another three months for rehab."
