## SC decides to hear case on U.P. violence today

It takes *suo motu* cognisance of Lakhimpur Kheri incidents

In a significant move, the Supreme Court on Wednesday took suo motu cognisance of the Lakhimpur Kheri violence and deaths, and listed the case for hearing in the next 24 hours.

A three-judge Bench, led by Chief Justice of India N.V. Ramana, will hear the suo motu case on Thursday.

The CJI will be flanked by Justices Surya Kant and Hima Kohli on the Bench.

Eight people have died, four of whom were reportedly farmers who were mowed down by a vehicle which was part of the convoy of Union Minister of State for Home Affairs and Bharatiya Janata Party (BJP) MP Ajay Kumar Mishra, in Lakhimpur Kheri in northcentral Uttar Pradesh. A journalist was among the eight who died.

The top court rarely takes up issues or incidents on its own motion unless they are of such consequence or seriousness that ignoring them would affect public interest, basic rights and the conscience of the country.

The court's decision to take up the case, now titled 'In re: Violence in Lakhimpur Kheri (U.P.) leading to loss of life' comes just 48 hours after a Bench of the

### Second autopsy silent on bullet injury: farmer's family

## Civilian killings cause concern in J&K

Targeted attacks meant to evoke fear, says J&K DGP

More civilians than security forces have been killed this year in Jammu and Kashmir (J&K) in various terrorismrelated incidents. The targeted killing of civilians, including prominent citizens and non-locals in the Valley, reverses the trend of the past six years, data show.

Till October 5 this year, as many as 22 civilians were killed in the Valley as against 20 security personnel in the same period. In 2020, the **Fatality count**

number of civilians who were killed stood at 33, while the number of security forces who were killed was 46 and in the year 2019, it was 36 civilians and 78 security

### NEET-SS new pattern plan dropped, says govt.

It has been put off to 2022, SC told

The Union Government on Wednesday turned around to inform the Supreme Court that it has dropped its decision to implement a new pattern for the National Eligibility-cum-Entrance Specialties **Test-Super** (NEET-SS) 2021 due in November.

Faced with criticism from the court for the sudden manner in which the new pattern is to be introduced at the last minute this aca-

demic year, the Centre, represented by Additional Solicitor-General Aishwarya Bhati, said the implementation of the new pattern had been postponed to 2022.

The November exam would follow the existing pattern, she submitted. "In deference of your lordship's observations & interest of students, the Centre has decided that the revised scheme will be implemented from 2022," she stated.

### WHO recommends first anti-malarial vaccine

Children in sub-Saharan Africa to get it

In a historic move, the World Health Organization (WHO) on Wednesday endorsed the first anti-malarial vaccine, as mankind enters a key turning point in a battle waged relentlessly over decades between man and mosquito, the vector.

At a press conference that went live on social media, WHO Director-General Tedros Adhanom Ghebreyesus said: "The long-awaited malaria vaccine for children is

a breakthrough for science, child health and malaria control... Using this vaccine on top of existing tools to prevent malaria could save tens of thousands of young lives each year."

The WHO said that it was recommending the use of the RTS, S/ASO1 (RTS, S) malaria vaccine among children in sub-Saharan Africa and in other regions with moderate to high P. falciparum malaria transmission.



## Delhi govt.'s campaign against dust pollution to start today

Over 30 teams formed to ensure implementation and compliance of rules: Rai

The Delhi government will run an anti-dust campaign from October 7 to 29 to curb pollution. Over 30 teams have been formed to carry out inspections, said Environment Minister Gopal Rai.

The government also released a list of 14 rules to be followed by all construction sites. Most of these rules are part of the existing guidelines by the Central Pollution Control Board, which is to be followed by all construction sites round the year.

"Today, we held a joint meeting with the engineers of the DPCC [Delhi Pollution Control Committee] and the green marshals of the Green War Room. We have decided that dust pollution will be fought on a priority basis. From October 7 to 29, we will run an anti-dust campaign in Delhi with full force," Mr. Rai

The Delhi government had run a similar campaign last

year too, before the air pollution levels spiked in winter.

According to officials, the rules are not new, but the government will put more manpower to implement the them during the campaign and increase compliance.

"Our teams will conduct inspections on construction sites and monitor the situation. The first phase of this campaign will begin tomorrow and continue till October 29. A total of 31 teams have

been formed for this purpose. Of these, 17 teams of DPCC engineers will work across various districts and 14 teams of green marshals will work with mobile vans," the Minister said.

#### Warned of action

He also warned of action against government agencies not following the rules while engaged in construction ac-

"In case we observe that

any department is not taking suitable action, then a showcause notice will be issued to them. In case the department is unable to clarify the show-cause notice within two days, they will be penalised," Mr. Rai said.

In case of violations, if a plot is up to 100 square metres, it can be fined ₹10,000. The fine can be ₹20,000 for 100-200 square metres, and if the plot is 20,000 metres, then the government can charge a penalty to the tune of ₹5 lakh or above.

Air pollution in the city rises during winter, chiefly due to a combined effect of stubble burning in the neighbouring States and climatic conditions, which lowers wind speed and mixing height, in turn trapping pollutants. On Monday, Chief Minister Arvind Kejriwal announced a plan to combat pollution during winter and action against dust pollution is a part of it.

### Judge critical of police probe in riots cases transferred

A day earlier, ASJ had said police witness was 'lying on oath'

Additional Sessions Judge Vinod Yadav, who was presiding over several cases related to the north-east Delhi riots at the Karkardooma court. was on Wednesday transferred to the Rouse Avenue court where he will serve as a Special Judge for cases pertaining to the Prevention of Corruption Act.

ASJ Yadav has been replaced by Virender Bhatt, who earlier served as Special Judge at Rouse Avenue court. The transfer order issued

by the Delhi High Court included seven Metropolitan Magistrates and four Additional Sessions Judges.

In addition to ASJ Yadav, Metropolitan Magistrate Fahad Uddin, who presided over another of the four special courts hearing matters related to the February 2020 riots, has been transferred as Metropolitan Magistrate, Tis Hazari court. Shama Gupta will replace him.

While hearing the riots

cases, ASJ Yadav had passed several scathing orders and pointed out loopholes in investigations. During one such hearing last month, he had observed that "failure to conduct a proper investigation will torment sentinels of democracy".

#### 'Sorry state of affairs'

A day before his transfer, ASJ Yadav had come down heavily on Delhi Police, saying one of its witnesses was "lying on oath"and it was "a very sorry state of affairs". He had asked DCP (Northeast) for a report in the matter

He made the observation after Head Constable Sanoj stated on oath in his evidence that he had identified three rioters by their names and professions, namely Vikas Kashyap, Golu Kashyap and Rinku Subziwala. However, Assistant Sub-Inspector Ram Dass stated in his evidence that the three accused "could not be identified during investigation".

ASJ Yadav in his order said

it appeared prima facie that one of the police witnesses in the case was lying on oath and the same was punishable under IPC Section 193 (punishment for false evidence).

The court noted that while the Head Constable had categorically asserted about the accused's presence at the spot, it was however admitted by the Investigating Officer (IO) "that there is nothing on record to substantiate that matter" and the fact that the three men were ever investigated despite their names being there on record.

"On the contrary, it is stated that the identity of these accused persons could not be established during investigation," the order read. ASI Yaday further said there was no material available on record which showed that efforts were made by the IO to apprehend the three men. The case pertains to incidents of robbery and vandalism at multiple houses during the riots in the Johripur Pulia area.

### Mother, twins die in house fire

Blaze was caused due to leakage in LPG rubber pipe: police

A 36-year-old woman and her twin children died while another daughter sustained injuries when their house caught fire following a gas leak, in central Delhi's Anand Parbat on Tuesday morning.

DCP (Central) Shweta Chauhan said the victims were identified as Sushila seven-vear-old and her twins - Mohan and Mansi. The injured daughter has been identified as Monika, 10, while another daughter Mehak, 13, escaped unhurt.

Police said that a PCR call was received at 9.02 a.m. regarding fire in a house. When they reached the spot in Punjabi Basti's Gulshan Chowk, four persons were found with burn injuries and were rushed to Ram Manohar Lohia Hospital. Sushila was declared dead and the twins succumbed to injuries during treatment, the police said, adding that Monika is undergoing treatment at Safdarjung Hospital.

Sushila's husband was at his workplace in Lawrence Road at the time of the incident.

Mehak said she was preparing tea for the mother and her siblings when the house suddenly caught fire. "I turned on the stove and it suddenly caught fire. I was close to the door of our room so I managed to escape. But the room is small and my mother and siblings were inside. They couldn't come out," she said.

"The fire was caused due to leakage in rubber pipe which connects the cylinder to the burner," Ms. Chauhan said. Delhi Fire Service said fire tenders pressed into service.

### DU issues guidelines on inclusion of State board subjects in cut-off calculation

'Colleges were rejecting applications without proper reason'

On the third day of DU admissions in various undergraduate programmes under the first cut-off list, around 59,000 applications were received by the university. Over 13,000 applications have been verified, a university spokesperson said.

Responding to the trend of a large number of students from State Education Boards securing admissions into colleges, DU has issued guidelines on inclusion of subjects

from other State boards equivalent to ones taught under the Central Board of Secondary Education in the calculation of cut-off marks.

Many candidates had complained that colleges were rejecting or withholding applications without substantial reason.

A DU official said that an equivalence committee, set up by the university, held a meeting to decide which subjects from State boards would be equivalent to CBSE subjects and if they could be included while calculating the "best four" subjects to arrive at the cut-off score. The official said that these guidelines have been shared with colleges after many requests were raised asking if particular subjects that are offered by State boards but not by CBSE could be included.

The Students' Federation of India said that DU is bound to admit students satisfying all eligibility criteria and that it is a matter of shame that applicants are being discriminated based on their boards.



### Telangana withdraws plea in SC on Krishna water

'Union Minister stated that the Centre will consider tribunal'

LEGAL CORRESPONDENT

Telangana on October 6 withdrew its plea in the Supreme Court for "equitable apportionment" of the Krishna River water on the basis of an assurance given by the Centre that it will "consider" constituting a tribunal to resolve the issue. Appearing before a Bench

led by Justice D.Y. Chandrachud, Telangana, in an application, said the Union Minister, in a meeting, stated that if the State withdrew its case from the Supreme Court, the Centre would "positively" consider forming a tribunal under Inter State River Water Disputes Act of 1956 after taking necessary legal opinion.

'Legal opinion'

Taking "legal opinion" before forming a new tribunal on the issue of Krishna River water sharing was necessary as

the Krishna Water Disputes Tribunal (KWDT II) was already seized of the inter-States'

Telangana had come to the Supreme Court complaining that it had been "unjustly denied" an equitable allocation of the water.

It had made the Centre and the riparian States of Andhra Pradesh, Karnataka Maharashtra respondents.

In its plea, Telangana had

complained to the Supreme Court that it had written a letter to the Centre in 2014 to constitute a tribunal under Section 3 of the Inter State River Water Disputes Act of 1956 to adjudicate the issue.

While the matter was pending with the Supreme Court, Telangana said the Union Minister, during a meeting, put forward the proposition to consider constituting the tribunal provided the State withdrew its case.

### Call for law on 'right to health care' revived

The Congress had promised this in its 2018 Assembly election manifesto

The demand for the enactment of a legislation on the right to health care, for which the ruling Congress had made a promise in its manifesto for the 2018 Assembly election, has been revived in Rajasthan. Health activists here affirmed that the law would streamline medical services and guarantee the availability of essential facilities to citizens.

'No burden on govt.'

The Jan Swasthya Abhiyan (JSA), a network of civil society organisations, has pointed out that the implementation of a statutory right to health care would not put any immediate financial burden on the State government as a sufficient number of doctors, health service providers, buildings, equipment and medicines are already available. The law, if enacted, is expected to strengthen the monitoring system in the health sector.



The law will ensure availability of essential services to all.

The JSA, which functions as the Rajasthan chapter of the global non-profit People's Health Movement, had prepared a draft Act on the subject and submitted it to the Health Department authorities shortly after the government formed in December 2018. No progress has been made in the enactment of the statute despite the lapse of two-and-a-half years.

Chhaya Pachauli, director of the voluntary group Prayas, said here on Wednesday that the State had gone through the COVID-19 pandemic in this interval, in which several lives had been lost and many patients had to spend huge amounts of money out of their pockets for treatment.

"Had the Act been implemented, many lives could have been saved and the exduced," Ms. Pachauli said.

Representatives of health rights groups and public health specialists discussed the issue at a State-level consultation here recently and demanded that the State government bring a Bill on the right to healthcare in the Assembly on the basis of the draft provided by the JSA. The legislation should ensure access for every citizen to basic healthcare services within 3 km of his or her residence.

Ms. Pachauli said the draft Act had laid emphasis on institutional mechanisms, such as social audit and public dialogues, to augment community participation in healthcare planning. A thorough assessment of all the primary health centres operating on the public private partnership (PPP) mode should also be carried out and any centre found below the standards should be immediately withdrawn from the PPP scheme, she said.

### 6 more held in Telugu Akademi scam

Accused illegally withdrew ₹64.50 crore from 43 FDs

STAFF REPORTER HYDERABAD

Hyderabad police on Wednesday claimed to have unravelled the Telugu Akademi's Fixed Deposits (FD) fraud. With the arrest of six more persons, including kingpin Chanduri Venkata Koti Sai Kumar (49).

Since December last, the accused persons swindled ₹64.50 crore out of the Akademi's 43 FDs in Karwan and Santosh Nagar branches of Union Bank of India and Canara Bank's Chanda Nagar branch. Surprisingly, police managed to recover only a few lakhs from the accused.

The mastermind behind the fraud, Sai Kumar, a real-

tor from the city was previously involved in similar offences in Andhra Pradesh and Chennai. He withdrew the FDRs of AP Minority Welfare Society in 2012 and the case is being investigated by the Crime Investigation Department (CID). Sai Kumar was also accused in AP Housing Board scam of nearly ₹6 crore and ₹25 crore FDR fraud of Northern Coal Fields in Chennai, both cases are being investigated by the Central Bureau of Investiga-

The other accused include Akademi's administrative officer and in-charge accounts officer Segoori Ramesh, Canara Bank's Chanda Nagar branch manager M Sadhana. Nanduri Venkata Ramana from Tanuku in West Godavari district. Venkateshwar Rao, a self-proclaimed registered medical practitioner and a realtor from Sathupallu in Khammam district and Somashekar alias Raj Kumar, a realtor from Dharmavaram.

"Except the bank employees, all other accused are in one way or the other involved in real estate," Hyderabad Commissioner of Police Anjani Kumar said. He said the accused persons have illegally withdrawn the money cleared their debts, invested in real estate and used the

Dilip Basak, 56, has been in the profession since the age of 11

"It's my nesha and not pesha [it's an addiction and not just a profession]," says Dilip Basak, 56, about his livelihood, which happens to be repairing fountain pens. If the Mont Blanc or Waterman on your desk – whether inherited from your grandfather or a new purchase - has developed a snag, Mr. Basak is not only likely to diagnose the problem but also fix it for

"I am the only person in whole of India who is still in this profession," Mr. Basak declares, adding, "and I am

able to make both ends

While it may be debatable whether he is the only one in the whole country doing this iob, there is no doubt he is one of the very few, and certainly a highly respected

member of the several groups on Facebook and WhatsApp formed by connoisseurs of the good, old fountain pen. Mr. Basak's fame among

pen lovers is inversely proportionate to the size of his workplace – a narrow rectangular space under a staircase of an old building in Bhabanipur – which he inherited, along with the profession, from his father Bholanath Basak, who died in 1998.

"I was hardly 11 or 12 when I got into this line, holding my father's hand. I will tell you why I came into the profession this early. I was a good student in school, always stood first or second, but one particular year, they refused to hand me the results because I hadn't paid the fee. My father eventually managed to get the money, but by then I had decided I will never return to school," Mr. Basak says.

Having dropped out of school that early, Mr. Basak himself may not be highly skilled with the written word. but fountain pens repaired by him have presumably scripted important moments in history. Pens he has fixed include those belonging to Satyajit Ray and Jyoti Basu.

"They never came to me personally, of course. Their pens were brought to me by dealers or the showroom people, who would tell me, 'Handle this with care, they belong to so-and-so'. For a long time, pens from the Raj Bhavan also came for repair," he recalls.

Fountain pens going out of fashion – combined with Mr. Basak deciding to stick to his profession – has only helped add to his popularity as a res-

The Tamil Nadu government on Wednesday announced the constitution of a welfare board for non-resident Tamils under the Tamil Nadu Non-Resident Tamils' Welfare Act, 2011.

The law was brought in at the fag end of the M. Karunanidhi government of 2006-11. But the AIADMK government (2011-21) did not constitute the board.

On Wednesday, Chief Minister M.K. Stalin said the board would have 13 members, including officials and representatives of the nonresident Tamils. The Tamil Nadu Non-Resident Tamils Welfare Fund would be created with an initial corpus of ₹5 crore.

A senior official told The *Hindu* that the board would focus on the welfare of nonresident Tamils and implement schemes for them. The Commissionerate of Rehabilitation and Welfare of Non-Resident Tamils would be involved in inter-departmental initiatives and those of the

A database of the non-resident Tamils would be created and those who had registered themselves with the board would be extended life and medical insurance cov-

Union Government.

er. "In case of the death of emigrants of low-income groups, financial assistance would be given to their children for education and marriage," Mr. Stalin said.

#### Legal aid centre

A centre would be opened to provide legal aid to non-resident Tamils. Since more than 7 lakh workers have returned to the State because of the impact of COVID-19, ₹6 crore would be earmarked

for extending them loans to become entrepreneurs.

"A majority of the non-resident Tamils are keen on depositing their savings in Tamil Nadu. Steps would be taken to sign MoUs to help them deposit [their money] in government and other industries," Mr. Stalin said.

#### Infrastructure scheme

Under a scheme, 'My Village', the non-resident Tamils can develop civic infrastructure and schools in their native villages. "They would be invited to help improve schools, hospitals, libraries...," the Chief Minister said.

All non-resident Tamils' welfare associations in various countries would be integrated and ₹4 crore would be allocated for cultural exchanges and interactions among them.

January 12 would be observed as the Day of Non-Resident Tamils, the Chief Minister said.

A sum of ₹6.40 crore would be allotted for constituting the welfare board and fund, ₹8.10 crore for welfare schemes and ₹5.50 crore for promoting art, literature and cultural exchanges.

Steps would be taken to impart Tamil lessons to the wards of non-resident Tamils through Tamil Virtual Un-

### NIA nabs former LTTE intelligence operative

The National Investigation Agency (NIA) nabbed a senior intelligence operative of the defunct Liberation Tigers of Tamil Eelam in Chennai on Tuesday.

Preliminary investigation revealed that the suspect, Satkunam alias Sabesan, 47, a Sri Lankan Tamil and a former member of the LTTE's in-

telligence wing, had transferred huge money to former cadres or sympathisers of the outfit to revive the movement in the island nation.

Searches on his premises and other places led to recovery of incriminating material, including details of the money flow from Tamil Nadu to Sri Lanka in the recent years, sources in the agency

NIA investigators were tracking Satkunam following specific inputs on his involvement in arms and drugs trafficking operations from Pakistan to Sri Lanka. The sources said Satkunam was among the trusted lieutenants of LTTE leader V. Prabhakaran. He was also closely associated with the then LTTE intelligence chief Pottu

### 'Dalits are people, have lives, wives, children'

Their lives get lost in description: Tully

SPECIAL CORRESPONDENT

When some write about oppressed people, the human being gets lost in a lot of adjectival description, former journalist and author Mark Tully said, adding that he doesn't want to underestianyone suffering.

He was speaking at a discussion organised by the Madras Book Club on his new book, *Upcountry* Tales, with N. Ram, Director, THG Publishing Group Pvt Ltd. "I don't want to underestimate anyone's suffering. I do want people to remember that Dalits are people, individuals, have lives, wives, children... We must have some description, but just as I see, sometimes Dalit lives get lost [in the writing]," he said, speaking about one of the stories in the book about a Dalit defying tradition to build a temple.

Mr. Ram said the people Mr. Tully speaks about in the book are not ordinary people but they are also not prominent.

"There are serious stories and some light-hearted ones as well. Tully has been engaging in key questions of modern Indian history...the [British] Raj, whether it had any impact, the impact of railways, Gandhi vs Nehru and so on...," he said and asked whether Mr. Tully was raising these questions through his characters.

#### 'Hangover of Raj'

"The hangover of the Raj went on for too long. It is going away now but whether it is going away in the right way has to be seen. I don't think India has still yet fully come face to face with the question of 'Asli Hindustan'. If you talk of 'Asli Hindustan', you are immediately deemed a support of Hindutva. India doesn't equal Hindutva," Mr. Tully explained.

Mr. Tully said one of the things he had learnt from India was that one must never go overboard over anything and about not seeing everything in just black and white.





### Recognising altruism

Good Samaritans can help reduce accident deaths, but road safety needs more work

The initiative of the Ministry of Road Transport and Highways to award Good Samaritans who save lives of road accident victims with a cash prize is a welcome attempt to reduce India's staggering annual death toll from mishaps. Ranking third among 20 nations that have the highest number of accidents, India fares far worse on an important metric – cases to fatalities ratio - compared to the U.S. and Japan, which have more recorded crashes but fewer deaths. During 2020, even with severely disrupted mobility due to CO-VID-19, National Crime Records Bureau data show 1,33,715 lives were lost in 1,20,716 cases attributed to negligence relating to road accidents. Under the Motor Vehicles law, a Good Samaritan voluntarily helps an accident victim with no expectation of payment or reward, and has no legal obligation to record his involvement or aid the investigation in the case. In spite of an entire chapter being added to the Motor Vehicles Act last year to sensitise police forces and hospitals on this, altruism is affected by the perception of harassment and legal complications. The Ministry's latest move seeks to overcome reticence by rewarding socially minded individuals who offer immediate assistance and rush a victim with certain kinds of injuries to hospital, with ₹5,000 and a certificate of recognition for saving a life. State governments are responsible for the plan, with the Centre providing an initial grant, but the Union Transport Ministry will give its own award of ₹1 lakh each to the 10 best Good Samaritans in a year.

Achieving a reduction in mortality on India's largely lawless roads warrants determined action on several factors, beginning with scientific road design and standards, and zero tolerance enforcement. It was only on September 3 that the Centre notified the long-pending National Road Safety Board, with a mandate to formulate standards on, among other things, safety and trauma management, to build capacity among traffic police, and put crash investigation on a scientific footing. Yet, on enforcement, State police forces generally appear to favour a populist approach of least engagement; regional transport bureaucracies - compared by Union Transport Minister Nitin Gadkari in 2015 to looting Chambal dacoits – can also benefit from a shake-up. As a steadily motorising country, the goal must be to reduce accidents and the ratio of deaths and injuries to cases. The Good Samaritan plan can work well if District Committees tasked with awarding these individuals readily recognise their contribution, aided by the police, hospitals and RTOs. Many more people will continue to be impelled by sheer altruism to help road users involved in a crash, and governments should get bureaucratic barriers out of their way.

### Sensing heat

Genetic mutations in cellular mechanism of temperature, pain sensation are insightful

his year's Nobel Prize for Physiology or Medicine warded to the researchers. David Julius and Ardem Patapoutian from the University of California, San Francisco and Scripps Research in La Jolla, California, respectively – recognises their seminal work in identifying the gene and understanding the mechanism through which our body perceives temperature and pressure. Our ability to sense touch and temperature – particularly noxious temperature – is essential for our survival and determines how we interact with our internal and external environment; chronic pain results when the pain response goes awry. Dr. Julius utilised capsaicin, a key ingredient in hot chilli peppers that induces a burning sensation, to identify a sensor in the nerve endings of the skin and the cellular mechanism that responds to uncomfortably hot temperatures. The receptor for heat gets activated only above 40° C, which is close to the psychophysical threshold for thermal pain, thus allowing us to react to external heat. In 2002, five years after the heat sensor was discovered, the two laureates, and independently, used menthol to discover the receptor that senses cold temperatures. Recent studies have found that discrimination between warm and cool temperatures is possible only through simultaneous activation of warmth-sensing nerve fibres and inhibition of cold-sensing nerve fibres. Using pressure-sensitive cells, Dr. Patapoutian discovered a novel class of mechanical sensors that responds to pressure on the skin and internal organs, and the perception of touch and proprioception – the ability to feel the position and movement of our body parts. The cellular mechanism that senses touch also regulates important physiological processes. Besides laboratory work, insights have been gained by studying people carrying genetic mutations in the cellular mechanism of temperature, pain, touch and pressure sensation.

The discovery of pain receptors and the cellular mechanism have attracted pharmaceutical companies as these could be targets for novel medicines. Though there are challenges to be addressed before such drugs can be clinically meaningful, the hope is that newer approaches may one day bypass the hurdles. Further research will help in understanding the functions of the receptors in a "variety of physiological processes and to develop treatments for a wide range of disease conditions". This year's Prize once again underscores the great contributions refugees fleeing war-torn countries can make to science and other fields. Dr. Patapoutian, who is of Armenian origin, grew up in Lebanon during the country's prolonged civil war and fled to the U.S. in 1986 as an 18-year-old. From being blissfully unaware about science as a career in Lebanon, he not only "fell in love doing basic research", but has also excelled in it to produce path-breaking discoveries in medicine.

## A strategy for India in a world that is adrift

The country's path to power will be affected by the geopolitical and economic centres of gravity now shifting to Asia

ew situations require fresh thinking. A few of us – Ya-N mini Aiyar, Sunil Khilnani, Prakash Menon, Nitin Pai, Ajit Ranade, Srinath Raghavan, and Shyam Saran - some of whom were authors a decade ago of Non-Alignment 2.0, were prompted by the tectonic shifts in India's internal and external environment to take another look at India's path to power in a world between orders. The outcome of our conversations is a discussion paper hosted on the Centre for Policy Research and Takshashila Institute websites called "India's Path to Power; Strategy in a World Adrift". It is our hope that we will receive comments, suggestions and criticism of the paper and that it will contribute to the national debate on our

#### Many power centres

The world is today adrift. We are neither in a bipolar Cold War nor in a multipolar world, though perhaps tending towards a world of several power centres. We are in a world between orders. The lack of a coherent international response to the COVID-19 pandemic is proof of an absence of international order and of the ineffectiveness of multilateral institutions. So is the ineffective international response to climate change and other transnational threats.

Secular stagnation in the global and Indian economies and a re-

treat from globalisation, the regionalisation of trade, a shifting balance of power, the rise of China and others, and structural China-United States strategic rivalry have shifted the geopolitical and economic centres of gravity from the Atlantic to Asia. Inequality between and within states has bred a narrow nationalism and parochialism. We are entering a new polarised information age, and face ecological crises of Anthropocene, making climate change an existential threat. The COVID-19 pandemic has accelerated some of these changes and transformed others. All in all, we can no longer take the success of our development model for

#### Asia as the nucleus

Over the next decade we expect Asia to remain the cockpit of geopolitical rivalries, and that the U.S. remains the most formidable power, though its relative power is declining. China sees a window of opportunity but acts in a hurry, suggesting that she believes that window may close or is already closing due to pushback from the West and others. China's crowded geography constrains her both on land and at sea. We see a slim prospect of Chinese hegemony in Asia, but expect her profile and power to continue expanding, particularly in our periphery. The result is likely continued friction, some cooperation, and quasi-adversarial relations between India and China, which others will take advantage of. As neighbours and in the present situation, a mix of confrontation and cooperation is likely to continue to mark India's rela-

Overall, we do not expect con-



ventional conflict between the great powers in Asia, though other forms and levels of violence and contention in the international system will rise, with Taiwan a

#### Challenges, opportunities

The uncertainty and changing geopolitical environment clearly pose considerable challenges to Indian policy but also throw up certain opportunities, enhancing our strategic options and diplomatic space, if we adjust policies internally and externally, particularly in the subcontinent. Increasing security congruence with the U.S. could enable growing cooperation in fields significant for India's transformation: energy, trade, investment, education and health. Other areas in which India and the U.S. could increase cooperation are: climate change and energy, on tech solutions for renewable energy, and on digital cooperation. Several middle powers are now India's natural partners. There is also an increasing possibility of working with partners in the developing world building broader coalitions on issues of common interest. This time of transition between orders is also when new standards and norms are being developed, particularly in the digital space. India can and must be pre-

sent at the creation. There are opportunities in other domains as well. At sea, the balance is today more favourable to us than before, possibly more so than on the continent. We suggest the creation of a Maritime Commission, a Bay of Bengal Initiative with partner countries, and increasing what we do with South East Asia in maritime security, cybersecurity and counter-terrorism. We should aim for multipolarity in Asia.

The way forward that we suggest is based on the core strategic principles in Non-Alignment 2.0 which are still relevant: independent judgement, developing our capacities, and creating an equitable and enabling international order for India's transformation. Today's situation makes India's strategic autonomy all the more essential.

At the same time, we must adjust to changing circumstances. We have no choice but to engage with this uncertain and more volatile world. One productive way to do so would be through issuebased coalitions including different actors, depending on who has an interest and capability.

**Revive SAARC** We also suggest initiatives to craft and reinvigorate regional institutions and processes in the neighbourhood, reviving the South Asian Association for Regional Cooperation (SAARC) for instance. India could be the primary source of both prosperity and security in the neighbourhood - the subcontinent and the Indian Ocean Region. The over securitisation of policy towards our neighbours has driven trade underground, criminalised our borders, and enabled large-scale entry of Chinese goods

destroying local industry in the northeast. While lessening dependence on China, and seeking external balancing, our primary effort has to concentrate on self-strengthening. If there is one country which in terms of its size, population, economic potential, scientific and technological capabilities can match or even surpass China, it is India.

#### Self-strength is key

Our paper also suggests several steps that we can take in India to ensure that India's role and influence abroad continue to serve the task of transforming India. Economic policy must match political and strategic engagement. Globalisation has been central to India's growth. A more active regional and international role for India is incompatible with a position on the margins of the global economy. Self-reliance in today's world and technologies can only be realised as part of the global economy. We should not imitate China's claims to being a civilisational state and its adoption of victimhood. Instead we should affirm our own strength and historic national identity.

In sum, we see self-strengthening as an absolutely essential precondition as also safeguarding the foundational sources of India's international influence. We cannot separate our domestic trajectory from the external course we need to pursue to transform India into a strong, secure and prosperous country.

## The Hindu vote, an emerging ethnocracy

The BJP's success in this is being emulated by its political rivals, as developments in Uttar Pradesh show

The forthcoming Assembly elections in Uttar Pradesh have seen growing competition over the Hindu vote. Political parties across the spectrum are engaging in competitive Hindutva. Not only are the Congress and the Aam Aadmi Party competing with the Hindu vote, but even parties such as the Bahujan Samaj Party (BSP) and the Samajwadi Party, whose claim to fame has been in advancing the politics of social justice, are appealing to Hindu sentiments. BSP supremo Mayawati was recently filmed carrying a trishul. The SP, whose founder-patron Mulayam Singh Yadav enjoyed the epithet "Mullah Yam Singh Yadav", has been promising to build temples to Parshuram, to Vishnu and other divinities. Such appeals demonstrate India's transition away from a democracy to an ethnocracy. Even as the BJP clamps down on Opposition parties supportive of the farmers' movements, we must not lose sight of our country's transition to

an ethnocracy. What is an ethnocracy? Israeli sociologist Oren Yiftachel defines ethnocracy as the specific expression of nationalism "where a dominant ethnos [peoplel gains political control and uses the state apparatus to ethnicise the territory and society in question". Ethnocracies – think about Israel, Sri Lanka and Malaysia - rigidify distinctions between people considered the core of the nation and others considered peripheral and external to the nation. To be sure, the dominant groups in ethnocracies value democracy (at least for themselves) and often of worship on key occasions and take pride in their democratic in stitutions. But a polity based on the structural exclusion of a section of its population cannot reasonably be said to qualify as a democracy.

#### A transition, since 2014

An ethnocracy has taken root in India since 2014, with Hindus established as the dominant people. Soon after the BJP stormed to power that year, Prime Minister Narendra Modi took the unprecedented step of celebrating his victory on the banks of the Ganga in the holy town of Varanasi. Varanasi was the parliamentary constituency that elected him, so it was to be expected that he would thank his voters. However, the spectacle of the Prime Minister, accompanied by

senior colleagues who would go on to assume key cabinet portfolios, flaunting his Hindu nationalist credentials was a clear break with the past. To be sure, India's heads of government – even when personally

agnostic – have frequented places religious occasions. But Mr. Modi's political association with religion as an inaugural act was rare. The links were made even more clear when a few weeks further, addressing India's Parliament for the first time, Mr. Modi referred to "1200 years of servitude" that Indians had suffered. This was a notso-subtle reference to the presence of Muslims in the Indian subcontinent and associated accounts of conquest, plunder, and domination by invaders of the Islamic faith. Mr. Modi's early actions offered a glimpse into his future years in office, in which Hindus would come to be considered the core of the Indian nation.

The principle that a dominant

Hindu ethnos can rule the country and marginalise others has firmly established itself. Images of Delhi Chief Minister Arvind Kejriwal reciting the Hanuman Chalisa, Congress scion Rahul Gandhi emphasising his roots as a janeu-dhari Brahmin, and West Bengal Chief Minister Mamata Banerjee, reciting the Chandipath as public declarations of their Hinduness suggest that such a principle is being established well beyond the BJP

and the Prime Minister. Indeed, the BJP has been so successful in creating an ethnocracy in India that its rivals are increasof tourism development schemes in Uttar Pradesh suggested that an overwhelming majority of legislators from the Opposition SP and BSP, both torchbearers of secularism and social justice in the 1990s, preferred Hindu religious sites over sites of other or no religion. Such performance of Hindu rituals is barely matched by performance of practices associated with other communities.

#### **Fulfilment of imagination**

Such developments resonate with the ideological vision of the Rashtriya Swayamsevak Sangh (RSS), the ideological fountainhead of the BIP. Established in 1925, the RSS strives to organise society in accordance with and ensure the

protection of the Hindu dharma, or way of life. The RSS's commitment to Hindutva, or 'Hindu-ness' at the expense of religious minorities is clear from a reading of its "vision and mission statement" that is publicly available on its website. Invoking the words of its founder Keshay Baliram Hedgewar, the statement declares: "The Hindu culture is the life-breath of Hindusthan. It is therefore clear that if Hindusthan is to be protected, we should first nourish the Hindu culture. If the Hindu culture perishes in Hindusthan itself, and if the Hindu society ceases to exist. er to the mere geographical entity that remains as Hindusthan. Mere geographical lumps do not make a nation. The entire society should be in such a vigilant and organized condition that no one would dare to cast an evil eye on any of our points of honour." 22-Oct-2012,

The RSS's vision and mission statement endorse their founder's reference to India as "Hindusthan", a cultural term to refer to the land of the Hindus. The competitive Hindutva on display in Uttar Pradesh has brought the RSS's vision and mission to fruition.

#### **Rural credit**

It is distressing to note that the interest rate charged to the ultimate beneficiary through micro finance institutions (MFI) lending ranges between 22% to 26%. The Reserve Bank of India needs to review the  $methodology\ presently$ 

followed on the cost of funds (COF) for NBFCs and MFIs. The sole aim of providing credit to the rural population is defeated under the present COF technique. Small finance banks (SFBs), whose objective is to introduce banking activities to the unserved and underserved sections of the population, appear to be expanding their branches in urban and metro cities. Having tasted profits, a few SFBs have even planned to exit the niche banking model and embrace the universal banking model, thus defeating the very purpose for which they were formed. Till the early 2000s, all public sector banks had a differential rate of interest scheme to provide credits to poor families (belonging to the economically weaker sections) for productive endeavours; it had a maximum loan ceiling of ₹15,000 with 4% simple interest. This scheme was a

boon for the rural poor. In

2012, the committee under the chairmanship of M.V. Nair, recommended doing away with the differential rate of interest scheme. The reasons: nil margin or thin spread available for banks, a disproportionate ratio between the loan quantum *vis-à-vis* inflationary trend, and the multiplicity of schemes such as the Swarnjayanti Gram Swarozgar Yojana. It is time that the credit policy of financing rural credit is strengthened and also regulates the role of private entities (Editorial page, "RBI microfinance proposals that are anti-poor", October 6). ### Transfer of judges

## The recent QES estimates are unreliable

The analysis is fraught with caveats and the interpretation of the survey results calls for caution



Last week, the Ministry of Labour and Employment released the results of a new Quarterly Employment Survey (QES) for April-June 2021 for the organised (formal) sector. It represents establishments (or units) emploving ten or more workers. The surveyed sectors were manufacturing, construction, trade, transport, education, health, accommodation and restaurant, Information Technology/Business Process Outsourcing (IT/BPO), and financial services. The survey reported the following. First, "It is heartening to note that the estimated total employment in the nine selected sectors from the first round of QES works out as 3 crores and 8 lakhs approximately against a total of 2 crores and 37 lakhs in these sectors taken collectively, as reported in the Sixth Economic Census (2013-14), implying a growth of 29%." Secondly, employment fell from 3.078 crore before the first nationwide lockdown in March 2020 to 2.848 crore post the lockdown on July 1, 2020. Thus, the report showed that 24 lakh jobs lost during the lockdown in 2020 came back by the first quarter of 2021.

The new QES is a welcome step as it will help generate timely employment estimates for the larger units. However, the above analysis is fraught with caveats and the interpretation of the survey results calls for caution.

#### Limited coverage

As is widely known, establishments with ten or more workers account for a small proportion of all non-agricultural establishments – a mere 1.66% as per the Economic Census (EC) of 2013-14. Also, a disproportionately large share of workers – 81.3% as per the Periodic Labour Force Survey (PLFS, 2018-19) - worked in the unorganised sector. With its limited coverage, the QES based on data for formal sector enterprises cannot provide a total picture of employment dynamics. Hence, drawing in-



ferences about overall job losses during the lockdown based on this survey is simply misleading.

Data from the Centre for Monitoring Indian Economy (CMIE) showed that during April 2020, 12.1 crore workers lost their jobs. Most of these workers were informally employed -9.1 crore job losses reportedly occurred amongst small traders and casual labourers. The official PLFS indicated the extent of distress in the labour market during the nationwide lockdown. The unemployment rate by current weekly status (i.e. the activity status during seven days preceding the survey date) in urban areas increased from 9.1% in January-March 2020 (before the lockdown) to 20.8% in April to June 2020.

Significantly, the new QES data suffer from many methodological shortcomings such as an outdated sample frame, non-comparability of employment numbers obtained from the EC-2013 with sample estimates obtained from the QES for only a quarter, and differences in methods used for gathering the information. We elucidate these pro-

Conducting a scientific sample survey requires a "sample frame", i.e. the list of units (e.g., persons, households, businesses, etc.) in the survey population. Since the basis for sample selection is this list, the frame is of utmost importance for the survey design. To generate a frame for its enterprise surveys, India has been conducting the ECs since 1977, albeit at long and irregular intervals. The most recent one was in 2013-14, which the QES has

used. The new QES has a sample of approximately 11,000 establishments. The datedness of the frame implies that the QES does not include units set up after 2013. Further, the EC-2013 has based itself on the "enumeration blocks" of the Population Census, 2011 as the primary geographical units. The outdated nature of the sample frame, which has been acknowledged for a while now, renders the new QES employment estimates irrelevant.

To understand the QES's origin, the Labour Bureau (LB) conducted the first such survey in 2009, with a modest sample size of around 2,000 manufacturing units for eight select labour-intensive and export-oriented industries in 11 States. The survey sought to assess the employment effects of the global financial crisis and was conducted till December 2015. In April 2016, the LB replaced this series with another quarterly series, which had a larger sample size and enhanced sectoral coverage. The EC-2013 served as the sampling frame for this survey, too. However, it was soon abandoned as a government-appointed Task Force on Improving Employment Data (2017) recommended doing away with the QES on grounds of its limited coverage and an outdated sample frame.

Given the above background, the rush to produce a new QES that draws its sample from the EC-2013 frame seems baffling. It would have been more prudent to await the release of a newly updated frame in the EC-2020 and then canvass for the QES. In fact, given the outdated frame, drawing inferences about employment changes even for the organised sector during the lockdown is misleading. It is also worth noting that QES was primarily a telephonic survey and verification of responses of establishments has not been done (as has been the usual practice for the LB's quarterly surveys).

Moreover, the comparison of the employment estimates obtained from the new QES for April to June 2021 with the employment number based on the EC-2013 reported in the first paragraph is confounding. The latter is a census, conducted over an entire year, to provide a frame. The former is a sample survey conducted with a short reference period. The questionnaire of the QES asks establishments about employment details for a specific quarter, in this case, April 1, 2021. In contrast, the EC-2013 questionnaire asks establishments about the number of persons working on the last working day prior to the date of fieldwork in the establishment.

#### **Conceptual problem**

In addition, there is a conceptual problem in comparing employment numbers of the EC with the QES. Although the former asks questions about the number of persons working in an enterprise, it is not a good instrument for estimating the size of the workforce or for analysing employment trends as the principal objective of the EC is generating a frame, not estimating employment.

The initiative to produce quarterly employment data for selected industries in the organised sector is desirable. However, in a rush to generate high-frequency estimates, there cannot be a compromise on data quality and its reliability. Hence, the inference drawn using the new survey data, as reported in the opening paragraph, is misleading. The LB's hurried effort has only created (avoidable) confusion and undermined the potential value of the QES.

### Trade multilateralism at risk

The World Trade Organization is facing an existential crisis

The World Trade Organization (WTO) – the global trade body - is facing a serious existential crisis. The upcoming WTO ministerial meeting scheduled for next month in Geneva provides an opportunity to rescue this critical global institution from irrelevance. Created in 1995, during the heyday of neoliberalism, the WTO became a shining example of triumphant free-market capitalism. Critics of neoliberalism chastised the WTO for pushing the American imperialist agenda. Paradoxically, more than two-and-a-half decades later, the United States seems to have lost interest in it. The feeling in Washington is that the WTO hasn't served the American national interest by failing to stem China's rise and regularly indicting the U.S. in several trade disputes. President Joe Biden has continued with the same policy towards the WTO that Donald Trump practised.

The continuation of the U.S. policy on the WTO is most evident in the sustained crippling of the Appellate Body (AB). The AB is part of the WTO's dispute settlement mechanism. It is a permanent body with seven members, and acts as an appellate court hearing appeals from the decisions given by WTO panels. However, since December 2019, the AB has stopped functioning due to rising vacancies. Over the years, the U.S. has consistently blocked the appointment of AB members. The U.S. also vetoes proposals to find solutions to this impasse, including stalling the proposal of the European Union to establish an alternative interim appellate arbitration mechanism. The number of pending appeals to the AB has increased sharply to around 20 cases. Countries now have an easy option not to comply with the WTO panel decisions by appealing into the void.

#### Other challenges

Additionally, there are four other challenges that the WTO faces. First, no solution has been found to the public stockholding for food security purposes despite a clear mandate to do so in the 2015 Nairobi ministerial meeting. This is of paramount concern for countries like India that use Minimum Support Price (MSP)-backed mechanisms to procure foodgrains. The WTO rules allow countries to procure, stock and distribute food. However, if such procurement is done at an administered price such as the MSP that is higher than the external reference price, then the budgetary support provided shall be considered trade-distorting and is subject to an overall cap. With rising prices and the need to do higher procurement to support farmers and provide food to the poor at subsidised prices, India might breach the cap. Although countries have agreed that legal suits will not be brought if countries breach the cap, it is imperative to find a permanent solution such as not counting MSP-provided budgetary support as trade-distorting.

Second, the WTO member countries continue to disagree on the need of waiving the Trade-Related Aspects of Intellectual Property Rights (TRIPS) agreement for COVID-19 related medical products. It was exactly a year back when India and South Africa proposed a TRIPS waiver to overcome intellectual property (IP)-related obstacles in increasing accessibility of COVID-19 medical products, including vaccines. The WTO needs to adopt a waiver in the upcoming ministerial meeting.

Third, the WTO is close to signing a deal on regulating irrational subsidies provided for fishing that has led to the overexploitation of marine resources by countries like China, which is the largest catcher and exporter of fish. However, this agreement should strike a balance between conserving ocean resources and the livelihood concerns of millions of marginal fishermen. An effective special and differential treatment provision that accords adequate policy space is what India and other developing countries should insist on. Fourth, the gridlock at the WTO has led to the emergence of mega plurilateral trade agreements like the Comprehensive and Progressive Agreement for Trans-Pacific Partnership (CPTPP) - a treaty between 11 countries. Another key trade treaty is the Regional Comprehensive Economic Partnership (RCEP) agreement between Asian economies and countries down under. These plurilateral agreements not only fragment the global governance on international trade but also push the multilateral order to the margin, converting the WTO to what some call an "institutional zombie".

Prime Minister Narendra Modi, during his recent U.S. visit, rightly pleaded for a rulebased global order. Institutional multilateralism would be the ideal antidote to unilateralism and economic nationalism. Notwithstanding its flaws, the WTO is the only forum where developing countries like India, not party to any mega plurilateral trade agreements, can push for evolving an inclusive global trading order that responds to the systemic imbalances of extant globalisation. What is at stake is the future of trade multilateralism and not just an institution.

### Road accidents can be reduced

Public discourse, improving infrastructure can help

Fifty-one passengers of an overcrowded bus died in an accident on the morning of February 16 when it fell into a canal near Sarda Patan village in Sidhi district, Madhya Pradesh. A griha pravesh (house-warming) ceremony for the beneficiaries of one lakh houses constructed under the Pradhan Mantri Awas Yojana in Bhopal, which was to be attended virtually by Union Home Minister Amit Shah, was cancelled due to the incident. Two days earlier, fourteen persons were killed when a minivan they were travelling in hit a divider on a National Highway (NH) near Madarpur village in Kurnool district, Andhra Pradesh. The van carrying 18 passengers was on its way to Ajmer in Raiasthan from Chittoor, when the driver lost control and hit the divider, tumbling on the other side of the road where a speeding truck crashed

According to a study conducted by the Ministry of Road Transport and Highways, 1,51,113 persons were killed and 4,51,361 injured in road accidents across the country in 2019. NHs and State Highways, which account for about 5% of the total road length, claimed 61% of the deaths related to accidents. Around 35,606 deaths were reported on the NHs, which come under the National Highway Authority of India (NHAI).

Speaking at a webinar organised by the International Road Federation on February 9, Union Transport Minister Nitin Gadkari said India topped the fatality figures in road accidents in the world, with 415 deaths each day. While commending Tamil Nadu for taking effective road safety measures that had resulted in the reduction of road accidents by 38% and deaths by 54%, he asked other States to emulate Tamil Nadu.

It is small wonder that he actively pursued the Motor Vehicles (Amendment) Act, 2019, with the well-intentioned motive of bringing down the death rate due to road accidents by 50% by 2020. This was agreed to by all participating nations in the United Nations Brasilia Declaration, of which India was a signatory. Though the number of deaths due to accidents declined to 1.20 lakh in 2020 due to COVID-19, Mr. Gadkari shifted the deadline to 2025.

But the steep like in the fines imposed for traffic violations in the Act was met with stiff opposition, with some States dismissing it as too harsh and, hence, not willing to implement it. What seems to have been ignored while drafting the law was the fact that a good number of those driving vehicles to earn their livelihood were from economically poor backgrounds. West Bengal decided not to implement the new law and continued with the West Bengal Motor Vehicle Rules, 1989.

The Madras High Court recently struck down the April 6, 2018 notification of the Union Government wherein the speed limit was hiked to 120 and 100 km/hour on expressways and highways, respectively. This was done as 66.7% of accidents was attributed to overspeeding in 2017, 55.73% in 2018 and 64.4% in

Studies carried out by various organisations have also come out with the causes for accidents and ways to curb them. The Accident Research Cell of the Delhi Traffic Police carried out an analysis of accidents and created a database that facilitates the formulation of policies to prevent accidents. While probing an accident that led to the death of former Union Rural Development Minister Gopinath Munde in New Delhi, the cell concluded that hedges along a road obstructed the visibility of drivers coming from the other direction. After the hedges were pruned, the stretch became free from accidents.


While the strict enforcement of traffic safety laws would go a long way, educating citizens about the impact of accidents on the kin of the victims through public discourse could help in reducing accidents. Improving road infrastructure with coordinated efforts by the police and civic authorities, identification of black spots that are prone to accidents and deploying an adequate number of police personnel, particularly during peak hours, could bring down accident rates. Highway patrols with police personnel trained in first aid and ambulances every 10 km could also help save precious lives.

#### Refugee crisis

"A time will come when India will have to tell Pakistan 'thus far and no further', as the burden of refugees from Bangla Desh is becoming too heavy to bear," Mr. R.K. Khadilkar, Union Minister for Labour and Rehabilitation, told newsmen here to-day. He did not explain the action the Government was contemplating. Mr. Khadilkar gave a grim picture of the refugee influx. He said that India must be prepared for a steep increase in the refugee influx from Bangla Desh from the present level of 91.46 lakh to over 1.2 crore as a result of the mounting guerilla activity of the Mukti Bahini and the consequent intensified repression from the West Pakistani army. Refugees were now coming to India at the rate of 41,000 per day. India had already spent Rs.120 crore on the refugees and would have to spend Rs.450 crore by the end of the year and Rs.600 crore by the end of March, 1972, assuming that the number of refugees would not exceed 10 million. Mr. Khadilkar called upon the international community to realise its responsibility and come forward with more generous aid.

#### A HUNDRED YEARS AGO OCTOBER 7, 1921

#### Disturbed Malabar

The trouble at Codacal on Sunday night happened in this wise. The alleged offence of the Christian population seems to be that they helped the authorities in apprehending some rebels a fortnight previous and as reprisal, Sunday's attack appears to have been planned. At midnight, armed Moplahs were seen near Edacoam railway gate, and approaching the petty bazar close by, shouted for a Christian tailor named Polycarp who they suspected had betrayed them to authorities. Local friendly Moplahs warned Polycarp who slipped away. The loyal Moplahs were caught and threatened that unless Polycarp was found, they would be killed. The gang marched to set fire on the Village Mausif who was absent from home. The Tea Factory was the next scene of attack. They surrounded Sukumaran's tea shop where Jacob and Isac were sleeping. The rebels clubbed them severely. Yesumatran, schoolmaster and father of five children, was then murdered in cold blood. The whole colony became frightened and took shelter in the fields. Before the factory could be attacked, a siren blew loudly. The rioters thought that military would come from Tirur and so bolted away. Refugees numbering five hundred have migrated to Calicut and Palghat.

### Civilian killings cause concern in J&K

On Tuesday, Makhan Lal Bindroo, a well-known pharmacist in Srinagar was killed by terrorists when he was in his shop. The Resistance Front (TRF), which the police believe is a front for the Pakistan based Laskhar-e-Taiba (LeT) has claimed responsibility for the killing.

The group said Bindroo was killed as he worked for the Rashtriya Swayamsevak

Another senior government official said there are inputs to suggest serious attempts to target prominent businessmen in the Valley and Jammu region. At least two such previous attempts have been foiled.

"Innocent people who had nothing to do with any group were killed. This is a terrorist incident, it was done to send a message to minorities who have been staying here peacefully for decades. Mr. Bindroo never left the Valley. The street vendor was killed because they do not want anyone from outside to come and work here... The signal has come from across the border," Mr. Singh said. He added that the taxi owner was killed on suspicion of being a police informer.

A street vendor from Bihar, Virendra Paswan and Mohammad Shafi Lone, the president of the Taxi Asso-

ciation in North Kashmir's Bandipora were also killed on Tuesday. The TRF accused Lone of being a police informer.

"TRF is run from Karachi. We recently killed Abbas Sheikh, TRF's leader in an operation. Some people associated with TRF who were working as over ground workers became active and resorted to the civilian killings," Mr. Singh said.

He added that as of now no leadership of terrorist groups remained active in the Valley.

#### 'Intolerance' flagged

"All sections of Kashmiri society have condemned the killings. The street vendor's killing reflects the sign of intolerance for non-locals by the terror groups," he said.

Former MP and senior People's Conference leader Nazir Ahmad Laway said the act was an attempt to create communal disharmony in the region.

The killings come at a time when a battery of Union ministers have been visiting the newly created Union Territory as part of government's mega outreach programme. Home Minister Amit Shah is expected to visit later this

### NEET-SS new pattern plan dropped, says govt.

A Bench led by Justice D.Y. Chandrachud expressed its satisfaction with the government's change of mind, and disposed of the case.

Ms. Bhati noted that the decision to revert to the old mode was done in consultation with expert bodies such as the National Board of Examinations and the National Medical Commission, taking into consideration students' interests.

"The impression we get is medical education has become a business, and medical regulation has also become a business. That is the tragedy of medical education in this country," Jus-Chandrachud

The court had observed that questions under the revised pattern were wholly from general medicine, which was a feeder category. The earlier pattern had 60% of the questions coming from the student's chosen field of speciality and the rest from the feeder category

"For 12 super specialties, 100% questions are from general medicine. The entire examination is going to be only be on general medicine. The logic seems to be, general medicine is the largest pool, and tap them to fill the seats. That seems to be idea," the Bench had

In an earlier hearing, the court had lashed out at the government, saying "young doctors cannot be left at the mercy of insensitive bureaucrats and cannot be treated like football". It had stated, "The interests of students is far higher than those of the institutions".

### WHO recommends first anti-malarial vaccine

The WHO's recommendation was based on the results from an ongoing pilot programme in Ghana, Kenya and Malawi.

The development comes at a time when the WHO and its partners have reported a stagnation in the progress against the disease that kills more than 2,60,000 African children under the age of five annually. Malaria remains a primary cause of childhood illness and death in sub-Saharan Africa, according to the WHO.

"For centuries, malaria has stalked sub-Saharan Africa, causing immense personal suffering," said WHO Regional Director for Africa Dr. Matshidiso Moeti. "We have long hoped for an effective malaria vaccine and now for the first time ever, we have such a vaccine recommended for widespread use. Today's recommendation offers a glimmer of hope for the continent



The vaccine was used in a pilot programme Ghana, Kenya and Malawi.

which shoulders the heaviest burden of the disease and we expect many more African children to be protected from malaria and grow into healthy adults."

The vaccine does significantly reduce life-threatening severed malaria, Dr. Tedros said, but added that, "It's not the only tool. Vaccination against #malaria does not replace or reduce the need for other measures, including bed nets [against mosquitoes]."

#### NIA takes over Mundra port drug haul case

The pharmacist, known for a loyal clientele, was one of the few Pandits who stayed back in Kashmir

Family members of Makhan Lal Bindroo, who was shot dead inside his famous pharmacy, Bindroo Medicate, here by militants on Tuesday, put up a brave face on Wednesday, saying "the gunmen may have killed a body but not the spirit" of the family.

"My father will always be alive in the spirit with which we have been brought up. Mr. [gunman], who shot my father while he was working, if you have the guts, then come have a debate with me. You won't. You merely know how to hurl stones and open fire," Shraddha Bindroo, the victim's daughter, said.

Bindroo's son said his father "was a principled man who earned a name by selling genuine medicine. He was respected by all in Kashmir for being helpful and friendly. He motivated me to return [to Kashmir] and serve people here. He had no threat as such. Even if he had, he was brave enough to keep his shop open, as he did since the 1990s."

The Bindroos, residents of Indira Nagar, were among a few Kashmiri Pandit families that decided to stay back in the Valley in the 1990s, when

militancy broke out. They earned a name by running a leading pharmacy in the Valley. On Tuesday evening, unknown militants barged into the busy pharmacy near the Iqbal Park area and pumped around four bullets into his body, leaving the 68-year-old Bindroo dead.

The killing evoked a public outrage in Kashmir. Scores of neighbours and loyal customers visited the Bindroos in Srinagar to express their condolences to the family.

Many recalled the generosity displayed by the family during tough times faced by neighbours and

Srinagar Mayor Junaid Azim Mattu said a road in the city "will be named after Bindroo as a tribute to his contributions to society". Farooq's condolences

Bench flags low SC/ST representation in Group A jobs

Seventy-five years of Independence have not been able to bring members of the Scheduled Castes and Scheduled Tribes on a par with the forward classes of society, the Government said in the Supreme Court on Wednesday.

Appearing before a Bench led by Justice L. Nageswara Rao, Attorney-General K.K. Venugopal said it was tough for a member of the SC/ST to reach the 'Group A' category jobs. Mr. Venugopal said the time had come for the top court to firm up and draw the basis for reservation in promotions for SC/ST candidates to fill up vacancies in top jobs.

The Bench referred to records filed before it to note that there was low representation of SC/ST category in Group A jobs. Instead of improving the situation in the Group A ranks, the court said, efforts are on to ensure adequate representation in Groups B and C. This was not fair, it remarked.

### **Ex-diplomat** V.M.M. Nair passes away

Vallilath Madhathil Madhavan Nair, former diplomat of India, passed away here on Wednesday, two days short of his 103rd birthday. He is survived by wife Krishnakumari.

Mr. Nair joined the In-

dian Civil Service or the ICS in 1942 and was allotted to the Bihar cadre. He was permanently seconded to the Indian Foreign Service on November 1, 1944. His early recruitment into the IFS during the Second World War meant he was present in the foreign affairs team of Prime Minister Jawaharlal Nehru from the very beginning of the

### India, U.S. to work closely on Afghanistan, says Shringla

U.S. Deputy Secretary lauds resumption of vaccine exports

SUHASINI HAIDAR NEW DELHI

Foreign Secretary Harsh Shringla on Wednesday held talks with visiting U.S. Deputy Secretary of State Wendy Sherman, who later said India, U.S. partnership was "indispensable" for both countries and the world.

Describing the partnership during a public address to the U.S. India Business Council (USIBC) India Ideas Summit shortly after the meeting, Mr. Shringla indicated that the future of the Indo-Pacific region, and the situation in Afghanistan were at the top of their discussions.

"Given the fast-paced developments in South Asia, especially in Afghanistan, India and the U.S. will remain closely engaged both on the future of Afghanistan, and on how we can maintain peace and stability in South Asia, and beyond," Mr. Shringla said. However, Ms. Sherman

reiterated U.S. concerns over India's 2018 agreement with Russia for the purchase of S-400 missile systems, which she described as dangerous. The delivery of the sys-

A delegation from the office of the U.S. Trade Representative is in Delhi for trade talks this week, and Finance Minister Nirmala Sitharaman is expected to travel to tems to India later this year Washington "soon", said government sources.

When asked if the U.S. is discussing the possibility of cooperating on sourcing military bases with India, or with countries like Uzbekistan and Pakistan, which are part of her current tour, Ms. Sherman, speaking at a roundtable with journalists, said the U.S. is discussing its options for airstrikes on Afghanistan through "over the horizon" (OTH) efforts, but did not elaborate further on India's response.

#### **Vaccine partnership**

Ms. Sherman and Mr. Shringla also spoke "at length" about the Quad vaccine partnership which will entail manufacturing one billion J&J American vaccines in India by end 2022, said sources, but denied that the issue of indemnity clauses, which India insists on, will be a roadblock to the Quad proposals. Ms. Sherman said she had "applauded" India's decision to resume its vaccine exports that were cancelled during the pandemic's second wave.

M. Sherman will travel to Mumbai on Thursday for meetings with business persons, and will head to Pakistan after that.

### Maha Vikas Aghadi leads BJP in local body bypolls

Congress puts up a spirited show

The Maha Vikas Aghadi (MVA) in Maharashtra, comprising the Shiv Sena, the Congress and the Nationalist Congress Party (NCP), overwhelmed the BJP in the byelections to 85 zilla parishad and 144 panchayat samiti seats announced on Wednesday.

The bypolls were held in six districts - Nagpur, Akola, Washim, Latur, Dhule and Palghar - with 367 candidates in the fray in the ZP polls and 555 for the pan-

chavat samiti seats. While the three parties together won 46 of the 85 seats in the ZP bypolls, the BJP nevertheless emerged as the single largest party

here, winning 23 seats. However, most significant of all was the Congress's spirited performance, coming off best within the coalition by winning 17 ZP seats and bagging the highest number of seats (35) among all parties (including the BJP) in the panchayat samiti by-

The MVA won a total 73 of the 144 panchayat samiti seats, with the BJP winning 33, second to the Congress tally. The Shiv Sena and the NCP managed to win 12 and 17 ZP seats respectively.

They bagged 22 and 16 panchayat samiti seats respec-

A jubilant Maharashtra Pradesh Congress Committee (MPCC) chief Nana Patole, who has been vocal about the party contesting independently in the coming civic body polls, said the results proved that it was on its way to becoming the top party in the State.

"Given the high-handed manner in which the BJP government at the Centre is behaving, be it suppressing farmers in Uttar Pradesh or abusing Central probe agencies, I think people have realised that only the Congress has the wherewithal to rein it in... I thank the public in all these six districts for recognising the Congress as a viable force to counter the BJP," said Mr. Patole, while promising to repair all organisational glitches within

the party. At the same time, he remained non-committal on whether the Congress would fight in alliance with the Sena or the NCP in the crucial civic polls next year, merely remarking that his aim was to build the party's strength. According to observers, the Congress's win would certainly give a major boost to the party rank.



## Second autopsy silent on bullet injury

Final rites of four farmers, who were among the eight dead in Lakhimpur Kheri incident, performed

With the cremation of Gurvinder Singh on Wednesday after a second autopsy was conducted by a new panel of doctors appointed by the government, the final rites of the four farmers, who were among the eight people dead in the Lakhimpur Kheri incident, were concluded.

Gurvinder's family, however, rejected the second autopsy report too as it did not mention any bullet injury, his family said on Wednesday a day after rejecting the first report.

The police said they would make arrests in the case, in which a Union Minister's son is booked for murder, after collecting evidence and corroborating it.

#### **Similar conclusion**

The second report had also given a similar conclusion that Gurvinder died of internal injuries and bleeding after being hit by car, the family alleged. He was cremated in his village in Bahraich dis-

Gurvinder was killed in the violent incident involving the convoy of Union Mi-

nister of State for Home Affairs Aiav Mishra in Tikonia. His family had demanded a fresh autopsy after they refused to accept the findings of the first post-mortem report. They alleged, on the basis of eyewitness accusations, that he was shot dead by Ashish Mishra, the Minister's son, after the latter tried

to escape into the fields after "running over farmers".

Mr. Ashish Mishra has denied the allegation, saying he was in his ancestral village Banveerpur at the time.

Gurvinder's brother-inlaw, Raman Singh, told The *Hindu*, "It [second autopsy] has nothing about the bullet. He has been cremated." However, a copy of the postmortem report was not yet

#### **Two FIRs**

While the first FIR in the case names Mr. Ashish Mishra and 15 to 20 people on charges of murder, criminal conspiracy and death by negligence for allegedly mowing down farmers, in the second FIR, lodged against unidentified persons for murder and other charges, the complainant, a BJP worker, alleges that farmers threw stones at the vehicle and attacked it with sticks.

Asked if any summons would be issued to Mr. Ashish Mishra for questioning or if he would be arrested, Additional Director-General of Police (Law and Order) Prashant Kumar said the investigation would "pace up" now as the police and administration had taken "swift action" to maintain peace in the "sensitive matter". "No guilty will be spared," he told a news agency, adding that both the FIRs would be investigated.

The officer said the police were examining all videos of the incident on October 3, including one showing a vehicle running over farmers, and would include them in the investigation. Apart from the four farmers, local journalist Raman Kashyap, BJP workers Shubham Mishra and Shyam and driver of the vehicle Hari Om Mishra were killed. There is no clarity on how each was killed.

## Rahul, Priyanka meet family of Kheri victim

Cong. leaders, CMs stopped at airport till farmers' funerals

After staging a brief and dramatic sit-in at Lucknow airport, Congress leader Rahul Gandhi along with the Chief Ministers of Punjab and Chhattisgarh - Charanjit Singh Channi and Bhupesh Baghel - and general secretary Priyanka Gandhi Vadra reached Palia village in Lakhimpur late on Wednesday where they met the family of Lovepreet Singh, one of the farmers killed on October 3.

Earlier in the afternoon, after landing at the Lucknow airport, Mr. Gandhi and the other senior Congress leaders staged a brief dharna after police told them to use the police vehicle instead of their own to travel to Lakhimpur. Mr. Gandhi, however, insisted that he would travel in his own car.

Mr. Gandhi again hit out at the Yogi Adityanath Government and questioned the reliability of the permission granted to Opposition leaders to visit the affected district after denving them

entry since Sunday. In a video that emerged from the airport, Mr. Gandhi was seen complaining that he was not being allowed to leave as a group of CRPF personnel were seen preventing his movement, despite permission been granted by the government. The Congress leaders

were allowed to travel to Kheri only after all four farmers out of the eight total dead were cremated and police allowed people to travel there in groups of five.

Mr. Gandhi then drove to Sitapur where Ms. Vadra has been lodged in detention at the PAC guesthouse since Monday after police prevented her from reaching Lakhimpur Kheri. After Ms. Vadra was released from detention, the two leaders travelled in the same vehicle after meeting Congress workers.

Earlier in the day, before heading for Lucknow, Mr. Gandhi told reporters in Delhi that a "dictatorship" prevails in the country where the farmers are being systematically attacked.



The Supreme Court on Wednesday directed investigation into the alleged acts of collusion of Tihar Jail officials with Unitech's imprisoned ex-promoters Sanjay and Ajay Chandra. Shah ordered criminal and corruption cases to be registered against the prison officers based on the recommendations made by Delhi Police Commissioner Rajesh Asthana in a sealed cover report. The court also directed the immediate suspension of the prison officers under suspicion in the report.

#### Bike Bot scam: ED attaches assets

The Enforcement Directorate has attached assets worth ₹26.98 crore of the Rose Valley group of companies in connection with a Ponzi scam The properties include land parcels, hotels, bank balance and demand drafts attributed to the group entities. The money laundering probe being carried out by the agency is based on the cases registered by the West Bengal police against the group and its chairman Gautam Kundu.

The Assam police on Wednesday arrested a former granted bail within 24 hours people with her car in Guwahati on October 2. A senior police officer said Rajkanya Baruah was booked under Section 308 of the Indian Penal Code for attempt to commit culpable homicide. The punishment under this section is jail up to seven years or fine or both. The 29-year-old model was arrested within minutes of a medical board of the Gauhati Medical College and Hospital declaring her to be in fine health. She had checked into the intensive care unit of a private hospital, citing poor health after the police summoned her on Tuesday

## SC asks firecracker makers why they stock barium despite ban

Court says it may order seizure of toxic chemicals from the manufacturers

LEGAL CORRESPONDENT

The Supreme Court on Wednesday wondered why firecracker manufacturers continued to stock huge quantities of toxic barium chemicals even after the court had banned its use in fireworks.

"Have you seen the reply by manufacturers? What they say is very surprising. They say that the huge quantity of barium purchased was to be kept in the godown. It was not for manufacture [of crackers]. Why have they kept them in the godown?" a Bench led by Justice M.R. Shah asked.

The court remarked that it might even order the seizure of the chemicals from the manufacturers.

The court was hearing a

plea by petitioners, including Delhi-based student Arjun Gopal, about the continued violation of the 2018 Supreme Court ban on the use of barium and other chemicals in firecrackers.

The court said "noisy" celebrations are replete with "joint crackers" even though it was banned.

#### CBI probe

On September 29, the court had referred to a preliminary inquiry report submitted by the CBI into the firecracker industry, including in Tamil

Nadu, which revealed rampant violation of the top court's ban on the use of toxic ingredients in the products. The court had ordered the Joint Director of the CBI, in Chennai, to conduct a "detailed" probe in an order in March 2020.

The agency had filed a report in a sealed cover in the court. The court said the agency report had shown that chemical analysis on samples of finished and semi-finished firecrackers and raw materials revealed barium content. ## LPG price hiked by ₹15 a cylinder

Petrol cost goes up by 30 paise a litre

The price of liquefied petroleum gas (LPG) was on Wednesday hiked by ₹15 a cylinder, while petrol and diesel rates saw their steepest increase in recent weeks, pushing prices to record levels across the country.

Rates of both subsidised and non-subsidised LPG were hiked, taking the increase in rates since July to



LPG now costs ₹899.5 per cylinder in Delhi.

A 5-kg LPG cylinder now

This is the fourth increase in LPG prices since July. Rates were increased by ₹25.5 a cylinder in July, followed by a ₹25 hike each on August 17 and September 1.

Alongside, petrol price was increased by 30 paise a litre and diesel by 35 paise.

Seven-year high

This is the steepest daily increase in recent weeks and follows international oil prices touching a seven-year

The petrol price in Delhi rose to its highest-ever level

### U.P. tops list of States emitting fine particulate matter: study

Council on Energy, Environment and Water does analysis

Uttar Pradesh is the largest emitter of PM2.5, the class of particulate matter considered most harmful to health, according to an analysis by the Council on Energy, Environment and Water (CEEW). The council, a research body, looked at five of the most reliable data sources - international and national - that have tracked and measured the quantum and sources of air pollution in India. The high emissions from

U.P. were largely due to a significant share of PM2.5 emissions from solid-fuel use in households and, by virtue of being India's most populous State, it had a higher proportion of households relying on this form of fuel.


Maharashtra, Gujarat, Odisha, West Bengal, Madhya Pradesh, Bihar, Tamil Nadu, and Rajasthan too feature in the list of top polluters but are differently ranked by the five sources.

Only Uttar Pradesh is at the top of the lists from all sources.

#### **Data sources**

The five data sources used are: Emissions Database for Global Atmospheric Research (EDGAR), maintained by the European Commission's Joint Research Centre; Evaluating the Climate and Air Quality Impacts of Shortlived Pollutants (ECLIPSE), maintained by the International Institute for Applied Systems Analysis (IIASA); Regional Emission Inventory in Asia (REAS), maintained by the National Institute for En-

Top polluters I Depending on the data source, U.P's PM2.5 emissions ranged from 588 to 976 kilo-tonnes (kt) per year whereas Maharashtra's ranged from 415 kt to 549 kt. A look at data sourced from various organisations on emissions



vironmental Studies, Japan (NIES); Speciated Multipolluter Generator (SMoG), maintained by the Indian Institute of Technology (IIT Bombay); and spatially resolved pollution emission inventory for India, maintained by The Energy and Resources Institute (TERI).

#### **Common pollutants**

There are differences in the periods over which these sources track the emissions as well as the pollutants, but most track the important ones: PM2.5, PM10, NOx (nitrous oxides), SO2 (sulphur dioxide), CO (carbon monoxide), NH3 (ammonia), and NMVOC (non-methane volatile compounds).

The CEEW analysis found "significant variation" in the estimates by various sources going up to as much as 37% particulate matter (PM2.5 and PM10), nitrogen oxide (NOx), sulphur dioxide (SO2) and carbon monoxide (CO). The overall variation in residential PM2.5 emissions was less than 25%. However, SMoG's residential PM2.5 emission estimates are approximately 50% higher than those estimated by TERI.

Because of the extent of variation, the Council said India ought to "develop and maintain a comprehensive inventory emissions".

India has a National Clean Air Campaign (NCAP) that aims to reduce pollution in 122 of the most polluted cities by 2024. "To meet the NCAP target of 20-30% reduction in particulate concentration by 2024, we need to estimate emission reductions needed across sectors. Estimating these reductions will only be possible when we have an official, representative emission inventory for India," said Tanushree Ganguly, Programme Lead, CEEW, and lead author of the study

### CPI(M) opposes changes proposed to Forest Act

Letter sent to Environment Minister

The Centre's proposal to amend portions of the Forest Conservation Act (FCA) has drawn criticism from the CPI(M). The Environment Ministry has invited comments and suggestions on the proposed amendments which are publicly available as a "consultation paper" on its website.

Brinda Karat, CPI(M) Polit Bureau member, on Wednesday wrote to Environment Minister Bhupendra Yadav that the proposed amendments appeared less about conserving forests and addressing environmental concerns and more to "facilitate takeover of forest land and make it cheaper and easier for corporates, intending to take the benefits of privatisation".

The proposals appeared to dilute the rights of the States to notify forests thereby further centralising authority in the Centre, she said. Currently, States have the authority to evolve their own criteria and declare tracts of lands as "deemed

#### Tribal rights

The consultation paper, Ms. Karat said, made no mention on protecting the rights of tribal communities and other traditional forest dwellers in any of the amendments proposed though the "direction of amendments proposed" would directly impact the rights granted under the Forest Rights Act, 2006.

As on Wednesday evening, the auction of 1,348 items at pmmementos.gov.in found no takers for some of the featured items, including some Olympics gear gifted to the Prime Minister. A Culture Ministry official said 1,083 items had already been bid upon as of Monday morning. A search for items with zero bids on the website showed 162 items as of 6 p.m. on Wednesday.

Many stoles and portraits,

including one of Mr. Modi

with his mother, have also found no takers yet.

However, many of these items had received bids of multiple crores each during the first week of the e-auction that started on September 17 – Mr. Modi's birthday, but those were found to be disingenuous and removed, another official said.

#### High bids for javelin

Meanwhile, the javelin used by gold medallist Neeraj Chopra had received two bids, taking its going price from the base of ₹1 crore to ₹1,00,50,000 as on Wednesday evening.

This was the third such auction of gifts given to Mr. Modi and bidding was set to go on till Thursday evening. Proceeds of the auction would go to the Namami Gange Mission, according to the Culture Ministry.



#### Dharma protects

'Dharmo rakshati rakshitah', it is said. That means if we protect dharma, then dharma in turn protects us. There are rules we have to follow in life. It is like adhering to lane traffic on a highway. 

### FM downplays risks from Evergrande, Fed moves

'Govt., RBI watching for taper tantrum'

Finance Minister Nirmala Sitharaman downplayed fears of global contagion from China's Evergrande crisis and said the central bank and the government were keeping a close watch to cope with any 'taper tantrum' risks arising from the U.S. Federal Reserve's likely shift in policy stance.

Without naming China, she also red-flagged a growing trend of smaller countries being driven into a debt trap that threatened their sovereignty.

"I am sure there will be, not specific to one country, but there will be this larger issue of debt sustainability, sovereignty and how smaller countries are facing a very trying and challenging situation when these two extremes are forced upon them," she said at the opening session at ICRIER's annual G20 conference.

Stressing that India and the world had learnt lessons from the 2008 global financial crisis, Ms. Sitharaman said she wasn't sure if the Evergrande crisis would figure in the upcoming G20 summit. "But without specifically referring to the G20 or any one particular country, it can be seen that globally, the sense of worry may be there but the fear that this is certainly going to

hit us, is not there," she said in reply to a query from NITI Aayog vice chairperson Rajiv Kumar on China's real estate sector's challenges spilling over to global markets.

'Debt trap'

"Specifically, not Evergrande, but debt sustainability is an issue. Which I am sure every global forum will have to address and talk about; particularly, debts which are being given, which also bring the sovereignty of a nation into the picture and threatens that; then it is a matter of serious concern and many of the countries are sitting up to say: What is happening around in the world?" Ms. Sitharaman remarked.

Emphasising that India had learnt its lessons from the way it handled the last taper tantrum which made it one of the 'fragile five' economies, she said: "Together with the Reserve Bank of India, we are definitely keeping a watch."

### Domestic air-passenger traffic rises 2-3% in Sept. from August, says Icra

'High ATF prices, low capacity utilisation to hit performance'

PRESS TRUST OF INDIA

India's domestic air-passenger traffic grew marginally by 2-3% to about 69 lakh in September as compared with about 67 lakh in August, credit rating agency Icra said on Wednesday.

When compared year-onyear (Y-o-Y), air-passenger traffic growth stood at about 74% in the month under review over September 2020.

Airlines witnessed about 61,100 departures in September as compared with 39,628 in the same month of 2020, it said, adding that on a sequential basis, the number of departures in the month gone by were higher by about 6%, as COVID-19 infections demonstrated a downward trajectory.

The average number of passengers per flight during September was 113, against an average of 117 passengers per flight in August.

Icra said that aviation turbine fuel (ATF) prices have seen a sharp increase of 78.6% on a Y-o-Y basis till October 2021, this coupled with low capacity utilisation of aircraft fleet will continue to weigh on financial performance of Indian carriers in FY22.

Furthermore, the credit profile of most Indian carriers continues to be characterised by a weak liquidity position, it added.



## China tensions worst in 40 years: Taiwan

Beijing has the ability to start a war but would weigh various outcomes, says Taiwan Defence Minister

Days after China's air force sent a record 56 aircraft towards Taiwan, Taiwanese Defence Minister Chiu Kuocheng described relations across the Strait as the most strained in 40 years.

"It is the toughest situation I have seen in more than 40 years of my military life," the Defence Minister, also a former General, was quoted as telling the legislature, amid stepped up aerial intrusions from China's air force.

The People's Liberation Army Air Force sent a record 38 aircraft into the Air Defence Identification Zone on Friday, October 1, China's National Day. Another 39 aircraft followed on Saturday, with a record 56 aircraft in two waves on Monday.

## Duo win Nobel Chemistry Prize for work on catalysts

They created an eco-friendly tool to build molecules

Germany's Benjamin List and U.S.-based David Mac-Millan on Wednesday won the Nobel Chemistry Prize for developing a tool to build molecules which has helped make chemistry more environmentally friendly.

Their tool, which they developed independently of each other in 2000, can be used to control and accelerate chemical reactions, exerting a big impact on drugs research.

Prior to their work, scientists believed there were only two types of catalysts metals and enzymes.

new technique, which relies on small organic molecules and which is called "asymmetric organocatalysis" is widely used in pharmaceuticals, allowing drug makers to streamline the production of medicines for depression and respiratory infections, among

others. Organocatalysts several steps in a production process to be performed in

an unbroken sequence, considerably reducing waste in chemical manufacturing, the Nobel committee at the Royal Swedish Academy of Sciences said.

Dr. List and Dr. MacMillan, both 53, will share the 10-million-kronor (\$1.1-million. one-million-euro) prize. "I thought somebody was making a joke. I was sitting at breakfast with my wife," Dr. List told reporters over telephone during a press conference after the prize was announced.

#### **Heads-up note**

In past years, he said his wife has joked that he should keep an eye on his phone for a call from Sweden.

"But todav we didn't even make the joke," Dr. List said.

"It's hard to describe what you feel in that moment, but it was a very special moment that I will never

forget." Asked about what the prize would mean for his future as a researcher, Dr. List promised he had "a few more plans".

Dr. MacMillan, born in Scotland, is a professor at Princeton University in the U.S., while Dr. List is a director at the Max Planck Institute in Germany.

"This work requires catalysts, which are substances that control and accelerate chemical reactions, without becoming part of the final product," it added.

Since their discovery, developments in the field can "almost be likened to a gold rush," with Dr. List and Dr. MacMillan designing "multitudes of cheap and stable organocatalysts," the science body noted.

### UAE claims to have 'overcome' COVID crisis

Fewer than 200 cases this month

The United Arab Emirates declared on Wednesday that it has overcome the COVID crisis, recording its lowest number of infections this month since summer last year. "I wanted to assure you

all that our lives must go back to normal," said Abu Dhabi Crown Prince Mohammed bin Zayed in footage published by the official WAM new agency.

"There are some changes in how we work, in our families' studies or our personal lives... but we thank God for everything," said the de facto UAE ruler.

"We also thank God that we have overcome this crisis... safely, in good health and with an experience, for which we paid the price, but we learnt a lot."

The seven emirates of the UAE recorded fewer than 200 new cases of COVID this month – the lowest figure since August last year.

While life in the UAE has largely returned to normal, it retains strict rules on wearing masks and social distancing. Dubai is counting on the six-month Expo 2020 Dubai – which opened on October 1 after a onevear delay - to attract millions of visitors and boost its

#### Taliban arrest 4 Islamic State members

The Taliban arrested four Islamic State members and seized their documents and weapons north of the Afghan capital, the group's chief spokesman said Wednesday.

Zabihullah Mujahid said the operation was carried out on Tuesday night by special unit forces in the Pashai area of Pagham district in Kabul province.

The extremist group has ramped up attacks since the Taliban consolidated power following the U.S. exit. It has claimed responsibility for attacks including two deadly bombings in the capital last month.

### Facebook blames outage on error during maintenance

It triggered a second problem making things worse

The global outage that knocked Facebook and its other platforms offline for hours was caused by an error during routine maintenance, the company said.

Santosh Janardhan, Facebook's vice-president of infrastructure, said in a blog post that Facebook, Instagram and WhatsApp going dark was "caused not by malicious activity, but an error of our own making."

The problem occurred as engineers were carrying out day to day work on Facebook's global backbone network - the computers, routers and software in its data centers around the world, along with the fiber-optic cables connecting them.

"During one of these routine maintenance jobs, a command was issued with the intention to assess the availability of global back-

bone capacity, which unintentionally took down all the connections," Mr. Janardhan said.

That change also triggered a second problem that made things worse by making it impossible to reach Facebook's servers even though they were operational. Engineers scrambled to fix the problem on site, but this took time because of the extra layers of security, Mr. Janardhan said.
