

5 Army men, 2 militants killed in four gunfights in J&K in a day

Ultras may have infiltrated recently from Pakistan

Five Army personnel, including a Junior Commissioned Officer (JCO), and two militants were killed in four encounters that raged between security forces and militants in different parts of Jammu and Kashmir within 12 hours on Monday.

A massive combing operation was launched in the Pir Panjal Valley's Surankote-Shahadra belt on Sunday night but the search party came under heavy fire on Monday morning from the militants, who may have infiltrated recently through the Line of Control in Poonch district.

"Based on intelligence inputs, the Army on Monday launched a cordon and search operation in villages close to Dera Ki Gali in Surankote area of Poonch. In the ensuing firefight, one JCO and four jawans suffered critical injuries. They were evacuated to the nearest medical facility but died of their injuries," Jammu-based Army spokesman Lt. Col. Devender Anand said.

The deceased soldiers were identified as naib subedar Jaswinder Singh, naik Mandeep Singh, sepoy Gaj-

jan Singh, all from Punjab; sepoy Saraj Singh from Uttar Pradesh; and sepoy Vaisakh H. from Kerala.

"After the initial encoun-

ter, the terrorists fled to nearby Bhangai village, and the encounter is still in progress," the Army said. Three to four heavily armed militants were sus-

Three to four heavily armed militants were suspected to be hiding in the tough terrain that has dense forest cover. The Army has not confirmed any casualty to the militants so far.

TRF militant killed

In the Kashmir Valley, security forces killed two ultras, including a militant of The Resistance Front (TRF) that was behind a civilian killing last week, in two separate operations.

TRF militant Imtiyaz Ahmad Dar was killed in Gund Jahangeer village of Hajin area of north Kashmir's Bandipora. "The slain militant was involved in the recent killing of a civilian at Shahgund," Inspector General of

Police Vijay Kumar said.

Muhammad Shafi Lone alias Sonu, a driver by profession, was among the five civilians killed in the Valley last week.

However, Dar's family al-

leged that he was picked up when he was harvesting the rice crop in the field and "killed in a staged encounter". "Dar is innocent. He was at home when the civilian was killed earlier last week and was working in the field when he was picked up by the security forces," the

family members stated. The Bandipora police, however, refuted the family's claims.

Shoot-out in Anantnag In another operation in south Kashmir's Anantnag, an unidentified militant was killed in the Khagund area.

"On specific information, when the police went to pick up an over ground worker, the militant opened fire, and an gunfight followed," the police said.

The fourth encounter broke out in south Kashmir's Shopian, where a group of militants is believed to be hiding in a residential colony. "The encounter started at Tulran in Imamsahab area of Shopian. Police and security forces are on the job," a police spokesman said.

India, China commander talks end in impasse

Each side blames the other for the deadlock

The 13th round of senior military commander talks between India and China on Sunday ended in a stalemate, with each side blaming the other for it.

In a statement, the Indian Army maintained that its side made "constructive suggestions" to resolve the "remaining areas", while the Chinese military alleged that India made "unreasonable and unrealistic demands".

Infrastructure build-up The acrimony comes amid

continuing build-up of troops and infrastructure by China on its side along the Line of Actual Control and as both sides are preparing to be deployed in the high altitude areas of eastern Ladakh for the second straight winter this year.

winter this year.

The Monday morning Army statement read, "During the meeting, the Indian side, therefore, made constructive suggestions for resolving the remaining areas but the Chinese side was not

agreeable and also could not provide any forwardlooking proposals. The meeting thus did not result in resolution of the remaining areas."

The talks were held at Moldo on the Chinese side, with the focus on working out the third phase of disengagement from Patrolling Point 15 in Hot Springs as part of the overall disengagement and de-escalation along the Line of Actual Control (LAC).

"The Indian side pointed out that the situation along the LAC had been caused by unilateral attempts of Chinese side to alter the status quo and in violation of the bilateral agreements," the Indian Army observed.

Industry seeks clarity on space policy

Industrialists told Prime Minister Narendra Modi on Monday that for the space industry to grow, the government should help small and medium sector enterprises (SME) access more capital as well as move faster on finalising its space policy.


The industry leaders were speaking at the inauguration of the Indian Space Association, an organisation meant to represent the interests of the space sector with government and private sector bodies across the board, including the Indian Space Research Organisation, Walchandnagar Industries, TATA Nelco, Pixxel, Mapmy India and Bharti Airtel.

In his address, Prime Minister Narendra Modi said his government was "the most decisive one in history" and that in sectors where the government "wasn't needed" the private sector ought to be stepping in. He cited the example of the recent decision of the government giving up its stake in Air India to a Tata group company.

The government's approach to space reforms, Mr. Modi said, is based on four pillars. First is the freedom of innovation to the private sector.

'Desh Ke Mentor' to guide govt. school children on career choices

They will be mentored by people who are successful in their respective fields

The Delhi government on Monday launched a mentorship programme for children studying in Classes IX to XII in its schools.

Under the 'Desh Ke Mentor' programme, students will be mentored by volunteers from across the country for 10-15 minutes daily on issues ranging from career choices to teenage-related concerns.

Chief Minister Arvind Kejriwal, while launching the initiative, said that through this programme children will get an elder brother, friend or sister with whom they will be able to share everything, and the youth, who want to become mentors, will be able to contribute to nation building by helping in guiding the future of the country.

'Non-judgemental guide' Speaking on the reason for starting such a programme, Mr. Kejriwal said when children reach Class IX, they de-

velop several emotional and physical needs as they have to deal with a lot of pressure from peers, family and siblings, besides studies and choosing a career.

"We want these children to get a non-judgemental helping hand and guiding light. Someone with whom the child can talk without any inhibitions. It is human nature that when you talk to someone, share your problems with them, you are inclined to feel cathartic. It helps one get out of a dark

mindset," Mr. Kejriwal said. The government is encouraging people in the age group of 18-35 years from across the country to join the initiative and they can do so by registering on an app developed for the purpose. "In our families, we see elder brothers and sisters guide their younger siblings. If we replicate the same model on the national level, the whole country will become a big family. People will start seeing beyond the fault lines of caste and creed, they won't see the re-

Delhi High Court gets two new judges

Two new judges of the Delhi High Court were sworn in on Monday, taking the working strength of the court to 31 against a sanctioned strength of 60.

Chief Justice D.N. Patel administered the oath of office to Justices Yashwant Varma and Chandra Dhari Singh, who were transferred to Delhi from the Allahabad High Court. Justice Varma was elevated as additional judge of Allahabad HC in October 2014 and took oath as permanent judge in February 2016. He graduated in law from Rewa University and got enrolled as an advocate in 1992.

Justice Singh was appointed as additional judge of the Allahabad HC in September 2017 and took oath as permanent judge in September 2019. He graduated in law from Delhi University in 1993 and got enrolled as an advocate in 1994.

The Supreme Court collegium had recently recommended the transfer/ retransfer of 17 High Court judges.

DCPCR appeals to Baijal to open schools from nursery to Class VIII

Letter says pandemic has caused serious learning losses

The Delhi Commission for Protection of Child Rights (DCPCR) on Monday urged Lieutenant-Governor Anil Baijal to open schools for children from nursery to Class VIII in a staggered manner. The commission said it has received complaints from different quarters on the matter and added that school closure is affecting about four million children in the city.

"Clearly, children not attending schools cannot keep them safe since the adults are moving about and returning home. There appears to be little evidence about how school closures Children not attending schools cannot keep them safe since adults are moving about and returning home

can benefit the children when all other sectors are open. It therefore remains unclear as to what extra vulnerability would children experience by coming to school," DCPCR chairman Anurag Kundu said in the letter to Mr. Baijal.

The pandemic has caused serious learning losses for children of all classes, Mr. Kundu said. "For example, 17% more Class I students

could not read letters in 2020-21 as compared to 2019-20, according to the Annual Status of Education Report 2021 by Pratham Education Foundation... About 80% of children aged 14-18 years report lower learning levels as opposed to when schools were open. About 92% of children on average have lost one specific language ability as compared to the previous years," the letter said.

The DCPCR also said that online education is inadequate. "The commission urges the Delhi Disaster Management Authority to issue necessary directions for the opening of schools and anganwadis," the letter added.

SDMC bans cross-gender massage at spa centres

Civic body frames new licence policy

The South Delhi Municipal Corporation on Monday announced the implementation of a new licence policy for spas and massage centres falling under its jurisdiction.

Approved by Lieutenant-Governor Anil Baijal, the corporation's press note stated that "cross-gender massages" will not be permitted and that male and female spa centres shall be in different sections".

Plea in court

Previously, a plea challenging the Delhi government's guidelines on banning crossgender massage services was filed in the Delhi High Court.

The petitioner, Associa-

tion of Wellness Ayurveda & Spa, said that cross-gender treatment has been "part of the traditional massage practices" and assuming prostitution to be only in the "heterosexual domain" is illogical.

"Permission will be granted in areas coming under the category of commercial, local commercial, notified commercial and mixed land use. In residential areas, new spa/massage centres will not be allowed," the press note stated, adding that spas and massage centres will be allowed to operate "only between 9 a.m. to 9 p.m.".

Last month, the East Delhi Municipal Corporation had also banned cross-gender massage at spas under its jurisdiction.

North body bans non-segregated waste collection from Nov. 1

NEW DELHI

The North Delhi Municipal Corporation on Monday announced that it will impose a complete ban on the collection of non-segregated waste – from households and commercial establish-

ments – from November 1. North Corporation Com-

missioner Sanjay Goel said the civic body will paste "red stickers" on the premises of regular defaulters. Speaking to *The Hindu*, Mr. Goel said the penalty for defaulters will be on a "daily

but nobody can afford to pay it all the time, so I think people would start adhering to the norms. Unless we attain a particular saturation level in waste segregation, the red stickers for defaulters will continue."

Mr. Goel said the move was being made in order to achieve the target of "100% segregation at source". Furthermore, deployment of workers at "dhalaos" has

been ordered to prevent the public from dumping nonsegregated waste.

"Under the Solid Waste Management Rule (2016), waste segregation is important and Swach Bharat 2.0 also says the same. One of the important tasks is to segregate the waste at the doorstep," he said.



Odisha hikes contractual workers' salary

SATYASUNDAR BARIK BHUBANESWAR

The Odisha government on Monday decided to enhance monthly remuneration of all contractual employees in the government sector and bring them under purview of medical reimbursement scheme.

The Cabinet chaired by Chief Minister Naveen Patnaik approved the proposal of amending the Con-Appointment tractual Rules 2013 and increasing the remuneration by 50%. Henceforth, they will be treated as 'initial appointee' instead of 'contractual employee'.

The decision assumes significance with the panchayat and civic body polls likely to be held early next year.

"As per the existing rule, the service of all the contractual employees is regularised after six years. Now, from day one, they will get 50% higher salary than that of present level," said Pratap Jena, Law Minister.

Mr. Jena said, "These initial appointees can get the medical expenses reimbursed like regular government employees.'

In another important decision, the State government has increased its contribution towards national pension scheme from 10% to 14% in respect of the employees covered under NPS. This decision will come into effect retrospectively from April 1, 2019.

To mark the birth anniversary of Jayaprakash Narayan, Rashtriya Lok Dal president Jayant Singh on Monday promised to implement a 'Sarvodaya Yojna' if people voted the party to power in the upcoming Assembly polls in Uttar Pradesh.

Since last week, Mr. Singh has been sharing features of the party's election manifesto that will be formally released on the birth anniversary of Sardar Vallabhbhai Patel on October 31.

Continuing with his bid to reach all sections of society, Mr. Singh at public meetings in Muzaffarnagar and Amroha said the party's election manifesto will guarantee protection to the minorities like all sections of society. "These days those who chose to stay in India after 1947 are being asked to prove their nationality," remarked.

Mr. Singh said a scholarship scheme would be launched for the students of the SC/ST and the OBC communities who get admission in top 500 universities of the world and promised an encouragement sum of ₹1 lakh for those seeking inter-caste marriage.

"We will also bring an entrepreneur fund of ₹2,500 crore for SC/ST and physically handicapped youth with

business aptitude to reduce economic disparity," he said. He assured financial pow-

ers to the Panchayati Raj Institutions as envisaged in the 73rd Amendment of the Constitution and promised to establish a fund of ₹2,500 agriculture crore for start-ups.

'Vote to seek revenge'

Addressing the farmers, Mr. Singh, who plans to participate in the last rites of the deceased in the Lakhimpur violence, said nobody thought that "a government chosen by you would not only ignore you but will also target you". "This government would try to make you forget the Lakhimpur violence but you have to remember the names who lost their lives," he said.

Referring to the local leadership, he added, "And ask those who have gone into hiding where were they when the farmers were being mowed down. Seek revenge through your vote," he said, describing his party as a fauj (army) of farmers that will work for their betterment.

Mixing the personal with the political, Mr. Singh said COVID-19 left a trail of sorrow in families across the region. "I lost my father, you lost a leader. But at that time, a section of people was having fun. According to an international magazine, the income of some corporates doubled."

Taking on the BJP government at the Centre and the State, Mr. Singh said, "One is remote-controlled by the corporates, the other is out of control."

In the season of appropriating icons, Mr. Singh is also not limiting himself to the legacy of his grandfather Chaudhary Charan Singh. Last week, he invoked BSP founder Kanshi Ram and promised to introduce a scheme in his name for the urban workers. Mr. Singh reminded how both Narayan and Charan Singh were followers of Mahatma Gandhi. It is significant because Charan Singh's supporters often held the anti-Emergency crusader responsible for 'decommunalising' Jan Sangh members and picking Morarji Desai over Charan Singh as the first non-Congress Prime

Dalit woman gang-raped in U.P.'s Jewar; one arrested

A middle-aged Dalit woman was allegedly gang-raped at gunpoint in Uttar Pradesh's Jewar area near Noida, police officers said on Monday, as the Opposition parties, including the BSP and the Congress, demanded action against the culprits.

One of the four accused has been arrested over the Sunday morning incident even as multiple police teams were formed and surveillance teams, along with dog squads, deployed, the officers said. The key accused is absconding.

Deputy Commissioner of Police (Women and Child Safety) Vrinda Shukla said, "Both are from the same village and known to each other." The key accused, a drug-addict, dragged the woman and forced himself on her, according to Ms. Shukla, even as local officials said the woman was raped at gunpoint.

Actor Nedumudi Venu is no more

Essaying an array of unforgettable roles, he held sway across Malayalam cinema for over four decades

S.R. PRAVEEN _____ THIRUVANANTHAPURAM

Nedumudi Venu, one of Malayalam cinema's most versatile character actors, passed away here on Monday afternoon. He was 73. He was admitted to a private hospital a few days ago following liverrelated ailments.

In a career spanning more than four decades and over 500 films, Venu portrayed a wide range of characters that showed his histrionic prowess. After proving his mettle on the stage, being a member of Kavalam Narayana Panicker's drama troupe, he made his film debut with G. Aravindan's Thambu in 1978. He won the national award for the best supporting actor in 1990 and a special mention in 2003. besides six State

Venu has been part of some of the most popular films to have been made here.

awards.

Some films which he recently completed, including Marakkar: Lion of the Arabian Sea, Aarattu, and Puzhu, are yet to be released in the theatres.

He had acted in several Tamil movies, the notable ones being Indian, Anniyan, Silambattam and the recent Sarvam Thaala Mayam.

Governor Arif Mohammed Khan, in his condolence message, said Venu was one of the finest actors in Malayalam and Indian cinema. His profound knowledge of traditional art forms and Indian style of acting reflected in his unique, endearing performances.

Chief Minister Pinarayi Vijayan said Venu found a place in the hearts of the people playing a variety of characters and through his folk songs. His passing was an irreparable loss to the State's cultural sphere, he said.

In one of the memorable

scenes from the 1987 film Sarvakalashala, college student Lal, played by Mohanlal, tells the free-spirited poet Siddhan Aashan, played by Venu: "If Aashan leaves from here, my beat would become like that of a dead body. I want that other beat, the rhythm of life." The scene leads into Aashan's rendition of *Athiru* Kaakkum Malayonnu Thuduthein Venu's own folksy

Breaking boundaries

That scene perhaps gives a hint of what Nedumudi Venu was to Malayalam cinema, someone with a deep link to its cultural ethos, its traditional art forms and literature, someone who imbibed the rhythm of life in Kerala's rice bowl Kuttanad and brought that sense of rhythm into his performances, which ranged from absurdly comical to deeply moving.

The actor often managed to break the boundaries of the classification of 'character actor', under which he was bracketed in.

There is not one quintessential Nedumudi Venu role. for, in his heydays, he was unrecognisable from one role to the next – a lecherous, petty thief in one and a kind priest or musician in another.

Born the youngest of five sons of P.K. Kesavan Pillai and Kunjikutti Amma in Alappuzha district's Nedumudi, a backwater village that he made famous, Venu took to acting quite early, scripting and acting in plays during his school days at the NSS School in Nedumudi and St. Mary's Higher Secondary School in Champakkulam.

During his days at S.D. College in Alappuzha, he teamed up with his classmate and filmmaker Fazil for drama and mimicry performances.

Cases lodged for 'hurting' Hindu sentiments in M.P.

Priests drop demand for barring women

The Ujjain and Indore police in Madhya Pradesh have lodged cases against a woman and five persons respectively for allegedly hurting Hindu sentiments.

Priests enraged over a video shot on the Mahakaleshwar temple premises in Ujjain demanded that the entry of women be stopped. The State's Home Minister asked the SP to lodge an FIR against the woman on Monday. The priests dropped their demand after the registration of the FIR.

In the second incident, cases against four non-Hindu youth and the organiser of a garba event were lodged in Indore on Sunday night after members of the Vishwa Hindu Parishad (VHP) and Bajrang Dal alleged that the event promoted "anti-Hindu activities".

The woman at the centre of the Ujjain controversy had posted the video she shot on Instagram, but took it down and issued a video statement apologising for her action which she said was not liked by priests and certain outfits.

Moolchand Junwal, assistant administrator of the Mahakaleshwar temple, told media persons earlier on Monday that the priests lodged a complaint with the Ujjain administration demanding action against the woman and seeking that women be disallowed entry into the temple henceforth.

"Stern action will be taken against people for releasing videos shot at religious places that hurt sentiments. In the context of a video released by a woman shot at Ujjain's Mahakaleswar temple, I have asked the Ujjain Superintendent of Police to lodge an FIR against the woman," tweeted Home Minister Narottam Mishra.

Garba event halted

In Indore, members of the VHP and Bajrang Dal created a ruckus during a garba event on Sunday alleging that it was promoting "love jihad", a term used by rightwing outfits to describe interfaith marriages involving Muslim men and Hindu women. They stopped the event at Oxford College in the town's Gandhi Nagar area insisting that participation of people from other religions is not acceptable at a Hindu event. The Gandhi Nagar police lodged an FIR against four persons and the organiser of the event, an official said.

The State's communally sensitive Malwa region has reported several incidents triggered by Hindu and Muslim radical groups in the past.

Man who used cobra to kill wife found guilty

Sooraj was brought to the court that was chock-a-block with lawyers, media and pu-

blic around noon. Sooraj remained impassive during the proceedings and when the

chargesheet was read, he said

he had nothing to say. Citing the guidelines laid down by the Supreme Court in Sushil Murmu vs State of Jharkhand (2004), Special Public Prosecutor G. Mohanraj argued that the brutal and monstrous nature of the case merited death sentence.

Uthra's family said they were grateful to the investigating team and prosecution.

Sooraj had used a cobra to murder his wife and it was his second attempt that took the 25-year-old woman's life. Uthra's body was found on May 7, 2020 at her home in Anchal. She had survived an earlier viper bite. Her husband had paid ₹10,000 for the snakes to a handler, who later turned approver. The investigation team had conducted a postmortem of the snake to confirm that the DNA of the same snake was found in the jar in which Sooraj had kept the co-

"It is unfortunate that a small part of my speech has been taken out of context.'

"My statement is based on a survey. The findings of You-Gov-Mint-CPR Millennial Survey show that among millennials, 19% are not interested in either children or marriage. Another 8% want children but are not interested in marriage. Among post-millennials (or Gen Z adults), 23% are not interested in either children or marriage. There are very little genderwise differences in these trends. It is applicable to both boys and girls," he said.



Dangerous deadlock

Past border agreements are in disarray as the Line of Actual Control sees heavy deployment s winter arrives on the Line of Actual Control (LAC), the latest round of talks – the thirteenth – between India and China ended with no resolution in sight, leaving tens of thousands of soldiers facing the prospect of another harsh cold season on the heights of Eastern Ladakh. The contrasting statements sharply underlined the deadlock. The Indian Army's statement on Monday morning noted that while India made "constructive suggestions" for resolving the remaining areas, the Chinese side "was not agreeable and also could not provide any forward-looking proposals". A Chinese statement on Sunday night accused India of making "unreasonable and unrealistic demands". There was no joint statement, as in the last round in August, when agreement was reached to disengage at Gogra. The only surprise is that the discord is now fully out in the open, in contrast to the anodyne declarations of both sides in August to "enhance trust" and "expedi-

tiously resolve" issues that have already dragged on for

more than one year. In fact, recent events on the boun-

dary offered a portent that all was not well. First, reports citing Indian official sources, put out two days before Sunday's talks, revealed a face-off in the Tawang Sector in Arunachal Pradesh; later, Chinese soldiers had been detained for a few hours. The reports sparked an angry reaction in China, where the military apparently leaked on social media images from last year purportedly showing injured Indian soldiers detained by China in the Galwan Valley. Statements from the Chinese Foreign Ministry, accusing India of following a "forward policy" in an explicit invocation of 1962, have vitiated the atmosphere. That China put out a statement on Sunday night barely hours after the talks concluded – a departure from normal practice in a country where statements usually are carefully vetted suggests the PLA had no real intention to seek a resolution. This leaves the LAC in a perilous situation. Not only are several hotspots unresolved – the latest round was to discuss Hot Springs, while disputes remain over Demchok and Depsang – the Corps Commanders were also set to work out new protocols for patrolling. Speaking this weekend, Indian Army Chief General M.M. Naravane noted a large-scale infrastructure build-up on the Chinese side, and said as Chinese troops were there to stay, Indian troops will be there to stay too. Ladakh and the western sector may remain the focus of tensions, but as recent flare-ups in Uttarakhand and Arunachal Pradesh show, the middle and eastern sectors are hardly tranquil. Past border agreements are in disarray in the wake of China's unprecedented amassing of troops, while around 50,000 troops of each side remain deployed in forward areas, all of which make for a dangerous mix as winter falls on the Himalayas.

Limits to accommodation

RBI's failure to rein in inflation will hurt savers and risk derailing a consumption-led revival

he RBI's latest monetary policy statement and accompanying actions reflect the dilemma confronting monetary authorities. While the RBI's Monetary Policy Committee voted unanimously to keep benchmark interest rates unchanged as part of its efforts to support growth as the economy recovers, one of the six members on the MPC demurred yet again and voted against continuing with an accommodative stance for 'as long as necessary'. Prof. Jayanth Varma had at the last meeting in August flagged the risks that prolonged monetary accommodation posed to the inflation outlook by 'stimulating asset price inflation' even as he posited that its impact in 'mitigating the distress in the economy' was arguably far more marginal. The MPC's own current inflation outlook is a mixed bag. The projection for average inflation for the full fiscal year has been cut by 40 basis points to 5.3% even as the committee stresses that with core inflation 'persisting at an elevated level', the Centre and States would need to further ameliorate supply side and cost pressures, including through calibrated cuts in indirect taxes on petrol and diesel so as to address the issue of 'very high' pump prices. In an acknowledgment of the difficulty it faces in containing price pressures even as it keeps interest rates at growth-supportive lows, the monetary panel reiterated its plea for fiscal authorities to step in and help contain inflationary pressures, especially the pass-through impact of elevated transportation costs.

Governor Shaktikanta Das tacitly conceded that the time had come to wind down the pandemic-era liquidity support as he announced the suspension of the G-SAP bond buying programme and simultaneously outlined measures to drain out surplus liquidity from the banking system. He cited the seemingly 'strengthening' growth impulses to justify the RBI's decision. Here again, the MPC's prognostication on growth is filled with uncertainties and caveats. Contact intensive services, which contribute about two-fifths to economic output and were among the worst hit by the COVID restrictions, still considerably lag their pre-pandemic levels; the manufacturing sector is still nowhere near supporting a rebound in investment demand; and, most crucially, the external environment that has so far been a major tailwind – through capital inflows and the demand for the country's goods and services - is turning more uncertain. With growing signs that some major advanced economies are gearing for an imminent normalisation of monetary policy, the elbow room for the RBI to stay accommodative is narrowing sharply. As Prof. Varma had noted in his dissent, monetary authorities face the danger of failing to fulfil the MPC's primary mandate of anchoring inflation expectations firmly around the 4% target. A failure that would hurt savers the most and risks derailing a consumption-led revival.

The 'yes or a no' the Court must ask about Pegasus

n July this year, a global coalition of media organisations revealed that a mobile phone spyware – Pegasus – was being used in a number of countries to surveil journalists, activists, dissidents, and political leaders. Manufactured by an Israeli cyber-arms firm called the NSO Group, Pegasus is a highly invasive malware that once installed on an individual's phone, can collect and transmit data, track activities such as browsing history, and control functionalities such as the phone camera. The NSO Group claims that its only clients are vetted governments. The Pegasus revelations thus indicated the possibility of serious governmental abuse.

Yet another episode

The revelations further showed that around 50,000 mobile phone numbers had been potentially infected by the spyware. Many of these numbers were Indian, and belonged to journalists, activists, and politicians. This was not the first time that such a thing had come to light. India featured on a list of Pegasus-using countries as early as in 2018. In 2019, it was found that a number of activists including some of the accused in the infamous Bhima Koregaon case had been potentially spied upon, and their mobile phones compromised. Later the same year, WhatsApp notified the Indian government of a Pegasus-related security breach, with as many as 121 Indian citizens being targeted. The July 2021 revelations, thus, were not new, but only the most recent and

tary-grade surveillance being carried out upon Indians.

A track of stonewalling

In the aftermath of the Pegasus revelations, certain countries such as France and Morocco ordered immediate investigations. In India, however, the story has been one of continuous official stonewalling. In October 2019, Right to Information requests about whether the Indian government had purchased the Pegasus software were met with a "no information available" response. Parliamentarians put questions to the Government in the Lok Sabha and Rajya Sabha, where, once again, no response on the purchase or use of Pegasus was forthcoming. The Government continued to maintain this stance in response to various Parliamentary questions put to it through 2020 and 2021, and even after the 2021 revelations, including the effective quashing of a Parliamentary Committee inquiry into the issue, with ruling party politicians disabling it from functioning by denying it a quorum.

This history clearly indicates that attempts in Parliament to hold the executive accountable for possible abuse of governmental surveillance powers has been entirely frustrated for more than two years. Under our constitutional scheme, however, there is a third wing of state that exists precisely to address situations where executive abuse and violations of fundamental rights are not being checked by the available mechanisms: the court. Consequently, at the end of July, multiple petitions were filed before the Supreme Court of India, alleging breaches of fundamental rights, and of India's legislative framework dealing with lawful interception of communications.

However, it has now been almost two-and-a-half months since the petitions came to court, with-

out meaningful action. Between August 5 and September 13, 2021, the Court held six hearings on the

The issues are simple

The issues before the Court were simple: did the Government of India authorise the use of Pegasus upon the individuals whose names had appeared in the list? If it did, was there any justification for the use of such intrusive surveillance upon individuals who, admittedly, were not accused of any wrongdoing? And if it did not, was it not a breach of the Government's constitutional obligations to protect its citizens from the use of military-grade surveillance by rogue actors? It is important to note that the petitions were not some fishing expedition asking the Government to reveal details about its general interceptions techniques: rather, they were brought to court by individuals who had themselves been affected by Pegasus, and were focused upon accountability: in essence, does the Indian Constitution allow for rampant and unchecked surveillance upon individuals – surveillance that goes far beyond simple interception of communication, and effectively hijacks and individual's mobile phone – with complete impunity?

Nonetheless, throughout the hearings, the Government continued upon its track of evasion: it repeatedly refused to file an affida-

until nudged by the Court to do so. The final affidavit that it did file was nothing more than a recapitulation of its evasive stance in Parliament. Furthermore, it continued to resist answering the core questions put to it, on the basis that doing so would undermine "national security". This has, however, been a recent, unfortunate trend: whenever the question of widespread and serious rights violations arises, the Government recites the words "national security" like a mantra, not simply to avoid providing answers, but to hint that even asking the question is somehow illegitimate. In this way, "national security" becomes a cloak for impunity.

On the court's conduct Nowhere was this more evident during the course of the Pegasus hearings. If a person whose mobile phone has been hijacked by a military-grade spyware that is only sold to governments, and if the Constitution means anything at all, it means that that person has the right to know why this has been done to him, and at whose behest. And – with the inability of Parliament to hold the executive to account – the only place where the individual can seek answers is the court. This has nothing to do with "national security", and everything to do with whether we are a country governed by the rule of law – where the rule of law applies to both individuals and to the state – or whether we are living under a regime of executive impunity.

Unfortunately, however, a record of the hearings so far indicates that the Court has allowed the Government to get away with much of its evasion. Despite the passage of two and a half months, the Court is yet to pass any consequential orders including, for example, orders directing the Government to provide information that it has refused to

provide Parliament and to citizens. Furthermore, the Court's conduct has not been limited to inaction. When the State of West Bengal set up a committee to investigate Pegasus, the Court entertained a plea against it - despite having no ground to do so - and by orally expressing its disapproval (without any clear grounds to do so), effectively compelled the State government to halt the investigation. At no point was any legal justification provided for why the Court decided to hear such an irregular plea, or why the State of West Bengal was required to stop investigating breaches of fundamental rights.

Need for direction

On the last date of hearing, September 13, the Court indicated that it would establish a Committee to look into the matter. However, this puts the cart before the horse: it is unclear why the Court has not yet drawn an adverse inference against the Government for its repeated refusal to answer straightforward questions about potentially abusive surveillance; the setting up of a Committee would make sense after such a finding had been returned. Moreover, the substantial amount of time that has passed since the last order is worrying. In India, we have a long experience of "death by Committee": issues that require urgent attention linger for many months in a Committee, and once public memory has dulled, are given a quiet burial. It is vital that this should not happen in the present case. Thus, a direction by the Court to the Government to answer whether it has been spying on citizens not accused of any offence - a direct yes/no question - and, if the answer is yes, to require it to explain why or face legal consequences – would be a good start.

The next step is a constitutional right to health

The brevity of human memory is often a blessing and even necessary for our colthe lessons we learn from suffering are possibly even more crucial. As our people continue to face individual and collective grief as a result of the novel coronavirus pandemic, it is the moral responsibility of our leaders to look ahead and learn the necessary lessons.

A place for this 'right'

The lesson here is the need for the constitutional 'Right to Health for all'. The pandemic has exposed and aggravated the cracks in our health-care systems, and this is a lesson we cannot afford to ignore and not learn.

In June this year, I called on the Parliament of India to take immediate measures to make necessary amendments to the Constitution to declare health care a Fundamental Right. I was reassured with positive responses from parliamentarians across party lines who have supported this call. Now, the time has come to make this a reality for India so our people never have to undergo the suffering that they did.

Through the eyes of citizens

The primary question raised is: can provide simple, transparent what will a constitutional 'Right to and quality health care to those I will try and explain this through the lens of three categories of citizens: farmers and unorganised workers, women and children.

Farmers are the primary protectors of our fundamental right to life. Yet, the majority remain at a loose end when it comes to their own rights and well-being, and that of their families. Without an anchor during times of severe illness or disease, generations of children of small and landless farmers, and unorganised, migrant and seasonal workers are thrown into bondage and debt by having to pay for medical costs from their limited earnings. Employment benefit schemes do not reach them, and the ones that do are mostly on paper. The implementation of the right to health



Women bear a disproportionate burden of the gaps in our healthcare system. The taboos and patriarchal expectations surrounding their health lead to immense avoidable suffering. In addition, social and economic challenges prevent them from freely and openly accessing the little care that is available. A 'Right to Health' would mean that services reach the woman where and when she needs them.

A large number of children who belong to the poorest and most marginalised communities of our country grow up working in hazardous situations be it fields, mines, brick kilns or factories. They are either not enrolled in schools or are not able to attend it due to the pressing financial needs of the family – often because of unexpected out-of-pocket medical expens-

Making it safer for children

My organisation has rescued over 1.00.000 such children from child labour, bonded labour, and trafficking. When rescued, these children are ridden with complex health impacts of working - primarily tuberculosis, skin diseases, trition, besides the substantial mental health impact. These children have been denied a safety net of early childhood care and protection, the consequences of which are felt for a lifetime. The 'Right to Health' will help transition the children in exploitative conditions into a safer future.

A constitutional 'Right to Health' will transform not only the health and well-being of our people but will act as a leap for the economic and developmental progress of the nation. Presently, any investment in health care fails to translate into a sense of security and sanctuary for the people of India. Instead, the complex and often corrupt means of accessing even existing health care only adds to the suffering instead of alleviating it. The vision for Ayushman Bharat will be strengthened with a constitutional 'Right to + Health'. The immediate financial security that will come with the constitutional 'Right to Health' will be seen as a measurable impact on family savings, greater investment, and jobs creation on the one hand, and in the long-term emotional, psychological and social security of people.

As a legacy

The world is taking steps, both big and small, in recovering from the pandemic through foresight in policy and investment. India must not lag behind. The right to free and compulsory education was arguably one of the most valuable legacies of the earlier Government. The true testament of bold leadership lies in its timely, compassionate and courageous decisions for the greater good. A constitutional amendment to introduce the 'Right to Health for India' can be the legacy of this Government.

Protecting India's natural laboratories

Preserving geological heritage is as important as safeguarding biodiversity and cultural heritage

Like social diversity, India's geodiversity, or variety of the geological and physical elements of nature, is unique. India has tall mountains, deep valleys, sculpted landforms, longwinding coastlines, hot mineral springs, active volcanoes, diverse soil types, mineralised areas, and globally important fossil-bearing sites. It is long known as the world's 'natural laboratory' for geo-scientific learning.

Lack of geological literacy

Broken loose from a supercontinent 150 million years ago, the Indian landmass, with all its strange-looking plants and animals, drifted northwards all by itself for 100 million years until it settled under the southern margin of the Asian continent. It got entwined with the world's youngest plate boundary. The geological features and landscapes that evolved over billions of years through numerous cycles of tectonic and climate upheavals are recorded in India's rock formations and terrains, and are part of the country's heritage. For example, the Kutch region in Gujarat has dinosaur fossils and is our version of a Jurassic Park. The Tiruchirappalli region of Tamil Nadu, originally a Mesozoic Ocean, is a store house of Cretaceous (60 million years ago) marine fossils. To know how physical geography gets transformed into a cultural entity, we need to study the environmental history of the Indus River Valley, one of the cradles of human civilisation. India offers plenty of such examples.

Geo-heritage sites are educational spaces where people find themselves acquiring badly needed geological literacy, especially at a time when India's collective regard for this legacy is abysmal. Indian classrooms view disciplines like environmental science and geology with disdain compared to how they view other 'pure' subjects like physics, biology, and chemistry. This lack of interest in the government and our academic circles towards geological literacy is unfortunate at a time when we face a

crisis like global warming. As the climate of the future is uncertain, decision-making is difficult. Learning from the geological past, like the warmer intervals during the Miocene Epoch (23 to 5 million years ago), whose climate can be reconstructed using proxies and simulations, may serve as an analogue for future climate. The awareness accrued through educational activities in geoheritage parks will make it easy for us to memorialise past events of climate change and appreciate the adaptive measures to be followed for survival.

The importance of the shared geological heritage of our planet was first recognised in 1991 at an UNES-CO-sponsored event, 'First International Symposium on the Conservation of our Geological Heritage'. The delegates assembled in Digne, France, and endorsed the concept of a shared legacy: "Man and the Earth share a common heritage, of which we and our governments are but the custodians." This declaration foresaw the establishment of geo-parks as sites that commemorate unique geological features and landscapes within their assigned territories; and as spaces that educate the public on geological importance. These sites thus promote geo-tourism that generates revenue and employment.

In the late 1990s, in what may be considered as a continuation of the Digne resolution, UNESCO facilitated efforts to create a formal programme promoting a global network of geoheritage sites. These were intended to complement the World Heritage Convention and the UNESCO Man

troyed due to the laying of a new rail track in the area. Similarly, a national geological monument exhibiting a unique rock called Nepheline Syenite in Ajmer district of Rajasthan was destroyed in a road-widening project. The Lonar impact crater in Buldhana district of Maharashtra is an important geo-heritage site of international significance. It is under threat of destruction, although conservation work is now in progress under the High Court's supervision.

We are inching towards the disappearance of most of our geological heritage sites. Thanks to unplanned and booming real estate business, many such features have been destroyed. Unregulated stone mining activities have also contributed to this destruction. This situation calls for immediate implementation of sustainable conservation measures such as those formulated for protecting biodiversity. Natural assets, once destroyed, can never be recreated. And if they are uprooted, they lose much of their scientific value.

Geo-conservation legislation

The protection of geo-heritage sites requires legislation. The Biological Diversity Act was implemented in 2002 and now there are 18 notified biosphere reserves in India. Geoconservation should be a major guiding factor in land-use planning. A progressive legal framework is needed to support such strategies. In 2009, there was a half-hearted attempt to constitute a National Commission for Heritage Sites through a bill introduced in the Rajya Sabha. Though it was eventually referred to the Standing Committee, for some unstated reasons the government backtracked and the bill was withdrawn. In 2019, a group of geologists under the auspices of the Society of Earth Scientists petitioned the Prime Minister and the Ministries concerned about the need for a national conservation policy under the direct supervision of a national body committed to the protection of geo-heritage sites. But the government's apathy continues.

The audacity of regional films

Regional cinema represents India in a much more holistic and meaningful manner than Bollywood

For long, Indian cinema has been synonymous with Bollywood. However, the pandemic-induced growth of over-the-top (OTT) platforms has opened up new vistas for audiences to watch and appreciate films from other parts of the country. Bollywood, which is largely influenced by the ebbs and flows of the box office, has often failed to capture the social complexities of Indian society. It is still quite distant from the experiences and sensibilities of the masses. It generally follows an escapist approach, where storytelling becomes a commodity. On the other hand, Malayalam, Assamese, Bengali, Marathi and Tamil cinema, to name a few, frequently depict gender, religious, caste and class disparities.

This is not to say that fantasy, which provides a break from the dreariness of our daily lives, is not an important aspect of cinema. But it is the safe distancing of Hindi cinema from hard-hitting issues such as the atrocities committed against Dalits and Muslims, religious majoritarianism, sexual inclusivity and class barriers that are a major concern.

Pushing boundaries

The cinematic treatment of Bollywood has been formulaic. Films either derive inspiration from the West or are compelled by the process of globalisation. Over the past few years, Bollywood has churned out many hyper nationalist films, films that misrepresent minority communities, and films that assert a certain culture, thus furthering the majoritarian nation-building project.

On the other hand, regional cinema is constantly pushing boundaries with experimental takes on social and political issues. In recent years, Tamil cinema has revolutionised the art with larger social observations. Filmmakers like Mari Selvaraj, Pa. Ranjit and Vetrimaaran have produced films that explore the issues of the common man. They represent the voice of the subaltern without being apologetic unlike their counterparts in Bollywood. Mari Selvaraj and Pa. Ranjit are known for making films centred around Dalit lives. In the 1970s and '80s, there was a wave of parallel cinema in Bollywood which spoke of the victimisation of Dalits. However, in contemporary Tamil cinema, Dalits are not victims; they are assertive protagonists who actively fight back against upper caste assertion. Through his films Kabali and Kaala and

most recently *Sarpatta Parambarai*, Pa. Ranjith has brought to us Dalit heroes, who are rare in Indian film history. Mari Selvaraj has established the normalisation of Dalit characters through *Pariyerum Perumal* and *Karnan*. These films further the politics of social justice in subtle ways instead of depicting communities as pitiable beneficiaries of certain policies and lacking in dignity.

Another regional industry which has resonated with the larger Indian audience is the Malayalam industry. Malayalam cinema is known to reflect on contemporary concerns and anxieties. Most Malayalam films have small budgets, but their impact is immense because of their fresh take on common people-centric stories. Jeo Baby's The Great Indian Kitchen, for instance, can be considered as one of the biggest disruptors of normative gendered labour and relations. While questioning regressive gendered practices, the filmmaker employs a layered and minimalist approach to drive the message home. On the other hand, Bollywood's approach tends to be loud and sensational, with a greater focus on costume, set design, light, colour, and location than the subject at hand. In Dileesh Pothan's Maheshinte Prathikaaram, even the slippers of the character played by Fahad Faasil has an important role to play. Regional films are often replete with metaphors and symbols.

Politics of majoritarianism

Today, when hyper nationalism is at its peak, Bollywood often acts as a tool in the hands of the majoritarian nation-building project. Many Hindi films use the archaic trope of cultural assertion and continue to vilify a particular community while downplaying structural inequalities in society. This trend can be witnessed in the surge in period dramas and biopics of politicians and sportspersons where characters are overglorified. On the other hand, certain filmmakers in Bengali and Marathi cinema, through their politically heightened content, are challenging polarisation and the threat to India's diversity. Aparna Sen in her 2019 film, Ghawre Bairey Aaj, highlights the jingoism prevalent in the political ecosystem. Another important movie is Nagraj Manjule's Sairat which treats caste as a political issue.

Regional cinema has woven narratives in a socially conscious manner and has the potential to substantially disrupt class and caste hegemony and majoritarianism. It represents India in a much more holistic and meaningful manner than Bollywood.

Tackling the climate crisis

The pressure to speed up mitigation and adaptation is at an all-time high

The recently published Intergovernmental Panel on Climate Change (IPCC) Sixth Assessment Report from Working Group I makes a clarion call for climate action. According to the report, the past decade (2011-2020) was warmer by 1.09°C than the period from 1850 to 1900, and the 1.5°C global warming threshold is likely to be breached soon. The IPCC report warns India against more intense heat waves, heavy monsoons and rise in weather extremes in the future. The Global Climate Risk Index (2021) ranked India the seventh-most affected country by weather extremes. Responses to climate change vary from place to place as there are differences in production systems, agro-climatic and socio-economic conditions across the country.

Adopt adaptation strategies

The pressure to speed up mitigation and adaptation is at an all-time high. India is doing well in achieving its mitigation commitments of reducing emission intensity and enhancing renewable capacity. India is targeting 450 gigawatts of renewable energy capacity by 2030 and it has launched mega solar and green hydrogen missions. The Shoonya programme by NITI Aayog, which aims to accelerate adoption of electric vehicles, is yet another effort towards adoption of clean technologies.

With escalating climatic risks, there is an urgency to adopt adaptation strategies. India has some dedicated initiatives towards adaptation, such as the National Action Plan on Climate Change and the National Adaptation Fund. However, a breakthrough on adaptation and resilience actions is needed to save hardearned developmental gains and adjust to new climate conditions. Adaptation planning needs to go beyond a business-as-usual approach. A development-centric approach that aligns climate change, food security, and livelihood perspectives and takes into consideration regional specificities is crucial for reducing poverty and distress migrations. Moreover, adaptation planning requires governance at different levels to understand, plan, coordinate, integrate and act to reduce vulnerability and exposure.

To strengthen adaptation and resilience, India can do the following. First, it can be more prepared for climate change with high-quality meteorological data. With improved early warning systems and forecasting, we can tackle the crisis better. Premier research institutes can be roped in to develop regional climate projections for robust risk assessments.

Second, for sustainable production systems, it is necessary to develop well-functioning markets for environmentally friendly products and disseminate them for the desired behavioural change.

Third, it is important to encourage private sector participation for investment in adaptation technologies and for designing and implementing innovative climate services and solutions in areas such as agriculture, health, infrastructure, insurance and risk management.

Fourth, we need to protect mangroves and forests to address climaterelated risks by blending traditional knowledge with scientific evidence and encourage local and non-state actors to actively participate. Fifth, major social protection schemes must be climate-proofed. We have an opportunity to create resilient infrastructural assets, diversify the economy and enhance the adaptive capacity of rural households. Sixth, for continuous monitoring and evaluation, effective feedback mechanisms must be developed for mid-course correction. Periodic fine-tuning of State Action Plans on Climate Change is crucial to systematically understand micro-level sensitivities, plan resource allocation, and design responses to serve at different levels of intensities of climate hazards.


Proactive and timely need-based adaptation is important. Without it, there will be a huge fiscal burden in the future. A more collaborative approach towards climate change adaptation is crucial. Next-generation reforms will promote new business and climate service opportunities across several sectors and thus create a sustainable economy.

Pak wooing ejected foreign newsmen

Rawalpindi, October 11: Shocked by its image abroad and worried about votes against it at the United Nations, Pakistan is wooing some of the same foreign newsmen it ejected summarily from Dacca in March when the Army routed the Awami League and seized Sheikh Mujibur Rahman. Spokesmen of the Ministry of Information here for the first time are promising regular briefings for foreign reporters. However, foreigners are still barred from weekly briefings conducted by the Ministry of External Affairs. Wooing does not extend to the domestic press. Although prepublication censorship of the local press has been lifted, news agencies and newspapers operate under a Martial Law regulation which amounts to virtually the same thing. The regulation forbids publishing material which "directly or indirectly" prejudices "the solidarity of Pakistan", criticises the Martial Law regime, creates alarm, criticises President Yayha Khan, creates illwill among the various groups of people in Pakistan and insults Islam or Mohamed Ali Jinnah. The Government has also warned newsmen against speculation on national issues such as the secret trial of Sheikh Mujib.

India, China talks end in impasse

"It was therefore necessary that the Chinese side take appropriate steps in the remaining areas so as to restore peace and tranquillity along the LAC in the western sector," the statement

This would also be in accord with the guidance provided by the two Foreign Ministers in their recent meeting in Dushanbe where they agreed that the two sides should resolve the remaining issues at the earliest, the statement said. Such resolution of the remaining areas would facilitate progress in the bilateral relations, it asserted.

"It is our expectation that the Chinese side will take into account the overall perspective of bilateral relations and will work towards early resolution of the remaining issues while fully abiding by bilateral agreements and protocols," it noted.

PLA statement

The Chinese military's statement on Sunday night came not from the Defence Ministry, as was the case in some of the earlier rounds, but from the PLA's Western Command in Chengdu, which has in recent rounds appeared to have taken over the responsibility for putting out statements on the LAC situation. This is seen by some observers as Beijing placing less importance on the slow moving negotiations.

Since the stand-off began in May last year, both sides have held a series of talks at different levels-political, diplomatic and military, and as part of agreements reached, have undertaken disengagement from both sides of Pangong Tso in February and the Patrolling Point 17 at Gogra area in August. The other friction areas that remain are Hot Demchok and Springs,

Officials remarked that while an agreement for resolving Hot Springs was within reach, Demchok and Depsang were legacy issues and tough to resolve. In addition to the overall disengagement and de-escalation, the two sides had also agreed to work out new protocols for patrolling to ensure such instances do not occur again.

The PLA statement did not suggest any agreement reached on either disengaging or on new protocols.

Senior Colonel Long Shaohua, spokesperson for the Western Theatre Command, stated, "China had made great efforts to promote the easing and cooling of the border situation and fully demonstrated its sincerity in order to maintain the overall situation of the relations between the two militaries. However, India still insisted on the unreasonable and unrealistic demands, which made the negotiations more difficult," he said. "China's resolve to safeguard national sovereignty is firm".

He called on India "to not misjudge the situation" and to "cherish the hard-won situation in the China-India border areas and abide by relevant agreements and consensus between the two countries and the two militaries.

The PLA's comment on India making "unrealistic demands" stands in stark contrast to New Delhi's view on the LAC crisis, which began in April 2020 when the PLA massed thousands of troops along the LAC, carried out multiple transgressions in eastern Ladakh, and disregarded the many previously agreed upon border agreements aimed at keeping the peace.

While negotiations have led to disengagement in some of the areas, thousands of PLA troops remain in forward areas.

Ashish sent to police custody for 3 days

Eight persons - four farmers, three BJP workers including a driver of a vehicle belonging to the Mishras and a local scribe – were killed in the incident, following which two first information

reports (FIRs) were lodged.

However, Chief Judicial Magistrate Chinta Ram granted the prosecution only a three-day police custody, said prosecution lawyer S.P

Mr. Yadav said the police remand was granted on conditions that Mr. Ashish would not be harassed, his medical examination would be conducted, and his lawyer would be allowed to be present during his questioning.

'Fair probe impossible'

On Saturday morning, Mr. Ashish went to the Crime Branch office in Lakhimpur after the police issued him a second summons as he failed to turn up after the first one on Friday.

The BJP on Monday got into a huddle over the Uttar Pradesh Assembly elections under the shadow of the events of Lakhimpur Kheri that left eight people dead and a cloud of controversy over local BJP strongman and Minister of State for Home Ajay Kumar Mishra.

U.K. asks India to update climate goals

Johnson calls Modi; they speak about vaccine certifications and Afghanistan situation

British Prime Minister Boris Johnson spoke to Prime Minister Narendra Modi on Monday, urging India to announce a "more ambitious" Nationally Determined Contribution (NDC) ahead of a United Nations climate change summit in the U.K. in a few weeks. The two leaders also spoke about the issue of vaccine certifications and the Afghanistan situation.

"Prime Minister conveyed India's commitment to Climate Action, as seen in its ambitious target for expansion of renewable energy and the recently announced National Hydrogen Mission," a Ministry of External Affairs (MEA) statement said.

As president of the coming climate change conference, the U.K. is asking all countries to update their NDCs to reflect climate targets for the next few decades. "Prime Minister [Johnson] underlined the importance of making concrete progress on climate change ahead of and at the upcoming COP26 Summit.

He noted that India already lead(s) the world in renewable technology and expressed his hope that they will commit to a more ambitious Nationally Determined Contribution and to achieving Net Zero emissions," said an official release from the U.K. government on the con-

One hundred and ninety three countries filed their first NDCs, but only 19 have so far updated them. India filed its first NDC in 2016, committing at the time to cut emissions by 33% by 2030 (from 2005 levels) and to ensure that about 40% of its installed power capacity comes from renewable energy, targets that the government says it is on track to reach. However, the U.K. and the U.S. have been asking India to do more in terms of declaring its second NDC, which includes India's promise of installing 450 GW of renewable energy by 2030, and to declare firm deadlines for achieving Net Zero carbon emissions and ending the use of coal for generating electricity, so as to keep global warming below 1.5 debeen invited to the UN Climate Change Conference of the Parties (COP26) in Glasgow from October 31 to November 12, but has not confirmed his attendance yet. He had been due to attend the G7 summit as a special invitee in the U.K. in June last, but had to cancel the visit due to the second wave of the pandemic. Mr. Johnson is also expected to reschedule his proposed visits to India in January and April this year, which had to be put off

Foreign Secretary visit

due to the pandemic as well.

However, high-level visits by two Ministers, including the new British Foreign Secretary Liz Truss are expected shortly, and could coincide with India-U.K. naval exercises involving the U.K. Carrier Strike Group led by HMS Queen Elizabeth. Ms. Truss spoke to External Affairs Minister S. Jaishankar over the telephone last week about the vaccine issue as well as the U.K. India "Roadmap" for ties till 2030 and an enhanced trade partnership.

According to the U.K.

statement, Mr. Modi and Mr. Johnson discussed the importance of "cautiously opening up international travel", and the issue of vaccine

Covishield recognition

Last week, the U.K. agreed to recognise Indian-administered Covishield and waived the need for nationals from India and 36 other countries to undertake home quarantines as long as they are vaccinated. However, the U.K. does not yet recognise Covaxin, which is awaiting clearances from the World Health Organization. "They agreed the U.K.'s recognition of Indian vaccine certification is a welcome development to that end," the British statement said.

The leaders also talked about Afghanistan, both sides said. "In this context, they agreed on the need to develop a common international perspective on issues regarding extremism and terrorism, as well as Human Rights and rights of women and minorities," the MEA

Modi to attend G20 virtual meeting on Afghanistan

It is likely to deliberate on political and humanitarian issues

Prime Minister Narendra Modi will attend an extraordinary virtual meeting of G20 leaders on Afghanistan to be held on October 12.

Mr. Modi had urged the international community to carefully act on the recognition of the Taliban as the legitimate rulers of Afghanistan and the G20 meeting is likely to deliberate on both political and humanitarian issues regarding the country.

Ahead of the meeting, External Affairs Minister S. Jaishankar and Minister of State Meenakshi Lekhi reminded the world about the multilateral norms that have been set in place regarding the Afghan crisis.

The G20 meeting comes soon after the United States held a round of discussion on assisting the Taliban deal with the unfolding humanitarian crisis in Afghanistan as winter is deepening amid shortage of essential commodities and a collapse of the banking system.

India explained the current position on Afghanistan on Monday, with Mr. Jaishankar meeting his Kyrgyz counterpart, Ruslan Kazakbaev, in Bishkek. At the end of his visit in Bishkek, Mr. Jaishankar said, "We are closely following the developments in Afghanistan. It concerns all of us. There are expectations of the international community from the current regime in Afghanistan which are adequately elaborated in the UNSC Resolution 2593."

Ms. Lekhi also highlighted UNSC Resolution 2593 while speaking at a meeting held on Monday in Belgrade to commemorate the 60th anniversary of the Non-Aligned Movement (NAM). "Following recent developments in Afghanistan, it is absolutely imperative that the approach of the international community is guided by the U.N. Security Council Resolution 2593," she stated, em-

phasising that the territory of Afghanistan should not be used to export terror against other countries. The G20 extraordinary meeting comes as Afghan hospitals run out of basic medicines and that country witnesses increased suffering in the rural sector because of the disruption of the agriculture supply chain.

Italy holds talks

Italy, the current chair of G20, has discussed the situation in Kabul and other cities of Afghanistan with world powers like Russia and China. Prime Minister Mario Draghi observed in September last week that the immediate aim of the world community was to ensure that human lives were saved in that country.

Italy believes that the Taliban's denial of women's rights makes it difficult for the world to recognise it as a legitimate political entity but maintains that people should receive financial sup-

Later, he said his father had been taken "hostage" in Delhi and was not being allowed to come to Patna. But Mr. Tejashwi responded, "Can a person like Lalu Prasad be taken hostage by anyone?" He added, "He [Mr. Prasad] would come to Patna soon."

Party leaders said Mr. Prasad may visit Patna in third week of October to seek support for party candidates for the byelections to the Kusheshwarsthan (Darbhanga) and Tarapur (Munger) seats.

Adani Group tightens cargo movement

Ports run by it won't handle containerised cargo from Iran, Pakistan, Afghanistan

The Guiarat-based Adani Group, which operates ports across the country, announced on Monday that it will not handle Exim containerised cargo originating from Iran, Pakistan and Afghanistan from November

A complaint filed under the Right to Information Act (RTI) in Odisha this summer would not be disposed of by the State's Information Commission until 2028 at the current rate of operations. Twelve State Information Commissions plus the Central Information Commission (CIC) would need at least a year to dispose of their appeals, and the nabacklog crossed 2.55 lakh cases, according to an analysis by the Satark Nagrik Sangathan

NGT need not 'wait for Godot' to save environment, says SC

It is a unique forum endowed with *suo motu* powers, it says

The Supreme Court has declared the National Green Tribunal's (NGT) position as a "unique" forum endowed with suo motu powers to take up environmental issues across the country.

The court said the NGT

need not wait for the "metaphorical Godot" to knock on its portal to flex its considerable muscles to save the environment. "The exercise of power by the NGT is not circumscribed by the receipt of applications. When substantial questions relating to the environment arise and the issue is civil in nature and those relate to the Act, the NGT, in our opinion, even in the absence of an applica-



tion, can self-ignite action either towards amelioration or towards prevention of harm," a three-judge Bench of Justices A.M. Khanwilkar, Hrishikesh Roy and C.T. Ra-

vikumar held in a judgment. Justice Roy, who authored the 77-page judgment for the Bench, dismissed objections from the Centre, legal experts and even the court's own amicus curiae who all argued against the NGT clothed with suo motu pow-

court, speaking through Justice Roy, explained that the role of the NGT was not simply adjudicatory in nature. The tribunal has to perform equally vital roles that were preventative, ameliorative or remedial in nature.

The judgment described the NGT "as a complimentary, competent, specialised forum to deal with all environmental multidisciplinary issues both as original and also as an appellate authority, which complex issues were hitherto dealt with by the High Courts and the Supreme Court".

Another series of raids on Deshmukh's houses

CBI searches houses in Nagpur, Mumbai

In yet another series of raids against Nationalist Congress Party (NCP) leader and former Maharashtra Home Minister Anil Deshmukh. the Central Bureau of Investigation (CBI) searched his houses in Nagpur and Mumbai in connection with the leak of the preliminary inquiry report against him.

The report had allegedly given a clean chit to the former Minister, which was later overruled by the top officials of the agency. The CBI has already arrested Mr. Deshmukh's lawyer, Anand Daga, and CBI inspector Abhishek Tiwari for leaking the report and influencing the case. Earlier in the day, it was rumoured that Mr. Deshmukh's son Salil and daughter-in-law would be arrested as the CBI team had come with an arrest warrant. CBI sources, however, did not confirm it.

Both the CBI and the Enforcement Directorate (ED) have raided Mr. Deshmukh's residential and commercial establishments times in the past few

The NCP came down on the agency over the repeated raids. "This is nothing but the pure harassment of an individual," said NCP's State president Jayant Patil.


No data on private vaccine procurement: govt.

'Information is not available as private hospitals procure vaccines directly from manufacturers'

The Union Health Ministry said it did not know how many COVID-19 vaccines were procured by private players, nor did it have separate data on how many vaccine doses were administered by private hospitals and service providers, according to its response to a Right to Information (RTI) request filed by Commodore Lokesh Batra (retd).

Despite the fact that the government had reserved 25% of vaccine allocation for the private sector, Health Secretary Rajesh Bhushan recently said only 6% of the doses administered since May were in private hospi-

tals. To date, India has administered 65.8 crore doses.

Commerce and Industry Minister Piyush Goyal had earlier targeted industry groups for not doing enough on the vaccine drive. The

Centre had capped inoculation charges by private players at ₹250. Commodore Batra's query, dated August 11, asked how many doses were directly purchased by private players and how many they administered.

Information denied

On August 31, the Health Ministry responded, denying the information requested. "Private hospitals/institutions etc procure vaccines directly from the vaccine manufacturers. Data asked pertains between manufacturers and private hospitals/ institutions, etc.," it said. After an appeal, the Ministry reiterated its stance on September 23, insisting that "this information was not maintained and was not available" as private procurement was done directly.

In his appeal, Commodore Batra had cited a June affidavit filed in the Supreme

Court where the Centre had said it would "facilitate supply of vaccines to private hospitals [under the 25% quota] and their payment through the National Health Authority's electronic platform" to ensure "equitable balance".

With regard to doses administered, the Ministry initially said, "Separate vaccination data is not available," pointing to the COWIN dashboard for overall data. On September 23, it said, "Data of COVID-19 vaccination doses administered by [private players] may be obtained from the States/UTs where such private COVID vaccina-

Anti-Corruption Bureau finds sale deeds during searches

Antı-Corruption Bureau officials in Odisha have come across a contract employee who purchased 60 plots in the first five years of his service period.

The accused, Bikash Kumar Behera, was working as the Gram Panchayat Technical Assistant (GPTA) in the rank of a junior engineer.

"The GPTA has not earned more than ₹10 lakh in his total service period, but we have detected movable and immovable properties worth over ₹1.02 crore from his possession," said Birendra Nayak, Deputy Superintendent of Police (Vigilance), Rourkela.

Panel issues notices to the J&K Govt., police over attacks

The National Human Rights Commission (NHRC) has issued notices to the Jammu and Kashmir Government and the police over the recent spate of targeted killings of civilians from minority communities.

The NHRC issued notices to the Chief Secretary and the Director-General of Police (DGP) of the Union Territory on October 9 after taking suo motu cognisance of media reports the previous day. The officials were asked to respond within four weeks, according to the proceedings. The painful incidents of killing of civilians al-

legedly by terrorists were a the Kashmiri Pandit comcratic fabric of the country and people's right to life, liberty, equality and dignity, it observed. "Targeted killings of those who are not Kashmiri Muslims is an attempt to keep non-Muslims out of the Valley. It is a gross violation of human rights of minority communities in the Valley," it added.

The commission referred to news reports about the killing of two government school teachers, Supinder Kaur, a Sikh, and Deepak Chand, a Hindu, in Srinagar on October 7. This was after well-known pharmacist Makhan Lal Bindroo, from

serious threat to the demo- munity, was gunned down on October 5 in Srinagar. On the same day, Virender Paswan, a street food vendor from Bihar, was killed.

"The commission takes suo motu cognisance of the incident and directs issuance of notices to the Chief Secretary, Jammu & Kashmir, and the DGP, Jammu & Kashmir, calling for a detailed report in the matter, including present status of the investigation being conducted and steps be taken or proposed to be taken by the authorities to safeguard innocent citizens' lives from being killed in a targeted manner," it said.

Storehouse of knowledge

Sastras are the storehouse of right knowledge and hence are rightly the basis for enquiry into Brahman. But the sastras themselves state that Brahman is not to be known by human word or thought. 'Yatha vacho nivartanthe aprapya manasa saha' is the famous statement in this regard. Still, the third sutra in the Brahmasutra 'Sastra Yonitvat' affirms that Sastra is the source of knowledge of Brahman through which we understand the nature of Brahman, pointed out Sri Mani Dravid Sastrigal in a discourse. This sutra is interpreted in

two ways by interpreters such as Adi Sankara. The first interpretation is that Brahman is the cause of the revelation of the Vedas. The Vedas are not a written text. It is held that they are apaurusheya, independent of human origin and that they are revealed as the very breath of the Supreme Brahman. The Supreme Brahman is omniscient and His knowledge extends to all things. The second interpretation means that only the Vedas can prove to us that Brahman is the cause of the production, etc of the world. In other words, apart from the Vedas there is no other proof that Brahman is the cause of creation, sustenance and dissolu-

The term Veda is synonymous with wisdom and the Vedic sages exemplify the genuine spirit of enquiry. So the scriptures urge the people to take up Brahma vichara as this is the ultimate aim for any jiva. The Brihadaranyaka Upanishad has this passage, "Verily it is the Self that should be seen, reflected on and meditated upon." Vyasa captures the essence of this spirit of enquiry in the first Sutra in the Brahmasutra, 'Athato Brahma Jignyasa." Jignyasa is the desire to know to enquire into, to examine, test, and when this effort is directed towards Brahman it is Brahma jignyasa.

Iran is ready to sign a strategic partnership with Russia, mirroring one concluded early this year with China, the Foreign Ministry said on Monday.

"The initial arrangements of this document, entitled the Global Agreement for Cooperation between Iran and Russia, have been concluded," said Ministry spokesman Saeed Khatibzadeh.

"We are in the process of finalising diverse clauses of the document, and we will send it to Moscow," he told reporters.

"In recent years, it has become necessary to improve relations between Iran and

HK's largest pro-democracy party shuns 'patriot only' poll

Most of city's Opposition figures jailed or disqualified

Hong Kong's largest pro-democracy party will not contest the upcoming "patriot only" legislature elections after none of its members met the party's own application deadline on Monday.

The decision means the December polls have been effectively boycotted by the city's pro-democracy Opposition with even the movement's most moderate wing deciding it is not worth taking part.

The Democratic Party's membership had been split on whether to continue with Hong Kong's political process as authorities crack down on dissent in response to huge and often violent protests two years ago.

On Monday, the party said none had applied from its membership by the deadline.

One member, veteran Tiananmen Square activist Han Dongfang, previously said he wished to run but did not manage to secure enough nominations within the

Hong Kong's government has been pushing the narrative that the once outspoken city remains politically pluralistic even as scores of Opposition figures are jailed and disqualified from standing for office.

Most of Hong Kong's major pro-democracy parties have either disbanded or seen their leadership decimated by arrests and prosecutions.

Under an overhaul imposed by Beijing earlier this year, only those deemed "staunch patriots" are allowed to take part in politics and anyone standing for public office must be vetted for national security risks.

The overhaul has also further reduced the number of directly elected seats in the city's legislature from half to less than a quarter.

The rest will be appointed by reliably pro-Beijing committees and special interest groups that have been vetted for their political loyalty.

Beijing is sensitive to any move that might cast doubt on its new "patriots only" political model.

Iraq says it has arrested Islamic State's financial chief

Sami Jasim served as a deputy leader of IS under Al-Baghdadi

Iraq said on Monday it has detained a top leader of the Islamic State group and a longtime al-Qaeda operative in a cross-border operation.

Iraqi Prime Minister Mustafa al-Kadhimi tweeted the news, identifying the man as Sami Jasim, who oversees the Islamic State's financial operations and served as the deputy leader of IS under the late Abu Bakr al-Baghda-

Mr. Al-Kadhimi described it as "one of the most difficult" cross border intelligence operations ever conducted by Iraqi forces.

Jasim has a \$5 million

bounty on his head from the U.S. State Department's Rewards for Justice programme, which describes him as having been "instrumental in managing finances

for IS terrorist operations." "While serving as IS deputy in southern Mosul in 2014, Jasim reportedly served as the equivalent of IS's finance minister, supervising the group's revenue-generating operations from illicit sales of oil, gas, antiquities, and minerals," the website says.

Iraqi intelligence officials said that Jasim was detained in an identified foreign country and transported to Iraq few days ago. They spoke on condition of anonymity because they were not authorized to speak of the operation on the record.

Jassem worked with al-Qaeda in Iraq leader Abu Musab al-Zarqawi, a Jordanian militant who was killed in a U.S. airstrike in Iraq in 2006. He assumed various security positions in Iraq, and moved to Syria in 2015, after the Islamic State group, an al-Qaeda offshoot, declared its caliphate in 2014 and became the deputy of al-Baghdadi, the extremist group's leader.

Al-Baghdadi was killed in a U.S.-led raid in northwestern Syria in 2019, under former U.S. President Donald Trump.

+ Car bomb blast in Syrian town kills 4

Tunisia gets a new government, with record number of women

This comes 11 weeks after Saied suspended Parliament

Tunisia got a new government on Monday after more than two months without one, with the Prime Minister naming her Cabinet, including a record number of women.

The ministerial appointments announced by Prime Minister Najla Bouden filled a vacuum that had persisted since President Kais Saied abruptly dismissed his former Cabinet and suspended Parliament 11 weeks ago, concentrating all executive powers. His critics and constitutional lawyers have likened his actions to a coup.

Ms. Bouden, named September 29 by Mr. Saied as Tunisia's first female Prime Minister, said during the swearing-in ceremony of her

U.S. based economist showed that higher minimum wages do not hurt hiring

The Nobel prize for economics was awarded on Monday to U.S.-based economist David Card for pioneering research that showed an increase in minimum wage does not lead to less hiring and that immigrants do not lower pay for native-born workers, challenging commonly held ideas.

The prize was shared with two others for creating a way to study these types of societal issues.

Canadian-born Dr. Card of the University of California, Berkeley, was awarded one half of the prize for his research on how minimum wage, immigration and education affect the labour market, while the other half was



shared by Joshua Angrist from the Massachusetts Institute of Technology and Dutch-born Guido Imbens from Stanford University for their framework for studying issues that can't rely on traditional scientific methods.

empirical work in the eco-

Together, the three helped rapidly expand the


use of "natural experiments", or studies based on the observation of real-world data. Such research made economics more applicable to everyday life, provided policymakers with actual evidence on the outcomes of policies, and in time spawned a more popular approach to economics, epito-

mised by the bestseller Freakonomics by Stephen Dubner and Steven Levitt. In a study published in

1993, Dr. Card looked at what happened to jobs at fast-food restaurants Burger King, KFC, Wendy's and Roy Rogers when New Jersey raised its minimum wage from \$4.25 to \$5.05, using restaurants in bordering eastern Pennsylvania as the control – or comparison – group.

Contrary to previous studies, he and his research partner Alan Krueger, who died in 2019, found that an increase in the minimum wage had no effect on the number of employees.

Dr. Card's minimum wage research fundamentally altered economists' views of such policies.

'DoT, TRAI working on optimal use of spectrum' '5G, satellite services spurring demand'

The Telecom Ministry is engaged in discussions with regulator TRAI to work out ways for optimum utilisation of "finite resource" spectrum, especially for airwave bands sought for both 5G services as well as satellite communication, a senior official said on Monday.

"The demand for satellite-based and terrestrial telecom services have put unprecedented demands on radio spectrum, in particular the C band and the Ka band frequencies are needed for both space-based as well as terrestrial telecommunications services," Telecom Secretary K. Rajaraman

Speaking at an event organised by newly-formed industry body Indian Space Association, the Secretary added that since spectrum is a finite resource, its value can be augmented through sharing and with coexistence by different services. "Thus, it is necessary to ensure efficient use of spectrum... including revisiting the uses in the existing frequency bands as well as in the new frequency bands. We are engaged in this exercise in consultation with

'Investments needed'

Speaking at the same session, TRAI Chairman P.D. Vaghela added that there was an 'urgent need' for policies that attracted investments, allowed use of space technology for the common man and ensured flexibility and ease of doing business.

Mr. Vaghela added that the regulator was in the process of releasing a consultation paper for licensing framework for satellite earth station gateways - an area



transformation" to facilitate establishment of earth stations by any satellite operators. Further, TRAI is working on bringing out a consultation paper for developing a comprehensive single window online portal, having interdepartmental linkages for transfer of application and information for parallel processing.

The Telecom Secretary added that the recommendations from TRAI on the licensing framework for satellite space connectivity for low bit-rate applications are currently under consideration by the DoT. "We hope to take a decision very soon. This is likely to open up a large potential for IoT and machine to machine-based applications," he said.

Speaking at an earlier session Telecom and IT Minister Ashwini Vaishnaw said that the government is fully committed to reforms and ensuring healthy competition in the sector and asked the industry to study the global best practices and come up with suggestions to contribute in formulation of enabling policy.


