India will achieve net zero emissions by 2070, says PM

Renewable energy will be tapped in a big way, Modi tells COP26 summit

India will achieve net zero emissions latest by 2070, Prime Minister Narendra Modi said at the COP26 summit in Glasgow on Monday. Until Monday, India was the only major emitter that had not committed to a timeline to achieve net zero, or a year by which it would ensure its net carbon dioxide emissions would be zero.

By 2030, India will ensure 50% of its energy will be sourced from renewable sources. India also committed to reduce its carbon emissions until 2030 by a billion tonnes. India will also reduce its emissions intensity per unit of GDP by less than 45%. India would also

UN: countries must act to save humanity

Cannot impose blanket ban on all firecrackers, says SC

Court reiterates restrictions on use of toxic chemicals

LEGAL CORRESPONDENT

The Supreme Court on Monday said a blanket ban on firecrackers may not be possible, but measures ought to be in place to prevent the use of toxic chemicals in firecrackers.

This is the second time in the past few days that the court had accepted the improbability of imposing a total ban on firecrackers. On October 29, the court had made it clear that there was no total ban on use of firecrackers.

"Only those firecrackers are banned which are found to be injurious to health and

affecting the health of citizens," the court had noted in an order.

On Monday, a Special Bench of Justices A.M. Khanwilkar and Ajay Rastogi orally said there could not be a complete ban of The firecracker industry had moved the top court after the Calcutta High Court "prohibited the sale, purchase, use, display or bursting of firecrackers of any type at all during the upcoming Kali Puja, Diwali celebration as well as the following Chatt Puja, Jagadhatri Puja, Guru Nanak's Birthday and/ or Christmas/New Year's Eve this year in the State of West Bengal".

"Strengthen the mechanism to stop misuse," the apex court reiterated its advice, with a reference to its October 29 order.

Modi discusses Afghanistan with Boris Johnson

Glasgow talks also cover climate change and post-COVID scenario

Prime Minister Narendra Modi and his British counterpart Boris Johnson on Monday discussed the evolving situation in Afghanistan on the sidelines of the COP26 summit in Glasgow. The Ministry of External Affairs (MEA), in a statement, said the leaders discussed bilateral partnership in the context of climate change, Indo-Pacific strategy and post-COVID global economic recovery.

"The two Prime Ministers reviewed the implementa-

tion of the Roadmap 2030 priorities, particularly in trade and economy, people to people [ties], health, defence and security areas," said the MEA.

The MEA said both the leaders reviewed progress in the trade talks for Enhanced Trade Partnership, and also discussed bilateral cooperation in green hydrogen, renewable energy and clean

technologies, including collaboration through the International Solar Alliance and the Coalition for Disaster Resilient Infrastructure. The meeting comes days

Capital's air quality to remain 'poor' today

Delhi's air quality stayed on the higher end of the "poor" category on Monday, official data showed. The effect of stubble burning has come down and the air quality is expected to remain "poor" on Tuesday.

City adds 18 COVID-19 cases, no deaths

The Capital reported no new COVID-19 deaths in 24 hours for the 10th consecutive day and the total number of deaths stood at 25,091. Eighteen new cases were reported, taking the total cases to 14,39,888, as per the Delhi Government bulletin on Monday.

City sees five more dengue deaths

As many as 531 cases reported last week; season's total reaches 1,537, the highest since 2018

The city reported 531 dengue cases over the past week (till October 30), and five deaths, a civic report said on Monday. While the fatality toll for the season has reached six, the caseload for October stands at 1,196 – the highest for the month since 2017. This season's total cases have touched 1,537, which is the highest since 2018.

"Three of the five deaths occurred in areas under the North civic body. All the three patients were admitted to private hospitals and they succumbed in mid-October," a North Delhi Municipal Corporation official, who did not wish to be named, said.

However, details about the remaining two deaths were not provided by civic body officials.

Highest cases in North Delhi North Delhi recorded the highest dengue cases last week at 134, followed by South Delhi with 127 cases. In the previous week, South Delhi had reported 98 cases, followed by North Delhi with 71 cases.

Till October 23, the city had recorded 665 cases of dengue for the month and the season's total stood at 1,006, the highest since 2018. In September, the city had reported 217 cases, which was also the highest for the month since 2018.

Delhi had recorded 1,072 cases and one death in 2020,

2,036 cases and two deaths in 2019, and 2,798 cases and four deaths in 2018.

South Delhi Municipal Corporation (SDMC) Mayor Mukesh Suryan said "no cases or deaths were recorded at SDMC hospitals" and that the civic body was taking adequate measures.

"About 60-70 dengue patients are admitted to our hospital and the number of people coming to the OPD every day is on the rise. I feel the situation will improve by the end of November when the temperature further drops. Till then, people have to be extremely careful," said Dr. S.P. Byotra, HoD of Internal Medicine, Sir Ganga Ram Hospital.

Poor people not being diagnosed properly: Centre

Union Health Minister Mansukh Mandaviya on Monday chaired a high-level meeting with Delhi officials to review the measures against dengue. "Many poor people are not diagnosed properly and their death goes unreported," he said, stressing on the need to ramp up dengue testing in the city. He added that primary healthcare centres may prescribe drugs to suppress the symptoms without addressing the root cause.

Cabinet clears 11% DA increase for government staff

With an eye on the upcoming Assembly elections in the State, due early next year, the Punjab Cabinet on Monday decided to reduce power tariff for domestic consumers by ₹3 per unit.

An official statement said the annual financial burden on the State government would be approximately ₹3,316 crore due to the tariff rationalisa-

The government will reduce the power procurement cost and it will be passed on to the consumers, it said.

Draft roll, Special Summary Revision, sees a dip in voters

Delhi's draft electoral roll for 2022, published by the Chief Electoral Officer on Monday, showed a decline in voters compared to last

The previous electoral roll, published on January 1, 2021, had 1,48,98,069 voters, whereas the latest with January 1, 2022, as the qualifying date has 1,47,95,549.

The latest roll - Special Summary Revision (SSR) shows while 3,19,222 voters were deleted from the draft, 2,16,702 were added to it. Among the deleted voters, 59,423 were declared dead and 2,51,062 had shifted within and out of the city.

Chief Electoral Officer (CEO) Ranbir Singh said all claims and objections regarding the electoral roll can be made from November 1 to November 30.

'Voter utsav'

Calling this month-long process "voter utsav", Mr. Singh said that the SSR was aimed at including "newly eligible and left out voters who have completed or will be completing the age of 18" on or before January 1, 2022. The final roll will be published on January 5,

Mr. Singh said the draft electoral roll has been published at all polling stations of Delhi and on the "website of CEO Delhi" on Monday.

Gender-wise count

According to the draft roll, total 80,88,031 voters are male, whereas 67,06,570 are female; on January 15, 2021, their count stood at 81,58,180 and 67,38,976 respectively. An increase in third gender voters was observed with 948 in the latest draft - compared to 913 in the previous roll. The SSR for the draft roll for November 1, 2021, was carried out across Delhi's 70 Assembly constituencies. The largest Assembly constituency is Matiala with 4,28,340 voters and the smallest Delhi

Cantonment with 1,10,255.

Chennai civic body pulls up school for attendance registers with caste names

Headmistress denies segregating students on caste basis

DENNIS S. JESUDASAN CHENNAI

A primary school had been maintaining attendance registers organising the student rolls on the basis of caste before it was pulled up by Greater Chennai Corporation on Monday.

The GCC has directed the school to discontinue the practice at once. Since the school had also divided its students into three batches on the basis of their attendance roster owing to COVID-19, it turned out that students were bunched together on the basis of their community alone.

'Alphabetical order'

The GCC directed the school to drop the existing practise and asked it to prepare fresh batches based on the alphabetical order of the name of students.

When this correspondent visited the school on Monday evening, the headmistress said: "This is not new and we have been following this attendance registers even before. We are not segregating students on caste basis. It so happened that most students of a caste are in one batch. It is unintentional."

She also produced attendance registers that showed caste mentioned against every student and said students are enrolled in the attendance register in the following order - SC (A), SC (O), MBC, BC-Hindu, BC-Christian, BC-Muslim and OC.

"This is only for administrative purpose. Students won't know which caste they are," she maintained.

When contacted, D. Sneha, Deputy Commissioner (Education), GCC said: "Across all schools, the attendance is meant to be in alphabet order only. This has never been the practice, and we'll ensure it's set right. Thank you for letting us know."

Asked about the batches, she said: "The batches will naturally change, the parents of the children will be informed today [Monday] evening."

Activist V. Gopalakrishnan demanded that action be taken against the teachers concerned. "If this can happen in Chennai city, we can only imagine the scenario in remote areas. They are teachers and they are supposed to teach against casteism and not remind them of their caste. Action must be taken against the teachers concerned. Be it intentional or otherwise, discrimination is discrimination and it cannot be tolerated."

Maharashtra reports lowest single-day cases in 17 months

Despite the State rapidly easing restrictions and the festive season round the corner, Maharashtra's rapidly declining trend in cases continued with the State reporting its lowest single-day surge in 17 months with just 809 new COVID-19 cases on Monday as against 1,901 new recov-



Malik, Fadnavis war of words heats up

NCP Minister tweets pic of 'drug peddler' with ex-CM's wife; BJP leader alleges former has 'links' with underworld

Kick-starting yet another controversy and taking former Maharashtra Chief Minister Devendra Fadnavis headon, Nationalist Congress Party (NCP) leader and State Minister Nawab Malik on Monday tweeted a photograph of alleged drug peddler Jaideep Rana with Mr. Fadnavis' wife, Amruta, saying "Come, let's talk about the relations between BJP and drug peddlers today". In return, Mr. Fadnavis alleged that Mr. Malik had connections with the underworld.

On Twitter

Mr. Malik said, "I have released a photograph of a person named Jaideep Rana who is presently in Sabarmati jail. He has been arrested in a case of drug trafficking. He was the financial head of the song 'River Anthem' released by Amruta Fadnavis in which Devendra Fadnavis too was featured. The drug business grew under his tenure."

He also tweeted a screenshot of the description of the 'River Anthem', where Mr. Rana has been mentioned as the Finance Head.

According to sources, the mention has been removed since the allegations.

Replying to Mr. Malik, Mr. Fadnavis said, "I will be exposing his underworld connections post-Deepavali and will give all the evidence to NCP president Sharad Pa-

Those who live in glass house should not throw stones at others, he added.

tweeted in Hindi. "Hai taiyar hum [We are ready]". Earlier, Mr. Malik mentioned Neeraj Gunde, one of close aides of Mr. Fadnavis during the latter's tenure as chief minister, demanding a CBI probe. "Neeraj Gunde used to frequent the CMO, from where he used to handle police transfers. Even Sameer

Wankhede was brought in by Fadnavis who is controlling drug operations. The Centre must conduct a judicial probe and even a CBI investigation," he said. The NCP leader alleged

that the BJP had been posting officers in Central services to target Bollywood and Maharashtra.

Baseless charges: Patil Meanwhile, the BJP's Maha-

rashtra unit president Chandrakant Patil said Mr. Malik should not make "baseless against the former chief minister.

"Apparently the ruling MVA Government has nothing to say on serious issues facing Maharashtra such as distressed farmers, rising atrocities against women and the agitations of desperate State transport department drivers. Twenty-nine drivers have committed suicide thus far, but the State Government has no answer. So, this Government asks somebody [Mr. Malik] to raise some issues to divert the public's attention," Mr. Patil said.

Exhorting the NCP leader to stop his "baseless allegations", Mr. Patil said Mr. Fadnavis had always shown "remarkable restraint" while directing any criticism towards a ruling party leader and had certainly never commented on anyone's wife or family. Mr. Patil also claimed that Neeraj Gunde, whom Mr. Malik accused of having shadowy connections, was in fact a "clean and good social worker".

Bihar Congress launches mega membership drive

State unit chief had earlier hinted at parting ways with RJD

The Bihar Pradesh Congress Committee (BPCC) on Monday launched a mega membership drive in the State apparently to regain its lost

ground among voters. Earlier, the State in-charge of the party Bhakt Charan Das had announced that Congress party would contest the upcoming 2024 Parliamentary elections in Bihar on its own.

"The mega membership drive is likely to continue till 31 March 2022. We're now moving towards our commitment to contest the upcoming Lok Sabha poll in 2024 on our own", Congress Legislature Party leader (CLP) Ajit Sharma said. During our mega membership drive, added Mr. Sharma, "the party will make connection with our old party cadres and voters and will also raise issues of price hike, unemployment and corruption in the State".

Earlier in 2020, BPCC had launched a digital membership drive which, party leaders said, "was not very successful as there were some technical issues not addressed properly".

The State party president Madan Mohan Jha flagged off the mega membership drive at Sadquat Ashram, State party headquarters. Other senior State party leaders like Prem Chandra Mishra, Chandan Bagchi, Kaukab Quadri, Brajesh Kumar Munnan, Rajesh Rathore too were present on the occasion.

"The party has set the target of making 80 lakh people to be members of the party during the drive. The membership form has 10 guidelines for the new members to follow", said State party leader and spokesperson Asit Nath Tiwari.

Recently, ahead of the bypoll on two seats in Bihar, Tarapur and Kusheshwarsthan State party in-charge Mr. Das

had declared to snap ties with the alliance partner Rashtriya Janata Dal in Bihar. The Congress party, later, also fielded candidates on two seats against RID and ID(U) nominees.

Claim refuted

However, RJD president Lalu Prasad kept reiterating that alliance with Congress party was still intact as he had spoken to Congress president Sonia Gandhi. But, State Congress leaders strongly refuted Mr. Prasad's claim and said there was "no talk between Ms. Gandhi and Mr. Prasad".

Earlier in 2000, 2005, 2009 and 2010 too both the parties had parted ways and contested poll separately. "Our electoral dependence on RID has made us weakened, but this time we'll do our best to rejuvenate our party workers and voters to gear up for the 2024 Parliamentary poll", said a senior

UDF walks out on Mullaperiyar issue

The Congress-led United Democratic Front (UDF) Opposition walked out of the Kerala Assembly on Monday, accusing the Government of jeopardising the State's interest in the Mullaperiyar dispute with Tamil Nadu.

Seeking leave of the House to move an adjournment motion to debate the issue, Congress leader Ramesh Chennithala said the 126-year-old dam had outlived its lifespan by at least 76 years. Experts doubted the structural integrity of the dam built to irrigate Tamil Nadu. An estimated 30

lakh people in five districts downstream of the Mullaperiyar dam lived in fear. However, the Government was dismissive of the danger. It had meekly agreed to Tamil Nadu's insistence to maintain the Mullaperiyar water level at a dangerously high 139.5 feet during the recent

flood, Mr. Chennithala said. Leader of the Opposition V.D. Satheesan said Chief Minister Pinarayi Vijayan's "thoughtless" statement that apprehensions about Mullaperiyar's safety were misplaced had bolstered Tamil Nadu's argument in the Supreme Court that Kerala was exaggerating matters.

Derecognise YSR Congress, Telugu Desam MPs urge EC

A delegation of Telugu Desam Party MPs has submitted a memorandum to the Election Commission urging it to de-recognise the Congress Party (YSRCP) alleging that the party had violated the Representation of the People Act by encouraging "statesponsored terror."

Meanwhile, the YSRCP will be meeting President Ram Nath Kovind on Tuesday to complain to him about the "false propaganda" by the Opposition TDP which, the ruling party claims, is hurting the image of Andhra Pradesh.

The latest allegation comes against the backdrop of a war of words between the two opponents. Last week, YSRCP leader Vijaysai Reddy had called the TDP a 'terrorist organisation'.

16-page memorandum TDP MP Kesineni Srinivas

(Nani), Rajya Sabha member Kanakamedala Ravindrakumar and former MP Nimmala Kistappa met the Election Commission and submitted a 16-page memorandum.

The TDP alleged that the YSRCP Government has been carrying out an allround assault on constitutional institutions in Andhra Pradesh, including the media and Opposition.

"The YSR Congress, founded on the ill-gotten gains by these leaders, has been a front for money laundering and illicit activities even now," the TDP memorandum said. And this money, the TDP claimed, was used to establish the media house Sakshi and to capture political power in the State.

Vanniyar quota law unconstitutional: HC

'The Act went against the Constitution'

The Madurai Bench of the Madras High Court on Monday declared as unconstitutional the law providing 10.5% internal reservation to the Vanniakula Kshatriya community within the 20% reservation for the Most Backward Classes (MBCs) in education and public employment.

The court held that it was ultra vires the Constitution.

A Division Bench of Justices M. Duraiswamy and K. Murali Shankar gave its judgment on a batch of petitions that challenged the validity of the Act, which was passed hours before the model code of conduct came into force in February for the Assembly election.

No supporting material It said the State had not collected any material to prove

that the Vanniyar caste that is, the Vanniakula Kshatriya, comprising Vanniyar, Vanniya, Vannia Gounder, Gounder or Kander, Padayachi, Palli and Agnikula Kshatriya - was unable to comwith the other pete extremely marginalised communities. When the entire Most Backward Classes were enjoying 20% reservation, this caste alone was given 10.5%. This would affect the prospects of the others, it said.

The government had not considered the caste-wise population, and there was no data available with the government to invoke the provision in the Constitution to provide internal reservation. There was nothing on record to establish that the government had held deliberations with all stakeholders, especially the communities that would be affected by the Act, the court

The court observed that by virtue of the 102nd constitutional amendment, the powers of the Assembly to include and exclude the Backward Classes was bestowed on Parliament. But the 105th constitutional amendment restored the power of the States to identify and notify the Backward Classes. The 102nd amendment came into existence on August 11, 2018, and the 105th amendment was enacted on August 19, 2021. The court held that on the date of its enactment, February 26, 2021, the State legislature had no power to pass such legislation.

The Tamil Nadu Backward Classes, Scheduled Castes and Scheduled Tribes (Reservation of Seats in Educational Institutions and of Appointments or Posts in the Services under the State) Act, 1993, was brought in to protect the 69% quota.

Unacceptable, says PMK

Meanwhile, PMK founder S. Ramadoss on Monday urged the Tamil Nadu Government to appeal in the Supreme Court against the Madras High Court's verdict declaring the 10.5% internal reservation for the Vanniyars unconstitutional.

In a statement, he termed the verdict "unacceptable" because such questions were not raised by the Madras High Court or the Supreme Court against the internal reservation provided to the Muslims or the Arundhathiyars in T.N.

He said Chief Minister M.K. Stalin, "who has understood the need for such a quota despite the fact that the law was passed by the previous [AIADMK] government", has the "duty and responsibility" to reinstate it through legal and political

More youngsters turn up for cardiac evaluation AFSHAN YASMEEN BENGALURU

Following the sudden death of 46-year-old Kannada actor Puneeth Rajkumar due to cardiac arrest, there seems to be panic among people, especially youngsters, who are now rushing to hospitals for a cardiac evaluation.

The outpatient department (OPD) at the State-run Sri Jayadeva Institute of Cardiovascular Sciences and Research was flooded with patients on Monday, although it was a government holiday.

Institute Director C.N. Manjunath told *The Hindu* that while doctors usually see around 1,200 patients in the OPD on Mondays, the flow was nearly 30% higher

than normal this Monday. "Till evening, doctors attended to over 1,600 patients, nearly 20% of whom had come just out of panic after watching television reports on Puneeth's death. Some 10%, who are followup patients, turned up ahead of their scheduled visits," he said. "The patient flow was unusually high on Sunday too. While we used to get around 150 patients on Sundays, we had over 550 patients on October 31 at our institute in Bengaluru. Even in Mysuru, where we see around 75 patients on Sundays, over 350 turned up this Sunday," Dr. Manjunath said.

He said, "It is prudent to undergo regular check-ups if people have a family history or comorbidities or have some symptoms. But, rushing to the hospital out of panic like this is unwarranted."



Puneeth's death triggers rush at hospitals in Bengaluru

Most of those who rushed to the OPD on Monday came with anxiety, Dr. Manjunath said, adding that some of them were even counselled.

Private hospitals too saw similar scenes. Cardiologists at the Aster CMI Hospitals said they noticed a three-fold increase in the OPD as well as emergency. Pradeep Kumar D., senior consultant (Interventional Cardiology)

at the hospital said patients, most of them in their 40s, came with complaints of chest pain and anxiety. Ranjan Shetty, interven-

tional cardiologist at Manipal Hospitals on Old Airport Road, who also saw an increase in his OPD, said such check-ups should not be out of panic. "We have been advising patients to get it done on a regular basis," he said.

The late Kannada actor, Puneeth Rajkumar, has gifted evesight to four persons. Doctors at the Narayana Nethralaya, who collected his corneas, said they sliced and transplanted them into four corneal blind patients.

Addressing mediapersons in Bengaluru on Monday, K. Bhujang Shetty, chairman and managing director of Narayana Nethralaya, said, "We are very fortunate and grateful for 'Power Star' Puneeth Rajkumar's eye donation. What was unique was that we used each eye to treat two patients by separating the superior and deeper layers of the cornea."

The superior layer was

transplanted into two patients, who had superficial corneal disease, and the deeper layer was transplanted into patients with endothelial or deep corneal layer disease. Hence, we created four different transplants from two corneas to restore the vision of four people. This has not been done in Karnataka so far, to the best of our knowledge," Dr. Shetty said.

Following in the footsteps of his father Dr. Rajkumar, the family of Puneeth Rajkumar donated his eyes on October 29.

Time for action

The G20 meeting has come at a critical moment for the global political economy

t their first in-person meeting in two years, leaders of the G20 did not shy away from re-engaging with the biggest issues facing the global community today, including the COVID-19 pandemic, climate change, a major tax agreement, and steps to address concerns regarding global economic growth and stability. On coordinated efforts to mitigate the pandemic, the focus was on vaccine production and distribution, with assurances of support to WHO's target of inoculating 40% or more of the global population against COVID-19 by 2021, and at least 70% by mid-2022. The implicit assumption in this commitment by G20 leaders is that initiatives to boost the supply of vaccines in developing countries will succeed, and cooperation will help the world overcome supply and financing constraints. On climate change, the Group leaders recommitted their nations to providing \$100 billion a year toward adaptation, mitigation, and green technologies, focusing on the needs of developing countries. However, in this sphere, a divergence of views still exists across developing and developed nations: ahead of this summit and the 2021 climate conference in Glasgow, India had rejected the call to announce a target of zero emissions. Prime Minister Narendra Modi appears to have scored a victory in this regard as the post-summit communiqué commits the G20 to limiting global warming to 1.5° C and identified sustainable and responsible consumption and production as "critical enablers".

The world community is on shakier footing regarding the fragile post-COVID economic recovery underway after paralysing lockdowns. Unsurprisingly, given the rising inflation, spiking energy prices, and alarming supply chain bottlenecks, G20 leaders were quick to affirm that national stimulus policies would not be removed prematurely. Even so, it would remain a challenge to walk the tightrope between preserving financial stability and fiscal sustainability. Perhaps in a bid to avoid potentially debilitating wobbles in global finance, the G20 leadership agreed to slap multinationals with a minimum 15% tax to create "a more stable and fairer international tax system". This would impact the tech titans of Silicon Valley, as this initiative would make it harder for such companies to benefit from locating themselves in relatively lower-tax jurisdictions. This OECD-led reform enjoys the support of 136 countries, which account for more than 90% of global GDP, and is likely to enter into force in 2023 or after. Nations such as the U.S. are divided on whether to approve this proposal domestically, and unless there is unanimity amongst the discussants, the initiative risks facing implementation delays. The G20 meeting has come at a critical moment for the global political economy. If it results in timely, effective, coordinated action across major nations, hope for recovery will remain afloat.

A vote for stability

The vote for Fumio Kishida underlines the dominance of the LDP in Japan's politics

efying expectations, Japan's ruling Liberal Democratic Party (LDP) stormed to an outright majority in the country's parliamentary elections on Sunday. The elections were the first major test for the new Prime Minister, Fumio Kishida, who took over last month amid enormous challenges. He followed the short-lived tenure of Yoshihide Suga, who succeeded Shinzo Abe. Japan's longest serving Prime Minister, Mr. Abe stepped down in 2020 citing health reasons. Mr. Suga's year-long term was marred by his government's poor handling of COVID-19 and economic woes. Facing the lowest approval ratings of any Japanese leader in years, he resigned. Entering the election in these circumstances, the LDP, which held 276 seats in the 465-seat House of Representatives before the polls, was bracing for a poor show, with wide expectations that it would need to rely on its coalition with the Komeito party to cross the halfway mark. But it coasted to victory unencumbered by coalition considerations.

Mr. Kishida now has to deliver on a range of pressing challenges, including the pandemic, the economy and on the security front, relations with China. He has committed to bolstering support to hospitals to ensure a far better response should Japan face another wave. On the economy front, he has put forward a "new capitalism" aimed at an economic revival keeping the interests of the middle class as a priority. He has pledged to come up with an ambitious stimulus package this month. On foreign policy, he will have to keep in mind the wishes of his party's conservative bloc which is calling for significant increases in defence spending. Those are voices he cannot ignore considering that the new leader-Mr. Kishida was also a Foreign Minister – has no real popular support to call upon and will be beholden to what his party wants. In the election campaign, the LDP said it would double defence spending to 2% of the GDP. China's recent air incursions into Taiwan were cited as one major reason, as also North Korea's missile tests. Mr. Kishida has said he will focus on shoring up relations with Washington, and in his early days, has already reached out to the leaders of the Quad. He has also spoken with China's President Xi Jinping, with positive noises about getting relations on track. Ultimately, matters at home will decide which of his two predecessors Mr. Kishida ends up emulating. Given the flagging reputation of the LDP towards the end of Mr. Abe's term and through Mr. Suga's turbulent time in office, the vote appears to be as much an endorsement for stability as it is for his government. It also reaffirms the LDP's unchallenged position in domestic politics regardless of the troubles it has faced in recent years, underlining there is no serious challenger to its continued dominance.

Kashmir's fragility has more complex reasons

To limit what is happening in J&K solely to the impetus created by a Talibanised Afghanistan could cost India dear

Tear is the prevailing sentiment across many parts of Kashmir today. It has, in turn, led to comparisons with the situation that existed during the 1990s and the early years of the 21st century. In the past few weeks, several civilians as well as security and armed forces personnel, have been killed by terrorists, some of the latter being labelled as hybrid terrorists, though it is not clear what this phrase signifies.

Ground realities

A predictable reaction to the situation has been the exodus of Hindus, especially of the Kashmiri Pandits, and of migrant labour, fearing for their lives and their future. Side by side with this, an impression has been created of increasing support to militancy, though it is unclear whether this is indeed the case. However, as in all situations of this kind, it is apparent that impressions often appear more real than actual ground real-

Latterly, Kashmir had managed to stay away from the headlines despite concerns expressed in different quarters about the 'disciplined democracy' being practised ever since the dilution of Article 370 and the restructuring of the erstwhile State of Jammu & Kashmir (I&K) into two Union Territories. In the absence of an agile press, it has not been possible to fathom the intensity of protests against the existing order, and whether they constitute a rejection of the changes effected.

Incidents of violence have, however, continued. Notwithstanding this, given the hullabaloo in the immediate aftermath of the changes effected in August 2019, a degree of surface calm seemed to prevail, not very different from that which existed previously. Whether this was peace brought about through controlled conditions, or otherwise, has been difficult to discern.

Given the recent recrudescence of violence, it is, nevertheless, evident that the situation remains fragile. Whether this means that the changes effected since August 2019 were merely a 'triumph of wishfulness over prudence', an overestimation of belief on what was possible ignoring the history of several decades past, and the failure of many previous attempts to change the status quo, is hence worth examining.

Pakistan apart

More important is what could possibly be the reasons for the revival of aggravated violence in Kashmir. While assessing the ground situation in Kashmir, Pakistan has always tended to be a factor. It is, however, again possible that the lessons of the past on what needed to be done - to effectively checkmate insurgency from across the border or inflame Kashmiri opinion - might have gone unheeded in the euphoria of having succeeded in altering the character of J&K and Delhi establishing a degree of direct control. Promises made and an unwillingness to use the time and opportunity to create fresh opportunities for dialogue with communities in Kashmir, allied with reputational interest in not accepting that the many steps taken, were inadequate to defeat the machinations from across the border, could also, perhaps, be additional reasons.

By this reckoning, Kashmir might well seem, in some remote way, to reveal the same attitude as many post-conflict, pre-modern, hybrid societies with mixed populations. It would imply that in the case of Kashmir, making a transformation to a more stable society will always prove difficult. In addition, Kashmir has difficult neighbours such as Afghanistan, Pakistan and China, which leaves little scope for experimentation - a true test for decision-making of any kind.

As violence escalated in J&K, it became commonplace to link it with the Taliban takeover of Af-



ghanistan. This could, however, be a highly simplistic answer to a more complex situation. In the current context, geopolitics is something that cannot and must not be ignored. The sudden surge in violence in Kashmir needs a more careful evaluation of the facts rather than simplistic answers. It is a fact, for instance, that India's world view has steadily expanded, especially in the Asia-Pacific region, and several, including some relatively unknown, tension points have emerged. All these will need to be carefully assessed before coming up with an answer more so since India is wedged between two known antagonists (Pakistan and China), has a Talibanised Afghanistan as its neighbour, and there has been a resurgence of international terror groups, notably the Islamic State and al-Qaeda.

The China factor Of particular consequence in this context is China's continuing cooperation with Pakistan in many matters, its growing assertiveness in regard to its territorial claims, vis-à-vis India, its opposition to the prominence given to India by the West in both Asian and global forums, etc. All these have further helped cement the nexus between China and Pakistan. Intertwined with this is again the battle raging for spheres of influence between China and India, which has intensified under China's President Xi Jinping. The latter is intent on establishing an Asian system in which China sits at the summit of a hierarchical re-

gional order. All this is altering the ground realities and it is worth considering whether Kashmir is emerging as a pressure point in this context.

What it all boils down to is the

Intelligence is critical

need for hard and better intelligence. Hard intelligence is critical to avoid misperceptions and miscalculations. The (recent) history of the world is replete with stories of intelligence failures, misperceptions and miscalculations, which had led to grave situations, and which might well have been avoided had there been better intelligence. The serious miscalculation about Iraqi President Saddam Hussein possessing nuclear weapons based on wrong intelligence led to unnecessary involvement by the United States and the North Atlantic Treaty Organization in Iraq, followed by an unfortunate train of events that continues to haunt the world to this day. As tensions between India and China, and between India and Pakistan, intensify, the need for hard intelligence is thus vital to be able to control the train of events and avoid any serious miscalculations.

What is common to most, perhaps all, intelligence agencies – irrespective of their degrees of competence – is their limited capacity for imagination, viz., to imagine future events and possibilities. Intelligence agencies, by and large, are adept at providing insights about yesterday's threats rather than future ones, specially those that exist just beyond the horizon. Moreover, as intelligence agencies become more wedded to technology, they need to realise that advances in technology tend to be a double-edged sword insofar as intelligence is concerned. It should not negate the need for improved analysis and also how important it is to provide decision-makers with information on what is taking place in the minds of their opposite numbers.

In the extant situation, Indian intelligence agencies must avoid the kind of lapses of both imagination and analysis displayed by western intelligence agencies

some years ago, who misread, misunderstood and failed to anticipate the role of Sayyid Qutb and his preachings which later set the stage for the 9/11 attack on the Twin Towers in New York and other targets in the U.S. Had they understood what Sayyid Qutb preached, viz., that martyrdom was a necessary part of 20th century jihad, they would not have underestimated the influence exerted by Islamist theology on the terrorist mindset.

It is, thus, important that the 'missing dimensions' of intelligence in most cases, viz., thinking imaginatively and improved analytical capabilities, receive the close attention of India's intelligence agencies. Only then will it be possible to understand the nature of current events as a precursor of future threats. This is important to ensure that they do not ignore signals that may not be all too obvious at this time, and keep chasing more obvious and current aspects. Too narrowly focussed intelligence requirements, limited to current events such as, for example, tensions with China on the border, or Pakistan's attempts to push in 'irregulars' and aid the Lashkar and Jaish elements to cross over into India, may prove self-defeating. The arc of intelligence needs to be much wider and Indian intelligence agencies such as the Intelligence Bureau, the Research & Analysis Wing as also the National Security Council Secretariat should ensure that they have the necessary capabilities.

Linked to this is also the danger of 'intelligence adjustment', viz., avoiding challenging conventional assumptions, which could undermine their ability to provide a more accurate picture of the larger threat. Today, when India faces problems all around it, to limit what is happening in Kashmir solely to the impetus created by a Talibanised Afghanistan without fully analysing all the facts could cost the country dear.

Finding a way out of India's deepening water stress

In any new National Water Policy, the aim should also be to encourage conserving water resources and efficient usage

The complexity and scale of the water crisis in India calls for a locus specific response, that can galvanise and integrate the ongoing work of different Ministries and Departments through new configurations. Such an integrated approach must necessarily cut across sectoral boundaries and not stop at the merger achieved between the two Ministries of Water Resources, River Development and Ganga Rejuvenation and the Ministry of Drinking Water and Sanitation, which led to the formation of the Ministry of Jal Shakti in

Understanding sources used Seeing India's looming water crisis through the locus of 'urban' and 'rural' not only allows a better grasp of the causative factors but also enables a stronger grip on the strategies to be deployed to reverse the water crisis. Fundamental to this is a preliminary understanding of the sources from which the country draws water to meet its varying needs. In the rural areas, 80%-90% of the drinking water and 75% of the water used for agriculture is drawn from groundwater sources. In urban areas, 50%-60% of the water supply is drawn from groundwater sources, whereas the remaining is sourced from surface water resources such as rivers, often located afar, in addition to lakes, tanks

According to the composite wa-

ter management index released by the think tank NITI Aayog in 2019, 21 major cities (including Delhi, Bengaluru, Chennai, Hyderabad) were on the brink of exhausting 🛓 📞 groundwater resources, affecting about 100 million people. The study also points out that by 2030, the demand for water is projected to be twice the available supply.

The Chennai example

A significant, and by no means less worrying, example of the water crisis that unfolded before our eyes was in Chennai in 2019, where life came to a standstill and parts of the city went without piped water for months. Though this may well have been forgotten, Chennai remains a spectacle of the impending tragedies brought about by the city's inability to meet the basic needs of citizens, vis-à-vis drinking water, cooking and sanitation.

A closer look at the factors that brought about the water crisis in Chennai is inescapable, should we gain a better grasp of the underlying problems, especially as this was a city which among others like Mumbai had suffered from floods previously. Many have cited the poor rainfall received in Chennai in the previous year as one of the main reasons for the water crisis. Though it is true that rainfall was low, which was 50% less than normal, focusing on this factor alone would absolve responsibility by blaming the vagaries of the rainfall patterns to a fast-changing climate, without understanding the ground-level steps (or missteps) which have been equally responsi-

Chief among these is that the city has been built by incrementally encroaching floodplains and paving over lakes and wetlands that

would have otherwise helped the process of recharging groundwater. The lack of space for water to

percolate underground prevented

rainwater from recharging the

This was further exacerbated by the loss of green cover (which would have otherwise helped water retention) to make way for infrastructure projects. Such a situation, on the one hand, leads to flooding during normal rainfall due to stagnation, and on the other hand leads to drought-like conditions due to the prevention of underground water storage. It is only that this situation was more magnified in Chennai, but other cities in India would echo these manifestations in varying degrees owing to a lack of sustainable urban

planning. There is also the example, in Mumbai, in 2019, when 2,141 trees were felled at the Aarey colony, amid massive protests, to make space for a shed for the Mumbai Metro Rail Corporation Limited.

Need for synergy

If the Government is serious about addressing the water crisis in urban areas, the Ministry of Water Resources must reconfigure its relationship with other Ministries and Departments (Urban Development, Local Self-Government and Environment). This would be for enhanced integration and coordi-

water zoning regulations that protect urban water bodies, grounding to enhance waste water recy cling and water recharge activities targeting aquifers and wells through rainwater harvesting.

Lessons from rural Punjab In rural areas, the situation is no

different, as the acute water crisis in Punjab shows. The draft report of the Central Ground Water Board concluded that Punjab would be reduced to a desert in 25 vears if the extraction of its groundwater resources continues unabated; 82% of Punjab's land area has seen a huge decline in groundwater levels, wherein 109 out of 138 administrative blocks have been placed in the 'over exploited' category. Groundwater extraction which was at 35% in the 1960s and 1970s, rose to 70% post the Green Revolution – a period which saw governments subsidising power for irrigation that left tu-

bewells running for hours. Concomitantly, cultivation of water intensive crops such as paddy have further aggravated water depletion, even turning water saline. Immediate measures need to be taken to manage and replenish groundwater, especially through participatory groundwater management approaches with its combination of water budgeting, aquifer recharging and community involvement.

Such an approach to water conservation again beckons new configurations between sectors and disciplines. At the sectoral level, the Ministries and Departments of water resources must coordinate efforts with their counterparts in agriculture, the environment and

nation through effective land and rural development for greater convergence to achieve water and food security. At the disciplinary water sources, wetlands and green level, governance and managecover while simultaneously work- ment should increasingly interact and draw from the expertise of fields such as hydrology (watershed sustainability), hydrogeology (aquifer mapping and recharge) and agriculture sciences (water-sensitive crop choices and soil health). Again, the importance given to groundwater conservation should not ignore surface water conservation including the many rivers and lakes which are in a critical and dying state due to encroachment, pollution, over-abstraction and obstruction of water flow by dams.

Protecting resources

The Ministry of Jal Shakti, last year, had announced an ambitious plan to provide water connections to every household in India by 2024. In view of the ongoing erosion of water resources and an ever-increasing demand for water, the thrust should not be on promising water supply. Instead the aim should be towards protecting and conserving water resources on the one hand and minimising and enhancing efficiency of water usage on the other. As the expert committee constituted under the Union Water Resources Ministry drafts a new National Water Policy, one hopes it would be rooted in locus specific realities and allows greater flexibility for integrating the insights and work of multiple departments and disciplines making way for new configurations to sustainably manage the country's



Why counting caste matters

Caste data will help us understand the contours of inequality and craft reasoned and inclusive policies

The debate about whether the decennial Census should collect data on caste from individuals who fall into the administrative categories of 'General' and 'Other Backward Classes' (OBCs) has been argued by public intellectuals, politicians, and government administrators for decades. As the Census currently only collects data on 'Scheduled Castes' (SCs) and 'Scheduled Tribes' (STs), it fails to provide comprehensive data on India's graded caste hierarchy. In the run-up to the 2011 Census, the political leadership agreed to include a full caste count in the Census. It later prevented a caste-wise enumeration in the Census. The suppression of caste-wise data took place then because of two interconnected dynamics which are likely to reoccur unless they are collectively challenged.

The importance of caste data

First, caste elites generally believe that caste no longer matters in shaping opportunities and outcomes in the 21st century. This caste blindness, or castelessness, obscures caste privileges and conceals sources of multi-generational structural advantage. Many caste elites view the collection of caste data about anyone but the most disadvantaged as unnecessary and a misuse of public resources. This perspective both serves their own interests and ignores the relational nature of caste that is, the same societal institutions, systems, and cultural norms that have led to historic and ongoing subjugation of oppressed castes have simultaneously empowered others. To understand the full scope of disadvantage, we must also examine the full scope of privilege and advantage.

The suppression also occurred as a result of the machinery of government. Organisations tasked with designing Census questions and overseeing data collection, similar to every other key institution in society, have caste-based inequalities entrenched within them. The bureauc-



racy blocked the inclusion of a full caste count in the Census 2011 on methodological grounds. It argued that a caste count would be "administratively difficult and cumbersome," "jeopardise the whole exercise," and "compromise the basic integrity of the Census". The official language used by the Congress-led government in 2011 was identical to the language used in the affidavit filed in the Supreme Court on September 23, 2021 by the present BJPled government. The presentation of (supposedly) insurmountable methodological and logistical challenges is particularly effective as an excuse because it silences non-experts. Caste elites have a numerical and cultural stranglehold over the upper bureaucracy, despite more than 70 years of Central government reservations. In 2019, out of the 82 Secretaries to the Government of India, only four were SCs or STs. Following the suppression of the caste count in Census 2011, the executive bureaucracy reconfigured the Below Poverty Line survey and renamed it the 2011 Socio-Economic Caste Census, which had little resemblance to the original demands by caste census advocates and produced unusable caste data.

The purpose for collecting castewise data in the decennial Census is to understand the contours of inequality. These data are crucial to understand how caste intersects with class, gender, and regionality to structure access to resources. The collected caste data should be publicly available for use. In this regard, the caste data would continue the existing practice of the Office of the Registrar General of India to make Census data publicly available. The Census has the legal standing, public trust, operational expertise, and resources to collect, analyse, and make

public caste data. Caste data must be collected as part of this constitutionally required exercise. Having the caste Census as part of another state project, or overseen by nodal agencies other than the ORGI, as happened 10 years ago, will relegate it to

parts of the bureaucracy with insuffi-

cient expertise in a nationwide data

collection operation. While counting (or not counting) caste is political, the decision should not be reduced to immediate political contingencies i.e., the expansion of reservation policies, the castebased mobilisation by political parties, etc. In the absence of detailed caste data, we fail to name and confront major structural and foundational problems of society; leave space for opportunistic politicians to exploit each caste; and miss the opportunity to craft reasoned, data-driven, and inclusive public policies.

Addressing concerns

Yet, important concerns remain. Some progressive and anti-caste scholars fear that a full-caste count will further entrench caste identities. A caste census will require all households to think about, acknowledge, and speak about caste identities. Yet, historically outcast groups have already had to provide caste data in all postcolonial Censuses to implement reservations. A full caste-wise enumeration will help to make visible privileges and resources that have become over time disassociated with caste, despite historical, sociological, and economic evidence to the contrary. Updated data on the entire caste system, including its intersections with other identities, will provide a more complete picture of exclusion and inequality in India.

Another concern is that groups will misuse the caste data. But mis-

use of caste data already takes place. Private groups with access to money and power regularly collect caste data for their needs. Political parties map the caste and religious composition of neighborhoods, cities, and villages to mobilise votes. Collecting caste data in the decennial Census removes this private power by making caste data publicly available to all.

While methodological and logisti-

cal challenges are real, they are surmountable. Demographers in government agencies and universities have extensive experience working through these challenges. Sample surveys such as the India Human Development Survey have collected caste-wise data. In addition, research on the failed caste count suggests the importance of careful planning to prevent groups from being made invisible in the data, such as Dalit Muslims, Dalit Christians, inter-caste and inter-religious households (particularly those that cut across the line of 'untouchability' or communal divide), and LGBTQ+ individuals. Related to the discussion of castelessness. if a 'no caste' option is included in the Census, the caste count will likely undercount well-to-do caste elites. Given the purpose of the caste count, omissions of marginalised groups and elites require specific attention while designing the survey instrument, training enumerators, educating the public, and analysing collected caste-wise data. Hence, the entire process requires external oversight if the data are to be usable and to minimise potential harm. As the process unfolds, a public oversight group should work to ensure that major operational and methodological decisions align with the data collection's purpose: to understand the scope of caste-based inequities and address structural inequalities. Anti-caste organisations and public intellectuals, who have devoted their life's work to challenging caste hierarchy, must provide oversight and input. Their perspectives and lived experiences of fighting caste oppression are the best safeguards to ensure that the collected data will be used for liberatory purposes.

The crypto conundrum

Cryptocurrencies possess no significant use value or exchange value to sustain their current high prices

Bitcoin and other private cryptocurrencies have been on a bull run recently. Unlike previous rallies, the current rally in bitcoin has witnessed the increasing participation of retail investors in India. Since 2020, when the Supreme Court overturned an order by the Reserve Bank of India dated April 6, 2018, restricting the use of cryptocurrencies, traffic in domestic cryptocurrency exchanges in India has grown many-fold. Yet, the future of bitcoin and other cryptocurrencies is unlikely to be as bright as many believe it to be.

A case of speculative mania?

The most important feature of cryptocurrencies that is flaunted by their enthusiasts is their limited supply. In a world where central banks create a lot of money out of thin air, it is natural for investors who are looking to protect their wealth to seek abode in alternative assets whose supply cannot be cranked up as easily. Money creation by central banks causes the price of all goods to rise and also tends to accelerate the adoption of alternative assets as currencies. When central banks create a lot of money, it leads to an increase in the prices of not just goods such as food and cars but also that of commodities such as gold and silver, considered to be alternative forms of money. Yet, for various reasons, the rally in bitcoin may be no more than a case of speculative mania.

For one, scarcity alone is not sufficient to facilitate the adoption of cryptocurrencies as money. Any asset must have either use value or exchange value in order for it to possess any fundamental value. This fundamental value, in turn, is reflected in the price of these assets in the long run. Stocks and bonds, for instance, possess exchange value that is based on the expected future cash flow from these assets. Commodities such as oil and steel possess use value because these assets are used to run vehicles and build real estate. Bitcoin and other cryptocurrencies may be scarce but it is questionable whether they possess any use value or exchange value. Gold and silver have traditionally served as hedges against inflation because they possess fundamental value derived from their use as jewellery and money. But bitcoin and other cryptocurrencies neither offer direct use value nor possess significant exchange value - bitcoin can buy you very few real

goods and services. In short, cryptocurrencies possess no significant fundamental value to sustain their current high prices.

Yet, many believe that the rising prices of cryptocurrencies reflect their likely future value as a currency. It is possible that investors are bidding up the price of bitcoin because they foresee a future in which private currency is widely accepted as money. After all, all investments are forward-looking. One may also grant that the extreme volatility seen in the price of cryptocurrencies, which seems unrelated to any similar fluctuations in their fundamentals, may be due to the nascent, illiquid nature of the cryptocurrency market. However, the more cryptocurrencies are accepted in exchange for goods and services, the greater the chances of governments cracking down on them.

Issuance of money

The monopoly that governments (and central banks) possess over the issuance of money is at the root of their power and influence. This allows governments to fund their budget deficits, particularly during times of crises such as the current pandemic when tax revenues have taken an unprecedented hit. It also allows central banks to tinker with the money supply under the mandate of managing aggregate demand in the economy. In essence, monopoly control over money allows governments to indirectly tax citizens by increasing the supply of currencies, thus devaluing them. If cryptocurrencies like bitcoin are going to challenge fiat currencies like the U.S. dollar as a medium of exchange, they would essentially be challenging the authority of the government to print and spend. This is not an assault that governments will tolerate for long. They will allow cryptocurrencies to exist only as long as these currencies remain a speculative asset and not a medium of exchange.

This is not to say that governments are justified in their crackdown against cryptocurrencies. China recently imposed a complete ban on all cryptocurrencies and plans to issue its own central bank-issued digital currency. Private alternatives to fiat currencies offer people greater choice in what currencies they choose to use as a medium of exchange. The benefits of free market competition in money were elaborated by economist Friedrich Hayek in The Denationalization of *Money*. Most notably, competition between currencies to cater to the demands of customers would ensure that fiat currencies that are printed indiscriminately simply go out of use. This is the outcome that governments fear and would fight to avoid at any cost.

Chandrababu Naidu is clearly on a mission to revive his old friendship with the Bharatiya Janata Party (BJP) at the Centre. In the hope of bringing back glory to the ailing TDP and to protect it from the ruling YSR Congress Party (YSRCP) back home, Mr. Naidu is making every effort he can to join hands with an old friend which his party has ignored at the cost of repeated setbacks in the last few years.

The TDP's growing desperation for a

Looking for an ally

strong ally has been quite obvious in Mr. Naidu's words and deeds. Recentlv, in an interview to this newspaper, when asked whether he was open to exploring a return to the National Democratic Alliance (NDA), Mr. Naidu said: "We must explore it, otherwise others will exploit us." This is an indication that he is worried about the BJP-YSRCP friendship. The BJP, in fact, had wanted the YSRCP in the Union Cabinet but the regional party has always been averse to it, being content, instead, with extending issue-based support to the BJP. Two weeks ago, after the TDP's offices were attacked by miscreants, Mr. Naidu alleged that party persons were being targeted by YSRCP-backed mobs and requested Union Home Minister Amit Shah to deploy Central forces to ensure adeq-

uate security to the party's offices. The TDP's tie-up with the BJP in 2014 had been successful. The TDP had gained from the anti-Congress sentiment following the bifurcation of Andhra Pradesh as well as the 'Modi wave'. The alliance was strongly supported by the popular actor, Pawan Kalvan. But trouble started brewing between the partners in 2018 over the issue of central funding to the State. Mr. Naidu was also upset that the Centre was not granting special category status to Andhra Pradesh and finally snapped ties with

the NDA. The BJP argued then that it had always been willing to grant the monetary equivalent of special category status to Andhra Pradesh. Mr. Kalyan launched a scathing attack against the State government, which TDP ministers alleged was being done at the behest of the BJP.

Patching up

After this fallout, Mr. Naidu started exploring alliances with the Congress and other parties, but these were unsuccessful. And so, Mr. Naidu was forced to wage a lone battle in the 2019 polls and met with an embarrassing defeat in the hands of the YSRCP. Post this debacle, Mr. Naidu has expressed regret - both in public and in private meetings with party members – for snapping ties with the NDA. During the post-poll meet of the party, Mr. Naidu said that he had


nothing against the BJP and that his decisions were purely aimed at protecting the interests of the State.

Over the years, Mr. Naidu's softened stand can be seen in his appreciation for Prime Minister Narendra Modi.

In April 2020, for instance, Mr. Naidu hailed Mr. Modi for taking a "bold and statesman-like decision" to extend the COVID-19 lockdown. But the patch up with the BJP is not going to be easy. It might be hard for the BJP to ignore the two betrayals of the TDP – first after the 2004 polls when Mr. Naidu blamed and deserted the BJP after losing to Congress's Y.S. Rajasekhara Reddy; and the second in 2018, when the TDP snapped ties with the NDA. In 2019, Mr. Shah had said firmly that the doors of the NDA would be permanently shut for the TDP. The party re-iterated this stand last month. Yet, anything is possible, says a senior BJP leader in the State on the condition of anonymity. After all, the Congress, a foe, suddenly became a friend for the TDP in 2018. For the TDP, whose prospects seem bleak in the short term, finding an ally is crucial.

FIFTY YEARS AGO NOVEMBER 2, 1971

Punitive action silences Pak. troops

The Indian defence forces have taken punitive action across the border for the first time on the eastern front to silence the Pakistani troops who have been repeatedly shelling for the last 11 days the Tripura township of Kamalpur causing considerable damage to property and loss of civilian life. The Defence Ministry spokesman, who disclosed the operation to-day [New Delhi, Nov. 1], did not say in so many words that the Indian armed forces had actually crossed the border to stop this Pakistani shelling, but he pointed out that this kind of action had been taken for the first time. He said: "Kamalpur has been shelled for the last 11 days by the Pakistan forces. There have been a number of civilian casualties and many buildings damaged. Our border forces have taken some action yesterday and to-day. The result is that there will be no further trouble from the Pakistan side in this sector. We were forced to take this action to stop the Pakistani shelling." The spokesman did not indicate the strength of forces involved on both sides in this operation. But he stressed that the fighting was confined to ground troops and that there was no air action.

A HUNDRED YEARS AGO NOVEMBER 2, 1921

Non-Co-operation

Mahatma Gandhi writes in "Young India": There is no doubt that non-co-operation is an education which is developing and crystallizing public opinion. And as soon as it is organised enough for effective action, we have Swaraj. We cannot organise public opinion in a violent atmosphere. Just as those who have been forced by the Moplahs to recite the Kalima are no Musalmans, even so those who call themselves non-co-operators from fashion or compulsion are no non-cooperators. They are a hindrance and no help. Our tyranny, if we impose our will on others, will be infinitely worse than that of the handful of Englishmen who form the bureaucracy. Theirs is a terrorism imposed by a minority struggling to exist in the midst of opposition. Ours will be a terrorism imposed by a majority and therefore worse and really more godless than the first. We must therefore eliminate compulsion in any shape from our struggle. If we are only a handful freely holding the doctrine of non-co-operation, we may have to die in the attempt to convert others to our view, but we shall have truly defended and represented our cause.

'India will achieve net zero emissions by 2070'

Modi, Boris Johnson discuss Afghanistan

The discussion on Afghanistan between the two figures is significant as India and the U.K. have been working together in the UN Security Council to ensure "unimpeded" humanitarian support for the people of Afghanistan who are facing a serious crisis because of breakdown in law and order and a famine.

The mention of Asia-Pacific is also a significant addition to the list of items on the agenda of the two top leaders.

The Hindu has learnt that the U.K. will deploy two warships permanently in the Indo-Pacific region in the near future.

Festive season fires up October GST revenues

The Union Finance Ministry said this reflected the recovery of economic activity and would have 'still been higher if the sales of cars and other products had not been affected on account of disruption in supply of

semi-conductors'. October's GST kitty was 24% higher than the corresponding month a year ago and 36% over the pre-pandemic levels of 2019.

This was driven largely by a 39% year-on-year surge in collections from import of goods, while domestic transactions and import of services were 19% higher than October 2020.

Pratip Chaudhuri in judicial custody; case pertains to two hotel properties

The Chief Judicial Magistrate's Court in Rajasthan's Jaisalmer city on Monday sent former Chairman of the State Bank of India (SBI) Pratip Chaudhuri, who was arrested from his Delhi residence for an alleged loan scam involving a hotel, to judicial custody for 14 days after rejecting his bail application.

Mr. Chaudhuri was arrested on the warrants issued by the court.

The case against Mr. Chaudhuri, who retired from the SBI in 2013, pertains to two hotel properties worth ₹200 crore in Jaisalmer having been sold at a much lower price of ₹25 crore after de-

them performing assets (NPA). The Godawan Group had taken a loan of ₹24 crore from the SBI for its hotel project in 2007. The project remained incomplete for over three years, while another hotel of the group was functioning.

The borrower, who had initially lodged a first information report (FIR) with the police against the sale of assets to Alchemist ARC, filed a protest petition in the CJM's Court on being aggrieved by the closure report filed by the police authorities. In a clarification on the matter, the SBI said on Monday that the sale to the ARC was carried out through "a laid down process as per the policy of the bank".

are the group's former managing director Shibamoy Dutta and then directors Ashok Kumar Saha and Ram Lal Goswami of Rose Valley Hotel & Entertainment Ltd. (Kolkata). Earlier, a chargesheet

was filed by the Tripura Police in January 2018. The CBI registered the case on October 18, 2019. They alleged that the group set up the

company with the intention of cheating people. They collected huge deposits by issuing certificates in the name of booking rooms in hotels to a large number of investors in violation of the Companies Act and Securities and Exchange Board of India (SEBI) regulations.

Agents were appointed to collect public deposits on the promise of high percentage of commissions and incentives, in violation of the Companies (Acceptance of Deposits) Rules.

The accused ran an illegal money circulation scheme, which was banned under the Prize Chits and Money Circulation Schemes (Banning) Act.

Four get death sentence in Patna serial blasts case

80 injured in the blasts at a Hunkar rally of the National Democratic Alliance in Patna in October 2013. Prime Minister Narendra Modi, who was then Gujarat Chief Minister, was among the leaders who attended the

All the accused were said to be members of the Students Islamic Movement of India (SIMI) and Indian Mujahideen (IM).

One Tariq Ansari had died while planting a bomb inside a toilet at Patna junction.

Out of the nine convicts, six were from Ranchi in Jharkhand, two from Mirzapur in neighbouring Uttar Pradesh and one from Raipur in Chhattisgarh. All the accused are currently lodged in the Beur central jail in Patna.

Fertilizer supply is set to increase, says Minister

'Production will surpass demand'

Production of fertilizers will surpass demand, Chemicals and Fertilizers Minister Mansukh Mandaviya said on

In a statement, he denounced rumours of shortage and urged farmers not to hoard fertilizers.

In the run-up to the sowing season for the rabi crop, farmers in many States have complained of difficulties in sourcing di-ammonium phosphate or DAP, the most popular fertilizer after urea. There have been reports of farmers travelling long dis-

tances and waiting in queues to buy DAP, as well as allegations of prices per bag being increased in some areas despite subsidies to fertilizer companies.

Mr. Mandaviya reviewed production targets for November with the officials.

"While the demand of urea is 41 lakh tonnes, 76 lakh tonnes of urea will be produced. Similarly, 18 lakh tonnes of DAP will be produced against a projected demand of 17 lakh tonnes. Supply of 30 lakh tonnes of NPK will surpass the demand of 15 lakh tonnes," the statement said.

NCSC to probe Wankhede's complaint

Mehbooba Mufti says New Delhi is resorting to 'naked communalism' in the U.T.

The Peoples Democratic Party (PDP) on Monday accused the Central Government of "creating and fostering new fault lines between the people of Jammu and Kashmir".

Immediately after chairing a meeting of the Political Affairs Committee (PAC) of the party, PDP president Mehbooba Mufti observed that New Delhi was resorting to 'naked communalism' and pitting people against each other on the basis of religion, cast, sect and ethnicity. They were the only tools of the BJP to cover up its failure in governance. Hence divisive policies were gaining fresh ground and promoted unabashedly.

A PDP spokesman said the PAC meeting noted that New Delhi was further dividing J&K people "to accomplish the agenda of complete disempowerment of people." The party wanted people to collectively rise in unison to

"The abject failure of the BIP government has given J&K the dubious distinction of having the highest unemployment rate in the counry," the PDP claimed.

Party chief spokesperson Sved Suhail Bukhari asserted that the PAC would redouble its efforts to fight the designs of dividing and disempowering the J&K people and would give voice to the concerns and aspirations of all the people of Jammu, Kashmir and Ladakh.

He sought the immediate release of all political prisoners and speedy and impartial investigation into cases of recent civilian killings.

Earlier in the day, Ms. Mufti alleged that she was disallowed to meet the family of a civilian, who was killed in a "crossfire" on October 25 in south Kashmir.



Rescue guide launched for Ganges river dolphin

The mammals often get stranded in irrigation canals

SHIV SAHAY SINGH

The Jal Shakti Ministry on Monday released a guide for the safe rescue and release of stranded Ganges river dolphins. The document has been prepared by the Turtle Survival Alliance and the Environment, Forest and Climate Change Department (EFCCD) of the Uttar Pra-Government. The desh guide has been drawn from years of experience of rescuing 25 Ganges river dolphins stranded in irrigation canals.

The Ganges river dolphin is the national aquatic animal of India and is listed as 'endangered' under the IUCN Red List Assessments, Schedule I of the Indian Wildlife (Protection) Act (1972), Appendix I of the Convention on International Trade

in Endangered Species of Wild Fauna and Flora

The species, whose global population is estimated at 4,000, is mostly found in the Indian subcontinent. The dolphins often accidentally enter canals in northern India and are unable to swim up against the gradient. They are also vulnerable to harm by people.

The manual is endorsed

by the IUCN Cetacean Specialist Group.

Best practices on crowd control, dolphin capture from canals and handling, transfer, transport and release are part of the guide.

"Found throughout the Ganges-Brahmaputra-Meghna and Karnaphuli-Sangu river systems of Nepal, India and Bangladesh, the Ganges river dolphin [Platanista gangetica gangetica] is a global priority and is also an indicator of healthy aquatic systems," said Shailendra Singh, director of Turtle Survival Alliance, India.

The guide was also simultaneously released via local fishermen at the Ghaghra river, a prime habitat where most of the rescued dolphins were released in the past few years.

CBI takes over investigation into the 'Bike Bot' swindle

The CBI has taken over the probe into the 'Bike Bot' scam in which more than two lakh people were allegedly cheated of about ₹15,000 crore on the false promise of lucrative returns on investments in a bike taxi service scheme by a company registered as the Garvit Innovative Promoters Limit-(GIPL). Under the scheme, an investor had to pay ₹62,100 per bike with an assurance of ₹5,175 in monthly returns and other

The agency has named 15 people, including the company's chairman-cum-managing director Sanjay Bhati, in the First Information Report (FIR). The Dadri police in Uttar Pradesh had earlier registered 11 cases and made several arrests in the matter.

According to the CBI case, complaints had earlier been submitted and the Noida district authority and the police were aware of the fraudulent activities of the company but did not take any action. The complainants alleged that the then Senior Superintendent of Police and the Superintendent of Police in Crime Branch pressured them to withdraw their complaints.

In a complaint lodged with the police, the boy's mother alleged that Mr. Singh and two other persons had been sexually assaulting her son for the last one month after intoxicating him with a narcotic substance. The judge and the two other accused had threatened the boy with implicating his family in false cases if he spoke about the assault to anyone. according to the complaint.

Mr. Singh allegedly befriended the boy at the District Club in Bharatpur, where he used to play tennis. He allegedly took the boy to his residence and had sex with him several times. The matter came to light when the minor told about this to his mother last week.

The other accused were identified as Anshul Soni, the judge's stenographer, and Rahul Katara, another staff member of the court. The FIR has been registered at the Mathura Gate police station.

The victim's family also alleged that ACB Circle Officer Parmeshwar Lal Yadav had threatened to kill the boy. The Home Department has placed Mr. Yadav under suspension as per the Rajasthan Civil Services (Classification, Control and Appeal) Rules,


A video of Mr. Singh apologising to the boy and his mother has gone viral on social media in Bharatpur. The police will verify the video during the investigation.

The judge has lodged a counter-complaint against the boy's family, accusing them of blackmail and extortion.

Rajasthan State Commission for Protection of Child Rights chairperson Sangeeta Beniwal has sought a report from the Bharatpur Superintendent of Police and asked the authorities to carry out an impartial probe.





Pentagon rattled by China's military push

They are expanding rapidly in space, in cyberspace and then in land, sea and air, says Gen. Mark Milley

WASHINGTON

China's growing military muscle and its drive to end American predominance in the Asia-Pacific is rattling the U.S. defence establishment. American officials see trouble quickly accumulating on multiple fronts - Beijing's expanding nuclear arsenal, its advances in space, cyber and missile technologies, and threats to Taiwan.

"The pace at which China is moving is stunning," says Gen. John Hyten, the secondhighest ranking officer in the U.S. military, who previously commanded the U.S. nuclear forces and oversaw the Air Force space operations.

At stake is a potential shift in the global balance of power that has favoured the U.S. for decades.

A realignment more favourable to China does not pose a direct threat to the U.S. but could complicate

U.S. alliances in Asia. New signs of how the Pentagon intends to deal with the China challenge may emerge in the coming weeks from Biden administration policy reviews on nuclear weapons, global troop basing and overall defence strategy.

For now, officials marvel at how Beijing is marshalling the resources, technology and political will to make rapid gains – so rapid that the Biden administration is attempting to reorient all aspects of U.S. foreign and defence policy.

The latest example of surprising speed was China's test of a hypersonic weapon capable of partially orbiting Earth before re-entering the ing" for the U.S. but added atmosphere and gliding on a manoeuvrable path to its target. The weapon system's design is meant to evade U.S.

missile defences, and although Beijing insisted it was testing a reusable space vehicle, not a missile, the test appeared to have startled U.S. officials.

Sputnik moment

Gen. Mark Milley, chairman of the Joint Chiefs of Staff, said the test was "very close" to being a Sputnik moment, akin to the 1957 launching by the Soviet Union of the world's first space satellite, which caught the world by surprise.

Gen. Milley and other U.S. officials have declined to discuss details of the Chinese test, saying they are secret. He called it "very concernthat problems posed by China's military modernisation run far deeper.

"That's just one weapon system," he said in a Bloomberg Television interview. "The Chinese military capabilities are much greater than that. They're expanding rapidly in space, in cyber and then in the traditional domains of land, sea and air." On the nuclear front, private satellite imagery in recent months has revealed large additions of launch silos that suggest the possibility that China plans to increase its fleet of land-based intercontinental ballistic missiles, or ICBMs.

Pentagon officials and defence hawks on Capitol Hill point to China's modernisation as a key justification for rebuilding the U.S. nuclear arsenal, a project expected to cost more than \$1 billion over 30 years.

U.K. vows action if France does not back down in fishing row

'The French have made completely unreasonable threats'

Britain on Monday warned France it will take action if Paris does not withdraw "unreasonable" threats to impose trade measures in an increasingly acrimonious row over post-Brexit fishing rights.

President Emmanuel Macron said on Sunday that Britain must give ground in the dispute or France will trigger trade reprisals on Tuesday, saying: "The ball is in Britain's court."

But Britain's Foreign Secretary Liz Truss told Sky News on Monday that "we will use the mechanisms of our trade agreement with the EU to take action" if Mr. Macron goes ahead with his plans. "The French have made completely unreasonable threats, including to the Channel Islands and to our fishing industry, and they need to withdraw those threats," she said.

"If somebody behaves unfairly in a trade deal you're entitled to take action against them and seek some compensatory measures. And that is what we will do if the French don't back down."

Angry Paris

France is angry that Britain and the Channel Islands of Jersey and Guernsey have not issued some French boats with licences to fish in their waters since Brexit took full effect at the start of

Paris has vowed that, unless licences are approved, it will ban U.K. boats from unloading their catches at French ports from Tuesday and impose checks on all products brought to France from Britain.

Jersey's Minister for External Relations Ian Gorst said on Monday that his officials had followed the terms of the Brexit deal, which stipulates that boats should only be granted licences if evidence is presented that they fished in the waters before 2016. "We've really tumbled over ourselves to be as engaging and as reasonable as possible," he told Sky News.

Britain's Prime Minister Boris Johnson complained to EU chief Ursula von der Leyen on Saturday that French threats over fishing were "completely unjustified" as he held out the option of invoking the Brexit dispute tool for the first time, drawing the EU itself into the row.

Islamists call off rally after talks with Pakistan Govt.

They are demanding release of leader

A banned Pakistani Islamist party on Monday called off a march to the capital and ended its occupation of a major highway after reaching a deal with the government, following more than a week of clashes that left seven policemen dead.

The Tehreek-e-Labbaik Pakistan (TLP) was protesting over the detention of its leader, arrested in April when the group was outlawed by authorities, and was demanding the expulsion of the French Ambassador from Pakistan over publication of blasphemous caricatures.

Several thousand supporters had begun a stop-start march from the eastern city of Lahore to the capital Islamabad, reaching about one third of the way. "We have called off our march to Islamabad after reaching an agreement with the government," Sajjad Saifi, a spokesman for the TLP, said.

"Our supporters have moved to the nearby park and until 50% of terms are fulfilled we will stay here," he added. The government has refused to comment on

Japan's PM Fumio Kishida calls victory after 'tough' election

He vows to take leading role in climate action

Japan's Prime Minister Fumio Kishida declared victory on Monday after his ruling coalition won a strong majority in national elections, vowing to boost the virus-hit economy and "take a leading role" in Asia's push towards carbon neutrality.

Mr. Kishida, a soft-spoken centrist who has been in office for a month, said he would set out plans for a pandemic spending package

this month in a bid to revive the world's third-largest economy. Before heading to the COP26 summit, Mr. Kishida said he was committed to climate targets set by his predecessor Yoshihide Suga.

"We will not only stand firm on our 2050 carbonneutral goal but also take a leading role in working towards zero emissions in Asia," he said.

The long-ruling Liberal Democratic Party (LDP) and its junior coalition partner Komeito won 293 of the 465 seats in Parliament's Lower House, local media reported while the official result was finalised. The coalition had previously held 305 seats.

"It was a very tough election, but the people's will that they want us to create this country's future under the stable LDP-Komeito government and the Kishida administration shown," Mr. Kishida said.

Abiy defiant as rival Tigray forces make advance

Federal troops are fighting: Ethiopia PM

Ethiopia's Prime Minister has called on citizens to redouble efforts to combat the rival Tigray forces who claim to have seized key cities on a major highway leading to the capital, while a new wave of detentions of ethnic Tigrayans has begun.

A move on Addis Ababa is a new phase in the war that has killed thousands of people since fighting broke out a year ago between Ethiopian and allied forces and Tigray ones who long dominated the national government before Prime Minister

Abiy Ahmed took office in 2018. His spokeswoman, Billene Seyoum, said on Monday that Mr. Abiy "is where he's meant to be, leading the country's front and

Mr. Abiy, in a statement on Sunday, said federal troops are fighting on four fronts against the Tigray forces and "we should know that our enemy's main strength is our weakness unpreparedness". Amid calls for attacks against ethnic Tigrayans, he said "we should closely follow those who work for the enemy and live amongst us".

Four killed in Lagos high-rise collapse

A high-rise building under construction collapsed in Nigeria's commercial capital Lagos on Monday, killing at least four people with dozens more feared trapped inside the rubble.

Rescue officials said many workers were caught inside the 21-floor building in Lagos's wealthy Ikoyi residential and business district when it crumbled.

Ibrahim Farinloye of the National Emergency Management Agency said four people had been rescued and four bodies recovered from the site.

+ Sri Lanka fisher leaders meet Indian envoy

They convey concern over 'delay in India's response' to bottom trawling issue

The Indian High Commissioner in Colombo on Monday assured Sri Lanka's northern fishermen that he would convey their concerns over bottom trawling by Indian fishermen in the Palk Strait to both New Delhi and Tamil Nadu and look at some immediate measures to address the problem.

A delegation of fisher lead ers from Sri Lanka's northern districts, along with Jafflegislator Sumanthiran, met Indian High Commissioner Gopal Baglay in Colombo on Monday, and voiced concern over the "delay in India's response" to the issue of bottom trawling in the Palk Strait. The meeting was con-

sion, held when High Commissioner Baglay called on Tamil National Alliance (TNA) leader R. Sampanthan last week, according to TNA spokesman Mr. Sumanthiran, who was also at the meeting. "The fisher community leaders recalled that the Indian side had agreed twice - in 2010 and 2016 - to phase out and end the practice of bottom trawling. But it has not ended yet," the Jaffna MP told The Hindu, after Monday's meeting.

A fortnight ago, northern Sri Lankan fishermen held a sea rally, demanding that Sri Lanka implement its laws against bottom trawling, a destructive fishing method that erodes the seabed, endangering marine organ-

isms. Dozens of boats with black flags travelled 100 km from the north-eastern Mullaitivu town to Point Pedro in Jaffna, with some TNA MPs ioining the protest. Fishermen from Tamil Nadu crossing the International Maritime Boundary Line (IMBL) and fishing in Sri Lankan waters, using the harmful bottom trawling fishing method, has been a recurring flashpoint in India-Sri Lanka ties.

"The High Commissioner listened to the fisher leaders' grievances and told them that he would convey their sentiments to both New Delhi and Tamil Nadu. He agreed that while long term solutions are taking time, it is important to come up with some short-term measures meanwhile," Mr. Sumanthiran said.

The Taliban-appointed supervisor of a small district hospital outside the Afghan capital has big plans for the place – to the dismay of the doctors who work there.

Mohammed Javid Ahmadi, 22, was asked by his superiors, fresh off the fields of battle from a war that has spanned most of his life, what kind of jobs he could

It was Ahmadi's dream to be a doctor; poverty had kept him from gaining admission to medical school, he said.

He chose the health sector. Soon after, the Mirbacha Kot District Hospital just outside of Kabul became his responsibility.

Different priorities

It's a job Ahmadi takes very seriously, but he and the other health workers in the 20-bed hospital rarely see eye-to-eye. Doctors are demanding overdue salary payments amid critical shortages of medicine, fuel and food.

Ahmadi's first priority is to build a mosque inside the hospital quarters, segregate staff by gender and encourage them to pray. The rest will follow according to the will of God, he tells them.

The drama in Mirbacha Kot is playing out across Afghanistan's health sector since the Taliban takeover. With power changing hands overnight, health workers have had to contend with a difficult adjustment. The host of problems that preceded the Taliban's rise were exacerbated.

In Mirbacha Kot, doctors have not been paid in five

"What can we do? If we don't want to come here there's no other job for us. If there was another job, nobody can pay us. It's better to stay here," said Dr. Gul Nazar.

October manufacturing activity quickens, job losses persist: PMI

'Producers recorded strongest improvement in operating conditions since Feb.'

The country's manufacturing activity expanded for the fourth month in a row in October, as reflected by the IHS Markit Purchasing Managers' Index (PMI). The surveybased PMI rose to 55.9 from 53.7 in September.

Manufacturing jobs continued to slidethough producers recorded the strongest improvement in overall operating conditions since February, and business optimism hit a six-month high. A PMI reading of 50 indicates no change in output levels.

Overall new orders grew at the fastest pace in seven months, while factory output also increased at the strongest pace since March.

New export orders surged as well, the quickest in three months, according to IHS Markit. Input purchases increased at the fastest pace since April, as producers geared up to cope with the surfeit of new orders. However, the cost of inputs be-

gan to pinch, with the overall inflation for them surging to a 92-month high. "Anecdotal evidence highlighted higher chemical, fabric, metal, electronic component, oil, plastic and transportation costs," IHS Markit noted.

As capacities were still not

fully utilised and government norms were in place surrounding shift work, employment continued to decline. The silver lining was that the rate of job shedding was marginal in October.

"With companies gearing up for further improvements in demand by building up their stocks, it looks like manufacturing activity will continue to expand throughout the third quarter of 2021-22 should the pandemic remain under control," said Pollyanna De Lima, economics associate director at IHS Markit.

She flagged input cost inflation as a worry, citing that it was "at a near 8-year high, as strong global demand for scarce raw materials continued to push up prices."

Borrowing cost for States spurts to 7.02%

For the first time this fiscal, the weighted average cost of States' market borrowings crossed the 7% mark at auctions held on Monday, with the average cut-off jumping by 12 bps to 7.02%.

The spike is surprising as seven of the nine States did not participate in the auctions after the States got the final tranche of the GST compensation last week, Icra chief economist Aditi Nayar said.

At 7.02%, the State developmental loan cut-off is the highest this fiscal.

This, despite the release of the final tranche of GST compensation loan of ₹44,000 crore on October 28, within weeks of the second tranche disbursal of ₹40,000 crore, the rating agency said.

Maruti, Hyundai October sales fall on supply woes

Chip shortage drives double-digit slide

Leading carmakers Maruti Suzuki India (MSI) and Hyundai witnessed a doubledigit drop in sales in October on account of the global semiconductor shortage impacting production. Kia India and Honda Cars also saw a fall in dispatches from a year earlier.

Tata, M&M buck trend

However, companies such as Tata Motors, Mahindra & Mahindra (M&M), Nissan and Skoda managed to show growth last month despite supply chain challenges.

The country's largest carmaker (MSI) said domestic sales slipped 32% to 1,17,013 units last month as against 1,72,862 units in October 2020. Rival Hyundai Motor India reported a 35% de-

cline in domestic sales to 37,021 units. It had dispatched 56,605 units to dealers in October 2020.

The global semiconductor supply constraint continues to be a challenge, resulting in lower production

across the industry, it said. Kia India witnessed a 22% decline in wholesales to 16,331 units, while Honda Cars saw domestic dispatches slide 25% to 8,108.

M&M said domestic passenger vehicle sales rose 8% to 20,130 units. Tata Motors reported a 44% jump in domestic passenger vehicles to 33,925 units in October compared with 23,617 a year earlier. Nissan India's domestic wholesales rose over threefold to 3,913 units, while Skoda reported a more than twofold jump to

3,065 units.

Electricity demand rose 4.8% in Oct.

India's power consumption grew 4.8% in October to 114.37 billion units (BU), indicating a good recovery amid coal shortages at electricity generation plants, according to power ministry data.

Last year in October, power consumption stood at 109.17 BU and in the same period in 2019, it was at 97.84 BU.

During October, the peak power demand met or the highest supply in a day stood at 174.60 GW, higher than the 169.89 GW seen a year earlier. The data clearly shows that there is recovery in power consumption as well as de-

Goods exports climb 42%, imports surge 63%

Inward shipments of coal, gold double

India's merchandise exports stood at \$35.47 billion in October, or 35.2% higher than the pre-pandemic level of 2019 and 42.3% above the number in October 2020.

"Encouragingly, non-oil exports rose to a sevenmonth high of \$30.3 billion in October, 30% higher from a year ago," said ICRA chief economist Aditi Nayar.

"A sustenance of healthy export growth will be crucial to contain the current account deficit in light of the recovery and commodity price-led surge in merchandise imports," she said, adding oil imports also dipped after a spike in September.

CIL output up 6.4%; supply for power jumps

earlier. British arm Jaguar

Buttler serves up yet another feast

His maiden T20I hundred sets up a 26-run win over Sri Lanka; England makes it four in four

Jos Buttler hit the first century of the ICC T20 World Cup England effectively booked its semifinal spot with a 26-run victory over Sri Lanka on Monday.

Buttler's unbeaten 101 his maiden century in 86 T20Is – steered England to 163 for four after being invited to bat first.

The bowlers, led by Adil Rashid, then combined to bowl out Sri Lanka for 137 in 19 overs and helped England win its fourth match on the trot in Group 1. Sri Lanka slipped to its third loss in four matches.

Only South Africa and Australia can match its eight points, but England already has the cushion of a far superior run rate.

Buttler smashed six fours and six sixes in his 67-ball knock and put on 112 with skipper Eoin Morgan, who made 40, to lift England after it was in trouble at 35 for

The England opener, who hit an unbeaten 71 in the win over Australia, surpassed his previous T20 best of 83 and leads the batting chart with

"I felt like I used a lot of my experience. I remember saying a while ago, if I can put both parts of my game together then I think I'll be getting into a really good place with my T20 batting," said Buttler.

Sri Lanka had England on the backfoot but Buttler took the attack to the opposition as he reached his hundred off the final ball of the innings with a six.

Leg-spinner Wanindu Hasaranga got two early wickets, that of Jason Roy and Jonny Bairstow, who was trapped lbw for nought off the first ball. The right-left combination of Buttler and Morgan stood firm to grind down the Sri Lankan attack with some sensible batting.

Buttler reached his fifty off 45 balls and shifted gears with some powerful hits that unsettled the Sri Lankan

Morgan joined the charge with one four and three sixes in his 36-ball knock before being bowled by Hasaranga, who returned figures of three for 21.

In reply, Sri Lanka lost early wickets and was never in the chase till Shanaka (26) and Hasaranga got together.

Relay catch

The two put on a threatening stand of 53 for the sixth wicket before a relay catch between Roy and substitute Sam Billings sent back Hasaranga. The Lankans never recovered from that blow.

Pakistan's hat-trick of wins in the ongoing ICC T20 World Cup means it is close to sealing its spot in the semifinals when it takes on Namibia on Tuesday.

Babar Azam's men began by ending their India hoodoo at World Cups with a record 10-wicket win in Dubai. It has set the tone for a tournament where Pakistan's uncharacteristic consistency and enviable chutzpah have become the hallmarks.

The world's No. 2 T20I team has a highlights reel of mesmerising bowling spells and whirling moments of brilliance with the bat, including Shaheen Afridi's fiery new-ball assault against India in which he claimed both openers and Asif Ali's unbeaten 25 off seven during which he hit four sixes in over to Afghanistan.

Pakistan has played 14 T20Is in the UAE since 2016, winning each of them. But one has to sacrifice the cold objectivity of stats to better understand what the team has achieved at this World Cup so far.

It isn't the emergence of a special sporting talent; it is a team working as one. Any fan of cricket will tell you that Pakistan has always been good before finding a way to collapse.

But implosion is one thing it has steered clear of this time – there were moments against New Zealand and Afghanistan when things could have gone awry, but they commanded the chase. There is a steeliness to this Pakistan side, but more importantly, there is a well-executed plan.


